PRESIDENT'S MESSAGE



Innovations

- In 2001 Southern Section was the first, and for eight years after, the only Section in the state to purchase its own property, thereby ensuring an equity holding. The Executive committee has approved a recommendation by the office to pay off the mortgage saving the Section \$56,000 per year in mortgage costs.
- In 2000 the Southern Section was the only Section in the state to institute a mandatory ball use contract. The result? Ball contract revenue has increased four fold and states throughout the country have followed suit.
- In 2006 the Southern Section became the only Section in the state to institute a television rights program for the regular season adding to the playoff rights it already controlled resulting in over \$200,000.00 returned directly back to member schools over the past 4 years.
- In 2008 the Section was the first and only Section to eliminate per pupil assessments for dues saving schools hundreds of dollars every year from their ASB accounts. We are the best value in the state and arguably the country.
- In 2010 the Section became the only Section to offer Bluebook 101 to the members of the media in our coverage area. This involved a one-day workshop to explain our governance structure and policies to the media members in attendance.
- As a result of the strong financial position we have established the Executive Committee has asked the staff to investigate a way to send money back to the schools – probably by reverting back to the 50-25-25 playoff split.
- Over the past 10 years the Section has been the only Section to hold athletic director, principals and new athletic administrator workshops that are held in the respective geographical areas of our membership.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

January 15, 2011

1. OPENING BUSINESS

- A. Call to order by Bill Dabbs, President of the Council - The meeting began at 8:35 a.m.
- B. Pledge of Allegiance
- C. Roll Call
- D. Any Introductions
- E. Adopt Agenda—Action - It was moved, seconded and approved to adopt the agenda and move a portion of the Closed Session after the Public Hearing Session. It was moved, seconded and approved to have item 5E follow the Closed Session.

F. Approval of Minutes –

- 1. Minutes of the November 4, 2010 Executive Committee Meeting – Action - The minutes were moved, seconded and approved.
- 2. Corrected Minutes of the September 30, 2011 Executive Committee Meeting – Action - The revised minutes were moved, seconded and approved.

2. PUBLIC HEARING SESSION

- A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes. There was no one present for the Public Hearing Session.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

There were no State Federated Council action items at this time.

B. SOUTHERN SECTION ACTION ITEMS

1. Proposal from Area Placement/Re-leaguaging Committee (Revised)

- a. Area Placement Process – Action - After discussion, it was moved, seconded and approved to support the Area Placement Process.

- b. Releaguaging Procedures – Action - After discussion, it was moved, seconded and approved to support the Releaguaging Procedures

- 2. Proposal from Football Advisory Committee regarding Bylaw 3214 and 3214.1, Number of Team Entries into Playoffs – Discuss - Discussion: This item deals with guaranteed fourth place teams and giving more opportunity to at-large schools. It was moved, seconded and approved to support.

- 3. Proposal from Executive Committee regarding Start Date of Contests for All Sports – Discuss - Discussion: If approved, this item would bring us in line with the start dates of the nine other Sections in the state. It was moved, seconded and approved to support.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

- 1. Eligibility: Transfers from List of Lowest Performing Schools (Revised) – Discuss - Discussion: This proposal would allow students to transfer from a school in the California Department of Education list of underperforming schools to another public high school (including charter schools) under the guidelines listed.

- 2. CIF Regional Championship Football Bowl Proposal (Revised) – Discuss - Discussion: The State Football Advisory Committee is recommending adding additional regional football games, north and south, starting in December, 2012. Revenue sharing was also discussed.

- 3. Southern California Boys and Girls

Tennis Regionals – Discuss - Discussion: The format for the proposed Southern California Regional Tennis Championship was discussed.

- 4. NCS Wrestling Proposal – Number of Team Entries – Discuss - Discussion: The State office is proposing changes to the team and individual entrant guidelines for post season competition to allow two wrestlers from the same team to compete at the same weight class. This is modeled after the Michigan High School Athletic Association which has been successful with their coaches.

- 5. Season of Sport – New Bylaw – Discuss - This new bylaw proposal sets the start dates for practice, last contest date, number of allowable contests and scrimmages allowed for all sports.

- 6. Cross Country Divisionals – Discuss - This item was pulled.

- 7. Transfer Rule 207B - Jim Staunton stated an upcoming rule change to 207B will be forthcoming. It will allow students who transfer after the beginning of the tenth grade to have unlimited eligibility in sports the student has not participated in at the varsity level since their initial enrollment in ninth grade. Specific conditions must be met and more information will be forthcoming.

B. SOUTHERN SECTION NON-ACTION ITEMS

- 1. 2010-11 Nominees to the CIF Southern Executive Committee – Discuss - Discussion: The nominees were discussed and additional names were added. Mark Rose, Athletic Director, Paso Robles and Lou Lichtl, Principal, Thousand Oaks High School will run for the Northern Area, Greg Franklin, Superintendent of Los Alamitos Unified School District and Nancy Billinger, Assistant Superintendent, Redondo Union High School District will run for the Superintendent Representative position. Rita Dever, Principal, Mary Star of the Sea, will run for the Parochial Area.

- 2. 2011-12 CIF Southern Section Budget – Discuss - Mitch Carty presented the 2011-12 budget.

5. NEW BUSINESS

- A. Governance Committee Report - Gary Smidderks/Sue Kuwabara - Sue Kuwabara reported on the activity of the committee.

- B. Sanction of Wilson High School/Long Beach Water Polo Coaches - Kristine Palle stated two Wilson/LB assistant coaches rushed an official after a game, berated the official in front of the teams for what was perceived as bad calls. This was reported to the school however, the school was slow in replying. After further discussion, it was moved, seconded and approved to support the action of the staff in taking sanctions against the two boys water polo coaches at Wilson/LB.

- C. Boarding School Update - Jim Staunton - A meeting was held with boarding school representatives. Jim Staunton and Gary Smidderks were also present. It was suggested to combine Bylaw 207 and 209 to make it consistent. There was opposition to this at the State Commissioners' meeting. This change would allow the boarding schools to bring foreign students to their schools and give them eligibility. This is still in discussion at the State level.

- D. Bylaw 209.1 – Transfers from a Foreign

Country

- E. Marketing Update - John Costello - John Costello discussed the current Southern Section marketing plan. He feels we need to stay in front, bartering with television sponsors and working professionally to keep it on a collegiate level. We model like professional and receive enough revenue to stay solvent. President Bill Dabbs asked John to present this same information to the Council.

6. CLOSED SESSION

- A. Personnel Issue (All members are requested to bring their work calendars to this meeting.) - Closed Session began at 8:45 a.m. and concluded at 10:10 a.m. It was moved, seconded and approved to use the Commissioner's Vacancy Flyer and Application as discussed and revised and to begin advertising the vacancy on February 1, 2011.

Closed Session began again at 3:25 p.m. to discuss the Commissioner's evaluation. It concluded at 3:30 p.m. with no action taken.

Executive Committee members reported on their activities during Fall playoffs and commended staff for their hard work.

The Public/Private issue is a serious concern with many students being recruited to private schools.

Many thanks were extended to Jim Staunton for his work as Commissioner of the Southern Section.

Concerns were expressed about district budgets and the future of athletics.

Staff discussed tighter penalties for fighting and disruptive behavior at games. The CIF Student Council will be creating a video to be played on our website and they will be involved in a community service project.

Basketball finals will be held over five days at the Anaheim Convention Center where a skills session for coaches will also take place. Ticket prices have been lowered by \$3 and parking will be \$3 less as well.

- Southern Section is the first and only Section to institute divisional placement based on competitive equity, thereby ensuring that schools of similar power play each other in playoffs. The rest of the state still uses enrollment-based placement resulting in:
 - The north has sent the same school to the top division in football five times. In that same time span the South has sent four different teams. The only two teams to beat De La Salle? Both public.
 - In girls volleyball and girls basketball the north last year sent the number one teams in the nation to state playoffs in Division III!
 - In Southern Section the proportion of public school championships to private school championships is commensurate with the percentage of membership. In some cases private schools may seem to dominate, but those generally are in divisions with disproportionate private school representation.
 - In Basketball the Southern Section is the only section in the state to place individual schools based on playoff success ensuring that schools play against like opponents regardless of schools size.
- The Southern Section eliminated the “Association Rule” which had been a fixture on our books for years.
- The Southern Section is the only Section to have “pre-flips” for our sport playoffs allowing our schools to make transportation arrangements well in advance of playoff contests.
- The Southern Section implemented “satellite” locations for divisions farther away from the office on football pairings day that provides coaches and athletic directors the ability to get draws, tickets and exchange film without having to make the drive all the way to the office.
- The Southern Section was the only Section in the State to hold the line on officials’ fees in the sport of lacrosse to give schools the financial relief to institute the sport in the first place.
- The Southern Section is the only Section to have instituted an Officials Fees Relations Committee to deal with relations between our officials and the schools and successfully keep fees affordable for our schools.
- The Southern Section, five years ago, instituted Champions for Character Award, the only program in the State to recognize specifically achievement in promoting “Pursuing Victory with Honor” for our students, coaches, administrators and media.
- The Southern Section is the only Section in the State that provides one-day coaches’ training in “Pursuing Victory with Honor.”
- The Southern Section is the only Section in the State to have instituted a public-private relations committee to deal with the perceptions and misperceptions surrounding private schools.
- The Southern Section is the only section in the state to have created the Student Leadership Council – they are presently filming a public service announcement to air on the web and through our media.
- The Southern Section endorsed the first time transfer rule to ease the pressure on students surrounding eligibility and to avoid the institution of a 30-day no-play rule that was being promoted in other Sections.
- Today the Council was asked to approve sweeping changes in the Area Placement-Releaguement section of the Bluebook. The purpose of these recommendations is to properly place schools and re-draw some area placements to provide equitable distribution of some of our schools who should play in other pools of talent. (approval would change a rule in the books for decades)
- These are a few of the changes the Section has seen over the last 11 years. What has stayed status quo? Ticket prices. The Section has maintained the same pricing for our championships for years. The Oak Middle School choir concert (lasting two hours) cost more than a general admission to our football championships – and there was no student ticket price! Compare our prices to the price of going to a movie.

It is often difficult to counter opinion and conviction with facts, but we will keep trying to shed some light on the current situation in high school sports.

The biggest issue and one that reflects status quo throughout the state is transfers. Seth Van Patton had to deal with a complaint from Compton High School in the 1920s about the “tramps” who were transferring to other

4. NON-ACTION SESSION

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. *** Football Mercy Rule (Revised) – Discuss - The football advisory committee is against this proposal because it limits participation of student athletes and is an issue that should be addressed on a game by game basis (as opposed to a universal rule forcing this to be applied).

2. *** Penalty for Lack of Administrative Oversight Affecting Student Ineligibility (Revised) – Discuss - This applies to situations where a student would have been eligible had paperwork been completed and turned into the CIF office. The fine would be used as a deterrent with the amount of the fine being determined by the office staff, Council and/or Executive Committee. The money could potentially be used toward coaches' education and/or scholarship funds.

3. *** Eligibility of Boarding School Students – Discuss - This bylaw applies to international students entering boarding schools. By rule, international students not coming to a school through a state approved foreign exchange program would have JV eligibility. In many cases boarding schools don't field junior varsity sports thus excluding these students from athletic participation for the first year they're attending boarding school. Boarding schools are looking for Bylaws 206 and 207 to apply to all incoming boarding school students including international students thus giving them immediate varsity eligibility (currently those students fall under Bylaw 209.1).

4. *** Legal Flow Chart (Revised) – Discuss - Moved to action

5. CIF Regional Championship Football Bowl Proposal (Revised) – Discuss - Football advisory committee is not in favor of this proposal. This would extend the CIF-SS season to 16 football games (if championship teams were forwarded). Coaches are in support of the current system without a regional playoff.

6. *** Southern California Boys and Girls Tennis Regionals (Revised) – Discuss - The tennis advisory committee is not in favor of a regional event as the Southern Section athletes are in the first week of their team playoffs when this event would be held. Calendar-wise, we would have to back up the Southern Section season 3 weeks to accommodate sending athletes to a regional event as Southern Section championships would have to be over in order to determine advancement. After soliciting the tennis community, the committee indicated that players being invited to this event would most likely decline as they will return to club season tournaments.

7. NCS Wrestling Proposal – Number of Team Entries – Discuss - The wrestling advisory committee is not in favor of this proposal that could send two wrestlers from the same weight class to the State Championship Qualifying Series.

8. *** Season of Sport – New Bylaw (Revised) – Discuss - This bylaw has been split into 4 parts, each of which will be voted on individually. This Bylaw is one that (if passed) will get the sections closer to the uniformity that the state legislature desires. Part "A" deals with first day of practice which would be the official start date of the season (including tryouts). Part "B" deals with the last contest date which is determined by each section. Part "C" talks about the number of

allowable contests per sport, per season. In the sports of basketball and volleyball, concern was voiced over loss of contests (meanwhile we're adding in football). Part "D" talks about scrimmages, 2 allowable before the first interscholastic contest.

9. ~~Cross-Country Divisionals – Discuss – Item pulled.~~

10. *** 2011-2012 CIF State Executive Committee Nominations (New) – Discuss - A list of nominations has been presented. The section requests that our representative go "uninstructed" to Federated Council.

11. *** Bylaw 207 Transfer Eligibility Revision – Discuss - This bylaw will allow for a student who has never competed at the varsity level, to transfer to another school without any limitations on their eligibility (in other words they would have immediately varsity eligibility). Athletic motivation and undue influence rules will still apply.

B. SOUTHERN SECTION NON-ACTION ITEMS

1. 2011-12 Nominees to Southern Section Executive Committee (Information included) – Discuss - From the Desert Area, a nomination was made for Mike Genthner from Kern Valley High School. Steve Miller (Parochial Area) withdrew his name from nominations.

2. 2011-12 CIF Southern Section Budget (Information included) – Discuss - First page includes our projected sport budgets based on the trend historically (5 years worth of data used). "Interest Income" on investments has been on a steady decline because of the conservative way we invest. There has been no increase in sport fees and/or ticket prices. Expense page (Page 2) based again on trends historically (5 years). "Interest Expense" has been blacked out as we are working to eliminate this expense by paying off the CIF building. "Major Medical Expense Percentage Increase" is an estimate as there is no way to accurately predict that cost. There was a large jump last year. This year's projected increase would account for anything up to 8%. A COLA increase of 3% to staff is reflected in this budget (last year it was zero). Page three shows a line item of "Special Events" as a Centennial Celebration fund will be put together for an event to take place in 2013 celebrating CIF's 100th birthday. Contact Mitch Carty at the CIF-SS office for any further clarification.

5. NEW BUSINESS

A. Governance Task Force Report - Gary Smidderks & Jim Staunton - There are always legislators that implement educational laws which naturally have a trickle down effect on our organization (reference to the Romero Bill). The governance task force is in place to help us understand the state's increasing authority, how to communicate through them (and to them) about methods to best reconcile these items with our current bylaws such that student athletes aren't adversely affected. The task force is about facilitating the resolution of issues that are rising (not decreasing).

6. REPORT SESSION

A. President's Report - Bill Dabbs - Bill Dabbs commended the efforts and efficiency of the CIF-SS and its Council. As a former educator/administrator in another CIF Section he feels that the Southern Section is the best at what we do and in its service to the athletic community. The staff and the Council should be commended for that. He appreciates the work of the governance task force as well. It is an important group to

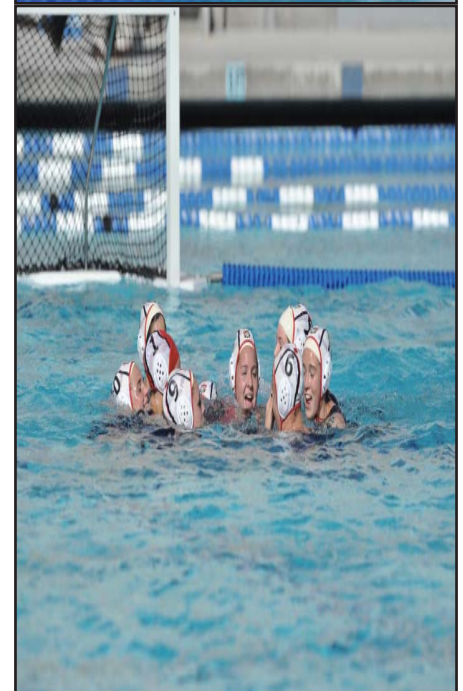

WINNERS OF THE 2010-11 CIF SOUTHERN SECTION ACADEMIC AWARDS

LOS ALAMITOS -- The winners of the annual CIF Southern Section-Ford Academic Awards program were announced at CIF-SS headquarters April 4, 2011.

The team awards, based on a cumulative grade point average, are awarded in 22 sports.

To be considered, teams must have a minimum 3.0 GPA average (4.0 scale) in college-prep courses in the first semester of the 2008-09 school year. The highest team GPA in each sport determines the winner. Schools are divided into two enrollment categories, 1500 and above and 1499 and below. The team with the highest GPA in each enrollment category for each sport receives the award. The first

place teams receive a banner to commemorate their achievement. All teams who participate receive Academic Award certificates for their student athletes.

Each CIF-SS member school is entitled to name a male and a female "Student-Athlete-of-the-Year" as well. Recipients of the individual awards must be seniors that have maintained a minimum of a 3.5 GPA (4.0 scale) in college-prep courses over the past three years, in addition to earning a letter in at least one varsity sport and participating in extracurricular activities (music, drama, service groups, etc.).

support with inevitable, upcoming change.

B. Commissioner's Report - Jim Staunton
- The Council was commended on the positive changes they have made to the organization over the past 10 years. The CIF building will be paid off immediately putting an additional \$54k into the budget each year; money which will go back to the schools in one way or another. The Southern Section has made great changes and improvements to the way we do business that hopefully will allow us to go back to a 50/25/25 split (the standard split prior to hiring another assistant commissioner in the office). We have implemented many conveniences for schools such as satellite areas for ticket pick up, pre-flip host site determinations during playoffs, education and workshops or new Athletic Directors and Principals, and a student council that member schools can send students to. In addition, ticket prices for students and adults haven't changed in 6 years despite the rising costs of doing business. The Southern Section has made serious improvements and continues to work toward technological change that will make everything we (and our schools do) easier and more efficient as we move forward.

C. Treasurer's Report - Reggie Thompkins
- The 2009-2010 audit was presented and approved. 99% of dues have been received. T-Shirt sales were \$37K, up 11% from 2009. Playoff reports are in for the fall thanks to the electronic process implemented by Mitch Carty. Cumulatively, we were up about \$6k from last year (fall sports), up 0.69% from last year.
