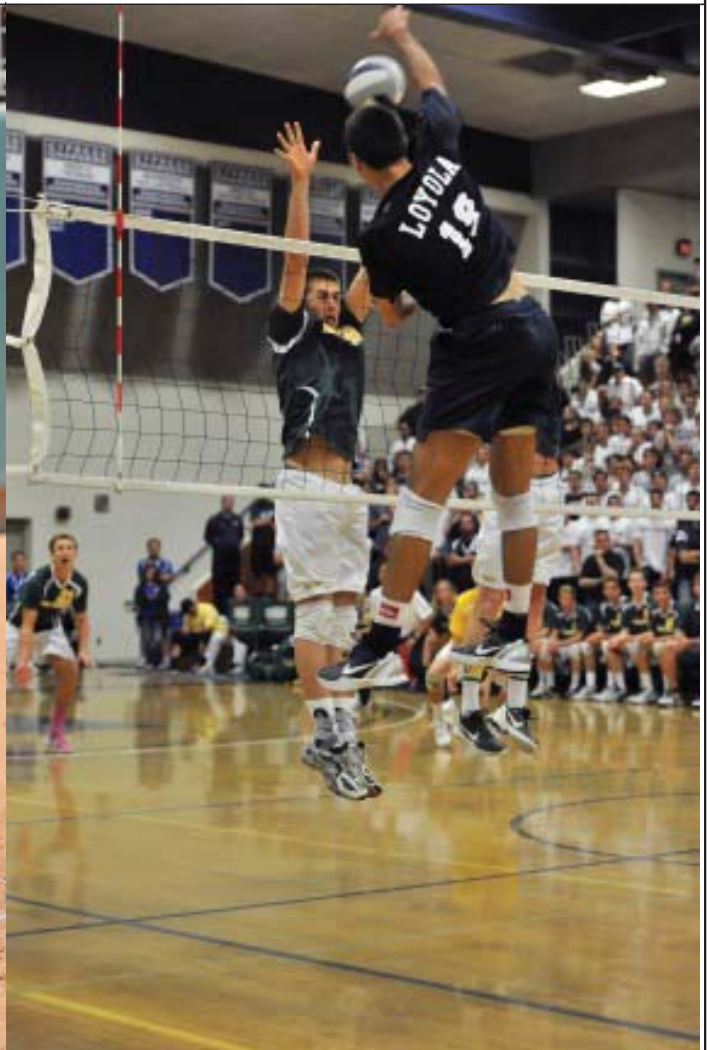
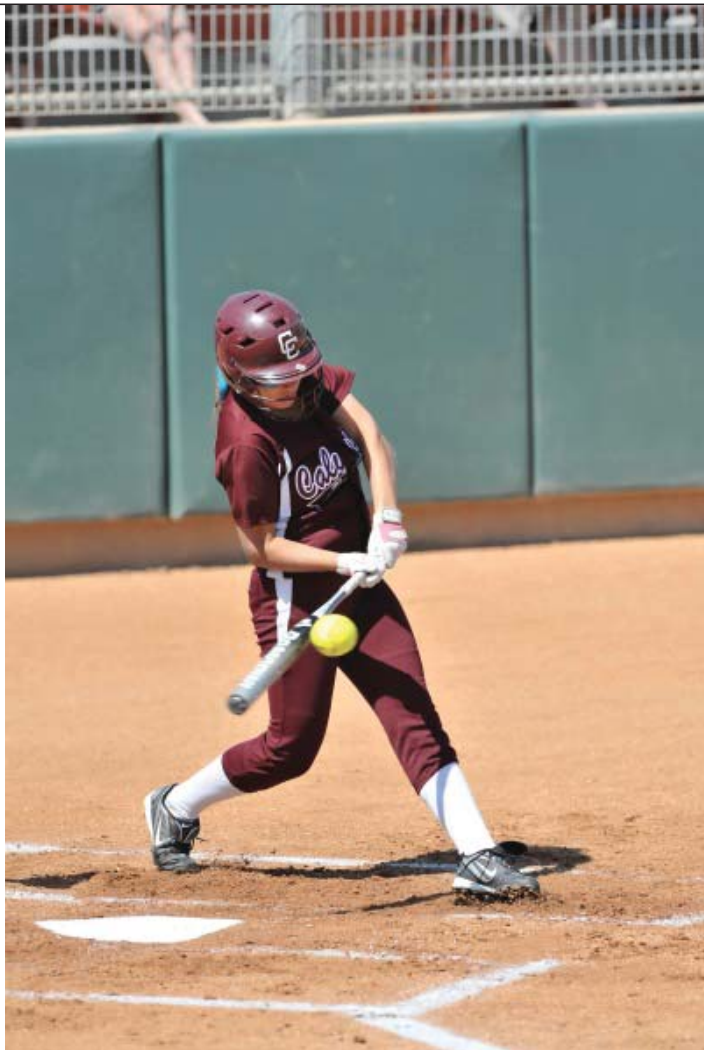

8. Open Division Basketball Proposal - Exec. Cmte. Recommends Support By a unanimous vote - There was a motion and second to support STATE441. The motion carried.

9. NorCal Boys Volleyball Championship Proposal - Exec. Cmte. Recommends Support by a Unanimous vote - There was a motion and second to support STATE442. The motion carried.

10. Revision of Bylaw 313: Concussion - Item Received After Exec. Cmte. Agenda was Finalized - There was a motion and second to support STATE449. The motion carried.

B. SOUTHERN SECTION ACTION ITEMS

1. 2012-13 Nominees to CIF Southern Section Executive Committee – ballots will be distributed at the meeting – Action - Ballots were distributed and votes taken. The first round of voting yielded a tie for the position of “Boys’ Athletic Director Representative” between Chris Calderwood (Palm Springs) and Wendell Yoshida (Peninsula). “President Elect” will be Reggie Thompkins. In the run-off race, Chris Calderwood prevailed with a vote of 35-31.

2. Approval of Proposed 2012-13 CIF Southern Section Budget - Exec. Cmte. Recommends Support by a Unanimous vote - There was a motion and a second to approve SS435. The motion carried.

3. Approval of Proposed 2012-2014 Playoff Groupings – Action - a. Appeals to be heard from the following leagues:

- i. Marmonte – Girls Water Polo and Football
- ii. Santa Fe – Boys Soccer
- iii. Victory – Baseball
- iv. Sunbelt – Football
- v. Pacific Coast – Football
- vi. Century – Football
- vii. Empire – Football

The Pacific Coast League (in football) will return to the Southwest Division. The Sunbelt League withdrew their appeal. The rest of the leagues who appealed will remain in the playoff divisions assigned by the CIF-SS office.

4. NON-ACTION SESSION

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

1. Revision of CIF State Football Championship Bowl Format – Discuss - Discussion was held regarding the Southern Section proposal to change the current format for State Football Regional Bowl Games. This proposal would adjust the current two week State Football Bowl Championship format into a one week format, in which all sections would participate.

2. Remove all References to “Athletically Motivated” and “Transferring for Athletic Reasons” from the CIF Constitution and Bylaws – Discuss - Discussion held regarding the Southern Section proposal to remove all language from the CIF Constitution and Bylaws relating to athletically motivated transfers. Motivation is difficult to prove and to adjudicate.

B. SOUTHERN SECTION NON-ACTION ITEMS

1. Proposal from Boys and Girls Water Polo Advisory Committee to create a 16-Team Playoff Bracket, Seeded 1-16 to be presented by Ethan Demato and Eric Henninger – Discuss - For water polo only, this proposal would help mitigate some of the difficult first round match ups that plague the 16-team brackets in water polo. Most sports have brackets of 32 where there are more options in terms of pairings in the initial rounds. In water polo, there will often times be a third place team (league-wise) that will appear within the top eight in the overall poll. Example: this past fall in Girls’ Division 1, Edison High School, third place in the very strong “Sunset League”. Edison was ranked 7th overall in the poll. Playoff guidelines have 1st place teams playing 3rd place teams (when possible); therefore Edison matched up with the number one team from the Channel League, Santa Barbara. They couldn’t be in the other quadrants for match up because of league-mates being there. Santa Barbara was the 6th seed overall. A first round 6-7 match up is tough. This proposal would allow league-mates to match up a round earlier, allowing the brackets to get closer to a true 1-16 seed. Some limitations will still apply.

5. NEW BUSINESS

A. Update on Student Athlete Leadership Council (SALC) - Blair Boyce (Villa Park High School) reported on the Student Athlete Leadership Council. He is an outgoing senior who, after three years of participation, encouraged the schools to send membership to this group. He enjoyed his

time working on lessons in sportsmanship, ethics in sport, and analyzing the importance of athletics as a co-curricular entity in high school. These skills can be taken back to schools and shared with teams, captain’s councils, leagues etc. to help enhance the educational aspect of interscholastic athletics. Blair will be attending Cornell University in the fall.

6. REPORT SESSION

A. President’s Report - Bill Dabbs - The President commended the staff for a well organized and executed winter playoff season.

B. Commissioner’s Report - Rob Wigod - Recognition was given to the CIF support staff in light of “Administrative Professionals Day”. Thanks were given Sister Cheryl Milner and Bill Dabbs for their service this year. The roll out of “CIF-SS Home”, our new electronic support system for schools and ADs will be coming shortly. The Commissioner encouraged all administrators and ADs to fill out the applications showcasing the worthy recipients of the “Champions for Character” awards. In this fiscal time, it’s imperative that we are honoring kids and showing the importance of high school athletics to our communities and stakeholders. Spreading the word in regards to the importance of this positive experience is crucial.

C. Treasurer’s Report - Reggie Thompkins - Membership dues are in. Sports net income for fall and winter is approximately \$1.4 million. Revenue sharing to schools totaled over \$800k.

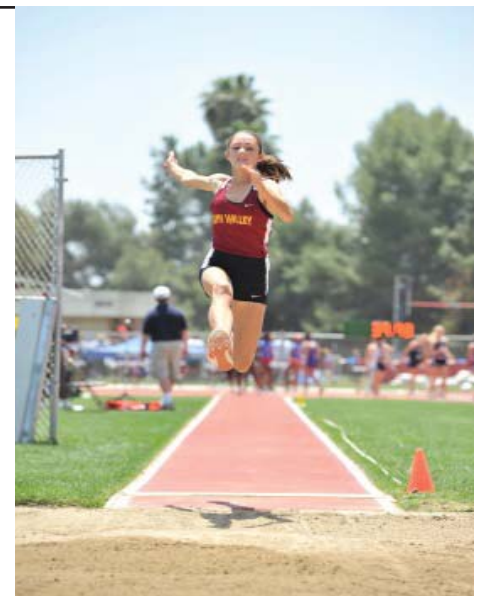

SYNOPSIS OF CHANGES TO 2012-2013 BLUE BOOK

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

APRIL 17, 2012

1. OPENING BUSINESS

A. Call to order by Bill Dabbs, President of the Council

B. Pledge of Allegiance

C. Roll Call

D. Any Introductions

E. Adopt Agenda – Action - It was moved and seconded to move Item 5A, Rule 125.2 Esperanza High School Reinstatement of Tennis Coach to be heard after Item 2, Public Hearing Session. The motion was approved.

F. Approval of Minutes

1. Minutes of the January 14, 2012 Executive Committee Meeting – Action - There was a motion and a second to approved the minutes of the January 14, 2012 Executive Committee. The motion carried.

2. PUBLIC HEARING SESSION

A. Recognition of anyone wishing to address the Executive Committee. Speakers must limit their remarks to three minutes.

3. ACTION ITEMS

A. STATE FEDERATED COUNCIL ACTION ITEMS

1. Revision of Bylaws 206: Residential Eligibility - Discuss/Recommend - There was a motion and a second to recommend support for Proposal 206-1. The motion carried by a unanimous vote.

Discussion: Proposal 206-1 is a change in language that gives students more options of school choice after a change of residence. It is less restrictive than the current language.

2. Reformatting/Revision of Bylaws 200-209 - Discuss/Recommend - There was a motion and a second to recommend support. The motion carried by a vote of 15-1 with 1 abstention.

Discussion: It was questioned if the item could be broken up and each part voted on separately. It was explained that these rules are interrelated and affect each other. Financial hardships were not listed among the allowable reasons and it was explained that due to the length of time needed to process hardship paperwork and time needed to set up an appeal hearing, the Sit Out Period would be a better solution for this process and it gives two options. The player can either have limited eligibility only for the current season or the player can "sit out" for a determined period of time and have varsity eligibility. The Commissioners of the Sections throughout the State felt that we needed to restrict some areas and unrestrict others.

3. Revision of Bylaw 303.D: Small Learning Communities, Small Schools, Alternative Schools and Charter Schools Housed on a Member School Campus – Discuss/Recommend - There was a motion and a second to recommend support. The motion carried by a unanimous vote.

Discussion: This proposal gives options for students to participate in sports at the school of attendance and not be forced to participate at their home school of attendance only.

4. Revision of Bylaw 207: Transfer Eligibility, Bylaw 208: Hardship and Bylaw 510: Undue Influence – Discuss/Recommend - There was a motion and a second to recommend support. The motion carried by a vote of 12-5.

Discussion: This proposal is attempting to deal with the issues of transfer eligibility, hardship and to clarify athletic motivation.

5. CIF State 2012-13 Projected Budget - Discuss/Recommend - There was a motion and a

second to recommend support. The motion carried by a unanimous vote.

6. CIF State 2012-13 Executive Committee Nominations - Discuss/Recommend - There was a motion and a second to recommend we support voting for Jim Perry and Reggie Thompkins for State Executive Committee and to have our representatives go uninstructed on President-Elect. The motion carried by a unanimous vote.

Discussion: Jeff Cardoza withdrew his nomination for the presidency because he has become the Assistant Commissioner of the Central Section.

7. Recommendation to Rescind Bylaw 1104 - Discuss/Recommend - There was a motion and a second to recommend support. The motion failed by a vote of 9-8 with no abstentions.

Discussion: This proposal takes away the appeal to the State Executive Director in certain issues that should be handled at the Section level. State CIF questions why they should hear certain appeals based on Section decisions. It was felt this proposal takes away the appellate process.

8. Open Division Basketball Proposal - Discuss/Recommend - There was a motion and a second to recommend support. The motion carried by a unanimous vote.

Discussion: Rainer Wulf explained how this proposal creates the opportunity for a greater level of competitive equity and the criteria that will be used to select teams.

9. NorCal Boys Volleyball Championship Proposal - Discuss/Recommend - There was a motion and a second to recommend support. The motion carried by a unanimous vote.

Discussion: Scott Raftery explained this proposal. It will mirror the SoCal Regional already in place.

B. SOUTHERN SECTION ACTION ITEMS

1. 2012-2013 Nominees to CIF Southern Section Executive Committee – Discuss - The nominees for Executive Committee were read and no action taken.

2. 2012-2013 CIF Southern Section Proposed Budget – Discuss - There was a motion and a second to recommend support. The motion carried by a unanimous vote.

4. NON-ACTION ITEMS

A. STATE FEDERATED COUNCIL NON-ACTION ITEMS

There were no State Federated non-action items.

B. SOUTHERN SECTION NON-ACTION ITEMS

There were no Southern Section non-action items.

5. NEW BUSINESS

A. Rule 125.2 Esperanza High School Reinstatement of Tennis Coach - Dr. Ken Fox, Principal and Kurt Kersten, Athletic Director, represented Esperanza High School. They came to find out if there would be any sanctions against their school if they reinstated a tennis coach who had pulled his team from a match with Sunny Hills High School. They felt that because the administration and coach were unaware of Bylaw 125.2, that requires a principal to remove the coach for the balance of the season when a coach fails to complete a contest that he should be allowed to return after sitting out 7 matches which would constitute his entire punishment. The coach felt it was an unsafe environment for his players, felt

intimidated by the opposing team's parents and for the lack of supervision at the school site. They asked for the Executive Committee if they could reinstate their coach. The Executive Committee voted 14-3 against reinstatement.

The Section office would like to examine potential rule changes related to violations. It is not a public verses private issue; it's about following and breaking the rules. Rob Wigod will contact our State Attorney to determine what can be done. A subcommittee of Nancy Billinger, Carter Paysinger and Jeff Jordan will look into changing the bylaws.

LOYOLA AND HARVARD-WESTLAKE CLAIM TITLES IN 21ST ANNUAL COMMISSIONER'S CUP

Loyola and Harvard- Westlake Claim Titles in Nineteenth Annual Commissioner's Cup

The CIF Southern Section is pleased to announce the top ten girls and boys athletic programs in the 21st Annual Commissioner's Cup

On the boy's side, Loyola of Los Angeles captured its' fourth title in a row in scoring 19 points through a championship in track and field and two runner-up finishes in volleyball and cross country. This is the Cubs record sixth Commissioner's Cup win. Their four other semi final appearances gave the Cubs a commanding win for the Cup.

Corona Del Mar finished second this year with 17 points, led by a championship in football and four runner up appearances (volleyball, track, water polo, and swimming and diving). Palm Desert finished off the top

three with championships in baseball and track.

On the girl's side, Citrus Valley ran away with the Cup, accumulating 14 points en route to its first Cup title in school history. Citrus Valley captured this feat through titles in soccer and softball, and two semi finals appearances in swimming and diving and water polo. Corona Del Mar has the most Commissioner's Cups on the girl's side with six to date. Mater Dei finished as runner-up via tiebreaker rules with St. Margaret's, and did so by recording 13 points. The Lady Monarchs were basketball champions, water polo and track and field runner-ups, and volleyball semifinalists. St. Lucy's and Newport Harbor both grabbed 11 points, but due to tiebreaker rules St. Lucy's claimed the third spot to round out the top three. They did so by winning a championship in vol-

leyball, and making three semifinal appearances.

The CIF-SS developed this recognition program based upon comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team-place finish sport (i.e. cross country, golf, swimming and diving, track and field); and one point for a fourth place finish in a team-place finish sport. In cases where a tie occurs the top ten were determined by several tie-breaker methods.
