Each team will consist of 9 players. Each school will be guaranteed to compete in 4 tennis matches.

## Format

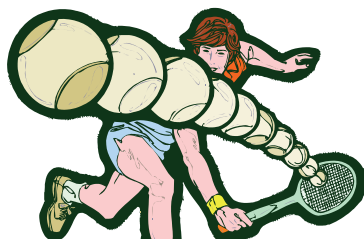
This is a dual match team tournament. Each team will have 3 singles players and 3 doubles teams. Each member of the team will play the corresponding player from the other team. #1 vs #1, #2 vs #2, and #3 vs #3. Each match will be a 8 game proset, with a set-tiebreak at 7-7. The winner will be the team winning the most matches, if still a tie then most games won. (Detailed rules to be sent with match times)
