SWIM PRELIMS, FINALS SET AT BELMONT PLAZA OLYMPIC POOL

Utilizing a new system of qualifying minmers for the CIF, SS, prelims, 1969 CIF, SS, prelims and chamber of the plaza Olympic Pool, site the 1968 CIF, SS, Water Polo Championships and 1969 CIF, SS, Symming Relays.

Under the new qualifying system, mimmers were given the opportunity meeting pre-established qualifying endards in any dual, invitational or largue meet after April 1, providing there were three watches timing his large.

Entry cards, similar to the cards formerly used to place boys into the prelims from league meets, were sent to each school, and swimming coaches are reminded that these cards must be in the CIF, SS, office no later than 4:30 pm. on Monday, April 28.

The swim prelims will be held on Saurday, May 3, 1969, at the Belmont Plaza facility beginning at 12:30 p.m. Diving prelims and semi-finals are sheduled for the Belmont Plaza pool on Saturday, May 3, beginning at 10 m.

The 1969 CIF, SS, Swimming Championships will be held at Belmont Plaza as Friday evening, May 9, beginning at 7:30 p.m.

SITES SET FOR CIF, SS, TRACK PRELIMS, FINALS

Sites for the 1969 CIF, SS, track relims, semi-finals and championship meets have been established, and track coaches are asked to note them for future reference.

Four sectional meets will be held on Saturday, May 10, at Westminster, Chaffey and Long Beach Millikan high schools and at Sentinel Field in Inglewood, hosted by Morningside High School.

From the prelims, athletes will qualify into one semi-final meet, to be held Friday evening, May 16, at Cerritos College.

From the CIF, SS, championship meet, top varsity finishers will qualify for the 1969 State CIF Track Meet, to be held at UCLA on Friday and Saturday, June 6-7.

CIF, SS, BASEBALL CHAMPIONS TO BE CROWNED IN FOUR DIVISIONS IN 1969 PLAY-OFFS

With an added play-off division because of an increased number of leagues in 1969, four CIF, SS, baseball champions will be crowned when play-off action ends on May 27 and June 3.

In the "AAAA" and "AAA" divisions, first and second-place teams from each league will be placed into the 32-team draw for action which gets underway on Friday, May 16.

"AA" and "A" leagues will send only their league champion into the 16-team play-offs, which also begin on Friday, May 16.

In the "AAAA" and "AAA" divisions, outright league champions and co-champions will automatically be placed into the draw, along with second-place teams from leagues which did not have co-champions.

After these teams have been placed, teams which tied for second place in their league would also be considered for play-off entry, providing there is space left in the draw. Under no circumstances will third-place teams be considered for entry.

In the "AA" and "A" divisions, outright league champions will automatically be placed in the draw, along with qualified free-lance entries. If space still exists, teams which tied for their league championship would then be considered for entry into the play-offs.

Play-off dates for "AAAA" and "AAA" divisions are May 16, 20, 23, 27 and June 3. "AA" and "A" play-off dates are May 16, 20, 23 and 27.

MINUTES OF CIF, SOUTHERN SECTION, EXECUTIVE COMMITTEE APRIL 19, 1969

The April meeting of the CIF, SS, Executive Committee was called to order by Chairman Steve Miletich at 9:00 a.m. on Saturday, April 19, 1969, at the Spa Hotel in Palm Springs.

The following members were in attendance: Chairman Miletich, vice principal, Beverly Hills HS; Richard Spaulding, principal, Buena Park HS; Keith Lee, principal, Yucca Valley HS; Keith Gunn, principal, Victor Valley HS; Rev. John J. Reilly, principal, Mater Dei HS; Lou Joseph, principal, Desert HS; Claud Hardesty, principal, Santa Barbara HS; James Faul, principal, Workman HS; Alex Alexander, principal, Indio HS; Art Hobson, assistant superintendent, Whittier UHSD; Rev. Thomas Kiefer, principal, Bishop Amat HS and Commissioner of Athletics, Ken Fagans.

- 1. APPROVE MINUTES It was moved, seconded and carried to approve the minutes of the Special Executive Committee meeting of February 14, 1969, as published in the March 1969, Monthly Bulletin.
- 2. APPLICATION FOR MEM-BERSHIP-It was moved, seconded and carried to recommend to the Council that the Rexford School of Beverly Hills and La Sierra HS of the Alvord District be admitted to membership and the Woodruff Jr. HS of Downey and Auburndale Jr. HS of Corona to Associate membership in the CIF, Southern Section.
- 3. TRANSFER OF MEMBER-SHIP - The Alpaugh High School, which is currently a member of the Central Section of the CIF, has re-

quested permission to join the Southern Section so that they may become a member of the Tri-County League and participate in the league's interscholastic athletic program. Because Alpaugh is located near the area of the Tri-County League schools, it was moved, seconded and caried to recommend to the Council that approval be given to Alpaugh High School's application for membership in the CIF, Southern Section.

4. BENNY FRIEDMAN SUM-MER FOOTBALL CAMP—The Committee was informed that the Benny Friedman Quarterback Camp, formerly held during Easter vacation, was to be conducted this year during the month of July, at the California Lutheran College in Thousand Oaks. Article XLII, Section 35, would prohibit any boy with remaining high school football eligibility from attending this camp without loss of high school eligibility.

Mr. Friedman indicated that personal problems in connection with his former situation at Villanova Prep School made it necessary for him to hold the camp during July. He requested the Southern Section to waive its rule for this year only, so that the high school boys from our member schools could attend this camp without loss of eligibility.

The matter was thoroughly discussed and it was the feeling of the committee that exceptions could not be made to this rule, particularly when they applied to commercial ventures. It was, therefore, moved, seconded and carried to deny Mr. Friedman's request to waive our out-of-season football practice rule in order to permit Southern Section boys with remaining eligibility to attend.

5. REDONDO VS. MIRA COSTA TRACK PROBLEM-The Vice Principals of Mira Costa and Redondo High Schools requested a waiver of Article XLVIII, Section 3, in order to permit Redondo High School to engage in one dual track meet in excess of the permitted number. The committee discussed the situation thoroughly and it was their opinion that this was a league problem and that CIF rules could not be waived under the circumstances. It was therefore, moved, seconded and unanimously carried to deny Redondo High School's request to schedule an additional dual track meet.

6. LIMITATION ON NUMBER OF CONTESTS IN SANCTIONED TOURNAMENTS - The Commissioner reported that many baseball and basketball tournaments are now being conducted on a round-robin basis, which means that in some cases participating schools are competing in

seven contests in one tournament Many tournaments are guaranteen that each participating school will to play at least three games.

It was the feeling of the group that many tournaments were now being a ranged in such a manner that school would be playing an excessive number of contests. It was suggested that rule change be proposed to the Comcil which would make it necessary charge each school in a tournament with the minimum number of cotests played by participating school

It was moved, seconded and car ried to direct the Commissioner place this matter on the agenda of the May 3rd Council meeting, and to draft a proposed rule to cover the situation.

7. REPORT OF SPORTS REGIL LATIONS COMMITTEE - Chair man Steve Miletich reported that his committee was proposing changes in out-of-season practice rules governing individual sports. He indicated that some modification should probably be made in the team sports, but the press ing issue at this time was to secure at tion on out-of-season practice in individual sports.

The recommendations of the committee were then discussed in detail with the group. The Executive Committee registered approval with all of the recommendations, but felt that in the sport of swimming and water pole we should combine the two under the heading of Aquatics Program. Because in most cases the same boys participate in both water polo and swimming, under the same coaches, it was felt that the combined seasons should extend from the day after Labor Day until the date of the CIF Championship Swim Meet in April.

It was moved, seconded and carried to direct the Commissioner to amend the sports regulations committee's to port to the Council to provide for as aquatics season instead of a separate water polo and swimming season.

7. ADMISSION CHARGES FOR CIF BASKETBALL AND FOOT BALL PLAY-OFFS-Current admis sion prices for basketball and football play-offs were reviewed. In general, was felt that admission prices were satisfactory, but in some cases the were less than that being charged our leagues. After a thorough discussion of the situation, it was moved seconded and carried that the following changes be effected for 1969 foot ball and the 1970 basketball play offs

10. COACHES EJECTED FROM ATHLETIC CONTESTS — At the present time the CIF, SS, has a rule which provides that a team must forthe a baseball game any time the much is ejected from a game for unportsmanlike conduct. Our Area ommissioners and various officials' mociations have recommended that tule be adopted by the CIF, SS, all sports. They feel that it has waked very well in baseball, and that would do a great deal to improve aches conduct in other sports if the

ang was adopted by the CIF, SS. There was a great deal of discussion accerning this matter, and there were any different views presented. Alsough the committee, by a vote of 6 took action to recommend its doption by the Council, it was the teing of all concerned that the issue important enough to be referred to the leagues for study. It was, enefore, moved, seconded and carto direct the Commissioner to the item on the agenda of the ay 3rd meeting of the Council for action by the Council.
PROPOSED WORKSHOP

CONTROL OF ATHLETIC ONTESTS-At the February 14th etting of the Executive Committee,

Dr. Richard Perry of USC appeared before the committee to seek assistance in developing a two day intensive workshop dealing with the specific problems involved in the administration of interscholastic athletic contests. He presented his proposal in writing and asked the CIF, SS, for some financial assistance.

The matter was discussed thoroughly by the committee, and in light of problems that have been occurring in connection with many of our interscholastic athletics contests, it was the unanimous opinion of the committee that we should offer to assist Dr. Perry in this worthy project.

It was moved, seconded and carried that we recommend to the Council that the CIF, Southern Section, render financial assistance not to exceed \$2,000.00, and that a committee be appointed to work with Dr. Perry and his group in setting up the program for the workshop.

12. MORNINGSIDE VS. LONG BEACH POLY BASKETBALL PLAY-OFF PROBLEM-During the recent basketball play-offs many problems developed at the conclusion of the Morningside-Long Beach Poly play-off game, held at Inglewood High School on March 4, 1969. The Commissioner thoroughly investigated the problem and secured written reports from the game officials and administrators from both schools. All correspondence pertaining to the situation was read to the committee.

After discussing the incident, it was moved, seconded and carried that copies of all communications relative to the Morningside vs. Long Beach Poly situation be mailed to the superintendents of both the Inglewood and Long Beach School Districts, so that they would be aware of the problem.

13. BASEBALL UMPIRES' FEES —Our present officials' fee schedule provides that in a two man baseball game, the plate umpire is to receive \$16.00, with the base umpire getting \$14.00. When only one man umpires a game he receives \$16.00. It was the recommendation of the Commissioner that when one man umpires a baseball game he should receive a higher fee than that paid to men working a two man game.

After some discussion it was moved, seconded and carried that Article XXXIII, Section 8, Paragraph C, be amended to provide that the umpire of a one man game be paid \$18.00 for "A" games, and \$16.00 for "B" games.

14. COMMISSIONER'S RE-PORT—The Commissioner reported that communications had been received from certain coaching associations rec-

ommending changes in the sports of wrestling and cross country. The wrestling coaches were interested in changing the present wrestling season so that practice would begin on January 5th instead of on November 15th. They also recommended that varsity matches consist of 3 two minute periods, freshman matches to consist of 3 one minute periods, and junior varsity matches to consist of 3 two minute periods, except where leagues take action to limit junior varsity matches to 3 one minute periods.

The cross country coaches submitted a recommendation calling for the holding of the CIF Prelims and Championship meets on Saturdays instead of on week days.

All of the above recommendations were thoroughly discussed and received the approval of the Executive Committee. No official action was taken, however, as it was felt that the recommendations, although coming from certain coaches groups, did not reflect the opinions of all of the coaches in the Southern Section. The Commissioner was therefore, directed to prepare a questionnaire listing in detail the specific proposals. This questionnaire to be distributed to the Athletic Directors in schools fielding cross country and wrestling teams, in an effort to find out how our coaches feel about these proposals. If the majority of coaches are in favor of the proposals, our By-laws would then be amended accordingly.

- 15. COACHES' HANDBOOK The Commissioner reported that many states have developed small handbooks in which are listed all of the pertinent regulations pertaining to particular sports. Many of the coaches at the present time, are unable to secure copies of the current Blue Book for study, and as a result there are many violations of existing regulations governing the conduct of particular sports. It was the recommendation of the Commissioner that a sports regulations handbook be developed for distribution to all coaches of all sports in the CIF,
- 16. SCHOLASTIC ELIGIBILI-TY-A committee member requested a clarification of Article X. Section 3. as it pertains to scholastic eligibility. A discussion of this rule brought out the fact that the present wording of this rule is difficult to interpret because many courses now give two or three semester units of credit instead of five units. Mr. Hardesty was asked to study this problem and submit a proposal to amend this section so that it would be easily understood and apply to the present situation.

17. ELIGIBILITY CASES — In accordance with Article XI and its applicable sections in the current Blue Book, the residence rule was waived to grant immediate eligibility to Joe Barry of Workman High School, Larry Allen of Fontana HS, Sam Wiley Jr. of Garey HS and Steve Gasca of Yucca Valley HS. A waiver of the residence rule was denied in the case of Warren Schlott of Walnut HS.

After reviewing the facts in each case it was moved, seconded and carried to deny a waiver of the age rule in the case of Terry Lamb of Bolsa Grande HS and Don Carnine of Upland HS.

After studying the transcript involving the attendance of Ed Parker of Temple City, it was the ruling of the committee that the boy will have completed his eight semesters of opportunity for athletics as of the close of the current semester.

18. SAN BERNARDINO PROB-LEM-A problem has developed in the San Bernardino City Unified High School District which will delay the opening of the new Cajon High School, for at least one year. Because of this the District is asking for an extension for one year, their authority to make certain exceptions to our residence rule for junior high school graduates in order to achieve ethnic balance. It was moved, seconded and carried that the permission granted to the San Bernardino Unified School District to deviate from the residence rule in certain instances be extended through the 1969-70 school year.

19. CROSS COUNTRY—A representative of the Bay League requested that all leagues with eight or more member schools be permitted three entries into the CIF, SS, cross country prelims, with those leagues having six or fewer teams being limited to two entries. It was moved, seconded and carried that this request be denied.

The Orange County Coaches recommended that the 1969 CIF, SS, Cross Country prelims and finals be conducted on Saturdays. It was moved, seconded and carried that the 1969 CIF, SS, preliminary meets be held on Saturday, November 22, with the championship meet being conducted on Saturday, November 29.

There being no further business to come before the committee the meeting was adjournd at 4:45 p.m.
