VERBUM DEI, MORNINGSIDE, EL DORADO, AND ATASCADERO WIN 1974 DIVISIONAL BASKETBALL CHAMPIONSHIPS

(Editor's note: In an effort to make this publication more relevant, a policy change has been effected that will eliminate detailed reports of play-off contests that are dated and have already been covered by the news media. Mention will be made for recognition and record-keeping only.)

Verbum Dei HS of Los Angeles became the first basketball team in CIF-SS history to win four consecutive 4A titles as they defeated a stubborn Millikan (Long Beach) ball club 70-60 in the concluding game of four divisional championship contests staged March 16 at the Los Angeles Sports Arena. Combined with their 3A and 2A crowns in 1970 and 1969, the Eagles now have an unbroken string of six basketball championships over the last six years. Led by first string All-CIF players David Greenwood (6'9" junior center) and Roy Hamilton (6'1" junior guard) who scored 50 points between them, the Verbum Dei squad under first-year Head Coach John Sneed, ended its season with an outstanding 30-2 record.

Coach Bill Odell's Millikan team moved through the preliminary rounds of the playoffs by beating the champions of three leagues, Fountain Valley (Irvine), Dominguez (Whitmont), and Palos Verdes (Bay) and the co-champion of a fourth — Marina HS of the Sunset League, an impressive performance for a team that finished second in its own Moore League. Second string All-CIF Jeff McHugh (6'7" senior center) helped the Rams on both offense and defense to take the battle to Verbum Dei until the last quarter.

After participating in 15 basketball playoffs since the school opened in 1952, Morningside HS of Inglewood reached the top of the ladder this year

with a hard-fought 55-49 championship victory over Katella HS of Anaheim. Coach Ron Jacobs and his Monarchs were in a tight struggle all the way against the Knights, coached by Tom Danley, who lost their second 3A championship game in two years

SOUTH TORRANCE TAKES 1974 SOCCER TITLE

Unbeaten South Torrance HS concluded its 1973-74 season by outkicking Claremont HS 4-2 in the CIF-SS Soccer Championship game conducted at West Torrance High School Stadium Friday night, March 8. In the preliminary contest, West Torrance HS blanked Santa Ana 6-0 to earn the 3rd place trophy.

With only an earlier tie with the same Claremont team to mar an otherwise perfect 29-game season, Coach Roger Bryant's Spartans became the winningest team in CIF-SS history. In defeat, the Wolfpack, coached by Otto Rieger, suffered only its third loss of the season and its second in two consecutive years of championship game competition, having lost the 1973 championship 1-0 to West Torrance HS.

Claremont, the undefeated San Antonio League Champion and highest scoring team in Southern Section history with 95 goals in league and play-off contests and 122 for the entire season, were led by Gesner Docarmo who scored once to bring his personal record-breaking season total to 46 goals in 18 league and playoff games.

Balanced scoring, a trademark for South Torrance all season, was again (Continued on Page Six)

Commissioner's Corner

OUR FINANCIAL PICTURE

We are pleased to reproduce a report by Dr. Hanford Rants, Principal of Gahr High School and Southern Section Treasurer, detailing our current financial status.

"Your CIF-SS Treasurer is grateful for the use of this space to explain the financial strains which have come upon our organization during the past three years. In my two years in this position, the Council has been brought up-to-date at our January meetings in preparation for decisions on means of obtaining additional revenue should expenses increase beyond original estimates. The Council members (your elected league representatives) have given us excellent guidance and support as problems have been presented. All of us must remember that we represent school districts as well as schools and that we should be acting as district spokesmen, keeping superintendents fully informed at all times.

It is my hope to explain as briefly as possible our major sources of income, our major expenses, and recent financial trends. Prior to a few years ago, the income always exceeded budget expectations, and a healthy cash reserve was maintained as provided for in Article XXVI, Section 8, of our CIF-SS Constitution By-Laws. From a cash gain of \$32,000 in 1969-70 we went to a

24,000 loss in 1971-72
18,000 loss in 1972-73

Although we adjusted the CIF-SS share of football playoffs upward and raised the dues to eight cents per student, we estimate that we will have an approximate \$12,000 to \$15,000 loss this year. All these losses have resulted from a sharp decline in attendance at playoff games since 1969-70.

After the loss of \$24,000 in 1971-72, we actually cut the budget \$500 from \$199,500 to \$199,000 in an attempt to hold and recoup. Our income from playoffs that school year did not meet the average of the past years, thus a 1972-73 loss of \$18,000 resulted. The effect of these losses on our reserve is shown with these figures:

Obviously, our reserve needs to be increased: a heavy loss in revenue from football playoffs (rain, energy crisis, etc.) could deplete the entire reserve. Generally speaking, we know that 90% of our income will be real-

MINUTES OF CIF-SS EXECUTIVE COMMITTEE MEETING

March 28, 1974

The March Executive Committee meeting of the Southern Section of the California Interscholastic Federation was called to order by Chairman Steve Miletich at 1:30 p.m. on Thursday, March 28, 1974, at the CIF-SS Office.

All members except Ted Gossard were present, and guests included Bill Russell, Executive Secretary of the California Interscholastic Federation.

1. **APPROVAL OF MINUTES:** Minutes of the Executive Committee meeting of January 17, 1974, as published in the February, 1974, issue of

ized from football playoffs (\$120,000), basketball playoffs (\$40,000), and membership dues (\$48,000). We also know that 80% of our expenses will be in the five areas of salaries (\$113,000), assignment of officials (\$50,000), awards (\$17,000), publications (\$9,000), and travel expenses for Executive Committee, Council, and all special committee meetings (\$12,000). The salaries include four secretaries, a commissioner, two full-time assistant commissioners, a half-time commissioner of girls' athletics, a full time officials' assignment secretary, and six part-time assignment secretaries.

Actual travel expenses are paid to Executive Committee members (10-14 meetings annually), Council members (3 meetings annually), and all committee meetings any members are asked to attend (e.g., relegating, girls' athletics, crowd control clinics, special problem meetings, etc.).

Budgets are prepared in June each year by our Administrative Committee, presented to the total Executive Committee for approval at their next meeting and finally to the full Council for approval. During the year, the Commissioner and the Treasurer each keep copies of checks written, and an audit is made each July.

The Southern Section of the CIF provides more services to its member schools and provides more opportunities for young athletes to gain recognition, thereby enhancing their future, than any association we know. This is done at less direct cost to schools (8¢ per student) than any association of which we are aware. (By way of illustration, one section of the CIF has membership dues amounting to over 70¢ per student.) In addition, the CIF is the only interscholastic athletic association in the nation that provides the assignment of officials as a service to its members. This item alone constitutes approximately one-fourth of our total annual budget.

As your elected representatives, we have tried in every way possible to

spend solely on the basis of services asked for by the schools in the Southern Section. Our Executive Committee feels that we must explore additional revenue possibilities for the 1974-75 school year. We also feel that a larger share of the net profit from playoff games (from 1/3 to 1/2) raises the most money with the least burden upon member schools.

In 1973-74, we changed the net profit percentage to 50% for the CIF-SS Office after the first round of the football playoffs. It might be that a 50% share to the CIF-SS Office for all playoff contests with a 25% share to each of the competing schools would stabilize and cover the budget indefinitely, but we just cannot predict the additional costs resulting from a full program of girls' athletics.

With this report we solicit your suggestions. As always, we wish to avoid additional costs to schools and districts whenever and wherever possible. It is necessary that we make a proposal at the May Council meeting and have some action taken for 1974-75. It is hoped that this explanation will eliminate or substantially reduce any misunderstandings or doubts that you may have had regarding our financial problems."

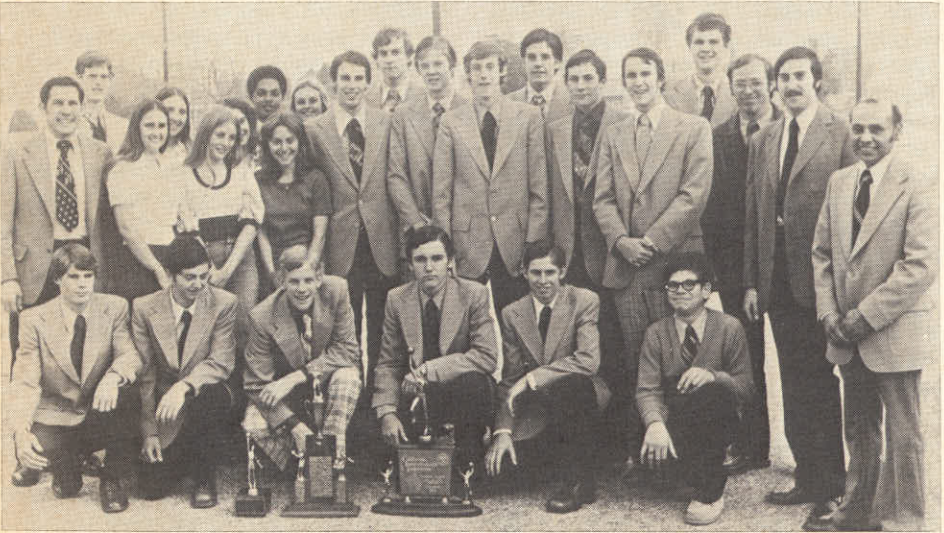

by six points. (Last year Murphy defeated Katella 51-45). Morningside's 6'7" Senior Center Mike Santos, 3A "Co-Player of the Year," and 6'4" junior forward Irving King supplied the firepower against Katella and their 6'6" senior center Jeff Welshans, first string All-CIF selection. The Monarchs finished their season with an impressive 29-3 record while the Knights concluded with a fine 26-6 mark.

In perhaps the most exciting of all the evenly played ball games of the day, El Dorado HS of Placentia outlasted Agoura HS 80-76 in overtime during the 2A afternoon championship contest. Tied at 71-all at the end of regulation play, the Golden Hawks hit

on 5 of 6 free throws in the 3 minute overtime period to insure a four point margin at the finish. Bill Roemer of Agoura finished the contest with 32 points, high for all championship games. The 6'4" senior center for the Chargers, named CIF-SS 2A "Player of the Year," was also voted the outstanding player of the 1A and 2A games at the Sports Arena.

Performing well in the cliff-hanger for Coach Nash Rivera's El Dorado team, his second in three years to reach the 2A finals, were second string All-CIF selection Kevin Heenan (6'2" junior guard) who scored 26 points, Jim DeWeese (6'4" senior forward) first string All-CIF, and second string All-CIF Tyrone Branyon (6'5" junior center). Scoring in double figures for Agoura, coached by Bob Sutton who guided the Chargers to an outstanding 26-3 season mark, were CIF-SS second stringers Dave Blessing (6'5" senior forward) and Art David (5'9" junior guard).

The CIF-SS completed its 1974 basketball season without an undefeated team as Elsinore HS, winner of 27 straight this season, was upset in the 1A final 56-48 by Atascadero HS. Coach Art Wilmore's Greyhounds, whose starting line-up averaged only 5'9", employed a tight man to man defense and speed to offset a marked height disadvantage. Dave Bobsin, 5'11" senior forward and 1A "Player of the Year," and Kurt Keller, 6'3" senior center, led the winners in scoring. Coach Ken Easter's Tigers, who proved to be tough but human, were sparked by their big 6'5" sophomore center John Greer, a first string All-CIF player along with teammate Andre Royal, 6'1" junior guard. The game, first of the day, featured a close score until the last two minutes when Atascadero expanded their winning margin to 8 points.

INTERIM POLICIES ADOPTED BY THE EXECUTIVE COMMITTEE MARCH 28, 1974

(To be in effect until July 1, 1974)

1. Member schools shall be directed to certify the eligibility of participants who are entered in CIF-SS girls' championship events.
2. A girl who has participated on a boys' (student) team in a specific sport shall not be eligible for girls' championship competition in that same sport during the same school year.
3. Girls on girls' sports teams may compete "unattached" in outside individual competition during the season of the sport in badminton, gymnastics, swimming, and track & field. (Current State CIF rule)
4. To be eligible for CIF-SS championships in swimming and track & field, a girl must qualify through girls' events in high school sponsored competition.
5. The number of berths allotted to each girls' athletic league for championship playoffs in team events shall be determined by the number of schools currently competing in league competition in the sport. Priority shall be given to larger leagues. Strong free-lance teams will be given consideration for open berths.
6. Current girls' athletic leagues shall select representative teams for participation in team championship events.
7. An entry fee of \$20 shall be required of schools qualifying for team championship playoffs in basketball and softball.
8. DGWS game rules shall be official for all sports, except where specified in joint championship events (e.g., track & field.)
9. The CIF-SS Office shall assign qualified officials for all championship events in cooperation with local officials' associations. Appropriate officials fees shall be designated for playoff competition.

CIF-SS RULES FOR GIRLS' ATHLETICS — 1974-75

1. Individuals on girls' sports teams shall not be classified by the exponent system. Varsity and Junior Varsity teams shall be determined by the athletic ability of the participants, regardless of grade level.

2. Girls may compete "unattached" in outside competition in the sports of badminton, gymnastics, and tennis.

3. The following sports are approved for girls' interscholastic sports teams: Badminton, basketball, field hockey, gymnastics, softball, swimming, tennis, track & field, and volleyball.

4. Rule books published by the Division for Girls and Women's Sports (DGWS), AAHPER, shall be official for all approved sports.

5. For special mixed events in tennis and volleyball, the following rule guides shall be used:

Tennis—United States Lawn Tennis Association (USLTA)

Volleyball—United States Volleyball Association (USVBA)

6. Article (News), By-Laws: Girls' Advisory Committee

Section 1—The Girls' Advisory Committee shall consist of eight members, four women and four men, appointed annually by the Chairman of the Executive Committee.

Section 2—The duties of the Girls' Advisory Committee shall include making recommendations to the Executive Committee concerning the governing of girls' athletics. This Committee shall also serve as a liaison with girls' athletic leagues.

7. Article VII, Eligibility Rules

2 . . . Girls Varsity and Junior Varsity teams shall be . . .

2.1 Only those member schools who indicated membership for girls'

2.2 Member schools must designate their two best teams as "Varsity" and "Junior Varsity."

2.3 Girls in grades 9, 10, 11, and 12 may be members of either Varsity or Junior Varsity teams.

8. Article XXII, Officials

Section 1—Add: for boys or student teams.

Section 2—Leagues will be responsible for assigning officials for girls' athletic contests, except CIF-SS conducted invitationals and playoff contests.

Section 3—It is highly recommended that DGWS rated or trained officials be used for all contests. It is also recommended that for practice or non-league contests, "Apprentice" officials be requested and that "State" officials be requested for league and tournament games.

SANTIAGO HS UPSET IN FINALS

All the Mira Costa HS (Manhattan Beach) Girls' Basketball Team had to go to win the first-ever CIF-SS Championship in that sport was to defeat the top two seeded teams on successive nights . . . and they did. By beating top-seeded Palos Verdes 48-46 in their semi-final game and second-seeded Santiago HS (Garden Grove) 39-32 in the finals, the Mustangs, coached by Sylvia Holly, took home the first CIF-SS Girls' Basketball Championship Trophy in history. It was a true team effort with balanced scoring and a tight zone defense, holding the usually high scoring Sea King and Cavalier squads to lower than usual point productions, that gained the upset wins for the Mustangs. Captain Jane Hickney of the Mira Costa squad enjoys the unusual distinction of serving as the captain of two CIF-SS championship teams in the same school year. Last November she captained the winning volleyball team. Mira Costa now has captured two of the three team championships conducted in the CIF-SS thus far in the present school year. Upland defeated Palos Verdes 41-37 for third place.

TRACK STARTING OPEN FOR WOMEN

The Southern California Track Starters Association, in its meeting of January, 1974, voted to extend membership to women beginning with the school year 1974-75. The association starts all Los Angeles and Southern Section CIF track meets. A training program, available to both men and women, will help to insure consistency in officiating boys' and girls' meets and will cover techniques, procedures, and rules.

School authorities are advised that the following revisions should be made on page 49 of the "Blue Book" regarding the fees to be paid to track starters in league prelims and finals:

3. League Prelims and Finals (starter and recall starter to work both prelims and finals)
 - A. Starter \$55 (over 1000 ADA) \$50 (1000 and under ADA)
 - B. Recall starter \$45 (over 1000 ADA) \$40 (1000 and under ADA)
5. League Finals only
 - A. Starter \$25 (over 1000 ADA) \$20 (1000 and under ADA)
 - B. Recall starter \$20 (over 1000 ADA) \$15 (1000 and under ADA)

INVITATIONAL TOURNAMENTS AND OTHER SANCTIONED EVENTS

Now that the energy crisis has become a reality, it is more important than ever that member schools consider carefully their responsibilities regarding the scheduling of tournaments and other sanctioned events.

For example, some school districts are currently limiting the distance school vehicles may travel. This could prevent certain schools from honoring athletic contracts. However, it should be understood that this problem does not relieve the individual school's responsibility in securing an honorable release from such an activity as provided for in Article XXV of the CIF-SS "Blue Book." This release should be secured at the earliest possible date, certainly well before the close of school in June. By the same token, schools hosting such sanctioned events should be prepared to assume a flexible posture in agreeing to such releases. Further, it is hoped that each member school keeps in mind that the energy crisis affects everyone and that planning should take into account the needs of other member schools.
