## CIF-SS LOOKS TO COUNTY COUNSEL SERVICES

**SPECIAL**—Thanks to the efforts of three Southern Section administrators, the State CIF and its member sections appear to have cleared the necessary hurdles in securing legal services for the protection of its organization.

At the most recent Association of California School Administrators (ACSA) Convention in San Diego, the State Legislative Committee gave its highest form of support by voting to sponsor an amendment which would change the State Education Code, permitting the CIF to utilize the County Counsel Services. It also stipulated that in the event of a conflict of interests, to provide the services of the State Department of Education.

Responsible for the work behind the scenes in the formation of the amendment by ACSA were Dr. Richard Cordano, principal of Arcadia H.S.; Robert Jacob, principal of Simi Valley H.S.; and Arleigh McConnell, principal of Buena H.S.

The State CIF and its member sections have long been interested in securing legal services and the Legislative Committee was formed with the threesome in the Southern Section. Its task was to explore various means of either amending the existing Education Code or developing legislation for providing free legal services to the State CIF and its member sections.

Reasons for the formation of the committee could best be substantiated in that the ever-present threat of litigation is of concern to the entire CIF.

Educators are acquainted with the high cost of providing adequate defense in case of law suits, the time lost, and expenditure of effort. Since the CIF is a corporation composed of secondary schools, any litigation involving a judgement of punitive damages would only prove to be a burden on its members.

## BOYS' RELEAGUING COMPILING INPUT

Meetings of the 1976-77 CIF Southern Section Boys' Releaguings Committee are now well in progress, under the direction of Chairman Walt Newland, principal of Hill J.H.S. in Long Beach.

Members of the Committee are currently preparing preliminary reports for league structures in the seven representative areas — Northern, Desert, Orange County, Citrus Belt, Bay, Private Schools, and Southeast.

These preliminary reports are based in part upon the releaguings questionnaire sent to all principals in the

CIF-SS and upon specific requests of member schools and leagues via correspondence.

Plans call for final preliminary reports to be mailed to all member schools prior to the close of the current school term for review. Additional input would then be received by the Committee, with the final report filed and submitted to the CIF-SS Council for vote at the 1975 September regular meeting.

This special joint Committee of men and women, authorized by the Executive Committee, was formed to study seasons of sports and its problems of overlapping between boys and girls. Another item being looked at by the Committee is the maximum number of contests for both boys and girls.

"We will be seeking input from all CIF Southern Section member schools on these topics as with the advent of growth in both boys and girls sports, we have encountered problems that didn't exist a few years back," commented Faul.

Members of the Seasons of Sports Committee are Barbara Wilson (Beverly Hills H.S.), Allene Hoeven (Muir H.S.), Tom Danley (Katella H.S.), Blinn Tenney (Central H.S.), Jack Rankin (San Marino H.S.), Karen Hellyer (University H.S.), and Dr. Richard Cordano (Arcadia H.S.).

"Following our initial meeting, which will be on an organizational one, we will forward a questionnaire to all member schools, but would be willing to accept any information or contributions before that time" added Faul.

### THE GOAL OR THE SYSTEM?

There are two basic directions from which changes in an organization may be attempted—from within the system and from without. Attempts to effect changes from outside a system may be successful, but in so doing they are undermining the basic structure of that system.

Principles upon which an organization was instituted, and rules by which it functions, are sacrificed in order to achieve goals that could have been and should have been sought within the system.

For those of us who believe "in the system" it is far better to wait (however long) for our goals to be achieved than to go outside that system and thereby contribute to its corrosion and perhaps eventual collapse.

We are members of the education profession. We therefore have a professional responsibility to act within our own system. Channels of communication are provided for grievance as well as information. Should a rule or decision generate negative reaction from a member school, representatives of that school have both opportunity and means by which they may pursue change.

"Going through channels" is an oft-used phrase, but its importance should never be discounted because of repetition. The coach who bypasses his athletic director and principal, the principal who bypasses his league representative, the superintendent who ignores an entire state-wide structure, are all guilty of failing to go through channels. Those who "leap frog" over designated referral bodies or who otherwise fail to exhaust all procedures in appeal efforts are similarly guilty.

## SOLID YEAR SUPPORTS ADDITIONS

### TREASURER FILES FINANCIAL REPORT FOR CIF-SS

It is customary at this time of year to file a capsule financial report of the CIF Southern Section and following is the summary compiled by Dr. Hanford Rants, Principal of Gahr High School and Treasurer of the CIF-SS:

This brief financial report cannot be as complete as we had hoped because some of the expenses we face are not exact as yet. We have had a great year financially and will be able to handle several additional but necessary adjustments that we have known were coming:

**\$ 17,000** Additional office space to house an administrator and secretary now working in the hall.

**\$ 12,000** Assignment of officials for Girls' Athletics.

**\$160,000** Retirement benefits for employees.

**\$ 5,000** Fringe benefits for employees.

**\$ 5,000** Additional — bookkeeper/secretary to the staff.

The additional space need is self explanatory and the cost is reasonable because there is an easy tie-in on the west side of the existing building. This construction should be well under way as you read this report.

Our experience with officials assignment for girls' athletics has indicated a definite need for better coordination. This has been a costly item through the years for boys, but it is vitally necessary to a smooth operation and organization.

The employees of the CIF-SS have never enjoyed retirement benefits (one exception, Ken Fagans), other than social security. We have been extremely fortunate to find good people, but they have had to sacrifice the teacher retirement program or the state employee's program if secretaries. In order to get into the state program we must bring everyone up-to-date, thus the very high initial cost. The program will cost approximately \$13,000 annually. We will pay the initial cost in regular installments because the state will charge only five per cent interest while we can draw seven per cent with our cash reserve we must maintain.

The Ken Fagans retirement cost has not been determined, but the adjustment to include him in the state program will save approximately \$20,000 of what had been set aside for that purpose.

It will be my recommendation that we pay each employee \$500 annually for fringe benefits. This would allow them to enroll in Blue Cross or whatever they wish in much the same way that schools and industry provide. This recommendation will be built into the

1975-76 budget if approved by the Executive Board and Council.

The total work load of the staff has increased with the growth of girls' athletics and with the services offered to schools. Our bookkeeping will be much more complex as we enter the retirement program and as we attempt to use our money to the best advantage. As the girls' program has grown, additional committees have been needed and our check-writing function has taken much more time.

Our income after basketball appears to be about \$50,000 over budget while our expenditures are within the estimates we made. This is really good news because we have come from a \$30,000 loss three years ago to a pretty solid position without too much of a burden on individual schools. We have been able to adjust to the growth problem very well.

Our organization is especially solid because of the outstanding volunteer help in support of a highly competent office staff. Your elected Council Members and Executive Board Members have really made an effort to represent schools and districts of CIF-SS.

It has surely been a highlight of my career to serve as your treasurer and to feel your support during this time of great change in our Section. Thank you most sincerely for your confidence in me for your participation in this association dedicated to molding better citizens through competitive athletics.

## MISSION VIEJO WINS 4A CIF-SS HONORS WITHOUT BLUE RIBBON

There's nothing like winning a CIF Southern Section championship and for the likes of Mission Viejo H.S., the feat was even more gratifying.

Not only did the Diablos claim the 4A swimming and diving title at the East Los Angeles City College facility, but gained top honors without the benefit of an individual champion in any of the 11 events.

Needless to say, it was depth that made the difference for the Diablos—running up 148 points and in the process, halting the reign of four-time defending champion and runnerup Foothill H.S.

No less than six CIF-SS records went by the boards: Sam Franklin (Tustin) in the 50 freestyle, Newbury Park's 200-medley relay team, Franklin in the 100 butterfly, Tim Shaw (L.B. Wilson) in the 200 freestyle, Bruce Furniss (Foothill) in the 200-individual medley, and Shaw in the 500 freestyle.

In the Frosh-Soph Division, top honors went to Mira Costa, which ran up 44 points to runnerup Thousand Oaks with 16.

Two standards were set in the Frosh-Soph segment, new CIF-SS efforts coming from Mike Maloney (Pasadena) in the 200 freestyle and Jeff Stevens (Newport Harbor) in the 100 freestyle.

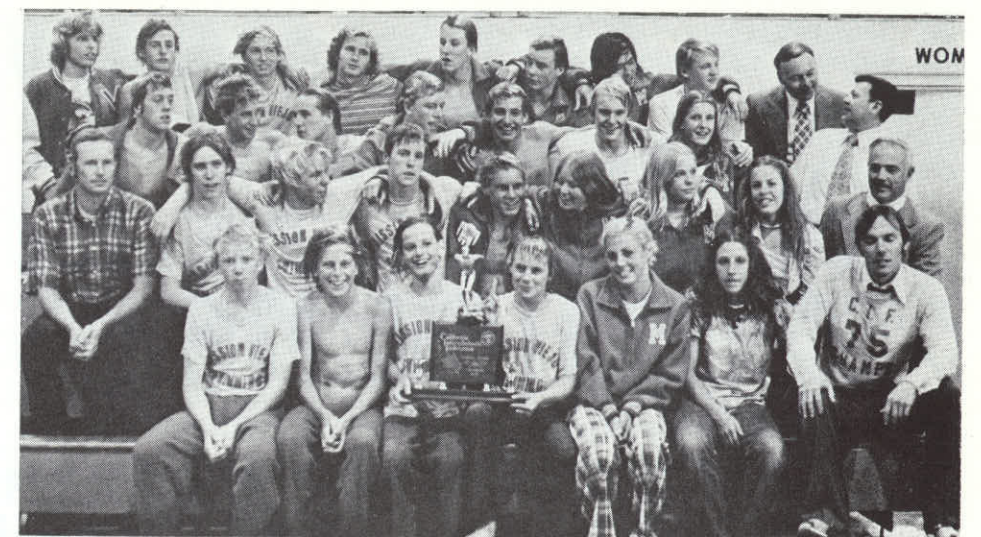

## SAN MARINO CLAIMS FIRST 3A TITLE TITANS NET TOP SWIMMING-DIVING HONORS

San Marino High School has the unique honor of sporting the CIF Southern Section's first-ever 3A swimming and diving championship, off the Titans impressive performance at the Santa Monica H.S. facility.

This marks the initial year that two major divisions (4A and 3A) have been formulated for the swimming and diving ranks and the Titans were equal to the task.

San Marino compiled 172 points to 144 by runnerup El Dorado, with the next closest rival in La Canada's 85-point effort.

Blue ribbons by the Titans' 200-yard medley relay team, Mike Elleman's win in the 500 freestyle, Scott Becker's blue ribbon in the 100 breaststroke and a strong second in the diving competition by Wendell Simpson accounted for a major segment of the point spread.

Two San Antonio League entrants claimed the No. 1 and No. 2 berths in the Frosh-Soph segment of the finals, with Upland compiling 42 points and runnerup Claremont netting 26.

This being the initial year for the 3A division, all marks set in either the CIF-SS Prelims or Finals are listed as records.

## CIF-SS MAY HAVE USE OF COUNTY COUNSEL SERVICES IN FUTURE

Any legal defense for the CIF would indirectly be a defense for all the schools under its umbrella. Experience has shown that one of the functions of the organization is to interpret rules and regulations concerning the athletic program.

This frequently places the CIF in a sensitive position regarding parents and athletes. Paradoxically, the decisions needed to run the organization sometimes are the cause for litigation.

The CIF Southern Section Legislative Committee explored numerous ways to provide free legal service, but felt that the most effective approach was to amend the Education Code.

There's authority for school districts to use the services of the County Counsel in Section 1015, and an additional amendment was devised that would include the State CIF and its member sections.

There are basically three types of support that ACSA may give. They range from one of "no action," which usually goes to legislative material appearing not to have an opportunity of passage; to "support" of material; and to the highest support any action might receive—that of "sponsorship of an amendment."

Ironically, it was at this same ACSA Convention that a similar proposal failed in 1974, but thanks to the efforts of the Committee, it was a success this time around.

Passage of the amendment is expected to come by June, reports Dr. Cordano, with just the mechanics remaining and the major obstacles cleared.

## PROCEDURE REMINDER FOR 'GAMES WANTED'

1. A "Games Wanted" list will be published monthly (September-May). One copy of which is sent to each member school.
2. The list will include games wanted, tournaments needing schools, coaches wanted, and coaches desiring positions.
3. The list will include information for both boys and girls' teams.
4. All entries published will not be repeated on the next mailing unless requested to do so by another communication from the school or individual concerned.
5. Schools and individuals will still be asked to notify the CIF-SS Office when the information is no longer applicable. This will ensure that telephone callers would be given valid and up-to-date information.

# STATE COMMITTEE SUBMITS REGIONAL STUDY

Thanks to the efforts of Ferren Christensen and his six colleagues on the CIF State Regional Championship Committee, their initial findings have been compiled and submitted to the State Federated Council members and the State and Section Commissioners.

The statistical data and consensus recommendations were submitted for review and presentation to the respective Section Councils in advance of the State CIF Council meeting in June. Plans call for discussion of the major

issues at the respective Section levels, with the findings to be submitted when the State Council convenes its June meeting in San Diego.

The data is a tabulation of the questionnaire mailed statewide to boards of education, superintendents, principals and athletic directors.

The consensus response to key issues reflects the current thinking of the seven member Regional Championship Committee and State and Section Commissioners as well.

## CIF-SS ARCHIVES RICH IN HISTORY TELEPHONE HOOKUP MAJOR EVENT IN ANNALS

There's a rich history in the archives of the CIF Southern Section and at times, a brief reflection on those eras provide one with the background that has made this—the State's largest Section with 458 member schools—one of the most successful and focused upon areas for prep interscholastic sports in the nation.

Let's reflect on just a segment of our heritage:

**THIRTY YEARS AGO**—It's April 1945 and Seth F. Van Patten is the Commissioner of Athletics, then making news as the CIF-SS Executive Committee held a meeting by what the telephone company called a conference. The five phones of the Executive Committee members and the CIF Office phone were hooked into a bridge in the telephone exchange. All could hear and be heard over the hookup, the records show, as Mr. Van Patten called the meeting to order . . . Long Beach Poly won the CIF Gymnastic Championship held at Mark Keppel HS with a score of 39 . . . There was a petition by 20 track coaches to the Commissioner, seeking a change to rule No. 26 in the "Blue Book" that states no boy in Class B is to run more than one 220-yard race or longer, including the relay.

**TWENTY YEARS AGO**—J. Kenneth Fagans is in his second year as Commissioner of the CIF-SS in April of 1955 and at the Executive Committee meeting that month, Rim of the World and St. John Vianney high schools were admitted as members . . . Long Beach Wilson HS captured the CIF-SS Swimming and Diving Championships at El Segundo HS with a score of 47 . . . Needless to say, prices have gone up as Huntington Beach HS placed a note in the April Monthly Bulletin and sold 90 high hurdles and 80 low hurdles for the bargain price of \$520.

**TEN YEARS AGO**—Rio Mesa HS of Oxnard and Valley HS of Las Vegas were admitted as regular and associate members respectively to the CIF-SS . . . Six bids were received from contractors interested in constructing the new CIF-SS Office in Artesia . . . A survey of Southern Section schools showed that an interest was developing in girls' track and field.

releaguings questionnaire reflects that the No. 1 choice of the majority of member schools is the criterion of school enrollment.

Following in order, proximity of schools ranked No. 2 in importance, with compatibility and strength of program virtually equal as the next criteria, and the final choice in terms of overall importance was that of being a three or four-year school.

Schools still have the opportunity to respond to the Releaguings Committee and are encouraged to do so through their area representative on the Committee.

Newland, Ted Gossard (Aviation HS) of the Bay Area; Arleigh McConnell (Buena HS) of the Northern Area; Wynola Kerry (Palm Springs HS) of the Citrus Belt Area; Don Haught (Laguna Beach HS) of the Orange County Area; Bruce Keuning (Valley Christian HS) of the Private Schools; Don Conde (Victor Valley HS) of the Desert Area; and Jack Mele (Whittier HS) of the Southeast Area.

The 1975-76 Girls' Releaguings Committee has submitted its final preliminary report to principals of member schools and will file its report with the CIF-SS Council for vote at the May 1 meeting at Rodger Young Auditorium in Los Angeles.

In the area of the concept of adopting Regional Championships in selected sports, the principals responded "YES" by a large majority, while the superintendents responded "NO" by a narrow margin.

According to interest of which sports should be implemented under the Regional concept, basketball, baseball, cross country, golf, track and field, gymnastics, swimming and diving, tennis and wrestling drew the highest response. It should be noted the above are not listed in rank of priority.

As for the time-line implementation of this concept, it was the consensus that one or two sports, basketball and gymnastics for example, could be approved for 1975-76 on a pilot basis as a forerunner to full-scale operation to provide an experimental environment for refinement of rules, effective management and measurement of spectator interest.

It was the consensus that the host CIF would conduct the competition under guidelines and supervision of the State Office commensurate with the present administration of the State track and wrestling competition.

Each section will serve as host for Regional Playoff games on a rotating basis, with a commissioners' committee, under the auspices of the State Federated Council, being established to study cost, disbursement of funds, travel reimbursement to schools, division of profit or loss among schools, section and State.

### UNCOMMON SITUATIONS ON THE DIAMOND DILEMMAS SOLVED FOR BASEBALL COACHES

If you're a baseball coach and have come up with one of those questions you can't find the answer to, possibly your dilemma might be solved by one of the situations found below.

It should be noted the following interpretations of the rules of the National Federation Baseball Committee do not set aside nor modify any rule. The rulings are approved and apply to the situations for which they are given.

**SITUATION**—May an appeal be made for a base running infraction before the "time of the next legal pitch" even though the pitcher has committed a balk or thrown the ball into a dead ball area in an attempt to make an appeal? **RULING:** Yes. The proper

### TIES ELIMINATED IN CROSS COUNTRY FOR NEXT SEASON

If you're a cross country coach and have had the "misfortune" to see one of your teams wind up in a tie for a dual meet, your frustrations are now over.

The official rulebook for the sport (Track and Field Rules and Records as published by the National Federation) contains a tie-breaking procedure for team competition, and this new regulation will be in effect for all activity—regular season and CIF Southern Section approved invitational—during the 1975 season.

The new rule can be found on Page 40 (Rule 12), and it reads as follows:

"Ties in team scoring shall be resolved totaling the scores of the first four finishers from the tying teams. If the tie remains, the scores of the first three finishers, then the first two and finally the first man will be used until the tie is broken."

## SPECIFIC GUIDELINES COVER MAY 1 DATE

It's just about May 1, and that date signals a rash of athletic activity at most CIF-Southern Section member schools. However, this would be an appropriate time to remind all athletic directors and coaches of the guidelines covering CIF-SS approved sports between May 1 and the close of school in June.

Organized before or after-school team practice may be held in all sports from May 1 until the close of school in June, but a member school may NOT participate in an interscholastic scrimmage, practice or contest during this time period. From the close of school in June until the opening day of school in the fall semester, there shall be no restrictions on high school coaches working with high school students or entering them in summer competition. A member school, however, may NOT sponsor a team's entry, issue equipment, or be responsible for students competing in summer leagues outside the season of sport.

Football and cross country have earlier cutoff dates prior to the opening day of school in the fall semester, and athletic directors and coaches should verify the specific dates in reference to their summer programs.

If there is any doubt on a matter, schools should consult the CIF-SS Red Book or the CIF-SS Office.

### ATHLETIC DIRECTORS REMIND OF CHANGE IN BASKETBALL JERSEY

Spring is the time of the year that the majority of high schools in the CIF Southern Section place their equipment orders for the next school term and in doing so, athletic directors are reminded of an upcoming change for basketball uniforms.

The rule change deals specifically with the basketball jersey and all schools purchasing new uniforms are reminded to make certain the jersey meets all rules criteria.

The National Basketball Committee has suspended the provision prohibiting diagonal lettering of names on shirts until the start of the 1977-78 season.

However, it should also be pointed out that no tails over or under names on shirts will be permitted beginning with the 1976-77 season.

The Basketball Case Book (page 3) calls attention to the fact that emblems or monograms are not permitted on the basketball shirt, and thus makes the jersey illegal. Jerseys with emblems or monograms will be legal until that time.

### GIRLS' SUMMER SPORTS CAMP SET TO OPEN

Summer camps have become virtually a "way of life" with the male counterparts over the past few years, but now, one of the most extensive summer programs is being made available for girls in the CIF Southern Section.

The Women's Physical Education Department of California State University at Long Beach is offering a specialized sports camp for girls, which will cover 10 selected areas.

The camp will be segmented over three, one-week sessions and is open to all girls, grades 7 through 12.

Under the format, a girl may select one of the sports being offered in each session, with the classes being separated for high school and junior high girls to bring about the most efficient level of competition.

**WEEK 1**—Offered June 16-20, covering sports of volleyball, gymnastics, and track and field.

**WEEK 2**—Offered June 23-27, covering sports of basketball, tennis, and gymnastics.

## TOTAL MEMBERSHIP IN 1976-77

### MEMBER SCHOOLS TO INCREASE NUMBERS

Girls' athletics in the California Interscholastic Federation is here to stay. The degree of participation is perhaps best exemplified in the Southern Section where 279 of our high schools have girls competing in one or more of our nine interscholastic sports for girls.

This figure is expected to increase to approximately 323 in the 1975-76 school year, with all of our more than 425 coed and all-girl junior and senior high schools participating in the following year. Because it has been mandated by the State CIF Federated Council that all member schools must abide by CIF rules for both boys and girls beginning in the fall of 1976, there will be upwards of 1,000 California secondary schools providing interscholastic athletic opportunity for girls.

It goes without stating that girls' athletics has existed in our schools long prior to CIF sanctioning of interscholastic athletics for girls. Other agencies, such as the Division of Girls' and Women's Sports (DGWS), Amateur Athletic Union (AAU), and local school districts and leagues have provided guidelines and suggested operating procedures during these years.

Although the California Interscholastic Federation must be the governing body, by September of 1976, for all girls interscholastic athletics, this in no

way should preclude the continuing efforts of other bodies to work towards improvement of any or all aspects of girls' athletics.

The goals of these other agencies are quite similar to that of the CIF in relation to girls' athletics, and there is no valid reason why such efforts need to be discontinued or even diminished.

There are several areas where cooperative assistance could be presently utilized:

1. **Publicity and Promotion:** Attention could be given in periodicals and notices regarding past and (Continued on Page 12)

## HIGH SCHOOL ATHLETICS . . . A BARGAIN!

The word "MONEY" plays a major role in the realm of high school athletics. And it's a word — and a role — which needs some clarification!

In a recent communication from the office of Clifford B. Fagan, executive secretary of the National Federation of State High School Associations, one snappy sentence does an excellent job of bringing interscholastic sports and the often-heard financial crisis in focus:

"Interscholastic athletic programs are not educational frills, but educational staples; money spent on athletics is not an educational extravagance, but an educational bargain."

The communication from Fagan to state associations like the California Interscholastic Federation all over the country goes on to say that "money spent for expanding athletic programs remains a pittance in comparison to the total school budget.

Support for this point is made by calling attention to the fact that the majority of school budgets segment a mere one per cent or less of the entire budget to subsidize interscholastic athletic programs.

"We challenge any other area of the curriculum to effectively operate a program for so many students at even twice the cost," writes Fagan.

He goes on to say: "Athletics are successful as educational tools because instructors and participants interact in emotional situations where they are visibly and measurably accountable for their performances. Athletics are perhaps the most economical way of reaching and affecting positively great numbers of boys and girls."

One member of a Board of Education went so far to say, "I suppose it is always possible in a terrible budget pinch that some people who don't understand values might want to cut the athletic program, but I think parents and people in the community would rise up and insist that it continue . . . If you lost athletics, you would lose one of the best supportive pillars. You would lose people who support the whole program."

Understanding values really is the key to the whole problem of money — as it relates to interscholastic athletics or, for that matter, as it pertains to anything. The question we must ask ourselves ultimately is: "Are we getting our money's worth?"

There seems to be a number of documentations supporting the fact that school sports are as good a bargain as you can find anywhere these days . . . let's not pass up a good bargain when we see one!

is democratic and self-governing. The rules by which we operate in the California Interscholastic Federation are formulated by representatives of member schools. These people, elected by their peers represent all member schools at both State and Southern Section levels in legislation and other decision making.

Each year, new rules are written as the need is indicated and felt. Old rules are eliminated or modified as they become obsolete, impractical, or in need of revision. Within our struc-

ture there is provision for both change and appeal. Those who would wish a rule revision, or who would seek appeal from a previous adverse decision, have opportunity to do so. The procedures for both are outlined and discussed in both our state and section constitutions and by-laws.

Those who would use other means to obtain what they feel is "right" are either ignorant of the procedures by which our organization operates or are placing a higher premium on the goal than the system. The former is unfortunate; the latter is abhorrent and has no place in our philosophy.

coming events and outstanding achievements by athletes, teams, and coaches.

- 2. Committees:** Service could be given on various girls' athletic committees; sports committees, rules committees, ethics committees, to name but a few.
- 3. Coaching Clinics:** The improvement of coaching techniques and the dissemination of valuable information at these clinics are most important in the development of better athletic programs. The work in planning, implementing, and presenting the clinics is extensive, and there is almost no limit to the number of dedicated people who can so serve.
- 4. Coaching Ethics:** Ethics is extremely important in any profession, and the coaching profession is no exception. Those who would so serve may write editorials, publish articles, speak at functions and meetings, serve on committees, and otherwise help to develop and promote ideals of ethical standards and conduct relating to coaching in general and girls' interscholastic athletics in particular.
