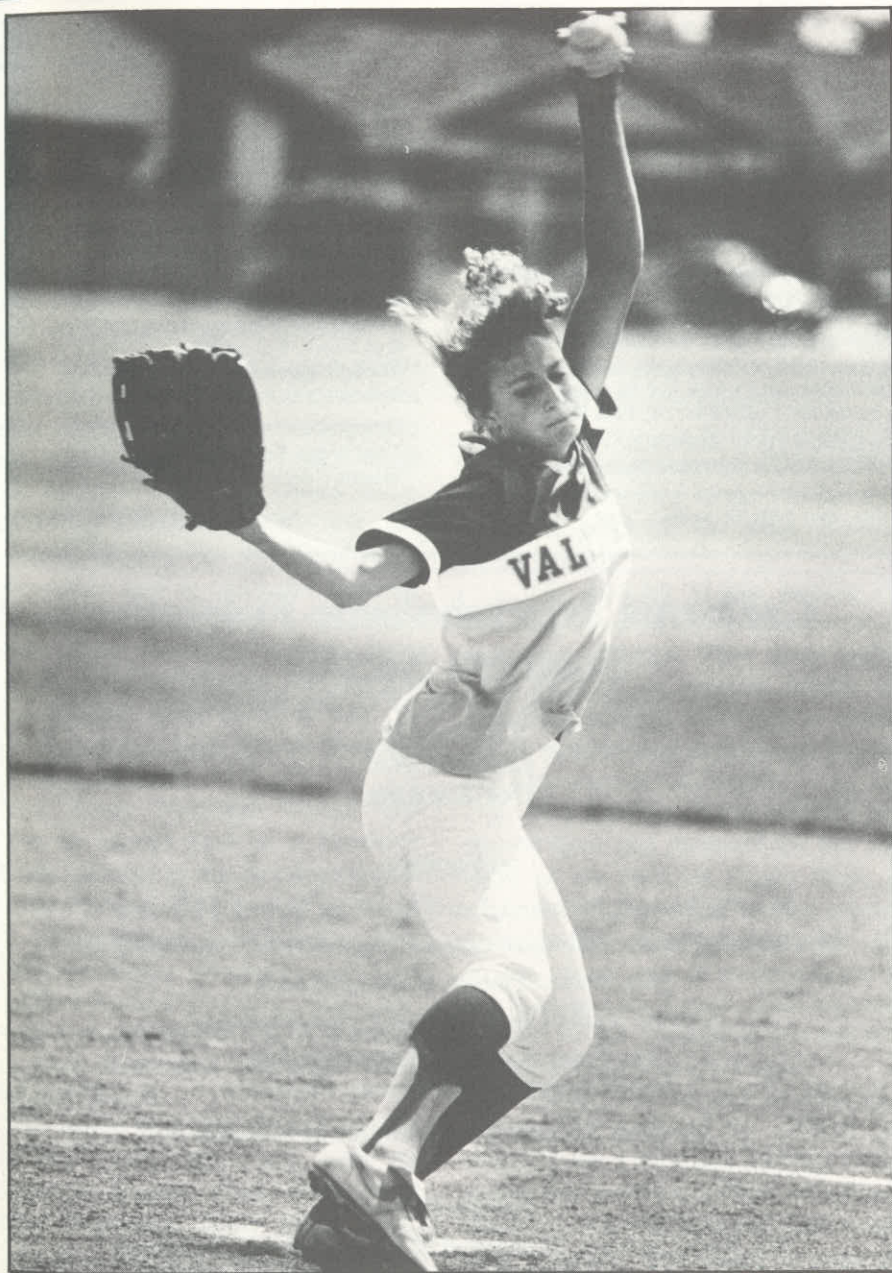

COMMISSIONER'S CORNER



**MEMBERSHIP
HAS ITS
RESPONSIBILITY**

Schools that become members of the CIF Southern Section are provided such opportunity based upon freedom of choice. An important element of this choice is the responsibility to recognize the accepted standard of rules by which this organization is governed. As Commissioner, it is my firm belief that membership in the State CIF and the Southern Section requires a fundamental knowledge and acceptance of the current rules and regulations as set forth in the constitution and bylaws.

Through years of review and refinement, this organization has developed a standard by which all members are expected to operate on a daily basis. This document is the CIF Southern Section Blue Book. It has been designed and written in a manner to provide a reasonable degree of interpretation for principals, office administrators and the Executive Committee. When a principal of one of our member schools has doubt or requires assistance in the clarification of any rule, a simple phone call to the section office will result in immediate assistance and is strongly recommended.

When a principal misinterprets a rule and allows his or her school to fall into an infraction—regardless of intent—it becomes the responsibility of the section commissioner and his staff to evaluate the incident and determine what form of sanctions or penalties—if any—should be imposed to correct the problem. Once a decision has been reached and communicated to the principal, an appeals process is made available to the school, athlete(s) or parent(s) involved. If the school in-

CIF-SS COUNCIL MINUTES March 17, 1988

The March meeting of the CIF Southern Section Council was called to order by President Pat Mauch at 9:30 a.m. on Thursday, March 17, 1988 at the Ramada Inn in Norwalk. All leagues were present with the exceptions of the Collegiate, Condor, Heritage, Liberty, Sunrise, Victory, All Girls', and Junior High Leagues.

1. APPROVAL OF MINUTES—It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of January 21, 1988 as mailed to the Council, and the CIF Southern Section Executive Committee minutes of February 18, 1988 as distributed to the Council.

2. PRESIDENT'S UPDATE—Pat Mauch, President of the CIF-SS Council, commended those teams that participated in the CIF-SS winter playoff activities.

3. COMMISSIONER'S UPDATE—Commissioner Stan Thomas reviewed with the Council the upcoming May Council meeting, scheduled to be held at the Sequoia Athletic Club in Buena Park. Additionally, Commissioner Thomas updated the Council on the recent withdrawal of membership by Harvest Christian School in Anaheim; concerns relative to an increase in the number of incidents and ejections in baseball; recent court cases and a need for support with regard to all CIF Rules and Regulations by member schools; and the upcoming playoff groupings which are now in the hands of league representatives and which will be voted upon in May by the full Council for the 1988-90 cycle.

4. TREASURER'S REPORT—Mr. Bruce Keuning, treasurer, reviewed background information and the proposed Southern Section budget for the 1988-89 school year. This is a

non-action item and will be voted on at the May 5, 1988 meeting of the CIF-SS Council.

5. NOMINATING COMMITTEE REPORT—Mr. Jim Douglas, Chairman of the CIF-SS Nominating Committee, reviewed the recommendations for representatives on the CIF-SS Executive Committee. The following names were placed in nomination:

involvement with the CIF-SS and other youth organizations throughout the United States," added Schmidt.

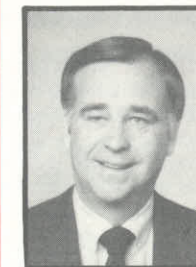

ALL-STAR BASKETBALL

With the completion of the 1987-88 basketball season, the CIF-SS Office has been asked to review the eligibility status of a student athlete who competes—during the spring—in an all-star contest.

The specifics as they pertain to all-star contests are covered under Article 9 of the Constitution and By-Laws. As you will note, participation by student-athletes is permissible in certain situations, **WITH THE EXCEPTION OF THE SPORTS OF FOOTBALL AND BASKETBALL.**

Thus, if a student following his or her high school season of sport (the winter season for basketball in this case)—regardless of whether the student is a senior or underclassman—participates in an all-star contest, the student will have made him or herself ineligible from further interscholastic competition immediately.

It is to be noted that this eligibility pertains to all other sports in which the student participates. As an example, if the student would also be a member of the track, baseball or softball team, his or her participation in the all-star contest would render him or her ineligible in these sports.

The CIF Southern Section Office urges all athletic administrators and/or basketball coaches to review this rule (Nos. 900-904 pg. 64 of the CIF-SS Blue Book) with those students involved in the school's basketball program. Additionally, it should be noted there are rules restricting the coaching staff from participation in the organization of said all-star contests as well.

This is a non-action item and will be voted upon at the May 5, 1988 meeting of the CIF-SS Council.

6. STATE COMPETITION COMMITTEE

REPORT - Executive Committee member Sheri Ross updated the Council on the State Competition Committee report which included the Girls' State Volleyball Championships which will be conducted in three divisions by enrollment classification beginning next year; cross country which will again be conducted by enrollment classification in three divisions for both boys and girls; and the recent expansion to five divisions for the State Boys and Girls Basketball Championships.

7. FALL SPORTS PRACTICE PROPOSAL

John Aycock, Principal of Boron High School, presented a proposal calling for ALL fall sports to begin practice on the same date as football. Following discussion, it was moved, seconded and passed to refer this item for a recommendation from the Season of Sport Committee to the full Council for a vote at the May 5, 1988 meeting.

8. REQUEST FOR CHANGE IN 1988-89 "R & R" WEEK

Mr. Bob Boehme, Sunset League Representative, presented a proposal calling for a change in the R & R Week for the spring of 1989 from May 15-20 to May 8-23. Following discussion, it was moved, seconded and passed to refer this item for a recommendation from the Season of Sport Committee to the full council for a vote at the May 5, 1988 meeting.

9. PROPOSAL FOR SUMMER "R & R" GUIDELINES

Mr. Neil Case, Sunkist League Representative, presented a proposal calling for a summer "R & R" period. Following discussion, it was moved, seconded and passed to refer this item for a recommendation from the Season of Sport Committee to the full Council for a vote at the May 5, 1988 meeting.

10. PROPOSAL FOR ADDITION OF SURFING

Mr. Tom Anthony, Principal of Capistrano Valley HS, presented a proposal for consideration of the adoption and sanctioning of the sport of surfing in the CIF Southern Section. This is a non-action item and will be voted upon at the May 5, 1988 meeting of the CIF-SS Council.

11. FOOTBALL PLAYOFF PROPOSAL

Dr. Richard Kirwin, Century League Representative, presented a proposal requiring home schools to assign responsible adults to the chain crew for all CIF-SS football playoff games. This is a non-action item and will be voted upon at the May 5, 1988 meeting of the CIF-SS Council.

12. HALL OF FAME COMMITTEE REPORT

Mr. Bruce Kitchen, Chairman of the CIF-SS Hall of Fame Committee, reviewed background information on the State and Southern Section lack of participation in the National Federation High School Sports Hall of Fame Program. It is the recommendation of the Committee to present to the State Federated Council for consideration and adoption, a Statewide nomination procedure that would be equitable to all Sections of the CIF, and to establish a nomination procedure within the Southern Section that would process recommendations from individuals, schools and leagues. This is a non-action item and will be voted upon at the May 5, 1988 meeting of the CIF-SS Council.

13. BLUE BOOK COMMITTEE REPORT

Mr. Gary Goff, Chairman of the CIF-SS Blue Book Committee, reviewed with the Council interpretations dealing with outside competition and practice in the sports of baseball and softball during the season of sport; summertime rules and summer pay coaches; rules dealing with undue influence; and the importance of due process and the need for school personnel to review Rule 1100 dealing with appeals procedures. Additionally, Mr. Goff presented items pertaining to amendments to the CIF-SS Constitution and By-Laws, effective with the 1988-89 school term. These recommendations, changes to the Constitution and By-Laws, will be voted upon by the full Council at their meeting of May 5, 1988 in the following areas:

A. CIF-SS Rule 522 - SCOUTING PROHIBITIONS - CURRENT RULE

- Motion pictures, video reproduction and/or any other type of reproduction such as still pictures, etc. shall not be taken for scouting purposes in any sport by a representative, official or unofficial, of a CIF Southern Section school in which his/her team member is not a participant, without written consent of the participating schools.

PROPOSED CHANGE - SCOUTING PROHIBITIONS - PRACTICE SESSION

- Scouting of any type which would include personal viewing, written notes, audio tape, motion pictures, video reproduction and/or any other type of reproduction, such as still pictures, etc. shall not be taken in any sport of a member school's practice sessions by anyone without written consent of the participating school(s).

Q & A - What is allowed with regard to scouting a contest?

There will be **NO** restrictions on the part of members schools regarding the filming/video taping of any contest. Home schools will maintain game management rights and responsibilities.

B. CIF-SS RULE 125 - ACCOUNTABILITY

CURRENT RULE - Upon the ejection of a coach from any CIF-SS contest and/or the removal by a coach of his or her team from the playing surface prior to the conclusion of the contest, it would be incumbent upon the principal of said school to file a letter of explanation with the CIF Southern Section Office which includes the circumstances surrounding the matter and what action the principal has taken to prevent a recurrence. Such correspondence is to be filed before allowing a coach to return to his/her role at the next contest. Failure to accomplish this would make such contest subject to forfeit until the task is completed.

PROPOSED CHANGE - 125.1 - COACH

EJECTION - Upon the ejection of a coach from any CIF-SS contest, it is the responsibility of the principal of said school to file a letter of explanation with the CIF Southern Section Office which includes the circumstances surrounding the matter and what action the principal has taken to prevent a recurrence. Said correspondence is to be filed within **THREE** school days of notification of the ejection. After the three-day filing period has passed, the coach will not be allowed to return to his/her role at the next contest until the Office receives the required correspondence.

125.2 - FAILURE TO COMPLETE A CONTEST

- When a school fails to complete a contest, due to a coach pulling his/her team from the floor, court or field, it is **MANDATORY** that the CIF-SS Office be notified by the Principal within 24 hours (excluding holidays and weekends). The competing schools and officials will be required to file written reports, and after review of the aforementioned material,

the principal of the school involved will be required to respond to the CIF Southern Section Office concerning his/her investigation of the incident.

Q & A - How serious is such action?

It has been the position of the CIF-SS Executive Committee to expect the building principal of the school concerned to relieve the coach from his/her assignment for the balance of that season or the Executive Committee is empowered to consider recommendations for additional penalties.

C. CIF-SS RULE 1106.2 - APPEALS DEALING WITH INTERSCHOLASTIC CONTESTS. CURRENT RULE

- Any protest of a playoff contest involving an ineligible player or matters other than playing rules will be processed by the Commissioner, who will have the sole authority to rule on the contest.

PROPOSED CHANGE - Any protest of a playoff contest involving an ineligible player, violation(s) of Southern Section rules and regulations which may affect teams in the playoff draw, or matters other than playing rules that might affect teams in the playoff draw, will be processed by the Commissioner, who will have the **SOLE** authority to rule on the contest or any contest to be played in upcoming rounds.

14. ORANGE COUNTY PILOT PROGRAM AND 1988-89 PROPOSAL

Administrator Bill Clark reviewed with the Council the present Orange County Officials Pilot Program and presented the Council with the Office recommendations for implementation which will be reviewed with League Representatives, school Principals, and Officials Associations during the months of April and early May, with a report to the Council at the May 5, 1988 meeting.

15. DIVING - THREE (3) METERS

- CIF-SS Administrator Bill Clark reviewed with the Council, State, Southern Section, and National Federation rules dealing with three-meter diving.

16. GEOGRAPHICAL RELEAGUEING

- Associate Commissioner Dean Crowley reviewed concerns with regard to the Coast and San Gabriel Valley geographical areas where the greatest number of school closures have been experienced in the last five years, creating a decline in the number of schools in these two specific relegueing areas. In terms of equity of competition, balance, school enrollement, and the number of schools in the relegueing area, it has been very difficult for schools to come to an equitable agreement in terms of relegueing procedures. The CIF-SS Staff, after several meetings with league representatives and principals, has come to the conclusion to recommend disbanding the current San Gabriel Valley relegueing area and attaching the 21 schools to other existing areas. At the present time, several plans are being drafted which will be reviewed by league representatives and school principals of the affected areas.

17. OUTSIDE COMPETITION - SOCCER

RULE 2712.1 - Dr. Robert Packer, Executive Committee member, reviewed with the Council the question of outside competition in the sport of soccer and the present State interpretation of Southern Section rule 2712.1, whereby the CIF-SS rule, as adopted earlier by the Council, was in conflict with current State rules and regulations, thus exposing the Southern Section to the risk of litigation. Following discussion, it was moved, seconded and passed to rescind rule 2712.1 -outside competition- for the sport of soccer only, effective immediately.

18. STATE CIF BUDGET - Mr. Bruce Keuning reviewed with the Council the proposed State

NEW BLOCKING TECHNIQUE HIGHLIGHTS

1988 NATIONAL FED. FOOTBALL RULE REVISIONS

Offensive blockers in high school football will have an additional technique to employ beginning with the 1988 season.

Meeting January 6-7 in Colorado Springs, the National Federation Football Rules Committee approved an additional technique for offensive blockers which allows them to fully extend their arms and use open hands. This new technique does not replace the former method but permits an additional style of blocking.

This addition to the rule 2-2-2 was one of 15 rules changes made by the committee, which is composed of one representative from 48 of the state member associations, including the District of Columbia, as well as representatives of the National Federation Interscholastic Coaches Association (NFICA) and the National Federation Interscholastic Officials Association (NFIOA).

"The rules committee believed that the 1987 football season was a good one and that the rules in place are appropriate for high school football," said Dick Schindler, assistant director of the National Federation and editor of the football rules. "The committee's action on the blocking rule accumulated several years of discussion and experimentation."

"The states that experimented with extended-arm, open-hand blocking (eight states last year) reported favorable results, and the committee believes the additional blocking techniques should not cause additional enforcement concerns for officials."

The new blocking technique, which is similar to that used at the college and professional levels, is a more favorable style of pass blocking and should help offensive linemen in protecting quarterbacks.

In addition to the blocking rule, the committee approved a change in the penalty for an ineligible receiver downfield by eliminating the loss of down. Beginning in 1988, only a five-yard penalty will be assessed for an ineligible receiver downfield illegally. Previously the penalty was 15 yards,

followed by a change to five yards and loss of down.

"The committee deleted the loss of down from this infraction because a team does not employ an ineligible receiver downfield to gain an advantage; it usually is simply a mistake," Schindler said.

In another Rule 7 change, the committee altered Rule 7-5-1 to redefine the reference point of a passer beyond the line of scrimmage from the release point of the ball to the location of the passer's feet.

Four changes were made in Rule 1, including 1-3-8, which allows state associations to authorize the use of supplementary equipment to aid in game administration. This includes any type of equipment, such as a 25-second clock, not currently addressed in the rule book.

A clarification of Rule 1-5-3c was issued to ensure that any hard portion of a knee brace that extends below the

pants must be covered. In addition, Rule 1-5-3-h-(1) now prohibits the use of ceramic materials for cleats.

A note also was added to Rule 1-5-3 which authorizes state associations to allow teams totally composed of deaf or partially deaf players to establish a rhythmic cadence by use of a drum. Teams in California and Colorado experimented with this rule last year.

Two changes were made in Rule 3 regarding periods, time factors and substitutions. Rule 3-2-1 now permits four captains from each team to be involved in the coin toss. Acknowledging that many teams have two offensive and two defensive captains, the committee made the change from two to four captains.

Rule 3-5-7 requires an injured player, if time has been stopped for the injury, to sit out at least one play. However, a change was made to allow a person who is injured on the last play of the first half to return on the first

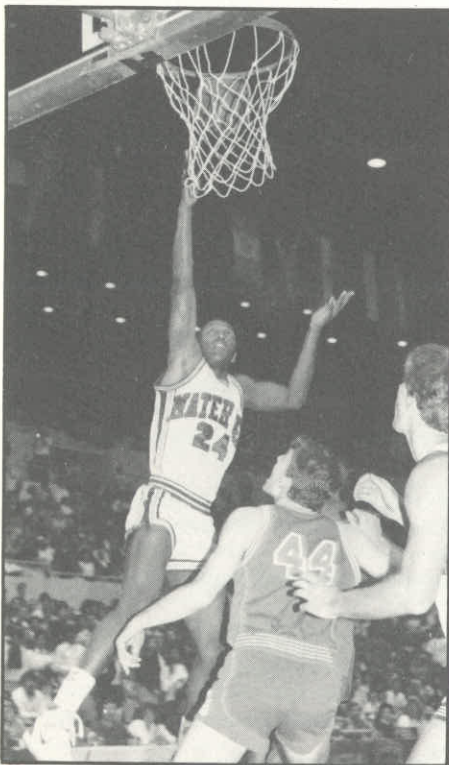

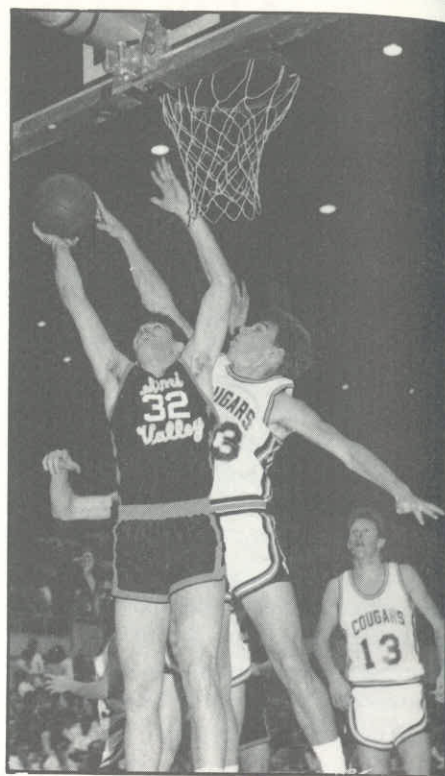

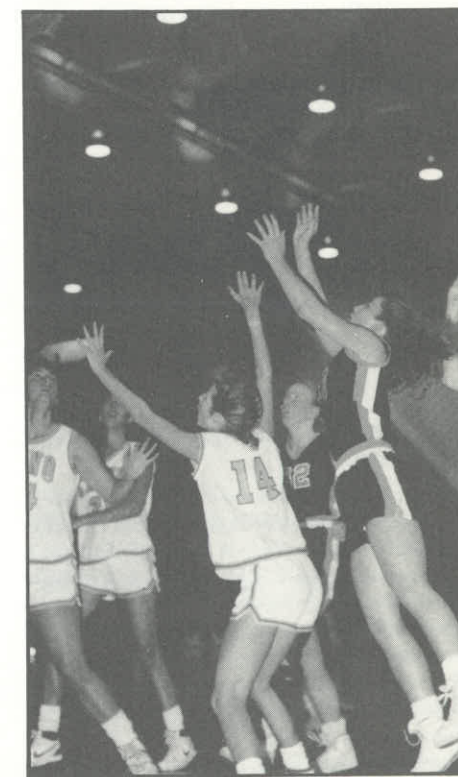

play of the second half. The change also applies to any overtime periods.

An addition to Rule 9-4-2 reemphasizes improper use of the helmet by prohibiting any player from intentionally using the helmet to butt or ram an opponent.

Two other changes were made in Rule 9. Rule 9-8-2 now allows team attendants to enter the field between periods, as has been the case with timeouts in the past, and the penalty for attendants on the field illegally has been reduced from 15 yards to five yards.

Two final changes in 11-man football were made in Rule 10, including Rule 10-4-5, which ensures that the receiving team's free-kick line will not be extended inside its five-yard line. Rule 10-5-4 now states that the penalty for a foul by the opposing team during

Changes were made in 6, 8 and 9-man football to extend coverage for the size of fields, numbers on receivers, snap spot after touchback or safety, and yard line for start of an overtime period.

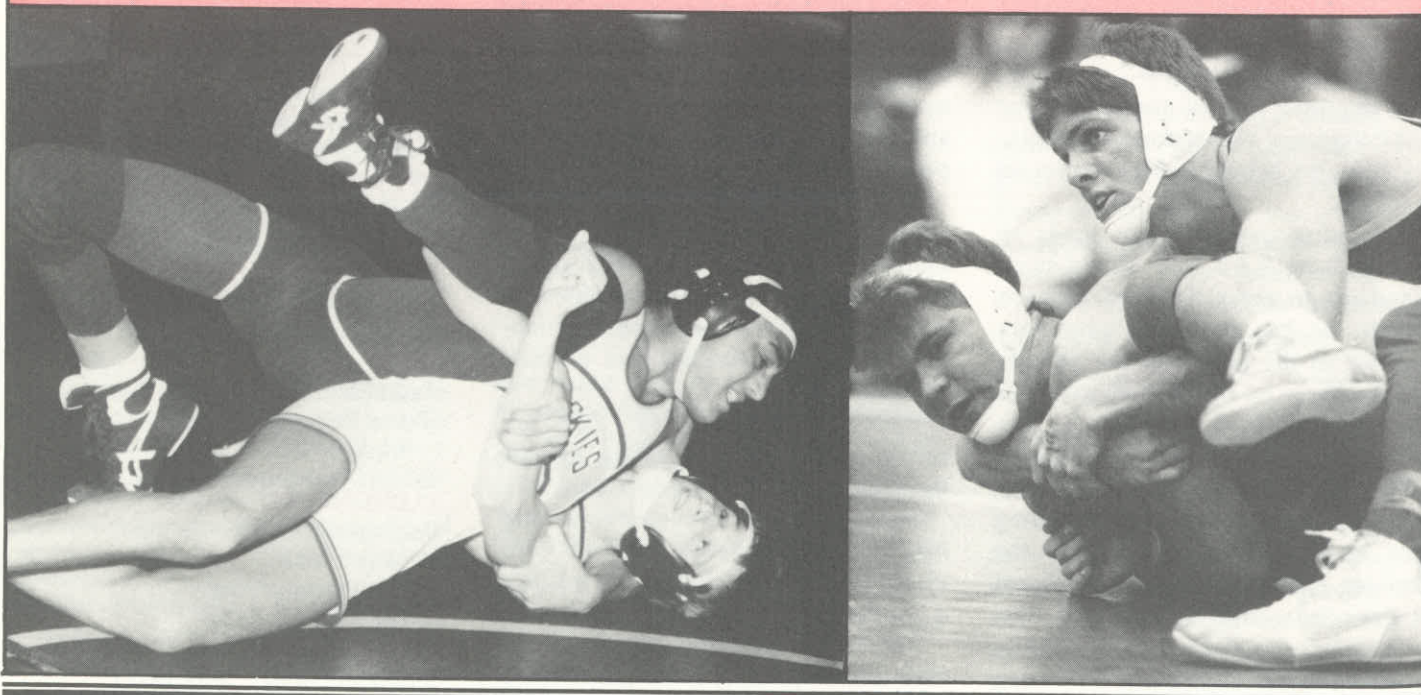

tends to appeal, the CIF-SS Executive Committee is informed of the incident and a three-member appeal committee is convened. If the committee sustains the decision of the commissioner after hearing the appeal, the state office is available as the next level of appeal.

If the state appeals committee sustains the decision of the section office and sanctions or penalties are enforced, a member school in good standing will accept the decision, knowing it has been made by elected representatives of all the member schools, who are understood to be reasonable people with a solid understanding of the daily business of interscholastic athletics. Further, it should be understood that such decisions are reached with the mutual benefit of the organization's entire membership in mind.

An incident may become a major issue when a member school, which has chosen to belong to this organization and abide by its rules, takes a course of action that will involve attorneys and the court system. On more than one occasion throughout the state, ignorance and misapplication of our rules has been demonstrated by people outside of the organization. If we are to survive within the family of Southern Section schools, every member principal should accept as a final decision the authority of the state appeals committee.

To proceed beyond the state level is the fundamental right of any school or individual; we all recognize the Constitution of the United States and the judicial process. However, once a member school crosses the line of choice and demonstrates a reluctance to accept the decision of its peers, a re-evaluation of its continued participation in our family of schools may be required. Such a school, in my estimation, is one that does not agree to abide by the accepted standards of membership.

If cases such as these continue, what should be done? Certainly, the financial impact upon the section and state organizations is enormous. Should we

continue to spend our time and suffer the financial consequences of defending the rules written by our principals and agreed to by our member schools in a democratic process? The cost of such practice will ultimately be born on our member schools.

It is my contention that this organization can live within the framework of the section and state constitutions without bringing our disagreements to the courts. Our member school principals must accept the responsibility of managing their athletic programs in a manner that facilitates the intent and spirit of all rules and regulations contained in our Blue Book. When we agree to avoid litigation at all costs, and accept the decisions of our elected officials, the State CIF and Southern Section will assume a stronger posture, free of outside influence.

CIF budget for the 1988-89 school year. Following the discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support the State budget proposal.

19. MODIFICATION OF RULES IN SWIMMING AND SOFTBALL - Administrator Karen Hellyer presented a State CIF proposal dealing with modification of rules in swimming and softball. It should be noted that these proposals are recommendations only that will be forwarded to the National Federation through the State Federated Council for consideration by the National Federation Rules Committee.

(A) **SWIMMING** - Recommended change in the scoring in dual swimming meets with pools of six or more lanes to align with NCAA scoring. Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support the proposal.

(B) **SWIMMING RELAY ENTRIES** - Recommendation to increase the number of relay team entries in championship swimming meets from one per team per relay to two per team per relay. Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council NOT to support this proposal.

(C) **SOFTBALL PITCHING DISTANCE** - Recommendation to increase the pitching distance in girls' fast-pitch softball from 40 feet to 43 feet to align with NCAA distance. Following discussion, it was moved seconded and passed to direct the Southern Section delegates to the State Federated Council to support the proposal.

21. FOOTBALL PLAYOFFS - FILLING OF BYES - Mr. Dick Klatt, Principal of Orange Lutheran High School, reviewed a proposal from the Olympic League pertaining to the criteria for the filling of byes in the football playoffs. Following discussion, the proposal was defeated.

22. ALL-STAR COMPETITION - BASKETBALL - Mr. Dave Wheeler, Principal of Laguna

Beach High School, reviewed a proposal from the Pacific Coast League dealing with all-star competition in the sport of basketball. Following discussion, it was moved, seconded and passed to recommend to the State Federated Council the deletion of basketball from Rule 900 and 904. It should be noted that this item will be forwarded to the State Federated Council for first reading at the April 29, 1988 meeting and will not be acted upon until October of 1988.

23. 10 SECOND MID-COURT LINE - GIRLS' BASKETBALL - Mr. Larry Brown, representing the Marmonte League, reviewed a recommendation pertaining to the mid-court line for girls' basketball. Following discussion, the proposal

was defeated.
