

AAF, CIF-SS TO EXPAND EDUCATION PROGRAM FOR COACHES

The CIF Southern Section and the Amateur Athletic Foundation of Los Angeles (AAF), are pleased to announce the expansion of their highly successful coaching education

A PARTNERSHIP FOR COACHING EDUCATION

program, which began last year. The decision to expand the unique program is based on glowing evaluation reports of a pilot program conducted for soccer coaches of 100 selected high schools last summer and fall.

The organizations are implementing plans to move ahead with expansion in the soccer program to include the additional 650-plus high schools encompassed in the AAF geographic region (the combined total of the CIF Southern, San Diego and Los Angeles City Sections). The battery of soccer clinics, to be conducted at six regional sites,

will be conducted in two sessions later this year: summer (July-August) and fall (October-November).

The AAF is also going ahead with plans for a 100-school pilot program to offer clinic-style instruction for coaches in the sport of track and field, scheduled for December of 1990 and February of 1991. If successful, track and field instruction for the full complement of high schools in Southern California will follow in the 1991-92 school year.

"The Amateur Athletic Foundation

is committed to enhancing the experience of an estimated 250,000 high school athletes in Southern California, by enriching the level of coaching they receive," says Skip Stolley, Program Associate of the Amateur Athletic Foundation. "The AAF-CIF Southern Section Partnership for Coaching Education has become the single largest program our organization funds."

The pilot program in soccer included three four-day clinic sessions, conducted at South Torrance High School last

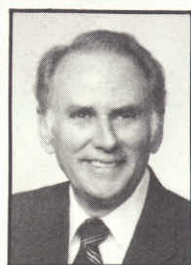

TAKING A STAND AGAINST VIOLENCE

The Orange County-based Freeway League is taking action to extinguish the flames of violence and unsportsmanlike acts, which have ignited with disturbing frequency at CIF Southern Section athletic events during the 1989-90 school year.

At the March 15 meeting of the CIF-SS Council, Sunny Hills High School Principal George Giokaris pointed out the urgent need to curb the unwelcome trend of rising incidents and unacceptable behavior on the part of student-athletes, coaches, officials and spectators. Speaking on behalf of the Executive Committee, I applauded the initiative of the Freeway League principles and athletic directors for taking a strong position on this vital issue.

I recommend that each of our member leagues take a good long look at the Freeway League action, if for no other reason, than as a starting point for discussion. The importance of this issue cannot be understated. Clearly, it is the very survival of high school athletics that is at stake here. If our schools cannot conduct their events without incident and without the proper deportment of participants, we have no basis for the continuance of interscholastic athletics.

In addition to Sunny Hills, the Freeway League consists of Buena Park, Fullerton, La Habra, Sonora and Troy High Schools. For the benefit of all member schools and leagues, the complete Freeway League initiative follows:

On March 14, 1990, the topic of violence in high school athletics was an agenda item of the Freeway League. The Principals and Athletic Directors unanimously agreed to the following course of action:

- I. Workshops will be held in September, 1990, involving Admin-

EXECUTIVE COMMITTEE MINUTES

February 22, 1990

The February meeting of the Executive Committee of the CIF Southern Section was called to order by Chairman Dr. Tom Jacobson at 1:20 p.m. on Thursday, February 22, 1990 at the CIF-SS Office. All members were present with the exception of Jim Fleming, Sheri Ross, Richard Ramirez and Dr. Robert Packer.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of January 13, 1990.

2. PRESIDENT'S UPDATE - Dr. Tom Jacobson reviewed with the Committee the progress of the winter playoff activities and the recent surgery of Dr. Packer, who is at this time recuperating at home.

3. COMMISSIONER'S UPDATE - Commissioner Stan Thomas reviewed with the Committee the State corporate support program; the AAF partnership; Loyola relegating appeal to the State CIF; work being done on the football playoff groupings; and the possibility of conducting a school board member and administrator symposium in late August prior to the opening of school. Additionally, Commissioner Thomas complemented Administrator Karen Hellyer on the success of the Athletic Administrators Symposium.

4. SUPERINTENDENT'S UPDATE - Superintendents' representative Cynthia Grennan discussed concerns regarding security, supervision and crowd control at playoff games, and the excellent format at the Athletic Administrators Symposium. Additionally, she updated the Committee on the implication of year-round school and the impact on CIF Section and State rules and regulations. Further, it should be noted that the aquatic certification program recently adopted by the State Legislature, which will be implemented in January of 1991.

5. TREASURER'S UPDATE - Treasurer Ken Gunn gave a brief update on the 1989-90 working budget and reviewed background information on the proposed 1990-91 budget which will be presented to the Council at the March 15, 1990 meeting, with a final vote set for April 26, 1990.

6. LEGAL UPDATE - Attorney Andy Patterson reviewed the Palmdale State appeal; litigation involving a foreign exchange student; and the ongoing hearings regarding the Victor Valley High School basketball incident.

7. STATE CIF REPORT - Commissioner Stan Thomas and State CIF Representative Gary Smidderks updated the Committee on ongoing negotiations with Reebok, the non-renewal of the Coca-Cola contract, and the continued negotiations with School Properties.

8. AT-LARGE EXECUTIVE COMMITTEE MEMBER - Dr. Tom Jacobson discussed the process by which an at-large member would be appointed to the Executive Committee. It should be noted that the Council approved a proposed by-law change that will provide for an at-large member on the CIF-SS Executive Committee. Following discussion, it was moved, seconded and passed to solicit a recommendation from leagues to nominate a minority, female/male Principal for consideration for this post.

9. FOOTBALL PLAYOFF INCIDENT - Dr. Clyde Smythe, Superintendent, and Dr. Bill White, Principal of Canyon High School discussed mutual concerns regarding the football playoff incident at the conclusion of the football game between Hart and Santa Barbara High Schools during the fall football playoffs. It should be noted that throughout the efforts of the Superintendent and the principal, along with the support of the Board, litigation in this matter

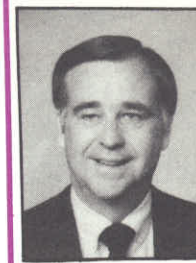

WEIGHT LIFTING

This is another in an on-going series of orientation questions which deal with various aspects of CIF Southern Section rules and at times may cause confusion due to its uniqueness.

QUESTION:

What is the rule with regard to weight lifting programs during or after school hours and the association of a coach with students having remaining eligibility?

ANSWER:

In that weight lifting is not an approved CIF sport, there is no violation if a coach associates with students having remaining eligibility for the purpose of a weight program during school and/or a general running or conditioning program.

Any violation would occur if the association is extended beyond this point and is so noted under the various sport sections of the Blue Book whereby a coach would attempt to teach skills or any phase of the game with potential team members. Examples would be a stance for linemen in football, the presence of a basketball outside the school day, etc.

Our Office receives a number of calls in this area and would appreciate your review of Rule 310 and 311 with your staff.

NEW QUALIFYING STANDARDS SET FOR EIGHT-MAN FOOTBALL PLAYOFFS

The following eight-man football playoff format was adopted by the principals of schools involved in eight-man football at a meeting conducted Tuesday, March 13, 1990 at the CIF-SS Office.

1. All eight-man schools will be requested to provide to the Southern Section, their enrollment figures as of October 1 of the current playoff year. At that time, schools will be divided into large and small divisions, depending upon their enrollment.

The top 1/3 will be placed in the large division and seeded in an eight-team bracket. The remaining 2/3 schools will be placed in the small school bracket, consisting of a 16-team draw.

2. Small schools will have the option of moving into the large school division and the request for same must be made when submitting the October 1 enrollment figures. If a school requests to move up, they will be considered a large school, thus affecting the 1/3-2/3 split.

3. All league champions will be guaranteed entry into the playoffs. Guaranteed entries will only be accepted from leagues where members have **PLAYED** at least three (3) league contests (forfeitures will not be accepted).

Leagues that do not participate in three league contests will become free-lance teams.

4. Eight teams or more in a league will be guaranteed two entries. (Must

CIF SOUTHERN SECTION COUNCIL MINUTES

March 15, 1990

The March meeting of the CIF Southern Section Council was called to order by President Dr. Tom Jacobson at 9:30 a.m. on Thursday, March 15, 1990 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Condor, San Andreas, Valley, Victory and Westside Leagues.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of January 13, 1990 as mailed to the Council; the minutes of the CIF-SS Council meeting of January 18, 1990 as mailed to the Council; and the minutes of the CIF-SS Executive Committee meeting of February 22, 1990 as distributed to the Council.

2. PRESIDENT'S UPDATE - President Dr. Tom Jacobson provided an update on the recent illness of past-president and former principal of Los Altos High School, Pat Mauch; the winter playoff activities; the success of the Athletic Administrators Symposium; and recent hearings and legal matters affecting the Section.

3. COMMISSIONER'S UPDATE - Commissioner Stan Thomas reviewed with the Council league visitations and the Southern Section officials' assigning program, stressing the importance of submitting (by school athletic directors) complete and accurate schedules to the assigning authority. Records indicate that during the fall and spring, there were far too many changes after schedules were submitted.

4. TREASURER'S UPDATE - Treasurer Ken Gunn reviewed background information and the proposed Southern Section budget for the 1990-91 school year. This is a non-action item and will be voted on at the April 26, 1990 Council meeting.

5. WINTER SPORTS UPDATE - Associate Commissioner Dean Crowley (basketball), Administrator Bill Clark (wrestling) and Administrator Karen Hellyer (soccer) reviewed with the Council the winter sport playoffs.

Additionally, George Giokaris, Freeway League Representative, addressed the Council regarding the violence in high school athletics and the course of action that is being contemplated by member schools in the Freeway League.

6. STATE CIF REPORT - Dr. Robert Packer, President-elect of the State Federated Council, reviewed items from the last State CIF meeting which included the 1990 football rules update; a report on anabolic and androgenic steroids; progress of the School Properties contract; negotiations and update on a proposed consortium between Sections to develop marketing and corporate support strategies for the Sections. Additionally, Dr. Packer encouraged support of the California State Athletic Directors Conference to be held in Burlingame April 19-22.

7. AMATEUR ATHLETIC FOUNDATION REPORT - Keith Cruickshank of the Amateur Athletic Foundation reviewed with the Council the CIF-SS Effective Coaching Program.

8. AQUATICS UPDATE - Administrator Bill Clark reviewed with the Council regulations pertaining to a change in the Health and Safety Code (Section 24100.3). It should be noted that the provisions of this bill (aquatics certification) recently adopted by the State Legislature will be implemented in January of 1991.

9. OUTSIDE COMPETITION RULE - President-elect Gary Smidderks reviewed with the Council rule 600 (outside competition). It is being proposed that By-law 600 regarding

students' participation in outside competition during the season of sport be removed from the State CIF Constitution and By-laws. This is a non-action item and will be voted on at the April 26, 1990 meeting of the CIF-SS Council.

10. AMENDMENT TO ARTICLE 7 - Executive Committee representative Fr. William Brelsford, representing the Catholic Athletic Association, presented a proposed amendment to Article 7, Section 70.5 limiting geographic representation on the Southern Section Executive Committee to no more than two individuals. It should be noted that all present members on the Southern Section Executive Committee would be permitted to complete their current term of office. This is a non-action item and will be voted on at the April 26, 1990 meeting of the CIF-SS Council.

11. SIERRA LEAGUE FOOTBALL OFFICIAL PROPOSAL - Mr. Ben Furuta, Principal of West Covina High School and President of the Sierra League, presented a proposal making the fifth official in the sport of football optional rather than mandatory. This is a non-action item and will be voted on at the April 26 meeting of the CIF-SS Council.

12. AREA PLACEMENT CRITERIA - Clark Stephens, Chairperson of the Area Placement Committee, presented a proposal dealing with specifics in the process and criteria for area placement - under article 3 of the CIF-SS By-laws. This is a non-action item and will be voted on at the April 26 meeting of the CIF-SS Council.

13. NOMINATING COMMITTEE REPORT - Mr. Jim Douglas, Chairman, reviewed recommendations for representatives on the CIF-SS Executive Committee. The following names were placed in nomination:

This is a non-action item and will be voted upon at the April 26, 1990 meeting of the CIF-SS Council.

14. STATE CIF REPORT - Dr. Robert Packer presented the following items which will be agenda items at the May State CIF meeting, thus requiring action by the Southern Section Council at its meeting of April 26, 1990 in order to give Southern Section delegates voting direction:

(A) **APPEALS AND DELEGATE POWERS:** The CIF general counsel and Executive Committee is recommending a language change to differentiate types of appeals and to expedite the business of the organization. The new language deals with appeals and delegate powers - Article 11, section 1100 of the State Constitution and By-laws.

(B) **STATE CIF PROPOSED BUDGET:** The State CIF budget recommends funda-

mentally the same format and approach as used for the 1989-90 budget. The State CIF budget comes as a recommendation of the State CIF Executive Committee for the 1990-91 school year.

(C) **MODIFICATION OF BY-LAW 905:** The modification of this By-law will bring the State Constitution in line with Rule 900 which now allows for limited participation in all-star basketball games. The purpose of this proposal is to clean up the language in order to provide consistency with State Rule 900.

(D) **WRESTLING AWARD:** The Wrestling Advisory Committee is recommending that in addition to the team trophy now presented in wrestling, an award be presented to the leading team with an enrollment under 1000 in an effort to recognize lower division schools, since there are no divisions in wrestling.

(E) **TRACK AND FIELD AWARD:** As in wrestling, it is recommended that in addition to the team trophy now presented in track and field, an award be presented to the leading team with an enrollment under 1000.

(F) **MODIFICATION OF RULE 604:** This modification is presented in order to clarify language (definition of "Olympic Development") and bring the State CIF in line with National Federation rules and regulations.

(G) **MODIFICATION OF WRESTLING BY-LAW 1702 (a):** This proposed modification is a change in the wrestling weigh-in procedure with reference to weigh-in calendar dates and competition. It should be noted that the present rules are to close to Christmas without a growth allowance, and the new proposal allows time for proper conditioning and nutritional preparation prior to weight certification.

(H) **WATER POLO RULE CHANGE:** This proposal, if approved, would be forwarded to the National Federation Swimming and Diving Rules Committee recommending modification of the present rule in order to permit water polo coaches, at appropriate times and in an appropriate manner, to converse with water polo officials during the course of the contest. It should be noted that if this is approved by the State CIF, it will be a recommendation only to the National Federation Rules Committee.

(I) **MODIFICATION OF STATE BY-LAW 505:** This proposed modification of By-law 505 would strike the words "football" and "wrestling" and add "all sports" to the by-law. If passed, it would allow no participation unless the players on such teams meet the age requirements of the California Interscholastic Federation. It should be noted that if passed at the State level, this would eliminate alumni contests which are presently provided for in Southern Section Rules and Regulations.

(J) **AD HOC BROADCAST REVIEW COMMITTEE:** This recommendation, if approved, will create a State broadcast review committee which will conduct research, review agreements and seek legal advice for policy development.

(K) **COACHING EDUCATION PROGRAM:** The purpose of the Coaching Education Program will be to provide uniform

CHERYL MILLER IS CIF-SS's FIRST IN NATIONAL HALL

Former Riverside Poly High School basketball great Cheryl Miller has been included with 14 individuals selected for induction into the National High School Sports Hall of Fame.

The 1990 class is the eighth group to be inducted into the National High School Athletic Hall of Fame, which was founded by the National Federation of State High School Associations in 1982. The Hall is housed at National Federation headquarters in Kansas City, Missouri.

Miller, the CIF Southern Section's first inductee, became one of just three Californians to be enshrined, joining Rafer Johnson of Kingsburg High School (also inducted this year) and Bob Mathias of Tulare High School (inducted in 1989).

Miller is one of the most decorated women's high school basketball players of all time. In four years of varsity competition, she scored 3,446 career points (ranking No. 1 all-time in the CIF-SS, fourth nationally) and pulled down 1,620 rebounds (second all-time in the CIF-SS, third nationally). Her contributions led the Bears to a 132-4 record -including an 84-game winning

istrators, Pep Squad Advisors, Pep Squad members Student Leadership Representatives, Booster Club Representatives, and Community Representatives. The purpose of the workshop will be to review their roles and responsibility as it pertains to 1) positive role models; 2) understanding and recognizing the code of ethics and regulations under which we operate inter-scholastic sports.

II. The following statements will become bylaws in the Freeway League Constitution and will be implemented on March 21, 1990.

A. If, during an athletic contest, league or non-league, any athlete who physically assaults a coach, game official or school official will be suspended from athletics for one calendar year from the date of the infraction.

B. If, during an athletic contest, any athlete actively competing

streak- and four consecutive CIF Southern Section titles. Her 105-point performance in a single game during the 1981-82 season stands as a national record.

Miller added two more championship trophies at the University of Southern California, as the Lady Trojans collected two NCAA titles during her four-year collegiate career. The all-time leading scorer (3,018 points) and rebounder (1,534 rebounds) at USC, she was a four-time consensus All-American and three-time national player of the year. She was also a two-time winner of the Broderick Award, as well as a three-time Pacific-10 Conference MVP. She is the first and only USC basketball player -male or female- to have her jersey number retired.

The highlight of Miller's amateur career came in 1984, when she was the leading scorer for the U.S. Women's gold medal-winning Olympic basketball team.

Currently, Miller is an assistant women's basketball coach at USC, in addition to working as a national network television and radio sports commentator.

in the contest is involved in an altercation or is ejected from the contest will be automatically suspended from the next contest.

C. Any athlete who leaves the "bench/sidelines" to go on the playing area during an altercation will be automatically suspended from the next contest.

III. Two proposals regarding coaches are referred to the Athletic Directors for review, study, and recommendation. The proposals will become action items at our next Freeway League meeting.

A. In the sport of basketball, coaches are required to sit on the bench except before the contest and during official time-outs.

B. In any sport, if a coach is removed from the game by an official, that coach will be suspended from coaching the next contest.

mity in training throughout the State. Certification of the coaches will be the responsibility of the school districts and participation in the program would be voluntary. It should be noted that the statement of intent and recommended minimum standards with reference to the coaching education program, as presented by consultant Larry Rice, was tabled by the State CIF until the May meeting.

15. BLUE BOOK COMMITTEE PROPOSAL (SOUTHERN SECTION ARTICLE 3, SECTION 31) - Jim DeLong, a member of the Blue Book Committee, reviewed with the Council a proposed change to Article 3, Section 31 of the CIF-SS by-laws. The proposed change would give voting rights and membership in the Council to superintendents, principals and assistant principals only. A motion to amend the proposal to add "school site administrator" was approved. Following discussion, the proposed amendment to Article 3, Section 31, including the addition of "school site administrator", was defeated.

16. AT-LARGE EXECUTIVE COMMITTEE MEMBER - President Dr. Tom Jacobson reviewed with the Council, communication from the Executive Committee with reference to an At-large Executive Committee member. It should be noted the deadline for leagues to submit their nominations must be made to the CIF Southern Section Office prior to the April 26, 1990 meeting of the CIF-SS Council. The following individuals were nominated from the floor:

SOUTHERN SECTION SCHOOLS WIN
FIVE STATE BASKETBALL TITLES

The CIF Southern Section enjoyed its best-ever performance in the 1990 CIF/Reebok State Championship Basketball Tournament, qualifying a record 39 teams for entry, winning nine of the possible 10 boys and girls Southern Regional titles and collecting five state championships.

In boys competition, Southern Section schools won four of the five state championships. Mater Dei of Santa Ana captured its second Division I crown with a 62-60 win over San Francisco Riordan. Coach Gary

McKnight's Monarchs (34-1) earned the trip to Oakland by defeating Southern Section 5-AA-champ Long Beach Poly, 46-45, on guard Jason Quinn's miraculous 3-point buzzer-beater in the Southern Regional final. Mater Dei also defeated North Hollywood, 76-74, and L.A. Manual Arts, 72-64, in state tournament play.

In Division II, Artesia High of Lakewood cruised to its first-ever state championship with a 57-50 win over Sunnyvale Freemont. Led by center Ed O'Bannon, Coach Wayne Merino's Pioneers (29-2) defeated Visalia Golden West, 65-36, Oceanside El Camino, 74-70, and Southern Section 4-AA-champ Glendora, 57-44 to reach the state final.

Although finishing fourth in its league and runner-up to Estancia for the Southern Section 3-AA Division crown, Anaheim Servite battled its way to the State Division III title with a 67-51 win over Hayward Mount Eden. Coach Richard Smith's Friars (21-11) earned the trip to Oakland with regional playoff wins over Lemoore, 57-55, Corona del Mar, 67-65, and CIF-SS 3-A-champ Dos Pueblos, 46-29.

Santa Clara High of Oxnard won its second-straight Division IV title under veteran Coach Lou Cvijanovich, with a lopsided 56-38 win over Travis AFB Vanden. Behind the play of Shon Tarver, the undefeated Saints (28-0) steam-rolled Imperial, 67-37, Laguna

NATIONAL FEDERATION ANNOUNCES FOOTBALL RULE REVISIONS FOR 1990 SEASON

Although several important rules were changed for the 1990 season by the National Federation Football Rules Committee at its January 5-6 meeting in Tucson, Arizona, the committee was more concerned about the state of safety and sportsmanship in high school football in the United States.

Because the number of catastrophic injuries continues to rise in high school football, despite years of emphasizing safety, the committee strongly emphasized that safety and sportsmanship must be top priorities in the coming season.

"The committee definitely was as concerned about these two points of emphasis as it was about the actual rules changes," said Dick Schindler, assistant director of the National Federation and editor of the high school football rules. "School personnel, coaches, officials, players and fans must take these two issues seriously for the sport of high school football to continue to be a vital part of interscholastic athletics."

Regarding general safety, special emphasis will be given to illegal helmet contact, late hits, out-of-bounds contact and roughing the passer. In the

sportsmanship area, the committee was extremely concerned about increased baiting and taunting between opponents and reports of increased acts of unsportsmanlike conduct.

Among actual rules changes adopted by the committee, some of the more significant are three dealing with conferences between coaches and players during a game.

Beginning with the 1990 season, the entire team may confer with coaches within five yards of the sideline during charged timeouts and intermission between periods. In addition, players may go near the sideline between downs to communicate with coaches; however, these conferences must be completed in the normal time span between downs.

Previously, only one player could come to the sideline during a timeout or between periods. As in the past, a coach may still elect to go on the field to confer with players rather than the players coming to the sideline.

The committee also approved one additional time for conferences during a game. A conference may be held after the down which precedes a kickoff, i.e., after a scoring play. As is the case with the above examples, players

may come to the sideline or the coach could huddle with players on the field.

"The time after a score is a logical time to communicate with players," Schindler said. "All of these changes are less restrictive, will improve communication between players and coaches and will not lengthen games. It was becoming difficult to administer all the restrictions we had in the rules."

In a major equipment change, the committee approved the use of a visually enhanced football with longitudinal striping. The ball has either white or yellow continuous striping that runs near and parallel to each side of the seams.

The committee approved the use of this football as an option after experimentation last year in nine states revealed many positive aspects, such as better visibility for officials, players and spectators, especially during night games and when lighting is poor.

Schindler said that the regular striped ball remains legal and that schools may elect to use either ball.

Another equipment change that takes effect next season concerns jersey numerals. Rule 1-5-1 will allow two, one-fourth-inch borders around the numerals instead of one. The borders must be different colors, and one of the borders may be the same color as the uniform. The numeral still must be a contrasting color to the jersey.

Two changes were made in penalty enforcement. Because of an increase in intentionally roughing the kicker or holder on extra-point attempts, the offensive team now will have the option, on a successful kick try for point, of taking the results of the play and enforcing the penalty on the kickoff or enforcing the penalty on the try with a replay.

Previously, the offensive team did not have the choice of enforcing the penalty on the kickoff. It simply had to take the play or enforce the penalty on the try and replay it.

The other penalty-enforcement change eliminates an exception in the basic penalty code. As is the case with all other loose-ball play infractions, enforcement of the penalty for fair-catch interference will be enforced from the previous spot rather than the spot of the foul.

In another safety-related change, the holder on a free kick, i.e., kickoff, will

July, Westminster High School in September-October and La Serna High School in Whittier in October-November. A total of 159 coaches from 86 high schools took part, 123 of whom completed the four-day course, which consisted of 30 hours of classroom and on-field instruction. What was unique about the program was that each of the coaches was paid a \$200 participation fee, thanks to the financial commitment of the AAF.

"Overall, the dry run (pilot study) proved the program to be very effective," added Stolley. "We remodeled the clinic format for the second and third sessions via feedback from the coaches and naturally, we felt the third session was the best."

Evaluation of the pilot study was based on the perspectives of a sampling of participating coaches in the following areas: 1.) Factors that motivated participation; 2.) Benefits to the coaches; 3.) Benefits generated to student-athletes; 4.) Benefits to the organized sport of soccer on campus;

5.) Value of such a program as a CIF Requirement.

The findings of the evaluation have been viewed as very positive. For example, 71 percent of the participating coaches surveyed had not attended any kind of soccer coaches clinic or any program of this caliber. The three most pronounced factors motivating coaches to participate in the program were to learn more about the sport and pick up new game techniques (50%); to improve oneself as a coach (43%); and to learn and hear from a very high-caliber of resource persons on the program slate (36%). Only a very small percentage (7%) were particularly motivated by the AAF's \$200 incentive, showing that improvement in performance, and not compensation for time invested was the foremost motivation of the coaches in participation.

"I don't think there is, or has ever been a program of this type and of this quality anywhere else in the country," pointed out CIF-SS Commissioner of Athletics Stan Thomas. "Both the Amateur Athletic Foundation and the CIF Southern Section are to be com-

mended for pioneering such a progressive and innovative program. It will put Southern California on the cutting edge of coaching education, providing high school coaches with the opportunity to receive exemplary instruction from the best people possible."

The Amateur Athletic Foundation, a legacy of the 1984 Los Angeles Olympics, is committed to benefit youth sports in Southern California by extending grants to fund existing youth sports programs; by creating and funding its own programs, such as the AAF/CIF-SS Partnership for Coaching Education; and by operating the nation's largest and most up-to-date sports resource center. Located at 2141 West Adams Boulevard in Los Angeles, the resource center includes an extensive sports library, including research materials, periodicals and the world's largest collection of sports instructional films. The center is available for unlimited use by coaches, athletes and members of the media. Currently, the AAF is involved in the operation of over 200 programs to benefit youth sports.

be afforded the same protection as the kicker. Henceforth, the receiving team cannot block the kicker or holder until the kicker or holder has advanced five yards beyond the free-kick line or until the kick has touched the ground or any other player.

Another kicking-situation change allows the kicking team to bat a grounded scrimmage kick away from the opponent's end zone. This will permit the kicking team to execute an exciting technique to keep the ball out of the opponent's end zone.

To be consistent with a number of other sports, the committee added Rule 1-3-9 to prohibit officials from using any television monitoring or replay equipment to make any decision

relating to the game.

"The committee agreed that to open high school football up to instant replay would create more problems than it would solve," Schindler said.

Following are other changes passed by the committee:

* A single-color, plain towel is the only uniform adornment that will be permitted. This rule prohibits the use of streamers, bandannas or anything other than a towel. Schindler said the towel cannot have any marking, writing or insignia on it whatsoever.

* In-bounds lines (hash marks) should be 24 inches long and four inches wide. The rules never had identified the dimensions of these marks, and the 24 x 4 marking is the same as used on college and professional fields.

* Support wrap that is not hard or

abrasive may be used on the hand, wrist or forearm to protect an injury if the material is not hard in its final form. Support wrap will be added to tape and bandage in Rule 1-5-3.

In addition to safety and sportsmanship, the committee added "starting each half promptly" as a third point of emphasis. The committee urged game administration to clear the fields promptly before the game and after half-time activities to ensure that both halves start on schedule.

More boys participate in football than any other high school sport. In 1988-89, a total of 951,699 boys participated in football in 13,993 schools.

or co-champions. If this is not accomplished in competition against non-section opponents, the non-section opponent will be considered a small school.

The determination of the power point ranking will be done by totaling power points and dividing by the number of games. Schools will be ranked in order, using this mathematical equation. Forfeitures will not count as a game or for points.

The ensuing playoff draw will be determined by the Southern Section Office, as it has been in the past.

- 1-2-3c Dimensions of inbounds lines are 24 inches long and 4 inches wide.
- 1-3-1c A ball with continuous 3/8 inch white or florescent yellow stripes parallel with, and on each side of the seams may be used.
- 1-3-9 Officials may not use television or replay equipment to make any game decision.
- 1-5-1 The jersey numerals may have two 1/4 inch borders, one of which may be the jersey color.
- 1-5-3 b,e Additional guard and brace materials added to list of those illegal if hard in final form and support wrap legalized if nonhardening, nonabrasive and used to protect an injury.
- 1-5-3o A single color plain towel is only uniform adornment permitted.
- 2-5 Authorized conference also permitted following the down which precedes a free kick, and the entire team may go to within 5 yards of the sideline.
- 6-5 Pen. The distance penalty for fair catch interference may only be enforced from the previous spot.
- 8-3-5; If B fouls during a successful try, the penalty may be enforced from the succeeding spot.
- 10-5-2
- 9-3-3 The placekick holder on a free kick is given the same protection as the kicker.
- 9-7-3 K may bat a grounded scrimmage kick toward K's goal line.

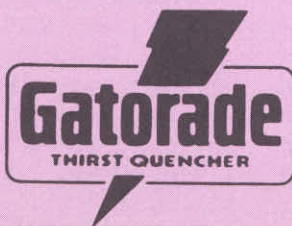
