Entries & Classification

None of the players on the team may have been ranked in the top 150 in the SCTA rankings for the past two years. The Tournament Committee reserves the right to disqualify any player for any reason. Each team will consist of 9 players. Each school will be guaranteed to compete in 3 tennis matches.

Format

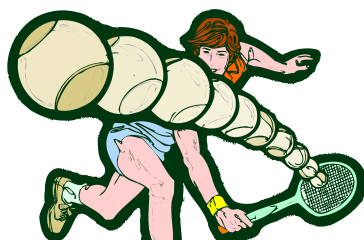
This is a dual match team tournament. Each team will have 3 singles players and 3 doubles teams. Each member of the team will play the corresponding player from the other team. #1 vs #1, #2 vs #2, and #3 vs #3. Each match will be a 8 game proset, with a set-tiebreak at 7-7. The winner will be the team winning the most matches, if still a tie then most games won. (Detailed rules to be sent with match times)
