Burbank edged Arroyo to capture the AAAA cross country title Nov. 28 at Cal State Long Beach in the CIF, SS championships, run over a two-mile course under overcast skies and under cool breezy conditions.

Lompoc, with sophomore Terry Williams coping individual honors at 9:39.5, captured the AAA title; San Marino edged Rio Hondo League rival La Canada 49-77 for the AA crown and St. Bernard, recording the lowest point total of the day, 43, took the A championship, and Chris Hoffman, the Vikings' ace runner, successfully defended his individual title with a 9:42.6.

Individually, Lakewood's Larry Greer toured the course in a record 9:29.5 outdistancing the other AAAA finishers by nearly 10 seconds.

Burbank got third and seventh place finishes from Scott Schweitzer and

Mark Kushner toward its team victory. Arroyo was paced by Richard Walker's second place finish in 9:39. Third place North (Torrance) was led by Don Barbray's 9:47 for fourth.

Lompoc's Williams bested Gordon Innes of Upland, who had recorded the best prelim time, as the Braves won their second straight title (they captured the AA race when the championships were run in three divisions last year). Larry Hildenbrand (fifth) and Roger Hansen (10th) also placed high for the champions. Palos Verdes edged Rancho Alamitos 97-100 in the

dogfight for second.

San Marino also won for the second consecutive year, this time in AA, topping league foe La Canada. Rowland's David Caldera scored a comfortable victory over Ivan Porto of San Marino in the race.

St. Bernard, second to San Marino a year ago, won a divisional diadem this year. Hoffman and Tom Razzeto were the only finishers in the top 10, but none of the St. Bernard runners finished lower than 22nd. Webb's Denis Cuff finished second to Hoffman.

FRONTIER LEAGUE PULLS TEAM FROM GRID PLAYOFFS

Violation of a long-standing Frontier League rule by two of the league's teams resulted in the two schools being declared ineligible for the football championship and for entry into the CIF, SS, A playoffs.

The CIF football playoff selection committee had reserved positions for two of three teams involved in a Frontier League three-way tie for second place behind champion Agoura. Santa Clara and Santa Paula were selected by the league as representatives, but a subsequent league investigation revealed that both Channel Islands (the third runner-up team) and Santa Paula were guilty of obtaining football films of other league teams' games for scouting and practice purposes, a practice that is illegal in the Frontier League.

No forfeitures were invoked, according to league secretary George Mataisz, athletic director at Nordhoff High School, and the result was that only Santa Clara of the three tied for second, was eligible for the playoffs.

Only two days before the first round, the CIF Executive Committee, learning of the ruling during its regular meeting, agreed that if another representative team wanted to participate, it should be given the chance to do so. Fillmore, the Tri-Valley League runner-up, and a team which received strong consideration in the original selection meeting, agreed to play, and lost a hard-fought 14-8 decision to unbeaten St. Genevieve, with only two days preparation.

That effort deserves a tip of the hat to coach Bruce Dempsey of Fillmore and his players.

BRETHREN COPS SIX-MAN CROWN

Brethren High of Paramount is the 1970 CIF, SS six-man football champion after a convincing 45-18 victory over Cuyama Valley at Santa Maria High School Nov. 27.

The Warriors, Academy League champions, completed a fine 11-0 season with the win. It was the first CIF title for Brethren since the school switched to the six-man system six years ago. Last season, Brethren lost the championship game to Ambassador.

It was tailback Bruce Levert, who once again paced the Warrior fortunes. The fleet senior scored touchdowns on runs of 58, 49, 31, 20 and two yards to hike his season TD total to 32. Levert ended with 2,048 yards rushing in 11 games.

Junior Mike Wrigley scored twice for Brethren, which grabbed a 32-6 halftime lead over the Tri-Country League co-champions.

Quarterback Bill Dykes led the losers, throwing touchdown strikes of 50 and 23 yards to Mike Jackson and scoring one himself on a seven-yard run.

MINUTES OF MEETING OF CIF, SS, EXECUTIVE COMMITTEE November 19, 1970

The November meeting of the CIF, Southern Section, Executive Committee was called to order by Chairman Steve Miletich at 1:00 p.m. on Thursday, November 19, 1970, at the CIF Office.

The following members were in attendance: Chairman Miletich, Vice-Principal, Beverly Hills High School; Donald Cogswell, President of Southern Section Council, Vice-Principal, Mira Costa High School; Keith Lee, Treasurer of Southern Section Council, Principal, Yucca Valley High School; Alex Alexander Assistant Superintendent, Desert Sands Unified School District; Tony Balsamo, Principal, Apple Valley High School; Ferren Christensen, Principal, Westminster High School; Richard Cordano, Principal, Arcadia High School; James Faul, Principal, Workman High School; Msgr. Thomas Kiefer, Principal, Bishop Amat High School; and Commissioner of Athletics, J. Kenneth Fagans, and Thomas Morgan, Administrative Assistant, CIF, Southern Section.

1. APPROVAL OF MINUTES. It was moved, seconded, and passed to approve the minutes of the regular Executive Committee meeting of September 19, 1970, as published in the October, 1970, Monthly Bulletin, and of the special Executive Committee meeting of September 26, 1970, as published in the November, 1970, Monthly Bulletin.

2. APPLICATION FOR MEMBERSHIP. It was moved, seconded, and passed to approve the application for associate membership in the CIF, Southern Section, effective immediately, for Imogene Garner Hook Junior High School of Victorville.

3. PIONEER LEAGUE REQUEST FOR CHANGE IN BASEBALL PLAYOFF GROUPING. The Pioneer League requested permission from the Executive Committee to be changed from the "AA" to the "AAA" division of the 1971 CIF, SS, baseball championship playoffs. It was moved, seconded, and passed to approve this request after the committee was informed that such a move would not cause any imbalance in the playoff groupings.

4. TRACK MEET REQUEST, GLENDORA HIGH SCHOOL. The Executive Committee reviewed a request from Glendora High School for permission to sponsor two simultaneous triangular track meets involving six schools on February 26, 1971, as opposed to having to sanction such an event as an invitational meet in accordance with Section XXI (Invitational

Tournaments and Sanctioned Events) of the CIF, SS, Blue Book. This request was based on the premise that this type of meet would help stimulate attendance and interest in interscholastic track and field competition and allow for two meets to be conducted at little or no increase in expense over that of a single meet. The committee took no official action on the matter, indicating that this event would be acceptable if it were conducted as two separate triangular meets. The committee asked that Glendora High School submit a report following the conclusion of the event in order to have the benefit of an evaluation of the success of such a meet available for future reference.

5. VIOLATIONS BY SOUTHERN CALIFORNIA CHRISTIAN SCHOOL. The Executive Committee was informed that Southern California Christian School had been suspended from membership in the Prep League for the period of the 1970-71 school year for repeated violations of CIF, SS, eligibility regulations. After carefully reviewing the information presented, the committee moved, seconded, and passed to fully endorse the actions of the Prep League in this case, and to state that any further violations of rules by Southern California Christian School would result in suspension from the CIF, Southern Section. The school will compete as a free-lance CIF, SS, member during the current year. The committee also moved, seconded, and passed that Southern California Christian School cannot participate in any CIF, SS, post-season championship activities while under suspension of the Prep League, and requested the Commissioner of Athletics to inform the school that eligibility lists for all sports this year should be submitted to the CIF Office in order to ascertain their validity.

6. CLARIFICATION OF EXPONENT COMPETITION, FOOTBALL. San Marino High School asked the Executive Committee for an interpretation of paragraph 8, Section XXXVIII (Exponent Classification) of the CIF, SS, Blue Book in order to determine whether it would be permissible for a Class B "reserve" team to compete against a Class C team in the sport of football. The committee moved, seconded, and passed to inform San Marino that such a game would not be possible, reaffirming that the intent of paragraph 8 is to maintain competition within exponent classifica-

tions for the sports of football, water polo, and basketball. It was suggested that a team consisting only of the freshman and sophomore members of the Class B "reserve" squad could schedule a game as a frosh-soph team against a Class C team by mutual agreement of the principals of the two schools.

7. BASEBALL RULES. Two contradictions currently exist between Section XXXX (Baseball Regulations) of the CIF, SS, Blue Book and the National Federation Baseball Rules Book. CIF, SS, baseball competition is governed basically by National Federation rules, so in order to bring these regulations into alignment the Executive Committee moved, seconded, and passed to recommend to the Council that the following by-laws changes be considered for action at its January meeting:

a) Eliminate paragraph 7 of Section XXXX of the Blue Book regarding the length of an official regulation game; Rule 4, Article 4 of the National Federation rules stipulates that it is a regulation game if 5 or more full innings have been played, or if the team second at bat has scored an equal or greater number of runs in 4 or 4 and a fraction terms at bat than the opponent has scored in 5 terms at bat.

b) Replace paragraph 9 of Section XXXX of the Blue Book, referring to tie games, with the following: A regulation called game with a tie score shall be counted as 1/2 game won and 1/2 game lost for each team. National Federation rules state that regulation tie games are not to be continued or replayed at a later date and will not be counted in computing won-lost percentages unless the special "1/2 game won—1/2 game lost" option is adopted by the state association, as recommended above.

c) It is further recommended that these by-laws changes become effective for the 1971 baseball season.

8. WORKMAN'S COMPENSATION. Commissioner Fagans informed the Executive Committee of the current status of the problem of Workman's Compensation insurance coverage with respect to officials assigned to high school athletic contests. He indicated that the CIF, SS, has been enjoined in a court suit involving this matter scheduled for January, and that the question of who is considered to be the employer of these officials has not been clearly answered as of the present time. He will continue to keep the committee and all member schools apprised of any further developments.

1971 FOOTBALL PRACTICE SCHEDULE

The start of fall football practice will once again return to the Tuesday following Labor Day for the 1971 season.

All CIF, Southern Section, member schools may begin their organized practice sessions on Tuesday, September 7, 1971. In accordance with this date, the following schedule will be in effect:

Pre-Practice Conditioning Period — August 30 through September 3

First Day of Organized Practice — Tuesday, September 7

Inter-school Scrimmage or League or District Carnival — Saturday, September 18

First Game — Weekend of Friday, September 24

CIF Playoffs — November 26, December 3-10-17

9. VIOLATIONS BY NOTRE DAME (RIVERSIDE) HIGH SCHOOL. Mr. James Hoxie (California School for the Deaf), President, Arrowhead League, Mr. Russell Reynolds (Big Bear High School), representative to the CIF, SS, Council, Arrowhead League, and Father R. Duffy, Principal, Notre Dame (Riverside) High School, appeared before the Executive Committee to explain possible violations of CIF, SS, regulations by Notre Dame High School. Specifically in question were the following charges: 1) That Notre Dame High School has been operating under a multiple-campus situation with one principal in conjunction with the Divine Word Seminary of Riverside without officially notifying the Arrowhead League or seeking approval for interscholastic eligibility from the CIF, SS; and 2) That Notre Dame High School violated paragraph 21(a) of Section XXXXIII (Football Regulations) of the CIF, SS, Blue Book by not conducting its pre-practice conditioning program at the school's regular practice field. The Arrowhead League had originally considered these charges, but then voted to refer the matter to the Executive Committee for clarification of the multiple-campus situation involved prior to taking any action.

Father Duffy explained that Notre Dame has been operating as a multiple-high school campus in conjunction with Divine Word Seminary for many years, but that he was unable to find any evidence of previous correspondence with the CIF, SS, Office concerning this matter. He had assumed, prior to this time, that the CIF was aware of this situation. He further explained that Notre Dame had conducted its pre-practice conditioning program at the football field at Divine Word Seminary, assuming that the Seminary was considered to be part of the Notre Dame campus and not being aware that such a practice area would be in violation of CIF, SS, rules.

The Executive Committee thanked the personnel involved for their ap-

pearances and complete cooperation in this matter; the guests were excused and the committee reconvened in executive session.

After considerable discussion, it was moved, seconded, and passed to: 1) Declare that Notre Dame High School has technically been in violation of the interpretation of the multiple-campus rule as established by the CIF State Federated Council, but that the Executive Committee would recommend no disciplinary action because of the nebulous nature of the existing rule. It was further recommended that Notre Dame immediately submit a letter to the CIF, SS, in order to clarify this situation and officially approve the interscholastic eligibility of those students from Divine Word Seminary at Notre Dame High School; and 2) Inform the Arrowhead League that the committee is of the opinion that there has been a violation of rules by Notre Dame High School for not holding its pre-practice conditioning program at its regular practice field, and to recommend this matter to the league for subsequent action as it may see fit.

10. CROSS COUNTRY RULES. The Executive Committee expressed concern over the fact that it had been reported that some individuals had entered two cross country races in the same day during CIF, SS, competition. The committee moved, seconded, and passed to recommend to the Council that the following by-law be considered for addition to Section XXXXII (Cross Country Regulations) of the CIF, SS, Blue Book at its January meeting: An individual may compete in only one cross country race in any one day.

11. FOOTBALL REQUEST, BARSTOW AND KENNEDY HIGH SCHOOLS. The Executive Committee reviewed requests from Barstow and Kennedy (Barstow) High Schools for permission to begin practice for the 1971 football season one week earlier

than allowed by Section XXXXII (Football Regulations) of the CIF, SS, Blue Book because of contracts which have already been signed for games on September 17-18, 1971, against Las Vegas high schools. The starting date for practice for 1971 will be the day after Labor Day, Tuesday, September 7, which would mean that the first interschool game may not be played until the weekend of September 24. However, these two schools had negotiated these contracts under the assumption that the fall practice schedule for next year would be the same as during the 1970 season when an exception was made to regular rules and practice began one week earlier than normal for all teams. The committee moved, seconded, and passed to deny this request, stating that these contracts had been signed in violation of CIF, SS, regulations. The committee pointed out that the above-mentioned exception to the football practice schedule for 1970 was publicized as being for one year only, and further suggested that schools should check with the CIF Office prior to negotiating contracts if they are ever in question as to starting dates for football or other sports.

12. APPLICATION FOR PARTICIPATION BY GIRLS ON BOYS' GOLF TEAMS. Attorneys Mr. Don Powars and Mr. Don Wallace appeared before the Executive Committee to appeal for girls to be allowed to participate on boys' golf teams for CIF, SS, interscholastic competition. They were acting in behalf of Miss Ann Wallace and Miss Nancy Wallace of Long Beach Poly High School and Miss Laura Baugh of Long Beach Wilson High School. This application was based on the premise that many girls could compete equally with boys in several CIF-sponsored sports, and it was therefore requested that girls be allowed to compete on boys' golf teams on a limited trial basis for the 1970-71 school year in order to determine the effectiveness of such a proposal. The committee advised the representing attorneys that State CIF rules would prohibit approval of such a request, and then moved, seconded, and passed to deny the application for girls to be able to participate on boys' teams in CIF, SS, competition.

13. GIRLS' ATHLETICS. The Executive Committee discussed a letter which had been received from Joanne Kellogg, President, Orange County Women's Physical Education Association, concerning girls' swimming seasons. Miss Kellogg pointed out the fact that most girls' swim teams find

KNOW YOUR BLUE BOOK

QUESTION: Can a high school boy be paid for officiating in any sport without jeopardizing his interscholastic eligibility?

ANSWER: Yes, he can officiate for pay under the following conditions:

- (1) If the team players are age 17 or under;
 - (2) If the game is not an interscholastic contest for students;
 - (3) If the total reimbursement does not exceed \$5.00 per contest.
- (Reference: CIF, SS, Blue Book, Section XVI (Amateur Rule), Paragraph 1 (J), Page 28)

problems in scheduling the use of facilities at their schools because of the short period of time between boys' water polo and swimming seasons. The matter was directed to Mr. Ferren Christensen (Principal, Westminster High School) for discussion among affected coaches in the Orange County area and for subsequent recommendation for action to the Executive Committee.

It was further recommended, following considerable discussion, that a committee be established to survey girls' athletics at CIF, SS, member schools. This committee would be responsible for circulating a questionnaire to all principals to determine the interest levels and financial capabilities for supporting extended girls' interscholastic competition. Commissioner Fagans and Chairman Miletich were directed to appoint a committee for this purpose so that the Executive Committee might be able to effectively ascertain the potential for the future development of girls' athletics.

14. REQUEST FOR SPECIAL PHYSICAL EDUCATION CLASS. The Executive Committee reviewed a request from Costa Mesa High School for permission to establish a special physical education class for distance runners that would take place five days a week between the hours of 7:00-8:00 a.m. and would replace the normal athletic period for those boys enrolled. The committee moved, seconded, and passed to deny this request, pointing out that to endorse such a proposal would be to violate the spirit of the rule of allowing athletic team practice to be conducted during regular physical education class periods. Since this class would not appear as part of the normal master schedule of the school, it was felt by the committee that this

would only lead to the creation of specialized coaching hours for out-of-season practice.

15. VIOLATION BY RIVERSIDE POLY HIGH SCHOOL. It was brought to the attention of the Executive Committee that a member of the football staff of Riverside Poly High School had visited the home of a junior high school graduate during the summer in order to ascertain the prospective student-athlete's intentions of enrolling in a senior high school. This is in direct violation of Section XVII (Undue Influence-Recruiting) of the CIF, SS, Blue Book which specifically prohibits such a visitation. After discussion, it was moved, seconded, and passed to direct the Commissioner of Athletics to send a strong letter of censure to the coach and the principal involved for allowing this type of activity, and to instruct the principal to make this a matter of record of the coach's personnel file.

16. WARREN-CENTENNIAL FOOTBALL GAME INCIDENT.

The Executive Committee was informed of letters received from concerned administrators and members of the booster club of Warren High School regarding the following incidents which occurred at the Centennial-Warren football game on November 6, 1970, at Ramsaur Stadium: 1) The audience was requested to remain standing for the playing of the Black National Anthem following the National Anthem; and 2) During the game when penalties were called against the Centennial football team by the officials, the public address announcer stated, "If you don't like the call, contact Ken Fagans at the CIF Office." The committee expressed concern over these matters, indicating that the intent has been to make every effort to improve athletic relationships among CIF schools. The members of the committee felt that it is appropriate only for the National Anthem to be played prior to any interscholastic athletic contest; however, if two competing schools wished to add to this procedure, there would be no objection by the CIF, SS, if there was mutual agreement on the matter between the schools involved. The committee looked with disfavor on the action of the public address announcer, and directed the Commissioner of Athletics to write a letter to the Superintendent of the Compton School District to call his attention to this matter and to express to him the serious concern of the committee.

17. SPRING FOOTBALL PRACTICE, SCHURR HIGH SCHOOL. In line with previous established policy,

The Executive Committee moved, seconded, and passed to approve the request of Schurr High School of Montebello to bus students from other schools who will be in official attendance at Schurr High School for 1971-72 for the purpose of conducting cross country practice this year. This is a new high school which will begin operation in September, 1971, as a balance member of the CIF, SS.

18. ELIGIBILITY CASES. After careful consideration of each case, it was moved, seconded, and passed to waive the residence or transfer rule to permit the following students to be immediately eligible to participate in interscholastic athletics:

Robert Gafare, La Puente High School; Stephen Gilburne, Rolling Hills High School; Detarra Howard, Norte Vista High School; Sergio Leal, Bonita High School; Nick Perez, Fillmore High School; James Sewell, Tustin High School (wrestling only); Robert Sweeney, Fullerton High School; and Wilbur Tiggs, Workman High School.

It was moved, seconded, and passed to deny the request to waive the residence or transfer rule for the following students:

Erwin Duarte, Workman High School; Fred Dulaney, Edison High

School; Edward Dummitt, Quartz Hill High School; and Rudy Gutierrez, Kennedy (Barstow) High School.

It was moved, seconded, and passed to take action as indicated below for the following two additional eligibility cases:

a) Reaffirm an earlier denial of waiver of the residence rule for Luzi Stamm, Anaheim High School;

b) Waive the transfer rule to allow Mike Aguerre to finish the current semester at Apple Valley High School and then be eligible for interscholastic athletics at Chino High School during the second semester of 1970-71.

Mr. Deriot Smith, Principal, Newbury Park High School, appeared before the Executive Committee to present the eligibility case of Kevin Flaherty. Following considerable discussion, it was moved, seconded, and passed to deny a waiver of the residence rule in order to permit eligibility for the student at Newbury Park High School.

The Executive Committee considered a request from Nogales High School for waiver of the previous semester rule in the cases of two educationally handicapped students. The committee
