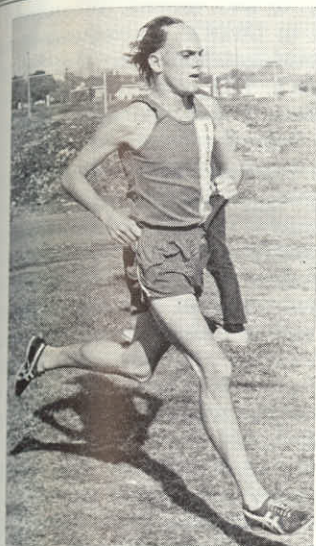

FAVORITES CAPTURE CROSS COUNTRY TITLES

Lompoc, Upland, La Canada and St. Bernard won divisional cross country titles as expected recently at Cal State Long Beach, but there were a few surprises after the winning teams were posted.

Most notable was the 12th place finish of Lompoc ace Terry Williams. The fleet junior, who had won the AAA race last year as a soph, "faltered" to a 9:48 as Santa Ana's Marc Genet

EXECUTIVE COMMITTEE ELIGIBILITY RULING UPHELD IN SUPERIOR COURT

A ruling made by the CIF, SS, executive committee on an interpretation of its residence rule in the case of a student transferring from a public to private school, was recently challenged in, and upheld by, Riverside County Superior Court.

The Arrowhead League requested a ruling and interpretation from the CIF, SS executive committee on the eligibility of John Kuschell at Notre Dame High School in Riverside.

As a ninth grader, John attended Notre Dame High, but decided to transfer to Riverside Poly High as a sophomore, feeling he would prefer the public school. After he attended Poly as a sophomore his family moved 45 miles away, to Crestline, in the San Bernardino mountains.

Dr. Kuschell, the boy's father decided to send his son back to Notre Dame in Riverside.

When confronted with the situation, the committee ruled that young Kuschell would be eligible for varsity competition at Riverside Poly (the school he had previously attended), Rim of the World High School (the public school in which area his parents resided) or Aquinas High School in San Bernardino (the nearest parochial school of the type his parents wished to send him to—Catholic).

However, Dr. Kuschell and his son chose not to take any of the three choices, and went to court, challenging the committee's ruling, that the boy would be ineligible for one year at Notre Dame for varsity competition (although he could attend Notre Dame and play on other than varsity teams through completing a "Form 99" transaction, with proper approval).

Dr. Kuschell petitioned the court to declare his son eligible at Notre Dame, Judge Robert E. Dauber upheld the executive committee ruling on the boy's eligibility.

Wrestling Officials Needed

**BRETHREN WINS SECOND
STRAIGHT SIX-MAN TITLE**

Paced by a pair of sophomores, Brethren High of Paramount captured its second CIF, SS six-man football championship earlier this month 45-33 over Cuyama Valley. The Warriors were co-champions of the Academy League, losing their only game of the season to Whittier Christian 21-12 in the loop opener.

It was the second straight year, also, that Brethren met Cuyama Valley of the Tri-County League in the finals. Cuyama was the host school again, but Brethren prevailed.

Cuyama scored first but coach Dan Cole's charges roared back behind quarterback Les Pearsey and running back Everett Williams, to lead at half-time 16-12.

Pearsey was six of 14 for 114 yards and three touchdowns, of 45, 45 and 19. One 45-yarder was to Williams and the other two to junior Dan Beaver. Quarterback Bill Dykes threw two touchdown passes to Tom Edgmon and scored another himself rushing to lead the Bears of Cuyama.

Pearsey threw 26 touchdown passes on the year and was 77 of 138 for 1,789 yards with only one interception. He also rushed for a 5.6 average and scored eight times. Williams was the leading rusher with 848 yards on 106 carries and 15 touchdowns. Beaver caught 24 passes for 545 yards and 10 touchdowns to lead the receivers during Brethren's 10-1 season.

**MINUTES OF MEETING OF CIF, SS, EXECUTIVE COMMITTEE
November 30, 1971**

The November meeting of the CIF, Southern Section, Executive Committee was called to order by Chairman Steve Miletich at 1:30 p.m. on Tuesday, November 30, 1971, at the CIF, SS, Office.

The following members were in attendance: Chairman Miletich, Vice-Principal, Beverly Hills High School; Rev. Lawrence Dunphy, President of the Southern Section Council, Principal, St. Bernard High School; Keith Lee, Treasurer of the Southern Section Council, Principal, Yucca Valley High School; Alex Alexander, Principal, Desert Sands High School; Tony Balsamo, Principal, Apple Valley High School; Ferren Christensen, Principal, Westminster High School; James Faul, Principal, Workman High School; Msgr. Thomas Kiefer, Principal, St. Genevieve High School; Rev. Alexander Manville, Principal, Bishop Diego High School; J. Kenneth Fagans, Commissioner of Athletics, Thomas Morgan, Administrative Assistant, and Mike Peck, Director of Public Information, CIF, Southern Section Office.

1. **APPROVAL OF MINUTES.** It was moved, seconded, and passed to approve the minutes of the Executive Committee meeting of October 16, 1971, as published in the November, 1971, Monthly Bulletin.

2. **APPLICATIONS FOR MEMBERSHIP.** It was moved, seconded, and passed to approve applications for membership in the CIF, Southern Section, for Marymount School of Palos Verdes Peninsula and Our Lady Queen of the Angels Seminary of San Fernando, effective immediately.

3. **ELIGIBILITY CASES.**

a. After careful consideration of each case, it was moved, seconded, and passed to waive the Residence Rule to permit the following students to be eligible to participate in interscholastic athletics:

b. It was moved, seconded, and passed to DENY the request to waive the Residence Rule for the following student:

c. **Ventura High School**—An interpretation was requested from the Executive Committee concerning the eligibility of Walter Teele, currently a student at Ventura High School. Walter came to Ventura from Mexico to live with an aunt and enrolled in Ventura High School in September, 1970; he participated as a member of the water polo and swimming team during the 1970-71 school year in violation of CIF, SS, residence eligibility regulations as they would apply to students from foreign countries not accompanied by their parents. This error in allowing Walter to participate was discovered by the Ventura High School administration on October 27, 1971, and all water polo and swimming contests in which the boy had participated were officially forfeited to the opposing schools.

The committee was asked to rule on the current eligibility status of Walter at Ventura High School. Although he has technically now spent his year of residence at Ventura which would make him eligible for interscholastic athletics, he was permitted to play when he should not have during the 1970-71 school year. Following discussion, the committee concluded that this case involved an inadvertent error on the part of the Ventura High School administration and was not an attempt in any way to circumvent CIF, SS, rules; further, since the school had been penalized by forfeiting all contests in which the boy had participated, it was moved, seconded, and passed to declare Walter Teele residually eligible for interscholastic athletics at Ventura High School as of September 15, 1971.

d. **San Gabriel High School**—Mr. John Seixas, Athletic Director, San Gabriel High School, Mr. and Mrs. William Fernando (parents), and Mr. Robert Fernando (uncle) appeared before the Executive Committee regarding the eligibility of Mark Fernando at San Gabriel High School.

On September 16, 1971, Mark had been declared residually eligible at San Gabriel when the Executive Committee waived the CIF, SS, Transfer Rule for reasons of hardship, upon an appeal from Mr. Thomas Willhite, Vice-Principal at San Gabriel High School. However, this action was subsequently protested to the State CIF Office by Delano High School (member of CIF Central Section), the school which Mark had previously attended before moving to San Gabriel to reside with his uncle. The protest questioned whether the hardship involved in this particular case should be considered as sufficient justification for setting aside transfer eligibility regulations.

The committee reviewed with Mr. Seixas and the members of the Fernando family all of the facts and information pertaining to this case in order to clarify the reasons surrounding Mark's move from the family residence in Delano to his uncle's residence in San Gabriel.

Following discussion in executive session, the committee moved, seconded, and passed by a vote of 7-2 to reverse its original ruling and to deny eligibility for Mark Fernando at San Gabriel High School during the 1971-72 school year on the basis of insufficient hardship reasons. It was determined that Mark could return to Delano High School and be immediately eligible, or he could choose to remain at San Gabriel and become eligible for the 1972-73 school year after spending one year of residency in accordance with CIF, SS, transfer regulations.

e. **El Modena High School**—The committee denied an appeal for Dave Cramer to be eligible for varsity athletics at El Modena High School, but because of extenuating circumstances granted special permission for him to participate in JV activities only.

4. **ELECTION OF COUNCIL OFFICERS.**

With reference to discussion of the Executive Committee meeting of October 16, 1971, concerning the election of a President and Vice-President of the CIF, SS, Council, the Commissioner presented recommendations proposed amendments to Articles I and VIII of the Constitution which would provide for the necessary election procedures. The committee reviewed the proposals, requested a change in the suggested lengths of terms for the officers, and then moved, seconded, and passed to direct the commissioner to prepare these amend-

**CROWD MANAGEMENT
CLINIC TAPES AVAILABLE**

A new concept has been introduced to the CIF, Southern Section, and as a result member schools may now obtain tape recorded highlights of the Crowd Management Clinic which was conducted at Rosemead High School on September 2, 1971.

The informative remarks of the guest speakers at the clinic were recorded live and have been reproduced on cassette tapes which are now available for sale at cost. ments in final form for recommendation to the Council for approval at its meeting of January 29, 1972.

5. **PEP BANDS AT BASKETBALL PLAYOFF GAMES.** Mr. Don Dorsey, a student from California State College at Fullerton, appeared before the Executive Committee to appeal the CIF, SS, regulation which restricts a pep band to 12 members at basketball playoff games. The committee discussed the issue with Mr. Dorsey, but expressed concern over the fact that this appeal was being presented by an "outside source" rather than by direct representatives of member schools or leagues. Mr. Dorsey stated that he had been in contact with several persons at schools which are members of the Freeway League, and it was then suggested that he work with that league in developing a formal proposal which could be recommended by the league for consideration by the CIF, SS, Council to increase the allowable number of pep band members.

6. **ELIGIBILITY LISTS.** The Commissioner informed the Executive Committee of several problem areas and other circumstances which have occurred recently over the mandatory exchange of eligibility lists as required by Article VI of the CIF, SS, By-Laws. The committee briefly discussed some of the principles behind the development of the present rules governing the exchange of these lists, and sug-

gested that this matter be carried over as a future agenda item to be reviewed again after the pending decision of the Council as to the type of classification system to be used for CIF, SS, interscholastic athletics.

7. **NEW BASKETBALL UNIFORM RULE.** The Executive Committee was advised of the new National Federation basketball rule which will become effective beginning with the 1973-74 season and will require that team uniform shirts be of the same solid color front and back, side seam inserts or trim may not exceed four inches in width, and piping around the neck and arm openings may not exceed one inch in width. The Commissioner reported that some types of uniforms recently purchased by schools would be in violation of this rule, and suggested that for economical reasons possible consideration be given to allowing these uniforms to be phased out by other than varsity teams. It was then moved, seconded, and passed to reaffirm that all CIF, SS, varsity basketball teams must comply with National Federation rule 3-4(a) for the 1973-74 season, but that it would be permissible for uniforms not meeting the new specifications to be used at other than the varsity level (i.e., JV, B, C, Frosh-Soph) until such time as existing sets of uniforms at schools are no longer useable. Schools would, of course, be expected to comply with this rule when purchasing any new uniforms, and existing sets of uniforms should not continue to be supplemented with equipment which does not conform to the above specifications.

8. **ASSISTANCE WITH HIGH SCHOOL JOURNALISM PROGRAM.** The Commissioner presented to the Executive Committee a request which had been received from the High School Journalism Association for assistance with mailing costs and other related supplies and materials in connection with distributing informational bulletins for the Association. The committee discussed the matter and indicated that, while the journalism program was a very worthwhile project, the CIF, SS, Office could not be authorized to expend funds or donate materials to outside organizations for non-CIF activities. It was moved, seconded, and passed to direct the Commissioner to inform the High School Journalism Association that the CIF, SS, could not honor this request for the above-stated reasons, but that the office would be pleased to cooperate by offering assistance in ways such as the use of addressograph facilities and other services not involving expenditures of funds.

9. **MEMBERSHIP STATUS OF RANCHO SAN ANTONIO.** Mr. Ben Mascarenas, Athletic Director, and Mr. Randy McTague appeared before the Executive Committee to review the current status of Rancho San Antonio with regard to regular membership in the CIF, Southern Section. Rancho San Antonio was originally granted special membership consideration as a residential home in conjunction with William Aggeler Junior and Senior High School, a social adjustment or continuation school, but recent reports have indicated that the Rancho residents now may also attend Chatsworth High School, a public high school in the Los Angeles City School District. The purpose of the discussion was to clarify the present organization and operation of Rancho San Antonio as applied to secondary school requirements for CIF, SS, membership as stated in Article II (Jurisdiction) of the Constitution. The committee obtained necessary information from Mr. Mascarenas and Mr. McTague, and then, because of the lengthy meeting agenda, decided to take the matter under consideration for final review and a decision at its next scheduled meeting.

10. **DOCTORS AT CIF, SS, FOOTBALL GAMES.** With specific reference to two incidents during this past football season where football officials died while working CIF, SS, games, the Executive Committee discussed the feasibility of recommending that it be made mandatory that a doctor be in attendance at all CIF, SS, football games. Current regulations require the presence of a doctor only at football playoff games. The committee was advised of problems schools have experienced, especially in outlying geographical areas, of being able to obtain the services of doctors for games, and it was felt that such a mandatory rule would work a hardship on many member schools because of the lack of available doctors in some areas and because of the expense involved in paying fees for doctors in other areas. The committee emphasized the value of having a doctor in attendance at all football games, and wished to go on record as recommending that every school make necessary plans for emergency first aid at football games in view of the reports of incidents which occurred this year. It was further suggested that the Director of Public Information publicize this subject in the Monthly Bulletin in order to make certain that all schools will be aware of the importance of the matter.

11. **OFFICIATING PROBLEMS.** The Commissioner advised the Execu-

tive Committee that a great number of reports and complaints have been received recently reflecting on the calibre of officiating throughout the CIF, SS. The committee discussed this subject at length, and expressed serious concern over the fact that the overall quality of officiating has apparently been on the decline. It was moved, seconded, and passed to direct the chairman to appoint a special committee to investigate and review the officiating procedures that have been established for the CIF, SS, with the specific purpose of recommending new guidelines which might be implemented to improve the officiating program.

12. **PROPOSED CHANGE IN TRACK FORMAT.** The Camino Real League presented a written recommendation to the Executive Committee to change the format for the CIF, SS, post-season championship track and field competition. Instead of the present system involving quarter-final, semi-final, and final meets in A, B, and C classifications, the league has proposed that competition be held only at the varsity level with team championships for three different divisions of schools (AAA, AA, and A). There would be a qualifying and championship meet at each level during the first two weekends of May, and the top finishers from each of the three meets would then come together for a final "grand championship" meet on the third Saturday in May to decide the overall CIF, SS, champions and to determine representatives to the State Meet. The committee felt that this proposal had merit and should be given additional consideration, and directed the Commissioner to refer the matter to the Playoff Committee for further study pending resolution of the classification issue now before the CIF, SS, Council.

13. **HAWAIIAN WATER POLO FORUM.** Permission was requested for selected water polo participants from CIF, SS, member schools to attend a clinic and forum sponsored by the Kalos Kagathos Foundation and the United States Navy in Honolulu, Hawaii, for two weeks during the month of December. In accordance with established policy governing learning situations such as this, it was moved, seconded, and passed to approve participation by student-athletes from the CIF, SS, in activities under the jurisdiction of the clinic without jeopardizing their remaining eligibility for interscholastic athletics.

14. **7:30 P.M. STARTING TIME FOR SATURDAY NIGHT FOOTBALL GAMES.** The Commissioner brought to the attention of the Executive Committee a request from a representative of the press to recommend

that Saturday night football games begin at 7:30 p.m. in order to help facilitate newspaper deadlines for Sunday morning editions. The committee discussed the issue, and was informed of favorable experiences in several member leagues which this year started all football games, including those played on Friday, at 7:30 p.m. Although the Executive Committee does not establish policy for member leagues in this regard, it was moved, seconded, and passed to recommend that schools consider 7:30 p.m. starting times, where possible, for football games scheduled on Saturday nights.

15. **LAKEWOOD — COMPTON FOOTBALL GAME.** The Executive Committee was advised by Lakewood High School that Compton High School substituted another musical number in place of the National Anthem during the pre-game ceremony for their football game on November 6, 1971, at Ramsaur Stadium. The committee felt that the principal of Lakewood High School had taken appropriate action in this case by notifying the principal of Compton High School, and that no further deliberation of the matter was necessary at this time. The committee did urge all member schools to coordinate arrangements prior to the dates of games so that proper pre-game procedures may be mutually agreed upon, and recommended that these procedures include the playing of the National Anthem.

16. **CROWD CONTROL INCIDENTS.** The Commissioner informed the Executive Committee that there were a total of 44 football games during the 1971 season in which crowd control incidents occurred and were reported to the CIF, SS, Office. These incidents varied in their degrees of severity, and most of the reports were for informational purposes, but the Commissioner was of the opinion that the development of the Incident Report Form has proven extremely successful because it has provided statistics regarding the numbers of and types of incidents and has been constructive because principals have been required to list the steps that have been taken to prevent the recurrence of these incidents.

17. **ADMISSION OF CLASSIFIED PERSONNEL TO PLAYOFF GAMES.** Mr. Ferren Christensen presented an appeal on behalf of Westminster High School to amend CIF, SS, policy in order to allow classified personnel from member schools to be admitted free of charge to playoff contests. The current policy, as adopted by the Council on May 9, 1970, applies only to faculty members. Mr. Christ-

zipped home in 9:29.6 over the two-mile-plus course.

The trail was damp from the previous evening's rain, but perhaps not as treacherous as for the prelims, although times were generally slower than the previous week. For all races

but the AAAA, the weather was cold and windy. Course distance was two miles, 50 yards.

Dos Pueblos, as expected, was second to Lompoc. The Braves' Roger Hansen was the highest finisher for the winners, at eighth. Costa Mesa had three runners in the top 10 and finished third. Lompoc's team time was the best of the day (49:35) for their top five and it equalled their time in winning the AAA in 1970 for third best over the last three years the finals have been run at CSLB.

LEAGUE VOTES LA QUINTA INTO PLAYOFFS IN AFTERMATH OF UNUSUAL RESIDENCE ELIGIBILITY CASE

La Quinta High School of Garden Grove, was involved in one of the most unusual and highly publicized eligibility cases in recent memory, during the past football season.

The Aztec football team had completed eight regular season games without a loss before an investigation, requested by the Garden Grove League, was conducted into the eligibility of Rick Curry a junior transfer student from Corona, who had become one of the outstanding players on the La Quinta team. The boy had been residing in Corona with his mother, who had been given legal custody of him at the time his parents were divorced. Last January the boy decided to take up residence with his natural father who had remarried and was living in the La Quinta attendance area.

In situations of this kind a boy would be ineligible unless the receiving school would petition for a waiver of the CIF, SS, transfer rule.

On Nov. 17 of this year, La Quinta did apply for a waiver of the Transfer Rule and after checking out the case the waiver was granted, making the boy eligible as of that date.

La Quinta then asked for retroactive eligibility which would have made the boy eligible as of Jan. 4, 1971, when he enrolled at La Quinta High School.

The request to make the waiver retroactive was unusual. Such action had never been taken in the past and the Executive Committee felt that it would establish a dangerous precedent. La

Quinta, therefore, was forced to forfeit any athletic contests in which the boy participated prior to November 17, 1971.

La Quinta then lost its final league game, making its record 0-9. Rancho Alamitos and Santiago would up as co-champions of the Garden Grove League. The league, after careful consideration of the situation, felt that La Quinta was its most representative team and therefore, in accordance with its prerogative, nominated La Quinta to replace Rancho Alamitos in the CIF, SS, playoffs.

Whitmont Now Mission Valley

The Whitmont League has changed its name and will be known as the Mission Valley League for 1972-73. The change came about after relegating took nearly all Whittier and Montebello (the origin of "Whitmont") to other loops. Schools in the Mission Valley League will be Arroyo, El Monte, Keppel, Monrovia, Mountain View, Rosemead, San Gabriel, and Schurr.
