## TOM BYRNES TO JOIN CIF, SS STAFF


## TOM BYRNES TO JOIN CIF. SS. STAFF

Thomas E. Byrnes, 35-year-old athletic director at El Dorado High School in Placentia, has been named Administrative Assistant to CIF, SS, Commissioner J. Kenneth Fagans.

Byrnes, who has been athletic director at El Dorado since 1965 and has coached the varsity baseball and swimming teams there, will assume his duties Tuesday, Jan. 2, at the office in Artesia. He replaces Thomas A. Morgan, who leaves the CIF, SS, after two years for a position as Executive Secretary with the Southern California Golf Association, located in North Hollywood.

Byrnes was a four-year football and baseball player at Eagle Rock High School, being named outstanding senior athlete at that school in 1955. He made all-league and All-City football teams.

He also played four years of baseball and football at Occidental College (Continued on Page 3)

## BRETHREN WINS THIRD STRAIGHT SIX-MAN CROWN

Brethren High of Paramount has captured its third straight six-man football championship, but six-man teams won't have to worry about the Warriors next season.

Brethren conquered Academy League rival Rio Hondo Prep in the season finale at LB Jordan High 72-64. It amounts to Brethren's goodbye to the six-man sport, as the Warriors join the Olympic League next season and will embark on an 11-man program.

Junior Everett Williams matched USC's Anthony Davis on the same weekend the Trojan star whipped Notre Dame with six touchdowns. Williams had scoring runs of 11, 10, 1, 11 and 3 and tallied on a 27-yard pass from quarterback Les Pearsey.

Dennis McDowell was the leading scorer for coach Jim Beaver's Warriors with 153 yards on 14 carries including touchdown runs of 72 and 10 yards. Williams had 102 in 20 totes. Pearsey scored the other TD on a 49-yard run. McDowell's 10-yarder was the decider, coming with 1:11 left.

Steve Martin ran for three scores and passed to three different receivers for three more in leading Rio Hondo. Jim Struck also hit a pair of TD passes for the losers, both to Steve Hershey.

Brethren finished the 10-game season without a loss, only the regular season 58-58 tie with Rio Hondo blemishing the mark.

# MINUTES OF SPECIAL MEETING OF THE CIF, SS, EXECUTIVE COMMITTEE November 14, 1972

A special meeting of the CIF, Southern Section, Executive Committee was called to order by Chairman Steve Miletich at 1:50 p.m. on Tuesday, November 14, 1972, at the CIF, SS, Office.

The following members were in attendance: Chairman Miletich, Vice-Principal, Beverly Hills High School; Mr. Alex Alexander, Principal, Desert Sands High School; Mr. Tony Balsamo, Principal, Apple Valley High School; Mr. Ferren Christensen, Principal, Westminster High School; Dr. Richard Cordano, Principal, Arcadia High School; Mr. Ted Gossard, Principal, Aviation High School; Mr. Keith Lee, Principal, Yucca Valley High School; Dr. Hanford Rants, Principal, Gahr High School; Mr. J. Kenneth Fagans, Commissioner of Athletics, and Mr. Thomas Morgan, Administrative Assistant, CIF, Southern Section,

1. APPEAL, MONROVIA HIGH SCHOOL. Representatives of Monrovia High School appeared before the Executive Committee for the purpose of appealing the recent decision of the Mission Valley League which had resulted in certain sanctions being imposed against the school for violations of CIF, SS, regulations governing football activities. Those persons present on behalf of Monrovia High School included: Mr. Fred Pasquale, Principal; Mr. John Daniels, Vice-Principal; Mr. Tom Paton, Football Coach; and Mr. Gerald Utti, Attorneyat-Law. Also in attendance were Mr. John Barton, League Representative, and Dr. E. Terry Irvine, President, Mission Valley League, along with other guests who had been invited by the league or the school to appear as witnesses to submit information concerning this matter. Mr. David Jacobsohn, Attorney-at-Law, represented Chairman Miletich. The chairman reviewed each of the charges involved in the case (Reference: Item 13(b), Executive Committee minutes of September 23, 1972, publishd in the October Monthly Bulletin), and offered all parties an opportunity to respond. Following the presentations of testimony and evidence, the committee members and representatives of Monrovia High School discussed the applicable facts and information with each of the respondents. Upon completion of discussion, the committee adjourned to executive session. After further deliberation, and a review of all testimony and evidence which had been presented, it was moved, seconded, and unanimously passed by the Executive Committee to affirm the find-

ings of the Mission Valley League at its meeting of October 26 and 27. 1972, with regard to violations of CIF. SS, football regulations by Monrovia High School, and to sustain the recommendations of the league as to the following penalties which were assessed: 1) The disciplining of the coach be reserved to the discretion of the Principal of Monrovia High School; 2) The varsity and junior varsity football teams at Monrovia High School be declared ineligible to qualify for a league championship during the 1972 season; and 3) That Monrovia High School be placed on probation for the balance of the 1972-73 school year. In addition, the Executive Committee moved, seconded. and passed to retain the services of Mr. David Jacobsohn as legal counsel representing the CIF, SS, in the event that subsequent court action is filed in this case involving Monrovia High School.

2. ELIGIBILITY CASES. After careful consideration of each request, it was moved, seconded, and passed to waive the Transfer Rule or Previous Semester Rule in order to permit the following students to be immediately eligible to participate in interscholastic athletics:

Lompoc's actual finish was 1-5-6-8-10, although, Curtis Beck's second place finish as an individual (not counting among team scores) moves each of the last four up one notch for scoring purposes.

Williams easily defeated Beck by 26 seconds, in warm weather over the two-mile course. Williams captured the AAA race as a sophomore after finishing fifth as a freshman in the AA race the year before. Last year he faltered to 12th, in his only loss of that season. His duel with Beck is likely to continue in track season. Beck is the current Section and state two-mile record-holder.

A 3-4 finish by Craig Weber and Bob Kryczko gave Upland its third title in five years. The Highlanders copped the AAA crown, while Bell-flower's Bob O'Brien recorded the second fastest time of the day (as he did in the prelims), a 10:12.8 for the individual title.

Central pulled a mild surprise in the AA, scoring 75 to Bishop Amat's 80 and co-favorite (and defending champ) La Canada's 92. Pat Dutzi easily outran the field in 10:17.4. Salesian backed up its second place finish a year ago by stunning favored Agoura for the A title 66-71. Santa Paula's John Henderson was the individual champ with 10:24.8.
