CIF STATE VOLLEYBALL CHAMPIONSHIPS

After being talked about for years, girls' volleyball teams from the Southern Section made a first-ever appearance in the CIF State Volleyball Championships. The Southern California champions in Division I Santa Monica and Division II Rim of the World qualified to advance to the CIF STATE VOLLEYBALL CHAMPIONSHIPS conducted on Saturday, December 12, 1981 at Memorial High School in Newark.

Action began with the SOUTHERN CALIFORNIA CIF VOLLEYBALL CHAMPIONSHIPS. This tournament was divided into two divisions, Division I (large schools - 4A and 3A) which was held at UC San Diego, Friday and Saturday, December 4 and 5. The Southern Section was guaranteed two entries, Irvine our 4A champion and Louisville who recently won the Southern Section 3A championship. There were also two At-Large entries in this division, which includes the Central, Los Angeles, San Diego and Southern Sections. They were Santa Monica our CIF-SS 4A runner-up and Highland High School of Bakersfield.

Division II (small schools — 2A and 1A) played at La Jolla High School also on Friday and Saturday, December 4 and 5. CIF-SS champions, Cajon (2A) and Rim of the World (1A) represented the Southern Section in this division. (San Diego Section, one entry; Central Section, one entry and Southern section, two entries.) There were no At-Large entries participating in this division.

Management of the Southern California CIF Volleyball Championships was under the direction of Ms. Jan Jessop, Assistant Commissioner of the San Diego Section CIF.

BIG FIVE / THRIFTY JOIN CIF-SS AS SPONSORS

CANDID INTEGRITY

Professionals indeed.

There are constant queries as to how this organization has functioned so successfully over the decades, an educational entity charged with the administration of interscholastic athletics and the eighth largest of its kind in the United States.

As for the blank spaces, the task is a simple one.

The candid integrity of the principals, athletic directors and their respective staffs not only provide the answers, but perpetuate the mere existence of the organization itself.

Evidence of same was plentiful over the just concluded fall sports season. In fact, when analyzed in collective fashion, it more than provides the impetus and challenge for the next daily shift.

Where else can one find individuals — loyal to their own school — placing a voluntary telephone call to the Southern Section Office to report an infraction which negates a potential perfect season and playoff opportunity?

Here's just a sampling of that professionalism:

... the principal who turned his team in three months after the fact for utilizing an "air bag" during summer football practice, an item just uncovered.

... the athletic director who called to report the forfeiture of eight wins at the sophomore level due to the fact one of the starting players had failed to take a physical examination.

... the principal who not only contacted the Office to report the use of an ineligible player, but the corrective action already taken with the coach.

These are just a sampling indeed, but one can't help but note the constructive process of one principal and athletic director in dealing with an over zealous walk-on coach.

The coach, unfamiliar with the rules and regulations, called a Sunday practice and brought along a few of the alumnus for some healthy opposition.

MINUTES OF THE CIF-SOUTHERN SECTION EXECUTIVE COMMITTEE MEETING OF

October 29, 1981

The meeting of the California Interscholastic Federation Southern Section Executive Committee was called to order by Chairman Dr. Robert Packer at 1:20 p.m. at the CIF-SS Office in Cerritos. All members were present with the exceptions of Bruce Keuning, Jim Faul, Barbara Wilson and Andy Patterson.

1. PRESIDENT'S UPDATE: Chairman Dr. Robert Packer updated the Executive Committee on the support to the CIF-SS by the Puma Corporation. Dr. Packer thanked the staff for their efforts in conducting a very successful Superintendent-School Board Symposium.

2. COMMISSIONER'S UPDATE: Mr. Ray Plutko, Commissioner of Athletics, reviewed with the Committee eligibility appeals, staff in-service, Athletic Administrators' Symposium, Puma Corporation contract and support income which has reached \$106,000 to date.

3. SUPERINTENDENTS' UPDATE: Dr. Maury Ross, superintendents' representative, reported on the positive relationships being developed with school board members and superintendents by the CIF-SS, and a recap of Senate Bill 19, which will become active January 1, 1982.

4. BOYS' ATHLETIC DIRECTOR UPDATE: Mr. Clyde Francisco, boys' athletic director representative, commended the Orange County Athletic Directors' Association work and reported on the role of the CIF-SS Athletic Directors Advisory Committee.

5. GIRLS' ATHLETIC DIRECTOR: Ms. Karen Hellyer, making her final report as the Girls' Athletic Directors' Representative, reported on the need for additional field hockey officials and the Coaches Certification Program.

6. STATE FEDERATED COUNCIL:

(a) **Change of June meeting date:** Mr. Tony Balsomo apprised the Executive Committee of the revised State Federated Council meeting dates. In order to accommodate the Section, the meeting scheduled for June 4-5 has been rescheduled for April 30-May 1, with the meeting to be held the first week in May in each year.

(b) **State Golf Championships:** Mr. Balsomo reported that the State Federated Council took action to eliminate golf as a state championship activity for boys and girls, due to the declining number of schools participating and cost involved.

(c) **Regional Championships:** Mr. Balsomo reported that the concept to conduct state regional tournaments in the sports of track, volleyball and wrestling was adopted by the State Federated Council, effective with the 1982-83 school year.

(d) **State Basketball Regional:** Mr. Balsomo reviewed action of the State Federated Council to allow the Los Angeles City Section participation in the 1981-82 State Regional Volleyball and Basketball tournaments upon the Section's willingness to comply with the state season of sport calendar effective with the 1982-83 school year.

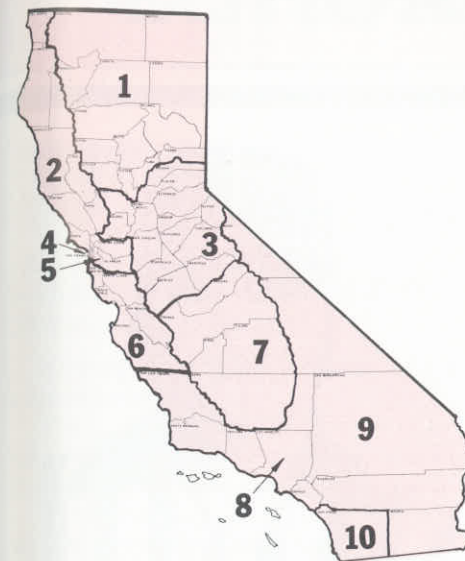

Editor's Note: The following items are highlighted from the minutes of the October 2 State CIF Federated Council meeting in Carmel and are included in an effort to apprise our membership of current and forthcoming issues of interest.

(3.1) CIF ADMINISTRATIVE COMMITTEE REPORT

FEDERATED COUNCIL DATE CHANGE

It was moved, seconded and *passed* to change the date of the 1982 October CIF Federated Council Meeting to the dates of October 21, 22, 23, 1982.

PRIVATE SCHOOL REPRESENTATION

A motion to add an additional Federated Council member representing the California Association of Private School Organizations *failed* to receive the necessary two-thirds roll call vote.

(3.2) CIF SECTION COMMISSIONERS' REPORT

REGIONAL TOURNAMENTS

Following discussion, it was moved, seconded and *passed* by roll call vote that state tournaments in track, volleyball and wrestling should be preceded by regional tournaments beginning in 1982-83.

MULTIPLE CLASSIFICATION

It was moved, seconded and *passed* to establish a multiple classification of schools in state and regional championship events involving team sports.

GOLF AS A STATE PLAY-OFF

Following discussion, it was moved, seconded and *passed* to eliminate golf as a state play-off activity for boys and girls, with the regional concept to remain in effect. It was moved, seconded and *passed* directing the CIF Section Commissioners to develop and return with a plan at the January meeting in order to implement regional golf championships for boys and girls.

BY-LAW 900 — ALL STAR COMPETITION

A motion to approve the proposed change in By-Law 900 was *defeated*.

RULE 600 — UNATTACHED ATHLETE CLARIFICATION

It was moved, seconded and *passed* to revise Outside Competition By-Law 606 to read, "An unattached athlete shall not represent any team. Points won by the athlete shall not be credited to any team. An unattached athlete shall not use a uniform which identifies a school or 'outside team'. Any violation shall be considered an infraction of Rule 600 (or Article 6)."

NEW BY-LAW 407 — UNATTACHED COMPETITION

It was moved, seconded and *passed* to add the following By-Law to Article 6 of the State CIF Constitution. "Unattached competition is not permitted in any CIF competition (see Rule 302). Individuals or teams entered in CIF competition must represent a CIF member school. No other form of representation shall be permitted in CIF competition."

NORTHERN CALIFORNIA CIF DIVISION III BASKETBALL PROPOSAL

Mr. Jim Cheffers, Chairman CIF Commissioners, presented a recommendation supporting the CIF Basketball Committee's proposal to conduct a Northern California CIF Division III Basketball Championship in 1982.

It was moved, seconded and *passed* to approve the recommendation as stated above.

CHANGE IN FEDERATED COUNCIL MEETING DATE

It was moved, seconded and *passed* to change the June 4-5, 1982 State Federated Council meeting date to the first weekend of May. Dates for the spring State Federated Council Meeting will be April 29, 30 and May 1, 1982.

BY-LAW 905

It was moved, seconded and *passed* amending the last sentence of By-Law 905 to read, "A student may not practice or try out for All-Star basketball or football games or teams prior to June 1."

(3.3) LEGISLATIVE COMMITTEE REPORT

Mrs. Barbara Wilson, Chairperson of the CIF Legislative Committee, reported that Governor Edmund G. Brown, Jr. had signed Senate Bill 19 into law to become effective January 1, 1982. Mrs. Wilson highlighted various amendments attached to the bill as well as indicated the continued need for the CIF organization to work closely with members of the legislature, the Department of Education, and school board members throughout the state.

(3.4) CIF EQUAL RIGHTS AND OTHER MINORITY QUESTIONS REPORT

Mr. Wilbur Conklin, Chairperson of the committee, reported on several suggestions raised by Mr. Barry Zolotar, Staff Counsel for the State Department of Education, in areas of possible non-compliance with the CIF Federal Court settlement. Mr. Conklin reported that the Equal Rights Committee will bring further recommendations back to the Federated Council Meeting in February, which would respond to the questions as raised by Mr. Zolotar.

(3.5) CIF ELIGIBILITY COMMITTEE REPORT

Mr. Lou Jones, Chairperson of the committee, reviewed the proposed amendment to By-Law 205. Following discussion, it was moved, and seconded to *table* the proposed amendment and further, the Eligibility Committee was directed to review the proposed wording of the By-Law change prior to possible resubmission to the State Federated Council.

(3.6) CIF MEDIA AND SPORTS PROMOTION COMMITTEE REPORT

Mr. Tony Balsomo, Chairperson of the committee, reviewed the Travelers Insurance Program, the Puma Shoe package, television coverage for the State Basketball Championships, and a sports promotion and marketing commission structure for the State CIF Office.

Following discussion, it was moved, seconded and *passed* giving the Media and Sports Promotion Committee the authority to make contracts for state and regional events.

(3.7) STATE DEPARTMENT OF EDUCATION REPORT

Mr. John Klumb, State Department of Education representative, reviewed Senate Bill 19 as well as indicated the availability of a tape cassette inservice package offered by the Orange County Office of Education which districts may use to qualify walk-on coaches in the three required areas of competency. Mr. Klumb also reported on the State Board of Education's policy regarding student fees for extra-curricular activities and distributed a statewide survey of secondary school physical education and athletics.

4. OLD AND NEW BUSINESS

(4.1) BY-LAW 604 — OUTSIDE COMPETITION SWIMMING PROPOSAL AND ARTICLE 6 — OUTSIDE COMPETITION

Following discussion it was moved, seconded and *passed* amending By-Law 604 to read, "Swimmers may compete for an amateur team during the season of sport in the United States Junior or Senior National Championship Meet." It was moved, seconded and *passed* making this amendment effective January 1, 1982.

A motion to delete Article 6 from the CIF By-Laws was *defeated*.

(4.2) LOS ANGELES CITY CIF SEASON OF SPORT REQUEST

It was moved, seconded and *passed* permitting Los Angeles CIF Section to participate in regional and state play-offs for the 1981 and 1982 seasons, with the stated guarantee that Los Angeles CIF Section will comply with the State CIF seasons of sport beginning with the 1982-83 school year.

BEYOND THE CALL OF DUTY

The CIF Southern Section would like to take this opportunity to commend the actions of an alert and quick thinking football official.

Randy Silva is his name and, according to involved school authorities, his actions may have meant the difference between life and death of a Yucaipa junior varsity football player.

The incident occurred during a J.V. game between Yucaipa and Barstow when an athlete, Brian Trask of Yucaipa, was injured and sustained a severe concussion. When Brian fell to the ground unconscious, the coach ran out to the field and was checking for neck and back injuries. Silva went over also, and discovered that the boy had stopped breathing and had no sign of a pulse. The official then called upon his CPR training, knelt down and proceeded to revive Brian. At that time the ambulance, which was on the field, arrived to take Brian to the hospital, where he was examined and treated. Fortunately, his injuries were not too severe.

This was a case of being in the right place at the right time for Silva, as he was not the regularly scheduled official for this game.

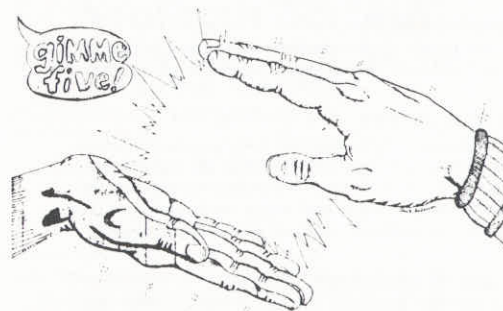

INFLATION AND THE CIF-SS BUDGET

Remember the Good Old Days

(EDITOR'S NOTE: The following is the first in a series of feature articles by Commissioner Ray Plutko, dealing with the structure and various insights to the CIF Southern Section budget.)

It's surprising what inflation can do to the working budget of a non-profit organization.

The year was 1915 and the Southern Section had just completed its initial full year of operation. When all the bills were in and paid, the organization finished on the plus side of the ledger by the exact total of \$136.90.

Needless to say, the bottom line provided the accountability and that's the same objective some 66 years later.

Just for the record, the working budget for the CIF-SS in the year 1915 was \$212.38!

And just to make a further point that then Commissioner Seth Van Patten was on top of matters, he was authorized "to pay a stenographer the sum of 20 cents per hour for clerical help."

Ah, those good old days.

It's 1981 and the working budget for the Southern Section is \$628,100.

Times have indeed changed and so has the inflation, but the Southern Section currently operates as the lowest dues assessed entity in the State and is one of the lowest in the nation.

Dues by way of the member schools and a share of the playoff receipts are still the two major resources for the budget, dating all the way back to 1916 when the organization initially adopted the financial policy of support in that fashion.

FEATURE ATHLETE OF THE MONTH

EDITOR'S NOTE: In an effort to give well deserved recognition to Southern Section athletes, this is the second in a series of articles featuring "all-around student-athletes."

The spotlight this month focuses on a very special junior from Saddleback High School in Santa Ana.

17-year-old Blake Smith was the starting defensive end on the Roadrunner football team. What makes Blake so very special is the fact that he is the only deaf player on his team.

While Blake is the second deaf boy to participate on a Saddleback varsity football team, he is the first to earn a starting position. Saddleback High School is the Orange County Center for Hearing Impaired.

According to Coach Jerry Witte, "We have a unique situation here. There are a few slight problems but nothing very serious. Blake is really a good kid and a great athlete and we love having him."

The problems Coach Witte refers to undoubtedly stem from the fact that much of the football terminology is hard to put in sign language. Blake can read lips but sign language works best. Because of this, an interpreter is present at every practice and team meeting.

When interviewed, Blake's comment regarding the problems he has



encountered was "sometimes in the game there will be a tackle made and I don't hear the whistle, so I have been penalized for this." However, he is quick to point out that problems such as this do not detract from his love for the game. When asked how he feels about playing, his reply was an emphatic, "football yes, it's number one!"

He states that he really enjoys working with the coaches and he gets a lot of support from some of the players. His courage and fortitude have inspired one of his teammates to take a class in sign language so that he might help Blake in the game.

Now that the football season is at an end, Blake is busy practicing with the junior varsity basketball team.

The CIF Southern Section staff salutes Blake. He is another fine example of the dedicated athletes involved in interscholastic activities — "THE OTHER HALF OF EDUCATION".

It was moved, seconded and passed amending the previous motion to state that "such permission to participate in regional and state play-offs be contingent upon approval of the Los Angeles School Board."

(4.3) MODIFICATION OF STATE RULE 214
It was moved, seconded and passed to modify the first sentence of State By-Law 214 to read, "A student who transfers from a school located in the United States (to be referred to as School A) to School B without a change of residence on the part of the parents or legal guardian from school attendance area A to school attendance area B shall be residentially eligible for all athletic competition, except varsity level competition in sports in which the student has competed in interscholastic competition during the 12 calendar months preceding the date of such transfer, provided the athletic eligibility is approved by both principals of the schools involved." It was the intent of the Federated Council that this modification be effective immediately.

(4.8) OTHER BUSINESS SAN DIEGO SECTION REQUEST

Mr. Richard Jackson, San Diego Section Representative, presented a request from the San Diego CIF Section asking for a one-year moratorium on the implementation of the CIF policy dealing with equal opportunity for out of section competition for boys and girls.

Following discussion, a motion to implement the proposed moratorium was lost.

SOCCKER REQUEST

It was moved, seconded and passed directing Mrs. Barbara Wilson, Chairperson of the Legislative Committee, to review and advise the Commissioner regarding an exemption in the outside competition rule for soccer in order to assist in the festivities surrounding the reopening of the State Capitol Building.

600 ATHLETIC ADMINISTRATORS ATTEND SYMPOSIUM

Attendance Tops Last Year's Record

Judging from the comments received from the recently returned critique, the November CIF-SS Athletic Administrators Symposium was a success. The Symposium "Focus On In-Service" which featured such well known speakers as Dr. Arthur Lange and Dr. Leonard Olguin fostered such comments as: "Best Symposium you have had; Dr. Olguin, best speaker of the day; continued to be excellent opportunity to hear ideas and concerns in critical areas; excellent opening and closing speakers; would like in-service on the Blue Book; more on local school fund raising; speakers well prepared, pertinent subjects; stress management speakers were excellent; more on in-service for walk-on coaches; more coaches and board members need to hear Mr. Mel Sims; add small group discussion for "Job Alike" concerns; let's hear more on stress management; very fine program — gained a great deal from it; would like to have attended all sessions; good variety of topics; I would like to see more of these, rather than once a year; Dr. Lange was terrific; I'm looking forward to next year."

Thank you to those who took time out of your busy schedule to complete the evaluation. Your input will be very helpful to the staff in planning next year's Symposium.

However, in the past 14 months, support income by way of advertising and corporate support now accounts for virtually one-eighth of the budget revenue.

The key factor is that the member schools have had their dues remain constant at 16 cents per student and \$10 for each varsity sport fielded over the past three years.

Elsewhere in the State, sections have dues as high as 40 cents per student and entry fees into the playoffs as high as \$150 per sport.

The Southern Section, is by far the lowest and has no entry fees.

There have been questions dating all the way back to 1916 as to possibly taking a smaller share of the playoff receipts, but this would simply penalize all schools.

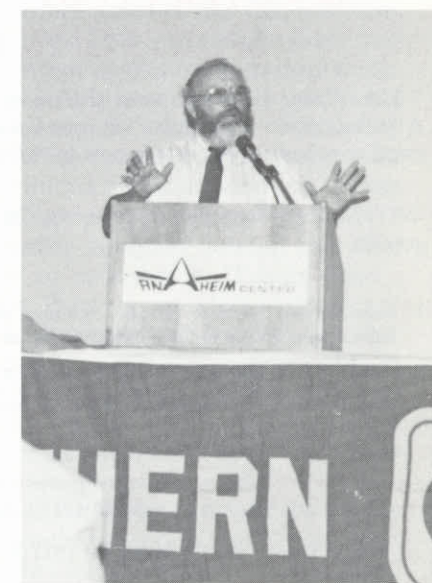
No school operates on a working budget that includes playoff receipts as there is no guarantee a team will enter the playoffs in any given year. Essentially, playoff receipts are added revenue for the schools, who put it to good use when the opportunity presents itself.

If one were to send a larger portion of the playoff receipts to a few schools, then the only means available of making up the deficit would be to raise the dues of all member schools.

Evidently, our founding fathers had some excellent insight.
