Rob Wigod announced the promotion of Director of Communications Thom Simmons to Assistant Commissioner, effective July 1, 2017. This news was received with a standing ovation.

B. Consideration of the Following Schools for Membership for the 2017-2018 School Year

Carter Paysinger stated that application numbers 5B7 and 5B8 have been withdrawn from consideration.

1. Baypoint Prep Academy -

Approved Probationary 20-0-0
Presented by Mike West
Mike West presented the details of his visit. This is a K-12 school located in Hemet. It is adjacent to a church and they are looking to purchase land for the 2019-2020 school year. They have 29 students currently enrolled, hoping to grow to 75 next year, and to 300 by the year after that. The principal and athletic director have CIF experience. There is a gym on campus but they may have difficulty using the baseball/softball minor league complex 10 miles away. I recommend probationary status.

A motion was made and seconded to grant probationary membership to Baypoint Prep Academy for one year beginning with the 2017-2018 school year. Monica Colunga asked for clarification that current enrollment is only 29 . Jim Monico asked if a survey was done with the students to see what the interest level was to participate in athletics. Mike West answered that they had not but have been running a middle school basketball program for years and they feel they can grow. The motion passed 20-0-0.
2. Beacon Hill Classical -

Approved Probationary 19-0-1

Presented by Dick Billingsley
Dick Billingsley presented the details of his visit. This school is in Camarillo and is currently a K-8 campus with 24-28 students in each grade and they are planning on 18 students as they start the high school. The principal and athletic director have athletic backgrounds and the coaching staff is on site. They have a practice field, two churches and two parks that they can use for athletic facilities. They are looking to move four miles north and are eager to get this going. I recommend to approve for probationary membership.

2. Beacon Hill Classical (Cont.)

A motion was made and seconded to grant probationary membership to Beacon Hill Classical High School for one year beginning with the 2017-2018 school year. Jill Matyuch asked if they had a girl's sport for the Fall and Dick Billingsley answered cross country. Carter Paysinger mentioned that they girls can play football. The motion passed 19-0-0.
3. Carnegie Schools Whittier -

Approved Probationary 11-9-0
5B3
Presented by Paula Hart Rodas
Paula Hart Rodas presented the details of her visit. The principal is in her first year as just a principal and not a principal/teacher, all of which were at the elementary level. The athletic director has an athletic background from CSULB. They are on a site right now but are planning to move north to a new location in the Fall. The athletic director is knowledgeable about athletics but knows nothing of the Blue Book. Three of the coaches that are listed were hired by the previous athletic director. Their plan is to go from 25 students to 300 in the next three years, but in my view, they are not ready now. Maybe they will be once they get their new school up and running. I do not recommend for membership.

A motion was made and seconded to grant probationary membership to Carnegie/Whittier High School for one year beginning with the 2017-2018 school year. Mike West asked about the athletic director coaching at the Riverside location and being the athletic director at the Whittier location. Paula Hart Rodas stated that there was a lot they did not know and they are planning to be like Carnegie/Riverside but had no real answers to any questions asked. Jim Monico asked if they know where all this new enrollment would be coming from and Paula Hart Rodas answered that their enrollment office handles all of that. Terry Barnum asked if they are going to be able to field the teams they have listed on their application. Paula Hart Rodas stated no and the sports they will field will only be at the varsity level. The principal and athletic director understand that there are rules to follow. Carter Paysinger added that they have a site that is successful and the ball is in their court. Paula Hart Rodas has identified the problems with the site and that is why there is a probationary period. The motion passed 11-9-0.
4. Ellen Ochoa Prep Academy -

Approved Probationary 20-0-0

Presented by Paul Lopez
Paul Lopez presented the details of his visit. This school was created in El Rancho Unified School District and is a STEM Academy. The principal is a first-year principal but was assistant principal at El Rancho High School and understands athletics. They have an intramural program right now and the Board of Education and the parents are ready to bring athletics forward. Current enrollment is 78 students and they are willing to do professional development. They have field space for soccer and lacrosse and their coaches are on campus. I recommend probationary status.

A motion was made and seconded to grant probationary membership to Ellen Ochoa Prep Academy for one year beginning with the 2017-2018 school year. Terry Barnum asked why they were offering lacrosse. Paul Lopez stated that they talked to their students and there was interest in lacrosse. Jill Matyuch asked that since they only listed frosh/soph levels, can they field JV or varsity? Rob Wigod answered that they can play whatever levels they can field. The motion passed 20-0-0.

## 5. Excelsior High School - <br> Presented by Loren Kleinrock

Approved Probationary 20-0-0

Loren Kleinrock presented the details of his visit. This school is lacking in facilities as it was designed for academics. The principal is bright and was the athletic director at Alemany High School. The athletic director has little background in athletics but is certificated. The principal is ready to be held accountable and wants to make this happen. They are unable to do soccer and basketball at this time, due to enrollment, and they are being realistic regarding their ability to field sports. I suggested they contact the International League for games. I recommend probationary membership.

A motion was made and seconded to grant probationary membership to Excelsior High School for one year beginning with the 2017-2018 school year. No discussion was held. The motion passed 20-0-0.
6. Geffen Academy -

Approved Probationary 19-0-1

Presented by Carter Paysinger
Carter Paysinger presented the details of his visit. This is a new high school on the UCLA Campus. The principal was an athlete at Thacher High School and their athletic director, David Collicutt, was the athletic director at Marlborough High School for many years. They are making good progress toward getting their department ready to go and David has reached out to leagues and gone to meetings. They have 70 students to start with, hope to build to a maximum of 400 , and the have the use of UCLA's facilities. I recommend probationary status.

A motion was made and seconded to grant probationary membership to Geffen Academy for one year beginning with the 2017-2018 school year. Terry Barnum stated that they are ambitious in the sports they are trying to field. Carter Paysinger replied that they did a survey of the student body and a majority of students will be playing multiple sports. The motion passed 19-0-1.

Presented by Sandy Gahring
Sandy Gahring presented the details of her visit. This school shares their facility with a special education facility. They have a new athletic director with some sports background. They have a small enrollment, are a K-12 campus and are hoping to see growth to 125 students in three years and 300 students in five years. They have lost their soccer coach, so they will be fielding 8 -man football and cheer instead. They will be using local parks and a school in the area for facilities and will be JV only as they do not know what the student response to having athletics is going to be. They are already working on getting into a league. I recommend probationary status.

A motion was made and seconded to grant probationary membership to Orion International Academy for one year beginning with the 2017-2018 school year. No discussion was held. The motion passed 18-0-2.

10. PAL Charter Academy -

Presented by John Norman
John Norman presented the details of his visit. This is a San Bernardino City Schools charter school located between Rialto and Cajon High Schools and has been around for 17 years. They have baseball and softball fields that are not being used, but the gym is located at a Boys and Girls Club a couple of miles away. The athletic director is new but has been in athletics for some time as a coach and has been reading and getting up to speed on the Blue Book. The principal also has some athletic background and owns a minor-league football team. There is a concern with the number of boys' sports versus girls' sports. The league they play in now does not have girls' basketball. The girls want to play soccer but they may play basketball and they will be building a multipurpose gym on campus. They have a soccer/football field but it is dry because of the drought. They are planning to add a new sport every year. I recommend probationary status.

A motion was made and seconded to grant probationary membership to PAL Charter Academy for one year beginning with the 2017-2018 school year. Loren Kleinrock noted that they are not listing a boys' and girls' sport in each season of sport, so can we approve probationary status. Rob Wigod stated no, since that is the minimum standard for probationary membership. The motion failed 0-18-2.
11. River Springs Charter Riverside -

Approved Probationary 17-0-3

Presented by Mike West
Mike West presented the details of his visit. This is the organization's third site, with one in Temecula and another one in Hemet. Paperwork was very basic, but when I arrived at the site, they had all the information. The principal is new to athletics but the athletic director is not. They will be hiring a permanent athletic director as they expand. They are in a new facility that was an old YMCA, complete with an indoor pool and upstairs gym. They currently have 100 students. Their coaches are on site and I met the basketball coach. The principal wants water polo, but probably will not happen immediately, but will be starting with varsity level competitions in their sports. I recommend probationary status.

A motion was made and seconded to grant probationary membership to River Springs Charter/Riverside High School for one year beginning with the 2017-2018 school year. No discussion was held. The motion passed 17-0-3.
12. South Hills Academy -

Not Approved 0-17-3

Presented by Jeff Jordan

Jeff Jordan presented the details of his visit. They are expanding to add the high school. The principal has been there five years and played high school sports. The athletic director is in his first year and asked many questions. He understands the organization as he is running the middle school program. There are not many coaches hired but they have the full support of their school board to hire them once their membership is approved. They cannot field girls' basketball as they only have six girls in the school and they are not interested in basketball. I recommend for probationary status.

A motion was made and seconded to grant probationary membership to South Hills Academy for one year beginning with the 2017-2018 school year. Jim Perry asked if they could field the required number of sports. Jeff Jordan recommend that they would field the proper number of sports if they had more girls enrolled who wanted to participate. It is not their choice they are unable to field all the sports at this time. The motion failed $0-17-3$.

## 13. St. Jeanne de Lestonnac Presented by Dave Reid

Dave Reid presented the details of his visit. The school was established in 1999 as a K-8 grade school and is expanding to add a high school for the 2017-18 school year. Their principal is a first-year principal with the school but was the principal at Rosary High School for several years. Their athletic director has six years of experience as an athletic director at Temecula Prep. They will only have 1215 students to start. The athletic director was well versed in the Blue Book. He could describe why recruiting is against the rules. I recommend probationary status.

A motion was made and seconded to grant probationary membership to St. Jeanne de Lestonnac High School for one year beginning with the 2017-2018 school year. Carter Paysinger asked how many students are enrolled right now and Dave Reid did not have that answer. The motion passed 14-5-1.
14. Summit Leadership Academy -

Approved Probationary 19-0-1 5B14
Presented by Mark Edgemon
Mark Edgemon presented the details of his visit. This school was a member of CIF a few years back and left to regroup. Since that time, they have a hired a new principal and athletic director. There are 220 students enrolled and they have the use of local organizations for facilities. The athletic director was a college and high school coach in New York and has been reading up on Blue Book rules. They surveyed fifty students, they want to play sports and should be able to field the minimum number of teams. I recommend probationary status.

A motion was made and seconded to grant probationary membership to Summit Leadership Academy for one year beginning with the 2017-2018 school year. No discussion was held. The motion passed 19-0-1.
15. USC College Prep -

Approved Probationary 19-0-1 5B15
Presented by Jim Perry
Jim Perry presented the details of his visit. This is one of five campuses run by the School of Education at USC. Two of five are Los Angeles City Section schools. This campus opened in August and is housed in a church in downtown Santa Ana. The principal is new and the athletic director is new but was a three-sport athlete at Segerstrom High School. They have an enrollment of 117 freshmen, all in uniform, and are split 50/50 between boys and girls. They have done a survey and found that most students will be two-sport athletes. They had a copy of the Blue Book and it was tabbed for questions. They are aware of the Orange County Athletic Director Association, the Athlete Administrators Summit and are very interested in professional development as their community wants this for their students. I recommend probationary status.

A motion was made and seconded to grant probationary membership to USC College Prep High School for one year beginning with the 2017-2018 school year. No discussion was held. The motion passed 19-0-1.

## 16. Weil Tennis Academy College Prep -

Not Approved 0-19-1

Dick Billingsley presented the details of his visit. This is a big tennis school. Principal is new and most students are international visa students. They have 54 students enrolled, with a country club next door that houses an Olympic size pool. They have just built six brand new tennis courts. They will only have four girls on their cross country team. Not sure how they are going to field sports other than tennis. They can use parks for practice and travel for track and cross country. They had a copy of the Blue Book and are in the process of hiring an athletic director. I have no recommendation one way or the other but they are looking to be a tennis powerhouse.

A motion was made and seconded to grant probationary membership to Weil Tennis Academy for one year beginning with the 2017-2018 school year. Mike West asked about their facilities and Dick Billingsley answered that their tennis facilities are great, but the soccer field is at a park and they would have no games at home. They said this is a three-year project for them. This looks like a tennis academy with a school. The motion failed 0-19-1.

Carter Paysinger called for a break at 3:18 p.m. The Committee reconvened at 3:28 p.m.

Rob Wigod suggested that a consent calendar be used for the next section of votes, except for items 5C1 and 5C3 that would be voted on separately. There was a motion and second to approve full membership for the rest of the schools on the consent calendar. Rob Wigod continued that all of the schools placed on the consent calendar sent in letters of evaluation, fulfilled the minimum number of sports per season, and met all other membership requirements. Motion passed to accept the consent calendar 18-0-0.

Rob Wigod stated that this school was not able to field any sports teams for the 2016-17 school year and is asking for probationary status for a second year during the 2017-18 school year. Rob Wigod then went over the letter submitted by the school, which was included in the agenda.

There was a motion and a second to grant a second year of probationary membership to the Academy of Sports Science High School beginning with the 2017-2018 school year. Mike West asked if this has this happened in the past. Rob Wigod was not sure that there has been a school that was unable to field any sports their first year of membership. Carter Paysinger asked if they went to the New Schools Orientation training last August. Rob Wigod responded yes. Monica Colunga asked if the same leadership is in place for next year. Jeff Jordan answered that it is the same principal. The motion failed 5-13-0 and the school will need to reapply for membership for the 2018-2019 school year.

# EXECUTIVE COMMITTEE APPEAL HEARINGS - FORMAT 

1) Introductions

- President of the Executive Committee (Chairperson for the appeal hearing)

Carter Paysinger welcomed the guests to the meeting and asked that we begin with introductions.

- Appellant

Daniel Guzman, Athletic Director at Santa Paula High School introduced Alfonso Gamino, Superintendent of the Santa Paula Unified School District; Kelsey Stewart, President of the Santa Paula Unified School District; and Michelle Kolbeck, Vice President of the Santa Paula Unified School District.

- Respondent

Dan Peeters, the President of the Tri-County Athletic Association (TCAA) introduced himself.

## 2) Presentations

- Appellant

Presentation began with Danny Guzman thanking the Executive Committee for allowing them to come. He then turned the presentation over to Alfonso Gamino who stated that the conversation regarding this multi-campus agreement began two and half years ago so a few community students could participate in athletics at Santa Paula High School. He yielded the floor to Michelle Kolbeck who continued the rest of the presentation. She gave her background as being with the Santa Paula USD for over 20 years and has nine of her own children that have gone through CIF sports and continued to play at the college level. She went on to say that the school board has followed the rules for completing the new multi-campus application and were denied allowing students that reside within our district and attend a small private non-CIF school the opportunity to participate in athletics because the size of the school precludes them from membership. The school district's boundary is a 5.6 square miles in which these students live, with taxpaying families that have supported two school bonds for the public schools. We have been working on this process for over two and a half years to get to this point. We have had two overflowing school board meetings, countless public comments, petitions offered with over 500 signatures and the new board members had this issue on their platforms and they won. Our concern is that the request overturned by non-elected officials without public knowledge or input. Only twenty-four students are affected by this agreement and less than five students will take advantage of this opportunity. It is interesting to note that of the seven schools that voted against this application, three were private schools and one was a public school with school of choice. They are already allowed to recruit students from all over the county. We are not asking to recruit students, just allow those that live in the Santa Paula Unified School District to participate at their local high school. As a public school, and especially our governing board, is held to a higher standard by the public but these athletic directors that are allowed to recruit from all over the county were able to overturn a decision that has taken countless hours of our time. Therefore, we respectfully ask that you approve the multi-school agreement between Santa Paula High School and St. Augustine Academy for the 2017-2018 school year. Please allow us to welcome our fellow Santa Paula student-athletes to participate in the wonderful vision of CIF Southern Section sports. Thank you for your consideration.

Kelsey Stewart was the author of the letter contained in the agenda packet and thanked the Executive Committee for this hearing. The only thing I would like to add is that there is tremendous community support for this and that we would like to try it out for one year and if it works, great, and if not, at least we gave it a try. Again, thank you for hearing us today.
2) Presentations (Cont.)

- Respondent

Carter Paysinger introduced Dan Peeters, president of the TCAA. Dan Peeters began with a point of clarification, in your packet you will see that three of the schools that supported this application were private schools. This is not a public/private issue, but it is a competitive equity issue. Our league has a bylaw that states that votes must receive a two-thirds majority and this vote was six for and seven against and you can see in your packet who voted for and against. The addition of 24 students in a district to one school would change the competitive equity in the league. We did have the opportunity to speak to the Malibu High School athletic director and he was not in support of this application. We are in a Releaguing situation and we have six schools leaving our association: Nordhoff, Carpinteria, Fillmore, Oak Park, as well as Santa Paula and Malibu and all of those schools were not in favor of this application. If they are looking at re-evaluating this every year, then it does not make sense to us to start it out.
3) Rebuttal (Anything else, if necessary)

- Appellant - There was no rebuttal.
- Respondent - There was no rebuttal.


## 4) Questions, Clarifications from the Executive Committee

Loren Kleinrock asked what is the enrollment of the private school and was told 72 total students. Loren Kleinrock then asked why are these students not attending Santa Paula High School from the start? Michelle Kolbeck answered that this is a private, religious based school with no facilities for sports. Loren Kleinrock then stated that many of the membership requests for 2017-2018 were small, private schools and why do they not apply to join the CIF Southern Section? Michelle Kolbeck stated that cost is an issue and that 72 students is not enough for fielding teams. Loren Kleinrock then asked why is the Executive Committee being asked to overturn a ruling by the TCAA. Michelle Kolbeck stated her only concern is that this bylaw was brought to the school board only a couple of years ago and I did not understand all the CIF things. Our local CIF organization is not as public as the school board. Our athletic director knows but we did not. We did not know what the vote was. They ended up having to have a special meeting to present their bylaw for the vote. As a board, we were never asked to come as a board and explain our position on this. To me, it is almost backwards, because if you read your own bylaws, you have to start with the school board. If it had been taken to their board first and they were not interested in it then it would have never come to our level. So, we spent two and a half years thinking it was just, you know, we did this and we did this and we had no idea that level could overturn it.
Mike West asked Dan Peeters that if the school has an enrollment of 72 students, but only four to eight students are going to take advantage of this agreement, what is the real concern? Dan Peeters answered that a member school will then have access to students that not all schools have access to.
Jim Monico asked if all the students attending the private school are in the Santa Paula High School attendance boundaries and Alfonso Gamino answered no.
Terry Barnum asked for some detail on the academic relationship between Santa Paula High School and St. Augustine High School. Alfonso Gamino stated that principal and the headmaster are working together and the Santa Paula principal would be responsible for the eligibility verification of the students. Terry Barnum reiterated then there is no academic relationship between the two schools and Michelle Kolbeck confirmed no, that this is a small religious school
Carter Paysinger asked if there are students that do not live in the Santa Paula High School attendance area but attend St. Augustine, what would they do if they wanted to compete in athletics? Michelle Gamino stated that according to the bylaws for multi-school agreements, students are required to go to their local school district public member school. This is a very small community.
Jim Perry stated that the families involved choose to send their students to St. Augustine knowing the school did not have athletics and Michelle Kolbeck confirmed this statement. Jim Perry went on to add that I need to look at the whole package. Am I going to send my child to a school knowing it does not have athletics and then say let's change the rules so my son or daughter can play at school even though I want to send them to a school I know does not have athletics? Michelle Kolbeck rebutted that she has been on the school board for over 20 years and this has never come up. It has only come up when you changed your rules. Your rules now allow for a multi-use agreement so you are the ones that changed the rules so my question is why even have that rule if it is not gonna... My only concern is all the order of this. If it is to go to a no vote at the local league level, let organizations like us know that it is probably not going to fly and we would not have spent two and a half years, school board members, community members, small sports organizations, having our board follow this issue and spend hours and hours of our time when our role is negated only because of your rules.
4) Questions, Clarifications from the Executive Committee (Cont.)

Jim Monico affirmed that when you say these are your rules, these are your rules, because this change was voted upon by the CIF Southern Section Council and representatives from your school and league. This was not done in isolation and I just want to clarify that. It sounds like we are just making these rules and no one knows about it. We make a considerable effort to make sure that every communication is out there. Now, if the representatives don't go back to your school site and tell you these things, obviously, there is an issue with you and your representatives, but I just wanted to make sure that you understand that. Thank you.
Dan Peeters asserted that the agenda was mailed out and minutes were mailed out and everybody in that room is a representative of the principal of that high school. This is not something behind closed doors and we are trying to give you the opportunity to be heard. The Santa Paula principal was at the meeting.
Mike West asked where is St. Augustine and why are they not represented at this hearing? Alfonso Gamino answered that St. Augustine would have been here had we called on them to come but it was felt that we are the member school and we needed to be here, not the non-member school.
Mark Edgemon stated that there is a line on the application for a signature of approval from the league, as they need to agree that this agreement is going to meet the standards of the CIF Southern Section. The rules have been established for the league to give clearance on this application and they did not.
Michelle Kolbeck added that it has been about miscommunication. I know, as a board member, there have been so many things that went on and miscommunications that have happened. St. Augustine is not a CIF member, so this was all new to them. The form itself has lines for the principals, the governing board, and then there is only one line above that which states that the rules have been followed. Again, for clarity, if you click, click, click, five times on your website, you finally see that the league votes but on the form, it doesn't say league votes.
5) Open Deliberation by the Executive Committee

There was no deliberation.
6) Motion to Approve - From an Executive Committee member (Should always be a positive motion to approve), Second, Discussion...

Carter Paysinger called for a motion. Jim Perry moved to approve the appeal and Mike West seconded the motion.
Jim Perry clarified that a yes vote would overturn the vote of the league and that a no vote uphold the league vote.
7) Call for the Vote - From an Executive Committee member

Carter Paysinger called for the vote.
8) Vote - Electronic

The Executive Committee voted via the electronic voting system.
9) The decision of the Executive Committee is FINAL

The motion failed 0-19-1.
Carter Paysinger thanked all those that came for this hearing.

Proposal Summary: The proposed bylaw revision would change the Sit Out Period (SOP) to a standardized percentage for all sports as determined by the Sections first allowable competition date through the final regular season completion date. This proposed change would ensure that all students would have the same percentage SOP dependent on the length of their season, regardless of the Section and Season of Sport as the SOP would be based on a standardized percentage. The year of implementation would be 2018-2019 to coincide with the State and Sections calendar revisions.

## Fiscal Impact: None

Background: The Federated Council approved the SOP in 2011 with implementation in 2012-13 that established a specific week and date for each season of sport for athletic eligibility under the SOP. Individual adjustments have been required over the years in an attempt to ensure equity in the length of the SOP. However, the length of the SOP still varies significantly with a Sit Out Period as high as $68 \%$ in one sport while most are close to 50\%.

## 207.B.(5) <br> TRANSFER ELIGIBILITY

b. Varsity Eligibility Applications (Non-Hardship Sit Out Period) Any student who transfers for the first time since their initial enrollment in the 9th grade in any school, or if the first transfer of schools for this student was granted due to an approved CIF hardship [see 207.B.(5).c], or a valid change of residence and whose circumstances causing the transfer do not meet any of the Hardship Exceptions outlined in c.(viii) below, may become eligible for varsity competition for the sport(s) in which they competed in the last 12 months at the former school or any other school, upon submission, review and approval by their respective CIF Section under the following provisions:
(i) This is the student's first transfer since they first enrolled anywhere in the 9th grade or had their first transfer determined to be a CIF hardship circumstance [207.B.(5).c.]; or a valid change of residence; AND
(ii) The student was academically eligible at the time of transfer from the former school; AND
(iii) The principal of the former school attests in writing that the move was not made in violation of Bylaw 510; AND
(iv) The student is not transferring either voluntarily or because their former school has determined they must withdraw, because of a disciplinary infraction at the former school as defined in Bylaw 209.C. (1); AND
(v) The student is not found by the CIF Section to have transferred to a school where their former high school coach has relocated or where a club coach with whom they have been associated is coaching, per Bylaw 207.C.(3) or (4); AND
(vi) The student has not been determined by their respective CIF/Section Office or the CIF to have made a transfer or change in schools in violation of Bylaw 510 ; AND
(vii) No student shall be eligible to participate in the same sport at two (2) different schools in the same school year unless the student changed schools as a result of a valid change of residence or pursuant to a hardship approved by their respective CIF Section; AND
(viii) The student has not competed at the new school at the sub-varsity level in that sport following the transfer during the current school year; AND
(ix) The student shall remain out of any competition at any level in each sport in which they competed in the last 12 months at the former school or any other school in accordance with the following Sit Out Periods (SOP):
The Sit-Out Period will be $50 \%$ of the total number days in that particular season of sport. The number of days in a season is determined by each Section in accordance with their first allowable competition date through the final regular season competition date. If total number of days in a season is an odd number, then the Sit-Out Period would be $50 \%$ plus one additional day.

Proposal Summary: The proposed bylaw revision would delete Bylaw 1906.B that mandates the 10-yard tie breaking procedure in Regional and State Football Bowl Championships. Tie breaking language for Regional and State Football Bowl games is more appropriately place in the "Blue Pages." If approved in October 2017, this would take effect immediately.

Fiscal Impact: None
Background: With the implementation of the CIF Football Bowl Championships in 2007 Bylaw 1906 was added that mandated the use of the 10-yard tie breaking procedure for the State Bowl Championships. This revision continues to allowed sections to determine their own tie breaking procedure (1906.A) as five sections currently use the 10-yard procedure and five sections used the 25 -yard procedure.

Agoura High School formally appeals the Northern Area proposal that was adopted by the member schools at the Northern Area Re-leaguing meeting on Thursday March 23, 2017. This meeting was hosted by Oxnard High School. Agoura High School specifically appeals their placement in the Coastal Canyon League for the 2018-19 school year and removing AHS from the Marmonte League. Agoura High School maintains that the move to the Coastal Canyon League was done arbitrarily and not based on the CIF criteria required for league placement, and contrary to Agoura High School's proposal.

The proposal was submitted by Dan Peters, Athletic Director at Bishop Diego High School on behalf of the Tri-Valley Athletic Association. The Coastal Canyon League will include Camarillo High School, Moorpark High School, Royal High School, Simi Valley High School, Oak Park High School and Agoura High School, creating a 6-team Coastal Canyon League but consequently leaving a 5 -team Marmonte League. Agoura High School maintains that it should remain in the Marmonte League, as asserted in the AHS proposal, for the following reasons:

## Geography:

Geography was not considered in the new league placement. Moving to the Coastal Canyon League would increase miles traveled by 72.8 miles for each sport at Agoura High School. Joining the Coastal Canyon League, would result in each AHS athletic team traveling a total of 165.8 miles to play each team one time within the new league. Currently, in the Marmonte League the travel distance for each team totals 93 miles to play each league school once. For all AHS Varsity sports to travel to league games in the Coastal Canyon League, there would be a cumulative increase of $1,383.2$ miles per school year.

You will notice, the travel mileage is almost double, creating the following negative impact on the school's athletes and athletic programs:

1. Students would miss more instructional time, as they would need to leave campus earlier from school because of longer travel
2. Students would either have less time at home to complete homework, or would have to stay up later at night to complete homework
3. The school and district would incur increased transportation costs

Concerning transportations costs, Agoura High School was at a deficit in their transportation funding in the amount of $\$ 22,200$ for the 2016-2017 school year. Neither the site, nor the Las Virgenes Unified School District is able afford an increase in our transportation costs. Currently, the athletic programs request a donation from the parents to cover the costs of transportation for athletics. Since it cannot be mandated that parents make this donation, over the years the number of donations has significantly decreased, despite the fact that Agoura High School is a public school that relies on donations from parents to cover the costs of transportation in the athletic department. The move to the Coastal Canyon League, where the distance is almost double, would cause transportation costs to greatly increase, exacerbating the shortfall.

## Competitive Equity:

It is evident that competitive equity was not a factor considered in the new league
placement. Over the last three years, Agoura High School has won 17 league championships and continue to send multiple teams from each season and individuals to the CIF playoffs every year. Please view the attachment for playoff appearances by sport over the last three years, showing our competitiveness within the Marmonte League and CIFSS. Furthermore, if placed in the Coastal Canyon League, AHS' aquatics and lacrosse programs would suffer in regard to competitive equity. The boys' and girls' water polo programs have been highly successful in the Marmonte league for the last decade. Subsequent to placement in the Coastal Canyon League, the AHS Water Polo teams would be moving to a league with fewer schools fielding water polo teams, as Simi Valley HS and Oak Park HS do not have boys' or girls' water polo teams. Also, neither school fields a swim team.

Agoura High School's boys' and and girls' lacrosse programs have also experienced much success in the Marmonte League. The AHS Girls' lacrosse has been crowned Marmonte champions for the last 4 years. Both the boys' and girls' teams went to the semi-finals in the lacrosse playoffs. Lacrosse will soon be a full CIF sport, however, the Coastal Canyon League fields fewer teams than the Marmonte League. Camarillo HS and Moorpark HS do not have a boys' or girls' lacrosse program. Subsequently, this data supports the lack of competitive equity in the aforementioned sports teams if AHS is placed in the Coastal Canyon League.

This school year, the Marmonte League added Sand Volleyball and Stunt as league sports, while the Coastal Canyon league has not. Agoura High School was very excited to add a Sand Volleyball program this school year and looks forward to expanding this sport to provide more opportunities for our female student-athletes. As evidenced here, Agoura High School is concerned with Title IX compliance issues ensuring to provide as many opportunities for our female student-athletes. Agoura High School is also looking to add a Stunt team for the 20172018 school year. Placement into the Coastal Canyon League would hinder our plans to expand our athletic program and include these sports.

A final reason for Agoura High School to remain in the Marmonte League is to keep both of the high schools in the Las Virgenes Unified School District competing in the same league. No one
will argue the amicable rivalry that exists among schools within the same district, competing for their league title. The Coastal Canyon League is the home for all high schools within the Simi Valley District, and the Marmonte league is the home for all Conejo high schools. Observing this pattern, it becomes evident that Las Virgenes would be the only district split, with Calabasas High School remaining in the Marmonte League, while Agoura High School shifts to Coastal Canyón League.

After the vote for the Northern area re-leaguing placements, Agoura High School sent a survey to all interested parties and stakeholders in the re-leaguing process(student-athletes, parents, coaches, administrators). Of those who participated, $88 \%$ wanted to stay in the Marmonte League. From the survey, here are the most popular concerns regarding entering the new league:
*Distance of schools in Coastal Canyon from Agoura High School ( $68 \%$ selected)
*Travel time to Coastal Canyon schools (Moorpark, Simi, Royal, Camarillo) ( $63 \%$ selected)
*Students missing more instructional time because of travel time ( $66 \%$ selected)
*Entering a new league without other LVUSD school(Calabasas) (55\% selected)
*Potential of student-athletes transferring to Marmonte League schools ( $\mathbf{3 3} \%$ selected)
The concrete reasons set forth in this appeal justify the request for reconsideration, rather than arbitrary reasons based on rumors or fallacies. Therefore, Agoura High School, in their appeal to remain in the Marmonte League, is asking for serious consideration by the CIF Executive Council to grant this appeal.

Through this letter, Thousand Oaks High School is formally appealing the Northern Area proposal that was adopted by the member schools at the Northern Area Re-leaguing meeting on Thursday March 23, 2017. This meeting was hosted by Oxnard High School. Thousand Oaks High School specifically appeals their placement in the football only leagues that were created by this proposal.

The proposal was submitted by Dan Peters, Athletic Director at Bishop Diego High School on behalf of the Tri-Valley Athletic Association. Thousand Oaks High School asserts that the three football leagues were created arbitrarily and do not meet competitive equity guidelines established in the CIF bluebook. When presenting this proposal to the Northern Area schools, Mr. Peters stated that the proposed football leagues were primarily based on the Max Preps rankings for the 2015 and 2016 football seasons and the following additional criteria:

1) Roster size
2) Coaching changes
3) Transfers
4) Strength of lower levels
5) How we felt

Thousand Oaks High School believes that the additional reasons cited above are not and never have been established criteria in determining competitive equity. Thousand Oaks High School has attached the Max Preps rankings for both the 2015 and 2016 football seasons for your review. Thousand Oaks High School was not placed in the proper football league based on the CIF-SS criteria, or as stated by Mr. Peters and the TCAA. Thousand Oaks High School asserts that their placement is arbitrary and does not reflect the stated intention of the proposal.

To further establish the credibility and validity of the appeal, Thousand Oaks High School approached Mr. Peters before the next to last voting segment and asked him if the Tri-Valley Athletic Association would be interested in having the 14 schools form a football association. Our rationale for this approach was rooted in our past-practice as this was previously established within our area. Further, Thousand Oaks High School expressed our concern about it's football placement in this proposal. Mr. Peters said that there would be no association, as they did not trust the other schools and that this proposal was about where teams project in the future. He said that his team has 28 Seniors next year and that Bishop Diego may not have a football team in two years. I stated that Thousand Oaks High School may not win a football game in the next two years, but this process cannot be determined by projections. He reiterated that this is all about projecting where you will be. I suggested that this may be seen as arbitrary, and does not reflect competitive equity based on past performance and/or the CIF-SS criteria. He then stated that they could switch Agoura and Thousand Oaks if that would help us. I reiterated that this switch would also be an arbitrary decision that would lead to an appeal, and compel the Northern Area to meet again this fall.

Thousand Oaks High School asks the CIF Executive Council to uphold the established practice that competitive equity be based on past performance, and not allow arbitrary reasons and projections to determine Thousand Oaks High School's placement in the Northern Area Re-leaguing proposal, and thereby grant this appeal.

# Minutes from Northern Area Releaguing Meeting Oxnard High School <br> March 23, 2017 

## Agenda for 3/23/17 Meeting

I. Welcome, Introductions, Attendance - The meeting began at 8:15 AM. Attendees introduced themselves. Attendance was taken using Google docs. 49 of the 53 schools in the NA were in attendance. Absent were Cuyama Valley, Maricopa, North County Christian and Shandon.
II. Review of items for consideration
A. Viable Leagues - problem and solutions - 22 proposals had a non viable Coastal Canyon league for aquatic sports. Calabasas High School offered to join the Coastal Canyon League for aquatics only in all 22 proposals. Other proposals that had non-viable leagues were withdrawn by the submitting school or league.
B. Four Year or Two Year Releaguing cycle - The Northern Area voted 43-6 to change from a four year Releaguing cycle to a two year Releaguing cycle.
C. Other Releaguing concerns
III. Review and Acceptance of Guidelines and Voting Procedures -

A proposal was made by Oak Park High School to eliminate the ability to amend proposals. That proposal was defeated 29-15.
A proposal was made to move the percentage required to amend a proposal from $50 \%$ plus one to 75\%. That proposal was defeated 32-16.
A proposal was made to move the percentage required to amend a proposal from $50 \%$ plus one to $67 \%$. That proposal passed $32-16$.
The area voted to accept the changes to our procedures 45-1-3
IV. Proposal Presentations and Voting -

Before voting began, 16 of the 42 submitted proposals were withdrawn from consideration. The first round of voting had 26 proposals. Those were narrowed down to 13. Laguna Beach High School is officially appealing its 2018 CIF league placement in the Sunset Conference. We are appealing on all three criteria that member schools were directed to consider when voting on proposals;
School size; competitive equity; and geography as members of the greater LBHS community do not believe that these were considered as evidenced in our new placement.

The evidence below indicates that the agreed upon CIF re-leaguing criteria was ignored by placing LBHS in the Sunset Conference:

## School Size

1. LBHS is currently the smallest public high school in Orange County by enrollment.
2. LBHS Currently has 1,085 students and enrollment forecasts show a continued decline in the next 5 years.
a. 2018-19 estimated enrollment is 1055
b. 2019-20 estimated enrollment is 1045
3. Current Sunset Conference enrollments:
a. Sunset Conference schools average student body size is 2,702 students.
b. LBHS is 1,617 students below the Sunset Conference average.


* Two schools 2000 + students on LBHS
** Four more schools $1000+$ student on LBHS
This is by far the largest size discrepancy any public school faces in Orange County.


## Competitive Equity

1. LBHS has been in the Orange Coast League - Bottom $1 / 3$ of the leagues in OC by rankings
2. LBHS has been placed in Sunset Conference - Top $1 / 3$ of leagues in OC by rankings

* Of the 24 sports LBHS will field, 18 of those 24 would be in the bottom conference according to current power rankings. Current power rankings indicate $25 \%$ of our teams would qualify for playoffs. Our football team has been placed in a completely different conference because of competitive equity concerns yet all other sports were not provided this opportunity. See supporting documents for further explanation.


## Geography

1. LBHS has been in the Orange Coast League - Longest drive 18 miles
2. LBHS in the Sunset conference - Five drives 20+ miles, Average drive 21 miles
3. LBHS to Los Alamitos - 32 miles and one hour plus drive time in typical traffic conditions.
a. No OC school is further from LBHS.
4. LBHS will either have to use the toll road (increased cost) and/or deal with heavy amounts of traffic on the 405 every afternoon for students going and coming from athletic competitions.

The evidence below indicates that the agreed upon CIF re-leaguing criteria was ignored when LBHS was placed in the Sunset Conference rather that Cypress HS.

## School Size

1. Cypress HS has an enrollment of 2,750 .
2. Cypress HS is expected to increase in size.
3. Current Sunset Conference enrollments:
a. Sunset Conference schools average student body size is 2,702 students.
b. Cypress HS is slightly larger than the current Sunset average.
4. Fountain Valley - 3,563
5. Los Alamitos $-3,334$
6. Huntington Beach $-2,957$
7. Edison $-2,532$
8. Marina $-2,410$
9. Newport Harbor - 2,363
10. Corona Del Mar - 1,755
11. Cypress $-2,750$

## Competitive Equity

4. Cypress has been competing in the Empire League and winning significantly more than other league schools
5. The Empire is a upper middle tier league and much more competitive than the Orange Coast. (LBHS current placement)
6. Cypress HS has significantly higher power rankings than LBHS in a majority of sports.

## Geography

6. Cypress HS average drive in Sunset Conference - 13 miles. (LBHS average 21)

The data below shows the appropriate placement by school size, competitive equity, and geography in the Pacific Coast Conference:

1. School Size

- LBHS Currently 1085 students

Pacific Coast Conference enrollments: Pacific Coast Conference average school size is 2,200 students. LBHS is 1,135 students below the average. This is still a significant school size difference but much more acceptable than the Sunset Conference placement.


No schools 2000 + students on LBHS
Four schools $1000+$ student on LBHS
This is not an easy placement but one that we can convince our stakeholders is fair.

## Competitive Equity

- LBHS has been in the Orange Coast League - Bottom $1 / 3$ of the leagues in OC by rankings
- LBHS being placed in Pacific Coast Conference - Middle $1 / 3$ of leagues in OC by rankings
- Moving from a bottom tier league to a middle tier league is an appropriate progression

Of the 24 sports LBHS will field we would be in the bottom conference in 15 according to current power rankings and the top conference in 9 sports. Based on current power rankings it looks like about $50 \%$ of our teams would qualify for playoffs. Our football team would be able to compete in the same conference the rest of our sports are in. This is a difficult placement but we feel $50 \%$ of our teams qualifying for playoffs does provide appropriate competitive equity for our teams. Supporting documents included.

## 3. Geography

1. LBHS in the Pacific Coast Conference - Longest drive 15 miles, average 12.5
2. LBHS in the Sunset Conference - Five drives 20+ miles, average 20.5
3. LBHS in the Pacific Coast Conference - Average drive time 25 minutes
4. LBHS in the Sunset Conference - Average drive time 40 minutes

LBHS's academic class schedule has our $5^{\text {th }}$ period ending at $1: 30 \mathrm{pm}$ and our $6^{\text {th }}$ period ending at $2: 35 \mathrm{pm}$. Both of these class periods are academic periods. Our $7^{\text {th }}$ period athletic class starts at $2: 45 \mathrm{pm}$. Traveling to the PCC
would allow our students to only miss their $6^{\text {th }}$ period class. Traveling to the SC would have our students missing part of their $5^{\text {th }}$ period class as well.

## Pertinent information on re-leaguing process:

1. Of the original sixty plus re-leaguing proposals only two had LBHS going to the Sunset Conference. Schools looking at the criteria knew that it is not a correct placement by criteria.
2. When counter proposals were presented the proposal with LBHS going to the Sunset Conference received significant interest as other schools who were unhappy with their initial placements had their placements changed. LBHS was placed without appropriate criteria being considered to appease other schools concerns. Specifically it left the Pacific Coast League and CVAA with the teams they requested without CIF agreed upon criteria being considered.
3. The final two proposals are included and points made below refer directly to them. Proposal 6 received 33 votes in the final vote and proposal 7 received 42 votes.
a. The Irvine schools agreed in a meeting with LHHS and LBHS present that a conference would provide for the best competitive equity. However they were not in favor of it because it was less convenient for them. "It would make scheduling more difficult". Support \#7 for conveniences not criteria.
b. The CVAA was pro \#7 because they would not consider any proposal that did not leave Laguna Hills with them. Reasoning - "we don't want to deal with another district", "we don't want a private school in our league". Both have nothing to do with competitive equity, school size, or geography. Supported \#7 for conveniences not criteria.
c. Nick Cazone, AD Segerstrom HS was asked why his group that developed \#7 (Goldenwest League) did not like \#6. Answer - we don't want to be in a conference. Reasoning by preference not criteria.
d. The Trinity League that has no political alignments to anyone voted unanimously for proposal \#6 because it best fit the criteria.
e. When proposals \#6 and \#7 were re-voted on the vote was 54 to 21 giving proposal \#7 the needed $60 \%$ to pass. While principals were directed not to change their vote to get the meeting over no further discussion was allowed in the group setting. League reps spoke in a group and then a re-vote was ordered. Circumstances around the criteria had not changed so why had the vote changed so drastically? The answer is that criteria are not being considered.

Laguna Beach High School would suggest the following adjustment to the current league placement. Laguna Beach and Laguna Hills high schools to the Pacific Coast League making it the Pacific Coast Conference.

Corona Del Mar high school replacing Laguna Hills in the CVAA.
Sunset League returning to a six team league.
This does not affect 8 of 11 league alignments. The Sunset league would prefer going back to a six team league as opposed to the current eight team alignment.

This provides Laguna Beach and Laguna Hills with requested and appropriate league placement by criteria.

Corona Del Mar fits with the CVAA with regards to competitive equity. Geographically the CVAA is a little further in miles but shorter on drive time.

Laguna Hills High School (LHHS) is appealing the 2018 placement in the Coast View Athletic Association (CVAA) based on two of the three criteria: school enrollment and competitive equity. LHHS has seen a steady decline in enrollment through the previous two releaguing cycles, which has created issues of competitive equity program-wide. Several proposals placed LHHS in an eight team conference configuration. Unfortunately, the final vote did not grant Laguna Hills High School the relief requested. The following data support LHHS' appeal based on school enrollment and competitive equity:

Enrollment Decline
Laguna Hills High School


LHHS enrollment has dropped from 1773 in 2008-09 to 1585 in 2016-17. This window spans the past two releaguing cycles, the duration Laguna Hills High School has been placed in the Coast View Athletic Association. Depth of roster and player safety have become a concern as the number of athletes program-wide have dwindled. Every program has been impacted and in
some cases levels are not offered. All LHHS sports have seen a numerically significant decrease in participation rates.

The other Coast View Athletic Association school enrollments range from 2135 to 3078. Laguna Hills High School competes against schools with 500 to 1400 more students enrolled. This is not an appropriate placement based on enrollment, and has been a contributing factor to the decline in LHHS enrollment since placement in the Coast View Athletic Association.

## Competitive Equity

Laguna Hills High School fields 24 sports with a potential 120 league championships. Over the last four-year cycle, LHHS accrued a total of nine league championships: wrestling(3), volleyball(1), cross country(2), soccer(1), water polo (1) and swim (1) for a total of $8.8 \%$ of possible league championships. LHHS has garnered a few victories from 2012 through 2016, however, from a program-wide perspective, the records depict a troubling scenario. The additional attachment (LHHS_Profile_2017) is the Laguna Hills High School profile from the Orange County Releaguing process. It shows an athletic program that has struggled on almost every front for the duration of the last cycle. The data is compelling, particularly when factored together with enrollment decline and the challenges of a small school setting. Competing against significantly larger schools and athletic programs has been detrimental, and continued placement in the CVAA perpetuates the concern of depth of roster and player safety. Laguna Hills High School needs an alternative placement to the Coast View Athletic Association.

## Proposal

Laguna Hills High School would like to propose the following:

- Join Laguna Beach High School and Laguna Hills High School with the Pacific Coast League, creating the Pacific Coast Conference.
- Replace Laguna Hills High School with Corona Del Mar High School in the CVAA.
- The Sunset League returns to a six team league configuration.
- The remaining leagues remain as voted on at the May 8th releaguing meeting.

This proposal provides LHHS with the relief requested based on enrollment and competitive equity criteria. Placement in a conference configuration with schools of similar rankings creates a competitive balance for Pacific Coast League schools as well. Over the past four-year cycle many Laguna Hills sports have played Pacific Coast League schools in non-league contests and the record reflects competitive equity. Both Laguna Hills and Laguna Beach High School are placed in a configuration with better enrollment balance.

## Voting according to the Bylaws

- Mr. Brennan reviewed the voting protocol according to the Bylaws (specifically 38.0 -
49.0) He stated, "At this meeting, we will review new league proposals, vote to a final five (5) initial proposals to three (3) initial proposals to two (2) initial proposals to the final CIF proposal. Each school may vote for only one proposal (each time) as we move from five (5) to three (3) to two (2) and the final CIF proposal. All principals or their administrative designee will have three (3) minutes to speak for or against the new league proposals. I will ask for the number of people who request to speak. Only a principal or their administrative designee may speak. No one will speak for or against the top three (3) or more proposals from the March 27 meeting. The same voting protocol will be performed to determine the final five (5), three (3) and two (2) proposals. If necessary, I will call for a caucus of no more than thirty (30) minutes for New League Proposals or each of the final five (5), three (3) and two (2) proposals. A motion will be passed. A second motion will be passed. Discussion will be held ( 3 minutes per principal or administrative designee). I will call for a vote. Each principal or administrative designee will digitally vote as we move to five (5), three (3) and two (2) proposals. (See Bylaws 16.0, 17.0, 27.0 and 28.0) Digital voting will be distributed and all schools will have one yes vote. Digital voting will be displayed on a screen for all member schools to view. This protocol will be followed until there are two final proposals. Passage of a motion to approve the final CIF Proposal will be approved by a sixty percent (60\%) majority vote. Therefore, one of the last two proposals must receive a sixty percent (60\%) majority vote. If a proposal receives a sixty percent (60\%) majority vote, voting ceases and that proposal will represent the area as its selection and will be immediately forwarded to the CIF office. (See Bylaw 16.0). If neither final CIF proposals receives a $60 \%$ approval ( 45 votes), there will be a caucus by leagues. (See Bylaw 17.0)."
- Mr. Mark Cunningham (University High School) requested clarification regarding a counter proposal. "The counter proposal that was presented is the same as an initial proposal from the last meeting that was not approved in the top three (3). Is this counter proposal acceptable per the Bylaws?" Mr. Brennan replied, "We did not find anything in the Bylaws that prevents an initial proposal from being a league requested counter proposal. Therefore, the Sunset league counterproposal is appropriate and approved."
- Mr. Brennan provided a few minutes (3 minutes) for everyone to review the Bylaws.
- During this time, Mr. Brennan expressed that one league did not post their counter proposal into drop box before the deadline of 11:59 p.m. on March 15, 2017. Unfortunately, their counter proposal was not approved."
- Mr. Brennan reviewed, "One league posted their counter proposal, but withdrew it before 11:59 p.m. because they accidently posted the wrong proposal. They reposted a different counter proposal before the 11:59 p.m. deadline. After reviewing the Bylaws, this is acceptable because the counter proposal had not been numbered we had not numbered and it was posted into Drop Box before 11:59 p.m. on March 15, 2017.
- Mr. Brennan clarified the voting protocol again. The reason for this was that a few schools believed that it should be three votes. ## Commissioner Wigod:

I first wanted to thank you for all that you do in overseeing all of the athletics for our CIF-Southern Section. I know it must not be an easy job and you are tasked with making some difficult decisions as well. There has been a recent decision pertaining to re-leaguing our school for the 2018/2019 school year that will severely impact our school and our athletic programs.

It is my understanding that as of the 2018/2019 school year that we will be going from our six-team league down to a four-team league that includes Rancho Christian, Carnegie, Temecula Preparatory, and us (Santa Rosa Academy). We are concerned with this league alignment due some of these schools not fielding full athletic programs or potentially dropping programs, as well as proximity with Carnegie moving to Upland in the future.

As a public charter school, our funding is limited and we attempt to minimize our costs by not scheduling teams that are too far away from our area, as well as not obtaining buses for unnecessary trips. We will be facing the potential of forfeiting any games against Carnegie where we will be required to travel to Upland due to school funding.

We also do our best to field all of the major boys' and girls' sports teams even though we are a small high school with approximately 525 students enrolled. It makes it difficult when we have multiple teams in our leagues that do not field all of the major sport's programs as it does require us to find teams who may not be in our area to play in order to fill our team's schedules.

One solution to this would be to form a league of teams that are in close proximity to us including: Nuview Bridge, California Military Institute, Temecula Preparatory, and San Jacinto Valley Academy. This would lower the financial strain from all of us. Another potential solution would be to combing the two four-team leagues that will be in place for the 2018/2019 school year with the teams scheduling league games annually with the teams closest in proximity to them.

I am hoping that you will be able to reconsider some of the decisions made pertaining to the leagues that were determined for the 2018/2019 schoolyear. I would also like to invite you out to our school for a tour of our facilities and to discuss this further if you are available to do so. Please do not hesitate to contact me and discuss this further as we are in hopes that you will take a second look at this and help us feel supported as a Character Award Winning school.

To whom it may concern
My name in Michael Hargis. I am the new athletic director of Western Christian High School in Upland California. I would like Western Christian to be reconsidered for the releagueing efforts. My reasons are as follows:

## 1) Athletic Equity

We struggle to compete in our current league. In many of the sports we participate in, the teams we play are all in much higher playoff brackets than we are. (For example: In football all of the teams we play are in DIV 8,9 or 10 for playoffs while we are in Div. 13) We continue to struggle to keep up with them, which creates an atmosphere of low expectations. Our school is fairly small (450 students) and a large portion of these students (25\%) are international students who are just being introduced to American sports. We spend a great deal of time working with them and other students to teach each sport. At present, we compete with larger schools that are able to have full JV and varsity programs. Some of these schools can even fill a freshman squad. We however struggle in many of our sports to fill a team.
2) Athletes safety

Also a concern of mine is player safety, particularly with football. Many of our athletes are first time athletes and are being taught the very basics. It can be a safety concern when they are going up against athletes that are Division 1 and 2 commits. It is not fair to ask these athletes to hold back when they play us and it is a safety concern to have our athletes play against them. Also with the smaller size of the program it is difficult to properly train the athletes in the off-season to be able to handle the rigors of an upcoming season. Many of our athletes play multiple sports which allows them to have a good high school experience but the it also leaves the coaches less time with each athlete to get them ready for the next season. This can lead to athletes incurring injury and also does not allow them enough time to spend in the weight room and in training to be as prepared as other schools in our division.
3) Travel Distance

I would like the opportunity to play schools closer to us so that we are not taking as many trips down to areas like Temecula and Murrieta. This excessive traveling creates added cost in transportation. At present we take multiple trips for basketball, volleyball, as well as soccer, which drives the price of transportation up for a small school. By being closer to home could save our program $\$ 1500$ per sport just in transportation.
Western Christian's small budget mixed with these high cost of transportation make it hard to add sports and maintain the quality of
the existing ones. The Travel distance also hinders the athletes to maintain a high level of academics. When they are traveling for 4 hours on a school night twice in a week the homework load can become overwhelming even to a disciplined student.

Any considerations for placing Western Christian into a different league would be greatly appreciated
