



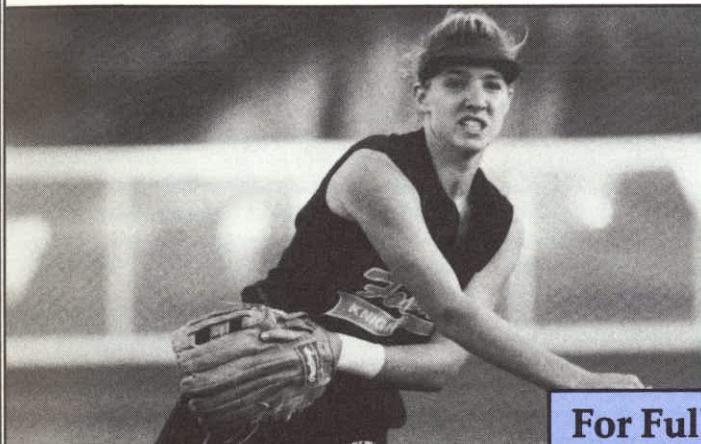

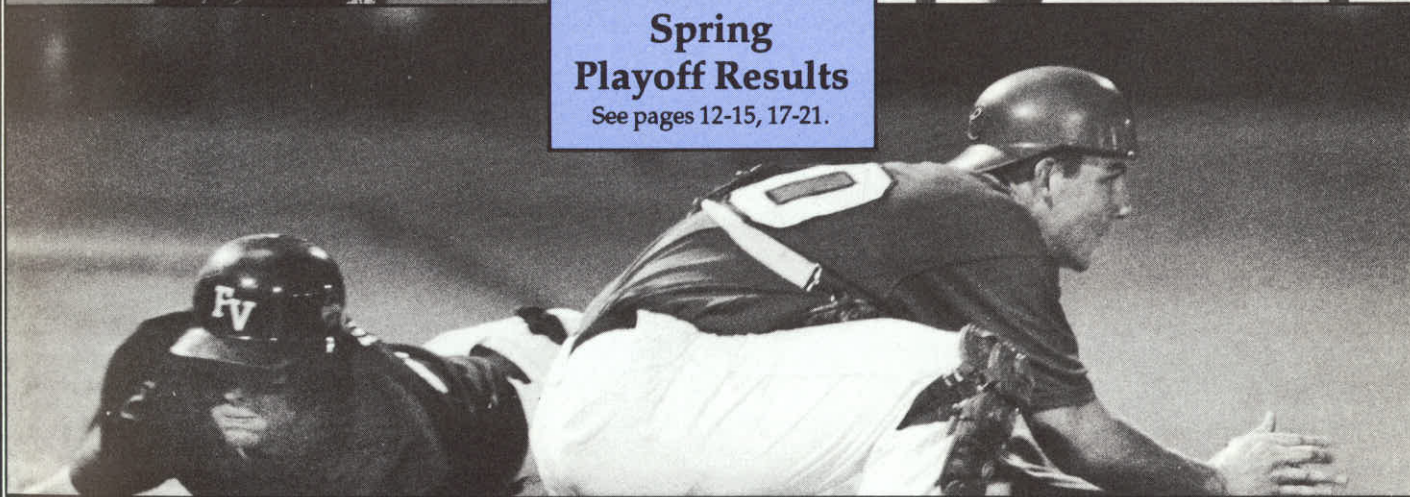

## PRESIDENT'S MESSAGE



**Playoff Regionalization: Has the time come?**

The formation of playoff groupings is one of the most controversial, time consuming, and overall negative experiences we all face. Invariably, even after lengthy appeal processes, no one feels they've won. Even worse, many feel they have been unjustly treated. Why does this continually occur? Why can't we design a process that eliminates or at least greatly reduces these perceived inequities. I believe the answer to both questions lie in our criteria. Competitive equity and geography can and often do lead to drastically different solutions. All of us want to be in a playoff group where we can win, where travel expenses don't kill us, and where our student/athletes and coaches don't have to miss large portions of the instructional program to participate. When any of these three don't exist in our groupings, we are dissatisfied. If two don't exist we are angry. The horror stories of past experiences are resurrected and used to prove that once again "We are getting hung by CIF." How often have you heard those now familiar refrains "We are a first place team and drew a tougher opener than the 'at-large' team," "We are a third place team and had to travel 250 miles to get beat," "Our athletes missed a whole day of school to get to the game and were too tired to come to school the day after," or my favorite, "If we have to play them, our kids will be physically injured. Isn't it time to at least look at something else?"

Suppose for a moment that it was possible to divide our section into 3, 4, 5 or even 6 playoff regions with approximately the same number of schools. Ideally these mythical regions would have an even distribution of small, medium, and large schools. The formation of regions would address the criteria of geography. Within each playoff region, schools would then be grouped solely on the basis of competitive equity. Regional champions at all levels would compete for the Southern Section Championship. If the true purpose of our playoff system is to determine a section champion, this idea would appear to be viable. If the purpose is to assure that the two best teams meet in the finals, it isn't. Obviously the two best teams could be in the same region and one be eliminated in an earlier round. Would a region format cut transportation costs, reduce out of class time for athletes and coaches, and increase local interest? We need to look closely to see.

## CIF-SS COUNCIL MEETING MINUTES April 28, 1994

The April meeting of the CIF-SS Council was called to order by Dr. Gary Smidderks at 9:06 a.m. on Thursday, April 28, 1994 at the Sequoia Athletic Club. All leagues were present with the exception of Express, Sunshine, Valley and Westside.

1. **MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 10 and minutes of the CIF-SS Executive Committee meeting of April 14, 1994.

2. **GOLD LIFE PASS/HALL OF FAME PRESENTATIONS** -- Those receiving Life Passes in recognition of their long standing service to the CIF-SS were introduced. Recipients were Lou Joseph, former Superintendent of South Pasadena Unified; Joe Rotcher, Torrance High School and Jim Graham, Gladstone High School. Additionally, the Hall of Fame honorees were: Dick Salter, Arcadia High School and Bob Betty, San Geronio High School.

3. **CITRUS BELT BASKETBALL PROPOSAL** -- Bob Hahn, Citrus Belt League Representative, presented a proposal asking that Blue Book Rule 1620 be deleted for the 1994-95 year since basketball officials fees are for single games only. This is a non-action item and will be voted on at the October 1994 meeting of the Council.

4. **LIBERTY LEAGUE PLAYOFF REVENUE PROPOSAL** -- Eric Walter, President of the Liberty League withdrew the proposal providing

for all playoff revenue to be returned to the Section. This item will be reintroduced at the October Council meeting.

5. **BLUE BOOK COMMITTEE PROPOSAL** -- Lawrence Strauss, Chairman of the Blue Book Committee reviewed the following items from the Blue Book Committee:

a) **Bench Conduct Rule (All Sport Sections)** -- Any player ejected for fighting or any player who leaves the confines of the bench or team area during a fight that may break out or has broken out shall be disqualified from participating in the remainder of the game and will be ineligible for the team's next contest was approved.

b) **Coach Ejection (Rule 125.1 and All Sport Sections)** -- Upon ejection, the head or assistant coach shall be disqualified from participating in the remainder of the game and will be ineligible for the team's next contest was approved.

c) **Rules 1622/3100.2** -- A recommendation requiring that on the last Saturday of competition no basketball contest be scheduled later than 5:00 p.m. was approved.

d) **Article 600 (Competition on an Outside Team)** -- a proposal recommending the repeal of State Rule 600 was defeated.

e) **Co-Champion Football** -- A recommendation that for the sport of football the tie breaker provisions in the National Federation Rule book be utilized and a champion be declared rather than

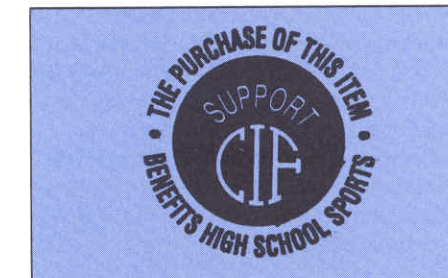
### VONS CONTRIBUTES TO HIGH SCHOOL ATHLETICS

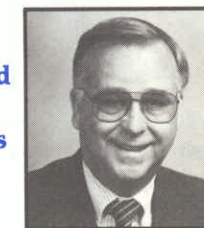

Daniels has served on numerous professional growth and assistance committee and workshops throughout her career. She is a member of the CIF-SS Blue Book Committee.

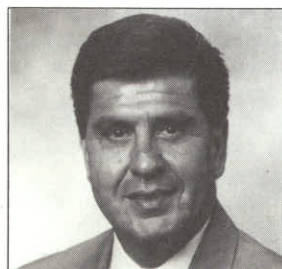
She holds a PhD from UCLA in Education, with a specialization in research methods and evaluation.

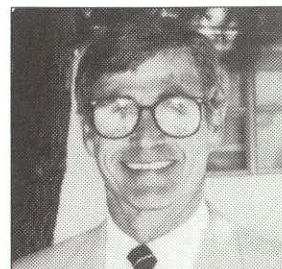

# MINUTES OF THE EXECUTIVE COMMITTEE MEETING

## April 14, 1994

The April meeting of the CIF-SS Executive Committee was called to order by Dr. Gary Smidderks at 1:06 p.m. on Thursday, April 20, 1994, in the conference room at Anaheim Stadium. All members were present with the exception of Fr. Robert Gallagher, Dr. James Fleming and Edna Her-ring.

**1. PRESIDENT'S UPDATE** - Dr. Gary Smidderks announced that the State CIF Section Relations Committee will be meeting on Monday, April 18, 1994, to consider the Orange County Section request. Additionally, he reviewed the Liberty League Playoff Revenue Sharing Proposal.

**2. CLOSED SESSION** - At 2:10 p.m. the Executive Committee moved, seconded and passed to go into Executive Session to discuss a personnel matter. At 2:43 p.m. the Committee returned to regular session.

**3. MONTCLAIR PREP SOCCER VIOLATION** - Dean Crowley, Acting Commissioner, introduced Greg Reece, Assistant Principal of Montclair Prep who reviewed with the Committee the violation of playing an ineligible player during the playoffs. Following discussion it was moved, seconded and passed to deny Montclair Prep boys soccer team entry into the 1994-95 Southern Section playoffs. In addition, Montclair Prep was requested to review guidelines and procedures with reference to coach orientation and appropriate administrative procedures to insure this type of violation does not occur in the future.

**4. ACTING COMMISSIONER'S UPDATE** - Dean Crowley, Acting Commissioner, reviewed with the Committee the passing of former South-

ern Section Commissioner, Ken Fagans, status of School of Choice Legislation as it affects eligibility, the positive completion of winter playoffs, the Marmonte League sportsmanship issue, the CIF-SS Golf Tournament sponsored by Herff-Jones and the positive response with reference to the Advisory Superintendent's Committee. In addition, he discussed the summer National Federation meeting to be held in Palm Springs. Following discussion, it was moved, seconded and passed to give approval for the treasurer to attend the summer meeting. Finally, he reviewed plans for the upcoming August Executive Committee meeting.

**5. GIRLS' ATHLETIC DIRECTOR REPRESENTATIVE** - Girls' A.D. Representative, Donna Gunstream reviewed with the Committee a program for athletic scholarships, concerns regarding soccer officials, awards presentations and materials currently available regarding sports injuries.

**6. BOYS' ATHLETIC DIRECTOR REPRESENTATIVE** - Boys' A.D. Representative, Donn Clickard reviewed with the Committee the continuing efforts to establish a uniform spring break in the Northern area, the information from the Symposium, "Best of Southern Section" being sent out to all schools and volunteered to work with Montclair Prep in education of coaches.

**7. TREASURER'S REPORT** - Tom Triggs, Treasurer, reviewed with the Committee the winter playoff financial reports.

**8. STATE CIF REVIEW FOR MAY MEETING** - Dr. Tom Jacobson reviewed the following items for the May State Federated Council meeting.

## GOLD LIFE PASS AWARDS WINNERS HONORED

### DR. LOU JOSEPH

Dr. Lou Joseph has been a teacher, administrator and superintendent since 1951 when he began his teaching career at St. Anthony High School in Long Beach. From 1969-70, Dr. Joseph served as administrative assistant for the CIF Southern Section under the late former Commissioner Ken Fagans. Dr. Joseph was the principal at Villa Park and Canyon/Anahiem High Schools and has been the superintendent for the Antelope Valley Union High School District and, most recently, the South Pasadena Unified School District. Dr. Joseph lives in Anaheim.

### JOSEPH ROTCHER

Joe Rotcher has dedicated some 34 years of service to students in the Torrance Unified School District. Rotcher began his teaching career at South High School in 1959. He was activities director, dean and counselor at South High from 1960-

66, assistant principal at West High from 1966-69, principal at South High from 1970-87 and principal at Torrance High from 1987-93. ## RULE REVIEW



### Open Enrollment

We are receiving a lot of questions at the CIF Southern Section office about the Open Enrollment rule.

Open Enrollment is legislation passed through the state of California and although it is not without precedence in many districts in the state, it certainly is unique for the entire state. The CIF has developed guidelines as it relates to implementation of Open Enrollment as part of Article 2, Section 222 of our Southern Section Blue Book. A great deal of time and effort has gone into development of this section. It is hoped we have taken into consideration all contingencies.

We will be constantly reviewing this rule as needed and will also be providing more information to schools. This article will simply attempt to provide an overview of the concept of open enrollment.

As it relates to CIF eligibility, Rule 222 is for public, private and parochial schools and states:

"Any student transferring under the provisions of an open enrollment board policy, public or private, will have immediate residential eligibility upon transfer from school A to school B, subject to the following limitations:

a) Only one transfer is allowed during the student's high school career after the initial enrollment as a ninth grader in a four-year high school or as a 10th grader in a three-year high school.

b) The transfer must be completed during the first 15 days of the new school academic year at school B.

c) The transfer must not be as a result of disciplinary action.

d) The receiving school B must certify that no consideration was given to the athletic performance of the student in accepting the transfer."

It is critical for each school district to have a specific open enrollment policy as the

## MINUTES OF THE EXECUTIVE COMMITTEE MEETING June 24, 1994

The June meeting of the CIF-SS Executive Committee was called to order by President Dr. Gary Smidderks at 1:26 p.m. on Friday, June 24, 1994, at the CIF-SS Office. All members were present with the exception of Dr. Debra Bradley, Dr. Tom Jacobson, Frank Cano, Donn Clickard and Bill McKinley.

1. **PRESIDENT'S UPDATE** -- Dr. Gary Smidderks reviewed with the Committee highlights of the CIF-SS Office Staff meeting of June 21. In addition, he commended the staff on their perseverance and dedication during a difficult year.

2. **COMMISSIONER'S UPDATE** -- Acting Commissioner Dean Crowley reviewed with the Committee the upcoming Herff Jones/CIF-SS Golf Tournament on July 25, the National Federation meeting July 5-10 and the Cavalcade of Champions in September to be put on in conjunction with the Rams. He also reviewed the football playoff grouping process, a new hardship appeal form, the new open enrollment policy and the revised format for the August Executive Committee meeting. Additionally, Acting Commissioner Crowley discussed the Brea-Olinda HS grade changing situation and possible effect on athletic eligibility. Following discussion it was moved, seconded and passed to direct Acting Commissioner to secure an explanation from the Brea-Olinda School District regarding the grade changing situation and its affect on athletic eligibility. Finally, Acting Commissioner Crowley reviewed the ending of spring sports and the positive ending of a difficult year.

3. **TREASURER'S REPORT** -- Tom Triggs updated the Committee on the spring playoff financial status. Gary Smidderks discussed the recommendations for the vacant sports on the Finance Committee and the new employee handbook. Following discussion, it was moved, seconded and passed to adopt the revised employee handbook. Additionally, President Smidderks discussed the need to upgrade current office computer equipment. Following discussion, it was moved, seconded and passed to upgrade the of-

fice computer equipment. Additionally, the Finance Committee will study resources as they relate to future needs.

place finish in a team place-finish sport. In cases where ties occur for the 10th place, total team-sport playoff appearances will be used to determine the top 10 schools. Each of the schools will be presented with an attractive banner for permanent display on campus.

From the Rams perspective, the program indicates a sincere desire to give something back to the community by recognizing student/athletes for their outstanding accomplishments.

"It is a pleasure to be associated with the CIF-SS and this fine recognition program. I congratulate the high schools who have earned the opportunity to be present at the awards ceremony," said Los Angeles Rams Head Coach Chuck Knox.

### EXHIBITING "CLASS" IS VITAL IN ATHLETICS

Whether it be as a coach, fan, administrator or player, we all recognize the element of "class" in athletics when we see it. Obviously, we also can easily detect the opposite behavior or approaches, those which lack class. However, even though "class" is easily observed, it is somewhat difficult to succinctly define.

When thinking about "class," it may be easier to illustrate some example which unfortunately occur in athletics and lack this quality. For example, we all might agree that the following are lacking in class:

- With a big lead, late in a basketball game,

the coach still has his or her team pressing.

- In a football game, the quarterback is still passing when his team has an insurmountable lead late in the game.

- Near the end of a contest, with a team having a big lead, there are still players sitting on the bench who have yet to enter the game.

- Despite the score or whatever team is leading, players taunt their opponents or engage in unsportsmanlike actions.

- While an opposing player attempts a foul shot or at other times in the game the fans use inappropriate language or gestures.

- Late in a football game in which his team has a large lead, the coach employs an onside kick.

The offending basketball coach in some of these examples might defend his or her actions by stating that, "No lead is safe with the three-point shot." Or perhaps, "You have to keep your starters sharp," might be another common rationale. Regardless of the reasons given, there is simply no justification. The lack of "class" is the only expression which applies.

## CIF-SS HALL OF FAME INDUCTEES NAMED

The CIF Southern Section Hall of Fame Recognition Award has two names to add to its list of recipients, with the induction of Robert Betty and Richard Salter.

The CIF-SS Hall of Fame Recognition Award was created in 1984 to bring public recognition to the numerous individuals who have contributed directly to the advancement of interscholastic athletics within the geographic boundaries of the organization.

"This award is a tribute to the individuals who have shown devotion, commitment and performance in the interscholastic athletic community over an extended period of time," said Dean Crowley, Commissioner of Athletics. "Congratulations to these most deserved recipients."

A biographical look at the 1994 inductees follows:

#### ROBERT BETTY

Bob Betty was the first athletic director named at San Geronio High School when it opened in 1965. His accomplishments were numerous, including being the first athletic director in the city of San Bernardino to push for equal opportunities for all athletes. He did this at San Geronio by supporting the first girls' soccer team in the city.

Bob also created a community involvement program on campus that supported Junior All-American teams and allowed city recreation sponsored activities to take place on the San Geronio High School campus at the end of the school day and on weekends.

Bob worked closely with Gene Knott and Clyde Francisco in the Inland Empire in solving problems that faced the area with regard to relegating, scheduling and the instituting of girls athletics in the CIF Southern Section in 1974.

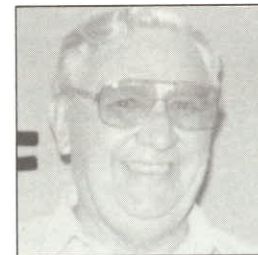
One of Bob's greatest accomplishments was the role he played in organizing the Citrus Belt Athletic Directors Association. He was one of its original members, president for one year and secretary-treasurer for three years. Betty also served on the board of directors for 10 years. The organization has played a major part in contributing to the CIF-SS and informing athletic directors in the area. Additionally, he helped organize a District Eligibility Committee.

Betty graduated from Charlotte High School in Charlotte, Michigan, before attending Alam College in Michigan, Michigan State University and the University of California at Riverside.

From 1965-67, Betty served as football line coach at San Bernardino High School, while coaching the junior varsity there.

From 1968-70, Betty was assistant varsity football coach at San Geronio High School. He also was co-head junior varsity coach and head coach of the B football team, which had a combined record of 16-1-1 in 1969. Betty also was boys basketball coach in 1969 and assistant varsity baseball coach in 1970.

Betty was named Athletic Director of the Year in the Citrus Belt League in 1990 and was voted into the Citrus Belt Athletic Director Association Hall of Fame in 1991.



Betty is a member of the Michigan Coaches Association and California Football Coaches Association. He also worked in the community as a manager and coach in the Del Rosa Little League.

From 1961-65, Betty worked as an official at high school basketball games in the Inland Empire. He served as co-chairman of the San Bernardino Kiwanis Basketball Tournament for 10 years.

#### RICHARD SALTER

Richard Salter has been involved in high school athletics for more than 40 years, beginning in 1952 when he coached Villanova Prep in football, basketball and baseball. Most of his career was spent at Arcadia High School where Salter directed the football team as head coach for 23 years and many outstanding seasons. His 1970 team went undefeated and his 1977 and '78 teams advanced to the divisional finals.

In addition to football, Salter coached basketball, baseball and wrestling at Arcadia. Previously, he coached football, basketball and baseball at Arroyo High School in 1957 and football and baseball at Cathedral High School from 1957-69.

Salter was Coach of the Year in the San Gabriel Valley in 1970-71 and head coach of the Shrine All-Star football team in 1971 and '78. He was 1986 Teacher of the Year for the Arcadia Unified School District and 1993 winner of the Clare Van Hoorebeke Awards by the Southern California Interscholastic Football Coaches Association.

Salter served as athletic director at Villanova Prep for four years, at Cathedral from 1957-69 and at Arcadia from 1969-92. In 1992, Arcadia High Stadium was named after Salter.

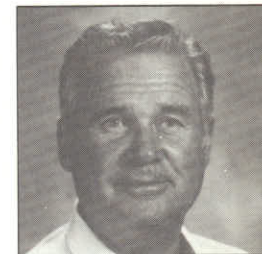
Salter belongs to a long list of professional organizations and was instrumental in assisting the CIF Southern Section over the years. Among his professional affiliations are with the CIF Football Advisory Committee and as a member of the Board of Directors of the National Football Foundation for Scholar Athletes. He attended many CIF meetings as a league representative of the Catholic League.

Salter also is a member of the Southern California Interscholastic Football Coaches Association, the Fellowship of Christian Athletes, the California Coaches Association, the Shrine Game Selection Committee and the Coach of the Year Clinic Committee.

Among other accomplishments, Salter initiated the Certification Program for Walk-On Coaches through Pasadena City College and addressed the State Board of Education on the subject of "Walk-On" Coaches.

Additionally, Salter served 16 years as a CIF basketball official. Born in Upland, Salter attended John Muir High School in Pasadena, received a Bachelor's degree from the University of Oregon and a Master's from USC.

He and his wife, Nancy, reside in West Covina.

CALIFORNIA TRACK & FIELD ATHLETE  
MAKING WAVES IN HIGH JUMP

By John Gillis

Having cleared the crossbar at a lofty 7-feet-4, high jumper Jeremy Fischer of Camarillo High School owns not only the nation's top outdoor high jump of 1994, but also one of the all-time best efforts.

Making Fischer's feat even more remarkable is the fact that he stands just 5-9. In a sport generally dominated by athletes six feet and taller, Fischer has jumped a prodigious 19 inches over his height. The all-time best high school boys high jump was recorded by Dothel Edwards of Athens (Geor-

gia) Cedar Shoals High School, who leaped 7-5 ¼ in 1984.

A basketball point guard through his junior year, Fischer dazzled onlookers with his 35-inch vertical jump and repertoire of dunks. This year, he elected to bypass basketball to focus on high jumping.

During his career, Fischer already has made great year-to-year strides. As a freshman, he cleared 6-4. The following year, he increased that to 6-11½ and placed fourth in the state meet. During his junior season, he

went 7-2 and placed second in the state meet. Despite the fact that he already has added another two inches this year, Fischer feels he has potential to go higher yet.

"I feel I still have a lot of room for improvement, which is a scary thought," Fischer said. "The thing I like best about high jumping is the fact that it is a one-person sport. If you do badly, you have nobody to blame but yourself. If you give

100 percent, you'll get 100 percent; if you give 80 percent, you'll get 80 percent.

"I love to watch Hollis Conway (former Southwestern Louisiana University high jumper who set the National Collegiate Athletic Association record of 7-9 ¾ in 1989), but I don't pattern my style after him. I have a different style. I lead with my arm when jumping, but I don't use it for power. Also, I point my toe outward, at a 180-degree angle, instead of in a diagonal direction, which is how most jumpers do it. It's not technically the best form, but it works, so I'll stick with it.

"I've been lucky to have a great coach. Coach (Dennis) Riedmiller is one of the elite high school track coaches in America. He is a former high jumper who also participated in track at Southwestern Louisiana University."

"In addition to his great leaping ability, Jeremy possesses a great mental attitude to compete," said Riedmiller. "He's only 5-9, and he often jumps against much taller guys."

Fischer, who maintains a 3.4 grade-point average and is on the school honor roll, helps coach the girls softball team and referees young kids basketball during his spare time. This fall, he will enroll at the Univer-

sity of Wisconsin, where he plans to major in biology/pre-medicine, with an eye toward a career as an orthopedic surgeon.

"I just want to work hard next year both in the classroom and in track to earn the scholarship the University of Wisconsin has provided me," Fischer said. "I really enjoy biology and medicine, and I feel I could enjoy a career in that field."

# CIF-SS, DODGERS AND ADOHR FARMS' "SHAKE FOR SPORTSMANSHIP" PROGRAM IN ITS 12TH YEAR

Recognized as perhaps the most positive of all CIF Southern Section activities each year, the 12th annual "Shake for Sportsman-ship" awards were presented to representa-tives of selected member schools at Dodger Stadium on May 11. Once again, the pro-gram was able to take place due to the generous co-sponsorship of the Los Ange-les Dodgers and Adohr Farms Dairies.

"I wish to commend the Dodgers and Adohr Farms for their efforts in the Shake for Sportsmanship awards," said Dean Crowley, CIF-SS Commissioner of Athlet-ics. "Sportsmanship is one of the most im-portant aspects of interscholastic athletics."

The Shake for Sportsmanship program provides recognition for schools singled out by a vote of their peers -- the members of

their respective leagues -- for outstanding sportsmanlike conduct throughout the school year.

Each of the winning schools were pre-sented with championship plaques pro-vided by Adohr Farms in a ceremony prior to the Dodgers-Houston Astros game.

"The CIF Southern Section appreciates being associated with this most outstand-ing program," Crowley added. "The receiv-ing schools are to be commended for the direction provided by their administrative and coaching staffs and especially for the positive actions of their student body mem-berships."

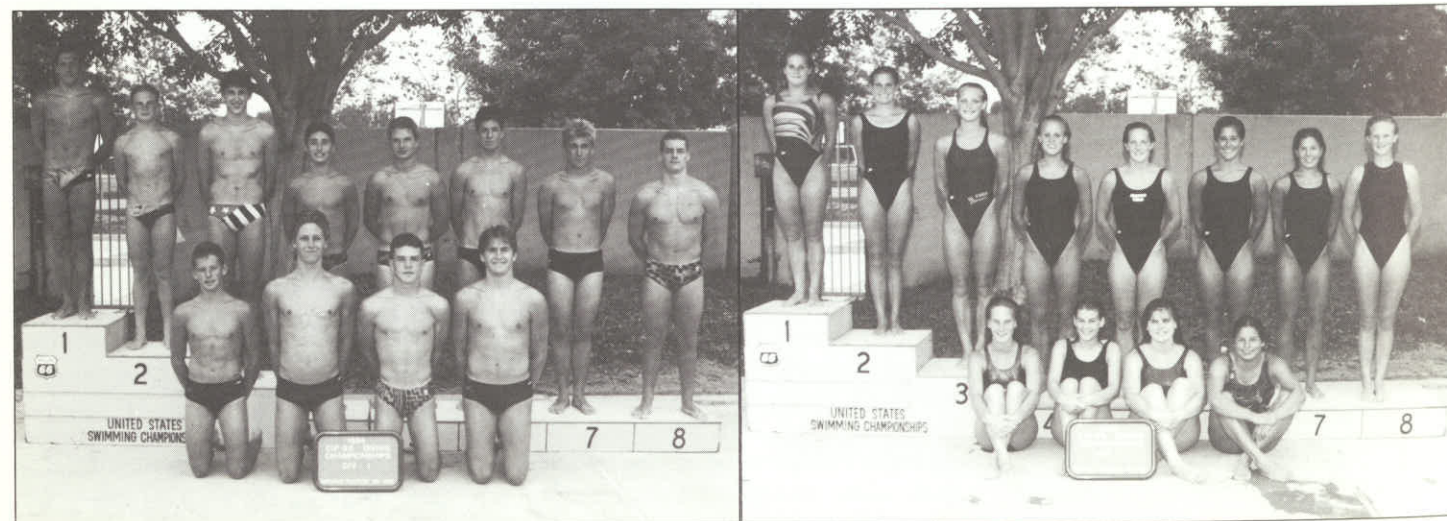

# LONG-LASTING LESSONS CAN BE LEARNED BY FINISHING ON SHORT END OF SCORE

It is a cliché, perhaps, but one that you have probably heard a sportscaster or two use.

A team puts together a tremendous rally, makes a big comeback and wins in the waning seconds to "snatch victory from the jaws of defeat."

Unfortunately, I think the converse of that can be true as well. A team can be coasting along on top and suddenly self-destruct and lose at the final buzzer. In the same fashion, we can take a good situation, one that could be very valuable and even memorable, and do something that messes it up. We can snatch defeat from the jaws of victory, too.

Perhaps I think of the switch on that phrase when I reflect on a few things that have happened thus far this year. No trends, no massive ground swell, but enough to give us pause.

One of the functions of a state association, of course, is to conduct championships. The very nature of a championship game, naturally, is to have one overall winner (and some would say, as a result, one loser, although I would argue that anyone who makes it to a state championship or state tournament is certainly not a loser). But we know that there are situations which may arise in the context of these sorts of competitions in which athletes, coaches or spectators are not happy with the outcome.

I have seen many athletes and teams handle the disappointment of defeat in a state final with grace and class. I remember seeing Rosewood's football team applaud as mem-

bers of the Murphy team received individual awards after Murphy had downed Rosewood for the 1-A championship, to cite one example.

Unfortunately, there have been some recent examples where the great learning process we call life -- of which high school athletics can be an integral part -- has been short circuited. A coach and his players complain bitterly and loudly about the officiating -- while they ungraciously accept their runner-up awards during the post-game ceremony. A state runner-up in men's tennis hurls his award into the stands as he stomps away from the ceremony. A runner-up football team refuses to stay on the field for the awards ceremony since it didn't win the championship.

I believe there are some wonderful, albeit somewhat painful, lessons which can be learned from coming up on the short end of the score. If high school athletics are not preparing young people for the certainty of winding up in second place on occasion, we are not only missing a tremendous teaching opportunity but sending the wrong message about what life will be like away from the playing field or court.

I know that society at large often reacts this self-centered way, but high school sports may be one of the last opportunities to teach the archaic notions of fair play, sportsmanship and clean competition. And from the looks of our culture, those may be extraordinarily valuable notions to learn.

As the NCHSAA Handbook has stated for the last 40 years or so, "Competitive athletics cannot be justified as a part of the school program unless it contributes to a wholesome rounding out of the personality of the participants and the spectators. We shall therefore insist on hard but clean play, resulting in honest victory, without conceit or honest defeat without bitterness."

Perhaps we don't take this notion seriously. Maybe some agree with the infamous quote by basketball coach Bill Musselman who said, "Defeat is worse than death because you have to live with defeat."

I may be wrong or perhaps misguided, but I sincerely believe defeat can be turned into victory, in the sense of some lasting, important, transcendent lessons from which an individual can benefit -- lessons that last far after the final score has faded from memory. "Losing," in that sense, does not have to be entirely negative.

But from the looks of things, there are a lot of people whose actions indicate they don't agree with this perspective. Winning isn't everything, it's the only thing. This attitude will continue, I fear, to assist people in snatching defeat from the jaws of victory.

And we will be losers because of that.

1994-95 school year begins. When we must interpret the rule, we will revert back to the board policy to help with the interpretation.

If the board open enrollment policy does not directly address a transfer, then it will be the ruling of the Southern Section office that the transfer is not an open enrollment transfer and thus would fall under Transfer Eligibility Rule 213 or Hardship 214.

While the open enrollment rule certainly gives parents and students much more flexibility as to the school they wish to attend, Undue Influence, Rule 510, is still in place. Coaches and schools cannot contact students because of their athletic ability to encourage them to attend their school.

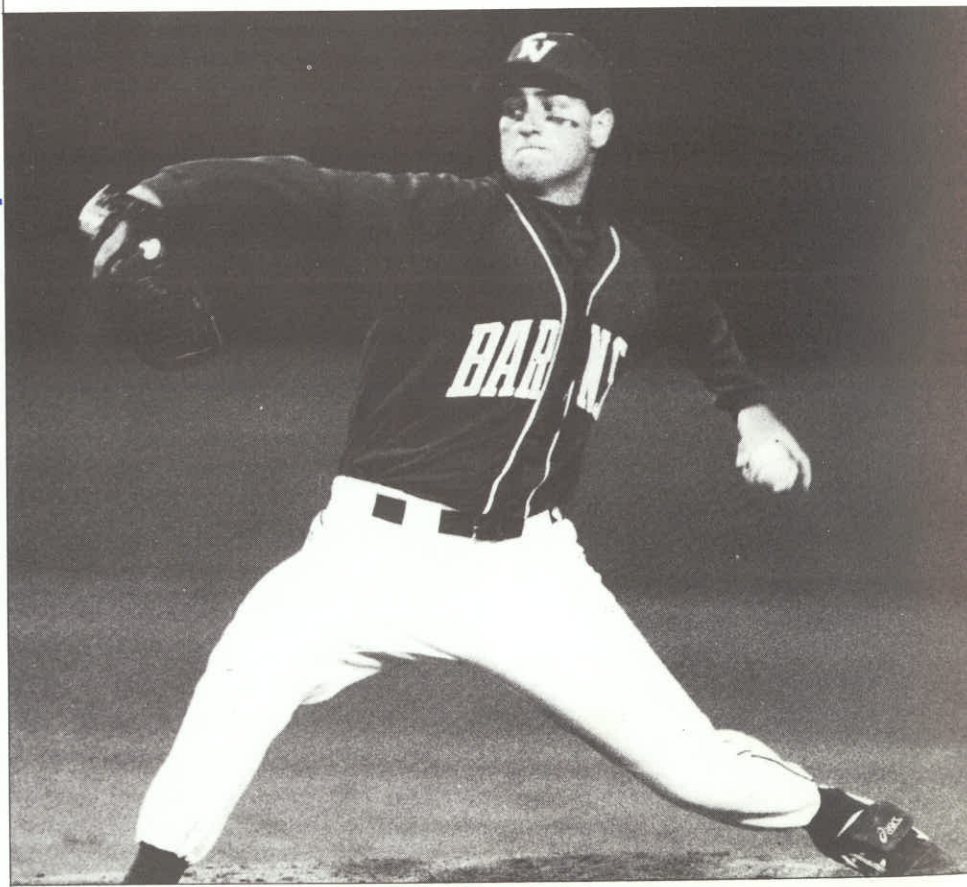

**6. EXECUTIVE COMMITTEE ELECTIONS** - Dr. Scot MacTaggart presented the report of the nominating as it relates to the CIF-SS Executive Committee. Following a vote by the council, those elected were: President-Elect - Tom Triggs, Principal, Buena Park HS; Citrus Belt Area - Dale Mitchell, Principal, Centennial/Corona HS; Coast Area - Margie Godfrey, Principal, Millikan HS; Foothill Area - Tony Ortega, Assistant Principal, Mark Keppel HS; Small Schools Area - Clark Stephens, Principal, Liberty Christian HS.

**7. OFFICIALS' FEES PROPOSAL** - Susana Arce, Chairperson of the Official's Fees Committee, reviewed recommendations of the Officials' Fees Committee for a two year agreement (1994-96) with a \$1.00 across the board increase for the 1995-96 school year. In addition they recommend an adoption of set of guidelines for inclusion into the Blue Book. Following discussion, it was moved, seconded and passed to approve the Officials' Fees section only and pass "A" through "H" of the guidelines for inclusion into the Blue Book as recommendations only.

The following suggestions may not guarantee that the label of "class" will be awarded or applied to a team or coach. These guidelines, however, are a step in the right direction and they certainly are worth adopting as a code of conduct.

- Regardless of personal feelings, never publicly criticize an opposing coach.
- If you lose a game, give credit to your opponent. At least admit that on this given day or occasion, the opponent may have played better. Perhaps the other coach simply did a better job.
- Do not blame a loss on injuries or officials. Over the long haul, these variables always even out among opponents.
- Always participate in the traditional post-game handshake. This simple act sets the

necessary tone for your players and fans.

• Avoid degrading your team publicly in print or verbally, even during games. The correcting of mistakes and criticizing of performance should take place in the privacy of the locker room and during practice session.

Having the element of "class," therefore, is a combination of many things. It is treating others in a dignified fashion with politeness, compassion, courtesy and respect, even under very trying circumstances. Being considerate and positive are certainly involved. Style might be another word which should be included. Or perhaps, exhibiting grace under adversity is what "class" is all about.

"Class" embodies and encompasses all of this. In spite of the difficulty to concisely

define this element in athletics, we do know it when we see it. Athletics are important and certainly a vital component in the total educational scheme of things for most schools and universities. Therefore, the exhibiting of "class" may be more vital and integral than we might imagine. The element of "class" just might be the greatest barometer of athletic success, even more important than wins or losses.
