





## PRESIDENT'S MESSAGE



**Break up the Southern Section, WHY?**

Over the last five years all of us have frequently heard that the Southern Section is too big. We have heard that 505 schools are too many. This is often contrasted with the Oakland Section with six schools to emphasize the point. We have heard that geographically the Southern Section covers too many miles. To bring home this point we often hear the horror stories of playoff travel. We also hear that the big schools' needs control the small schools and vice versa that the small schools' votes control the big schools. What we don't hear is that the Southern Section is poorly run. We don't hear that you can't talk with Dean, Karen, Bill and the rest of the office staff. We may hear that you disagree with a decision but not that the phone call was ignored. For the last two years the staff have made a concerted effort to attend league meetings and listen to area concerns. We don't hear that the Southern Section is deficit spending or that dues have increased. On the contrary, none of us can even remember the time this occurred. Financially 1994-95 was one of the most successful years in the history of the section. The office staff and executive committee are exploring ways to rebate money to leagues or schools. So why consider a "break up"? Lets look briefly at some of the issues.

### NUMBER OF SCHOOLS

What constitutes "too many" or for that matter "too few"? This is a continual debate at the state level. Do we provide the competitive equity which is of utmost importance to coaches and athletes? Are leagues and individual schools involved in the decision making process? My answer to both is a resounding yes. If there appears to be inequity in your league, who made the last relegating decision? I can count on the fingers of one hand the number of times I have seen an area's decision reversed by our council. Is your league given the opportunity to participate in decision making? If you think the answer is no, you haven't attended a council meeting. The vote may not go your way but you certainly had the opportunity to persuade and to cast your vote. Would being smaller improve either of

## CIF-SS COUNCIL MEETING MINUTES April 20, 1995

The April meeting of the CIF-SS Council was called to order by Tom Triggs, President-Elect at 9:05 a.m. on Thursday, April 20, 1995 at the Sequoia Athletic Club. All leagues were present with the exception of the De Anza, Del Rey, Freedom, High Desert, Sunrise and Valley.

**1. MINUTES** -- It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 9, 1995, and minutes of the CIF-SS Executive Committee meeting of April 6, 1995.

**2. GOLD LIFE PASS/HALL OF FAME PRESENTATIONS** -- Dr. Tracy Brennan, Chairperson of the Gold Life Pass Committee introduced those receiving Life Passes in recognition of their long standing service to the CIF-SS. Recipients were Larry Arason, Santa Ana Valley High School; Dr. Wesley Bosson, Temple City Unified School District; Bill Boswell, Huntington Beach Union High School District; Speed Castillo, Anaheim Union School District; Dr. Phil Jones, Downey High School; Sr. Barbara Joseph, St. Joseph High School/Lakewood; Joanne Kellogg, Huntington Beach High School; Dr. Robert Packer, Duarte Unified School District. Additionally, Hall of Fame honorees were: Gene Smith, Official and Harvey Grody, Official.

**3. EXECUTIVE COMMITTEE ELECTIONS** -- Dr. Scott McTaggart presented the report of the Nominating Committee as it relates to the CIF-SS Executive Committee. Following a vote by the Council those elected were: Northern Area -

Susana Arce, Assistant Principal, Nordhoff High School; Orange County Area - Dr. Warren Stephenson, Principal, Western High School; Superintendent Representative - Dr. David Long, Superintendent, Elsinore Unified School District.

**4. CIF-SS 1995-96 BUDGET PROPOSAL** -- Margie Godfrey, Treasurer, presented the proposed 1995-96 budget. Following discussion, it was moved, seconded and passed to adopt the budget as presented.

**5. DESERT VALLEY/IMPERIAL VALLEY LEAGUES FOOTBALL PROPOSAL** -- Jon Gaffney, Principal, La Quinta High School, reviewed with the Council a proposal to allow a student to participate at any level in football by ability rather than age once the student enters high school. Following discussion, it was moved, seconded and passed to approve the Desert Valley/Imperial Valley League Proposal for recommendation to the State CIF Federated Council for their consideration.

**6. EMPIRE LEAGUE DUAL MEET WRESTLING CHAMPIONSHIP PROPOSAL** -- Dr. John Dahlem, Empire League Representative, presented a proposal to conduct the CIF-SS Dual Meet Wrestling championships as a one day tournament instead of the current two day configuration. Following discussion it was moved, seconded and passed to approve the proposal.

**7. BLUE BOOK COMMITTEE PROPOSAL** -- Dean Crowley, Commissioner, reviewed the fol-

and Marina del Rey, will continue to provide free athletic training services for high schools of the Bay and Ocean Leagues through their Sports Medicine Center's innovative *Training to Win* Program begun last year.

In addition, this year the program will include a secondary insurance plan, free of charge, to student-athletes attending schools that join the program.

Dr. Keith S. Feder, Chief of Orthopedic Surgery/Director of Sports Medicine at Daniel Freeman Hospitals, say, "This is a unique program in the Los Angeles area. The benefit to student-athletes with regard to injury treatment, injury prevention and

7. To achieve a thorough understanding and acceptance of the rules of the game and the standards of eligibility.


8. To encourage leadership, use of initiative, and good judgement by the players on a team.

## COMMISSIONER'S CORNER

**Sportsmanship:  
An Ongoing  
Issue**

As we begin the 1995-96 school year, all of us involved in the interscholastic program must continue to reinforce the principles of good sportsmanship.

Good sportsmanship begins with the school administration. There is no doubt that the quality of sportsmanship displayed at athletic contests reflects the leadership of the administrative staff. This does not mean that you are not going to have some problems, but how you attempt to solve those problems indicates the leadership and philosophy of the school administration.

Programs for promoting and improving sportsmanship are a must for schools and leagues in this day and age. If someone were to ask you what represents the greatest danger to the survival of high school athletics, you might think specialization, overemphasis, officials, coaches, or finances. You would be wrong!!

The greatest peril to interscholastic athletics is the lack of good sportsmanship.

If having a coach fail to teach and exemplify sportsmanship, then they have failed clearly in their responsibilities as a coach. The values our young athletes learn from having participated in sport are the ingredients and perhaps the greatest by-product of our endeavor. They are necessary in life's work. A coach cannot afford to lose perspective of these values.

The athlete identifies the coach as someone special - a TEACHER! The shaping of the athlete's general attitude and demeanor is, in part, molded by the coach.

We must never forget that high school athletics is an extension of the classroom. Language and behavior that is not acceptable in the classroom should not and will not be acceptable on the playing field, from our student athletes and especially coaches who are the educational leaders of the school.

Over the past ten years, we have become a nation of poor sports. Those of us in the field of education must fight for what is right and enforce the rules and the Code of Ethics.


Born and raised in Ventura County, Arce received her bachelor's and master's degree in english from San Jose State University.

Dr. Jack Clement has been involved in education since 1965. He has been the principal at Monrovia High School, Redondo Union High School and most recently, El Toro High School. Clement was also the Director of Fiscal and Administrative Services for the South Bay Union High School District from 1992-93.

Clement received his bachelor's degree in social science from Cal State Fullerton, a master's degree in history from Chapman University, a master's degree in school administration from Cal Lutheran University and a doctorate in school administration from U.S. International University.

Upcoming President of the Sea View League, Clement is a past president of the South Coast and Rio Hondo Leagues. He is a member of the Executive Board of the Association of California School Administrators Region XVII.

Clement and his wife, Nancy, live in Placentia. They have two sons, Timothy and Randall.

## TWO SOUTHERN SECTION ALUMNI SELECTED TO NATIONAL HIGH SCHOOL SPORTS HALL OF FAME

Pat Haden and Ann Meyers-Drysdale were among the 14 individuals selected for induction into the 1995 class of the National High School Hall of Fame. The 1995 class is the 13th group to be inducted into the Hall of Fame, which was started in 1982 and is housed at the National Federation of State High School Associations in Kansas City, Missouri.

The pair were inducted on July 5 in Portland, Oregon during ceremonies held in conjunction with the National Federation's Summer Meeting.

### PAT HADEN

Pat Haden still holds virtually all passing records at Bishop Amat High School in La Puente, where he concluded his football career in 1970. In three years as quarterback at Bishop Amat, Haden completed 527 passes for 7,633 yards and 82 touchdowns. He still ranks seventh in career completion percentage (62.0) and third in season completion percentage (67.9) in the National High School Sports Record Book.

Haden led Bishop Amat to the 1970 CIF-SS 4-A Championship and was CIF-SS co-player of the year with teammate John McKay, Jr. that same year. Haden still holds CIF-SS records for most career TD passes (82) and most TD passes in a season (42). He still holds the following Bishop Amat records: career completions (527), season completions (224), game completions (31), career passing yardage (7,663) season passing yardage (3,127), game passing yardage (470) and game touchdown passes (7).

Haden was a two-time all-CIF Southern Section player and all-America as a senior. He was named Catholic all-America as a junior

and was chosen for the all-CIF state team as a senior. He quarterbacked the South team to a victory in the 20th Shrine All-Star Football Game after graduating from Bishop Amat.

At the University of Southern California, Haden quarterbacked the Trojans to three Rose Bowl appearances and two national championships. He also was two-time academic all-America and was awarded a Rhodes Scholarship to Oxford University. He later earned his law degree from Loyola (California) Law School.

Haden played professional football for seven years, six with the Los Angeles Rams. He was named to the Pro Bowl in 1977. Currently, Haden is a broadcaster with TNT, a general partner in the venture capital firm of Riordan, Lewis & Haden, and is associated with the Los Angeles law firm of Riordan and McKinzie.


### ANN MEYERS-DRYSDALE

Ann Meyers-Drysdale was a pioneer in girl's and women's sports during her careers at Sonora High School in La Habra in the early 1970's, and the University of California, Los Angeles, in the mid 1970's. At Sonora High School from 1970 to 1974, Meyers-Drysdale competed in track, basketball, softball, badminton, field hockey and tennis and earned 13 most valuable player awards in high school sports. In four years of basketball competition, she led her teams to an 80-5 record while averaging 20 points, nine rebounds, eight assists and five steals per game. Her field hockey teams were 40-5 in four years.

Because of opportunities in athletics for women were limited in the early 1970's, Meyers-Drysdale participated on boys teams on





## SOUTHERN SECTION FINALISTS NAMED FOR CIF SCHOLAR-ATHLETES OF THE YEAR

Student athletes from Southern Section member schools represented 11 of the 20 finalists named for the 1995 Scholar-Athletes of the Year Award.

The 20 finalists, which include 10 boys and 10 girls, were selected from a field of 668 candidates throughout California who were nominated for the prestigious award by high school principals.

Six girls and five boys from the Southern Section were finalists for the awards.

Girls included Theresa Meredith Bastain, Long Beach Wilson,

Swimming; Carrie Anne Caulkins, Esperanza, Track and Field; Kimberly Kimiko Cobb, San Clemente, Swimming; Susan Prchal, Mater Dei, Volleyball; Stephanie Diane Secosky, Alta Loma, Basketball; Rosemary She. Whitney, Tennis.

Boys included Benjamin Paul Breig, Esperanza, Water Polo; Aaron P. Bruhl, Colton, Swimming; David Yongil Lee, Sunny Hills, Soccer; Jimmy J. Lee, Tustin, Golf; Rick Westberg, Long Beach Wilson, Water Polo.

## GOLD LIFE PASS AWARDS WINNERS HONORED

The California Interscholastic Federation, Southern Section honored three longtime contributors to the cause of high school athletics and CIF-SS activities with the prestigious Gold Life Pass Awards at the April 20 Council Meeting in Buena Park.

The Gold Life Pass Award, emblematic of the highest service honor the organization can bestow upon an individual, celebrated its 43rd year this spring. The award was initiated in 1952, with the first presentation going to Seth Van Patten, generally regarded as the "Father of the CIF Southern Section" and its first Commissioner of Athletics (1930-50). Including the eight recipients awarded this year, a total of 148 Life Pass Awards have been presented.

Biographical sketches of the 1995 honorees, Lary Arason, Dr. Wesley Bosson, Bill Boswell, Speed Castillo, Dr. Phil Jones, Sr. Barbara Kellogg, and Dr. Robert Packer follow:

### LARRY ARASON

Larry Arason began his teaching and coaching career at Buena Park High School when the school opened in the fall of 1956. After a brief hiatus from education, Arason returned to teaching and coaching at Santa Ana High School becoming its Athletic Director in 1964. In 1979, he became the Coordinator of Athletics and Physical Education for the Santa Ana Unified School District. Arason was named California State Athletic Director of the Year. Arason is a Charter Member and former President of the California State Athletic Directors Association and has been Track and Field and Cross Country Rules Interpreter for the state of California for eight years.

### DR. WESLEY BOSSON

Dr. Bosson's 36 year involvement with the CIF has included positions as Head Football Coach at La Serna High School and Galdstone High School, Principal, Rio Hondo League President and Superintendent of Schools for the Temple City Unified School District. After Bosson's arrival at Temple City High School in 1969, the school's athletic program has enjoyed tremendous success, including seven CIF-SS football championships from 1970-1979. Bosson has received the PTA Honorary Life Service Award from the 1st District and from Temple City High School. Bosson is also an adjunct professor at USC.

### BILL BOSWELL

Bill Boswell's teaching and coaching career began in 1957 at Artesia High School. In 1959, Boswell was hired as the first football coach at Westminster High School. In 19 years leading the Westminster football program, the school compiled a record of 120-65-5, and won five league championships. Boswell also became the Athletic Director at Westminster before becoming the Athletic Coordinator for the Huntington Beach Union School District. A past President of the California State Athletic Directors' Association, Boswell has been selected as California Athletic Director of the Year and National Athletic Director of the Year. Boswell has also been the Meet Manager for numerous CIF Southern Section wrestling tournaments including Finals and Masters Meets. A graduate of Huntington Beach High School, Boswell earned his degree from USC.

### SPEED CASTILLO

Espiridon "Speed" Castillo began his teaching career as a general business and physical education teacher at Orangewood Junior High School in Anaheim in 1959. In 1970, Castillo was named Coordinator of Compensatory Education for the Anaheim Union School District and in 1973 was promoted to Coordinator of Child Welfare and Attendance. Most recently, he had been an assistant

principal at Gilbert High School until his retirement in 1993. Speedy has been the Officials Liaison for Orange County for over five years and is the Instructional Chairperson for Orange County Officials.

### DR. PHIL JONES

Dr. Phil Jones' education career started in 1957 when he became a teacher and coach at Downey High School. Jones has been a principal at Woodruff Junior High, Griffiths Middle School, South Middle School, West Middle School, and since 1986, at Downey High School. He was the San Gabriel Valley League President in 1988-89, and was the San Gabriel Valley League Representative to the CIF Council from 1987-94. Jones has held the positions of President, Director, Secondary Principals Representative to State and Treasurer of Region XIV of ACSA. Additionally, Jones is a part-time instructor at the Los Angeles Academic Center of Chapman University. Jones resides in Bellflower.

### SISTER BARBARA JOSEPH

Sister Barbara Joseph was the principal at St. Joseph High School in Lakewood from 1975-1983. During that time, she became the first woman member of the Executive Committee of the Catholic Athletic Association. She then became the Vice-President of the CAA from 1980-83. Sister Joseph has also served the CAA as Executive Secretary, member of the Releaguings Committee and representative of the Executive Board for Appeals. From 1978-87, Sister Joseph was the CIF-SS All-Girls Schools Council Representative. She served on the CIF-SS Eligibility Committee from 1981-83 and in 1981, was nominated to the CIF-SS Executive Committee. Sister Joseph was the first woman voting member of the CIF-SS Council.



### JOANNE KELLOGG

Joanne Kellogg has been a physical education teacher since 1956.

During that time, she has had a storied career in athletics that has included coaching the Huntington Beach High School girls basketball team to four Sunset League titles and CIF-SS Championships in 1977 and 1978. She was also named Girls Basketball Coach of the Year in 1977 and 1978. Kellogg was also the Athletic Director at Huntington Beach from 1974-92, Sunset League Coordinator from 1988-90, and served on the CIF-SS Basketball Advisory Board from 1976-79. Other positions Kellogg has held include Advisor on the Girls Athletic Association, President of the Orange County Women's Physical Education Association and member of the Orange County Athletic Directors Board.

### DR. ROBERT PACKER

Dr. Robert Packer's educational career as a teacher and coach at La Puente High School in 1958. In 1962, he moved on to Nogales High School where he eventually became principal. Packer was named principal at Costa Mesa High School in 1973 and from 1977-80, he was the Orange County Representative to the CIF-SS Council and Executive Committee. Packer served on the CIF-SS Executive Council for seventeen years, holding the presidency from 1981-84. He has also been a member of the CIF State Federated Council for fourteen years, and was President from 1990-92. Other positions Packer has held include Deputy Superintendent for the Tustin Unified School District and Superintendent for the Duarte Unified School District. A former member of the National Federation Football Rules Subcommittee, Packer currently lives in Palm Springs.

## SOUTHERN SECTION TRACKSTERS TAKE HOME 18 TITLES

Track athletes from Southern Section schools won championships in sixteen events and took both team titles at the CIF State Track Meet held at Cerritos College this past June.

On the girls side, LaKeisha Backus of Long Beach Wilson established herself as the premier sprinter in the state by winning the 100 meters (11.39) and the 200 meters (23.01) and Joanna Hayes of J.W. North is the state's dominant hurdler by taking the 100 HH (13.45) and the 300 LH (41.20).

Other individual winners include Chino

freshman Angela Williams in the 400 (53.40), Esperanza's Kelly O'Connor in the triple jump (40-6 1/2) and Nadia Lopez of Arroyo Grande in the discus (152-6).

Long Beach Poly won the 400 relay (45.1) and the 1600 relay (3:39.53) on the way taking the team title. Poly scored 52 points, edging out Logan High School of Union City by two points.

In the boys portion, Obea Moore of Muir won the 400m (46.08) and finished second in the 200 (20.82).

The 200 was won by Dana Hills sopho-

more Bryan Harrison (20.82), who also finished third in the 100 (10.51).

Mickey Grimes from Canyon Springs won the 300 IH (36.83), Michael Turner from Morningside won the triple jump (49-2), Loyola's Matt Pentecost won the shot put (62-33/4) and Chad Jones of Arroyo Grande took the Discus with a mark of 183-9.

In the relays, Muir won the 1600 in a time of 3:13.08 and finished third in the 400 (41.36). Muir won the team title with a comfortable 38-24 margin over Dana Hills.

### Open Enrollment Transfer Form

California's Open Enrollment legislation has been in place for a year now and there is still considerable confusion to the law's effects.

First, we must consider what the Open Enrollment laws state:

#### INTRA-DISTRICT OPEN ENROLLMENT - AB1114

1. District policy should have been established by July 1, 1994.
2. No timeline for transfers (Student/athletes must meet CIF regulations.)
3. Selection process must be "random and unbiased," which generally means students must be selected through a lottery process rather than on a first-come, first-served basis. A district cannot use a student's academic or athletic performance as a reason to accept or reject a transfer.
4. Parents/guardians do not have the right to appeal the decision if their transfer is denied, but districts may, however, voluntarily decide to put in place a process for parents/guardians to appeal the decision.

#### INTER-DISTRICT OPEN ENROLLMENT - AB19

1. This law allows, but does not require, each school district to become a "district of choice." A "district of choice" means that a district may accept transfer students from outside the district under certain education code sections.
2. Selection process must be "random and unbiased," which means students must be selected through a lottery process rather than on a first-come, first-served basis. A district cannot use a student's academic or athletic performance as a reason to accept or reject a transfer.
3. Applications must be submitted by January 1 preceding the school year for which the student wants to be transferred, unless the "district of choice" obtains a waiver from the California Department of Education. Apply

## SOUTHERN SECTION TO HONOR SCHOOLS FOR ATHLETIC ACCOMPLISHMENTS

The CIF Southern Section will recognize the top ten girls and boys athletic programs of the 1994-95 school year in the Fourth Annual CIF-SS Cavalcade of Champions. The Southern Section is currently exploring the most appropriate way to acknowledge these fine programs.

On the girls side, Long Beach Poly took top honors, scoring 16 points on the strength of championships in basketball, soccer and track and field. Peninsula and Woodbridge tied for second with 14 points, each winning two CIF-SS titles. The boys portion was won by Santa Barbara (15 points), who won championships in tennis and soccer. Alta Loma and Santa Ynez finished in a tie for second with 14 points.

The CIF-SS developed this recognition program based upon comprehensive excellence in interscholastic athletic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and member schools.

Awards are presented to the top 10 member schools (for both

boy's and girl's athletic programs) for overall excellence in team sports throughout the school year. The winners are chosen based upon playoff competition conducted during the previous school year.

Winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team place-finish sport (i.e. cross country, golf, swimming/diving and track/field); and one point for a fourth place finish in a team place-finish sport. In cases where ties occur for the 10th place, total team-sport playoff appearances will be used to determine the top 10 schools. Each of the schools will be presented with an attractive banner for permanent display on campus.

"This type of program is at the heart of what our organization stands for. It is an exciting way to recognize such outstanding performances," says Dean Crowley, CIF-SS Commissioner of Athletics.

The CIF Southern Section Hall of Fame Recognition Award has two names to add to its list of recipients, with the induction of Harvey Grody and Gene Smith.

The CIF-SS Hall of Fame Recognition Award was created in 1984 to bring public recognition to the numerous individuals who have contributed directly to the advancement of interscholastic athletics within the geographic boundaries of the organization.

"This award is a tribute to the individuals who have shown devotion, commitment and performance in the interscholastic athletic community over an extended period of time," said Dean Crowley, Commissioner of Athletics. "Congratulations to these most deserved recipients."

A biographical look at the 1995 inductees follows:

#### HARVEY GRODY


Harvey Grody has officiated in over 600 soccer matches, including over 400 at the varsity level in his high school refereeing career. Since becoming a CIF Southern Section soccer referee during the 1978-79 school year, through his retirement in 1993, Grody has worked in the playoffs, at least through the semifinals, nearly every year. He has refereed in seven CIF-SS Finals, many of which were in the major-division, and was center official in four of those matches.

Aside from officiating at the high school level, Grody has also refereed many intercollegiate contests, including Division I and II playoffs, as well as playoffs involving the community colleges. He was a member of the National Intercollegiate Soccer Officials Association from 1985-1990.

Grody was not only recognized as a fine official, he is a well-respected referee instructor. He has been an instructor with the Southern California Soccer Officials Association (SCSOA) and the Orange County Soccer Officials Association (OCSOA) for over ten years. He has served on the Board of Directors of the OCSOA for nearly twelve years, has been a Vice President of the SCSOA, and has held the position of Director of Certification for the OCSOA for five years.

Among other positions Grody has held include Assistant State Director of Referee Instruction for the California Soccer Association-South, United States Soccer Federation Certified State Referee Instructor, and periodic clinician for the Orange County Soccer Referees Association. Grody has also represented the CIF Southern Section as a referee spokesman at various coaches meetings.

Grody's other officiating assignments include the L.A./Watts Summer Games, The Olympic Games sponsored by the Interna-



tional Games for the Deaf, and numerous youth and senior league matches and tournaments.

Grody has also been known to volunteer his times to supervise non-profit tournaments, alumni games and has remained active as an instructor even after his retirement in 1993.

Born in Hartford, Connecticut, Grody graduated from Alhambra High School and received his undergraduate degree from UC Berkeley. He also earned his Master's Degree from Cal, then earned a Ph.D. from UCLA.

#### GENE SMITH

Gene Smith has been involved in high school athletics for 40 years, beginning in 1955 in Wapakoneta, Ohio where he coached basketball and baseball and was an assistant coach in football. Most of his career was spent at Jordan High School in Long Beach, where he taught for 30 years. In those thirty years, Smith coached baseball at the JV level and was an assistant basketball coach from 1959-65.

Smith's officiating career started in 1963 when he began umpiring high school and intercollegiate baseball. In 1965, Smith started refereeing basketball, he also refereed football at the high school and college level for 21 years.

Smith's accomplishments as a CIF official includes 3 Southern Section Football Championships and 4 Baseball Championships. He has also officiated at 8 L.A. City Section Baseball Championships. Smith has also umpired in the State Junior College Finals and has worked in the NCAA baseball playoffs.

In 1987, Smith was honored as the Retired Collegiate Umpire of the Year. Other positions Smith has held include President of the California Football Officials Association, President of the Southern California Baseball Officials Association, Faculty President of Jordan High School, and Secretary-Treasurer of the Long Beach Football, Baseball, and Basketball Officials Association. The Basketball and Baseball Associations of Long Beach were, in fact, started by Smith himself.

Smith was born in West Jefferson, Ohio and graduated from Grandview (Ohio) High School. He then attended Miami (Ohio) University on a football scholarship and also played baseball and basketball. Smith was drafted by the Chicago White Sox and played 3 years of professional baseball.

In 1951, Smith received his Bachelor's Degree in Business from Miami, earned another Bachelor's degree in Education in 1955, then completed a Master's Degree in Education in 1958.

### FIRST EVER CIF-SS GIRLS POLE VAULT CHAMPIONS CROWNED

Jeni Candipan of Marina, Vanessa Brenton of Temescal Canyon, Hannah Johnson of Atascadero and Breanna Elton of San Jacinto will enter the CIF-SS record books as the first-ever champions in their respective divisions of the girls pole vault in CIF-SS competition. Candipan was also the top finisher from the Southern Section at the 1995 CIF State Track Meet, finishing seventh after clearing a height of 10-2. The pole vault was not recognized as a scoring event until this year. Another Californian, Melissa Price of Kingsburg is the National Record Holder, recording a vault of 12-6.

### SOUTHERN SECTION ATHLETES DOMINATE NATIONAL RECORD BOOK IN TRACK AND SWIMMING

The National High School Record Book shows the Southern Section's domination in the sports of Track and Field and Swimming. In Track, CIF-SS girls hold seven individual and two team national records. 

## GLASGOW AND BERG LEAD SOUTHERN SECTION AT THE CIF/SCGA GOLF TOURNAMENT

Jenny Glasgow of Corona del Mar became the fifth straight Southern Section golfer to win the Girls Individual Championship at the 1995 CIF/SCGA Golf Tournament held at the Bernardo Heights Country Club in San Diego. San Marcos' Mike Berg was the top Southern Section golfer in the Boys Individual Championship finishing second to Charley Hoffman of Poway.

Glasgow completed a steady round of 73, including two birdies and three bogies. Her 73 was good for a ten stroke improvement from the 1994 CIF/SCGA and was the lowest score at the tournament since Michelle Lyford's 70 in 1987.

Berg, the final qualifier in the Southern Section tournament, made a run at Hoffman by eagling his 16th hole then birdieing his 17th to force a tie. Berg then bogied his 18th to fall out of a playoff. Hoffman was the first player in 25 years to successfully defend his CIF/SCGA Boys title.

Westlake, paced by Matt McCrite (71), was the the top Southern Section finisher in the team competition. The Warriors finished third with a score of 378, behind Torrey Pines of San Diego (369) and Clovis West of Fresno (371). The Westlake team is made up of McCrite, Ross Fulgentis, Alex Kuyumijian, Brandon DiTullio, Andy Sirvicha, and Kiroshi Hawashima.

Other top finishers for the Southern Section girls include: Julie Oh, Torrance (2nd, 74), Jenny Lee, Sunny Hills (T3rd, 75), Leilani Bagby, Santa Monica (5th, 76) and Nicole Dalkas, Palm Desert (6th, 77). several occasions. It is believed she was the first girl to play on a boys elementary basketball team in the fifth and sixth grades, and the first girl to play on a boys high school basketball team.

Meyers-Drysdale was the first woman to receive a full athletic scholarship to UCLA, where she scored 1,685 points and averaged 17.4 points per game during her four-year basketball career. She holds virtually every UCLA women's basketball record and was the first person to have her basketball jersey retired at UCLA. She was the first four-time Kodak all-America and received the Broderick Cup in 1978 as the top collegiate female athlete.

In Olympic competition, Meyers-Drysdale was the first high school basketball player to be selected to a U.S. national team and was a member of the 1976 U.S. Olympic basketball team that won the silver medal. She also competed in two World Championship Games, two Pan-American Games and one World University Games.

Among her many "firsts," Meyers-Drysdale was the first woman to be signed to an NBA contract when she signed as a free agent with the Indiana Pacers in 1979. She later signed with the New Jersey Gems of the Women's Professional Basketball League (WBL) and was the WBL most valuable player in 1980.

Meyers-Drysdale has been inducted to the Orange County Hall of Fame, the Cincinnati Sports Hall of Fame, the UCLA Sports Hall of Fame, the California High School Sports Hall of Fame and the Basketball Hall of Fame in Springfield, Massachusetts.

Currently, Meyers-Drysdale is a sports broadcaster for CBS, TBS, ESPN and Prime Ticket, and she also conducts basketball camps and clinics.

these issues?

### SIZE OF AREA

There is no question that the Southern Section covers a lot of miles. The question is, how often are we "required" to travel great distances? My answer is too often. That is why the upcoming proposal on the regionalization of playoff groupings is important. I am very curious how we will vote on this one. Another question that needs to be asked is how far do we voluntarily travel for preseason games and tournaments. I suspect it has a lot to do with who pays for busses (the district or the site). If the section was smaller would we really travel less?

### GOVERNANCE

Do big schools or small schools dominate the decision making process? Does one area dictate policies? Is one area ignored? If you haven't attended a council meeting, this could appear to be the case. If your "really good" idea/proposal was rejected you may disagree. In my opinion, decisions are usually based on each league's view of what is best for kids. This year's experiment with weighted voting may answer some of these questions. Would a smaller council make better decisions?

I am proud of the Southern Section. I believe our council and executive committee make good decisions. I believe that Dean Crowley and his staff are extremely open and responsive and that they are excellent athletic administrators. I know we are fiscally sound. Like any organization we need to improve. We need to more actively involve superintendents and better inform Boards of Education. We need to solicit ideas from ASB directors. We need to continue to improve our communications with leagues and athletic directors. I just don't believe we need to be smaller to accomplish this.

cants must be notified of their final acceptance or rejection no later than May 15.

4. If an application is rejected, the reason(s) for rejection must be provided by the district in writing to the parent or guardian.

The CIF has developed guidelines as it relates to the implementation of Open Enrollment as part of Bylaw 222/213.8 of the Southern Section Blue Book.

Bylaw 222 is for public, private and parochial schools and states:

"Any student transferring under the provisions of an open enrollment board policy, public, or private, will have immediate residential eligibility upon transfer from school A to school B, subject to the following limitations:

a) Only one transfer is allowed during the student's high school career after the initial enrollment as a ninth grader in a four-year high school or as a tenth grader in a three-year high school.

b) The transfer must be completed during the first 15 days of the new school academic year at school B.

c) The transfer must not be a result of disciplinary action.

d) The receiving school B must certify that no consideration was given to the athletic performance of the student in accepting the transfer.

e) Approval by the CIF-SS Office.

The Southern Section has since developed an Open Enrollment form in order to eliminate some of the confusion with regards to transfer eligibility under this rule. The form is a simple way to ensure that the transferring student meets all criteria for receiving immediate eligibility under Open Enrollment.

Students will not be eligible for athletic competition, unless this form is completed. Any student who has enrolled in a new school over the summer or within the first fifteen days of this school year must have this form completed prior to any competition. However, the use of this form does not apply to those who transferred last year under Open Enrollment.

Forms have already been mailed to schools and more will be included in the fall packet. Schools are encouraged to make copies of this form if more forms are required.

following items from the Blue Book Committee:

A) Nominating Committee Make-Up Article 8, Section 81 -- A recommendation to amend the wording in Article 8, Section 81 to read: The six member Nominating Committee of the CIF-SS shall consist of one representative each from Northern, Eastern, Orange and Los Angeles County areas, as well as a representative from the parochial schools and one from the private schools was approved.

B) Association Rule Language (All Sport Sections) - A recommendation to delete the word "representative" in the current Association Rule language in all sport sections of the bylaws replacing with the term "no member of the athletic staff" was approved.

C) Golf, Tennis and Badminton Practice Rule (Article 20, Section 2001; Article 26, Section 2601.1-2601.2; Article 14, 1401) -- The Committee's recommendation to delete the last sentence in the golf, tennis and badminton organized team practice rule to provide consistency in all team practice rules for sports currently conducted by the CIF-SS was approved.

D) Open Enrollment (private school to public school of residence, Rule 222/Rule 213) -- a recommendation to develop new language under Rules 213/222 allowing an individual transferring from a private school back to his/her public school of residence a one time only transfer, under the open enrollment policy as it now exists in Rule 222 was approved.

E) Playoff Eligibility (Rule 3111) -- The Committee recommended the following language be included as part of Rule 3111 to provide consistency in Southern Section rules for playoff participation:

Playoff Eligibility - An ineligible player is one who is in violation of any State CIF or Section scholastic residence, transfer, age, semesters of attendance, or other eligibility rules.

(a) Games in which the student participated, after the occurrence of the violation shall be forfeited (See Rule 500.2).

(b) For the period between the last league contest and prior to the first competition of any playoff contest, violations discovered will be assessed only against the individual(s) and will not

affect the advancement of a team into the playoffs.

(c) Violations discovered after the first round of any playoff will result in disqualification of the ineligible player's team from the playoffs and forfeiture of its last playoff competition. In such cases, the losing team will advance provided the date of the next scheduled contest has not elapsed.

(d) Free Lance schools will submit eligibility rosters prior to their second contest of the season to the CIF Southern Section Office. Any additions to the Free Lance school eligibility roster will be made directly to the CIF-SS Office within five (5) school days of each occurrence.

F) Executive Committee Area Representation (Rule 70.5) -- The Committee recommended amending Rule 70.5 to increase the number of geographical area representatives from two persons to no more than three persons serving on the Committee from any one geographical area at the same time was approved.

**8. STATE CIF PROPOSALS** -- Dr. Gary Smidderks, presented the following agenda items for the May State Federated Council meeting which requires action by the CIF-SS Council in order to give voting delegates direction:

A) State Executive Committee Elections -- Vote to send delegates uninstructed.

B) Statewide contest limitations - Vote NOT to support.

C) State CIF Budget -- Vote NOT to support. In addition, a motion was made to support a balanced budget or a process to attain a balanced budget was approved.

D) Principles for Effective Governance -- Vote to support.

E) Statewide Financial Policies (updated) -- Vote to NOT support. In addition, a motion to put in place a procedure to remove section and league implications was moved, seconded and approved.

F) Coaching Education Concept -- Vote NOT to support.

**9. COMMISSIONER'S REPORT** -- Dean Crowley, Commissioner reviewed the National Federation summer meeting, the one year extension of S.B. 237, D and O insurance, status of the CIF-SS video, the hiring of Art Munda to replace Sports Information Coordinator Ed Zintel; and a new year

end evaluation survey of the CIF-SS.

**10. TREASURER'S REPORT** -- Margie Godfrey, Treasurer, updated the Council on the final winter playoff activities.

**11. WEIGHTED VOTING REVIEW** -- Dr. Gary Smidderks, reviewed with the Committee the current progress of the committee. Following discussion it was determined the committee will continue the review of the weighted voting issue.

There being no further business to come before the Council, the meeting was adjourned at 12:07 p.m.


