



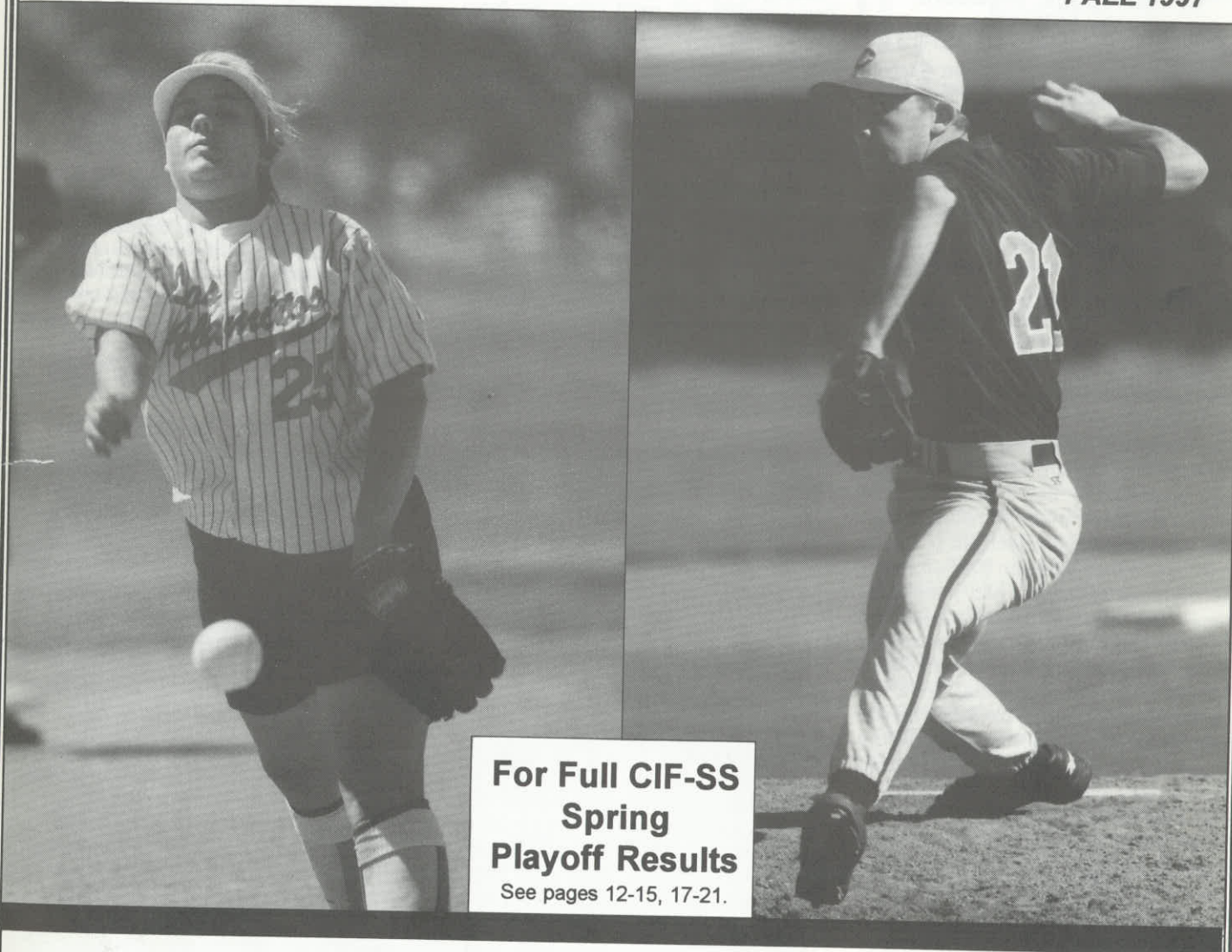

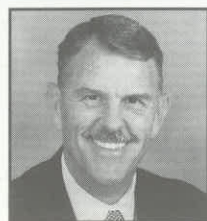

PRESIDENT'S MESSAGE



**Releagu-
ing- The
Agony and The
Ecstasy**

The bell tolls for the CIF Southern Section releagu-
ing on October 21, 1997. That is the day on which the CIF's Southern Section Council is scheduled to take final action on the various proposed alignments of schools commencing the next four-year releagu-
ing cycle (for the term beginning 1998-99 and ending 2002-2003). This past school year, principals in each of the nine releagu-
ing areas met on a regular basis, using structured methods and established procedures to apply the criteria of (i) enrollment, (ii) geography, and (iii) competitive equity together for purposes of establishing the most appropriate league configurations.

The process of releagu-
ing in recent years has become significant, complex, and high profile endeavor of key interest to most everyone in our communities including principals, superintendents, members of boards of trustees, parent booster club organizations, financial sponsors, and community groups. The increased media attention on the process and the pressure for athletic and economic success have brought out an emotional element to the debate. Thus, this intense environment is the backdrop behind which our Southern Section principals are charged with the responsibility of placing 500 secondary schools into 72 leagues that we trust will meet the needs of the student athletes. Historically, releagu-
ing has had results that vary from satisfaction and minor concerns for most and serious complaints from a fractious few.

In the current process, CIF-SS Council representatives (voting members) have and will continue to weigh the deliberate on each of the nine separate area proposals. With respect to each proposal that is approved, Council representatives will hear any appeals that may be asserted from schools in each respective area. The Council may rule on such appeal in any of three ways:

- Deny the appeal and thus uphold the area proposal;
- Grant the appeal, reversing the underlying proposal and adopt an alternative proposal; or

CIF-SS COUNCIL MEETING MINUTES May 1, 1997

The May meeting of the CIF-SS Council was called to order by Tom Triggs, President at 9:07 a.m. on Thursday, May 1, 1997 at the Sequoia Club. All leagues were present with the exception of Desert Mountain, Freedom, Heritage, Liberty, Mountain, Freedom, Heritage, Liberty, Prep, Santa Fe and Victory.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 13, 1997. Additionally, the minutes of the CIF-SS Executive Committee meeting of April 9, 1997 were submitted as an information item.

2. PUBLIC HEARING SESSION - Brian Hurst, Assistant Principal at Burroughs High School (Burbank), reviewed concerns regarding a recent California Supreme Court decision and its effect on hiring coaches.

3. GOLD LIFE PASS PRESENTATION - Dr. Tracy Brennan, Chairperson of the Life Pass Committee, introduced those receiving Life Passes in recognition of the long standing service to the CIF-SS. Recipients were Dale Ackerman, Thousand Oaks High School; George Allen, Valencia High School; Cynthia Grennan, Anaheim Union High School District; Ron Barney, Ojai Unified School District; Jim Bayshore, Carpinteria High School; Bob Dugard, California High School; Don Duncan, Hoover High School; Marge Fulton, West Torrance High School; Robert Hahn, Redlands High School; Jack Mount, San Gabriel High School and Dick Salter, Arcadia

USC UNIVERSITY HOSPITAL AND MISSION HOSPITAL REGIONAL MEDICAL CENTER JOIN CIF-SS CORPORATE TEAM

The CIF Southern Section welcomes the University of Southern California and USC University Hospital. The agreement will make them the "Official Health Care Provider of the San Gabriel Valley."

In the rough and competitive world of high school athletics, injuries are an unfortunate fact of life. Not content to stay on the sidelines of this concern, the Center for Athletic Medicine at USC University Hospital created *Excellence in Athletics*, a high school program designed to help minimize these injuries and ensure young athletes receive prompt, quality medical care.

This innovative community outreach program provides athletic trainer coverage for area high schools, low-cost pre-season physicals, free weekly Saturday morning injury clinics, and educational seminars for coaches, athletes and student trainers. More than 3,000 high school athletes are currently involved in the *Excellence in Athletics* program, representing high schools in the San Gabriel area.

This program gives high school athletes access to specialist physicians and comprehensive services and provides a Certified Athletic Trainer for 10 hours per week to each participating high school. These athletic trainers are experts in injury prevention, evaluation, management and rehabilitation.

Other components of *Excellence in Athletics* include:

- Preventive injury programs
- Expertise and guidance in building training rooms
- Subsidized secondary insurance plans to student athletes of participating high schools

Another key aspect of *Excellence in Athletics* is its commitment to education. The program provides coaches clinics on injury prevention and management, and educational seminars for student trainers. They also offer quality continuing medical education courses to allied health professionals including athletic trainers and physical therapists.

The Center for Athletic Medicine is staffed by world-class orthopaedic surgeons and specialists from numerous other disciplines at the University of Southern California School of Medicine. These specialists take care of the USC intercollegiate athletes as well as amateur, professional and Olympic athletes.

"We are proud to be involved with the CIF Southern Section and to help young athletes enjoy interscholastic sports in as safe an environment as possible. Our commitment to the community extends from the training rooms to the playing fields to

the classroom," said Brian Chavarin, Sports Medicine Program Coordinator for USC University Hospital.

The CIF Southern Section also welcomes Mission Hospital Regional Medical Center for the 1997-98 school year. The agreement will make them the "Official Health Care Provider of South Orange County." According to Peter Bastone, President and Chief Executive Officer of Mission Hospital Regional Medical Center, "Sports can be an integral part of a student's education, and Mission Hospital is proud to support CIF and its efforts to provide our youth with formalized sports leagues. At Mission Hospital, one of our goals is to create a healthier community. By partnering with CIF, we contribute to creating a positive environment for staying healthy."

Mission Hospital Regional Medical Center was founded in August 1971 as Mission Community Hospital for the purpose of providing acute care hospital services to the residents of the rapidly growing South Orange County. In 1980, the hospital's emergency department helped pioneer the Trauma System for Orange County and has housed south county's designated trauma center - one of only three in the county since that time.

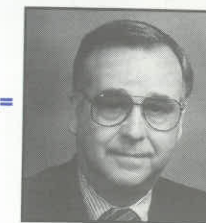
In September 1994, Mission Hospital joined the St. Joseph Health System and became one of the nine not-for-profit hospitals sponsored by the Sisters of St. Joseph of Orange. The hospital has a medical staff of more than 600 physicians representing over 50 specialties and sub-specialties. Mission Hospital is fully accredited by the Joint Commission on Accreditation of Healthcare Organizations. The hospital was designated as a paramedic base station in 1973, and since then, the hospital has housed the region's designated trauma center which serves an average of 700 patients each year.

As the largest medical center in the area, Mission Hospital's full service facilities provide quality medical care to all residents of South Orange County. The hospital's areas of specialization include trauma and 24-hour emergency care; maternity services including high risk obstetrics, perinatology and a fetal diagnostic center; orthopedic services and sports medicine; Mission Center Care Center; Mission Regional Heart Center; Mission Regional Imaging Center; renal lithotripsy services (kidney stones); Center for Sports & Wellness;

The Golden Rule =
Good
Sportsmanship**

Each year brings new challenges with it. As we launch the 85th season of the CIF Southern Section, it is important that those of us in leadership roles in interscholastic athletics rededicate ourselves to the values of healthy athletic competition - proper ideals of sportsmanship, ethical conduct, integrity, and fair play.

Our work as leaders of young people is more closely scrutinized today more than ever before. Our role as a member of the educational community is larger than in the past. Education and athletics must go hand-in-hand for co-curricular activities to be an extension of the classroom. After all, isn't the athletic field as much of a learning laboratory as the classroom.

So often we see the results of certain unsportsmanlike examples being set at higher levels of athletic competition adversely affect the behavior of student, coaches, and adults in our own community. It is up to the educational and athletic leadership to provide the direction and constant vigilance under which good sportsmanship can prosper and have a positive impact on our student athletes, the leaders of tomorrow and ourselves.

RESPECT. The Golden Rule. An interscholastic athletic event takes place with student athletes or the field of play and fans packed around the arena to watch the outcome. The game begins. The play of both teams is exceptional. Spectators show their approval as the competition brings out the best in all players and coaches.

Fans ride an emotional roller coaster as the contest goes back and forth. Finally, the outcome becomes clear. The game ends. The spectators give the participants a standing ovation. Players on both teams, exhausted, meet in the center of the arena to exchange pleasantries and congratulate each other on a job well done.

The final score of this fictitious event doesn't matter. What matters is that all involved in the game displayed **RESPECT** and the Golden Rule. If you were to at-

CIF SOUTHERN SECTION INDUCTS NISSLEY AND VALDES TO HALL OF FAME

The CIF Southern Section Hall of Fame Recognition Award has two names to add to its list of recipients, with the induction of Harry Nissley and Al Valdes.

The CIF-SS Hall of Fame Recognition Award was created in 1984 to bring public recognition to the numerous individuals who have contributed directly to the advancement of interscholastic athletics within the geographic boundaries of the organization.

"This award is a tribute to the individuals who have shown devotion, commitment, and performance in the interscholastic athletic community over an extended period of

time," said Dean Crowley, CIF-SS Commissioner of Athletics. "Congratulations to these most deserved recipients."

A biographical look at the 1997 inductees follows:

For over 50 years, Harry Nissley has coached the tennis team at El Monte High School. Although Nissley retired in 1992, his dedication to El Monte High School is apparent by his remaining as the Lions tennis coach. Also a basketball coach early in his career, Nissley was responsible for the CIF-SS "B" and "C" tennis championships as assigned by then Commissioner Seth Van Patten.

In 1987, Nissley received a service award from the San Gabriel Valley Administration Association. The following year in 1988, he was nominated for the Representative Coach for the Western States by the National Coaches Association at their National Convention.

In addition to coaching tennis, Nissley is still active in the El Monte athletic community, serving as the timer at Lions basketball, football, and wrestling events. The Santa Ana High School graduate also

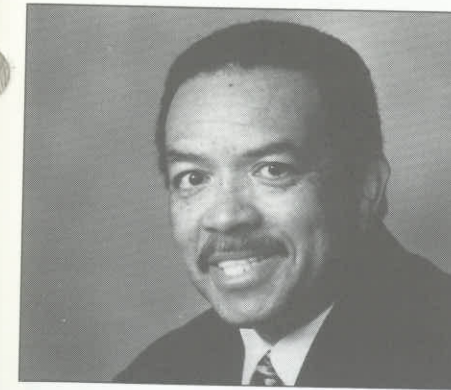

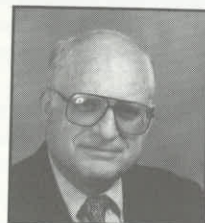

RULE REVIEW



A New Look at Open Enrollment

The Open Enrollment Rule has taken on a new look beginning this fall. The rule, now designated as 214.1, essentially gives every student one free transfer, provided that the transfer meets specific guidelines. Additionally, a new form must be filed with the Southern Section office for the transfer to be processed.

The rule designates that for students transferring from one district to another, certain criteria must be met in order for the student to gain immediate athletic eligibility (all private and parochial schools are considered separate districts). First, the intent to transfer must have been made known by May 15 of the previous school year. Next, the transfer must be for non-athletic and non-disciplinary purposes and lastly, the transfer must take place during the first fifteen days of the school year.

For those transferring within a certain district, the May 15 date becomes inconsequential, but the student must transfer under the district's open enrollment policy. Again, the transfer must be non-athletic and non-disciplinary in nature. Like inter-district transfers, enrollment must take place in the first fifteen days of the school year.

Should a student transfer after the first fifteen days of the school year, he or she would have restricted eligibility (eligibility only for non-varsity competition) in the sports he or she competed in at their previous school for the remainder of the school year. As an example, if a student transfers in at the semester break and fulfills all the other criteria of the open enrollment rule, the student would be restricted in the sports he or she competed in at the previous school until June. When the new school year rolls around, he or she would gain unrestricted eligibility.

This new rule, as voted in by the Southern Section Council, allows students only one open enrollment transfer during their career in order to retain unrestricted eligibility. Therefore, if the student has had one open enrollment transfer approved in his or her career, he or she can only gain unrestricted eligibility for subsequent transfers through a bona fide change of address or hardship.

WOODBIDGE AND SANTA MARGARITA CLAIM TITLES IN THE SIXTH ANNUAL CAVALCADE OF CHAMPIONS

The CIF Southern Section is please to announce the top ten girls and boys athletic programs in the Sixth Annual Cavalcade of Champions.

On the girls side, Woodbridge took top honors scoring fifteen points on the strength of championships in tennis and softball. The Warriors also claimed a runner-up finish in track and field and a semifinal finish in volleyball. Santa Margarita was second tallying up twelve points, with championships in volleyball and soccer. The Eagles also reached the semifinals in tennis. Rounding out the top three was Nordhoff. The Rangers scored 11 points based on a championship in cross country and runner-up finishes in tennis and track and field.

Santa Margarita won the boys title for the

second straight year. The Eagles scored a whopping 26 points, winning CIF-SS titles in football, soccer, and volleyball. Santa Margarita was also runners-up in cross country, swimming and diving, and tennis. Additionally, Santa Margarita's golf team took third place in CIF-SS team golf action. Second place went to Mater Dei with 16 points. The Monarchs won championships in football, basketball, soccer, while the track and field team finished in a tie for third place. The No. 3 spot went to Long Beach Poly. The Jackrabbits scored fifteen points, winning CIF-SS crowns in basketball and cross country. Poly's track and field team finished second and its football team reached the semifinals.

The CIF-SS developed this recognition

program based upon comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team place-finish sport (i.e. cross country, golf, swimming and diving, and track and field); and one point for a fourth place finish in a team place-finish sport. In cases where a tie occurs for 10th place, total team-sport playoff appearances will be used to determine the top ten schools.

GOLD LIFE PASS AWARDS WINNERS HONORED

The California Interscholastic Federation, Southern Section honored eleven longtime contributors to the cause of high school athletics and CIF-SS activities with the prestigious Gold Life Pass Awards at the May 1 Council Meeting in Buena Park.

The Gold Life Pass Award, emblematic of the highest service honor the organization can bestow upon an individual, celebrated its 45th year this spring. The award was initiated in 1952, with the first presentation going to Seth Van Patten, generally regarded as the "Father of the CIF Southern Section" and its first Commissioner of Athletics (1930-50). Including the eleven recipients awarded this year, a total of 164 Life Pass Awards have been presented.

Biographical sketches of the 1997 honorees, Dale Ackerman, George Allen, Ron Barney, Jim Bashore, Bob Dugard, Don Duncan, Marge Fulton, Cynthia Grennan, Bob Hahn, Jack Mount, Dick Salter.

DALE ACKERMAN

Dale Ackerman is the long time Athletic Director and Assistant Principal from Thousand Oaks High School. Having served on the CIF-SS's Athletic Safety Committee, Ackerman also still serves as the Marmonte League Representative to the Council. A former teacher and coach at Oxnard High School, Ackerman became the first basketball coach at Thousand Oaks. In 1971, Ackerman moved into administration as a counselor at Thousand Oaks. He went on to become an Assistant Principal/Head Counselor at Westlake High School, then returned to Thousand Oaks as Assistant Principal/Athletic Director. During his tenure at Thousand Oaks, Lancer athletic teams won 80 league titles and 12 CIF-SS championships.

GEORGE ALLEN

George Allen spent many years as the Principal at Esperanza High School and at Valencia High School in Placentia. A former football coach, counselor, and assistant counselor, Allen was also the Chair for the committee that studied the feasibility of an Orange County section to the CIF. Allen served on the CIF-SS Council as league representative and also spent time on the CIF-SS Playoff Groupings Committee.

RON BARNEY

Ron Barney spent 39 years in the field of education, with over 20 years of involvement with the CIF Southern Section. A former teacher and coach, Barney was the Principal at Thousand Oaks High School and Nordhoff High School before becoming an Assistant Superintendent with the Ojai Unified School District. He served the CIF-SS Council as the Marmonte League Representative and was President of both the Marmonte and Frontier Leagues. Additionally, Barney was the Chair for the CIF-SS Season of Sport Committee and the Geographical Realignment Committee. He also spent time on the CIF-SS Nominating Committee and Releaguings Committee.

JIM BASHORE

Jim Bashore was the Athletic Director at Carpinteria High School for the past 11 years. Bashore began his career in high school

athletics as a football and basketball coach at Santa Clara High School. He then went on to coach at Thousand Oaks, Rio Mesa, before settling into a 30 year career at Carpinteria. The Tri-Valley League Representative to the Council for the past 8 years, Bashore also served on the CIF-SS Season of Sport, Playoff Regionalization, Basketball Advisory and Basketball Seeding Committees. Also a track and football official, Bashore is a five-time Tri-Valley League Basketball Coach of the Year, a Two-time Southern California Interscholastic Basketball Coaches Association (SCIBCA) Coach of the Year, and was recently inducted into SCIBCA's Hall of Fame.

BOB DUGARD

Bob Dugard was the cross country coach for 40 years and the track and field coach for 33 years at Sierra and California High Schools. In addition to his coaching career, he served as Athletic Director for 16 of those years. In his retirement, Dugard continues to be directly involved with the CIF Southern Section as the Del Rio League Coordinator and as a member of the Track and Field Management Committee. He also remains as the cross country coach at California High School. A former member of the CIF-SS Track and Cross Country Advisory Committee, Dugard is also a track and swimming official.



DON DUNCAN

Don Duncan spent 21 years as the Principal at Hoover High School. A graduate of Hoover himself, Duncan began his educational career as a teacher and coach, spending six years as a coach at Crescenta Valley High School. Now the Graduate Education Coordinator for Chapman University's Moreno Valley Academic Center, Duncan served the CIF Southern Section as the Pacific League Representative to the Council. Additionally, he served on the Life Pass Selection Committee and he was the Releaguings Chair for the Foothill area.

MARGE FULTON

Marge Fulton is the first woman to be a starter at the State CIF Track and Field Meet. The long-time track official was also an official for the 1984 Olympic Games in Los Angeles. A former teacher and coach at West Torrance High School, Fulton is currently still on the CIF-SS Track and Field Management Committee and as the "expediter," she is essential to the timely fashion in which all CIF-SS Track and Field meets are conducted.

CYNTHIA GRENNAN

Dr. Cynthia Grennan is a former Superintendent of the Anaheim Union High School District. Her educational career started as a junior high teacher in Palatine, Illinois, moving into the Anaheim District in 1964. She got her start in administration as an Assistant Principal in 1972. Grennan served the CIF Southern Section as the Superintendents Representative to the Executive Committee, she served on the Sportsmanship Committee, and she helped coordinate CIF-SS Superintendents Symposium for two years. She was the Superintendents Representative to the State CIF and was

LONG BEACH POLY PULLS OFF RARE SWEEP AT 1997 STATE CIF ARCO am/pm TRACK AND FIELD CHAMPIONSHIPS

Long Beach Poly became only the second school ever to pull off a sweep of the team titles at the State CIF ARCO am/pm Track and Field Championships, held on June 6 & 7 at Hughes Stadium on the campus of Sacramento City College. Only Berkeley, in 1981, had accomplished the rare feat, until the Jackrabbits pulled it off this spring.

The Poly's girls team had to hold off a St. Bernard team, whose 4x100m relay squad set a new national record, to win by a narrow 49-48.5 margin. Individual winners for the Lady Jackrabbits were Bunni Ogunleye in the long jump (20-0 3/4) and Cynthia Ademiluyi in the shot put (47-5 1/4).

On the girls side, the Southern Section enjoyed tremendous success claiming championships in 10 events. Highlighting the action was, of course, St. Bernard's record-setting effort and Angela Williams' chase of Marion Jones' (Thousand Oaks) national mark in the 100m. Williams, from Chino, came up short by 1/100 of a second from tying Jones' time, running a 11:15.

Another highlight was the double championship effort by Kinshasa Davis of Long Beach Wilson. Davis took home titles in the 200m (22.90) and the 400m (52.66). Other event winners were Nicole Hoxie of J.W. North in the 100m high hurdles (13.35), St. Bernard in the 4x400m (3:39.43), Tayyiba Haneef of Laguna Hills in the high

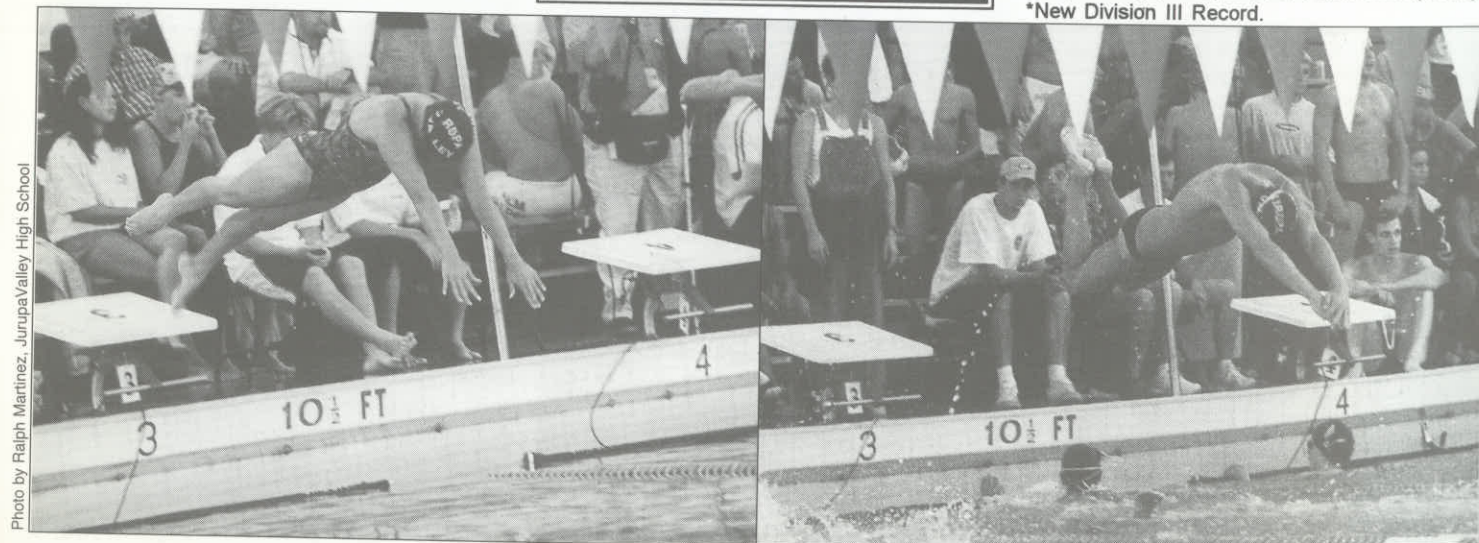
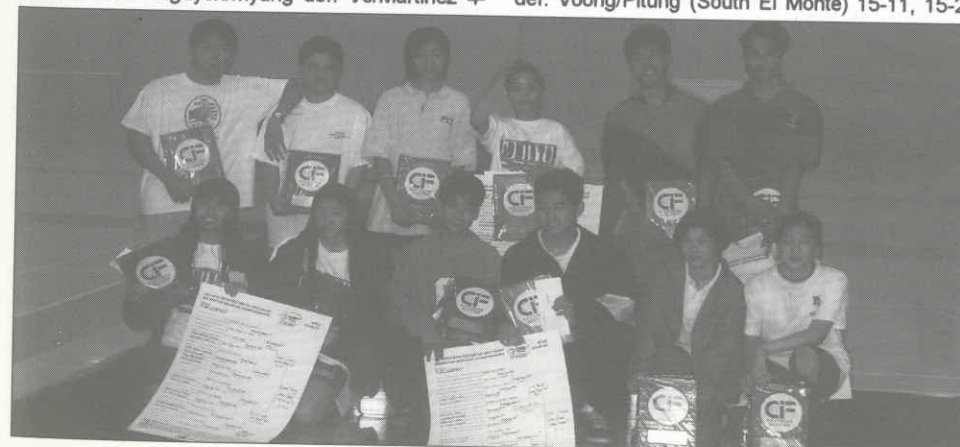

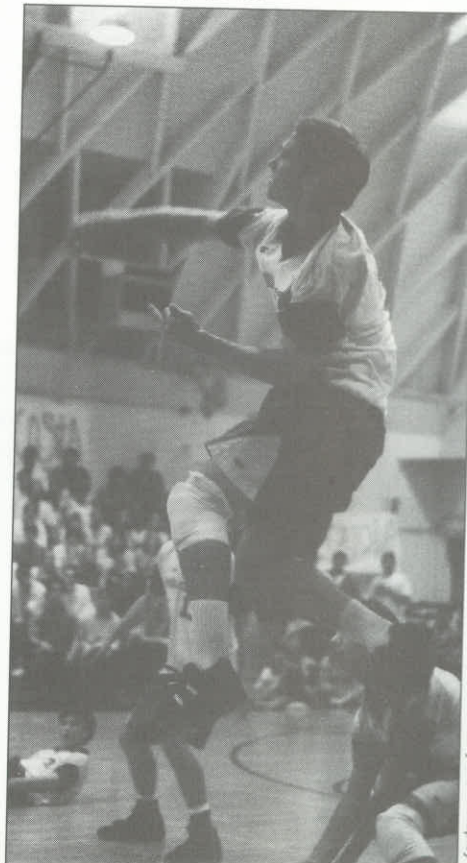

AAF/CIF SOCCER CLINIC SCHEDULE ANNOUNCED

These are free clinics designed specifically for high school soccer coaches, although anyone may attend. The Amateur Athletic Foundation and CIF Southern Section, in partnership with Umbro, developed this program and is offering it to soccer coaches at regional clinics across Southern California. The program now allows the opportunity for coaches who attend the clinics to receive a National Soccer Coaches Association of America (NSCAA) Regional Diploma.

The AAF/CIF Soccer Coaches Program will continue to offer the four-day clinic, while allowing coaches to attend the advanced two-day clinic. The two-day clinic curriculum has been revised to include new field sessions and lectures that focus on the use of small sided games to teach offensive and defensive tactics. The four-day clinic is a prerequisite for the two-day clinic. However, previous attendance at an AAF/CIF Soccer Coaches Clinic, or possession of a state "D" coaching license or NSCAA Regional Diploma fulfills the requirement for the two-day clinic.

c. Grant the appeal and direct the area to reconvene and releague, taking into account the merits of the appeal.

Of paramount concern, which must not and shall not be lost as Council representatives consider the proposals and appeals, is the objective of fundamental fairness to the student athlete and member schools.

It is also imperative that all interested parties glean wisdom from this experience. This wisdom should be used to augment the calculus of future relegating cycles. In the future, we must attempt to:

1. Clearly and effectively articulate the processes and procedures to all interested parties to establish respect for and avoid misperceptions about relegating.

2. Inservice new principals from the outset on their roles in the decision-making process.

3. Continue to be creative and forward thinking, to the improve the relegating paradigm.

It would be naive to presume the final action on relegating in October will be a perfect solution so as to placate all concerns and issues in the nine relegating areas. Nonetheless, through dispassionate diligence, applying rational bases, and avoiding destructive self-serving interests, we can seek to establish a plan which, perhaps solely for the term of this four year cycle, will be equitable, appropriate and fundamentally fair.

served the U.S. Army Air Corps in World War II as an accountant. Nissley attended U.C.L.A., Cal Berkeley, and the Claremont Graduate School.

In 1952, Al Valdes was asked to give officiating a try and from then on he never looked back. Valdes officiated basketball for 41 years, football for 37 years, baseball for 33 years, softball for 8 years, volleyball for 8 years, and track for 3 years.

Valdes first got involved in athletics as a youth league basketball coach for his Church of Latter Day Saints in Downey. He volunteered to officiate his church league games and two years later, Valdes was certified to officiate high school basketball games. Another two years later, he was certified to officiate football and baseball as well. Valdes served the CIF Southern Section as assigner of officials for basketball, football, and baseball in the Long Beach/Whittier area until his retirement in 1996.

Additionally, Valdes was instrumental in the growth of the number of women officials in the Long Beach/Whittier area. He also helped start the successful Downey High School Softball Classic, now to be named the "Al Valdes Downey Softball Classic."
