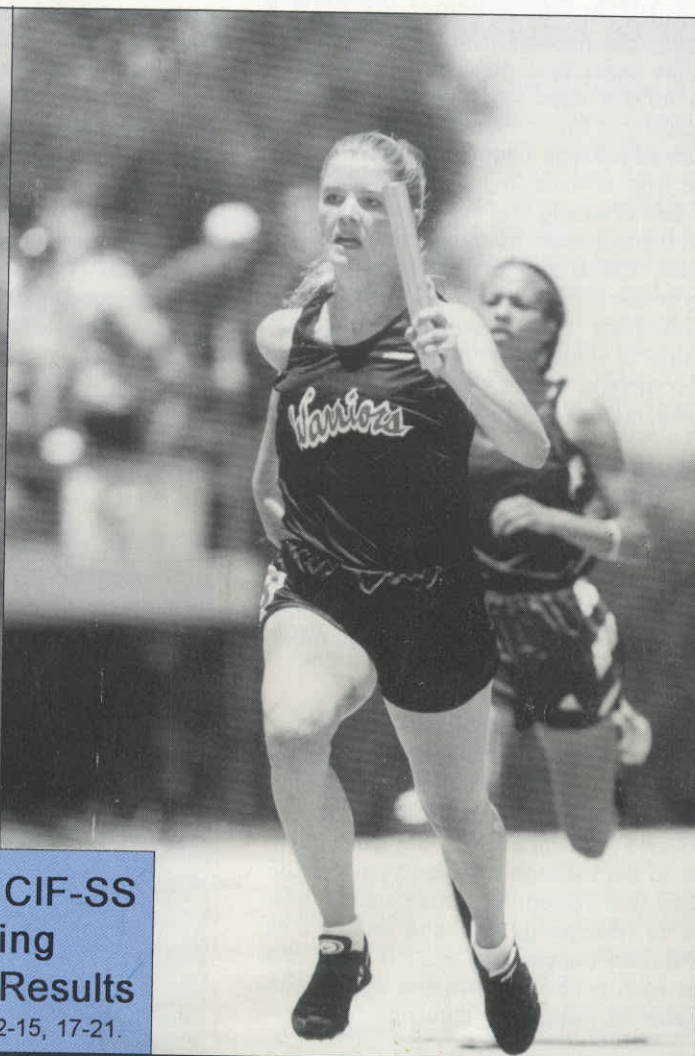
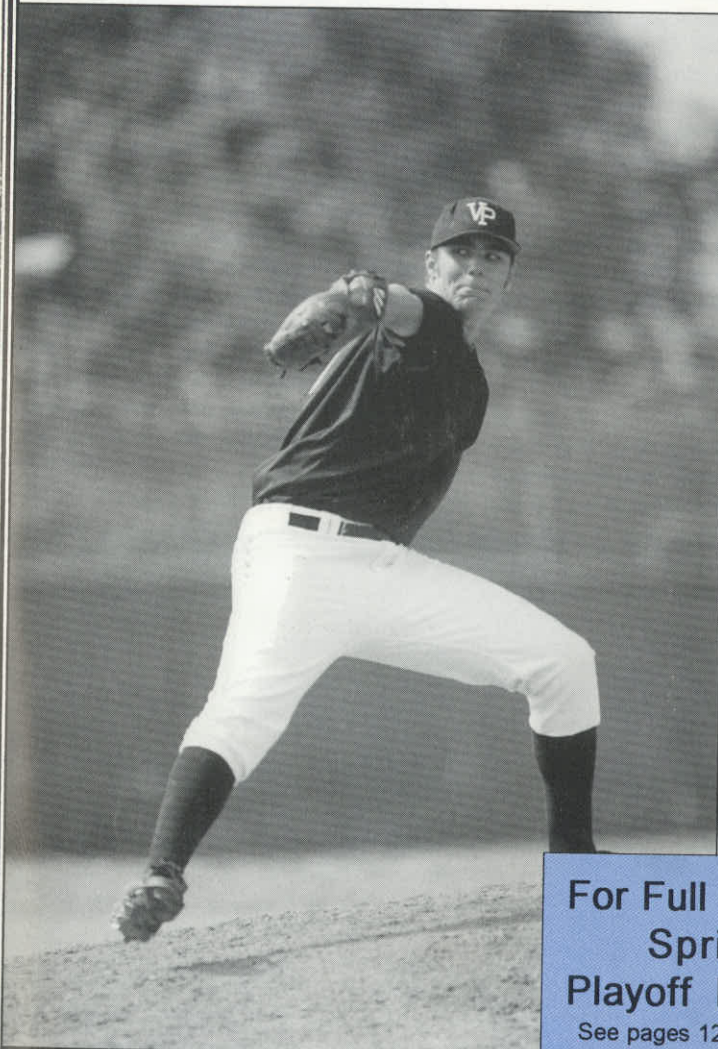

PRESIDENT'S MESSAGE



THE JOB OF RELEAGUING

Let me begin by expressing my appreciation for the opportunity to serve you as president of the CIF-Southern Section. I count it a privilege to represent all of our 500 plus high schools and dedicate myself to the task of seeing that our student athletes gain the maximum from their athletic experience. CIF is a great organization with a lofty mission of providing the best educational/athletic experience for the greatest number of students. I hope I can count on each athletic leader to support our CIF representatives in the year to come.

During this new year we will go through the procedure of relegating the section. This very important process gives us the opportunity to adjust league structures to account for changes in competitiveness of schools. In so doing we hope we can maintain and/or improve competitive opportunities within leagues.

Relegating is intensely democratic with every principal given the opportunity to represent his/her school and the best interests of students and athletic programs. Because of its importance, pay close attention to the mailings received from the CIF office and relegating chairpersons relative to relegating. No one knows their school like the principal and it is imperative that each principal attend and actively participate in relegating meetings.

Great efforts have been made to keep the process fair. The area relegating committees, the relegating committee, the executive committee, and the council are all forums where principals can make known the needs of their athletic programs. If the principal fails to be actively involved, he/she runs the risk that decisions will be made without the benefit of needed information and perspective.

We will have successfully accomplished the relegating process when each of our member schools is placed in a league where there is a balance of athletic com-

CASTILLO NAMED NEW ASSISTANT COMMISSIONER

Paramount High School Athletic Director Paul Castillo was named as a new Assistant Commissioner of Athletics for the CIF Southern Section today. Castillo, 57, replaces Dr. Harold Cebun who left to become Superintendent of Schools for the Lynwood Unified School District.

"The CIF Southern Section is pleased to have someone of Paul's experience and proven leadership," said CIF-SS Commissioner of Athletics Dr. Jim Staunton. "We were extremely happy with the pool of candidates and could not have made a wrong choice with any of the three finalists."

"I am extremely honored to be named to the position considering the other finalists," said Castillo. "This is a great opportunity for me and something I consider to be the pinnacle of my 12 years in athletic administration."

Castillo entered the field of education in 1966 after earning a bachelors of arts degree in physical education/health science from the San Fernando Valley College (Cal-

fornia State University, Northridge) in 1965. His first teaching position was in P.E. at San Fernando Junior High School, where he taught until 1969. He moved to Paramount High School in 1969, first as a teacher and Physical Education/Health and Sciences Department Leader (1969 to 1988) as well as a coach for boys' and girls' tennis, football and basketball (1969 to 1998). Castillo was named Athletic Director at Paramount in 1987 and had served in that role until now.

Castillo also served as an English teacher at Compton Community College (1972-1978) during that time. In 1977 he completed a Masters in Arts program at the College of St. Thomas. Castillo has served on numerous CIF Southern Section, CIF-State, San Gabriel Valley League, Paramount Unified School District and Paramount High School committee's. Castillo was named California State Athletic Directors Association (CSADA) Athletic Director of the Year during the 1991-92 school year.

Bill has, for more than 20 years, guided the development of CIF, turned our championships into classy, profitable events and adjusted our rules to meet a number of significant changes. Now he leaves. By the time this bulletin reaches you, we will have selected a replacement, but we will still be feeling the sadness of Bill's leaving as well as the challenge of filling his shoes. We wish him well; we will miss him and will not forget his contributions to our organization.

Our Executive Committee welcomes Tom Peters, newly appointed interim representative for the small schools area. Tom comes to CIF with strong recommendations and a long history of participation in our organization. This year, we are piloting some changes that will have an effect on communication with the section. CIF-SS COUNCIL MEETING MINUTES April 23, 2000

The April meeting of the CIF-SS Council was called to order by Margie Godfrey, President at 9:04 a.m. on Thursday, April 13, 2000, at the Sequoia Club. All leagues were present with the exception of Arrowhead, Bay, Coast Valley, Foothill, Freedom, Imperial Valley, Liberty and Rio Hondo.

1. **ADOPT AGENDA** – It was moved, seconded and passed to adopt the agenda as revised.

2. **MINUTES** – It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of March 23, 2000.

3. **GOLD LIFE PASS PRESENTATION** – Margie Godfrey, Chairperson of the Life Pass Committee, introduced those receiving Life Passes in recognition of their long standing service to the CIF-SS. Recipients were Dick Larson, Damien High School; Bob Bias, Claremont High School; Jim Judd, Hemet High School; Ardyce Masters, Canyon High School (Canyon Country); and Dean Crowley, Commissioner, CIF-SS. Additionally, Hall of Fame Honorees were Paul Branum, Coach, Trona High School; Lyman Clower, Athletic Director, Edison High School and Marti Walker, Coach, Wilson High School.

4. **CIF STATE FEDERATED COUNCIL MAY ACTION ITEMS** – Clark Stephens, President-Elect, presented the following agenda items for the May CIF State Federated Council meeting in order to give Southern Section delegates voting direction.

A. Change in Article 4, Section 43 to allow representatives of allied organizations to serve as officers of the organization – vote to support.

B. Recommendation to alter terms of the President-Elect and Past President (Article 4, Section 43) – vote to support.

C. Revision of Article 2, Section 20, to include a school board representative on section governing boards – vote to support.

D. Revision of By-Law 308 that bans competition or practice on Christmas and Sunday – vote to support.

E. Proposed addition to By-Law 1200 which would prohibit sections approving sports not on the list of approved sports listed in the State Constitution and By-Laws approved by the Federated Council – vote to support.

F. Proposal to eliminate Article 2, Section 20 and language to By-Law 103, Federated Council Voting – vote to support.

G. Track and Cross Country Advisory Committee recommendation to allow at-large entries for the State Track and Field Meeting – vote to support.

H. Track and Cross Country Advisory Committee recommendation to allow At-large entries for the State Cross Country Meet – vote to support.

I. A proposal from the Commissioner's Committee which allows flexible enrollment divisions in cross country – vote to support.

J. Volleyball Advisory Committee proposal to allow a change in scoring pattern to provide for "Rally Scoring" in State and Regional Championships – vote to support.

K. State CIF Budget for 2000-2001 fiscal year – vote to support.

4. **BLUE BOOK COMMITTEE PROPOSAL** – Nancy Billinger, Blue Book Committee member, reviewed the following items from the Blue Book Committee:

A. Maximum Athletic contests in One Day (Rule 2915) – A Recommendation that Rule 2915 read, "All interscholastic contests are to be arranged in such a way that no student shall take part in more than two athletic contests in any one day", was approved.

B. Football Scrimmage (Rule 1915.8) – A recommendation to delete Rule 1915.8 was approved.

C. Football Scrimmage (Rule 1915) – A recommendation to allow a scrimmage at all levels i.e., frosh, sophomore, etc. was approved.

D. Football Spring Practice (Rule 1921.1) – A recommendation to delete last sentence was approved.

6. **CIF-SS 2000-2001 BUDGET PROPOSAL** – Clark Stephens, President-Elect reviewed the proposed 2000-2001 Southern Section budget. Following discussion, it was moved, seconded and passed to adopt the budget as presented.

7. **BASLINE LEAGUE PROPOSAL** – Tabled until the October Southern Section Council meeting.

8. **2000-2002 PLAYOFF GROUPINGS** – Dr. John Dahlem, Chairperson of the Playoff Groupings Committee, presented the Playoff Groupings Committee's recommendation for the 2000-2002 cycle. Following discussion, a motion to approve the Playoff Groupings Committee's recommendations was passed.

9. **EXECUTIVE COMMITTEE ELECTIONS** – Gary Ernst, Chairperson, reviewed recommendations for positions on the CIF-SS Executive Committee. Following a vote by the Council those elected were: President-Elect - Paul Breit, Principal, Ganesha High School; Girls' Athletic Director - Sharen Caperton, Athletic Director, Brea Olinda High School; Mt. SAC Area Representative - Dr. Ken Gunn, Principal, Walnut High School; Orange County Area Representative - Dr. John Dahlem, Principal, Loara High School; Parochial Area Representative - Sr. Cheryl Milner, Principal, Bell-Jeff High School and Superintendent Representative - H.J. Green, Area Superintendent, Long Beach Unified School District.

10. **STATE FEDERATION COUNCIL NON-ACTION ITEM** – Clark Stephens, President-Elect, presented the following agenda item for the May State Federated Council meeting:

A. Executive Committee -- election process, nominations, terms of office and succession.

11. **AREA PLACEMENT/RELEAGUING** – Susana Arce Releaguings Chairman, reviewed the area placement and releguing process for the next cycle 2002-2006.

12. **TREASURER'S REPORT** – Shirley Frazier, CIF-SS Director of Budget and Finance, reviewed the status of the 1999-2000 CIF-SS budget.

13. **COMMISSIONER'S REPORT** – Jim Staunton, reported on area placement, releguing, State Athletic Directors' Conference, S.B. 1618 and water polo litigation.

14. **PRESIDENT'S REPORT** – Margie Godfrey, reviewed CIF-SS awards, Blue Book format, and President's Council Representation.

15. **PASSING OF THE GAVEL** – Margie Godfrey, President, relinquished her duties to President-Elect Clark Stephens, for the 2000-2002 term as President of the CIF-SS Council.

There being no further business to come before the Council, the meeting was adjourned at 12:30 p.m.

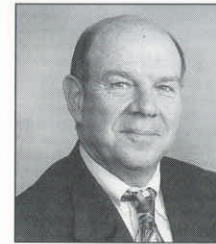

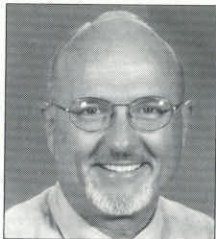

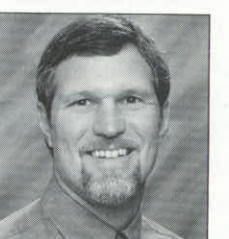

SYNOPSIS OF CHANGES TO 2000-2001 BLUE BOOK

The following is designed for the benefit and convenience of athletic administrators and coaches in an effort to provide a capsule summary of the changes in the State CIF and Southern Section Constitution and Bylaws. These changes have been enacted by the State CIF Federated Council and the Southern Section council throughout the course of the 1999-2000 school term.

STATE REVISIONS

- 70: Defines selection and role of State Executive Committee.
- 103: Revises weighted voting.
- 212: New list of approved Foreign Exchange Programs.
- 227: New section on home study and home schooling.
- 303: Adds charter schools.
- 308: Allows practice or interscholastic games on Christmas.
- 702: Adds note regarding bordering state sanctioning.
- 1100: Revises student eligibility appeals procedure.
- 1200: Clarifies approval process of new sports.
- 1700: Revises CBED divisional format.
- 1702: Clarifies at-large entries in state cross country.
- 1900: Revises age requirement for varsity participation.
- 2002: Clarifies participation during championship tournament week.
- 2704: Clarifies at-large entries in state track and field.
- 2800: Adds rally scoring to regional and state volleyball championships.
- 3000: Revises wrestling statewide modifications.

SOUTHERN SECTION REVISIONS

- Article 4: Adds language regarding Brown Act.
- Article 5: Revises Area Placement Process Guidelines.
- 125.1 Q&A: Clarifies attendance at contest.
- 214.3 F: Identifies Open Enrollment Verification Form.
- 500.21 Q&A: Clarifies status of ineligible player.
- 600 Q&A: Clarifies competition on an outside team.
- 1413: Clarifies penalty for player ejection. Also added to all other sport sections.
- 1414: Clarifies penalty for coach ejection. Also added to all other sport sections.
- 1915: Allows a scrimmage at all levels.
- 2915: Adds new definition for maximum contests in one day.
- 2908: Changes maximum team contests to 20.
- 3002 F: Clarifies making weight and entry into CIF-SS Individual Championships.
- 3100.1: Adds track and field to enrollment based playoffs - also no move-ups allowed in enrollment based playoffs.

LONG BEACH POLY AND SANTA MARGARITA CLAIM TITLES IN NINTH ANNUAL CAVALCADE OF CHAMPIONS

The CIF Southern Section is pleased to announce the top ten girls and boys athletic programs in the Ninth Annual Cavalcade of Champions.

On the girls side, Santa Margarita took top honors scoring 19.5 points on the strength of championships in water polo swimming and diving and volleyball. The Eagles also claimed a runner-up finish in cross country and a semifinal finish in track and field. Foothill was second tallying up 15 points, with championships in water polo, cross country and softball. Rounding out the top three was Harvard/Westlake. The Wolverines scored 14 points based on a championship in tennis and runner-up finishes in water polo, volleyball and golf.

Long Beach Poly won the boys title for the second straight year. The Jackrabbits

scored 17 points, winning CIF-SS titles in cross country, basketball, and sharing a title in football. Long Beach Poly was also runner-up in track and field. Second place went to Mater Dei with 16 points. The Monarchs won championships in basketball and shared titles in football, and soccer. Additionally, Mater Dei was runner-up in volleyball. The No. 3 spot went to Santa Margarita. The Eagles scored fifteen points, winning CIF-SS crowns in soccer and golf. Santa Margarita's track and field and swimming and diving teams finished third and its cross country took fourth.

The CIF-SS developed this recognition program based upon comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and

member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team place-finish sport (i.e. cross country, golf, swimming and diving, and track and field); and one point for a fourth place finish in a team place-finish sport. In cases where a tie occurs for 10th place, total team-sport playoff appearances will be used to determine the top ten schools.

"We at the CIF-SS would like to congratulate these fine schools for their outstanding performances," said Dr. Jim Staunton, CIF-SS Commissioner of Athletics. "They all have a lot to be proud through their accomplishments and those of their entire athletic

NFHS AUTHENTICATING MARK PROGRAM

When varsity athletic competition resumes this fall in high schools around America, student-athletes, coaches, athletic administrators and contest officials now will enjoy a higher standard of quality in game equipment with the implementation of the new NFHS Authenticating Mark Program.

The NFHS Authenticating Mark Program, which was approved by the NFHS Board of Directors in January 1998, will ensure that the equipment meets NFHS rules specifications and will promote programs that benefit the high school community. The program will allow the development of more sophisticated standards in balls and pucks and clearly communicate to administrators that those standards are being met. The program will help fund sports medicine research and coaches education projects.

Forty-two companies (identified below) have contracted with the NFHS to participate in the Authenticating Mark Program, which replaces the NFHS Approved Products Program. As part of the Authenticating Mark Program, all balls and pucks used in varsity interscholastic competition in baseball, softball, football, basketball, ice hockey, volleyball, soccer, water polo and field hockey will be required to carry the mark beginning with the 1999-2000 school year.

"The NFHS is pleased that these 42 companies have contracted to participate in the NFHS Authenticating Mark Program," said Robert F. Kanaby, NFHS executive director. "Through that participation, they are communicating to high school administrators, coaches and officials that their equipment is consistent with NFHS specifications. We

appreciate their commitment to high school sports."

In October 1998, the NFHS Board of Directors adopted the following statement: "The NFHS recognizes that circumstances will inevitably come to light that cannot be rectified within the established time frame for implementation of the NFHS Authenticating Mark Program.

State associations will have broad leeway to work with schools, manufacturers and dealers to implement the program in a way that minimizes hardship to all interested parties.

In the event that a properly marked ball or puck is not available for use in a given contest, the NFHS recommends that the

GOLD LIFE PASS AWARDS WINNERS HONORED

The California Interscholastic Federation, Southern Section honored five longtime contributors to the cause of high school athletics and CIF-SS activities with the prestigious Gold Life Pass Awards at the April 13 Council Meeting in Buena Park.

The Gold Life Pass Award, emblematic of the highest service honor the organization can bestow upon an individual, celebrated its 48th year this spring. The award was initiated in 1952, with the first presentation going to Seth Van Patten, generally regarded as the "Father of the CIF Southern Section" and its first Commissioner of Athletics (1930-50). Including the five recipients awarded this year, a total of 178 Life Pass Awards have been presented.

Biographical sketches of the 2000 honorees; Bob Baiz, Dean Crowley, Jim Judd, Dick Larson, and Ardyce Masters follow.

BOB BAIZ

Bob Baiz was head football coach at three CIF-SS high schools during his 28 years as a varsity head coach. Baiz coached at Lasuen (1961-70), San Dimas (1970-79) and Claremont (1979-1996). Baiz also served as Athletic Director at San Dimas. Having served as Baseline League Coordinator from 1985-95, Baiz claimed CIF titles at both Lausen (1962) and two titles while at Claremont. Baiz notched 213 victories during his career and 12 league titles. Baiz was selected Coach of the Year in 1984 and 1985. Coach Baiz was also selected to coach in five All-Star games during his career including the Shrine, San Gabriel Valley Hall of Fame, San Gabriel Valley Rotary, South Bay All-Star and Catholic All-Star games. Baiz has served as a Charter Member and second president of the Foothill/Citrus Athletic Directors Association. A board member of the Southern California Interscholastic Football Coaches Association for 12 years, Baiz has served as Clinic Director for SCIFCA since 1986. Baiz is currently an Assistant Principal for Academic Affairs at Damien High School.

DEAN CROWLEY

Dean Crowley devoted 23 years of his professional career in the service of the CIF-SS, including his last six as Commissioner of Athletics. Crowley came to the CIF-SS in 1976 after serving in the roles of Assistant Principal, teacher and coach at Gahr High School in Cerritos. An active participant in all areas of athletics, Crowley recently served as President of the National Association of Sports Officials. He has served on the board or as president for both the Southern California Basketball and Football Officials Associations. He officiated at four major college football bowls (Aloha, Independence, Freedom and Las Vegas) as well as a supervisor

for college football and basketball officials on the West Coast. Due to his outstanding service to officiating, Crowley was awarded the Distinguished Service Award from the Southern California Basketball Coaches Association in 1982.

JIM JUDD

Jim Judd spent nearly 40 years in the field of education, with over 28 years of involvement with the CIF Southern Section. A former teacher and coach, Judd was Athletic Director at Palm Springs High School and Hemet High. He served the CIF-SS Council as the Desert Valley and Sunkist League Representative and served on the CIF-SS Officials Fees Committee from 1995-99. Additionally, Judd also served as a baseball basketball coach at Palm Springs. Judd also served as an official at various levels from 1965-73. A member of the California State Athletic Directors Association, Judd was named CIF-SS Athletic Director of the Year in 1997-98.

DICK LARSON

Dick Larson served as the Athletic Director at Mt Carmel and Cantwell High Schools as well as longtime football, basketball, baseball and track coach at four different

schools. Larson began his career in high school athletics as an assistant football, baseball and basketball coach at Cantwell in 1961. He then went on to coach at Salesian, Mt Carmel and back at Cantwell, before settling into a 23 year career at Damien. During Larson's time as a football coach, his teams compiled a record of 227-127-6 (.630). His teams advanced to the playoffs 21 times and earned CIF-SS titles twice while garnering league titles 10 times. Larson was CIF-SS Coach of the Year twice as well as Inland Valley and Pomona Valley Coach of the Year. Larson coached in the 605, San Gabriel Valley and Catholic All-Star games a combined total of six times.

ARDYCE MASTERS

Ardyce Masters was Athletic Director at Canyon of Canyon Country High School from 1970 to 1998. During that time, she was not only a successful coach, but also an advocate for girl's athletics. In 1971 she was instrumental in the organization of girl's sports within the Golden League. From the early 1970's until 1994, she served as CIF-SS representative and coordinator for the Golden League and, later, for the Foothill League. During this time, Masters also won 12 league championships as the girls volleyball coach, four league titles as the boys volleyball coach, a league crown as girls basketball coach and one as girls badminton coach. Masters continues to serve Canyon High School as a Physical Education instructor.

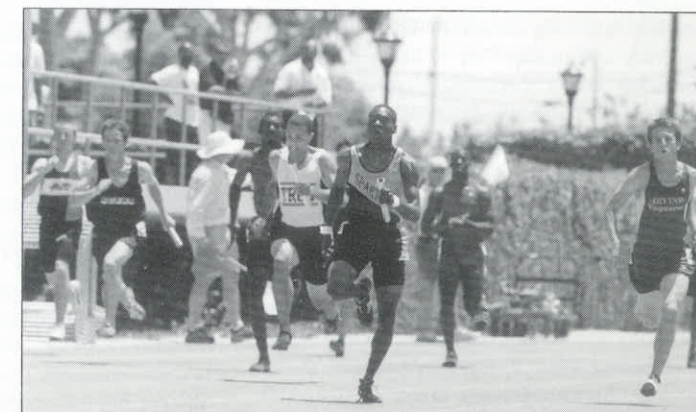

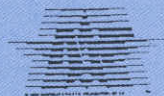
