PRESIDENT'S MESSAGE



Why Am I Doing This?

It's time to checkup on our motivations. Whether you are a superintendent, principal, athletic director, coach, official or someone else involved in high school athletics, every once in awhile you need to ask yourself the question, "Why am I doing this?"

Probably (hopefully) at one time you were motivated by a desire to give students a quality athletic experience as part of the process of producing "good" people. You know what I mean. People that have admirable character. People that have the characteristics of honesty, endurance, respect for authority, courage, leadership, service, and the ability to work as a team.

Sometimes we may find ourselves spending so much time and effort in producing the best athletic play that we neglect to use our influence and opportunity to develop the best personal characteristics in our players.

What would you rather have? The greatest team with members of questionable character or a team with lesser abilities, but with outstanding people. If we haven't succeeded in helping students to be better people, then their wins become hollow, without substance.

The story is told of a basketball team behind in a big game when the coach called a time out to talk to his players. The coach said, "Boys, you are running the plays with precision. Your passes are crisp and accurate. You are dribbling the ball with skill and finesse. You are working as hard as you can. BUT if we don't put the ball in the hoop, we're going to lose this game."

I have to ask myself some questions, while I invite you to do the same. Am I getting the ball into the hoop? You know, getting the real job done. "Am I looking good? Am I doing all the right stuff, but

neglecting to focus on the real job of helping boys and girls grow into outstanding men and women of character? Or am I settling for wins instead of striving to be victorious?"

Do you remember what it felt like when you had a former player find you years later and you could tell that he or she had put it all together in his or her life while you knew that you played a part in helping that student develop into a good person? I hope you have. There's nothing like it.

Dave came by the school the other day and took the time to tell me that he was happily married and thoroughly enjoying his new child. He told me of his satisfying job and his hopes for the future. We talked about his experiences and how he was responding to life's normal trials. We shared information about his former teammates and coaches. Then he said, "I think about playing on the team all the time. I learned so much about myself and about life and I'm so glad I had a chance to play sports. Coach and the players had a great influence on me."

I don't know about you, but that's why I do what I do. I love being a part of a program that has a profound influence on young people. And when some boy or girl turns into a man or woman of character, then we know we put the ball into the hoop.

opponents. Imagine if we were allowed to learn club selection from the first person on the tee. If he were to share information that could help someone else in his/her foursome learn that a six iron won't get you across the water, wouldn't that hurt the outcome of the competition and be unfair to the first player on the tee? What if a player tells a competitor the wrong club to use? Can we see the day in high school golf when coaches in golf carts and/or walkie talkies cruise the course telling players what clubs to play on what hole? Of course one has to ask just how much help advice gives, but nevertheless many people argue that it should be allowed in Southern Section contests

This is why I was pleased to see the press carry an item on Greg Chalmers, PGA professional. Chalmers was playing in the Kemper Insurance Open. He became miffed when he saw a caddie spying to see what clubs he was playing (remember caddies can give advice to their pros). He was upset after hitting a bad shot and turned to an offending caddie and said something like "1 hit a six-iron-now get away from me."

What I see as inspiring is that Chalmers found out about the rules violation after he completed his round. He reported the incident immediately to the rules official. With that knowledge, the official had to rule against him for signing an incorrect scorecard. Chalmers disqualified himself. It cost Chalmers a lot of money, but it makes an important point: the proper conduct of sport requires every participant to adhere to the rules.

The skeptic might laugh at him for walking away from so much money. The truth is that he will play again and will have a chance to make even more as he plays the tour. His decision to self-report is inspiring to me and should be to young players.

Michael Josephson tells us that ethical behavior means doing the right thing, even though the price we pay may be more than we want to spend. Well, Chalmers spent a lot, but he also earned the respect of the golfing community and upheld a set of rules that have been around for a long time. He behaved ethically. Should we change the rule? I don't think so. Golf is as much a mental challenge as physical. Let's let each player compete to the best of his/her ability, without interference, spying, or discussion. When mistakes are made, expect the offender to report it and move on. That's what the game is about.

NFHS ADDRESSES FOOD SUPPLEMENTS

(Recently, there has been an increased coverage of the use of food supplements and there effects on athletes at all levels. On August 14, 1998, the NFHS released a policy statement presented by their Sports Medicine Advisory Committee. The following is a re-print of that statement for your information)

In response to the recent focus on the use of food supplements, specifically creatine, the NFHS Sports Medicine Advisory Committee has issued a position statement on the use of drugs, medicine and food supplements in interscholastic sports. Text of the committee's statement follows:

"School personnel and coaches should not dispense any drug, medication or food supplement except with extreme caution and in accordance with policies developed in consultation with parents, health-care professionals and senior administrative personnel of the school or school district.

"Use of any drug, medication or food supplement in a way not prescribed by the manufacturer should not be authorized or encouraged by school personnel and coaches. Even natural substances in unnatural amounts may have shod-term or long-term negative health effects.

"In order to minimize health and safety risks to student-athletes, maintain ethical standards and reduce liability risks, school personnel and coaches should never supply, recommend or permit the use of any drug, medication or food supplement solely for performance-enhancing purposes."

Jerry Diehl, assistant director of the NFHS and staff liaison to the Sports Medicine Advisory Committee, said the committee issued this statement in response to requests from member state high school associations to address the increased use of food supplements such as creatine.

The Sports Medicine Advisory Committee is composed of four state association representatives and six members of the medical community, and is chaired by Don Herrmann of the Wisconsin Interscholastic Athletic Association.

COMMISSIONER'S CORNER

Golf **Advice**

"There are two kinds of fools in the world: those who ask for advice and those who give it."

The topic of advice in the sport of golf has been discussed in our golf advisory committees on several occasions. There are some strong feelings on either side. Presently, CIF Southern Section enforces a strict policy against competitors, even teammates, from exchanging information during a competitive round. This restriction is against "any counsel or suggestion that could influence a player in determining his play, the choice of a club or the method of making a stroke."1 This prohibition is complicated because teammates are defined as "fellow competitors" during stroke play. It doesn't make sense to many coaches that we would restrict teammates from sharing information during a round, especially since high school is a time when students learn the rules of games and many coaches want to develop team camaraderie. Besides, many contend that coaches in the NCAA are allowed to give advice, and caddies in the professional ranks can give advice also. "What's wrong with kids exchanging advice?" they ask.

golf Rule 8-1 reads, "During a stipulated round, a player shall not give advice to anyone in the competition except his partner and may ask for advice only from his partner or either of his caddies."3 Well if it says that you can get advice from a partner, doesn't that make it all right? No. In stroke play, partners are defined as "fellow competitors

The other reason offered for adhering to the advice rule is that we need to teach respect for our games and their traditions. Golf has long prided itself on the conduct of its competitors. Players are expected to call penalties on themselves as soon as they realize there has been a breach of the rules. As far as advice goes, the game asks that competitors not gain unfair advantage by learning appropriate club selection from See COMMISSIONER page 23.

The April meeting of the CIF Southern Section Executive Committee was called to order at 1:00 p.m. by President Clark Stephens at Edison International Field, Anaheim. All members were present, with the exception of Susana Arce, Tom Peters, Liza Scruggs, Gary Smidderks, and Jeannine Martineau

- 1. ADOPT AGENDA It was moved, seconded and passed to adopt the revised agenda.
- 2. MINUTES It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of February 7, 2001.
- 3. COMMUNICATION TO THE EXECUTIVE COMMITTEE - Resignation of Margie Godfrey from the Executive Committee. A motion to accept her resignation was approved.

4. ACTION ITEMS -

- A. SKYWARD CHRISTIAN-Failure to comply with CIF-SS Rule 3120. After discussion, it was moved, seconded and passed to not allow Skyward Christian to host any CIF playoff contests, effective this spring, and including the 2001/02 school year.
- B. MASADA AND WESTMARK HIGH SCHOOLS-Masada and Westmark High Schools regarding delinquent CIF dues. After discussion with representatives from both schools, and assurances that both schools will not allow this to happen again, their re-applications for CIF membership were accepted.
- C. CROSSROADS HIGH SCHOOL Regarding actions at the 2001 State Basketball Championships. After discussion, it was recommended that the following steps be taken:
- 1. Crossroads High School will prepare their response, and send it in writing, to the Commissioner of Athletics.
- 2. The Commissioner of Athletics will send copies to the Executive Committee.
- 3. Crossroads High School will appear before the CIF Southern Section Executive Committee, at their next regularly scheduled meeting, on June 6th, 2001.

- H. CENTENNIAL HIGH SCHOOL (COMPTON) - The Commissioner provided the background information regarding several rules violations committed by Centennial High School during the past two years. The Commissioner recommended that Centennial High School be placed on probationary status for the 2001/2002 school year. Motion to support - passed.

PASO ROBLES AND HARVARD-WESTLAKE CLAIM TITLES IN TENTH ANNUAL CAVALCADE OF CHAMPIONS

The CIF Southern Section is pleased to announce the top ten girls and boys athletic programs in the 10th Annual Cavalcade of Champions.

On the girls side, Harvard/Westlake took top honors scoring 22 points on the strength of championships in volleyball, basketball and a cochampionship in soccer. The Wolverines also claimed a runner-up finish in golf and water polo, as well as a semifinal finish in tennis. Corona del Mar was second tallying up 21 points, with championships in cross-country, track and tennis. The Sea Queens also reached the semifinals in volleyball, water polo and soccer. Rounding out the top three was Poly of Pasdaena. The Panthers scored 14 points based on championships in soccer and track. Poly also claimed a runner-up finish in volleyball as well as a fourth place finish in cross-country.

Paso Robles won the boys title. The Bearcats scored 17 points, winning CIF-SS titles in football, wrestling, and swimming. Paso Robles was also a semifinalist in basketball. Second place went to Newport Harbor. The Sailors also scored 17 points, but took second on the basis of a tiebreaker criteria. Newport Harbor won championships in basketball and water polo while the football team finished as a runner-up. The Sailors were also semifinalists in swimming and volleyball. The No. 3 spot went to Santa Margarita. The Eagles scored 16 points, winning a CIF-SS crown in volleyball. Santa Margarita's swimming team finished second-and their basketball, soccer, track and golf team's reached the semifinals.

The CIF-SS developed this recognition program based upon comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition. sportsmanship, and goodwill among the student athletes and member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team place-finish sport (i.e. cross country, golf, swimming and diving, and track and field); and one point for a fourth place finish in a team place-finish sport. In cases where a tie occurs several tie-breaking methods will be used to determine the top ten

"Congratulations to these fine schools for outstanding performances," said Dr. Jim Staunton, CIF-SS Commissioner of Athletics. "They are to be proud of the accomplishments of their entire athletic programs."



LONG BEACH POLY CLAIMS SIXTH GIRLS TITLE AT 2001 CIF STATE TRACK AND FIELD CHAMPIONSHIPS

The best in the nation is the way the CIF State Track and Field Championships are often described. And for good reason.

The 2001 meet, held at Hughes Stadium in Sacramento on June 1st and 2nd, was filled with great individual and team performances as two national high school records and one state meet record was set. In addition, Long Beach Poly won a record sixth girls' team title with a 59-point effort.

Shayla Ballentine of Morro Bay High School provided one of many meet highlights with a national record vault of 13-8. Her mark topped the previous best of 13-4 set by Stacie Manuel of Albertville High School in Minnesota set in 2000.

Big Bear's Ryan Hall then challenged the 4-minute mark in the 1600, setting a state meet best time of 4:02.62. Michael Stember of Jesuit had the previous state mark of 4:04.00 (1995).

The Long Beach Wilson girls then broke their own national mark in the 1600 meter relay in a sizzling 3:35.72. Wilson set the previous standard of 3:36.32 at the 1998 state meet. Bei and Siraki, of Hoover Glendale High, also had the top national marks of the year in the 3200 at 10:11.11 and 10:11.79 respectively. Both will attend Stanford University in the fall.

Candace Bauchman sparked Long Beach Poly to the girls' team title finishing first in the triple jump (42-04.50) and third in the Long
