The California Interscholastic Federation Southern Section (CIF-SS) is the largest of ten sections governing high school athletics and activities in California. There are more than 560 schools, 84 leagues and approximately 300,000 student/athletes served. Making sure all sections monitor and oversee rules, changes, appeals, and disagreements is the responsibility of each section's commissioner's office.

COMMISSIONER'S CORNER

Welcome Back

Welcome to a new school year. 20062007 holds great promise for the athletic community. This year our Section begins a new league cycle and with it new playoff groupings. It figures that throughout our championships we will see some new, and perhaps long overdue, match-ups. For the first time we will see a State Football Bowl Championship. We will even discuss an expansion of the concept to soccer and perhaps softball and baseball. This is exciting.

We have several challenges ahead, however. I'd like to open this year with a review of what issues we see as important and timely.

Officials Fees - This year ends our threeyear agreement with our officials. Office staff, as well as our Officials' Fees committee has begun discussions on how to craft an agreement that meets the needs of both parties. We understand that gasoline prices and the higher cost of doing business affects everyone. Your Council will hear regular reports from the Committee as the year begins.

Transfer Rules - The State Federated Council Executive Committee charged Marie Ishida with the responsibility of crafting a statewide transfer rule. The reason is simple; there are different transfer rules in our sections and that has become a liability. Two separate committees met this summer to propose transfer rule language that can pass the test of scrutiny in every section. If a common rule can be adopted then we face less exposure to lawsuits and legislative action. I know our section members feel strongly about indiscriminate athletically related transfers. We need to maintain our high standards while still allowing deserving students their eligibility.

Strategic Planning - Your Executive Committee asked office staff to discuss the direction of the Section with constituent members to get a sense of where we should go in the next few years; to develop a roadmap for our future. We have begun our meetings to discuss officials and

# PARTICIPATION IN HIGH SCHOOL SPORTS INCREASES AGAIN

INDIANAPOLIS, IN (September 18, 2006) - For the 17th consecutive year, the number of student participants in high school athletics increased in 2005-06, according to the National Federation of State High School Associations (NFHS). Announcement of the increase comes as the NFHS, the national leadership organization for high school athletics and fine arts activity programs, launches new initiatives toward becoming a more proactive force for the future of high school activity programs nationwide.

Based on figures from the 50 state high school athletic/activity associations, plus the District of Columbia, that are members of the NFHS, participation for the 2005-06 school year rose by 141,195 students to 7,159,904, according to the 2005-06 High School Athletics Participation Survey conducted by the NFHS. Through the survey, it was also determined that 53.5 percent of students enrolled in high schools participate in athletics.
"We're thrilled with this year's survey results," said NFHS Executive Director Robert F. Kanaby. "The results show that even more students are participating in high school sports, which will have positive effects on their long-term personal success. The results support the NFHS 2005-2008 Strategic Plan, in which the organization committed to providing stronger leadership and support for high school athletics and fine arts activities."

For years, the NFHS has been the source of official playing rules, training programs for coaches and officials, and coordination and communications among individual state high school associations. In addition to these foundational roles, Kanaby said the NFHS will be working to gain awareness and support from state and local governments, media, corporate partners, and especially students and their parents.
"It is unfortunate that, in some cases, financial support for high school athletics and activities has been declining," Kanaby said. "Students want these programs. This latest survey shows a continuing trend toward more participation, and that's good for students and their communities. We can demonstrate that participation in athletics and activities helps students succeed in life."

In addition to the overall numbers, the girls participation total of 2,953,355 set an all-time record. The boys total also increased, reaching 4,206,549, the highest participation in the past 28 years. This year's boys participation figure is second only to the record 4,367,442 in 1977-78.

Competitive spirit squads gained the most female participants in 2005-06 with 14,154, followed by outdoor track and field with 11,002 , indoor track and field with 6,265 and cross country with 5,504.

Eleven-player football gained the most participants among boys sports in 2005-06 with 26,281, followed by outdoor track and field with 17,282 , baseball with 10,954 and wrestling with 8,525 . Basketball remained the most popular sport for girls with 452,929 participants, followed by outdoor track and field $(439,200)$, volleyball $(390,034)$, fast pitch softball $(369,094)$, soccer $(321,555)$, cross country $(175,954)$, tennis $(173,753)$, swimming and diving $(147,413)$, competitive spirit squads $(98,570)$ and golf $(64,195)$. In boys sports, 11-player football once again topped the list with $1,071,775$ participants, followed by basketball $(546,335)$, outdoor track and field $(533,985)$, baseball $(470,671)$, soccer $(358,935)$, wrestling $(251,534)$, cross country $(208,303)$, golf $(161,284)$, tennis $(153,006)$ and swimming and diving $(107,468)$.

Texas held its title as having the most sports participants with 742,341 , followed by California $(678,019)$, New York $(350,349)$, Illinois $(323,703)$, Michigan $(321,250)$, Ohio $(316,529)$, Pennsylvania $(267,147)$, New Jersey $(243,260)$, Florida $(214,023)$ and Minnesota $(213,476)$.

The participation survey has been compiled since 1971 by the NFHS through numbers it receives from its member associations. The complete 2005-06 Participation Survey is available on the NFHS Web site .

## SYNOPSIS OF CHANGES TO 2006-2007 BLUE BOOK

The following is designed for the benefit and convenience of athletic administrators and coaches in an effort to provide a capsule summary of the changes in the State CIF and Southern Section Constitution and Bylaws. These changes have been enacted by the State CIF Federated Council and the Southern Section Council throughout the course of the 2005-2006 school year.

## STATE CIF REVISIONS

Rule 22.B.(12): Conditions of Membership - Adds "dietary supplements banned by the United States Anti-Doping Agency as well as synephrine."

Rule 303: Expands the rule to include students with a qualifying disability in accordance with IDEA and State law.

Rule 304: Explains where to get information on independent study/home study programs.

Rule 305: Defines independent study/home study programs.
Rule 524: Adds, "dietary supplements banned by the United States Anti-Doping Agency as well as synephrine, without a written prescription from a licensed health care practitioner to treat a medical condition."

Rules 3103 and 3104: Wrestling Weight Management Program is now mandatory and binding under
NFHS Rules.

## SOUTHERN SECTION REVISIONS

Rule 23.1: Provides for two categories of membership for new schools in the C.I.F. Southern Section.

Rule 32 Releaguing Procedures: Establishes guidelines for the formation of athletic conferences.

Rule 149: Establishes guidelines for the televising of Southern Section regular season and playoff contests in all sports.

Summertime Rules (All sport sections): Establishes a start date and an end date for the Summer Dead Period.

Rule 3214.1: Changes the minimum number of wins from 11 to 12 for at-large petitions into the Boys and Girls Basketball Playoffs.

## COACHES ARE THE TRUE HEROES OF HIGH SCHOOL SPORTS

I watched the parent yell at him. He listened, he nodded and then he calmly responded. I couldn't hear the words, but I really didn't need to. I've seen it before- a coach being yelled at by a well-meaning but unhappy parent.

I asked him about it just before we started our interview, and he just shook his head.
"It happens every year," he said. "You just can't make everybody happy. But I'm not here for the parents. I'm here for the girls."

I used to wonder why any sane person would volunteer to coach high school sports, but after years of watching them work, I understand the attraction, the addiction and the affection. No one told me why they coach, they just showed me, game after game, season after season, year after year.

I see them helping students with their homework. I see them talking to athletes about problems at home and how to deal with them. I see them offering a candy bar or leftover sandwich to a hungry student who didn't have lunch before practice. I see them get angry and I see them break down.

I watch them from the beginning of the season, full of hope and promise, until the end, when all but one are disappointed, but most are still proud. I see them teaching their girls how to block a volleyball, how to rebound a basketball, and how to steal bases.

I see them confronting teenagers who feel responsible and heartbroken after a loss. I see them accepting the grateful thanks from their players after a win. I see them posing for photographs, and I see them taking immense amounts of heat.

I see them reminding students that they need to register for ACTs and asking how they did on that troublesome math test. I've seen the explain why a teammate has earned her starting spot and what it will take to earn it back. I've seen them arrange for rides and tutoring countless times.

I've seen them buy equipment, school supplies and personal hygiene supplies with their own money. l've seen them push their athletes physically while trying to nurture their very delicate emotions.

The coaches I know and work with every day try to teach their players skills that will help them win games so they will understand the connection between hard work and successboth on the court and off. They very best ones understand they're socializing young people and every moment is a chance to change the world.

Some days, as I watch them work, I wish people could see the world of prep sports from my vantage point. I wish they could understand the miracles being worked in gyms and on fields in individual lives every day. And then I remember, thousands of student-athletes are watching these same coaches and learning these same lessons- whether they know it now or not.
"Teaching somebody something that improves her life and the lives of those around her is the only immorality I know," a coach once told me.

If that's so, long live the coach.

REVIEW

For the past few months you have probably heard discussions over Rule 214 otherwise known as the "transfer rule".

As you already know the CIF Southern Section rule states that in order for a student to transfer from high school A and into high school B and have immediate varsity eligibility that student must have completed one of two requirements: A. a bona fide change of address (defined in Rule 214-A-1) or through a "hardship" (defined in Rule 215).

If neither of these things occurs then that student would be restricted eligible, meaning he/she could only play junior varsity or below in that sport or sports he/she competed in the last 12 calendar months.

This is a rule that our membership of the Southern Section has stated as something they are very comfortable with.

However, other sections in the state find themselves with problems unique to their areas and, for that reason perhaps, have less restrictive measures in place.

Herein lies the dilemma.
Some state legislators have become concerned with the disparity around the state as it relates to individual section transfer rules. In the past six months we have seen lawmakers bring legislation to the education committee in order to pass a bill that would allow greater student movement from school to school without any eligibility restrictions. While these bills failed in committee there is every expectation that they will resurface and they underscore the possible need for a rule that would be uniform throughout the state.

Now, what form that rule would take will be up to all of you as member schools.
Some in the state have suggested a 30 or 45 school day period of ineligibility for all transfers. Some have supported a return to "Open Enrollment" or a one-time free transfer at all grade levels, or after the 9th grade only.

Both the executive committee and the section staff believe a compromise will need to be made on this issue with all sections coming to a united agreement of what transfer rule works best for all. We would appreciate your thoughts on this matter as this subject truly affects you, the member schools.

## Officiating Consistency <br> and <br> Rules Interpretations

Recent newspaper accounts have detailed failings of college football replay officials. Major league baseball debates the merits of a computerized strike zone. The NBA makes a rules change regarding debating calls with officials. The NFL again tries to explain the quarterback "tuck rule"!

All of the above demonstrate the everpresent accountability of officials. With more high school contests on television, "right" and "wrong" calls become larger.

Officials often interpret rules under the guideline of "philosophies of play", such as advantage, disadvantage. Coaches might interpret "letter of the law" - holding is holding regardless of the score or where it occurs on the field. One challenge in reaching the goal of consistency in officiating is the vast geography of the Southern Section.

How do we gain consistency in rules interpretation? One example is what recently occurred with the Football Advisory Committee. The Committee invited a member of the instructional staff of the California Football Officials Association to discuss rules and rules interpretations. From that meeting a consensus was reached on a variety of items, and those interpretations were communicated through the CFOA website.

The human factor will always mean varying interpretations to the "a rule is a rule" guideline. This should not stop coaches, players and officials from reaching for the goal of the \#1 request of coaches and participants: a consistently administered game!

## OAKS CHRISTIAN AND CORONA DEL MAR CLAIM TITLES IN FIFTEENTH ANNUAL COMMISSIONER'S CUP

The CIF Southern Section is pleased to announce the top ten girls and boys athletic programs in the Fifteenth annual Commissioner's Cup (formerly known as the Cavalcade of Champions).

On the girl's side, Corona del Mar took top honors for the third year in a row by scoring 22 points with titles claimed in 4 championships. The Sea Queens literally ran and swam away from the competition, winning titles in cross country, track and field, water polo and swimming/diving. Marlborough finished second in the competition with 13 points by claiming two titles in basketball as well as track and field while earning points in two other sports. Rounding out the top three was Sage Hill, who earned 12 points and also captured two titles in basketball and volleyball.

On the boy's side, Oaks Christian claimed back-to-back Commissioner Cup titles with four titles. The Lions scored 20 points after winning the same three titles they captured last year (Football, volleyball and swimming/diving) as well as capturing a fourth title in track and field. Palos Verdes finished second in the competition with 14.5 points. The Sea Kings captured titles in baseball as well as swimming/diving. Palos Verdes also received points for a split title in soccer and a semi-final appearance in water polo. Temecula Valley round out the top three programs with 13 points accumulated. The Golden Bears won titles in soccer
and wrestling. They also received points for their result in track and field.

The CIF-SS developed this recognition program based upon the comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team-place finish sport (i.e. cross country, golf, swimming and diving, track and field); and one point for a fourth place finish in a team-place finish sport. In cases where a tie occurs, total team-sport playoff appearances will be used to determine the top ten schools.
"The CIF-SS would like to congratulate these outstanding programs for their championship performances," said Dr. Jim Staunton, Commissioner of Athletics. "They all have a lot to be proud of through their accomplishments and those of their entire athletic programs."

THEY EXCEL AT MIXING SPORTS \& ACADEMICS

It's always good to remember how high school sports can bring out the best in teenagers, both on and off the field. Here are three girls who understand that equal commitments to academics and athletics are helping them achieve a complete high school experience. Growing up, Emilie Still of Duarte wasn't interested in playing sports. "I hated P.E. and didn't like to run," she said. "But my dad was a runner and he got me into it. My friends and I decided to join the track team when I was a freshman." She soon discovered it fit her perfectly. "After a good, hard run, you feel good," she said. "I'm not running to just win first place in high school. I love it. It's a good stress reliever." Still, a senior, has become the No. 1 cross-country runner for Duarte and won the Montview League's 3,200-meter track title last season. She also has an impressive 4.2 grade-point average and has never received a grade other than A on a high school report card. "She's a great person," Athletic Director Danny Cardona said. "She's a gogetter. She does everything in extra. She's a coach's dream." Still is a lawyer-in-themaking. She participates in the nationwide mock trial program and received an award as outstanding defense attorney in Los Angeles County three years ago. "I try to argue for the truth because that's what should rule, and you do that by reasoning and proving the evidence," she said. "And it's also good to appeal to emotion if you can get the judge or jury to feel your side of the case."

She has argued cases from the defense and prosecution sides and feels motivated to prepare herself to help others. "I don't want to be one of those Wall Street people," she said. "My heart has always gone out to people who haven't had as much as me." Whether running track or cross-country, or
arguing cases, Still has figured out what's important: "Whether you win or not, it's the experience," she said.
Amber Oland of Santa Ana Foothill isn't simply a standout water polo player. She's considered the No. 1 goalie for her class in the nation. Add to that, she has a 4.0 GPA. Asked how she pulled off these two tough feats, Oland said, "A lot of sleepless nights." She practices water polo every afternoon, then does her homework, and if that means studying late into the night, so be it. "If it gets me to college, it's worth it," she said. It is important to Oland to be good enough athletically to earn a college scholarship and to have the grades to pick any school she wants. "Water polo is so much fun, and I really wanted to go to a good academic school," she said. "Keeping up your academics is part of that dream." Her dream is about to come true. Oland is being recruited by Stanford, UCLA and USC. Last summer, she traveled to Greece, Italy and Canada as a member of the U.S. junior national team. As much work as she has put into the pool and into her studies, she has no regrets. "I don't think I've had to sacrifice," she said. "I love doing it." Her two older brothers, who set a high standard, provided motivation for academic excellence. Her parents had a standing offer: Whichever sibling had the highest GPA got to choose where to go for dinner, so the family competition was intense. Oland would prefer less homework and more water polo, but she's not complaining. "I love it," she said of her high school experience.
If Becky Hernandez has any free time, it's probably devoted to sleep because she rarely slows down, day or night. She is a
