We are determined to offer service to our schools, to give a quick response to queries and authoritative interpretations of the Bylaws. As a value added to our schools, we will repeat our One Day Coaches' Trainings during the year as well as a new parent presentation.

Rob Wigod and I have worked together to create a Parent Presentation. Central to our efforts to promote Pursuing Victory with Honor are our parents and fans. Often, our student athletes exhibit poor behavior that is ignored by parents, or in some cases, applauded. HISTORY OF THE CALIFORNIA INTERSCHOLASTIC FEDERATION SOUTHERN SECTION

32nd historical "tidbit."

TRACK AND FIELD - THE FOOTBALL THROW

1932 – 1938

JOHN RAITT – FULLERTON HIGH SCHOOL

STATE RECORD HOLDER - 1935 - 220'

The CIFSS and the State CIF had always been concerned about the liability of the discuss and javelin throw events in the State Track Meet. As a result, in 1932 the football throw became an exhibition event to replace the javelin and discuss events. The football throw became a regular event in 1933 and was discontinued in 1938. Javelin rules applied and the football had to have intercollegiate specifications. In addition, "nothing could be used on the hands of the contestants which would in any way interfere with others who wished to use the ball" (State Federated Council Minutes, May 25, 1935). John Raitt, Fullerton High School, led the Indians to a State Championship in the meet held at Fresno State College. Raitt won the shot put with a throw of 55' $\frac{1}{4}$ " and set the all time state record in the football throw with a toss of 220' (almost 70 yards). He received a scholarship from USC but decided to attend Redlands. John Emmett Raitt later became a star of the musical theatre and stage. He has a star on the Hollywood Walk of Fame and is best known for his stage roles in the musicals *Carousel*, *Oklahoma!*, and *The Pajama Game*. He set the standard of handsome and strong-voiced leading men during the golden age of Broadway musicals. He starred in the 1957 movie version of *The Pajama Game* with Doris Day and sang along side Mary Martin in *Annie Get Your Gun*. He is in the Fullerton High School Hall of Fame. He is the father of the famous country singer Bonnie Raitt. His grandson, Bay Raitt, is the creator of Gollum's face for the Lord of the Rings film trilogy.

CIFSS TO HONOR COACHING LEGENDS

The CIFSS Hall of Fame was created in 1984 to honor the people who have contributed to the strength of the organization. In 2005, the Blue Book criteria for the Hall of Fame and Distinguished Service Awards were changed to clarify the difference between the two awards. The Service Award now stands for "contributions" to the CIFSS, while the Hall of Fame honors those individuals for their "accomplishments." In looking back at the history of the CIFSS it became clear that many coaching legends were not in the Hall of Fame and need to be so recognized. Similar to baseball's Hall of Fame "Veterans Committee" template, the CIFSS will begin to honor those individuals who, based on their exemplary coaching status, belong in the Hall of Fame. Examples include coaching legends Clare Van Hoorebeke (football-Anaheim High School), Bill Armstrong (basketball-Compton High School), Glenn Bassett (tennis-Santa Monica High School), Urho Saari (water polo-El Segundo High School), Frank Crosby (wrestling-San Diego High School) and many other deserving candidates. These names will be forwarded to the Hall of Fame Committee for their consideration.

The key to any honor is that someone...like YOU, takes the time and effort to nominate a deserving candidate. The Blue Book covers the necessary criteria, dates and simple forms are available on the CIFSS website (www.cifss.org). Please honor those great coaching legends for their coaching accomplishments and impact on the student/athletics of the CIFSS.

PLUNKETT, STEINBACH HEAD 2007 HALL OF FAME CLASS

Jim Plunkett, a three-sport star at James Lick High School in San Jose, California, in the 1960s prior to leading the Oakland/Los Angeles Raiders to two Super Bowl victories, and Terry Steinbach, the top high school baseball player in Minnesota in 1980 who enjoyed a highly successful 14-year professional career with the Oakland A's and Minnesota Twins, headline the 2007 class of the National High School Hall of Fame.

Plunkett and Steinbach are among 12 individuals who will be inducted in the National Federation of State High School Associations (NFHS) National High School Hall of Fame July 4 at the Desert Springs Marriott Hotel in Palm Desert, California. The Hall of Fame Induction Ceremony will be the closing event of the 88th NFHS Annual Summer Meeting.

Other former high school athletes selected for the 2007 class are Clyde Duncan, a track and field standout at Des Moines (Iowa) North High School in the early 1960s who is currently the track and field coach at Texas Southern University in Houston; Jim Johnson, the most prolific scorer in high school ice hockey from Cranbrook High School in Bloomfield Hills, Michigan; and Charlie Wedemeyer, considered one of the greatest athletes in Hawaii history after excelling in football, baseball and basketball at Punahou High School in Honolulu in the 1960s.

Rick Insell, who won 10 state girls basketball titles at Shelbyville Central High School in 28 years and now is the women's basketball coach at Middle Tennessee State University, is one of four coaches selected for the 2007 class. Other coaches are John Bagonzi, who won seven state

baseball championships and five state basketball titles at Woodsville (New Hampshire) High School; Lewis Benitz, wrestling coach at Lincoln High School in Wisconsin Rapids, Wisconsin, who has won 17 state championships; and Joan Wells, who won 15 state championships as volleyball coach at Lawrence (Kansas) High School.

Two contest officials were selected for this year's class: Jane Hansen, field hockey and lacrosse official from New Jersey, and Sam Short, a veteran football and basketball official from Alabama. The final member of the 2007 class is Tim Stevens, a long-time high school sportswriter for the Raleigh News and Observer in North Carolina.

The National High School Hall of Fame was started in 1982 by the NFHS to honor high school athletes, coaches, contest officials, administrators, fine arts coaches/directors and others for their extraordinary achievements and accomplishments in high school sports and activity programs. This year's class increases the number in the Hall of Fame to 338, and this year's event will be the 25th induction ceremony.

The 12 individuals were chosen after a two-level selection process involving a screening committee composed of active high school state association administrators, coaches and officials, and a final selection committee composed of coaches, former athletes, state association officials, media representatives and educational leaders. Nominations were made through NFHS member associations.

New Blue Book Rules

On behalf of the CIF-SS office, welcome to the 2007-2008 school year. As you may know, after 26 years of devoted service to, Karen Hellyer, Assistant Commissioner, retired. It is with great enthusiasm I join the office staff and look forward to serving the athletic community. I can only dream to serve a term as successful as that of Karen Hellyer. To earn the respect and reverence she had is an enormous challenge I truly look forward to.

Along with the change in season comes the revision of the Blue Book. There are a few changes to be aware of in the numbering sequences which have seen some revision. The 200 Series (Eligibility Section) would be a great place to start in noting those changes. Contained within your Fall Packet is the "Synopsis of Changes to the 2007-2008 Blue Book". Please review that memorandum carefully as notations are made to highlight specific rule changes for the year.

The new "freshman transfer rule" taking effect July 1, 2007 is one of the statewide revisions to be aware of. In the past, without a valid change of residence, generally an athlete was guaranteed "restricted eligibility". The new transfer rule makes the provision that all 9th grade students transferring for the first time "prior to the first day of the student's third consecutive semester (typically the first semester of the sophomore year) of attendance since the initial enrollment" will have unrestricted eligibility. Situations that could adversely effect this students' unrestricted eligibility are (but aren't limited to) pre-enrollment contact, a move due to disciplinary action, or academic ineligibility at the previous school. This is definitely one you will want to familiarize yourself with, as I'm sure you'll see these transfer situations passing through. Schools will still need to fill out the new Transfer Form (207) and the Pre-Enrollment Contact Affidavit (510) for these freshmen transfers. Please make sure that all transfer paperwork is on the 2007-

The Executive Committee's approval of a three year agreement with officials groups represents the largest increase in section history. Officials will receive a \$12 fee increase over the next three years, beginning with the 2007-08 school year.

The Southern Section remains a leader at or near the top percentile statewide in pay per sport for officials.

The agreement was reached after input from officials representation to the officials fees committee, chaired by Ralph Trigsted of Sunny Hills High School.

One common theme of many officials who presented to the Committee as that "it is not just about the money." To that end, numerous non-monetary issues were addressed and can be found in the 2007-08 CIF Southern Section Blue Book, including:

- Recommended school responsibilities related to the game officials.
- Providing for the game officials.
- New player conduct language (amendment 2/5/2007)

Fostering a positive relation with game officials is good public relations and enhances the statue of your school and district.

The Southern Section has expanded its website (www.cifss.org) to include additional recruitment and unit information regarding officials.

Officials will for the first time, starting this school year, be required to sign a CIF officials' Code of Ethics. Like athletes and coaches who now sign such agreements, officials will agree to the guidelines that include:

- Being punctual and professional
- Be aware of emergency situation
- Uphold the honor and dignity of their profession
- Master rules of the game
- Be prepared both physically and mentally for all contests.

The 2007-08 school year offers officials, schools, players, and supporters the opportunity to continue a positive working relationship.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING APRIL 24, 2007

VIEWPOINT AND MARLBOROUGH CLAIM TITLES IN SIXTEENTH ANNUAL COMMISSIONER'S CUP

The CIF Southern Section is pleased to announce the top ten girls and boys athletic programs in the Sixteenth Annual Commissioner's Cup.

On the girl's side, Marlborough took top honors in a tie-breaker scoring 20 points on the strength of four championships. The Mustangs claimed titles in the sports of tennis, basketball, track and field and Cross Country. Marlborough claimed ended with the same number of points as Corona del Mar (who was looking to claim their fourth-consecutive title) however, the first tie-breaker (school with the most championships during the school year) moved Marlborough up to the top-spot. Corona del Mar scored their points with titles in tennis, cross country and track and field. CDM also claimed a runner-up trophy in volleyball and reached the semifinals in water polo. Rounding out the top three is Ayala with 16 points. The Bulldogs made the top-three with championships in cross country and basketball. Ayala added to their total with a runner-up finish in water polo, a semifinal finish in volleyball and a fourth place ending in golf.

On the boy's side, Viewpoint claimed their first Commissioner Cup title with two sports championships and a pair of second-place finishes. The Patriots scored 16 points, winning CIF-SS titles in tennis and volleyball. Viewpoint also had a runner-up finish in soccer and baseball. Oaks Christian, the 2005-06

champions, finished with 15 points and claimed the second-place spot via another tie-breaker. The Lions won titles in football, swimming and diving and volleyball. Also with 15 points was perennial cup favorite, Loyola. The Cubs hold a title in baseball and a co-championship in soccer. Loyola also had runner-up finishes in track and field as well as swimming and diving.

The CIF-SS developed this recognition program based upon comprehensive excellence in interscholastic competition. The purpose of this program is to enhance the spirit of competition, sportsmanship, and goodwill among the student athletes and member schools.

The winners are determined by a point system that provides: five points for a divisional championship; three points for a divisional runner-up finish; two points for advancing to the semifinal round or a third place finish in a team-place finish sport (i.e. cross country, golf, swimming and diving, track and field); and one point for a fourth place finish in a team-place finish sport. In cases where a tie occurs the top ten schools were determined by several tie-breaker methods.

"The CIF-SS would like to congratulate these outstanding programs for their championship performances," said Dr. Jim Staunton, Commissioner of Athletics. "They all have a lot to be proud of through their accomplishments and those of their entire athletic programs."

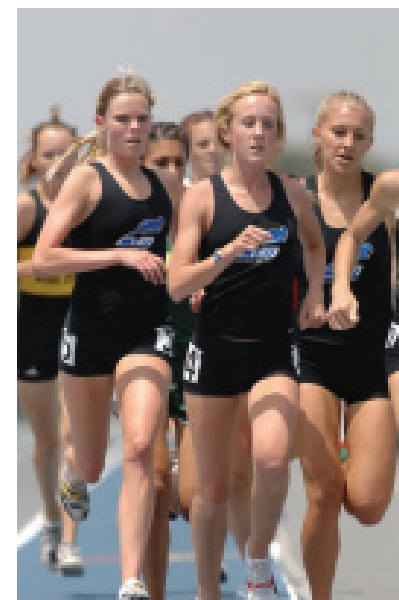
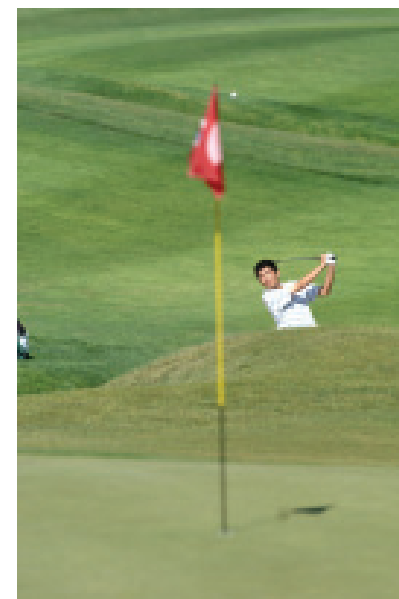
