MINUTES OF THE COUNCIL MEETING OF FEBRUARY 2, 1946, HELD IN THE BOARD OF EDUCATION ROOM AT COMPTON COLLEGE

The meeting was called to order by our President, Mr. Frank M. Chase, Jr., at 10:00 A. M. A roll call showed the leagues represented as follows:

About thirty administrators and coaches were present in addition to the Council members.

The meeting was opened by a salute to the flag led by President Chase.

Rev. Carl Allen of the Compton Board of Education gave the invocation.

Minutes Approved

The minutes of the Council meeting for May 27, 1945, and of the Executive Committee for October 24, 1945, were approved as printed.

These latter minutes suggested that a clarification of the rule requiring pupils to be passing in four regular subjects was needed.

Mr. Moore stated that the Federated Council intended that a pupil to compete in athletics must be passing in 20 units of new work as defined by the State Board of Education, 5 of which units may be physical education. It was moved by Mr. Hartman and seconded by Mr. Bowers that Mr. Moore's statement be approved as the C.I.F.

Southern Section's interpretation of the rule. Carried.

Financial Report

Mr. Van Patten presented the financial report printed below. It was moved by Mr. S. Chester McIntosh and seconded by Mr. Carpenter that the report be approved. Carried.

Mr. Van Patten reported that the Executive Committee had recommended that \$6000.00 of the money in the checking account be used to purchase investment certificates in Federal Building and Loan organizations. It was stated by Mr. Catlin that the insurance on the Federal Building and Loan Association was of such a character that in case of failure, the funds might be tied up for a long period of time. It was moved by Mr. Catlin and seconded by Mr. Don McIntosh that the Treasurer and the Commissioner of Athletics be advised to invest the \$6000.00 in government bonds.

Releaguing for 1946-1947

The Executive Committee had had three meetings (January 17, January 29, and February 2) to consider the question of releaguing for 1946-1947. The releaguing set-up printed on page 4 of this Bulletin was presented by Mr. Hamilton, President of the Executive Committee to the Council and recommended for adoption.

It was moved by Mr. Thompson and seconded by Mr. Badenoch that the recommendation be approved. The motion was adopted by the unanimous vote of the Council.

Mr. Stanley Shaver, Vice Principal of the Covina High School, was present and asked to be recorded as protesting for Covina High School against its league placement. He based his protest upon two grounds, namely, that Covina High School is too small in numbers for the Foothill League, and that the distance from some of the other schools of the league is too great.

Japanese Boy's Reinstatement

Mr. Theodore Copp of the Burbank High School stated to the Council that a number of Japanese boys had enrolled in the Burbank High School about the end of the first ten weeks of this school year. The Federal Government had closed the schools for the summer vacation in June and had not opened them again in September. The boys had not been able to earn 20 hours of credit during the first semester and therefore could not compete this semester if rule (e) page 14 of our 1945 Blue Book is followed.

It was moved by Mr. Moore and seconded by Mr. Hamilton that boys who were in good stand-

ing and who were kept out of school by Federal Government orders shall be considered in good standing if they return to school as soon as possible when the government restrictions are lifted. Carried.

Moved by Mr. Don McIntosh and seconded by Mr. Berlin that boys ruled eligible by the above motion be counted eligible as long as they continue to keep their grades up in 20 semester hours of work. Carried.

Pay of Officials for Games

Mr. Van Patten reported that several leagues and several Officials Associations had recommended that the pay for athletic officials is not adequate if the table on page 27 of our 1945 Blue Book is followed.

It was moved by Mr. Thompson, seconded by Mr. Badenoch that the Executive Committee bring to the Council at its next meeting a recommendation for the needed changes in the pay of officials. Carried.

Football on Outside Teams

Mr. Van Patten stated that a boy in the Pasadena Bull Pups football team had been ruled ineligible for competition the past season under rule (2), Article VI, page 16, of our 1945 Blue Book. He suggested that the rule which has been in our books for more than fifteen years may have become obsolete.

It was moved by Mr. Thompson, and seconded by Mr. Berlin that the C.I.F., Southern Section reaffirm this rule. Carried unanimously.

Error in Printing

Mr. Van Patten called attention to an omission from rule (e), page 14, in the printing of the 1945 Blue Book. A note (for crediting purposes a semester ends on the last day of the semester. For playing purposes one semester does not end until the next semester starts.) was left out.

It was moved by Brother Edwin and seconded by Mr. Bowers that the note is still in force. Carried.

Football Practice

The Council of the C.I.F., Southern Section on February 1, 1941, passed the following regulation: "That all football activities of any kind be limited to the period between September 10 and December 1 for any year, except that in the Spring semester a 20 day period of 2½ hours per day of practice may be had, starting after May 1. Football classes and all intramural scrimmage and games of football are to be eliminated between December 1 and May 1 of any school year."

There being no objection the President ruled the above regulation in force although it is not in the 1945 Blue Book.

Basketball Player Not Eligible

A boy in the Alhambra High School was ineligible last semester for athletic competition. During last semester while ineligible under C.I.F., Southern Section rules he played on an outside team during the school season of basketball. He became eligible at the start of the second semester. Can he play basketball now?

It was moved by Mr. Thompson and seconded by Mr. Catlin that he is ineligible for basketball under rule (j), page 14 of the 1945 Blue Book. Carried.

Letterman, Definition

The Nordhoff High School had raised the question as to what constitutes a letterman.

It was moved by Mr. Don McIntosh and seconded by Mr. Redding that a letterman is one who has qualified for a letter in any interscholastic sport. Carried.

This action leaves the question to each individual school.

Letterman Regulations

During the school year 1944-1945, a committee consisting of Mr. Badenoch, Mr. Bergstrom, Mr. Hildreth, Mr. Lawson and Mr. Murray, made a study of questions regarding the issuing of letters, awards, etc.

This committee issued a lengthy report (four pages) which was mimeographed and sent to all of our schools in November 1945.

It was reported that the Catholic Schools League, the Bay League and the Tri County League have already adopted the report as a regulation for issuing letters and awards within the league.

It was moved by Mr. Bergstrom and seconded by Mr. Catlin that the report be favorable recommended to all leagues for consideration. Carried.

Final Track Meet

Mr. Van Patten reported that the San Diego High School had asked that the Final Track Meet be awarded to San Diego High School to be run either at the Balboa Stadium or at the State College Field in San Diego.

It was moved by Mr. S. Chester McIntosh and seconded by Mr. Bowers that the request be granted and that San Diego High School be allowed to pick the field. Carried.

State Meet

The State Meet is to be held this year on Saturday, May 25, under the management of the C.I.F., Southern Section. It was moved by Mr. Thompson and seconded by Mr. Badenoch that the State Meet be held at the Los Angeles Coliseum if it can be held there alone, otherwise to be held at Compton College as an afternoon and evening affair. Carried.

Wrestling Championships

Mr. Van Patten presented a letter from the Imperial Valley League asking that the final wrestling meet be held at El Centro on March 15 and 16.

Moved by Mr. Don McIntosh and seconded by Mr. Berlin that the wrestling championship be awarded to Central Union High School for 1946. Carried.

Pasadena Games

Mr. Van Patten reported on a conference he had had on February 1, with Mr. Harold Musselman of Pasadena, and Mr. William G. Lopez of Los Angeles City School relative to the Pasadena games set for June 1 this year in the Rose Bowl.

Two questions were put to the C.I.F., Southern Section Council.

Will you approve an intersectional track meet, Class A, between the C.I.F., Los Angeles Section, and the C.I.F., Southern Section as part of the Pasadena games? The second question was: Will you approve the C.I.F., Southern Section Schools competing as schools in the Pasadena games?

It was moved by Mr. S. Chester McIntosh and seconded by Mr. Catlin that the answer to the first question is no. Carried. The meet would be an anti-climax after the State Meet.

The answer to the second question was yes if the high school part of the Pasadena games is sponsored by one of our member schools. Carried.

Ojai Tennis Tournament

Mr. Bowers presented a request from the Ojai Tennis Club for a sanction to the Nordhoff High School for the interscholastic part of the Ojai Tennis Tournament for 1947.

Moved by Mr. Don McIntosh and seconded by Mr. Bowers that the Ojai Tennis Club be notified that the sanction would be issued to the Nordhoff High School if and when requested. Carried.

Safety Deposit Boxes and Bonds

Mr. S. Chester McIntosh, our Treasurer, discussed at some length the plan now followed in caring for and disbursing the C.I.F., Southern Section funds. He pointed out that at present he is not bonded. That Mr. Van Patten is bonded for only \$2500.00. That the certificates of investments for our saving fund of \$2500.00 are now on deposit in the safety deposit box of the Puente High School.

Moved by Mr. Hamilton and seconded by Mr. Thompson that a safety deposit box in the name of the C.I.F., Southern Section be secured for

our valuable papers and that Mr. McIntosh and Mr. Van Patten both be adequately bonded, in accordance with our present financial worth. Carried.

Medal Contract

Mr. Van Patten presented a proposition from Herff-Jones Co. for furnishing medals for track, swimming, and other sports. There being no objection the President ruled the matter be referred to the Executive Committee with power to act.

Compton Thanked

It was moved by Mr. Catlin and seconded by all present to thank Compton College for the fine quarters furnished for the meeting and for the splendid lunch service. Carried unanimously.

At 3:00 P. M., there being no further business, President Chase declared the meeting adjourned.
