# 3.3 Million Football Fans Saw CIF Prep Games in 1966

Football records were established in the stands as well as on the gridiron according to the results of a high school football attendance survey released today by CIF Commissioner of Athletics Ken Fagans.

While Mickey Cureton was rewriting the individual record book and El Rancho was dominating the team accomplishments, more fans than ever before attended prep football games as played by schools in the CIF's Southern Section.

"Our Survey shows that 3,312,894 people saw high school football in our ection last fall," said Commissioner Fagans. "It's an amazing figure when you realize that many of our small schools play games where less than 200 people might be in attendance.

"The survey includes regular season and play-off games with an all-time high of 256,929 fans watching play-off

games," Fagans added.

"Our survey of the 1965 season howed the total attendance at all games to be 3,075,257 so this year's ncrease is more than 237,000 fans," Fagans said.

"One reason for the increase," said Fagans, "is that each year many new high schools begin their athletic programs. But we feel that the spectacular trand of football being played by our schools has much to do with the tremendous spectator interest in the Southland."

Play-off attendance records zoomed apward when Orange County's "dream game" became a reality and Mater Dei tangled with Anaheim for the first time. The game, played at Anaheim Stadium, drew 33,374 fans, the second largest crowd to see a CIF game. The all-time mark of 41,383 taw Anaheim and Downey tangle for the 1956 CIF crown at the Coliseum.


El Rancho and Anaheim's championhip game at the Coliseum drew 25,-149, highest figure since the 1956 same. El Rancho and Lakewood drew 14,808 for their semi-final game while all 15 "AAAA" play-off games averaged 10,299

Regular season records were established, too, when Mater Dei and Servitte played before 20,092 at Anaheim Stadium. It is believed to be the biggest regular season crowd in the section's history.

# Consolation Game Eliminated In "AAA" Basketball Play-offs

A slight change in tournament format was announced this week for the 1967 CIF basketball play-offs which begin on February 24 in the "AA" and "A" divisions and on Feb. 28 in the "AAA" division.

Sixteen leagues will send two entries into the "AAA" and "AA" play-offs while 13 leagues will qualify two teams each for the "A" division tournament.

In format changes, the CIF Executive Committee has taken action to eliminate the Saturday afternoon session during which the "AAA" third place game and "A" division finals were played.

The third place game will be abandoned while the "A" division championship game will be played on Friday night, March 10, at a suitable neutral location. Further, the committee ruled, the "AA" division quarter-final games will henceforth be played on neutral courts following similar action taken two years ago when all "AAA" quarter-finals were moved to neutral locations.

"We have found over the years that there is really very little fan appeal in the AAA consolation (third place) game," said Commissioner Ken Fagans. "The teams are flat after losing in the semi-finals on Friday because their hopes of winning a CIF championship have been thwarted. Coaches have commented that is is impossible to get the boys 'up' for the third place game and attendance has indicated that even the participating student bodies are not interested."

Semi-finals in the "AAA" division will be played on Friday, March 10, at the Long Beach Arena with the "AA" and "AAA" finals following on Saturday night, March 11.

Each league is permitted two entries in the play-offs. If a tie for first place exists, both teams will be invited; if an outright champion is declared the second place team is entered, too. No league is permitted more than two entries.

If a three-way tie occurs or a tie for second place exists, the league involved must determine its play-off entrants.

Determination of play-off divisions was based on average enrollment of all students in all grades, number of schools in a league, number of boys in the upper three grades, relative strength of leagues and the record made by representatives from each league in previous play-offs.

Leagues assigned to the "AAA" division: Bay, Catholic, Channel, Citrus Belt, Coast, Foothill, Freeway, Garden Grove, Montview, Moore, Pacific, Pioneer, San Gabriel Valley, Sky, Suburban and Sunset.

# Commissioner's Corner NEW BASEBALL RULES By J. Kenneth Fagans

Because of recent action taken on the State level relative to the adoption of the National Federation Baseball Rules, a great deal of confusion has been generated among coaches and administrators in Southern California. The San Diego, Los Angeles City, and Southern Sections were opposed to this action, but it was nevertheless passed at the Spring meeting of the Federated Council.

Our opposition was based mainly on the confusion that would result among players, coaches and umpires if two rule books were in use. Little League, Pony League, American Legion, junior college, colleges, universities, semi-pros and professional teams would be using the Professional Rule Book, while the high school teams would be using the Federation Rule Book. The same situation now exists in football, and it has caused untold problems over the past 14 years in the enforcement of the rules by the officials.

The Southern California Baseball Officials Association was greatly concerned that their members would encounter real problems in trying to master two rule books, which in addition to rule differences have differences in wording and meaning. After meeting with representative coaches and administrators from the City and Southern Section and representatives of the Baseball Officials Association, it was agreed that the umpires this year would study only the Professional Book and would then learn the differences between the two rules books.

An insert, showing the differences, has been printed by the association and will be placed in each Professional Rule Book issued to the umpires. This will enable them to become thoroughly conversant with one set of rules and then learn only the differences in order to successfully umpire games under two different sets of rules.

In the Southern Section we will be operating under the National Federation Baseball Rules. To more easily apply and understand them, however, we will in effect be using the Professional Rules with the differences which will modify them to meet the Federation Code.

It is hoped that in 1968 an agreement can be reached with the Southern California Baseball Officials Association which will permit us to furnish Federation Rule Books for both the umpires and coaches in our member schools.

Meanwhile, we are reproducing below, a copy of the National Federation rules which will supplement the professional baseball rules.

# HIGH SCHOOL BASEBALL RULES

The Professional Baseball Rules of play will apply to all high school games with the following exceptions:

- 1. Head protectors must be worn by the batter and all base runners. If a player refuses to comply with this ruling he must be removed from the game.
- 2. First, second and third base thickness is two to five inches.
- 3. All high school games are limited to seven (7) innings unless extended because of a tie score.
- 4. Any one player of the offensive team may occupy each coacher's box while his team is at bat. Players that have been removed from active play by their coach or manager also have this privilege.
- 5. Each team is limited to three charged conferences during the game, without penalty, to permit the coach or his bench representatives to confer with a defensive player or players. For any charged conference in excess of three, the pitcher must be removed as pitcher for the duration of the game. The Umpire-in-chief shall notify a manager when he has been charged with the three conferences. Any conferences that occur after the enforced removal of a pitcher will constitute tactics for delay of the game.
- 6. The pitcher is restricted to not more than two pumps or rotations of the arms prior to pitching from the windup position. Penalty: If a runner is on base a balk shall be called and if no runners are on base the umpire will call a

- 7. At the beginning of each inning or when a pitcher is replaced during the inning, the pitcher warm up by using not more that the throws to a player unless the umpire authorizes more thrown because of inclement weather other circumstances.
- 8. A batter is out if he appears a bat with an illegal bat.
- 9. All base runners are awarded on base if the batter is interfered with by the catcher. The batter advanced to first base.
- Bench jockeying between members of the competing teams will not be permitted.

2. NOMINATING COMMITTEE REPORT—The following candidates were placed in nomination by the Nominating Committee for Executive Committee and State Federated Council offices:

Executive Committee member repretenting Los Angeles County (four year team)—James Faul, principal, Workman HS and Walter Newland, principal, Long Beach Poly HS.

Executive Committee member reptesenting the northern area (four year term) — Harry L. Bigger, principal, Fillmore HS and Roland H. (Bud) Ewing, vice-principal, Atascadero HS.

Representative to State Federated Council (two year term)—Steve Milesth, vice-principal, Beverly Hills HS and Rev. John C. Hughes, principal, Bernard HS.

Representative to State Federated Council (two year term)—Robert D. Ashton, assistant superintendent, Norsalk-La Mirada Unified School Distrat and Roger C. Weeks, principal, Sterra HS.

The election will be held at the Spring Council meeting, scheduled for Saturday, May 6, 1967, at Loyola High School in Los Angeles.

3. RELEAGUING — The Ivy League recommended to the Council that Bloomington HS replace Moreno Valley HS in the Desert-Valley League and that Moreno Valley HS replace Bloomington HS in the Ivy League, effective September 1, 1967. The recommendation was supported by the Desert-Valley League.

It was moved, seconded and carried to approve the switch, effective Sept. 1.

4. INCREASE IN OFFICIATING FEES—Requests for increases in officiating fees were received from representatives of the wrestling, track and baseball officials groups. The commissioner was instructed to prepare a bulletin, to be sent to all leagues, outlining the current fee scales in all sports and indicating when each group had last received raises. The officials' groups were instructed to prepare bulletins to be sent to the CIF office for distribution to the Council, outlining reasons for their increase requests.

The entire officiating pay structure will be discussed further at the May meeting.

5. NEW METHOD OF SELECTING RELEAGUING COMMITTEE
—Art Hobson, chairman of the committee appointed by the Council to propose a new plan for selecting members to serve on the Releaguing Committee, recommended that Article III of the Constitution under duties of the Council be amended to include:

"D. Group member schools of the CIF, SS, into leagues or place on a free lance basis, depending on geographic location, size of school, school organization and other consideration. (This shall be accomplished at the September meeting of the Council.)

"1) The Executive Committee shall annually align all established leagues in area groups.

"2) The representatives from each league in the area group shall meet prior to the January Council meeting to elect an administrator to represent their area on the Releaguing Committee.

- "a. A releaguing representative shall serve for a term of three years. He shall be eligible to re-election for one additional
- "b. Releaguing representatives shall be superintendents, assistant superintendents, principals or vice principals who have served in an administra-

tive capacity in a CIF, Southern Section, school for two or more years.

"3) At the first meeting of the Releaguing Committee each year, a chairman shall be elected. His duties shall be to preside at all meetings and make the committee report to the Council at the September meeting."

It was moved, seconded and carried to adopt the above an addition to Article III of the Constitution.

To initiate the new method the committee recommended that each of the seven established geographic areas elect their representatives at the earliest possible time and inform the commissioner of their selections. Five of the seven areas were able to elect a man during a recess in the Council meeting.

So that the terms will be staggered with approximately one-third of the committee being elected each year, the elected men drew straws for length of terms. Two will be on the committee for a one-year term, two for a two-year term and three for a three-year term.

The following were elected: Northern Area (one-year term) - Claud Hardesty, principal, Santa Barbara High; Southeast Area (two-year term) - Walt Newland, principal, Long Beach Poly; Citrus Belt Area (three year term) - Vic Sherritt, principal, Ganesha High; Orange County (threeyear term) - Dick Spaulding, principal, Buena Park HS; Private Schools Leagues (two-year term) - Rev. Donald Montrose, superintendent, Los Angeles Catholic high schools; Desert-Valley area (one-year term) — Alex Alexander, Principal of Indio High School; and Bay Area (three-yearterm) - Steve Miletich, vice-principal, Beverly Hills HS.

6. REPORT ON GIRLS' ATHLE-TICS—State representative Robert D. Ashton, who is a member of a State CIF committee on girls athletics, reported to the Council on his committees' activities. He informed the Council that the State Constitution has been rewritten to provide for girls interscholarship athletic competition and that such competition was optional on a sectional, league and school basis. In other words, he said, there was no outside group telling the high schools they had to compete in the program.

Ashton noted that each principal in

the State had been sent further information regarding the girls' program and urged that all members study the material and make suggestions toward the formulating of the program.

7. SAN ANTONIO LEAGUE PROPOSAL — The San Antonio League proposed that the Council recommend to the State that Article XXXIX, Section 30, of the By-Laws be amended to permit ninth grade

boys in a junior high school to participate in spring football practice at the public high school in the attendance area in which the boy and his parents reside.

It was moved and seconded to make this recommendation to the State Council but the motion was defeated by a vote of eight yes and 33 no.

8. REPORT OF TRANSFER RULE COMMITTEE—Two proposals were presented by the Committee covering the eligibility of junior high graduates transferring to senior high schools and the eligibility of boys transferring between member schools when there has been no change of address on the part of their parents which necessitated a change of schools. Both proposals will be duplicated and sent to all league representatives for discussion within leagues and will be brought up at the May meeting for action.

The first proposal recommends that Article XI of the Blue Book be amended to read: "Any boy who attends the ninth grade in a public high school will be ineligible for a period of one year if he transfers to any senior high school other than the public senior high school in the attendance area in which he and his parents reside."

The second proposal is to amend Article XI, Section 10, of the Blue Book and reads: "Any boy transferring from one member school to another without a change of address on the part of his parents which necessitates a change of schools will be ineligible for Varsity competition in all sports in the new school for a period of one calendar year from the date of enrollment in the second school. Such a transfer will be eligible immediately, however, for JV, B, C, or D competition involving dual or invitational competition but will not be eligible for CIF championship competition."

9. NATIONAL CONVENTION DELEGATES FROM STATE COUNCIL-Keith Gunn, State CIF representative, reported that he is a member of a committee studying the question of selecting representatives from the State Federated Council to attend the National Federation Meet-

The Southern Section, with four representatives on the State Council, has requested that the study be made as at the present time only one Southern Section man attends the National meeting every three years.

It was moved, seconded and carried that Mr. Gunn be instructed to suggest that the Southern Section have one representative from the State Council attend the National Federation Meeting each year.

10. LOS ALAMITOS REQUEST— A request was received from the new Los Alamitos High School in the Ana-

heim District seeking permission to have a spring football practice for boys currently enrolled in the ninth grade of the junior high schools which will form the student body at Los Ala-

It was moved, seconded and carried by a 19-6 vote to approve the request.

There being no further business to come before the Council, the meeting was adjourned at 12 noon.

FOOTBALL CONTRACTS—A was received from a member hool protesting the actions of anschool in the handling of condiscussions pertaining to a proposed football game next year between the two schools.

The committee discussed the issue at length but felt that no rule could be legislated regarding whether or not two schools are bound by verbal discussions when it comes to scheduling football games.

It was the opinion of the committee that in contractural discussions:

- 1. A firm date for finalization of any contract should be established. If the contract is not signed and returned by the agreed upon date, it is
- 2. All contracts should be put in writing as soon as possible after discussion of same.

3. Schools should be aware of the fact that some home and home contracts might have to be broken because of releaguing changes.

4. That athletic directors and other administrators should make every attempt to avoid keeping the other party "hanging" while conducting negotiations with a third, perhaps more desirable, opponent.

8. TIMES INDOOR MEET—It was moved, seconded and carried to approve the CIF, SS, section of the Los Angeles Times Indoor Track Meet to be held on Saturday, February 11,

The meet will have three high school events-four man sprint relay, long jump and two mile run. Because this is an indoor meet, participation will not count as one of the four permitted invitations to which a boy is limited in the outdoor season.

The four schools entering relay teams are four which have never before competed in the Times Games-Upland, Newport, Lutheran and Morningside.

9. ELIGIBILITY CASES — The committee discussed and acted upon the following cases:

a. El Dorado-Committee members concurred with ruling by Commissioner that George Pyne is eligible at El Dorado. He will be ineligible his senior year, however, because of the eight semester rule.

b. Rancho Alamitos-Approved waiver of the transfer rule to permit Larry Young to be eligible at Rancho Alamitos.

c. Kennedy, Buena Park-Confirmed eligibility of Kenneth Bickel at Kennedy High.

d. Anaheim Junior Highs-Discussed the cases of some Anaheim boys who participated on a junior high football team while in the eighth grade. The committee ruled that these boys would not lose any of their high school eligibility because of this participation and responded in this manner to a letter from Mr. B. J. Teaters, who sought clarification of his son's future eligibility.

e. Corona del Mar - Approved waiver of the transfer rule to permit Kwang Ik Choi to be immediately eligible at Corona del Mar.

f. Marina-Approved waiver of the transfer rule to make Ken McCloskey eligible beginning February 1.

g. Arroyo-Approved waiver of the transfer rule to permit Dennis Chambers to be eligible for interscholastic athletics at Arroyo HS, as of February 1, 1967.

h. Whittier Christian-Denied a request for waiver of the transfer rule in the case of Stephen Thompson at Whittier Christian High School.

10. LEAGUE PASSES SIMILAR TO CIF COURTESY CARDS—Come missioner Fagans informed the committee of several reports he had received during the football play-offs of persons attempting to gain admission to CIF play-off games using league passes. Only CIF Courtesy Cards are recognized at play-off contests. However, it was reported that several leagues had passes which indicated "Official CIF Pass" on the league card. In some cases the league pass also happened to be the same color as the CIF Courtesy Card.

It was moved, seconded and carried that leagues be prohibited from using the terms "CIF" or "California Interscholastic Federation" on league passes. In addition, the CIF will publish in the spring the colors of the various CIF passes for the following school year and ask that leagues refrain from using the same colors on

11. COMPETITION AMONG CONTINUATION SCHOOLS—An inquiry was received from Bellflower High wondering if it were permissible for a Continuation School to compete in interscholastic athletics with a regular member school of the CIF, SS.

After thorough discussion of the matter it was the opinion of the Executive Committee that a continuation school should not schedule games with regular member schools but rather, should attempt to schedule activities with other Continuation Schools.

The entire matter, however, is being referred to a State CIF committee which is studying athletic eligibility and competition with specific regard to continuation schools.

12. APPROVAL TO ENTER AAU TRACK MEET-It was moved, seconded and carried to approve the request of Jerry Proctor of Muir High School to compete in the 1967 AAU Track and Field Championships as an unattached individual even though the competition comes while his high school season is still in progress. This is in accordance with Article XXXXIV. Sec. 6, of the Blue Book.

Jerry is a talented long jumper who has attained world-class distances in his event and the CIF, SS, wishes him

well in his endeavors.

13. SPORTSMANSHIP VIOLA-TIONS - Commissioner Fagans reported on two incidents where high school basketball coaches removed their teams from the court before the completion of the contest because of disagreements with game officials. In one case, the coach has already been removed from his position and in the other case the school principal is investigating and will file his report with the Commissioner as soon as his findings are completed.

The Executive Committee will hear results of the principal's investigation

at its next meeting.

14. DETERMINATION OF STATE CIF REPRESENTATIVE TO NATIONAL FEDERATION MEET. ING-Present policy on the state level provides that one of the four SS representatives on the state CIF Federated Council will be sent to the annual National Federation meeting every three years with expenses paid. It is the responsibility of the section to designate its representative. After some discussion it was moved, seconded and carried that the SS representative should be selected each year on the basis of seniority on the Federated Council. Keith Gunn, having served the longest on the Council, was named to represent the state CIF at the 1967 meeting to be held in Honolulu early in July.

There being no further business to come before the committee, the meet-

ing was adjourned.
