## THE OTHER HALF OF THE DEBATE

Figuratively speaking, it was a bum rap. Not only did they lack the opportunity and medium by which to respond, but the "inference" lacked substance.

They, in this arena, are the student/athletes.

Recently — and in almost lightning fashion — the student/athlete has become the center of controversy as it pertains to academic standards and eligibility in the sphere of interscholastic competition.

However, before probing this debate, it seems only appropriate to set the proper forum.

**The philosophical question of "should there be a "C" average" is not being debated in this dialogue. However, an aggressive defense of the student/athlete is being presented.**

It was distressing for me to hear, as I'm certain it was for you, that all student/athletes were earning four D's and one F in their academic work!

With little in the way of a pause for accountability, the cry rang out — "Raise the eligibility standards higher. Look what sports are doing to our athletes."

For some reason, the word student was dropped from the correct term, student/athlete, and the bandwagon began rolling downhill.

Now, for the other half of the debate . . .

Recently, the CIF Southern Section hosted its annual Football Press Conference for the finalists, with each school represented by three-four student/athletes.

During the course of the introductions, three student/athletes were recognized as student body presidents, four as student body officers and no less than six as representatives of the yearbook and/or school newspaper staff.

Considering there were approximately 35 student/athletes in attendance, they just didn't fit the academic mold of four D's and one F.

In fact, I felt somewhat of a warm inner glow when they were introduced.

But, let's not form an opinion too hastily.

There's also the results of a case study recently conducted by West Torrance High School.

# MINUTES OF CIF-SS EXECUTIVE COMMITTEE MEETING

January 15, 1983

(Minutes of CIF-SS Executive Committee Meeting — January 15, 1983)

The meeting of the Executive Committee of the California Interscholastic Federation, Southern Section, was called to order by Chairman Dr. Robert Packer at 8:00 a.m. on Saturday, January 15, 1983 at Arcadia High School. All members were present with the exceptions of Gerald Harer and Dr. Maury Ross.

**1. APPROVAL OF MINUTES** - It was moved, seconded and passed to approve the minutes of the December 2, 1982 meeting of the CIF Southern Section Executive Committee as mailed.

**2. COMMISSIONER'S UPDATE** - Mr. Ray Plutko, Commissioner, reviewed with the Committee the upcoming Athletic Injuries Symposium and presented a brief review of the winter National Federation meeting held in Nashville, Tennessee.

**3. TREASURER'S REPORT** - Mr. Bruce Keuning provided an update of the working budget and a possible concern in the area of income from the football playoffs.

**4. CENTENNIAL HIGH SCHOOL INCIDENT** - It was moved, seconded and passed to conduct a hearing with all parties concerned to review the facts of an incident that took place following a basketball game.

**5. AREA PLACEMENT RELEAGUE-ING APPEALS** - Representatives from Needles, El Segundo and Palo Verde High

Schools appeared before the Committee, and Commissioner Plutko reviewed correspondence from Mammoth and Bishop high schools relative to the final area placements for relegue-ing on the 1984-86 cycle. Following all appeals, it was moved, seconded and passed to deny the requests of Mammoth, Bishop, Needles and El Segundo high school; and it was further moved, seconded and passed that Palo Verde High School be placed on a freelance basis for the 1984-86 year.

**6. CIF SOUTHERN SECTION AWARDS** - It was moved, seconded and passed to retain the policy that use of CIF-SS championship medals and awards be reserved for CIF-SS post-season championship participation.

**7. SOUTHERN SECTION SANCTIONED EVENTS** - It was moved, seconded and passed to maintain the current format and procedures for sanctioning invitationals and tournaments in the CIF Southern Section. (Note: the State CIF will change the procedures effective July 1, 1983.)

There being no further business to come before the Executive Committee, the meeting was adjourned at 11:20 a.m.

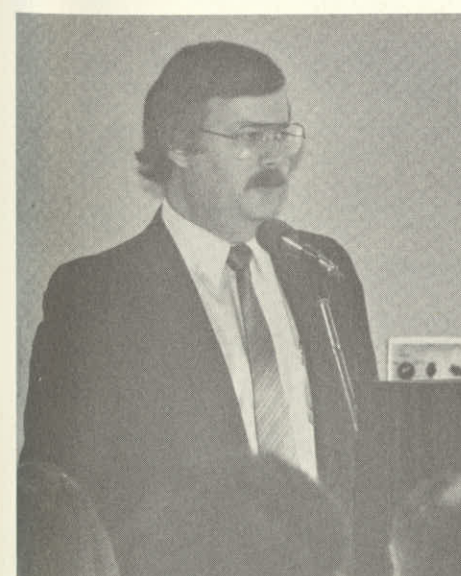

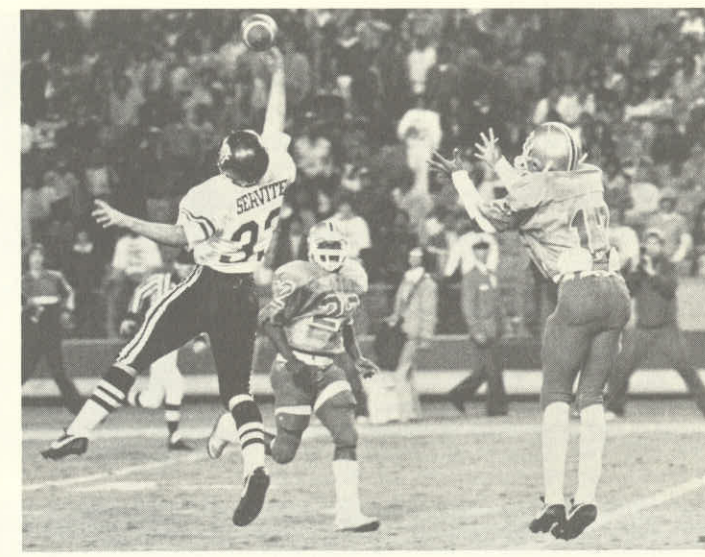

## 1982 CIF-SOUTHERN SECTION CONFERENCE FOOTBALL WINNERS

A crowd of 16,515 was on hand at Anaheim Stadium Friday, December 10 to witness Servite High School earn the 1982 **Big Five Conference Championship**, with a decisive 31-7 romp over Long Beach Poly.

Coach Ron Smeltzer's Friars breezed into the final game with a near perfect 10-1 record, having defeated all Southern Section opponents this season. The only loss for the Angelus League Champs came early in the year to the legendary Moeller High School of Cincinnati.

The Friars had little trouble controlling the Jackrabbits as quarterback Steve Beuerlein completed 14 of 24 attempts for 218 yards and 1 touchdown and defensive end Tim Prukop scored three times on runs of 1, 4 and 1 yards.

Poly's only score came in the 3rd quarter after a 77-yard pass from Derrick Morgan to Tyrone McColluch.

On Saturday at Anaheim Stadium, Damien and Ramona both grabbed a share of the **Eastern Conference** title when the game ended with a 28-28 tie. In the second game of the doubleheader a crowd of 20,592 fans watched Los Altos High School clinch its fifth CIF title when the Conquerors outscored the Aztecs of Esperanza, 31-14, to win the **Southern Conference Championship**.

Los Altos quarterback Mike Smith completed 21 of 30 attempts for 330 yards and 4 TD's. In doing so, Smith broke the CIF-SS single season passing yardage record, previously held by Pat Haden. Smith has passed for 3,132 yards.

Billed as a regional battle to decide the supremacy of Orange County prep football, the **Central Conference** championship game matched El Toro High School's 11-2 record against a perfect 13-0 Fullerton. However, the South showed its might as the Chargers snapped the Fullerton Indians' win streak by a 35-19 score.

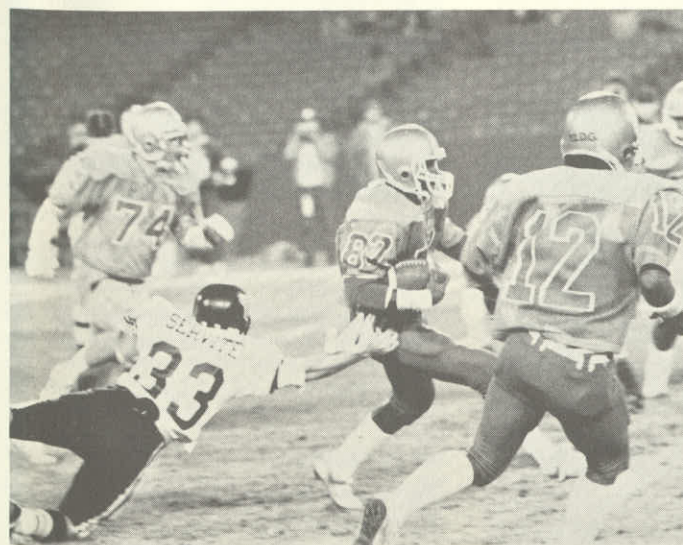
West Torrance gained the **Coastal Conference** laurels by upsetting the defending champions Santa Monica 35-21 at Santa Monica City College. Atascadero maintained its perfect record and grabbed the **Desert Mountain Conference** crown at the same time by their 21-6 win over St. Genevieve.

The **Inland Conference** finalists seemed to be perfectly matched and the final score proved that conception to be pretty accurate as Olympic League #1 Brethren with a 12-1 record battled Olympic #2 Ontario Christian which boasted the exact same 12-1 record for the championship. The Brethren Warriors persevered and defeated the Knights 7-0.

In **Northwestern Conference** action, Verbum Dei High School, winner of the 1980 Desert Mountain Conference, proved that changing conferences didn't intimidate them at all, when they met a strong Monrovia team and defeated them 7-0 to clinch their second consecutive title.

Co-Champs were declared in the **Southeastern Conference**, as when the final gun went off the score was Rosemead 19 - Garey 19.

The **Eight-Man Conference** finals could have been a rematch of last year as the participating teams were the same, however, this time it was Rio Hondo Prep with their perfect 12-0 record which came up the winners as they defeated Templeton 35-12.

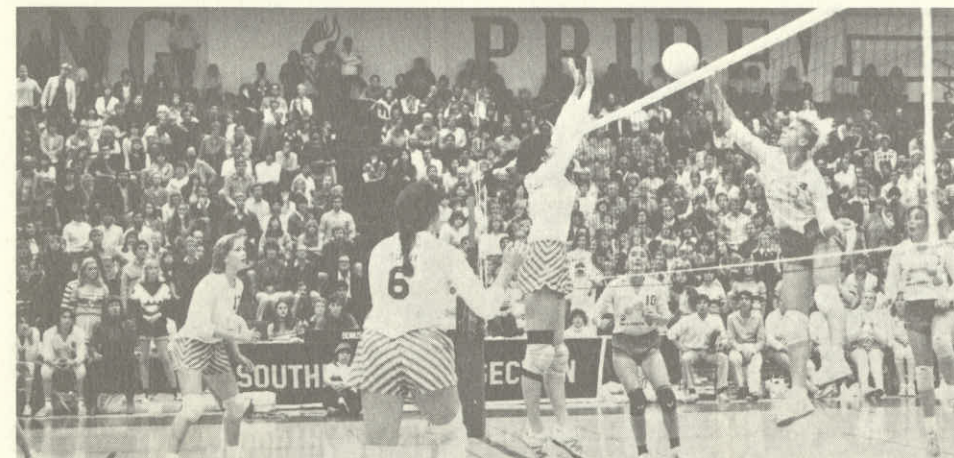

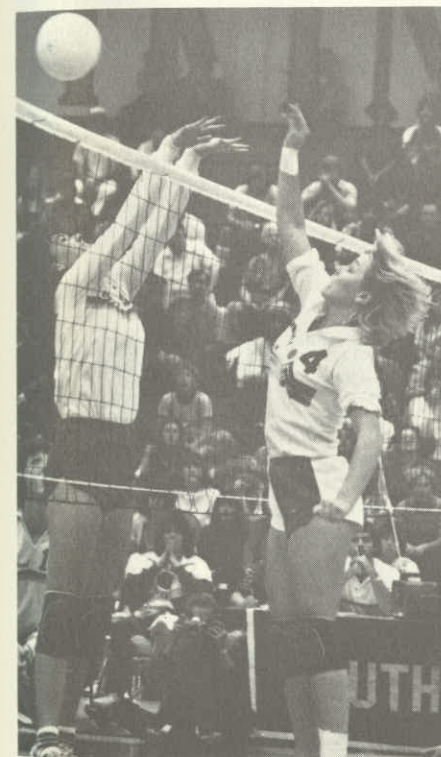
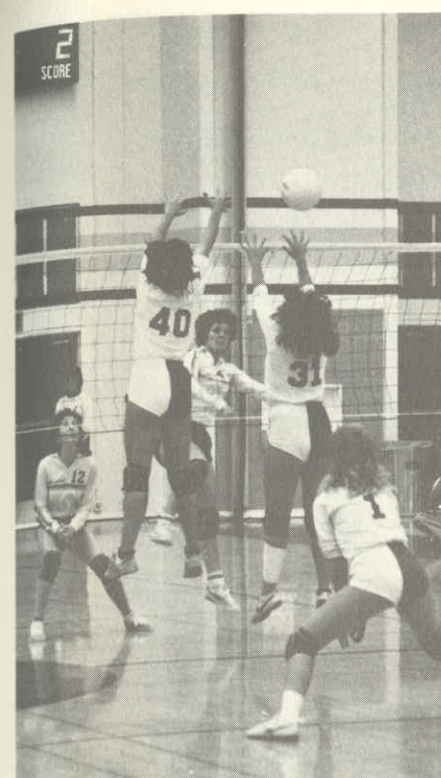

## 1982 GIRLS' VOLLEYBALL CHAMPS

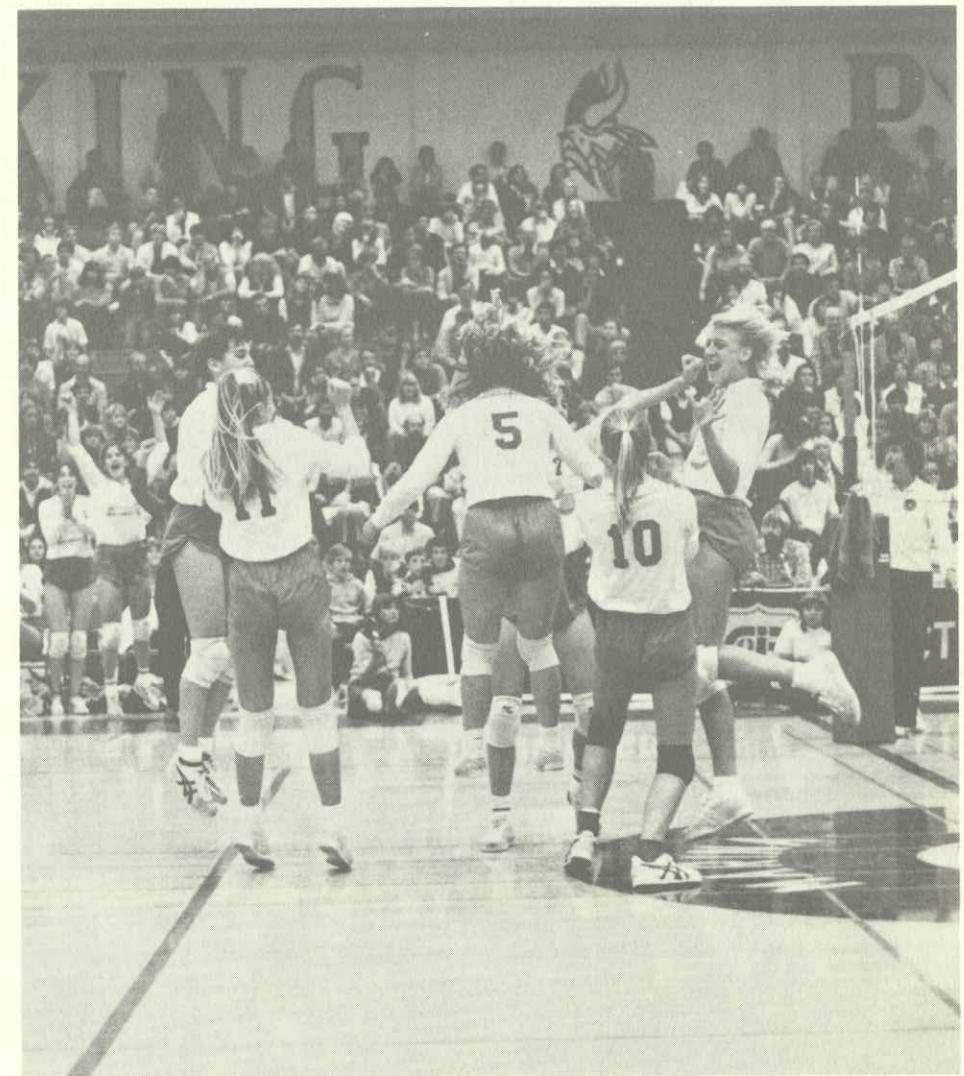

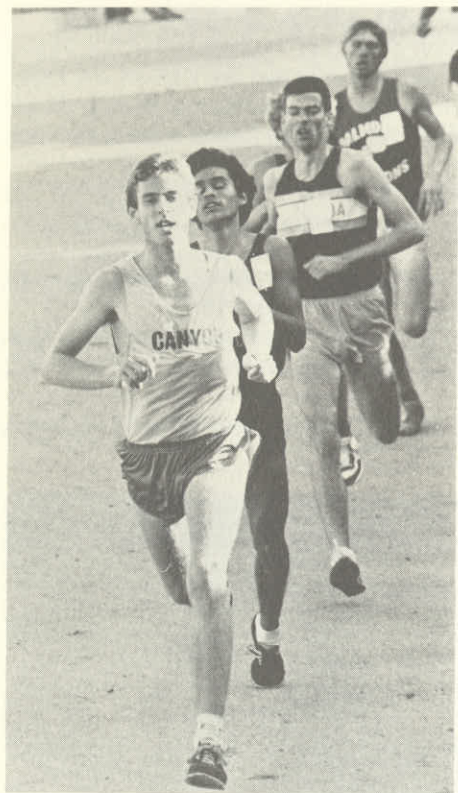

## PLAYOFF GROUPINGS TO BE DECIDED

It's time once again for the CIF-Southern Section to issue its recommendations as to your league's divisional placement (4A, 3A, 2A, 1A, Small Schools) for next school year, 1983-84.

In case you've been curious as to the process used for assigning your league to a particular grouping, here's how it works: First, since leagues (not schools) are grouped into playoff divisions, a communication was sent from the CIF-SS Office to your league to submit suggestions or ideas to the CIF-SS Office no later than March 1, 1983. The Southern Section then uses these recommendations to develop an overall grouping in each sport division as an office recommendation back to your league.

At this juncture, those leagues objecting to their divisional placement are given the opportunity to appeal in writing to the Playoff Groupings Committee. Note leagues are given the appeals option only if they **previously recommended changes** or if they **have been changed** from their present status.

Early in April, the final recommendations of the Playoff Groupings Committee will be mailed to League Representatives.

Final disposition in playoff groupings will take place at the last meeting of the CIF-SS Council in May. Leagues which appealed in April that are still dissatisfied may forward a written appeal to the Commissioner's Office asking for time on the Council agenda.

As a separate item, we bring to your attention a directive from the CIF-SS Executive Committee which will create an additional grouping in some sports in the Small Schools Division in order that leagues with very small enrollment should not be placed in a grouping with leagues of far greater enrollment.

Overall, placement for leagues in the Southern Section is based on both average enrollment and success within a playoff grouping, particularly if it appears that a given school or league might perpetuate dominance. Additionally, placement could change based upon movement of schools from one league to another, which may alter the overall strength of a league.

## WE'VE COME A LONG WAY, BABY!!!

### TURKEY DAY AT RAMONA

On the return trip the train stopped at Moorpark. A boy from one of the crowded cars got out and went to a road-side stand and bought a lug box of fine ripe tomatoes and returned to the train.

The faculty chaperones had visions. BUT LOW — the students were hungry, and in a very few minutes the tomatoes had all been eaten."

### SANCTIONED EVENTS

"The Beverly Hills High School has been Set February 13 and 14 for its Major Conference Invitational Basketball Tournament.

Several novel and interesting features are being developed in addition to the playing of the games.

Beverly Hills High School has three gymnasiums for use in the tournament. The finals will be played in Beverly Hills' beautiful and unique swim-gym with aqua sports events during the intermission."

## WHAT'S HAPPENIN' IN THE OTHER 49 STATES

### ITEM: 100 Mile Limit

In the state of Vermont, if schools must travel more than 100 miles to play a contest at a home school, the game will be played on a neutral site.

### ITEM: Written Contracts Important

If a school has a contract for a game and breaks it (by paying the forfeiture fee) without mutual agreement with the other school involved, the Alabama High School Athletic Association counts the game as one of the offending school's allowed games and will be officially called a forfeited game. The school receiving the forfeit shall not count the game as a win if the game is replaced on its schedule.

### ITEM: Official's Service Report

Football Officials in Oklahoma complete and turn in reports to the association office which rate the conduct of senior high school teams, school officials and crowds.

### ITEM: Coach Ejected from a Contest

Oklahoma requires that a coach, when ejected, be held out of the next game.

## NCAA CONTACT

If you haven't already, be prepared for occasional contact from the NCAA by way of its member institutions due to a new provision in its By-laws as it relates to contact and recruitment of student/athletes. The following is the wording for the new By-law (Section 2-(a)-(1)-(i):

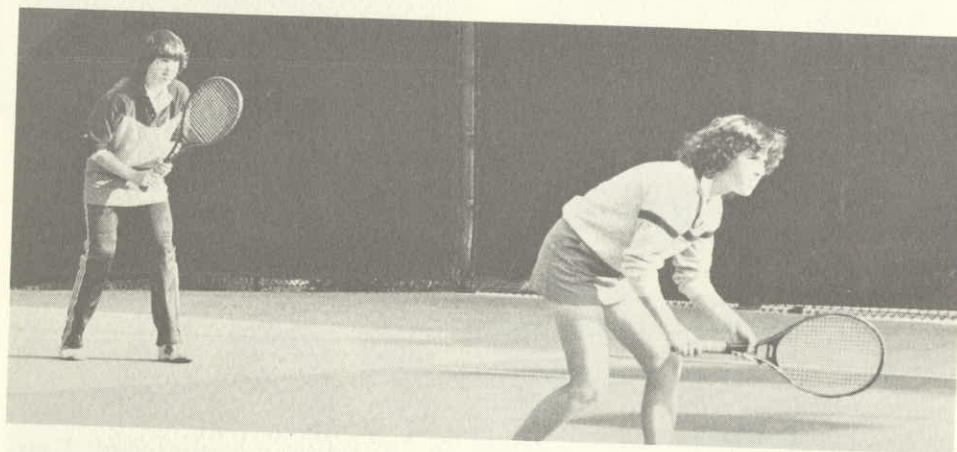
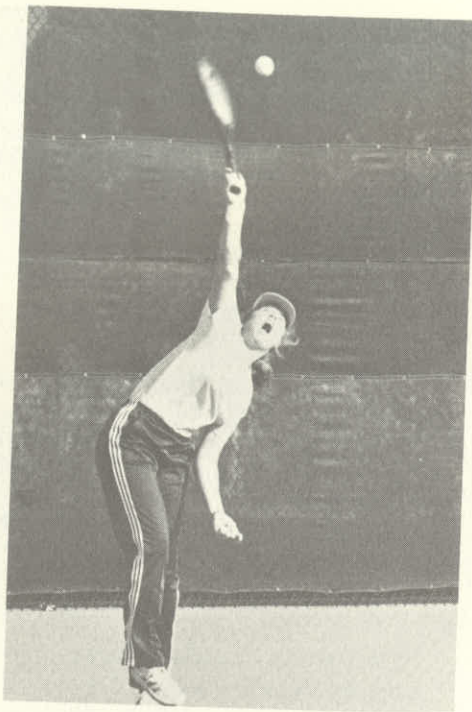
"Three additional in-person, off-campus contacts per prospect shall be permitted by each member institution on the grounds of the prospect's educational institution and with the written approval of that institution's executive officer or the designated representative."

The normal format we have seen to date is that the building principal of our member schools will receive a brief form in the mail, seeking permission from a specific college and/or university to visit on the high school campus with a specific student. Pete Pappas, principal of Pasadena High, was one of the first contacted and reports no problem with the procedure being utilized by the NCAA.

This victory for the Sea Kings was the first water polo championship the school has won since 1974 and while that fact made the win sweet, it also avenged an earlier season loss (their only loss) to the top-ranked Sailors.

In 3A Division action, it was Tustin coming from behind to defeat defending champion Villa Park, 13-8, and win their first-ever water polo title.

A very impressive Servite breezed through the 2A Division championship match and dominated the Los Amigos Lobos. The Friars took the early lead and never let up in their quest to bring home to school a first water polo championship.

The energetic and personable Assistant Principal Melvina Marble ran a grade point check of every member in the junior and senior class — the results were enlightening to say the least: . . . of those seniors participating in interscholastic athletics, the average G.P.A. was 2.68 as compared to 2.40 for those seniors taking no part in school activities; . . . of those juniors participating in interscholastic athletics, the average G.P.A. was 2.62 as compared to 2.21 for those juniors taking no part in school activities.

Enough said?

If not, there's the letter received from a superintendent earlier this week, revealing that a computer check of the general student body indicated 19.1 per cent fell below a "C" average.

However, a check of the same computer of those involved in athletics uncovered a mark close to eight full percentage points above the balance of the student body in terms of academic proficiency.

The results of a national survey have been revealed before, but it is more than

appropriate to review those once again:

(1) Students involved in extracurricular activities have higher grade point averages than those not participating.

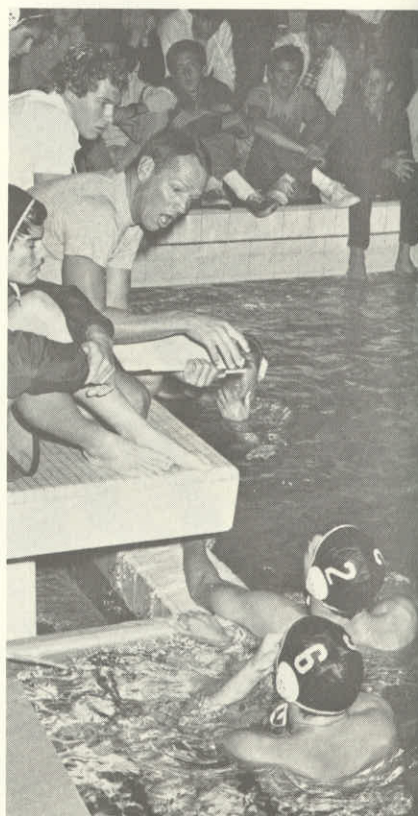
(2) Students involved in extracurricular activities have better attendance records than non-participants.

(3) Students involved in extracurricular activities have fewer discipline referrals than non-participants.

(4) ACT and SAT testing programs state they can predict a greater degree of career success among participants than non-participants.

(5) An exhaustive study of 46,000 dropout students revealed that 96 per cent were non-participants before leaving school.

It would have been great if the student/athletes would have had the opportunity to respond.





## PLUTKO SELECTED FOR NATIONAL COMMITTEE

The National Federation of State High School Associations recently named Ray Plutko, CIF-SS Commissioner, to the National Federation Television Committee. Plutko will be representing Region 7 which includes California, Nevada, Utah, Arizona and Hawaii.

This eight-man committee has been given the task of developing policies and procedures to assist schools and states regarding the televising of athletic events. All this will be published in a manual which will be distributed nationwide. In addition to the manual, workshops have been planned for every state.

## MINUTES OF CIF-SS COUNCIL MEETING

January 20, 1983

The January meeting of the California Inter-scholastic Federation, Southern Section Council was called to order by Chairman Dr. Robert Packer at 9:30 a.m. on Thursday, January 20, 1983 at the Saddleback Inn in Norwalk. All leagues were represented with the exceptions of the Frontier, Liberty, Los Padres, Santa Fe, All Girls' and Junior High representative.

1. **APPROVAL OF MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of September 23, 1982 as published in the January issue of "The Bulletin;" minutes of the CIF Southern Section Executive Committee meeting of October 28, 1982 as published in the January issue of "The Bulletin;" minutes of the CIF Southern Section Executive Committee meeting of December 2, 1982 as published in the January issue of "The Bulletin;" and the minutes of the CIF Southern Section Executive Committee meeting of January 15, 1983 as distributed to the Council.

2. **COMMISSIONER'S UPDATE** - Mr. Ray Plutko, Commissioner, reviewed with the Council the CIF-SS-National Athletic Health Institute Athletic Injuries Workshops being conducted in Norwalk, Ontario and Santa Barbara; the league varsity championship awards program set for the 1983-84 school year under the sponsorship of the W. R. Moody Trophy, Company and the State and Regional Basketball Championship hosted by the Southern Section. Additionally, the Commissioner introduced the new "CIF Southern Section Story" brochure to be distributed to member schools.

3. **TREASURER'S UPDATE** - Mr. Bruce Keuning reviewed with the Council the fall sport playoffs and the projection of the budget for the balance of the 1982-83 school year.

4. **NATIONAL FEDERATION UPDATE** - Mr. Tony Balsamo provided an overview of the National Federation's winter meetings held in Nashville, Tennessee. In addition, Mr. Balsamo updated the Council of the new football rules for the 1983 season.

5. **STATE CIF FEDERATED COUNCIL UPDATE** - Dr. Robert Packer provided an overview of current State Federated Council items under study by the various state committees, as well as an update on the Section Relations Committee.

6. **PACIFIC LEAGUE FOOTBALL PROPOSAL** - Mr. Sam Nicholson, Principal of Crescenta Valley High School, reviewed with the Council a proposal on behalf of the Pacific League which would alter the starting and ending dates for the football season of sport, effective with the fall term of the 1984 school year. This will become an action item at the March meeting of the CIF Southern Section Council.

7. **RIO HONDO LEAGUE FOOTBALL PROPOSAL** - Mr. Mickey McNamee, Assistant Principal of San Marino High School,

reviewed with the Council a proposal on behalf of the Rio Hondo League which would alter the starting date for pre-season football practice effective with the fall term of 1983. This will become an action item at the March meeting of the CIF Southern Section Council.

8. **PROTESTS OF PLAYOFF CONTESTS** - Mr. Tony Balsamo reviewed with the Council a proposal dealing with protests of PLAYOFF CONTESTS ONLY and the recommendation that the Southern Section fall in line with the National Federation sports playing rules which do not provide for same once the contest has been completed. This will become an action item at the March meeting of the CIF Southern Section Council.

9. **CENTURY LEAGUE ENTRY PROPOSAL** - Mr. Jim Turner, Principal of Tustin High School, reviewed with the Council a proposal on behalf of the Century League which calls for amending the CIF-SS By-laws to provide that more than three entries be permitted in the playoffs in the sports of football and water polo when byes exist. This will become an action item at the March meeting of the CIF Southern Section Council.

10. **SEA VIEW LEAGUE PLAYOFF ENTRY PROPOSAL** - Mr. Dennis Evans, Principal of Corona del Mar High School, reviewed with the Council a proposal on behalf of the Sea View League to amend the CIF-SS By-laws, providing that more than three entries be permitted to enter the playoffs to fill byes which exist in the opening round draw. This will become an action item at the March meeting of the CIF Southern Section Council.

11. **FOOTBALL PLAYOFF FILM EXCHANGE** - Mr. Robert Paisola reviewed with the Council a proposal on behalf of the Film/Video Tape Committee, as so constituted by the Executive Committee, calling for specific guidelines in the exchange of film and video tape, effective with the 1983 fall term. This will become an action item at the March meeting of the CIF Southern Section Council.

12. **PLAYOFF GROUPINGS COMMITTEE** - Mr. Ray Plutko, Commissioner, reviewed with the Council a proposal from the Playoff Groupings Committee calling for the procedure to be conducted every two years, effective with the 1984-86 cycle, thus combining the cycles of playoff groupings with that of relegueing. This will become an action item at the March meeting of the CIF Southern Section Council.

13. **SOCCER PLAYOFF OVERTIME PROCEDURES** - Mr. Moe Chavez reviewed with the Council a proposal developed in order to resolve the overtime dilemma which has perpetuated itself over the past three years in the soccer post-season playoffs. This procedure is to effect the playoffs only and become effective with the current 1983 season. Following discussion, it was moved, seconded and passed

to approve the proposal.

14. **SPORTS SANCTION FOR CIF-SS PLAYOFFS** - Mr. Tony Balsamo reviewed with the Council a proposal to be incorporated into the CIF-SS By-laws as it pertains to the addition and/or suspension of a sport as sanctioned for post-season playoff activity. The basis of the proposal calls for no sport to be added until such time as 20% of the total senior high school membership participates and that no playoffs be conducted by the CIF-SS Office when less than 20% of the same membership is not attained. Following discussion, it was moved, seconded and passed to adopt the recommendation effective with the 1984-85 school term.

15. **RIO HONDO LEAGUE BASEBALL/ SOFTBALL PROPOSAL** - Mr. Mickey McNamee reviewed with the Council a proposal calling for restructuring of the baseball/softball post-season playoff dates, effective with the 1983-84 school year. Following discussion, it was moved, seconded and passed to approve the proposal.

There being no further business to come before the Council, the meeting was adjourned at 11:20 a.m.

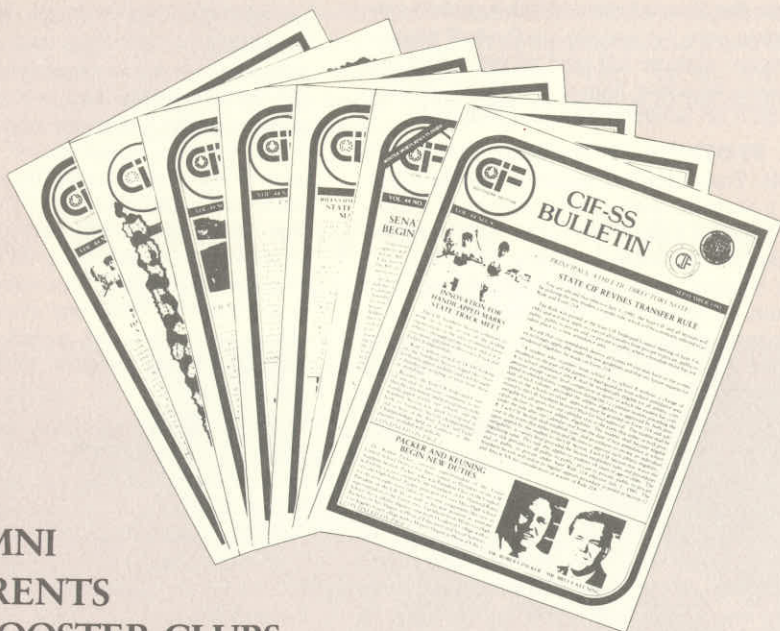
