I. What is a Basketball Game?

- (1) It was moved, seconded and lost that if the second half of a basketball game is started it shall be declared a legal game. Lost 8 to 1.
  - (2) It was moved, seconded and carried unanimously that a basketball game should be played the full time in order to be called a game, unless the time is shortened by mutual agreement before the game starts. This does not nullify the 10 minutes after sunset rule on page 10.
- A. School asked this question:-Boy finished his 8th semester Feb. 1st, he is on the basketball team and the schedule is not finished. May he finish the schedule? Ans-No.

II. Shall we change rule on page 12-All championship basketball games are to be played on outdoor courts etc. ?

- (3) It was moved, seconded and carried 6 to 4 that there be no change in this rule.
- (4) It was moved, seconded and carried that in all semi-final and final games if the two teams cannot agree the basketball manager shall have the game played on a court about 35' x 70' and said court must have a clear space around the perimeter of at least 3 feet and an overhead clearance of at least 20 ft.
- (5) It was moved, seconded and carried that in semi-final and final games, if one school requests two officials the manager shall see that the same are supplied.

(6) It was moved, seconded and carried that President Malcolm and Basketball Manager Squires be a committee to draw up the schedule for semi-final and final games in Basketball.

B. The Basketball Manager requested a copy of each league basketball schedule. The Chair instructed each member to see to it that Mr. Squires was furnished with a schedule.

- C. It was ordered that the Secretary write to T. V. Allen that Santa Ana High School had won the unlimited football championship and Huntington Park Union High School had won the 130 lb. championship in football.

He was also ordered to notify these two schools to get in touch with T. V. Allen.

- IV. Track was then taken up.  
It was moved, seconded and carried that the Southern Section Track Meet be held April 22d 1922.

The Track Manager then reported that he had received a request from Santa Ana that the meet be held there.

- (7) It was moved, seconded and carried that the Manager, Mr. Van Patten, be advised to visit Santa Ana and then in conference with the President and Secretary decide where the Southern California Track Meet shall be held.

- D. The Manager requested that he be allowed to take the following men with him Mr. Hamilton, Fred Johnson, Thomas Davis, G. M. Green, J. C. Malcolm-Granted.

- (8) It was moved, seconded and carried that in the Southern California Track Meet each boy be allowed to enter only three events and relay.

- E. Notice- The attention of each league is called to the second rule on page 12 under "Duties of the Track Manager"

- (9) It was moved, seconded and carried that the President and Secretary of each league must certify to Mr. Van Patten the list of point winners and the Principal of the school must certify as to the eligibility of his point winners.

- F. Notice- The next to the last rule on page 13 under "Duties of the Track Manager" will be strictly enforced this year.

- (10) It was moved, seconded and carried that Mr. Van Patten be placed in charge of our track team which will enter the state meet,

- (11) It was moved, seconded and carried that the Council of the California Interscholastic Federation-Southern Section express to Mr. Seth Van Patten and Mr. H. J. Moore the appreciation of all the High Schools of the Southern Section for the many fine services which they have performed in the past in managing the track meets and football games. Especially do we commend their fair mindedness and their ability in managing these sports.

- (12) The Track Manager requested that the following men who have acted in the past be asked to serve:

It was moved, seconded, and carried that we request these gentlemen to serve us.

- (13) It was moved, seconded and carried that we appropriate \$30.00 per man toward the expenses of our team to the State Meet.
- (14) It was moved, seconded and carried that we appropriate \$200. for a set of "Legal Hurdles;" that Mr. Van Patten and Mr. Weaver to be a committee of two to determine the "legality" that we accept with thanks the offer of Hollywood High School to make these and that Mr. Van Patten be made "custodian of hurdles".
- (15) It was moved, seconded and carried that any man competing in the state meet winning first place and making an exception al record may apply to the State Council for permission to enter the National Meet held outside of the State. A meeting of the State Council will be held on the day of the State Meet shortly after the close of the meet to receive any such application.
- G Notice:- In order to enter men in the Southern California Meet the "Passive" schools must take part in the League Meet and must place in said meet.

The following questions were referred to the several leagues for consideration:

- a. No pupil shall contest in any game or meet with another school who has reached his twentieth (20th) birthday.
- b. In track meets one boy shall not be allowed to take part in more than two of the following events in one meet-The Mile; The Half Mile; and the 440.
- v. The Status of the Private School.

After a general discussion in which it seemed to be the general opinion that these schools take part by invitation only, it was agreed to defer action on this question until the May Meeting.

- (15) It was moved, seconded and carried that in order to give San Diego, Harvard and the Army and Navy a chance to enter men in the Southern California Track Meet that the Army and Navy take part in the Orange County League; Harvard in the Central League and San Diego in the City League; and in the City Meet 1-2-3-4 and 5th place men be allowed in the Southern California Meet.
- (17) It was moved, seconded and carried that Harvard and Army and Navy be "free lance" schools for Basketball and Baseball and must win all games out of an approved schedule of five games, in order to enter semi-finals; schedule

to be approved by the President.
