CLAREMONT PROVES OUTSTANDING IN "AA" FOOTBALL PLAYOFFS

Claremont High School's great football team once again proved that the size of the school is not the important thing in winning football games as they proceeded to blank San Marino 20 to 0, to win the Southern Section "AA" football championship in a thrill packed contest played before 5,000 fans on Friday, December 12, in the Mt. SAC stadium.

With an enrollment of a little over 500, Claremont HS has competed in the playoffs for the past five years against schools two and three times their size and have compiled a most enviable record. Coach Leonard Cohn can look back on a fantastic coaching record in the past four years which has seen his teams capture two SS championships, gain the runner-up spot once, and reach the semi-finals the other year. We would have to go a long way back in the record book to try and match this performance, and it appears that this is not the end of championship teams at Claremont because Coach Cohn is predicting he will have his finest team in 1959.

Although Ray Sevilla, Claremont Quarterback, threw 3 touchdown passes to End Mike Macklin, it was the brutal running shown by the Wolfpack which picked up the biggest chunks of yardage and was mainly responsible for the great upset victory. In the third quarter San Marino put on a brilliant goal line stand to stop a Claremont drive on the one-yard line, but throughout the rest of the contest Claremont was not to be denied.

With the combining of the former Northern and Southern Groups of leagues into one playoff, we had for the first time this year, a true "AA" champion. Sixteen teams, all of them champions or co-champions of a league, entered this year's playoffs, which required four weekends to complete. Claremont, Tri-County league champs, slaughtered Barstow in a first round encounter 51 to 0, took the measure of El Centro 34 to 13, and eked out a victory over defending champions Mater Dei 14 to 13, to qualify for the finals. San Marino, seeded in the lower half of the draw, defeated Bosco Tech 37 to 6, Brawley 12 to 0, and Hart 14 to 6, to advance to the championship game.

WINSTON NELSON ELECTED STATE CIF PRESIDENT

Mr. Winston Nelson, Principal of Ganesha HS of Pomona, and for the past five years a SS representative on the State CIF Federated Council, was recently elected to serve as President of the Council for the coming year. This is a great honor for the SS and we are confident that the personable and very capable Mr. Nelson will perform his new duties in an outstanding manner, and will give great leadership to this important policy making body which controls and directs the interscholastic athletic program in California.

Mr. Nelson brings a wealth of background to this new position as he has served for many years as a high school administrator besides being actively engaged in the administration of the SS interscholastic athletic program for the past 12 years. For seven years Winston Nelson served as an administrator at Oceanside HS, leaving that position in 1943, to become principal at Pomona HS where he served until this year when he took over as principal of the new Ganesha HS.

Winston has been very active in CIF, SS affairs having started as a league representative from which position he was elected to the Presidency of the SS Council for the 1948-49 school year. In 1953, he was elected Treasurer of the SS and has so efficiently carried out the duties of that office that he has been re-elected to that position annually. Upon the retirement of Harry J. Moore from CIF activities in 1954, Winston Nelson was elected to replace Mr. Moore as the SS representative on the State CIF Federated Council.

The State Council is most fortunate in having a man with the background and the interest in interscholastic athletics that has been shown by Mr. Nelson, and we can look forward to a most successful year under his expert leadership.

LB POLY CAPTURES CIF, SS FOOTBALL CHAMPIONSHIP

LB Poly captured its seventh CIF, SS football championship with a resounding 31 to 19 triumph over previously unbeaten Santa Monica in the Coliseum on Friday night, December 19, 1958. A crowd of 14,152 screaming fans watched the terrific Jackrabbits dominate the game save for the last two minutes of the first half and the first 90 seconds of the second half. During those three and one half minutes a plucky Samohi crew pulled up from a 0 to 12 deficit to go ahead 13 to 12, but this turn of events only served to fireup the Bunnies, who took the subsequent kickoff and marched 64 yards in 4 plays to go in front to stay.

The performance of the Poly team throughout the season was a tribute to the fine coaching job turned by Dave Levy and his outstanding corps of assistants. After winning the tough Harry J. Moore League title, the Jackrabbits were pitted in the opening round of the playoffs against a fired up North Torrance club that was out to pull off the upset of the year. With only seconds to go in the contest the score was tied and North Torrance was leading in first downs 10 to 6. It appeared that the greatest upset in the SS playoffs was in the making, but the fans had not counted on the resourcefulness of the Poly players. On the last play of the game, with the ball near midfield, the Poly quarterback called for a pass play off a double reverse and when the ball settled down into the waiting arms of a Poly player in the end zone, the valiant effort of the North Torrance boys went for naught. Poly then advanced through the next two rounds by decisively defeating San Diego 26 to 18, and Colton 41 to 27.

Santa Monica on the other hand had to battle to capture the Bay League crown and were underdogs in the first three playoff encounters. They did not let the odds bother them however, and disposed of Paramount 14 to 13, Mt. Carmel 13 to 6, and Sweetwater 34 to 20 to reach

the final round. Enough credit cannot be given to Coach Leon McLaughlin who, in his second year at the helm, brought his boys into the championship game. With a squad dominated by juniors, we can look for Santa Monica to be a real threat when next year's playoffs roll around.

Prep football with its free substitutions and wide-open type of play continues to please the public and record breaking crowds were in attendance at nearly all of the games. In general good weather prevailed during the playoffs although there was one instance in a semi-final game at Long Beach when the fog rolled in and nearly obscured the field of play from the spectators. Fortunately for the 14,000 persons in attendance the fog lifted enough so that it was not necessary to call the game prior to its conclusion. The neutral officials assigned did an outstanding job and good sportsmanship on the part of players, coaches and spectators was in evidence throughout the playoffs.

MINUTES OF CIF, SS COUNCIL MEETING, DECEMBER 13, 1958

The first regular meeting of the CIF, SS Council for the 1958-59 school year was held on Saturday morning, December 13, 1958, in the patio or Helms Hall. The meeting was called to order by President Vaughn Cummings, Supervisor of Athletics for Pasadena City Schools. Official representatives from all leagues were in attendance with the exception of Hi-Lo and San Bernardino City leagues.

1. It was moved, seconded, and carried that the Minutes of the Council Meeting of October 7, 1958, be approved as published in the No-

vember Monthly Bulletin. 2. It was moved, seconded, and carried that the Minutes of the Executive Committee Meeting of November 17, 1958, be approved as read.

3. It was moved, seconded, and carried that the Minutes of the Executive Committee meeting of December 13, 1958, be approved as read.

4. Mr. Winston Nelson, SS representative on the State CIF Federated Council, reported on the CIF meeting held in Los Angeles on November 28 and 29, 1958. Mr. Nelson informed the Council concerning the following items that were on the Agenda: (a) a revised State Constitution was approved by the Council. This new Constitution embodies eligibility rules which conflict with certain present SS regulations and will make necessary some changes in SS eligibility rules: (h)Mr. Dave Snyder of the Oakland City Schools was elected to a three-year term as the California representative on the National Federation Football Rules Committee; (c) Mr. Pete Clentzos of Roosevelt HS in Los Angeles, and a member of the CIF Weight-Training Committee, gave an outstanding presentation on the benefits of weight training in our high school athletic program. Copies of this report will be mailed to all schools in the near future from the State Office.

5. Mr. Matt Korwin, Avocado League Representative, pointed out that with the great increase in the membership of the SS Council in recent years, there was a need for a change in the present SS quorum rule. It was moved, seconded, and unanimously carried that Article IX. Section 1, of the Constitution be changed to read as follows: "A quorum shall consist of a (simple) majority of Council members."

6. At a recent meeting of the Executive Committee, Mr. Ben F. Jamison was appointed as committee of one to contact a lawyer to investigate the advantages of the CIF, Southern Section incorporating as a non-profit organization. Mr. Jamison reported that he had been advised that it would be in the best interests of all concerned for the SS to incorporate for not only the protection of individual Council members, but due also to the fact that the SS was in the process of acquiring real property. The cost of incorporating would not exceed an expenditure of \$22.00. After some discussion it was moved, seconded and carried that the President and Secretary be authorized to execute and sign the necessary papers of incorporation for the CIF, Southern Section.

7. The Commissioner reported that during the past few years numerous principals of our member schools had called the SS Office to report that athletic contracts had been broken by certain schools for what appeared to be insufficient reason. It was pointed out that many states have regulations pertaining to the problems of contractual relations between member schools and that it might be wise for a special committee to be appointed to study and make recommendations concerning the situation. It was moved, seconded and carried to authorize the president to appoint a committee of three to meet with the Commissioner for the purpose of studying the problem of contractual relations among member schools and report their findings and recommendations to the Council at the February meet-

8. President Cummings called on the Secretary to report on the progress of the new SS office building. Mr. Fagans reported that construction had begun on the new building and was proceeding at a normal rate. It is expected that it will be ready for occupancy about the first of March.

9. The President announced a deviation from the Agenda and called on Mr. Bergstrom to come forward for the purpose of making a special presentation. Mr. Bergstrom, Chairman of the Executive Committee, informed the Council of the recent retirement of Mr. William G. Lopez, from his position as Supervisor of Athletics for the Los Angeles City Section of the CIF, after 25 years of distinguished service. During part of that time the Los Angeles schools were a part of the Southern Section and Mr. Lopez worked very closely with the Executive Committee and Council of the SS.

Mr. Lopez, or Bill as he is familiarly known to his thousands of friends in the athletic world, is a native son, having been born in Santa Barbara where he received his early schooling. After graduating from the University of California, Bill entered the service and in 1919 joined the LA City Schools as an assistant coach at Jefferson HS. He later coached at Franklin HS until he became supervisor. A long term member of the Southern California Committee for the Olympic Games and currently on its Executive Committee, he is a former president of the Southern California Officials' Association, and is Chairman of the Advisory Council of the Examiner Scholastic Sports Association.

In recognition of his long and outstanding service Mr. Bergstrom presented Mr. Lopez with a CIF, SS Gold Life Pass. Mr. Lopez responded with a short speech in which he thanked the Council for this high honor and recognition and recalled incidents in the past when he had worked closely with present members of the Council. He remarked that he was looking forward to his retirement, but that he did not intend to lose contact with his friends in the SS.

10. Mr. Winston Nelson brought to the attention of the Council the recommendations of the Awards Committee pertaining to CIF individual awards for members of SS Championship teams. (The complete report of this committee was published in the December Monthly Bulletin.) It was moved, seconded, and carried to accept the report and instruct the league representatives to bring this matter up in their individual leagues and be prepared to decide the issue at the February Council meeting.

11. The Executive Committee recommended to the Council the adoption of the following eligibility rule to be included in Article VIII of the Blue Book:

"A boy who transfers from one school to another without a change of residence on the part of his parents or legal guardian, or without court order, shall be ineligible in the new school for one semester, or for one year if he has ever participated in an interscholastic athletic contest. If the boy returns to the original school to reside with his parents or legal guardian, he shall become eligible immediately provided he is eligible under CIF. SS regulations and has not participated in

an interscholastic athletic contest in the second school."

It was moved, seconded, and carried to refer this proposed change in our present eligibility rules back to the leagues for consideration and that the item be placed on the Agenda of the February Council meeting.

12. Mr. George Phelps, Jr., Chairman of the SS Survey Committee, presented the following report:

(a) In view of the 168 to 38 vote in favor of the CIF limiting the number of games played in all sports and the establishment of starting dates for practice in all sports, we recommend that the CIF limit the number of games played in all sports and establish starting practice dates for the same activities.

(b) Because of the tremendous vote opposing Number 6 which reads "Do you favor summer basketball leagues in which players are being coached by the high school coaches?"— Yes - 145, No - 55, we wish to recommend that a committee be appointed to establish regulations regarding summer high school basketball and coaches participating in summer practices and games.

(c) We feel that there are other areas that we should continue studying, but at the moment, these three have created the most interest in the way of one-sided voting.

It was moved, seconded, and carried that the report be accepted and that the committee be authorized to present specific recommendations concerning the items covered in the report at the next meeting of the Council.

13. Mr. B. L. Bergstrom, Chairman of the Releaguing Committee, was called upon to present the recommendations of his committee. Mr. Bergstrom gave a short talk on the philosophy of releaguing and then indicated that the only area that presented problems was in the Bay region. He suggested that the Council first consider the recommendations for all areas excep the Bay area. This procedure was agreed upon and Mr. Bergstrom then presented the following recommended changes in leagues for the 1959-60 school year:

(a) Cantwell HS be removed from the Catholic League and placed in the Parochial League; (b) La Salle HS be removed from the Olympic League and placed in the Parochial League; (c) Bishop Amat and St. Paul HS be placed in the Parochial League; (d) Mary Star of the Sea and St. John Vianney be removed from the Parochial League and be placed with St. Monica's, St. Bernard, Bishop Montgomery, and Alemany HS in a new league, which is as yet unnamed; (e) La Habra and Western HS of Anaheim be removed from the Freeway League and placed in the Sunset League; (f) Westminster HS, Sunny Hills HS, Bolsa Grande HS and the new Santa Ana HS, be placed in the Freeway League; (g) Carpinteria and Lompoc be dropped from the Frontier League and placed in the Tri-Valley and San Luis Obispo Leagues respectively; (h) San Marcos HS of Santa Barbara and Hueneme HS be added to the Frontier League; (i) the present San Diego City

League be divided into two leagues in the following manner-League "A" to consist of Crawford, Hoover, Lincoln, St. Augustine, and San Diego HS, with league "B" to be composed of Clairemont, Kearny, La Jolla, Mission Bay and Point Loma; (j) Downey HS be dropped from the Coast League and placed in the Harry J. Moore League; (k) Dominguez HS be removed from the Crescent League and placed in the Coast League; (1) a new league be formed in the San Gabriel Valley area to be known as the Suburban League and composed of Charter Oak, Duarte, Edgewood, Los Altos, Mayfair, Montclair and Mayfair high schools; (m) Aquinas, Boy's Republic, California School for the Deaf, Elsinore N & M, and Notre Dame HS of Riverside be removed from the Arrowhead League and formed into a new association to be known at the Mt. Rubidoux League; and (n) the present Riverside County League be given one month to rearrange their league to either provide membereship for Yucaipa and Indio high schools, or to guarantee them contests during the league season in all sports. After a short discussion it was moved, seconded, and carried that the above recommendations of the Releaguing Committee for the 1959-60 school year be approved.

14. Mr. B. L. Bergstrom informed the Council that a difficult problem presented itself in the Bay area due to the fact that Santa Monica desires membership in a league, and the Bay league which is the logical place for Santa Monica, does not wish to have Santa Monica as a member of the league. In order to resolve this impasse it was necessary for the Releaguing Committee to come up with a compromise which of course is never very satisfactory to either party concerned. In the Bay area the releaguing committee is recommending that the Crescent League be disbanded and that the 15 schools located in that area be leagued as follows: (a) Pioneer League be composed of Aviation, Beverly Hills, Culver City, El Segundo, Lennox, South, and Torrance high schools. (b) The Bay League to be composed of Hawthorne, Inglewood, Leuzinger, Mira Costa, Morningside, North, Redondo and Santa Monica high schools. Santa Monica's membership in the Bay League would be for all sports except football. Because of scheduling difficulties it would be further recommended that the Bay League would be expected to furnish not less than four football games for Santa Monica during the regular league season.

Dr. Goodwill, Superintendent of the Santa Monica School District, expressed the viewpoint of his school by stating that Santa Monica definitely wanted to be in some athletic league and he felt it was the responsibility of the CIF, SS to place Santa Monica in a league. A request was made for representatives of the Bay League to express their opinions in the matter, but there was no response from respresentatives of Bay League schools who were in attendance. A number of Council members, including Mr. Tonini of the Coast League, Mr. Price of the Sierra League, Mr. Spaulding of the Freeway League, Mr. McIntosh of the Citrus Belt League and Mr. Campbell of the Metropolitan League expressed the opinion that size of school and winning were not the important factors to be considered in this matter and it was their opinion that Santa Monica should be placed in the Bay League for all sports. After considerable discussion, it was moved, and seconded that the recommendation of the releaguing committee for the Bay area be accepted with the modification that Santa Monica be included as a full member of the Bay League. A roll call vote was requested on this item. The motion was carried with 32 members approving, 2 members dissenting, and one member abstaining.

15. By action of the State Federated Council the high school discus has been added as an official event, with points counting, in the California State High School Track and Field Meet to be held in Bakersfield, Friday, May 29, 1959. The SS will be entitled to three entries in this event and the Commissioner requested that the Council consider one of the following four alternatives as the policy of the SS:

(a) Have no competition in the high school discus and do not permit entries in this event from the Southern Section into the state meet.

(b) Include the high school discus as a regular event in the SS prelims, semi-finals and championship meet, with leagues qualifying boys into the prelims in the same manner as they do for all other events.

(c) Have a special tryout to be held on the morning of the Championship meet to qualify three boys from the Southern Section into the State Meet. Medals would be given to the first five boys, but points would not count towards the team championship. Leagues could qualify boys for entrance into this event in any manner they decide.

(d) The Commissioner of Athletics would set up a special time and place when eligible boys could compete for the right to be entered in the State Meet.

It was moved, seconded, and carried that SS member schools will not engage in discus competition of any type, and that no entries from SS schools will be permitted in the State Meet.

There was considerable discussion on this matter and Mr. Gil Strother, representing the Pacific League, stated that in his opinion we were working an injustice on SS track teams by not permitting them to enter boys in the State Meet while other sections would have entries and could possibly score points which might deprive a southern section school from winning the State Championship. It was moved and seconded that the motion be reconsidered and a roll call vote be taken. The motion to reconsider was defeated by 33 to 2 vote.

There being no further business to come before the Council the meeting was adjourned at 12:15 P.M. The next Council meeting is scheduled for Helms Hall on Saturday, February 7, 1959.

SMALL SCHOOL FOOTBALL PLAYOFFS HUGE SUCCESS

A finalist in 1957, Ramona HS was not to be denied this year as they came roaring back in the 2nd half to defeat Needles HS 26 to 21, to win the CIF, SS "A" football championship on Friday, December 12, on the loser's field. An overflow crowd was in attendance and they were privileged to witness an exciting contest in which the final outcome was in doubt until the waning moments of the last quarter.

Both teams went into the championship game undefeated, but in the final analysis it was the power and speed of the Ramona backfield that decided the outcome. Junior Willis played brilliantly for the Mustangs in a losing cause as he averaged 8.4 yards per carry to amass a total of 164 yards gained. Gary Mayer of Ramona, wrapped up the CIF scoring title with 198 points, the final 7 of which were scored in the championship game. The game was close as far as the score was concerned, but Ramona's statistics show a decided edge for the Bulldogs. They gained 376 net yards to 263 for the Mustangs, and had 18 first downs to 11 for Needles.

Six league champions entered this year's playoffs which necessitated two Bye dates in the bracket. In the first round encounter Ramona overwhelmed Trona, the Desert Inyo champions 44 to 0, and then drew a Bye in the second round to qualify them for the championship game. As it was necessary for Needles to engage in a playoff game for the Arrowhead League championship they were given a Bye in the first round. In the second round Needles met Santa Clara who had advanced as a result of a 20 to 14 victory over Mission HS of San Luis Obispo. The Santa Clara-Needles contest was played in Oxnard, with Needles easily winning by a 33 to 7 score to qualify for the championship game with Ramona.

Although it was necessary for the competing schools to travel in some cases great distances, all games were played without a financial loss and all participating schools were of the opinion that the playoffs had provided a worthwhile educational experience for the boys. It is anticipated that next year there will be an additional two or three leagues in the "A" playoffs which will eliminate byes and make for a more balanced playoff.

EL CAJON HS REPEATS AS SS CROSS COUNTRY CHAMPIONS

El Cajon HS represented by a speedy group of runners retained their CIF, SS large schools cross country championship by scoring 54 points in the championship meet held on Friday, December 5, before an overflow crowd on the rugged Mt. San Antonio Junior College course. Although Coach Joe Brooks of the Braves found it necessary to remove his star performer from the team because of disciplinary reasons, the remaining members of the squad battled just a little bit harder and still managed to finish in front of second place Huntington Beach which scored 103 points. Ten of the outstanding varsity teams in Southern California qualified for the finals and competition was keen throughout the race.

Individual honors were captured by Sal Ramirez of El Rancho and Morris Nunez of Mt. Miguel who finished with times of 9:01 and 9:03, respectively, to lead the pack. Both of these fine runners were entered as individuals as their teams had not qualified in the preliminaries.

The highlight of the meet occurred in the second race of the day which was limited to schools with an enrollment of under 1200 in the upper three grades. In this race Dale Story of Orange HS ran one of the most fabulous races in the history of CIF, SS cross country competition, when he covered the course in the record time of 8:52.1. This performance shattered the course record of 9:01.8, which had been established by Cruz Lopez of El Rancho HS in the 1956 championship meet. No one was even close to Story as he romped across the finish line, and big things are expected from this young man next spring when he makes an all out effort to lower the SS record in the mile run, which has eluded all of the great high school distance performers for the past 25 years.

Coach Bill O'Rourke's spirited team from Culver City, captured the small school team championship with 51 points and were closely followed by Torrance HS with 66 points. In the junior V MALL SCHOOL DIVISION:

ta, whose fine team scored 32 points. In second and third place were Morningside HS and Helix HS with 71 and 74 points, respectively. Kit Bonham of the championship Mira Costa team placed first among the individual performers with a time of 9:45.8.

To determine qualifiers for the championship meet, four sectionals were held on November 26, at San Diego, Huntington Beach, San Bernardino, and Inglewood. These meets were managed by Mr. Don Clarkson, of the San Diego City Schools, Coach Jack Rowan of the Huntington Beach HS, Coach Louis Finn of Pacific HS in San Bernardino, and Coach Norm Lumian of Aviation HS. On behalf of the CIF office and the competing schools we would like to express our sincere appreciation to these fine men for the outstanding job they performed in conducting their respective meets.

Coach Hilmer Lodge of Mt. San Antonio JC again offered his outstanding facilities and served as manager for the championship meet. With a large crowd on hand Coach Lodge had things well organized and the meet ran off on schedule. We would like to thank Mr. Lodge for the fine service he rendered to our Southern Section cross country program.
