



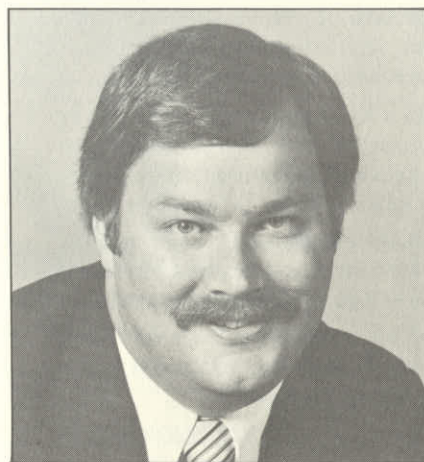

MINUTES OF THE MEETING OF THE CIF SOUTHERN SECTION COUNCIL September 23, 1982

The September meeting of the California Interscholastic Federation Southern Section Council was called to order by Chairman Dr. Robert Packer at 9:30 a.m. on Thursday, September 23, 1982 at the Saddleback Inn in Norwalk. All leagues were present.

1. **APPROVAL OF MINUTES:** It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of May 6, 1982 as published in the September issue of "The Bulletin;" minutes of the CIF-SS Executive Committee meeting of June 19, 1982, as published in the September issue of "The Bulletin;" and the minutes of the CIF Southern Section Executive Committee meeting of August 28, 1982, as mailed to the Council.

2. **PRESIDENT'S MESSAGE:** Dr. Robert Packer introduced new Executive Committee members Gerald Harer, principal, Pacific Christian High School; Fr. Charles Hill, principal, Pius X High School; H. L. Looney, principal, Troy High School; and Mr. Lon Hardgrave, assistant principal, La Sierra High School. Also introduced were members of the Council and guests.

Dr. Packer reviewed the purpose and role of Council representatives in representing their respective leagues and stressed their responsibility to stimulate communication at all levels within their scope.

3. **COMMISSIONER'S UPDATE:** Mr. Ray Plutko, commissioner, reviewed with the Council summer activities of the Southern Section office and upcoming plans for the 1982-83 school year. These included the new Blue Book format, eligibility posters, the Athletic Administrators Symposium set for October 25, and work being done with the National Athletic Health Institute and up-

coming plans for three geographical spring seminars. The commissioner also stressed that the staff will continue to extend communication by means of the Principal and Athletic Director Newsletters, the new "CIF-SS" brochure, and a major emphasis on the "Focus on High School Activities", scheduled for October 18-30, 1982.

4. **TREASURER'S REPORT:** Mr. Bruce Keuning reviewed with the Council the Auditor's report culminating the 1981-82 school year, which reflected an unexpected net of \$1,923, in addition to the \$20,000 carryover to the 1982-83 budget.

5. **NATIONAL FEDERATION UPDATE:** Mrs. Barbara Wilson provided an overview of the National Federation's summer convention as it related to trends in the area of interscholastic athletics throughout the U.S. and participation by representatives of the CIF Southern Section.

6. **STATE CIF FEDERATED COUNCIL:** Mr. Tony Balsamo presented an orientation to Council members on the CIF State Federated Council, as well as representation and voting procedures by the Southern Section representatives.

Mrs. Barbara Wilson provided background information on a discussion being conducted at the State Federated Council level pertaining to scholastic eligibility standards. This issue was presented as a discussion item to draw input from the Southern Section enabling our representatives to carry the views of the CIF-SS to the upcoming State Federated Council meeting.

7. **SOCCER PLAYOFF OVERTIME PROCEDURE:** Mr. Moe Chavez reviewed with the Council a proposal developed in order to resolve the overtime dilemma which

SPECIAL NOTICE

The Southern Section Office has experienced a problem which has perpetuated itself over the past few years as it pertains to proper supervision and entry of student-athletes in the post-season playoffs.

The situation relates only to individual sports, i.e., cross country, tennis, track, etc. and the official recognition and registration of entrants at the respective playoff sites.

State and Southern Section Rule 307 states:

"No CIF team (i.e., individual) shall participate in interscholastic or approved competition with any other team unless the CIF team is under supervision as required by the California Administrative Code Title V of CIF By-Law #506(b)."

It should be noted that schools representing the same district may send one credentialed or certified supervisor for three or four students. These individuals have been recognized and are to continue to be recognized for registration and participation purposes in that the district has assigned the supervisor role for all students from its member schools to this one individual.

However, the concern is for those students who are not accompanied by a faculty representative and report to the playoff site by themselves or with a parent.

PLEASE NOTE, THIS RULE WAS REVIEWED WITH BOTH THE STATE CIF OFFICE AND THE SOUTHERN SECTION EXECUTIVE COMMITTEE AT ITS MEETING OF OCTOBER 28, 1982 AND REAFFIRMED THAT THE INTERPRETATION STAND AS ABOVE AND THAT ANY STUDENT REPORTING FOR COMPETITION WHO IS NOT UNDER THE DIRECT SUPERVISION IN ACCORDANCE WITH STATE AND SOUTHERN SECTION RULE 307, IS TO BE "DENIED" ENTRY FOR PARTICIPATION IN THE COMPETITION.

As pointed out by the Southern Section and State CIF Attorney, there are also inherent liability problems when an individual competes in violation of said rule. Please review this rule with your staff in that it will be strictly enforced as per the above application.

COACHING STAFF INFORMING STUDENT/ATHLETES

Not only are in-service programs proving beneficial at the administrative and coaching levels, but a recent trend of coaches working with student/athletes and the rules and regulations which pertain to their specific sport. Along these lines, we would urge that one additional item be covered, that dealing with video-tape equipment. Southern Section Rule 522 states, "Motion pictures, video reproduction and/or any other type of reproduction such as still pictures, etc. shall not be taken for scouting purposes in any sport by a representative, official or unofficial, of a CIF Southern Section school in which his/her team member is not a participant, without written consent of the participating schools."

Over the past few years, the area of video equipment has become commonplace, even at the student level. Additionally, isolated situations have occurred where students are found taping athletic contests as a "third party" to competing schools which are opponents a few weeks hence. We would urge that coaching staffs cover this rule with their athletes at the start of each sport season.

MINUTES OF EXECUTIVE COMMITTEE MEETING

October 28, 1982

The October meeting of the Executive Committee of the California Interscholastic Federation was called to order by Chairman Dr. Robert Packer at 1:35 p.m., Thursday, October 28, 1982 at the CIF-SS Office in Cerritos. All members were present with the exception of Tony Balsamo.

1. **PRESIDENT'S UPDATE:** Chairman Dr. Robert Packer commended the Office Staff on the recent article in the CIF-SS Bulletin explaining the playoff pairing format and the successful Administrators' Symposium conducted at the Anaheim Convention Center for over 600 member school administrators, athletic directors and support personnel.

2. **COMMISSIONER'S UPDATE:** Mr. Ray Plutko, Commissioner of Athletics, reviewed with the Committee, "Focus on High School Activities Week"; the soon to be released CIF Southern Section Story brochure; and the three upcoming NAHI regional athletic injury prevention and treatment workshops. Additionally, the Commissioner briefed the Committee on support income, 214 transfer eligibility, and procedures with regard to the water polo playoffs.

3. **BOYS' ATHLETIC DIRECTORS' UPDATE:** Mr. Clyde Francisco, Boys' A.D. Representative, reported on progress being made through the Athletic Administrators Advisory Committee on improving communication with the boys and girls athletic directors' representatives on the Executive Committee.

4. **GIRLS' ATHLETIC DIRECTORS' UPDATE:** Ms. Sheila Burrud, Girls' Athletic Directors' Representative, reported on the various geographical athletic directors' associations and their efforts to promote interscholastic athletics.

5. **SUPERINTENDENT'S UPDATE:** Dr. Maury Ross stressed the importance of good lines of communication between school personnel, central office staff and boards of education. Dr. Ross also reviewed concerns relative to scholastic and residential eligibility.

6. **TREASURER'S UPDATE:** Mr. Bruce Keuning reviewed with the Committee the current status of the CIF Southern Section working budget, and the positive deadline response to the submission of dues for the 1982-83 school term.

7. **STATE FEDERATED COUNCIL:** Mrs. Barbara Wilson reported on items from the State Federated Council meeting of October 22-23, which included the role and function of the State Executive Committee, the scholastic eligibility question, division of money from state playoffs, hearings to be conducted by the section Relations Committee, new sanction event procedures to be voted on in January for the 1983-84 school year, and a variance for YMCA swimmers which will be decided at the State Federated Council meeting in January.

8. **NATIONAL FEDERATION REGION VII REPORT:** Dr. Packer and Commissioner Plutko reported on the recent National Federation Region VII-VIII meetings held in San Diego.

9. **LEGAL UPDATE:** Mr. Andy Patterson reviewed with the Committee the Seattle helmet decision, implication of product liability, and a current residence eligibility case in the Sac-Joaquin Section.

10. **CIF-SS MEMBERSHIP STATEMENT AND CRITERIA:** Commissioner Plutko reviewed with the Committee a proposal whereby a consistent format and application procedure would be established for prospective schools seeking CIF Southern Section membership. The Commissioner will submit the final draft at the December meeting.

11. **FOOTBALL FILM EXCHANGE AND VIDEO TAPE GROWTH:** Bill Clark, administrator, shared with the committee concerns relative to the number of schools now using video tape in lieu of 16mm film for football contests. During playoff periods this has created problems with regard to film exchange. After discussion, Chairman Packer appointed a subcommittee for further review. The Committee was directed to bring back to the Executive Committee a recommendation for the 1983-84 season.

12. **BIG BEAR/RIM OF THE WORLD FOOTBALL CONTEST:** The Executive Committee reviewed an appeal from Big Bear High School regarding a football contract. Following discussion, the Executive Committee ruled the contract as void with respect to the 1983-84 season.

13. **MEMBERSHIP REQUEST:** It was moved, seconded and passed to approve the reinstatement of membership for Hesperia Junior High School and North County Christian School (Atascadero) effective this date.

14. **ALL CIF AWARDS UPDATE:** Commissioner Plutko reviewed with the Committee correspondence from Mr. Bill Schroeder of the First Interstate Bank Athletic Foundation relative to the All-CIF awards program.

15. **CREDENTIALLED SUPERVISION OF CIF-SS ACTIVITIES:** Commissioner Plutko reviewed with the Committee the problem which has perpetrated itself over the past few years as it pertains to proper supervision and entry of student athletes in the post-season playoffs in individual sports. Following discussion, the Executive Committee sustained the interpretation of the Office that individuals must be supervised as required by the California Administrative Code Title V of CIF By-law II 506 (B) or competition entry be denied.

16. **COLTON HIGH RESPONSE:** Commissioner Plutko reviewed with the Committee correspondence from Mr. Rollin Grider, principal of Colton High School, with reference to the question of undue influence surrounding the transfer of a foot-

ball player from Arlington High School. Following discussion, the Committee ruled that the matter be closed, with specific guidelines forwarded to Colton High School as it pertains to its summer weight program.

17. **WALNUT HIGH SCHOOL CROSS COUNTRY APPEAL:** Mr. Dean Crowley, administrator, reviewed with the Committee an appeal of a decision by the Sierra League with reference to a protest of the Walnut-Rowland cross country dual meet of October 13, 1982. Following discussion, it was moved and seconded to sustain the decision of the Sierra League.

18. **UNIVERSITY HIGH SCHOOL ELIGIBILITY:** It was moved, seconded and passed to grant an extension of the waiver of the residence eligibility rule to Robert Solomon of University High School, as established by the Commissioner.

There being no further business to come before the Executive Committee, the meeting was adjourned at 5:45 p.m.

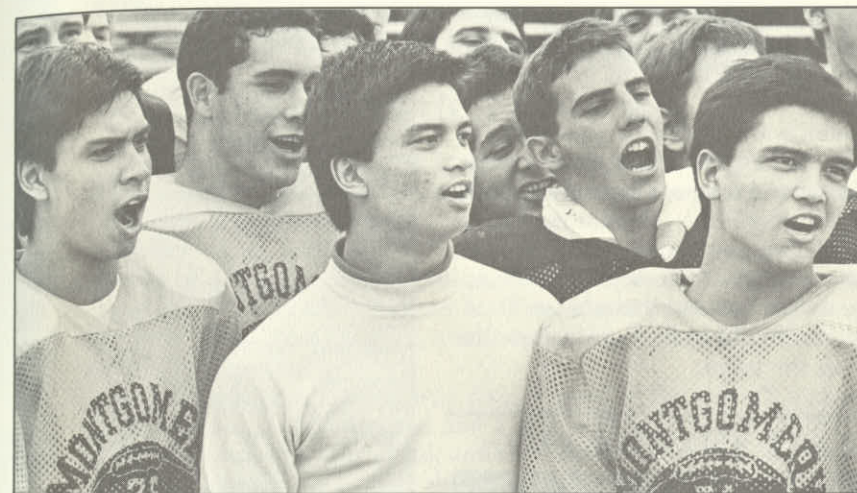

FEATURE ATHLETE OF THE MONTH

EDITOR'S NOTE: In an effort to give well deserved recognition to Southern Section athletes, this is the first in the 1982-83 series of articles featuring "all-around student-athletes".

The spotlight in December focuses on not one or two but a trio of athletes from Bishop Montgomery High School in Torrance.

The Clementes', Domingo, Demanche and Dominic have a lot in common apart from the fact that they are brothers and were born in the same month. Uniquely, all three first names mean "Sunday" in Spanish, French or Italian.

"Togetherness" seems to be the theme of the brothers' story as 17-year-old Domingo (Senior), 16-year-old Demanche (Junior) and 15-year-old Dominic (Soph.) all play varsity football for Bishop Montgomery; all have starting positions and are excellent athletes.

Two of the brothers (Demanche and Dominic) play basketball and all three are actively involved in the school's track program. They are good to average students and are very popular with other students, coaches and administrators.

Outside of school activities, they ski together and are avid campers.

With college looming ahead for Domingo and then Demanche, the boys will experience a slight break in the closeness they share. However, they plan for the separation to be a temporary one as future plans call for the brothers to establish a corporation together.

INFORM SENIOR ATHLETES OF "CAPS"

Agencies such as the College Athletic Placement Service offer students a service to market their athletic abilities and/or sport reputations for a fee. Student/athletes must be made aware that contracting an individual or agency to represent them for compensation in collegiate placement as the recipient of athletically related financial aid would render themselves ineligible for athletics in that sport under NCAA rules. Furthermore, the NCAA member institution involved would also be penalized.

Currently, the AIAW has no rule against same, but coaches and athletic administrators should be aware of the increasing number of athletic programs are changing each year from AIAW to NCAA, or in fact hold dual membership.

MINUTES OF THE EXECUTIVE COMMITTEE MEETING

December 2, 1982

The December meeting of the Executive Committee of the California Interscholastic Federation, Southern Section, was called to order by Chairman Dr. Robert Packer at 1:35 p.m. at the CIF-SS Office in Cerritos. All members were present with the exceptions of Tony Balsamo, Sheila Burrud, Fr. Charles Hill, and Andrew Patterson.

1. **APPROVAL OF MINUTES:** It was moved, seconded and passed to approve the minutes of the October 28, 1982 meeting of the CIF Southern Section Executive Committee as mailed.

2. **PRESIDENT'S UPDATE:** Dr. Robert Packer reviewed with the Committee items of special interest from the State Federated Council meeting. In addition, Dr. Packer praised the Office staff for the smooth seeding procedure in the fall team sports, much of which was attributed to the article written by Commissioner Plutko in the October, 1982 issue of the CIF-SS Bulletin clarifying the playoff pairing procedures.

3. **COMMISSIONER'S UPDATE:** Mr. Ray Plutko apprised the Committee of the upcoming CIF Southern Section/National Athletic Health Institute Regional Athletic Injuries and Treatment workshops. Additionally, the Commissioner outlined details of a promotional advertising package for the CIF Southern Section Football Championships.

4. **BOYS' ATHLETIC DIRECTORS' UPDATE:** Mr. Clyde Francisco reported on concerns relative to scholastic eligibility requirements and the image created when coaches make unfounded charges in the press relative to their opponents.

5. **SUPERINTENDENT'S UPDATE:** Dr. Maury Ross reported on his meeting with newly elected State Superintendent of Public Instruction, Bill Hoenig.

6. **TREASURER'S UPDATE:** Mr. Bruce Keuning provided an update of the 1982-83 working budget.

7. **STATE FEDERATED COUNCIL:** (a) **SECTION RELATIONS COMMITTEE HEARINGS** — Dr. Packer reviewed with the Committee the hearing held in Visalia and the scheduled hearings in Ontario and Oakland.

(b) **STATE BY-LAW 1404** — Following discussion, it was moved, seconded and passed to deny support for the proposal which would allow Sections to establish rules and procedures for waiving restrictions relative to eighth and ninth graders taking part in spring football practice at the high school.

(c) **YMCA REQUEST — BY-LAW 604** — Following discussion, it was moved, seconded and passed to support the proposal which would allow YMCA swimmers to compete attached at the YMCA National Championship Meet.

BADMINTON AS A HIGH SCHOOL SPORT

The number of people playing Badminton has grown at a very rapid rate for the past two or three years. Its growth in popular esteem is probably as great as that of "soft ball".

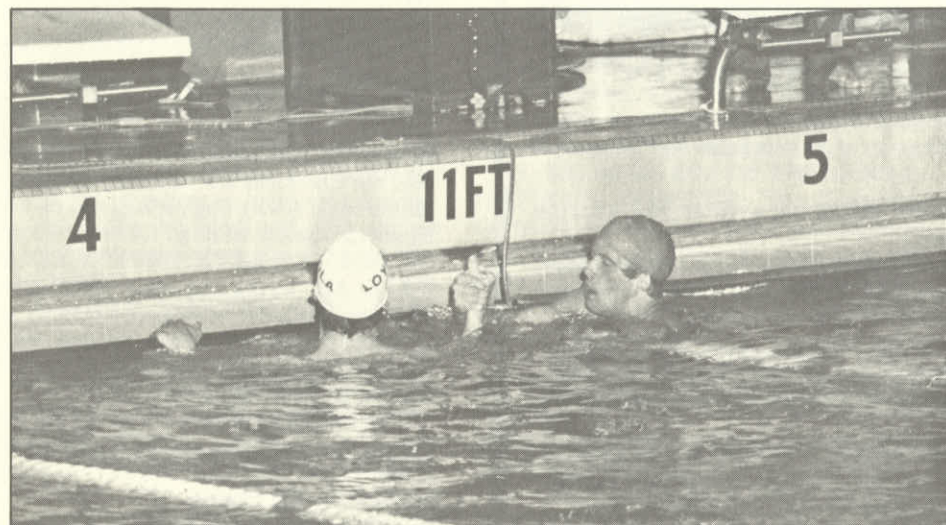
All ages and both sexes seem to enjoy the sport. It has been our privilege to note the progress of the game in one neighborhood. Two courts were established on lawns of two of the residences. Four families enter into the games with friends from other communities dropping in occasionally for games. Men, women, and children join in the sport. Grandpa in his middle sixties is quite apt to take on the grandson of twelve and the game is nip and tuck.

The game has numerous advantages among which are — (a) the equipment is not costly, (b) a large space is not required, 25' by 50' is quite ample, (c) the game may be played leisurely or with vigor, (d) speed, skill and science can be used when competition is keen.

The advantages enumerated above should all tend to popularize Badminton as a playground activity in high school, as well as for interscholastic competition.

We are ready in the C.I.F. Office to sanction any Invitational Badminton Tournament should any school request such a sanction. Should such a tournament be held we will assist in any way possible in staging the event.

8. **BASELINE LEAGUE PROPOSAL:** Mr. Glenn Fisher, principal of Upland High School, withdrew a proposal from the Baseline League which called for withdrawal by the Southern Section from participation in all regional and/or State CIF competition.

9. **STATE SANCTIONING OF CIF PLAYOFFS:** Mr. Tony Balsamo reviewed with the Council a proposal to be incorporated into the CIF Southern Section By-laws as it pertains to the addition and/or suspension of a sport as sanctioned post-

season playoff activity. This will be an action item at the January meeting of the CIF Southern Section Council.

10. **BASEBALL/SOFTBALL PROPOSAL:** Mr. Mickey McNamee, athletic director of San Marino High School, reviewed with the Council a proposal calling for restructuring of the baseball and softball post-season playoff dates for the 1983-84 school year. This will be an action item at the January meeting of the CIF Southern Section Council meeting.

11. **TRI-COUNTY LEAGUE PROPOSAL:** Mr. Mike Michael, principal of Moorpark High School, reviewed the Tri-County League proposal which would change the

JUNIOR HIGH NEWS

The Simi Valley Junior High Athletic League was formed in the Fall of 1973 as the Simi Valley Unified School District's approved governing body for interscholastic athletic competition among the district's junior high schools — Hillside, Sequoia, Sinoloa and Valley View Junior High. These schools became associated with the CIF in the Spring of 1974. During the period from 1973 until 1978 these schools fielded teams at the ninth grade freshman level and the seventh and eighth grade levels in boys' and girls' cross country, track and field, basketball, tennis, girls' volleyball and boys' wrestling.

In 1978 interscholastic competition was discontinued at the seventh and eighth grade level. The league was reorganized and a new constitution and by-laws was adopted. Girls' gymnastics was also added, and the league competition was expanded to include freshman teams from outside the Simi Valley. Girls' volleyball and boys' and girls' basketball now play an eight team home and home schedule with freshman teams from Thousand Oaks High School, Newbury Park High School, Westlake High, Alemany High and in girls' sports, La Reina High. A number of other freshman teams from both the Marmonte League schools and the Frontier League schools are regularly invited to the Christmas boys' basketball tourney, girls' basketball and volleyball tourneys, invitational relay meets and the boys' wrestling tourney.

Each junior high school recognizes and honors their athletes at two or more evening awards programs. League championships are recognized with a perpetual rotating trophy with the name of the school and the year engraved on the trophy.



CIF SOUTHERN SECTION ADMINISTRATOR HONORED BY NATIONAL FEDERATION

The National Federation has invited CIF Southern Section Administrator, Karen Hellyer to serve as a member of the National Federation Field Hockey Rules Committee. Hellyer will begin her four year term on the working committee, which writes the playing rules for high school competition throughout the United States, immediately.

Although Hellyer has been with the Southern Section staff for only one year, her long-time expertise in the sport of field hockey makes her a perfect choice for this committee. Previous to assuming her present position, she taught at University High School in Irvine where she coached hockey winning the 1981 CIF-SS Field Hockey Championship.

In addition to coaching at the high school level, Hellyer, who is a member of USFHA has been actively involved in the sport of field hockey for many years. She organized and hosted a national coaching clinic as well as a National Olympic Developmental "D" Camp. She coached selected players for the Los Angeles Field Hockey Association and for the past two years has served as a member of the National Youth Hockey Developmental Committee.

Our congratulations to Karen on her appointment. We know she'll serve us well.
