CIF-SS AWARDS PROGRAM BEGINS

The CIF-SS proudly announces the Hall of Fame Recognition Program. The official nomination forms will be sent out to all schools and media during the month of January. When asked about the new program, Commissioner Plutko indicated that, "So many have contributed to the CIF-SS over the years and yet have not qualified for the Life Pass. Their efforts have gone virtually unrecognized. We want those individuals acknowledged for all their efforts on behalf of high school athletics in the Southern Section".

Nominations for this prestigious award can be made by any school administrator or individuals of similar positions in other support organizations. Those eligible to receive awards under this new program include administrators, coaches and support personnel; such as officials, equipment personnel, trainers, members of the Media, athletic secretaries, and other.

1. Life Pass - Prerequisite to remain same as printed in the Blue Book.
2. Executive Committee - Appropriate memento upon leaving the Executive Committee, following a minimum of one full term in office.
3. Superintendent - Appropriate memento following retirement from the field of education following ten years of service with the Southern Section.
4. Principal/Site Administrator - Appropriate memento follow-

ing retirement from the field of education following ten years of service with the Southern Section.

5. Athletic Director - Appropriate memento following retirement from the field of education with a minimum of ten years of service in that position.
6. Coach - Appropriate memento following retirement from the field of education with a minimum of twenty years of service at one or combined levels.
7. Official - Appropriate memento

upon retirement following twenty years of service.

8. Support Personnel - Appropriate memento for individuals upon retirement and/or advancement from their specific field of expertise such as equipment men/women, trainers, members of the Media athletic secretaries, etc., with a minimum of ten years service.

COMMISSIONER'S CORNER



"SOLUTION
IS RIGHT
AT HAND"

This is one of those problems we can solve ourselves.

The realm of game officials assigned to work our interscholastic contests has experienced a dramatic change over the past two decades. Time was when, neither quantity nor quality were questioned.

In fact, during that era the vast majority of officials were school personnel — ranging from coaches whose sports were not in season, teachers who had retired from the coaching ranks, and administrators.

Evidently, times have changed on two fronts.

Recent surveys reveal a mere 10 percent of the officials today are from the field of education. Additionally, in select sports, there is also a shortage of qualified game administrators.

Few, if any, will debate the above. Conversely, few, if any, will admit we have perpetuated the dilemma.

As to the cause, no single response will suffice.

Often overlooked is the growth of additional high schools over the past 20 years and with it, a volley of new programs and teams.

However, without question, the major growth factor has been the emergence of the girls' athletic program — thus, virtually doubling the number of teams and needs for officials.

But, there have been other subtle factors as well.

New teaching contracts, relative to hours educators must be available on campus, has accounted for a vast decline in the number of officials for afternoon contests.

Another setback has been a change in physical education requirements for graduation, which in turn has reduced the number of P.E. majors on faculties — individuals who generally possess a broad background of expertise for a variety of officiating.

Although limited to a small percentage, we would be remiss in not men-

MINUTES OF THE CIF-SS COUNCIL MEETING September, 22, 1983

The September meeting of the CIF Southern Section Council was called to order by Dr. Robert Packer at 9:30 a.m. on Thursday, September 22, 1983 at the Saddleback Inn in Norwalk. All leagues were present with the exception of Express, Desert Inyo, and Los Padres representative.

1. APPROVAL OF MINUTES — It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of May 12, 1983 as published in the September issue of "The Bulletin;" minutes of the CIF-SS Executive Committee meeting of June 18, 1983 as published in the September issue of "The Bulletin;" and minutes of the CIF-SS Executive Committee minutes of August 27, 1983 as mailed to the Council.

2. PRESIDENT'S MESSAGE — Dr. Robert Packer introduced new Executive Committee members Warren Stephenson, vice principal, Long Beach Polytechnic High School and Father Charles Motsko, principal, Servite High School. Also introduced were members of the Council and guests.

Dr. Packer provided an overview and welcomed the entire CIF Southern Section Council to the first meeting of the new year recognizing new orientation programs for athletic administrators and stressing the importance of their role as members of the CIF Southern Section Council.

3. COMMISSIONER'S UPDATE — Mr. Ray Plutko, Commissioner, reviewed with the Council the specific programs and goals for the CIF Southern Section for the upcoming year. Commissioner Plutko also ex-

pressed the appreciation of the Southern Section to the W.R. Moody Trophy Company for the donation of league trophies which were distributed at the Council meeting.

4. NATIONAL FEDERATION UPDATE — Mr. Robert Paisola reported on the National Federation summer meeting held in Seattle.

5. TREASURER'S UPDATE — Mr. Bruce Keuning reviewed the recently completed auditor's report and reported to the Council that the findings were excellent and indicated a very optimistic outlook for the upcoming year.

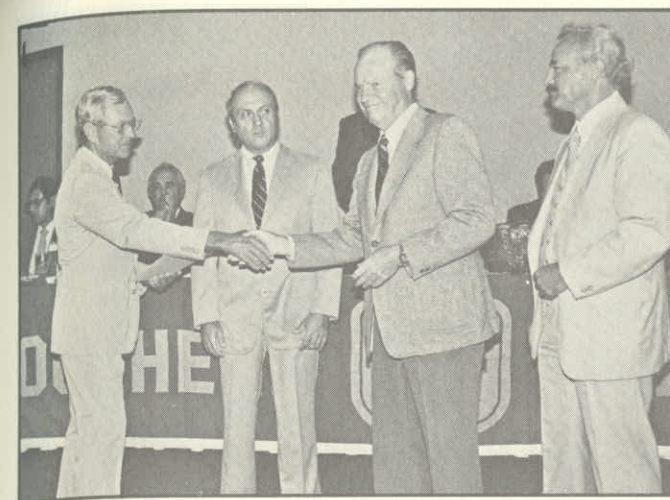
6. STATE FEDERATED COUNCIL — Mr. Tony Balsamo reviewed with the Council the governance structure of National Federation of State High School Association and how it differs from the governance of the California State Federated Council.

(a) STATE WRESTLING FORMAT — Following discussion, it was moved, seconded and passed to support the return to the original concept of a two-day State Wrestling Championship.

(b) WRESTLING WEIGH-IN PROPOSAL — Following discussion, it was moved, seconded and passed to support the wrestling weigh-in proposal.

(c) AMEND STATE BY-LAW 802 — Following discussion, it was moved, seconded and passed to send the state delegates uninstructed in regards to this amendment.

Establishing new precedents is an enjoyable task at the CIF Southern Section Office, and we are pleased to announce another "first" with the cooperation and generosity of the FRIENDS OF COLLEGE GOLF of the BEL AIR COUNTRY CLUB of Los Angeles.

The recipients of the BEL AIR gesture are the thousands of athletes participating in golf programs in high schools in the CIF Southern Section. At the present time, there are more than 200 schools actively fielding varsity golf programs, and of these schools, twenty will benefit directly with bequests in the amount of \$500.00 to each school pulled from a drawing of all golf schools. This amount will be used specifically to enhance and enlarge the golf program in the winning schools. In addition, BEL AIR COUNTRY CLUB and the FRIENDS OF COLLEGE GOLF will, through their donation to the CIF Southern Section Office, underwrite the cost of the CIF Southern Section Golf Championships conducted at six different locations throughout the Southern California area in the spring of 1984.

The FRIENDS OF COLLEGE GOLF of BEL AIR COUNTRY CLUB is an organization formed just two years ago to help fund a golf program at UCLA. In that short span of time, over 400 contributors from around the world have worked to build the golf program at UCLA into one of the top ranked in the ratings.

Under the able leadership of Mr. John Anderson, president of the group, the FRIENDS OF COLLEGE GOLF easily achieved their goal at UCLA and then directed their ef-



forts to include promotion of the sport of golf at the high school level, and the CIF Southern Section is the beneficiary of their fine efforts. Mr. Eddie Merrins, Golf Pro at Bel Air and Varsity Golf Coach at UCLA assists Mr. Anderson and the CIF Southern Section with this program.

tioning incidents involving a lack of sportsmanship on the part of crowds and/or coaches. These in turn have caused some to have "second thoughts" on becoming an official.

But, what about a solution?

Ironically, we have to travel to further than our respective high school campuses for the answer.

At the conclusion of sport seasons each year, coaches meet with seniors as to their future plans — only a small percentage who will make the transition to collegiate athletics.

But, what of those students who would like to remain associated with a particular sport?

Few, if any, are aware they can become an official upon

graduation, not only meeting their initial goal but providing a source of income at the same time. The latter would be particularly true if they are working their way through college at the same time.

It seems a little added counseling, complete with a hand-out sheet as to who to contact, would be fitting indeed at the end of this season.

If each coach in the CIF Southern Section would entice just one student/athlete to become an official, there would be 467 more officials available next season . . .

. . . that is 467 multiplied by 25 (each sport offered for boys and girls) for grand total of 11,675 new faces!

Seems as though we have the solution right at hand.

7. SUNSET LEAGUE OFFICIALS' FEE ADJUSTMENT — Mr. David Hagen reviewed with the Council a proposal calling for an amendment to Article 12, Section 1218 of the Southern Section By-Laws which calls for an official working alone to receive one-half of the absent official's fee.

After discussion, it was moved, seconded and passed to refer item to the Official Fee's Committee for review. Report and/or recommendation of the Committee will be made at the January Council meeting.

8. SEAVIEW LEGUE STATE PLAYOFF PROPOSAL — Mr. Dennis Evans reviewed with the Council a proposal for the Southern Section to withdraw from regional and state playoffs for boys' and girls' in the sport of basketball. This will be an action item at the January CIF Southern Section Council meeting.

9. CENTURY LEAGUE WATER POLO PROPOSAL — Mr. Jim Turner, reviewed with the Council a proposal calling for an amendment to Article 20, Section 2008 of the Southern Section By-Laws which allows a representative from a school to be a coach or administrate a non-school sponsored team with youngsters who have remaining eligibility at the school after May 1, and following a schools last competition in the season. This will be an action item at the January CIF Southern Section Council meeting.

10. GOLF FOUNDATION PROGRAM — Commissioner Ray Plutko introduced Ed Merrins, Arthur Kelly, Dr. David Bosko and Larry Marion, who explained the Golf Foundation Program as it relates to high school golf programs. At the Council meeting, \$10,000 was donated to 20 CIF Southern Section schools (\$500 each) to promote high school golf. The 20 schools picked at random were Montebello, Orange-Lutheran, Magnolia, Corona del Mar, Azusa, Carpinteria, Glendale, Hoover, South Pasadena, South Torrance, Covina, Thousand Oaks, Glendora, Nogales, Yucca Valley, Big Bear, Rolling Hills, St. Joseph (Santa Maria), Twentynine Palms and Murphy High School. It is hoped this program will continue in the future. Previous winners will be ineligible for selection each succeeding year.

11. RELEAGUING PROPOSAL FOR 1984-86 — Mr. Fernando Ledesma, Chairman of the Releaguings Committee, presented the respective releaguings proposals for the 1984-86 school years. Following discussion, it was moved, seconded and passed to accept the alternate proposal for the Coast and Private areas. Following further discussion, it was moved, seconded and passed to accept the original proposal for the Desert, Foothill, Mt. Sac, Orange County, San Gabriel and Parochial areas. In

TOURNAMENT BASKETBALL IN SOUTHERN CALIFORNIA

Basketball in Southern California has made rapid strides in the past ten years. Few schools had gymnasiums up to the year 1925 and many games were played outside. With the addition of basketball floors in the newly built gymnasiums the game took on a new interest and the past decade has seen Southern California come to the front in this sport.

In comparison with other states in this sport, we will find Southern California using many of the styles of play found in the east and midwest. The fast break game, the delayed offense combined with the man to man and zone defense have all become as much a part of basketball in this section as anywhere that the game is highly regarded.

Tall, rangy boys are found in the high school ranks of this section and many of them that have come up through high school have made good in college basketball. It has been noticeable that high school boys copy the form or style of some particular basketball star in college or university and there is no question that Hank Luisetti exerted a tremendous influence during his stay at Stanford University. His one hand push shots combined with his splendid timing and co-ordination made him the idol of every high school boy in the state.

Tournament play is quite lacking in this section. Invitational tourneys have become annual affairs in some four or five schools and have been conducted very efficiently. Instead of being held at the close of the league season they are staged at the holiday vacation and some teams use them as a means of getting practice instead of attempting to point for honors. An attempt was made some years ago on the part of the CIF to hold a tournament to decide the Class A championship. Interest was good in this initial attempt but it was not a financial success.

Climatic conditions here do not place the emphasis on basketball as an indoor game that is seen in the midwest and east. Outdoor activities in this section will make it difficult to create the interest necessary to make tournament play a financial success. Transportation problems must be ironed out and a central gymnasium selected in which to hold the final round, that will accommodate a large crowd. Sport scribes are none too cordial to basketball publicity and they might give more space to the game itself if some movement was started to bring it to the front. It has always been a general belief among coaches in this section, that if the Los Angeles City schools were permitted to have a part in tournament play for

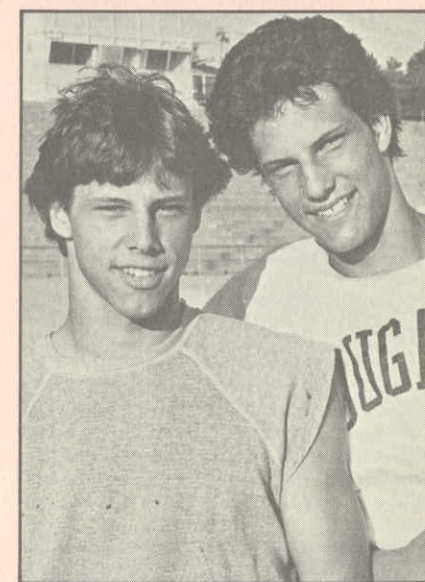
EDITOR'S NOTE: In an effort to give well-deserved recognition to Southern Section athletes, this is the first in the 1983-84 series of articles featuring "all-around student-athletes".

On Friday, October 21 Buena and Ventura high football teams faced each other in a traditional cross-town rivalry, while there is nothing unusual in that, the fact both the starting quarterbacks and one of the assistant coaches was named FORTIN made this one a highly uncommon game.

The youngest member of this Fortin trio is Roman, a junior at Ventura High School. In his second year at starting quarterback, Roman is described by his coach as an outstanding athlete, very outgoing and socially oriented. A very popular student at school, Roman can also lay claim to being an honor student.

Lance Fortin is a senior and starting quarterback at Buena High School. In his third year on the team, Lance is also spoken of very highly by his coach. Apart from football he is very active in school government at Buena. He is an honor student and was recently named "Boy of the Quarter".

Off campus both boys are directors of the "Christian Fellowship of Athletes",



an organization which meets at the Fortin home and has several members of each football team as part of the group.

Dr. Bob Fortin, the boys' father, is also very active in athletics. Last year he coached football at Buena and is currently coaching at Ventura High School.

The CIF Southern Section salutes both Lance and Roman Fortin - they are fine examples of the dedicated student-athletes involved in interscholastic athletics - "THE OTHER HALF OF EDUCATION".

the Southern California championship, it would be an easy matter to build up a fine tournament.

Southern California can be divided into regions and sections the same as other states and bring eight finalists into Los Angeles to meet eight Los Angeles schools. That should attract more interest than is now shown in the present manner of allowing only league winners to play off for the Southern California title. Many teams improve in their play after their league competition and are better in tournament play than in league competition. It is well that some of the teams get away from the same competition each year and meet other teams outside their league. It broadens the scope of basketball activity and is a progressive idea. The boys will enjoy the change and will look forward to tournament play each season as a climax to the season of that sport.

Teams in the midwest would find real competition from such western schools as

Piedmont, Whittier and Santa Rosa where basketball has become highly developed. Both Indiana and Illinois have brought splendid teams to the front but California basketball teams can match them in height, speed and shooting ability. The one hand push shot has been far more developed here than in the east. Teams here are employing better defensive tactics than they were five years ago. Officiating is better and more uniform than ever before. Many new gymnasiums are being built in this section that will encourage more interest in basketball and the game is bound to gain in prominence. Competition is very keen here in Los Angeles City leagues as well as in all of the major leagues of the CIF-SS. Chaffey, Long Beach Poly and Whittier have led in taking the most titles in the Class A division the past ten years.

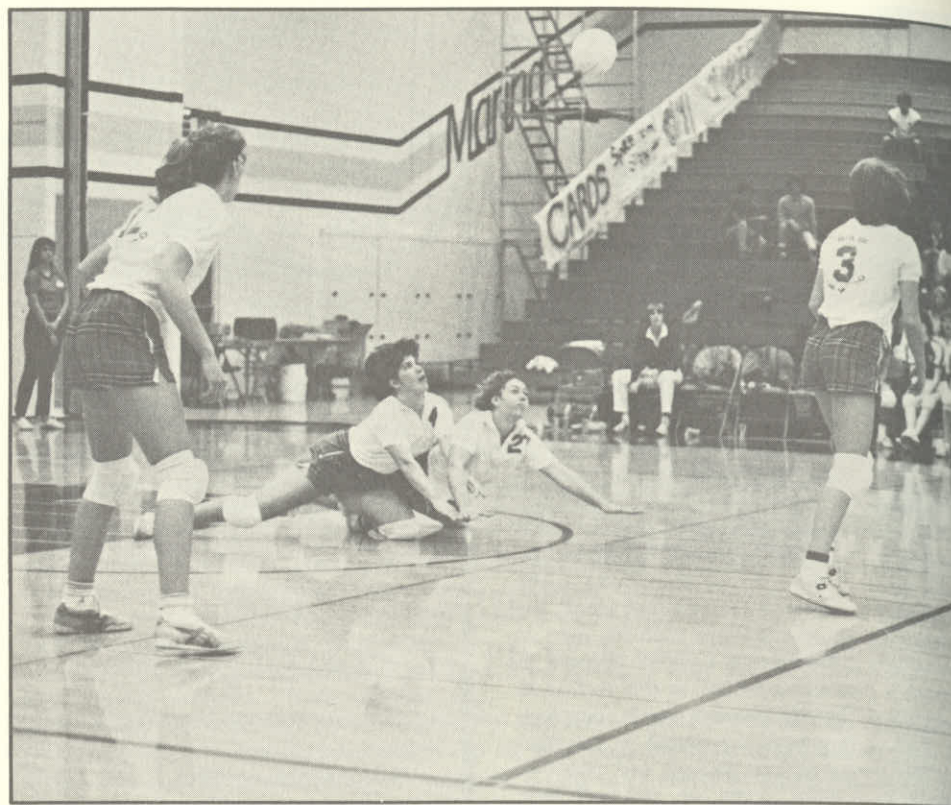
A well organized championship tournament among Southern California high schools should be a success.

MINUTES OF CIF-SS EXECUTIVE COMMITTEE MEETING
October 27, 1983

The October meeting of the Executive Committee of the California Interscholastic Federation, Southern Section was called to order by Chairman Dr. Robert Packer at 1:25 p.m. on Thursday, October 27, 1983 at the CIF-SS Office in Cerritos. All members were present with the exception of Tony Balsamo and Andy Patterson.

1. **PRESIDENT'S UPDATE** — Dr. Robert Packer introduced new Executive Committee member, Rev. Charles Motsko, principal of Servite High School, who was appointed to fill the vacant position of Rev. Charles Hill, on leave from Pius X High School to study in Rome. A warm welcome back was also extended to Pat Mauch, principal of Los Altos High School, who was seriously injured in an accident in August.

2. **COMMISSIONER'S UPDATE** — Mr. Ray Plutko, Commissioner, reported on the very positive response received by the Office on the "New Principal's and Athletic Director's Orientation Program." In addition, Commissioner Plutko updated the Committee on his league visitation plans for the current school year, corporate funding and a planned activity in the spring honoring all CIF Southern Section corporate sponsors. Also reviewed was the continued effort of the Office to promote the interscholastic athletic program.

3. **BOYS' ATHLETIC DIRECTORS' UPDATE** — Mr. Mike Moropoulos, Boys' Athletic Director Representative, reported on concerns relative to walk-on coaches and programs of certification which seemed to lack adequate information relative to league, Section and State rules and regulations. He also reported on the current shortage of qualified athletic officials and the importance of coaches and athletic directors to continue their efforts in recruiting young officials from former players.

4. **GIRLS' ATHLETIC DIRECTORS' UPDATE** — Sheila Burrud, Girls' Athletic Director Representative, reported on the importance of leagues alternating playing dates due to the shortage of officials in Girls' sports.

5. **SUPERINTENDENT'S UPDATE** — Cynthia Grennan, Superintendent's Representative, reported on the positive feedback received relative to the symposium and orientation programs conducted by the CIF Southern Section.

6. **TREASURER'S REPORT** — Mr. Bruce Keuning reviewed with the Committee the current status of the CIF Southern Section working budget and the cooperation of member schools in submitting their yearly dues.

7. **STATE FEDERATED COUNCIL REPORT** — Mr. Moe Chavez reported on the State Federated Council meeting held on

October 21-22, 1983, covering background information on the report of the Section Relations Committee; a revision of State By-Law 404; passage of State By-Law 802 increasing the current award allowance; in order to preserve the tax exempt status of the State organization, a change in language in the State Constitution was approved; and the proposal relative to a change in weigh-in procedures and a return to the original concept of a two-day wrestling championship for the present school year was approved by the State body. A proposal that live network and/or cable network telecast of an athletic contest that crosses section lines, be approved by the State Media and Promotions Committee was defeated.

8. **NATIONAL FEDERATION REPORT** — Dr. Packer and Commissioner Plutko reported on the National Federation Region VII and VII meeting held in Portland, Oregon. Specific areas covered were the composition of the Executive Committee at the National level, input relative to lead-time when changes are made in National Federation playing rules and regulations, and the comparison of notes relative to State Office procedures and how they function.

9. **MIRA COSTA HIGH SCHOOL BASKETBALL APPEAL** — It was moved, seconded and passed to approve an appeal from Mira Costa High School relative to an adjustment in a tournament playing date.

10. **MIRALESTE HIGH SCHOOL REVIEW** — It was moved, seconded and passed to recommend an additional option be made available to the principal of Miraleste High School in the designating of four games the school's basketball coach may not take part in coaching duties due to a violation of CIF Southern Section Rules and Regulations during the 1983 playoffs.

11. **SANTA BARBARA PARTICIPATION FEES CASE** — Mr. Robert Paisola updated the Committee on the status of the Santa Barbara participation fees case, which was heard by the State Supreme Court. A written decision is expected in two or three months.

12. **PLAYOFF BYE PROCEDURE** — Commissioner Plutko reviewed with the Committee the Office procedures and communication to member schools relative to filling byes in the brackets for team sports in the Section playoffs.

13. **NEW SCHOOL MEMBERSHIP** — It was the decision of the Committee to table the application for membership of Oak Pines High School in Idyllwild until such time as more information is available.

14. **GOLF PLAYOFF CALENDAR** — It was moved, seconded and passed to adjust

MINUTES OF EXECUTIVE COMMITTEE
December 1, 1983

The December meeting of the Executive Committee of the California Interscholastic Federation, Southern Section, was called to order by Chairman Dr. Robert Packer at 1:30 p.m. on Thursday, December 1, 1983 at the CIF Southern Section Office in Cerritos. All members were present with the exception of Blinn Tenney.

1. **MINUTES** — It was moved, seconded and passed to approve the minutes of October 27, 1983 meeting of the CIF Southern Section Executive Committee as mailed.

2. **COMMISSIONER'S UPDATE** — Mr. Ray Plutko reviewed with the Committee the fall playoffs; TV coverage of the upcoming BIG FIVE football championship contest; concerns relative to undue influence; unethical conduct on the part of coaches and others and the need for all members of this organization to review the Code of Ethics and Sportsmanship. In addition, Commissioner Plutko updated the Committee on his league visitations and input from Bill Moody regarding the CIF-SS awards program. Commissioner Plutko also shared his concerns with the Committee regarding the upcoming football championships at Anaheim Stadium and problems facing the office staff should it rain the weekend of the football finals. This could cause cancellation of our contract with the City of Anaheim for the use of the stadium, due to current NFL regulations.

3. **GIRLS' A.D. UPDATE** — Ms. Sheila Burrud reported on the positive response received relative to the awards program sponsored by the W.R. Moody Company.

4. **SUPERINTENDENT'S UPDATE** — Ms. Cynthia Grennan, Superintendent's representative, reminded members of the Executive Committee to continue to promote the high school athletic program through the issuing of league passes to all Board members, and the importance of Principals informing their respective Boards about the CIF and its activities. Ms. Grennan also reported to the Committee activities of the District Legislative Committee and reviewed upcoming legislation.

5. **TREASURER'S REPORT** — Mr. Bruce Keuning provided an update of the 1983-84 working budget.

6. **STATE FEDERATED COUNCIL** — Dr. Packer covered background information on the report of the State Section Relations Committee, and Moe Chavez reported on the passage of an amendment to State By-Law 802 and the award allowance. The change is as follows, effective July 1, 1984:

"A high-school student may not receive from any source an athletic award for CIF high-school competition in any individual tournament of more than twenty

dollars (\$20) in value. For League championships the awards will be a maximum of fifty dollars (\$50) in value. In the event a high-school student accepts an athletic award above the value stated, the student becomes ineligible for further high-school athletics and shall be penalized according to rule 400. The twenty dollars (\$20) or fifty dollar (\$50) value for the individual award is the actual cost of the item, exclusive of engraving. Such award cannot be cash, a gift certificate, or merchandise alone. It may be merchandise, badge, medal, plaque, ribbon, picture, certificate or trophy, if it is suitably engraved or identified as an award. CIF sections may permit an award of not more than \$100 in value to students who are members of CIF section championship teams."

7. **RIVERSIDE POLY HIGH SCHOOL REVIEW** — Mr. Joe Rile, Principle of Riverside Poly High School and Dr. Charles Beaty, Principal of John W. North High School in Riverside and Ivy League President for the 1982-83 school year, appeared before the Executive Committee relative to the use of a possible ineligible player in basketball during the 1982-83 season.

Following a review of the matter, it was moved, seconded and passed to declare all games forfeited in which the ineligible player participated prior to gaining full eligibility status on February 18, 1983. Additionally, the Committee directed the league to review the playoff status of Riverside Poly for the past 1982-83 season.

8. **PERRIS HIGH SCHOOL REVIEW** — Dr. Horace Jackson, Principal; James Coming, A.D.; and Head Football Coach Joe Smith appeared before the Executive Committee relative to an alleged breach of the CIF Southern Section Code of Ethics during the football playoffs. Following its review of the incident, the Executive Committee directed that a letter of official censure for actions unethical in nature involving the scouting of a playoff opponent in football be sent to the Principal of Perris High School. Additionally, Perris High School will be placed on probation for a period of one year.

It was further pointed out that the booster club is an extension of the school, one of which the school is responsible, and the Executive Committee further specified that an orientation program be conducted with the coaching staff and booster club as to the parameters from which they can operate in their respective spheres of influence while representing the school.

9. **NEW MEMBERSHIP** — It was moved, seconded and passed to deny membership to Oak Pine School in Idyllwild, California.

10. **LEGISLATIVE UPDATE** — Cynthia Grennan and Commissioner Plutko reviewed with the Committee the emergency walk-on coach's certification program which sunsets in June, 1984. Concern was expressed that there is no formal direction being taken at the present time by the State Legislature to extend the bill. Following discussion, the Commissioner and members of the Executive Committee will be contacting the State CIF Legislative Committee with their concerns and ask that that body take formal position for extension of the bill.

11. **PLAYOFF OBLIGATIONS** — Commissioner Plutko reviewed with the Committee violations of playoff commitments during the girls' team tennis playoffs by Corvallis High School and Marymount High School. Following discussion, it was moved, seconded and passed that Corvallis High School and Marymount High School not be eligible for the girls' team tennis playoffs for the 1984-85 season, should they so qualify.

There being no further business to come before the Executive Committee, the meeting was adjourned at 5:30 p.m.

All candidates will be judged on their significant and/or long term contribution to interscholastic athletics. Nominees must exemplify the highest standards of sportsmanship, ethical conduct, moral character and carry the endorsement of their league or association where appropriate. Once nominees are inducted, they will be recognized as members of the CIF-SS "Recognition Hall of Fame".

We would like to encourage everyone to get involved. There must be someone in your school or support organization that would qualify for this award. All ballots must be received by March 1 for consideration this spring. Nominees will be screened by the CIF-SS Office and the Life Pass Committee. The awards will be presented at the spring Council Meeting or other appropriate local school or community ceremonies.

Commissioner Plutko added that "Eventually, we hope to develop a Hall of Fame room located at the CIF-SS Office so all award winners will be permanently on display".
