PLAYOFF GROUPINGS TO BE DECIDED

It's time once again for the CIF Southern Section to issue its recommendations as to your league's divisional placement (Big Five, 4A, 3A, 2A, 1A, Small Schools) for the 1986-88 school years.

In case you've been curious as to the process used for assigning your league to a particular grouping, here's how it works: First, since leagues (not schools) regrouped into playoff divisions, a communication will be sent in early January from the CIF-SS Office to your league to submit suggestions or ideas to the CIF-SS Office no later than March 1, 1986. The Southern Section then uses these recommendations to develop an overall grouping in each sport division as an office recommendation back to your league.

At this juncture, those leagues objecting to their

divisional placement are given the opportunity to appeal in writing to the Playoff Groupings Committee. Note leagues are given the appeals option only if they previously recommended changes or if they have been changed from their present status.

Early in April, the final recommendation of the Playoff Groupings Committee will be mailed to League Representatives.

Final disposition in playoff groupings will take place at the last meeting of the CIF-SS Council in May. Leagues which appeared in April that are still dissatisfied may forward a written appeal to the Commissioner's Office asking for time on the Council agenda.

As a separate item, we bring to your attention a directive

COMMISSIONER'S CORNER



TIMES MAY HAVE CHANGED

Times may have changed, but this question is still deserving of the same answer.

A few years back, a query was posed by a member of the Media as to the most difficult of situations encountered in my role as Commissioner. The ensuing reflective response seemed more than appropriate at the time but ironically, the identical question repeated itself within the past week.

Needless to say, with time some responses necessitate a slightly different slant or inflection, but in this particular instance, it remained identical.

The most serious of violations?

Recently, a member of the Media raised the question as to what the CIF Southern Section Office considers to be the most serious of situations in dealing with member schools.

My immediate response was that the query would draw a command performance if seeking the most positive aspects derived in working with our constituency of administrators and coaches.

However, that would be side-stepping the question.

When one considers the myriad of beneficial activities which take place on the 500 campuses each day, it's unfortunate that a mere sampling reaches the respective communities served.

Needless to say, the sampling is critical in terms of accountability.

All-too-often, the majority are associated with the actions of just a few. As a result, the process begins anew of rebuilding the countless hours of dedicated service provided by those committed to the ideals of interscholastic athletics.

Without question, the most serious breach within the realm of our programs presents itself when an individual coach removes a team from the playing facility prior to the conclusion of a contest.

MINUTES OF THE CIF-SS COUNCIL MEETING September 26, 1985

The September meeting of the CIF Southern Section Council was called to order by President Moe Chavez at 9:30 a.m. on Thursday, September 26, 1985 at the Ramada Inn in Norwalk. All leagues were present with the exception of the Baseline, Hi-Lo, and All-Girls.

1. **APPROVAL OF MINUTES** - It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of May 9, 1985 as published in the September issue of the CIF-SS *Bulletin*; minutes of the CIF-SS Executive Committee meeting of June 22, 1985 as published in the September issue of the CIF-SS *Bulletin*; and minutes of the CIF-SS Executive Committee meeting of August 24, 1985, as mailed to the Council.

2. **PRESIDENT'S UPDATE** - Mr. Moe Chavez introduced new Executive Committee member Jim Carmichael of Antelope Valley High School, appointed to fill the vacant position of Mr. Blinn Tenney who recently retired.

Mr. Chavez welcomed the Council representatives to the first meeting of the year, reviewing the purpose and role of Council representatives and stressed their responsibility to stimulate communication at all levels within their scope. Additionally, the CIF-SS Office staff was praised for the publication of the new *Athletic Administration* and *Sports Preview*, and special recognition was paid to Scott Cathcart, Media and Public Relations Director, for his outstanding work.

3. **COMMISSIONER'S UPDATE** - Commissioner Ray Plutko welcomed the Council to

this, the 73rd year of the organization, while highlighting this year's goals and objectives and the special emphasis on the creation of an awareness in the areas of legal and liability responsibilities. Also noted were an overview for the upcoming year, Athletic Administrators Symposium, Superintendent and Board Member Symposium set for April, the regional coaches workshops, an upcoming survey dealing with all aspects of eligibility rules and regulations, work on the three-year study of the state of athletics in the CIF Southern Section, corporate support, the use of eligibility cards in cutting down the number of forfeitures at the school site level, and resource material on chemical and alcohol awareness now being made available to member schools.

4. **NATIONAL FEDERATION UPDATE** - Mr. Lon Hardgrave provided an overview of the National Federation summer meeting held in Lexington, Kentucky as it related to trends in the area of interscholastic athletics throughout the United States; due process of athletes; chemical awareness; certification of walk-on coaches; and problems with the eligibility of foreign students.

5. **TREASURER'S UPDATE** - Mr. Bruce Keuning, treasurer, reviewed the recently completed auditors' report, the findings of which reflected an excellent checks and balance system and a surplus resulting from the 1984-85 school year. Additionally, Mr. Keuning provided an update on the 1985-86 working budget.

from the CIF-SS Executive Committee which will create an additional grouping in some sports in the Small Schools Division in order that leagues with very small enrollment should not be placed in a grouping with leagues of far greater enrollment.

Overall, placement for leagues in the Southern Section is based on both average enrollment and success within a playoff grouping, particularly if it appears that a given school or league might perpetuate dominance. Additionally, placement could change based upon movement of schools from one league to another, which may alter the overall strength of a league.

Ironically, the justification invariably lacks substance at a subsequent hearing – personal dissatisfaction with an official or the citing of dangerous conditions is the usual tenor of that thrust.

It is also paradoxical that such action is spawned by the individual coach on the short end of the score at the time.

How serious is such an action?

It has been the position of the CIF-SS Executive Committee to expect the building principal of the school concerned to relieve the coach from his/her assignment for the balance of that season.

When one considers the focal point is to involve as many student-athletes in our programs as possible, we lack accountability to those considered the heart of our organization – not to mention the officials, the entire student body, the district and the community.

Each individual contest, regardless of the sport, lasts but a few minutes. The damaging results from such an occurrence are timeless.

Administrators are urged to review this aspect and the potential consequences with their staffs at the start of each sport season . . .

. . . it takes but a few minutes.

MINUTES OF EXECUTIVE COMMITTEE MEETING October 23, 1985

A meeting of the CIF Southern Section Executive Committee was held on Wednesday, October 23, 1985 at the CIF Southern Section Office. President Moe Chavez called the meeting to order at 1:25 p.m., and all members were present with the exception of Bruce Keuning, Tony Balsamo and Andy Patterson.

1. **PRESIDENT'S UPDATE** – Mr. Moe Chavez commended the CIF Southern Section Office Staff for its continued efforts in keeping school personnel informed as to activities within the Section. He also commented on the positive response of the goals and objectives of the organization as submitted to the Council.

2. **COMMISSIONER'S UPDATE** – Mr. Ray Plutko, Commissioner, reviewed with the Committee the on-going services of the CIF Southern Section to member schools, highlighting the Athletic Administrators Symposium, the Regional Area Coaches Workshops, and the Superintendent/Board Member Symposium set for April.

3. **BOYS' ATHLETIC DIRECTOR UPDATE** – Mr. Mike Moropoulos, Boys A.D. representative, discussed the positive comments regarding communication from the CIF Southern Section Office and the various workshops and symposiums that have been conducted by the staff. Mr. Moropoulos pointed out that there is an on-going concern among athletic directors regarding the recruitment of officials for both boys and girls athletic contests.

4. **GIRLS' ATHLETIC DIRECTOR UPDATE** – Ms. Sheila Burrud, Girls A.D. representative, discussed the importance of athletic safety checks at the school site. This would include facilities and equipment.

5. **SUPERINTENDENTS' UPDATE** – Ms. Cynthia Grennan apprised the Committee that the walk-on coach handbook as published by the Anaheim Union High School District and the tape, "You Have A Duty," is available for use by all member schools. Additionally she reviewed current legislation dealing with walk-on coaches, academic eligibility standards, and an on-going concern of superintendents relative to the continued increase in liability coverage.

6. **TREASURER'S REPORT** – Commissioner Plutko reviewed the report of Treasurer Bruce Keuning on the current status of the CIF-SS working budget and the cooperation of member

schools in submitting their dues.

7. **STATE REPORT** – Dr. Robert Packer reviewed background information relative to the agenda of the State CIF Federated Council meeting, scheduled for October 25-26 in San Jose.

8. **NATIONAL FEDERATION SECTION VII/VIII REPORT** – Mr. Moe Chavez reported on the National Federation Section VII/VIII meeting as it related to trends in the area of interscholastic athletics. These included student catastrophic insurance, liability concerns, corporate sponsorship, eligibility, and television and computer utilization.

9. **CIF SOUTHERN SECTION PARTICIPANT LIABILITY** – Commissioner Plutko reviewed with the Committee the various liability coverage packages of State and CIF Southern Section activities.

10. **BALDWIN PARK RELEAGUING CORRESPONDENCE** – Mr. Pat Mauch updated the Committee on background correspondence relative to concerns of Baldwin Park High School's placement in the Sierra League for the 1986-88 relegating cycle. The Commissioner was instructed to prepare the response along the guidelines presented.

11. **OFFICIALS AD HOC REVIEW** – Mr. Bill Clark, Administrator, reviewed the meeting of the Executive Ad Hoc Officials Committee. The Committee felt that the Southern Section emphasis should be on the recruitment of new officials, assisting officials associations with their organizational structure, training and evaluation of officials, with an annual report to be submitted from each officials association serving the Southern Section as to their operation and implementation of recommendations. It was recommended this information become part of the agenda of the CIF-SS Officials Committee.

12. **REVIEW OF ELIGIBILITY STANDARDS** – Commissioner Plutko reviewed with the Committee the overall plan and timeline for a review and possible update of existing eligibility standards by member leagues which will be presented to the Blue Book Committee for its consideration and review. The plan calls for appropriate proposals to be made to the CIF-SS Council.

13. **MIRALESTE HIGH SCHOOL APPEAL** – Mr. James Hanson, girls' varsity tennis coach of Miraleste High School, presented an appeal to the Executive Committee pertaining to the

dates for the finals of the girls' team tennis championships. Following discussion, a motion to approve the appeal failed to carry the necessary majority.

14. **NEW MEMBERSHIP** – It was moved, seconded and passed to approve the membership of Bible Missionary of Santee, with the provision that if the school should qualify for playoffs, due to their location in San Diego County, it would be designated as the visiting team in all playoff contests.

15. **REVIEW OF CORRECTIVE ACTION** – The CIF Executive Committee approved respective cases handled by the Commissioner of the CIF Southern Section as they pertain to violation of rules and regulations with the corrective action taken in closing out the particular situations.

ADMINISTRATIVE ACTION (August 26-October 22, 1985)

CASE #1:

The Commissioner approved closure of a violation with respect to the starting of football conditioning practice one day early. Action taken included the canceling of one day of scheduled practice; attendance by football staff members at the CIF-SS Fall Coaches' Orientation Workshop; development of a school orientation program for staff members prior to the start of the 1986 fall term; and notation in the school file.

CASE #2:

The Commissioner approved closure of a violation with respect to the use of an ineligible athlete. Action taken included the forfeiture of all contests in which the student participated; review of past administrative procedures as they pertain to eligibility clearance and refinement, where appropriate and the implementation of the CIF-SS "Eligibility Clearance Cards"; attendance at the Athletic Administrator's Symposium; and notation in the school file.

CASE #3:

The Commissioner approved closure of a scheduling violation with respect to Rule 1802 (organized team practice). Action taken included adjustment of the scheduled class period; development of a school orientation program for walk-on coaches prior to the start of the 1986 fall term; attendance by the varsity basketball coaches at the CIF-SS Winter Orientation Meeting; and notation in the school file.

MINUTES OF CIF-SS EXECUTIVE COMMITTEE MEETING December 5, 1985

A meeting of the CIF Southern Section Executive Committee was held on Thursday, December 5, 1985 at the CIF Southern Section Office. President Moe Chavez called the meeting to order at 1:20 p.m., and all members were present with the exception of Sheila Burrud.

1. **APPROVAL OF MINUTES** – It was moved, seconded and passed to approve the minutes of the CIF Southern Section Executive Committee Meeting of October 23, 1985 as mailed.

2. **PRESIDENT'S UPDATE** – President Moe Chavez commended the office staff for the smooth seeding procedure in the fall team sports and the recently conducted championships in the sports of cross country, tennis, volleyball and water polo.

3. **COMMISSIONER'S UPDATE** – Commissioner Ray Plutko reviewed with the Committee the upcoming football championships, the newly-instituted reserve fund, the increase of eligibility appeals, the Hall of Fame Recognition Program, the successful winter orientation workshops for coaches, and the decrease in contest forfeitures due to the use by member schools of the eligibility cards. Additionally, he updated the Committee on a ticket promotion in conjunction with KFI Radio for the football championships and the recently completed Press Guide and Record Book at a cost savings of over \$5,000 by use of the computer and in-house processing.

4. **BOYS' ATHLETIC DIRECTORS UPDATE** – Mr. Mike Moropoulos updated the Committee on the National Athletic Directors Conference to be held in Anaheim in December.

5. **SUPERINTENDENTS' UPDATE** – Ms. Cynthia Grennan reviewed with the Committee the on-going work of the State Legislative

Committee, focusing on Senate Bill 19. Additionally, she reviewed the spring Symposium for Superintendents and Board Members which will be held on Tuesday, April 15, and the importance of establishing a communication base with Board members throughout the Southern Section by way of CIF-SS courtesy passes beginning with the 1986-87 school year.

6. **TREASURER'S UPDATE** – Mr. Bruce Keuning, Treasurer, provided an update of the 1985-86 working budget and the fall playoff incomes. Additionally he apprised the Committee on the cooperation of member schools in submitting their annual dues.

7. **STATE REPORT** – (A) Sac Joaquin Section – Mr. Tony Balsamo reviewed with the Committee recent correspondence from the California School Boards Association with reference to representation in the Sac Joaquin Section.

(B) State By-law 306 – Following discussion, it was moved, seconded and passed to recommend to the CIF-SS Council at the January meeting, an affirmative vote on this issue dealing with athletic physicals.

(C) State Track Event – Following discussion, it was moved, seconded and passed to recommend to the Council at their January meeting, it *not* support the inclusion of the heptathlon and decathlon as part of this year's State Track Meet.

(D) Liability insurance – Mr. Tony Balsamo reviewed with the Committee a proposal from the Reudlinger Company to the State CIF regarding athletic liability insurance.

8. **LEGAL UPDATE** – Commissioner Plutko and attorney Andy Patterson reviewed with the Committee pending litigation, appeals

hearing protocol and state appeals representation.

9. **WRESTLING COMMUNICATION** – Mr. Bill Clark, Administrator, reviewed communication from Dr. Joseph G. Ouslander relative to the importance of the upkeep, cleanliness and sanitation of wrestling mats.

10. **CATHEDRAL HIGH SCHOOL COMMUNICATION** – Commissioner Plutko reviewed with the Committee a letter from Cathedral High School, with reference to a recent decision by the Archdiocese that the school will now remain open and not close as previously announced. Specific guidelines were established with reference to the acceptance of ninth grade students entering Cathedral HS beginning in January of 1986.

11. **HERZL HIGH SCHOOL BASKETBALL REQUEST** – Mr. Dean Crowley, Administrator, presented a request from Herzl High School to participate in a basketball tournament out of state during March, 1986. Following discussion, it was moved, seconded and passed to approve the request for the 1985-86 season only.

12. REVIEW OF CIF-SS OFFICE ADMINISTRATIVE ACTION OF VIOLATORS (October 23-December 5, 1985)

In keeping with procedures adopted by the CIF Southern Section Executive Committee, the items below require review and approval, then becoming part of the official minutes for accountability to the member schools.

SITUATION #11:

The Commissioner approved closure of a one-day violation with respect to Rule 310 (Association Rule) in the sport of basketball. Action taken included the cancelling of the opening day of scheduled

6. **STATE FEDERATED COUNCIL UPDATE** – Dr. Robert Packer reviewed with the Council items pertaining to the working operation of the State Federated Council for the 1985-86 school year.

7. **TRI-VALLEY LEAGUE DISCUS PROPOSAL** – Mr. David McCullough, representative of the Tri-Valley League, presented a proposal calling for consideration of the discus throw as a CIF-SS championship event to be conducted at the CIF-SS divisional and masters qualifying meets. This will be an action item at the January meeting of the CIF-SS Council.

8. **"R AND R" WEEK GUIDELINES PROPOSAL** – Mr. Pat Mauch, Chairperson of the CIF-SS Season of Sport Committee, presented the By-Law wording as to the working guidelines for the approved 1986-87 season of sport calendar which reflects a week of "R and R" (rest and recreation) between each season of sport. This will be an action item at the January meeting of the CIF Southern Section Council.

9. **NORTHERN LEAGUE BOYS' TENNIS PROPOSAL** – Mr. Bob Paisola, representative of the Northern League, presented a proposal calling for a change in the playoff format of singles and doubles competition in boys' tennis. This will be an action item at the January meeting of the CIF-SS Council.

10. **SEA VIEW LEAGUE RESIDENCE PROPOSAL** – Dr. Dennis Evans, representative of the Seaview League, presented a proposal as it pertains to residence eligibility and foreign exchange students. This item will be an action item at the January meeting of the CIF-SS Council.

11. **RIO HONDO LEAGUE BASEBALL PROPOSAL** – Mr. Mickey McNamee, representative of the Rio Hondo League, presented a proposal seeking a recommendation to the State Federated Council for the use of optional metal cleats for baseball effective with the 1987 season. This will be an action item at the January meeting of the CIF-SS Council.

12. **BAY LEAGUE SOCCER PROPOSAL** – Ms. Barbara Alexander, representative of the Bay League, reviewed a proposal calling for the following revisions in the rules governing the sport of soccer:

1. A player who receives a red card in any game (non-league, tournament, league or playoff) may not play in the team's next game. Following discussion, it was moved, seconded and passed to approve the proposal, effective with the current 1985-86 school year.
2. A player who receives a yellow card in any game (non-league, tournament, league or playoff) must be substituted for. The player may re-enter the game at any subsequent time that a legal substitution may be made. Following discussion, it was moved, seconded and passed to approve the proposal, effective with the current 1985-86 school term.
3. Prior to any game (non-league, tournament, league or playoff) each coach must submit completed line-up cards to the referee and opposing coach. Following discussion, it was moved, seconded and passed to approve the proposal effective with the 1985-86 school term.
4. A soccer team will be permitted to play no more than 20 games during the season, including tournaments, but excluding CIF-SS

playoffs. Following discussion, it was moved, seconded and passed to approve the proposal effective with the 1985-86 school year.

13. **RE-LEAGUING** – Mr. Frank Cano, Chairman of the Re-leaguings Committee, presented the respective proposals for the 1986-88 cycle. Following discussion, it was moved, seconded and passed to accept the area proposals for the Mt. San Antonio, Coastal, Foothill, Orange County, Desert, Northern, San Gabriel Valley, private and parochial areas.

Rev. Walter Wilczek, Principal of Notre Dame High School in Riverside, and Mr. Lynn Pletcher, Principal of Yucaipa High School, presented appeals relative of the Citrus Belt area. The Principal of Notre Dame High School then appealed the adoption of the Citrus Belt area to the full Council. Following discussion, the Council voted to sustain the adoption of the Citrus Belt area.

There being no further business to come before the Council, the meeting was adjourned at 11:45 a.m.

TEACHING SPORTSMANSHIP AND VALUES
Values Don't Come Merely from Participation in Sports

In most school districts, physical educators, athletic educators, and school administrators concentrate on teaching positive values and sportsmanship in a variety of ways. They discuss sportsmanship in physical education classes and in school assemblies, beginning in the upper elementary grades and continuing on through high school.

In a discussion of sportsmanship, ideas that should be stressed include:

- Spectators, players, and coaches have an obligation to accept the officials' decisions without crying, objecting, complaining, arguing, or fighting.
- Visiting teams and fans are guests in the home team's house.
- The most important objective of all games – class, intramural, and inter-scholastic – is to learn to play and root hard while being fair to opposing players and treating officials with dignity.
- Spectators should cheer and encourage their own team – not boo or discourage opposing players of fans.

Since the class or intramural situation is meant to be a practical laboratory for life, teachers and coaches should not hesitate to stop action in class or intramural games to point out examples of good or bad sportsmanship. We've even seen instances where home coaches at high school basketball games have called time and lectured crowds for poor sportsmanship. Seeing is believing and boys and girls will learn more from one example than a dozen sermons.

Establishing Guidelines

One approach that has worked well in developing sportsmanship and overall

conduct on the part of players, spectators, and coaches is to establish guidelines for each segment of the school population. GUIDELINES FOR PLAYERS:

Players should be taught to:

- Treat opponents the way they'd want to be treated. Home-team players, particularly, should adopt this philosophy. It's tough enough to play away from home without being mistreated by opposing players and spectators.
- Shake hands with members of the opposing team before and after the game in full view of the crowd. Don't go away mad. If you and a member of the opposing team have had a hard battle on the court or field, make a real effort to talk it out and leave as friends.
- Don't argue with officials. You seldom, if ever, win. All you accomplish is to get yourself excited, cost your team a penalty or technical, incite the crowd, and generally create a negative attitude. Incidentally, players should be told that their performance suffers when they allow themselves to become emotionally upset over an official's call.

GUIDELINES FOR SPECTATORS: Educators should take the time to tell spectators that they should:

- Learn and observe the principles of sportsmanship.
- Censure fellow students whose behavior is unbecoming and obnoxious.
- Respect the decisions of the officials.
- Refrain from booing and fighting. Make it perfectly clear that the playing field belongs to the players and not to the fans once the game starts.

GUIDELINES FOR COACHES: On

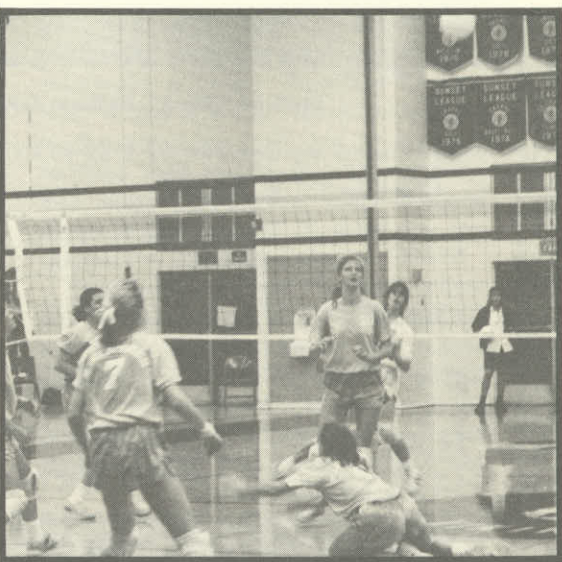
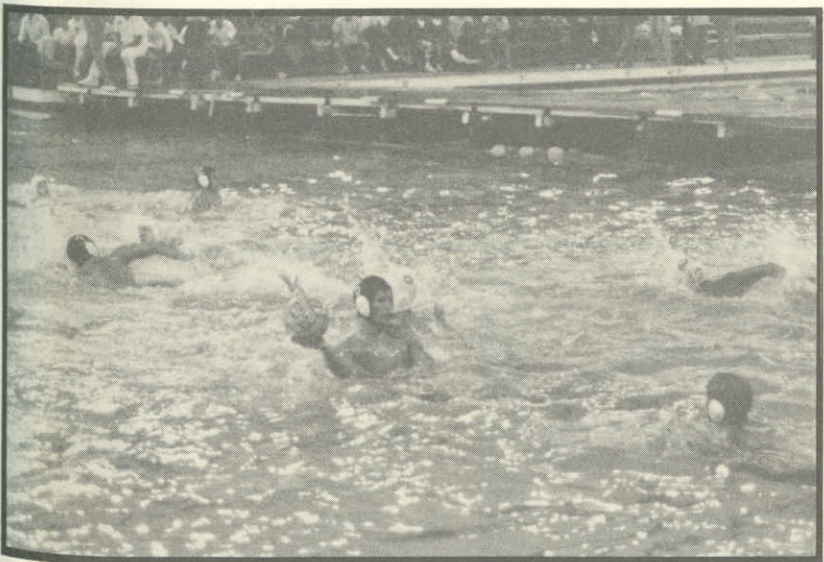
the field of play, coaches should:

- Set a good example for players and spectators to follow. This means that there should be no arguments in front of players and spectators, no gestures which indicate an official or opposing coach doesn't know what he or she is talking about, no throwing a coat or hat down on the field in disgust.
- Teach sportsmanship and demand that their players be good sports. Coaches should have the courage to remove players from a game or the squad if they continuously demonstrate poor sportsmanship and poor conduct.
- Respect the judgment of officials. Shake hands with them before and after the game in full view of the crowd.
- Keep all disagreements with officials on a gentlemanly basis. This is best done in private, out of view of players and spectators.
- Do not criticize officials or opposing coaches publicly, particularly to reporters. This is bad policy. Too often, coaches vent their spleens over losses by blaming everyone but themselves and their teams. Such criticism may help sell newspapers but is counterproductive in terms of positive values developed through sports.

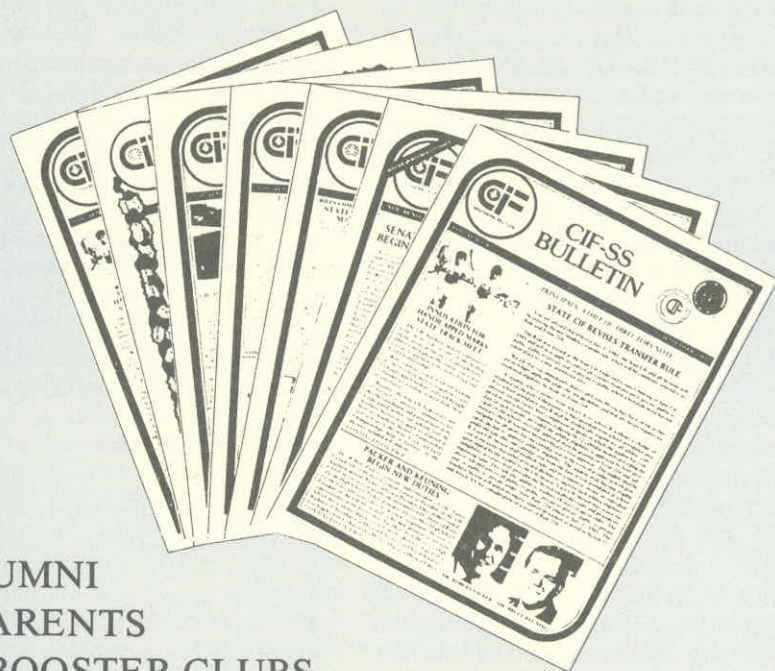
Values of Athletics

practice; review of past administrative procedures as they pertain to staff orientation at the start of the school year and appropriate refinement, as necessary; attendance by the varsity basketball coach at the winter CIF-SS Coaches Workshop; and notation in the school file.

SITUATION #12:

The Commissioner approved closure of a violation with respect to Rule 221 (Legal Guardian). Action taken included the forfeiture of all contests in which the student competed; the school will review past administrative procedures as they pertain to eligibility clearance and will implement refinement, where appropriate; implementation of the CIF-SS eligibility clearance cards; attendance by the head coaches at the CIF-SS spring orientation meetings for those sports being offered; notation in the school file.

SITUATION #13:

The Commissioner approved closure of a violation with respect to Rule 1710 (Association Rule). Action taken included the resignation of the coach from all responsibilities for the balance of the season; development of school orientation program for staff members prior to the start of each sport season; notation in the school file.

SITUATION #14:

The Commissioner approved closure of a violation with respect to Rule 707 (Tournament Contests Charged). Action taken included the tournament being placed on administrative probation for 1986-87; tournament bracket sheet and sanctioned event form must be reviewed in advance by CIF-SS Office; notation in the school file.

There being no further business to come before the Executive Committee, the meeting was adjourned at 4:45 p.m.
