
Steve Clute, representing the 68th Assembly District in Riverside County. Mr. Clute will address high school athletics as it relates to the state government.

TRANSFER ELIGIBILITY **CONCERNS**

During the fall season of sport, the CIF Southern Section Office, member schools and student athletes, were faced with the dilemma of forfeitures on the part of member schools due to the simple fact that eligibility rules were not properly interpreted. In football alone, ten schools forfeited games and eight of those schools lost out on CIF-SS playoff activities.

In a number of these cases, the schools probably would have qualified for entry into the playoffs. Three of the teams would have been highly seeded in the playoffs, while one had hoped to defend a CIF-SS championship.

In most of the cases where schools were faced with forfeitures, TRANSFER ELIGIBILITY RULES were not properly interpreted or transfer students went unchecked by school personnel. In ALL cases, the schools in question did NOT use the TRANSFER ELIGIBILITY CARDS as provided by the Section Office. We can't emphasize enough that each and every time a new student transfers into your school, you MUST take the proper precautions to insure their eligibility. The use of an ineligible player not only affects the school, the team members, but it has an adverse affect on the community.

The affect on the community is very emotional, and in two cases within a five-day period of time, the Southern Section was faced with litigation where parent booster clubs were attempting to secure temporary restraining orders in order to allow their respective teams into the playoffs. We were fortunate in that the judge in each case up held our rules and regulations. However, in see COMMISSIONER'S CORNER page 13

CIF-SS EXECUTIVE COMMITTEE MINUTES

October 19, 1987

The October meeting of the California Interscholastic Federation Southern Section Executive Committee was called to order by Chairman Pat Mauch at 1:40 p.m. on Monday, October 19, 1987 at the CIF Southern Section Office. All members were present.

1. PRESIDENT'S UPDATE - President Pat Mauch reviewed with the Committee the State liability insurance package, the National Federation Region 7 and 8 meeting, and extended congratulations on behalf of the entire Executive Committee to Tony Balsamo, who will be serving as Vice-President of the National Federation Executive Committee. Additionally, President Mauch appointed a Committee consisting of Bruce Kitchen, Chairman, Jim Carmichael and Joe Rotcher to recommend candidates from the CIF Southern Section to the State CIF for consideration for the National Federation Hall of Fame program.

A special presentation was made to Mr. Gene Emmons on completion of

the building addition of the CIF Southern Section Office, as donated by the Padelford Construction Company of Cerritos.

2. COMMISSIONER'S UPDATE -

Commissioner Stan Thomas reviewed the goals and objectives of the CIF Southern Section for the 1987-88 school year. Additionally, he updated the Committee on work being done by the Blue Book committee dealing with summer regulations and summer pay to coaches, 75-year banquet plans, review of ticket prices for the 1987-88 CIF championship events, and the possibility of a releagueing appeal from the Northern area to the State CIF and discussions held relative to the realignment of the geographic area for releagueing purposes, a draft of which will be forthcoming to the Executive committee for review at the Febraury meeting.

3. BOYS' A.D. UPDATE - Boys' Atheltic Director Representative Mike Moropoulos expressed concerns rela-

A PRIMER FOR THE HIGH SCHOOL ATHLETIC DIRECTOR

In order to be a strong and effective Athletic Director, it is imperative that you consider your Athletic Program as your own team. COACH IT! The same factors that were successful for you as a coach will bring you administrative success as well. Consider your coaches as your assistants and encourage them to "buy in" to your game plan.

As in any head coaching job, the welfare and attitude of your staff must be paramount. Your immediate and most significant efforts should be concentrated on creating the best possible athletic environment and circumstance for those under your direction. Hopefully those efforts will ensure the attainment of your ultimate goal of providing positive athletic opportunity for your student-athletes. If you can achieve that particular goal, all of the enducational benefits of competition will be realized and your success will be ensured.

For any team to be successful, there must be a direction, a plan, an underlying philosophy, the real heart of the program. What is it that you are striving for, what is yor ultimate objective and how best to go about achieving it? In building that philosophy, you must accept the premise that all of us have a responsiblity and an obligation, perhaps even a debt to our profession and to our student-athletes to maintain the integrity of the contest itself. It is incumbent upon us to establish and maintain the highest possible standards of competition, constantly striving to upgrade our programs in terms of quality and class. This is most effectively accomplished within the framework of ethical conduct, good sportsmanship, respect, and a high degree of professionalism. We can never allow contests to degenerate into fighting, taunting, and personal animosities, and in turn must encourage the practice of good sportsmanship. Our athletes must be convinced that such an attitude can be realized within a framework of intense competition and a fierce desire to win. There is nothing wrong with wanting to win.

Such a philosphy is analogous to our PLEDGE OF ALLEGIANCE. It is an ideal, it is not so much what we are doing as it is what we are trying to do. We cannot tolerate the chair throwers, the face-spitters, and the eye-gougers that our athletes are constantly exposed to on TV. We must convince our coaches, and they in turn must convince our athletes that they can be honorable, respectful, play within the rules of the game and the code of good sportsmanship and still play an aggressive, all-out brand of competition. All of us must consider that the sport


is a class, the field is a classroom, and

the coach is a teacher. If we lose that

perspective, we will become the ultimate hypocrites. We must convince our staff members that their sport exists only to provide a teaching-learning circumstance for our athletes. We sometimes reject the lable of role model, but learning does take place by design or by association. We teach, good and bad through our appearance, our demeanor, and our actions/reactions to the emotion of competition. Coaches must seize upon that opportunity to teach the lessons that we talk about in our profession, loyalty, the work ethic, discipline, unselfishness, positive reaction to adversity, honorable behavior, integrity, and other traits and lessons that we consider valuable and worthwhile. If we ever come to believe that character cannot be taught, enhanced, or encouraged, then early retirement is in order. You win with good character, and lose when it is weak. If coaches can accept this entire premise while teaching kids to run, serve, pitch, block, and shoot - and they can - then our dual purpose of creating good citizens and winning teams can be accomplished.

Remember, we use athletics to assist student-athletes, we do not use studentathletes to help the athletics program. If there is to be a golden rule, why not

WORKING TOGETHER WITH YOUR OFFICIALS

The CIF Southern Section strongly believes officiating is a major factor in the continuing progression of the intersholastic athletic program.

For this reason, the CIF-SS is pledged to devote both time and energy to the technical and organizational aspects of officiating.

In this article we will attempt to highlight what we feel are a few of the items you as a school administrator should do in order to establish a positive relationship with officials working atheltic contests - regardless of the level - at your school.

Here are some guidelines for your consideration:

- 1.) Contact officials well in advance of schedule changes.
- 2.) Make sure to have paychecks prepared in the proper amount.
- 3.) Notify officials in advance of scheduled contests to provide with directions and parking information.
- 4.) Provide adequate dressing facilities for the officiating crew, separate from participant's facilities.
- 5.) Escort officials to the dressing/pregame facility.
- 6.) Discuss half-time procedures (i.e., homecoming, length of halftime, pregame entertainment, etc.).
- 7.) Be certain officials' dressing facilities are open at halftime and provide
- 8.) Take preventative measures to keep spectators from disrupting officials and their duties. Make crowd control your priority and responsiblity.
- 9.) At the end of the game, provide escort from field or court. Make sure officials' facilities have hot water, soap and towels available.

If these courtesies are observed, your contest should proceed without incident.

CIF SOUTHERN SECTION COUNCIL MINUTES

September 24, 1987

The September meeting of the CIF Southern Section Council was called to order by President Pat Mauch at 9:35 a.m. on Thursday, September 24, 1987 at the Ramada Inn in Norwalk. All leagues were present with the exceptions of the Collegiate, Express, Liberty, San Fernando Valley and Junior High School.

1. APPROVAL OF MINUTES – It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of May 7, 1987 as published in the September issue of the CIF-SS BULLETIN; mintues of the CIF Southern Section Executive Committee meeting of June 20, 1987, as published in the September issue of the CIF-SS BULLETIN; and the CIF Southern Section Executive Committee minutes of August 22, 1987 as mailed to the Council.

2. PRESIDENT'S UPDATE - Mr. Pat Mauch introduced new Executive Committee member Mike Shanahan, Principal of Buena High School, who will serve as the Northern Area Representative. Also introduced were new members of the Council and guests. Mr. Mauch welcomed the Council representatives to the first meeting of the year and commented on the State CIF liability insurance package, the Amateur Athletic Foundation pilot program in track and field which is now being reviewed, with the final decision due later this year. It was announced that Tony Balsamo was elected to the position of Vice-President of the National Federation.

3. COMMISSIONER'S UPDATE – Commissioner Stan Thomas welcomed the Council to this, the 75th year of the organization. Additionally, Commissioner Thomas reviewed with the Council the Orange County Officials Assignment program; the 75 Year Inaugural Golf Tournament; the feasibility of a year-end banquet as a culminating activity for the CIF Southern Section's 75-year anniversary; the State CIF basketball and cross country playoffs which will be conducted this year by enrollment classification; the new Principal and Athletic Directors'

Orientation programs; R & R Week; and the Reebok/Coke corporate support programs. It was also stressed to members of the Council to review with their leagues a rededication to the high standards that the CIF Southern Section has been noted for these past 75 years. It is asked that all Building Principals reviewed with their coaching staffs the Code of Ethics which are the basic foundation of the CIF Southern Section.

4. NATIONAL FEDERATION UP-DATE – Dr. Tom Jacobson provided an overview of the National Federation summer meetings held in Denver, Colorado, as it related to trends in the area of State governance of high school athletic programs; walk on coaches; eligibility; fund raising, and the promotion of events at the interscholastic level.

5. TREASURER'S UPDATE – Mr. Bruce Keuning, treasurer, reviewed the recently completed auditors' report, the findings of which reflected an excellent check and balance system that met the 1986-87 Section projection. Additionally, Mr. Keuning provided an update on the 1987-88 working budget.

6. STATE FEDERATED COUNCIL UPDATE - Dr. Robert Packer reviewed with the Council the recent State CIF Executive Committee decision that CIF Southern Section Rule 2712.1 - soccer - relative to the number of players on an outside team during the school year outside the season of sport, was in conflict with State rule 600. This ruling by the Executive Committee upheld an earlier opinion of State CIF Commissioner Thomas E. Byrnes. This will be an action item for consideration to delete this rule from the CIF Southern Section Blue Book at the January meeting of the CIF Southern Section Council.

7. EMPIRE LEAGUE FOOTBALL
HELMET PROPOSAL – Jerry Glenn
of Loara High School, representing the
Empire League, presented a proposal
for consideration of utilizing football
helmets during the conditioning period
prior to the football season. This will

be an action item at the January meeting of the CIF Southern Section Coun-

8. SEASON OF SPORT COMMIT. TEE PROPOSAL - President Pat Mauch provided an update of the season of sport committee recommendation to lengthen the fall season of sport from 53 to 57 days and from 9 weeks to 10 weeks' duration; decreasing the winter season of sport from 85 to 78 days and from 14 to 13 weeks' duration. It should be noted that this will not affect the date of of the first contest in the sports of B/G Basketball, B/G Soccer and Field Hockey. The first contest in wrestling will be November 26, which will allow for 10 days of practice for those students not a member and participant of a fall sports team. This item will be an action item at the January meeting of the CIF-SS Council.

9. FOOTBALL HOME FIELD AD-VANTAGE – Jerry Witte, member of the Football Advisory Committee, presented a proposal calling for extending to football league champions who have been identified as a No. 1 entry, a guarantee of home field advantage if they survive, for the first 3 rounds of the playoffs. This will be an action item at the January meeting of the CIF Southern Section Council.

10. GIRLS' HURDLE PROPOSAL – Associate Commissioner Dean Crowley reviewed with the Council a proposal to increase the height of the girls' hurdles from 30 inches to 33 inches, commensurate with the 1988-90 track season. This will be an action item at the January meeting of the CIF-SS Council.

11. BLUE BOOK COMMITTEE REPORT/RECOMMENDATIONS – Chairman Gary Goff discussed with the Council concerns relative to the services of medical doctors at CIF-SS events; the value of awards in CIF-SS tournament and invitational activities, with the value of the individual awards being the actual manufacturer's cost of the item; and concerns with the outside competition rule, as expressed by the

tive attitude towards visiting schools. However, it is extremely important that all of your athletes understand you are making a special effort to welcome their opponents. Start with a phone call, followed by a game letter or informational packet with pertinent data about tickets, parking, game ball, seating, bands and other aspects of competition. Offer services such as arranging for meals, lodging, or resting facilities. Ask when they expect to arrive and have a staff member plan to meet them. If appropriate, advise them of any training and or medical help including ice. Introduce them to the person they might seek out for help, security, or equipment problems. Many schools provide hosts and hostesses. A cold soda for a Football team after a game might cost you \$15.00 . . . a lot of gesture for so little effort and

Provide the very best treatment, facilities, and service for your opponents, and while we may not be able to provide great facilites, we can provide great effort. You will undoubtedly find some resistance on the part of coaches who either have not been treated well when visiting other schools, or who feel that you are contributing to the effort of the opponent with the hospitality. Your only recourse is to continue exercising your philosophical beliefs and hope that your opponents will appreciate the courtesies and respond in kind. Hopefully you can convince your staff, and in turn your athletes and fans, that you can provide for your opponents with diginity, class, and respect for their program, and still win.

Build a philosophy, sell your staff and athletes on the merits and the eventuality of a positive outcome. Visit each of your teams, especially the younger ones, and explain that their team belongs to the school and the community. Talk with them about ethics, sportsmanship, respect, and class. And lest they misunderstand, whether it be Track, Football, Baseball, Swimming, or Tennis, let them know you expect aggressive, all-out, enthusiastic competitiveness.

Sherilyn Ross, Director of Girls' Athletics at El Toro High School, has been appointed as the newest member of the CIF Southern Section Executive Committee.

Ms. Ross will fill a vacancy in the position of Girls' Athletic Director's Representative, created by the resignation of Sheila Burrud of John Muir High School. Ms. Burrud served as an Executive Committee member since the 1982-83 school year.

Ross began her career as a physical education instructor at El Toro in 1972. Just one year later, she became the girls' athletic director, athletic department chairman and girls' varsity swim coach.

As the El Toro Athletic Director, Ross has coordinated eight girls sports encompassing 21 teams for the past 14 years. Her administrative duties have included fund raising, scheduling, transportation, staffing, public relations and financial accounting.

The National Football Foundation and Hall of Fame will hold its annual Scholar-Athlete Award Dinners to honor outstanding Southern California gridders in February and March.





AUSTRALIAN OFFICIALS GET A LOOK AT BASKETBALL CALIFORNIA STYLE

A cultural exchange between the California Basketball Officials Association and the New South Wales Basketball Association of Sidney, Australia, provided a trip to Southern California for two Aussie officials in early December.

The visitation was arranged and conducted by Chuck Osborne, Executive Director of the the Universal Sports Accord and an active member of the CBOA.

Steve Carey, 28, and Darren Brown, 23, both residents of Sidney, toured the Southland between Nov. 24 and Dec. 10 to observe the mechanics and procedures utilized by their California counterparts. During their visit, Carey and Brown worked five CIF-SS contests, involving Coachella Valley, Indio, Elliott Pope and Palm Desert High Schools. They also had a glimpse of the big leagues, as guests of the Los Angeles Clippers at their game against the Phoenix Suns on Sunday, Dec. 6.


In Australia, basketball adheres to the rules of the Federation of International Basketball (FIBA), which are also the official rules of Olympic competition. Becoming certified in Australia parallels the California policy, where prospective officials must attend six study sessions and pass a written exam each year.

Basketball is played in club competition in Australia, with approximately 50 teams in the Sidney area alone. There are open men and women's divisions for players of age 22 and over, a youth league for players under 22 and a junior league for youngsters between the ages of 12 and 18. The highest level is the Australian National Basketball league, an amateur league with 14 member teams nationwide.

Both Carey and Brown compared the Australian brand of basketball on par with the competiton they had seen in California for age group levels, but said there was nothing in their country to campare with the NBA or major college levels of the United States.

"Basketball is catching on in our country," noted Carey. "The growing media coverage is a sign of its increasing popularity."



CAGE PLAYOFF SCHEDULE STAGGERED

Scheduling for the 1988 CIF Southern Section Basketball Playoffs will provide Central and Southern California prep cage fans an opportunity to see more post-season action than ever before. This winter's playoffs will open with wild-card round games on Feb. 17 and conclude March 5.

The staggered schedule basically follows a Tuesday-Friday slate for the boys and Wednesday-Saturday set up for girls. Additionally, the boys' major division (5-A) will play its first two rounds on Thursday nights to avoid conflicting dates with the other boys divisions.

"The factors considered in changing this year's playoff schedule are three-fold," noted Dean Crowley, Associate CIF-SS Commissioner of Athletics and Basketball Administrator. "First, it will give us more flexibility in securing facilities, second, it will offer the fans an opportunity to see more of our outstanding teams; and third, it will give our schools and athletes greater exposure and increased media coverage."

The boys competition opens Feb. 17 with wild-card round games where necessary, followed by the first round in the 5-A on Feb. 18 and in all other divisions on Feb. 19. The second round in all divisions (with exception of the 16-team 5-A) will be played Feb. 23, followed by the quarterfinal round on Feb. 26. The 5-A quarters are scheduled for Feb. 25. The semis will be played in all divisions on Mar. 1, but the 5-A will feature a two-night semifinal slate on Mar. 1 and 2. The 2-A, 3-A, 4-A and 5-A finals will be played Saturday, Mar. 5 at the Los Angeles Sports Arena, while the 1-A and Small Schools titles will be decided on alternate court sites Friday, Mar. 4.

The girls playoff schedule also opens on Feb. 17 with wild-card round action, followed by first round games in all divisions Feb. 20. All divisions will proceed with second-round games Feb. 24, quarterfinal-round games Feb. 27 and semifinal-round games Mar. 1. The girls finals are slated for Friday, Mar. 4, with the 4-A and 3-A games at Cal Poly Pomona and others at sites to be announced.

cases like these, everyone is the loser.

We ask all administrators to carefully check eligibility prior to the start of the season - NOT prior to the playoffs. Doublecheck all transfer students to be sure they are both residentially and scholastically eligible. QUESTIONS: Has there been a bonafide address move on the part of both parents? Moving from one parent to another does not constitute eligibility. Who did the student reside with during the previous 12 months prior to entering your school? Just moving on the part of the student alone does not constitute eligibility. If a student has not had a bonafide address change under the provisions of Rule 214, eligibility will be restricted in some cases, and it should be noted that students are NOT ELIGIBLE until such time as the Form 214 has been processed by the CIF-SS Office.

This Office can guarantee that if school administrators will use our current eligibility cards, transfer students will be red flagged when transfer rules and regulations are questionable. A simple phone call to Commissioner Thomas, Associate Commissioner Dean Crowley, or Administrator Karen Hellyer will answer any questions you might have with regard to the student transfer in question.

The fall playoff period was one of the section's most trying in terms of forfeitures since the eligibility cards were instituted. In order to protect the eligibility of your athletes, it is imperative that school administration give strong consideration to the use of TRANSFER ELIGIBILITY CARDS as furnished by the Southern Section Office.

If you are in need of these cards (now in the process of being updated to reflect the new G.P.A. rules and regulations) please feel free to call the Office and we will send them out to you immediately. DO NOT LEAVE ANYTHING TO CHANCE! QUESTION EACH AND EVERY TRANSFER STUDENT!!

PRIVATE SCHOOL TRANSFER

Administrators of private and paro-

chial schools are requested, when counseling students and parents that are leaving their respective schools, to inform them of atheltic eligibilty rules and regulations. It has been brought to the attention of this Office by parents of students transferring that upon leaving their original school of eligibility, they have not been made aware of the transfer eligibility rules and possible restrictions involving athletic participation. This should not be a responsibility of the receiving school, as many times youngsters enroll and are attending school only to learn that they will not be eligible under current CIF-SS rules and regulations. Additionally, if a counseling process takes place prior to enrollment, it would help if eligibility regulations with regard to transfer students are reviewed with both the student and the parents.

NEW G.P.A. INTERPRETATION

One of the outgrowths of the new "C" AVERAGE REGULATION has been the question of courses taken in summer school to make up deficiencies during the previous grading period. Under the new State interpretation approved by the Federated Council on October 23, 1987, if a student is repeating a course previously taken, the repeat grade replaces the previous grade and should be averaged along with all of the courses during the preceding grading period. In other words, if a student is taking a class during the summer to improve his G.P.A. with reference to a class that has already been taken, the new grade can be averaged with all grades that were accumulated in June. The intent of the rule is to help students. In no way can students hurt themselves by repeating a class to improve their G.P.A.

tive to the 2.0 legislation and its effect on entering ninth graders, and walk-on coach legislation.

4. GIRLS' A.D. UPDATE – Sheilla Burrud, Girls' A.D. Representative, raised questions relative to the legal and liability State CIF assessment and current grading policies and procedures and their implication to the new CIF scholastic eligibility regulations.

5. SUPERINTENDENTS' UPDATE

- Superintendents' representative Cynthia Grennan discussed the importance of the "No to Drugs" program and the wearing of "red ribbons" during the week of October 26-30.

6. TREASURER'S UPDATE – Bruce Keuning, treasurer, provided an update on the 1987-88 working budget.

7. STATE REPORT – Tony Balsamo reviewed background information relative to the agenda of the State Federation Council meeting scheduled for October 22-24 in Palm Springs.

8. SECTION 7-8 MEETING REPORT – Mr. Pat Mauch reported on the National Federation Section 7-8 meeting as it related to issues facing state high school athletic associations. These included communication, AIDS policies, corporate sponsorship, liability concerns associated with cheerleading competition, dues structure, national championships, eligibility hardship cases, summer activities, and the recruitment of officials.

9. LEGAL UPDATE – Attorney Andy Patterson reviewed with the Committee the CIF State liability insurance package and an overview of the Calabasas 8-semester eligibility case currently on appeal to the Second Appellate District Court.

10. CORPORATE SPONSORSHIP – Administrator Larry Zucker updated the Committee on the current status of the State CIF and Southern Section corporate sponsorship programs.

11. NEW SCHOOL MEMBERSHIP

– It was moved, seconded and passed to approve the membership of Bethel Christian High School (Lancaster), Montessori Academy (Claremont), and Pacific Shores (Laguna Hills), effective with the 1987-88 school year.

12. ATHLETIC ADMINISTRATORS' SYMPOSIUM – Administra-

tor Karen Hellyer reported that the 1987-88 Athletic Administrators' Symposium will be held on Wednesday, January 20 at the Anaheim Convention Center. Topics will include drug testing, walk-on coach legislation, new principal orientation, eligibility and summertime activities.

13. ADMINISTRATIVE COMMITTEE REPORT – Bob Paisola reviewed agenda items discussed by the Administrative Committee which included the increased custodial load due to the addition of the new wing at the CIF-SS Office, a proposed Los Angeles City vs Southern Section post-season volleyball competition, the need for increased input from member schools, and the involvement of the athletic director representatives in outside activities.

14. REVIEW OF NEW PRINCIPAL AND ATHLETIC DIRECTOR ORIENTATIONS – Administrator K aren Hellyer reviewed with the Committee the very successful Athletic Director and Principal Orientation meetings held at the Sequoia Athletic Club. It should be noted that due to the October 1 earthquake, many administrators were not able to attend, thus this subject will be the topic of a workshop at the January Symposium in order to accommodate those administrators who were unable to attend.

15. ORANGE COUNTY PILOT PROGRAM – Administrator Bill Clark updated the Committee on the Orange

County officials pilot program, and an upcoming evaluation meeting which will be held with organizations involved in the program in the fall phase of the program in November.

16. TITLE V UPDATE – Cynthia Grennan reported that the Title V regulations dealing with certification of coaches will be forthcoming soon from the State Department of Education.

17. 2.0 UPDATE – Dr. Robert Packer reviewed concerns relative to the completion of the State CIF scholastic eligibility rules and regulations dealing with 2.0 G.P.A.

18. STATE RULE 600 - Dr. Robert Packer reviewed with the Committee the recent State CIF Executive Committee decision that the CIF Southern Section Rule 2712.1 - soccer - relative to the number of players on an outside team during the school year outside the season of sport was in conflict with State Rule 600. This will be an action item for consideration to delete this rule from the CIF Southern Section Blue Book at the January meeting of the CIF Southern Section Council.

There being no further business to come before the Committee, the meeting adjourned at 5:35 p.m.
