A copy of the Minutes of the meeting of the Federated Council held in Los Angeles Saturday, November 30, 1935 is enclosed. There is also enclosed a reprint of important rulings of the State Council of the C.I.F. brought down to the present date.

SWIMMING AND WATER POLO CLASSIFICATIONS

In past years only two classes in swimming and water polo have been undertaken. For a number of years we had Class A and Class C. For the past six years we have had Class A and a so called "Lightweight" Class. For the past two years the Lightweight Class has included all boys with an exponent of 60 or less according to the Four-Point System. The Executive Committee has approved the continuance of the Class A and the Lightweight Class for the coming season of water sports. Under the new Three-Point System the Lightweight Class will include all boys with an exponent of 64 or less. Boys with an exponent of 65 or over must compete with Class A. These two classes of competition will be arranged for in any play-off that may occur in water polo and in the championship swimming meet at the end of the season. The various leagues of course are privileged to follow the usual classification in swimming and water polo if they so desire.

MINUTES OF SPECIAL EXECUTIVE COMMITTEE MEETING - DEC. 10, 1935

A special meeting of the Executive Committee was called for 1:30 P.M. to decide question of the Muir Tech High School in the Football Play-Off.

Following a review of the case which was presented to the Committee by Mr. Mead the following action was agreed upon unanimously.

In the matter of the Muir Tech vs. Herbert Hoover San Diego football quarter finals and Monrovia semi-finals.

Facts referred by Mr. Rufus Mead, Principal of Muir Tech are as follows: Anthony Beebe who attended San Diego Army and Navy last year carried two credits only for the last year. Beebe carried the Transfer from San Diego Army and Navy himself to Pasadena Junior College 12th grade. This Transfer when it was sent to Muir Tech carried three school credits.

Mr. Mead presented the foregoing facts to the C.I.F., S.S. Court and acquiesced to its decision.

The Constitution, Article X, Section 2:

"The contest and points won in any play-off event in which an ineligible player is used shall be forfeited to the other school."

By the Court:

The play-off games played by Muir Tech shall be forfeited to its opponents.

The Court finds that Muir Tech and its Principal, Rufus Mead, acted in good faith and could not have had knowledge of the facts until brought to their attention one day before this meeting.

Principal Mead in accordance with Article X, Section 2 of the Constitution made a formal tender of the moneys accruing to Muir Tech from the two play-off games in which the school had taken part.

Moved by Mr. McIntosh, seconded by Mr. Fischer that we accept the forfeiture of moneys allotted to Muir Tech and because of the fine sportsmanship displayed that we return the money to Muir Tech. Carried unanimously.

It was informally agreed that Monrovia be substituted in the final game of the play-off for Muir Tech High School. The following points were considered in selecting Monrovia.

1. Monrovia was the last team put out by Muir Tech.
2. Monrovia had made an especially strong showing in the game with Muir Tech.
3. Monrovia had already played two games after the close of its regular season. No other team in its side of the bracket had played more than one game.

Since the Rose Bowl in Pasadena was available for the final game, the Executive Committee directed that it be played there and that Monrovia be designated the Home Team.

A regular meeting of the Executive Committee had been called for Friday, December 13. It was unanimously agreed that today's meeting be continued following the disposal of the Muir Tech case and that matters set for December 13 be disposed of today.

Mr. McIntosh requested permission to invite the Reedley High School to participate in a basketball tournament to be staged at the Puente High School December 28.

The request was granted and Mr. McIntosh notified that the Central Section of the C.I.F. must also approve Reedley's coming to the C.I.F., Southern Section for competition. ✓

Major J. B. Wonsetler, Superintendent of the Pacific Military Academy, appeared before the Executive Committee and asked for a review of an act of suspension passed against his school by

the Preparatory League.

Facts Presented

1. Pacific Military Academy charged with having played an ineligible boy in a football game with St. Anthony's School October 19, 1935.
2. Preparatory League met October 28 to consider case.
3. Pacific Military though duly notified of League meeting failed to be represented.
4. League suspended Pacific Military until September, 1936.

Conclusion

Pacific Military directed to apply to the Preparatory League for a hearing (Mr. Hamilton, President of the League, agreed to arrange for a hearing when requested to do so.) After the League hearing, an appeal may be made to the Executive Committee should Pacific Military still feel that its case has not been fairly handled.
