MINUTES OF COUNCIL MEETING

The Council met at the Herbert Hoover High School in Glendale, May 17, 1941 at 9:30 A. M. Roll call showed the following members present:

1. Minutes of Council and Executive Committee

Moved by Mr. Allison, seconded by Mr. Gerhart that the minutes of the Council meeting printed in the February 1941 Bulletin be approved as printed and the minutes of the Executive Committee printed in the May 1941 Bulletin be approved. Carried.

2. Treasurer's Report

Mr. S. Chester McIntosh, Treasurer, presented the report printed below. Moved by Mr. Burnight, seconded by Mr. Bergstrom that the report be approved and printed in the Bulletin. Carried.

3. Election of Officers

Moved by Mr. Bergstrom, seconded by Mr. Perry that the Southern League Representative, Mr. Allison, be elected President for 1941-42. Carried.

Moved by Mr. Perry, seconded by Mr. Hamilton that the Sunset League Representative, Mr. Burnight, be elected Vice-President for 1941-42. Carried.

Moved by Mr. Fischer, seconded by Mr. Burnight that Mr. Van Patten be elected Commissioner of Athletics for 1941-42. Carried.

Moved by Mr. Bergstrom, seconded by Mr. Hamilton that the salary of the Commissioner of Athletics be the same for next year as for 1940-41. Carried.

Moved by Mr. Gerhart, seconded by Mr. Berlin that Mr. Moore be elected for a two year term in the State Council. Carried.

Mr. Bergstrom, Mr. Fischer, Mr. Hamilton, Mr. Hayhurst and Mr. Thompson were nominated as members for the Executive Committee. Moved by Mr. Perry, seconded by Mr. Greenough that the nominations be closed and the Secretary cast the unanimous vote of the Council for the five nominees. Carried unanimously.

Mr. McIntosh, the Treasurer, stated that the work entailed in handling the funds of the organization took more time than he felt he could give the job. He recommended that the Treasurer's duties be combined with those of the Commissioner of Athletics in the C.I.F. Office.

Moved by Mr. Berlin, seconded by Mr. Harkness that the selection of a Treasurer be left with the Executive Committee with power to Carried.

4. Ice Activities

Mr. Slatore discussed the growing interest in ice activities in San Diego and vicinity. Mr. Smith of Pasadena J. C. told of the development going on in Pasadena. Mr. Van Patten told of conference he had had with the manager of the Ice Palace in Pasadena.

Moved by Mr. Burnight, seconded by Mr. Berlin that the Executive Committee be instructed to study the ice activity development and report to the Council at its next meeting. Carried.

5. Golf Development

Mr. F. W. O'Bannon, President of the American Golf Association, spoke briefly to the Council on efforts being made by his association to make it possible for more high school pupils to play golf. A special low rate for green fees has been arranged with a large number of public golf courses. Provisions have been made for class instruction by golf professionals at little or no cost. Collecting and reconditioning of used golf equipment is being carried on. As-

Mr. Wm. Hickey, Professional at Brookside Golf Course in Pasadena, told how golf clubs had been organized in the Pasadena junior high schools and in the Pasadena Junior College.

Mr. Hickey invited the Council to send a committee to dinner and meeting of golf professionals to be held at the Riviera Country Club on May 26.

Moved by Mr. Thompson, seconded by Mr. Perry that Mr. Hickey's invitation be accepted, and that Mr. Moore be asked to act as chairman of such a committee. Carried.

6. Football—December 1 to May 1

At the February meeting of the Council Mr. Burnight in presenting a report of the Releaguing Committee made recommendations regarding football activities between December 1 and May 1 of any school year.

It did not seem to be clear to all members of the Council whether the regulation as approved applied to all schools in the C.I.F., Southern Section or to the schools of the Seventeen School Conference.

Moved by Mr. Burnight, seconded by Mr. Moore that the regulation as passed applies to the Seventeeen School Conference only.. A roll call on the question was requested. The vote was 12 to 2 in favor of the motion. The Coast League and the Metropolitan League opposed the motion. The Tri-County League and the Ventura Minor League refrained from voting.

Other schools in the C.I.F., Southern Section, will therefore be governed by regulations printed in the 1940 Blue Book, page 28.

8. Annual Report Materials

Mr.Van Patten asked approval of an outline of materials to be included in the Annual Report.

Moved by Mr. Fischer, seconded by Mr. Berlin that the recommendation be approved. Carried.

9. Placques for 1932-34

Mr. Van Patten reported that during the years 1932 to 1934 owing to a shortage of funds that placques had not been given in all sports. He stated that he had had from time to time, requests from schools concerned, for these back placques.

Moved by Mr. Perry, seconded by Mr. Hayhurst that these back placques be issued at this time. A roll call was requested. The vote was 12 to 4 for the motion. The Bay, Citrus Belt, San Luis Obispo and Southern Leagues voted "no".

10. Los Angeles Coliseum Relays

Mr. Van Patten read a letter from Mr. Wm. Ackerman, Chairman of the Executive Committee of the Los Angeles Coliseum Relays, expressing the hope that dates and other conditions could be so arranged that boys from the C.I.F., Southern Section schools could compete in the Coliseum Relays next year.

Moved by Mr. Thompson, seconded by Mr. Aker that a Committee be appointed to confer with the Los Angeles Coliseum Relay management regarding arrangements for another year. Carried.

11. Mr. Van Patten reported than on several occasions during the past year the future of the State Track and Field Meet had been discussed by coaches and others. The question in the minds of those who had brought up the subject being the advisability of continuing the activity.

Moved by Mr. Thompson, seconded by Mr. Bergstrom that the C.I.F., Southern Section go on record as in favor of a continuation of the State Meet. The motion was lost. Moved by Mr. Burnight, seconded by Mr. Allison that the matter be referred to the Leagues for consideration and report. Carried.

12. A request from the Alhambra High School to have John Gridley ruled eligible for competition next semester, though he will not pass in three subjects this semester owing to absence from school because of a Doctor's orders, approved by the school health department, was received.

A motion to approve failed to get a second and the Chair ruled the request was tabled for lack of a motion.

13. Moved by Mr. Moore, seconded by Mr. McIntosh that (in all questions referred to the leagues for consideration that the League Representative be requested to report the number of schools in his league voting for, and voting

- 15. Moved by Mr. Thompson, seconded by Mr. V. Berlin that the question of using 39 inch hurdles be referred to the leagues for consideration. Carried.
- 16. Moved by Mr. Burnight, seconded by Mr. Bergstrom that the question of holding the team tennis play-off finals on the fourth Friday and Saturday in May instead of on the third week end as this year, be referred to the leagues for consideration and report. Carried.

The Council adjourned at 12:00 noon for lunch and for the track meet.

The Executive Committee met in the C. I. F. Office Wednesday, May 28 at 3:30 P. M. Members present were—

- 1. The Committee elected Mr. Hamilton President for the year 1941-42.
- 2. The Method of handling the funds of the C.I.F., Southern Section was discussed at considerable length. Mr. McIntosh pointed out that the actual time consumed in keeping books, writing checks, making reports, etc., was more than

The Committee adjourned to meet Saturday, October 4 if not called together at an earlier date by the President.

Moved by Mr. Fischer, seconded by Mr. Hayhurst that Mr. McIntosh be appointed Treasurer of the C.I.F., Southern Section; that Mr. Van Patten as Secretary to the Executive Committee keep the financial records of the C.I.F., Southern Section; that funds of the C.I.F., Southern Section be handled by the C.I.F. Office; that both Mr. McIntosh and Mr. Van Patten sign all checks for payments from C.I.F., Southern Section funds; that Mr. Van Patten prepare financial reports whenever requested for Mr. McIntosh to submit to the Executive Committee; that Mr. Van Patten be bonded for the sum of \$5,000.00 or more, if funds in excess of that amount are on deposit. Carried.

3. Mr. Van Patten reported that he had been contacted by the officers of the American Golf Association, by the Public Golf Course Managers' Association, and by the Golf Professionals' Association. All these organizations are anxious to do anything they can to promote golf among high school boys and high school girls in Southern California. What these Associations request is that the schools formulate a program and tell them how they may best assist in promoting high school golf. Moved by Mr. Fischer, seconded by Mr. Hayhurst that a committee be appointed to make the necessary surveys, and formulate plans to be submitted to the Executive Committee at its next meeting. Carried.

The President appointed Mr. H. J. Moore, Chairman of a golf committee, Mr. A. R. Veenker and Mr. Donald Douglass.

4. Mr. Van Patten reported that the C.I.F. Office and the Executive Committee in presenting facts to the United States Revenue Department regarding exemption from Federal taxes on our athletic activities had over a period of two years received counsel and assistance from Judge W. Cloyd Snyder of South Pasadena. Judge Snyder had presented a bill for fifty dollars.

Moved by Mr. Hayhurst, seconded by Mr. Fischer that the bill be approved and paid. Carried.

5. Mr. Van Patten called attention to the fact that the Orange County League and the Pomona Valley League had neither of them been represented at either of the Council meetings of the current school year.

Moved by Mr. Fischer, seconded by Mr. Hayhurst that the schools of these two leagues be notified that the leagues have become liable to suspension for a semester according to Article IV, Section 1, Page 6 of our Constitution. Carried.
