MEETING OF THE EXECUTIVE COMMITTEE OF THE C. I. F., SOUTHERN SECTION

Saturday, May 22, 1943

The Committee met in Mr. Hayhurst's office in the Hoover High School, Glendale, at 8:45

Mr. Van Patten, Commissioner of Athletics, Mr. Burnight, President of the Council, and Mr. McIntosh, Treasurer of the C. I. F., Southern Section, were also in attendance.

1. TEAM TENNIS PLAY-OFF

The Santa Barbara High School had requested to be entered in the team tennis play-off, although it had been unable to arrange any schedule of team matches during the season. Santa Barbara is known to have a group of good individual players and was last year's champion. Santa Barbara requested to be allowed to come down to the Los Angeles area and be entered in the Final match. It was moved by Mr. Fischer, seconded by Mr. Hayhurst, that Santa Barbara be allowed to enter the semi-finals. Carried.

Mr. Van Patten was directed to take care of other details regarding the match.

2. INDIVIDUAL GOLF CHAMPIONSHIP

Mr. Van Patten recommended that we have an individual golf championship at the Montebello Golf Club on Friday, June 4; that the championship be determined by eighteen holes of medal golf and that the Beverly Hills High School Golf team and the Woodrow Wilson High School Golf team, who are contenders for the team championship, be allowed to determine the team championship and play in the individual championship at the same time. Moved by Mr. Bergstrom, seconded by Mr. Thompson, that the recommendation be approved. Carried.

3. EL SEGUNDO HIGH SCHOOL

The El Segundo High School, through its principal, W. P. Schlechte, requested admission to the C. I. F., Southern Section, as a Free Lance member. Moved by Mr. Thompson, seconded by Mr. Hayhurst, that the El Segundo School be admitted if and when we have word from

Mr. Huston of the Los Angeles City Schools, that El Segundo is released from membership in the Los Angeles City Section of the C. I. F., and that El Segundo, if admitted, be advised that the Executive Committee thinks membership in the Preparatory League should be asked and accepted. Carried.

4. FINANCIAL REPORT

Mr. Van Patten presented a financial report, which is printed elsewhere in this issue of the bulletin. He called attention to the fact that annual dues had not been received from eight of our member schools. The matter of delinquent dues was discussed at some length. There being no motion, the President ruled that the schools which have not paid annual dues be notified that their membership has lapsed and that their names will be dropped from the C. I. F., Southern Section, rolls until dues are paid and they have been reinstated. There being no objection to this ruling, it was accepted as final in the matter of unpaid dues.

There being no further business, the Executive Committee adjourned at 9:30 to attend the Council meeting.

**1. MINUTES OF THE COUNCIL AND
EXECUTIVE COMMITTEE MEETINGS**

The minutes of the Council meeting of May 16, 1942 and the minutes of the Executive Committee meetings during the year 1943 were presented to the Council. It was moved by Mr. Bergstrom, seconded by Mr. Catlin, that they be approved as printed. Motion carried.

2. FINANCIAL REPORT

Mr. Van Patten presented the financial report, printed elsewhere in this bulletin. It was moved by Mr. Earl Thompson, seconded by Mr. Moore, that the financial report be accepted and printed in the next issue of the bulletin, and that Mr. Van Patten be commended for having accepted a 50 per cent reduction in salary at the beginning of the year when the financial outlook for the C. I. F. was not at all encouraging. Motion carried.

It was moved by Harry J. Moore, seconded by Mr. Harry Thompson, that the Executive Committee be authorized to make a proper adjustment of Mr. Van Patten's salary for the past nine months. Motion carried.

3. TRANSPORTATION DEVELOPMENTS

Mr. B. L. Bergstrom, who is Chairman of the Rationing Board for the El Monte district, had contacted the O. P. A. office and the O. D. T. office for Southern California in regard to any possible changes in the regulations with reference to gasoline rationing and the use of busses for the transportation of high school athletic teams. Mr. Bergstrom reported that so far as he was able to learn, there had been no changes in the past several months and no changes are in prospect for the immediate future.

**4. RE-GROUPING OF THE SCHOOL OF
THE C. I. F., SOUTHERN SECTION,
FOR PURPOSES OF ATHLETIC COM-
PETITION**

It was moved by Mr. Weakley, seconded by Mr. Earl Thompson, that the Council approve the general policy as stated by the Executive Committee and printed in the special bulletin sent out to all schools under date of March 15. Motion was carried.

It was moved by Mr. Hamilton and seconded by Mr. Sloane, that the League set-up, as it has existed for the past year, be frozen for the duration of the transportation emergency. This motion was discussed at considerable length and it was agreed that the present league representatives be continued as members of our Council unless the individual leagues see fit to change their representation on our governing body. Motion carried unanimously.

The question of arranging groups to carry on athletic competition was gone into at great length. The Executive Committee presented a report calling for seven leagues to remain as constituted for 1942-43 and the creation of 20 new groups. The new groups suggested had membership ranging from three to seven schools.

In the discussion that took place, a number of changes were made in the grouping recommendation that was presented by the Executive Committee. When all changes had been discussed and agreed upon, it was moved by Mr. Weybright, seconded by Mr. Buxton, that the grouping be set up for the period of the transportation emergency. Carried, unanimously. The groups, as finally adopted, appear elsewhere in this bulletin.

5. FOOTBALL SCHEDULES

It was moved by Mr. Moore, seconded by Mr. Earl Thompson, that the groups that had been set up, meet and arrange football games within the group before any games outside of the group are scheduled. Carried. It was moved by Mr. Harry Thompson, seconded by Mr. Sloane, that the Executive Committee be given authority to pass on details of football schedules that may arise under the general policy recommended by the Executive Committee and adopted in Item 4 above. Carried.

6. FOOTBALL RULES

Mr. Van Patten reported that the N.C.A.A. had frozen its football rules for the duration of the war. It was moved by Mr. Perry, seconded by Mr. McIntosh, that the C. I. F., Southern Section, freeze the rules used in the 1942 season for the duration of the war. Carried.

7. ELECTION OF OFFICERS

Following the precedent established a good many years ago, that is: choosing our president

from the league next in the alphabet following the league that is now furnishing our president, it was pointed out that the Tri-County League representative would serve as our Chairman for next year. It was moved by Mr. Perry, seconded by Mr. Berlin, that the Tri-County League representative act as Chairman of the Council for the year 1943-44. Carried unanimously. It was moved by Mr. McEuen, seconded by Mr. Perry, that the Ventura Major League, next on the list after the Tri-County, furnish the Vice-President for 1943-44. Carried unanimously. Mr. Earl Thompson of the Tri-County League, and Mr. H. A. Berlin of the Ventura Major League were asked to take a bow.

Executive Committee

Mr. Bergstrom, Mr. Fischer, Mr. Hamilton, Mr. Hayhurst and Mr. A. R. Veenker of Santa Monica were nominated for members of the Executive Committee for 1943-44. It was moved by Mr. Buxton, seconded by Mr. Catlin, that the nominations be closed. Carried. Moved by Mr. Catlin, seconded by Mr. Sloane, that the Secretary cast the unanimous ballot of the Council for the nominees. Carried.

State Representative

Mr. Harry J. Moore's two-year term as State Representative expires at the end of this school year. It was moved by Mr. Hamilton, seconded by Mr. Hayhurst, that Mr. Moore be elected to another two-year term. Carried unanimously.

Commissioner of Athletics

It was moved by Mr. Perry, seconded by Mr. Earl Thompson, that Mr. Van Patten be elected as Commissioner of Athletics for another year. Carried.

It was moved by Mr. Moore, seconded by Mr. Weybright, that the salary of the Commissioner of Athletics be set by the Executive Committee. Carried.

Treasurer

It was moved by Mr. Harry Thompson, seconded by Mr. Perry, that Mr. S. Chester McIntosh be elected treasurer for the ensuing year. Carried unanimously.

There being no further business, the Council adjourned at 12:15 for lunch which was prepared by the Herbert Hoover High School Cafeteria personnel.

Present members of the Council were urged to attend the track meet during the afternoon.

In addition to the Council members named above, a number of coaches and others interested in the work of the C. I. F. were present, among whom were: Ernest Hartman, Compton; Merrill Green, South Pasadena; Sam Roberts, South Pasadena; Frank Williamson, South Pasadena; William Hess, Alhambra; Sam Keith, Anaheim; and Otho Pettyjohn of Herbert Hoover High School.

FROM MIMEOGRAPHED BULLETIN OF MAY 24, 1943

Special C.I.F. Southern Section, Bulletin

In our Special Bulletin sent to all of our member schools on March 15, it was indicated that our Executive Committee would submit to our Council at the Annual Meeting to be held on May 22, the following recommendations:

1. That we make a definite curtailment in our athletic program at the start of next school year.
2. That schools in the 1943 football season play not over six games of football, the six contests to include practice games and inter-scholastic scrimmages.
3. That there be no play-off games among group or league champions.
4. That groups for competition be limited to from three to five in number.
5. That mileage to be travelled be of first consideration, and that 10 to 12 mile trips be the maximum except in unusual geographical situations.
6. That size of schools in groups be secondary to mileage problems.
7. That the re-grouping recommended to the Council be definitely understood to be for the war emergency only.

The Council on Saturday, May 22, approved the above recommendations and divided our schools for purposes of competition into the groups as listed on the accompanying page of this bulletin.

The Commissioner of Athletics was directed to name someone in each of the new groups to call a meeting of the schools in the group and arrange a football schedule for next football season.

Mr. Verne Landreth, Chief of the Division of Physical and Health Education of the State of California, is working with the Office of Education in Washington, D. C., and the O. P. A. on a plan to have additional gas coupons issued to schools whose football schedule can be approved as to maximum competition and minimum mileage travelled in getting to games. A final ruling in this set-up has not as yet been received from the O. P. A. The Council, however, directed that each school submit its entire schedule of games with the necessary mileage to be travelled, to the C. I. F., Southern Section, office in order that we may present the schedule of all schools to Mr. Landreth for consideration and approval if and when the plan now before the O. P. A. is approved.
