## EXECUTIVE COMMITTEE MEETING MAY 21, 1955—MINUTES

Joseph Bonnet of Fremont Jr. HS, Pomona; Oliver Corbin of Covina HS; Floyd A. Johnson of Hoover HS, San Diego; Winston Nelson of Pomona HS; and Kenneth Fagans, Commissioner of Athletics.

- 1. It was moved, seconded, and carried that the Minutes of the April 25 meeting of the Executive Committee be approved as read.
- 2. The following eligibility case situation from Temple City HS was presented to the Executive Committee for interpretation. A boy in attendance at Temple City HS found it necessary to transfer to Morningside HS in Inglewood, because he had to accompany his father to that community to work at the Hollywood Race Track. His father was setting up residence there for two months. In the fall the boy would return to Temple City to re-establish residence and the boy would then re-enter Temple City HS. Would he be eligible to compete in athletics? It was ruled that the father, by setting up residence in Inglewood, has made a legal change of residence, therefore under C.I.F., Southern Section rules the boy would be eligible to participate in athletics at both schools.
- 3. It was agreed that the final meeting of the Executive Committee would be held at Santa Barbara HS at 12:00 noon, Tuesday, June 21, 1955.

- 3. The Minutes of the Executive Committee meeting, held at 9:00 A.M., May 21, 1955, were read and approved as presented.
- 4. It was moved and seconded to change the cross country season from a Fall to a Winter sport. A roll call vote was taken and the motion was lost by an 8-5 vote.
- 5. It was moved, seconded, and carried that Mr. Floyd A. Johnson of Hoover HS, San Diego, be elected as the Southern Section representative to the State C.I.F. Council for a two-year term, beginning July 1955 and terminating June, 1957.
- 6. The election of the Southern Section Council officers was the next item of business:
  - (a) In accordance with the C.I.F. Constitution, the Orange League will succeed to the Presidency for the 1955-56 school year. The Presidency was turned over to Mr. Frank Hopkins of Brea HS.

- (c) It was moved, seconded, and carried that Mr. Winston Nelson of Pomona HS be re-elected as Treasurer for the 1955-56 school year.
- (d) It was moved, seconded, and carried that Ken Fagans be re-elected as Commissioner of Athletics for the 1955-56 school year.
- (e) Six candidates were nominated for positions on the Executive Committee. A ballot was cast, and the following five men who received the greatest number of votes were elected as members of the Executive Committe for th 1955-56 school year: B. L. Bergstrom, Oliver Corbin, Floyd Johnson, B. F. Jamison, and Doug White.
- 7. It was moved, seconded, and carried that second-place teams in baseball be permitted to enter the 1955-56 Central Group playoffs if they so desire.
- 8. Mr. Nelson, Treasurer of the Southern Section, presented the findings of a survey made to determine the possibility of the Southern Section assisting our outlying leagues in the expense involved in having officials assigned for their league contests. After much discussion it was moved, seconded, and carried that the C.I.F., Southern Section, upon written demand from the various leagues, would pay up to a maximum of \$25 per school to assist leagues in the expense involved in the appointment of officials for their contests.
- 9. The president was requested to appoint a committee to study the problem of the recruitment of officials for C.I.F. athletic contests. Mr. Bonnet appointed the following committee to

study this matter and report back to the Council at the December meeting: Mr. Art North, Principal, Temple City HS; Mr. Ted Gorrell, Principal, Baldwin Park HS; Mr. James Riewer, Vice-Principal, El Segundo HS; Mr. Lyle Martin, Principal, Claremont HS; and Ken Fagans, Commissioner of Athletics.

- 10. It was moved, seconded, and carried that the Commissioner of Athletics be authorized to secure a properly engraved gold-life pass to be presented to Mr. Harvey J. Holt, at the June 21 meeting of the Executive Committee, for his distinguished service to the C.I.F., Southern Section.
- 11. It was moved, seconded, and carried that the Southern Section Council extend its appreciation to outgoing President, Mr. Joseph Bonnet, of Fremont Jr. HS of Pomona, for outstanding service during his past term of office.

The meeting was adjourned at 11:40 A.M. in time for a delicious luncheon served to the Council members at Chaffey HS cafeteria. After the luncheon the Council members enjoyed the C.I.F., Southern Section Championship track and field meet held at Chaffey HS.

#### TEAM TENNIS TITLE TO LA JOLLA

A strong La Jolla HS tennis team defeated the Santa Barbara Dons 19-9 in the Finals of the large school division, to win the Southern California Championship on the courts of the Los Angeles Tennis Club, Friday, June 10. The La Jolla team showed exceptional strength throughout their lineup and this victory culminated an undefeated season for the netters of Coach McFuen.

In winning the championship, La Jolla HS took possession of the beautiful sterling silver loving cup donated by the Southern California Tennis Patrons Association, which is emblematic of the C.I.F., SS Team Tennis Championship.

In C.I.F. team tennis, eight boys (4 singles players and two doubles teams) make up the team. No boy may compete in both singles and doubles. Each singles participant plays one set with each of his four opponents; and each doubles team plays two sets with each of its two opponent teams. Each set won in singles scores I point, and each doubles set won scores 1½ points. In event of a tie in scoring, the total number of games won by each school in the dual match would determine the winner.

In the first round Santa Barbara defeated Ventura, Arcadia defeated El Rancho 19-9, Chaffey defeated Anaheim 19-9, and Muir defeated Loyola 16½-11½. In the second round Santa Barbara defeated Beverly Hills in a close match, Arcadia defeated L.B. Wilson, La Jolla defeated

Chaffey 23-5, and Santa Monica defeated Muir 14½-13½. In the semi-final round Santa Barbara defeated Arcadia 15½-12½, and La Jolla defeated Santa Monica 20-8, to go into the Final round to defeat Santa Barbara 19-9, in a hard fought battle.

### L.B. WILSON GOLFER WINS INDIVIDUAL GOLF CHAMPIONSHIP

Pinky Stevenson of L.B. Wilson HS, shot a par-breaking 68, to capture the C.I.F., SS individual golf championship on Tuesday, May 31, on the Montebello Municipal Golf Course. Shooting steady golf all day, Pinky was out in 34, and on the final nine he birdied the 18th hole to come in with a 34 and win the coveted championship.

Four individual trophies were given to the winners this year, and three boys shot a 69 to tie for 2nd place. In a sudden death playoff, Bob Meade of L.B. Poly was eliminated on the 1st hole and finished 4th. On the second playoff hole Jerry Gallardo of Cathederal took one less stroke than his brother Joe, to gain possession of the 2nd place trophy.

A record breaking entry list of 88 of the finest high school golfers teed off, with ten boys shooting par, or better, over the par 72 course. The weather was ideal and the C.I.F., SS wishes to express its appreciation to the Montebello Golf Course for permitting our tourney the use of its outstanding facilities. ## FREE LANCE GOLF LEAGUES

This year the C.I.F. Office conducted two free lance golf leagues to take care of seventeen of our schools who were unable to find enough schools in their league fielding golf teams. In the Northern league, Santa Barbara was declared the champion with Muir HS taking runner up honors. In the Southern league, two Long Beach

schools, Wilson and Poly wound up the season in an identical tie, with each school winning one victory over the other.

A playoff among the four top teams had been planned, but a full schedule of activities at the end of the school year, plus travel difficulties made it impossible for the four schools to get together in a playoff. Because the golf coaches had agreed in their spring meeting to hold the playoffs at the Montecito Country Club in Santa Barbara, and because the other three schools involved could not travel north, the team trophy and individual medals were awarded to Coach Clarence Schutte and his Santa Barbara golf team.

### RAIN MARS CLASS B & C TENNIS TOURNEY

The Class B & C Tennis Tournament held at Santa Ana High School's fine battery of courts on May 7 and 14th, was marred by rain which delayed the opening of play for two hours. Because of the inclement weather a number of entrants failed to put in an appearance and a few others unknowingly left before the play began. The sun finally made its appearance however, and the tournament was completed on schedule, with Chaffey HS winning the Class B title, and El Monte HS taking home the Class C Plaque.

Bill Barber of Santa Ana HS defeated Harry Coleman of El Monte HS 6-3, 6-3 to capture the Class B singles crown, while in the doubles two teams from Chaffey HS met in the finals with Ray Davis and Bob Garner triumphing over their team mates John Karlsten and Doug George in straight sets, 6-1 and 7-5.

In Class C the singles were won by Bob Engle of Victor Valley HS who defeated John Cownie of St. Monica's HS in a hard fought three set battle, 2-6, 7-5, and 6-3. Allen Snethen and Tom Cooksey of El Monte won over John Somedy and Gary Thrall of Chaffey HS 6-4, 6-3, to capture the Class C doubles title.

## THACHER WINS SMALL SCHOOL TEAM TENNIS CHAMPIONSHIP

This year for the first time, the C.I.F., SS team tennis championships were held in two divisions, with the small schools entering one division, and the large schools taking part in the other. In the small schol division nine league champions and one free lance school were entered in the competition, with Thacher School of Ojai, representing the Tri-Valley League, emerging as the champion.

Thacher blasted its way into the finals with clean cut victories over San Marino, free lance entry 20-8, and Barstow, Desert-Inyo League champions  $25\frac{1}{2} \cdot 2\frac{1}{2}$ . In the finals Thacher easily

defeated a strong team from Coronado HS 24½-3½. Interest in tennis was high this year, and the small schools welcomed the oportunity to compete for the coveted championship against schools of their own size. With this years playoffs being such a success we look for all leagues to be represented in the competition in 1956.

In the preliminaries Coronado defeated Helix, 21-7: Laguna defeated Army & Navy; Barstow defeated Puente; and Thacher defeated San Marino 20-8. In the semi-finals Coronado defeated Laguna 25½-2½; and Thacher defeated Barstow 25½-2½. Coronado and Thacher entered the finals, with Thacher emerging the victor, with 24½-3½.

#### BASEBALL TITLES TO MONTEBELLO, BASIC AND GROSSMONT

Close competition was the highlight of the 1955 C.I.F., SS baseball playoffs, which saw plaques being awarded to Montebello, Basic, and Grossmont high schools for winning the championships in the Central, Northern, and Southern groups of leagues, respectively. With good weather prevailing, all of the games were played as scheduled although a great deal of travel was entailed, because the semi-finalists in all of the groups came from the extreme limits of the Southern Section.

For the second successive year a strong nine from Fullerton HS was nosed out for the Central Group championship in a game played at Montebello City Park before an overflow crowd on Friday, June 10. In 1954, it was Loyola that defeated Fullerton 3-2, and this year they were turned back by a well-balanced Montebello team in 14 thrilling innings, 6-5. Going into the 9th it appeared that Fullerton had a safe lead of three runs, but Montebello put together three hits with an error and a couple of walks to score three runs and send the game into extra innings. Both starting pitchers, Dale Zeigler of Montebello HS and Fullerton's Gerald Runyan, went the first nine innings. The winning run was produced in the 14th inning as Fullerton's relief pitcher, Ken Enright hit Rodney Burrell with a pitch with the bases full. This scored catcher Ted Coutts with the run that gave the Montebello Oilers their first C.I.F., SS baseball champ-

The Northern Group Championship was decided on a play at the plate in the 9th inning that could have gone either way. When the dust had cleared away, the umpire had called the Basic runner safe with what proved to be the winning run. It gave Basic HS of Henderson, Nevada, the title over a strong San Luis Obispo nine, 5-4 in regular innings. To reach the finals Basic HS had narrow squeaks over Burroughs of China Lake 9-8, and over Mira Costa HS 6-5. San Luis Obispo defeated Villanova in the first round 4-3, and had an easy win over St. Francis of Flintridge in the Semis 11-1.

The Southern Group finals brought together teams from Grossmont HS and Puente HS in a game that was played in San Diego on June 3. After winning their first two games handily the Puente pitching staff fell apart in the championship encounter and Grossmont HS pounded out an easy 8-0 victory.

Interest was high in this years baseball playoffs, with all of the games being well attended, and it is too bad that more closed ball parks with adequate seating capacity are not available for our playoff games. At Montebello the stands were filled and hundreds of spectators were forced to watch the game from the extreme limits of right and left fields, or miss out on one of the classic prep playoff games of all time.

### 1955 TRACK AND FIELD CHAMPIONSHIP MEET GREATEST IN HISTORY

On Saturday afternoon, May 21, under ideal conditions, the finest track and field meet in the history of the C.I.F., SS was held before a near capacity crowd of over 2,000 enthusiastic spectators at Chaffey HS in Ontario. Before the meet was over one national and thirteen CS.I.F., SS records had been broken, or tied. The national record was set in the High Jump when Charles Dumas of Centennial HS, cleared 6' 8%" on his final try. This was a tremendous leap by a high school athlete, but even this outstanding mark was to last only one week as Dumas again raised the national standard in his favorite event by clearing 6' 9%" at the State Meet held in the Los Angeles Coliseum on May 28.

A new C.I.F., SS record was set in the Class B Pole Vault in the semi-final meet held at Huntington Beach HS, when Hammond of Grossmont cleared 12' 11" to erase the former record of 12' 10" set by Dick Vanderhoof of So. Pasadena HS way back in 1942. In the semi-final meet held at Compton HS, Jerry Hren of Inglewood HS vaulted 13' 8 15/16" to eclipse the old Class A record of 13' 7½" set in 1954 by a trio of Varsity pole vaulters. All records tied or broken in the meet at Chaffey are indicated in the results of that meet which are printed elsewhere in this Bulletin.

Coach Bill Gill's strong Centennial HS varsity showing exceptional strength in the hurdles,

dashes, high jump, and relay easily won the Class A team title when they ran up the amazing total of 44 points. Their closest competitor was Riverside HS which finished second with 15 points. In the Class B competition Grossmont HS edged out a favored Centennial team 181/2 to 17, to capture honors in that division. Close competition also prevailed in the Class C meet where Palm Springs HS won the championship by scoring 11 points to 101/2 garnered by Glendale Hoover.

### MINUTES—SWIMMING AND WATER POLO COACHES MEETING

A meeting of swimming and water polo coaches was held in the C.I.F. Office on Monday, June 6, 1955, for the purpose of formulating plans for their respective activities for the 1955-56 school year. The Minutes of the meeting were presented to the C.I.F. Executive Committee, and approved by that group on June 21, 1955, as follows:

#### SWIMMING

1. The following dates were established: C.I.F. INVITATIONAL SWIM RELAYS—

Prelims-Feb. 21, 3:00 P.M. @ L.B. Poly HS Feb. 21, 3:00 P.M. @ La Habra HS

Finals -Feb. 24, 7:30 P.M. @ El Segundo HS The first four teams from each preliminary meet will qualify by time for the finals.

C.I.F. CHAMPIONSHIP MEET—

Free Lance Qualifying Meets-April 27 @ 3:30 P.M.

- a. Whittier HS for schools in large Los Angeles Metropolitan area b. Santa Barbara HS for schools in north-
- ern area
- c. A high school in the San Diego area will be selected to hold qualifying meet for schools in southern part of section.

Prelims-Swiming: May 4, 3:30 P. M. @ Fullerton HS May 4, 7:00 P.M. @ El Segundo HS

Semi-Finals-Swimming: May 8, 3:30 P.M. @ Beverly Hills HS

Prelims-Diving: May 9, 3:30 P.M. @ Beverly Hills HS

Finals-Swimming and Diving: May 11, 7:30 P.M. @ Beverly Hills HS

Qualifications: Each league holding a swim meet may qualify four boys into the Prelims. The Free Lance meet at Whittier HS may qualify four boys into the prelims. The Free Lance meets at Santa Barbara and San Diego may qualify three boys into the Prelims. The six fastest boys in each Prelim will qualify for the Semi-Finals. The six fastest boys in the Semi-Finals will qualify for the Finals. Six divers in each class will qualify for the finals.

2. It was recommended that the C.I.F. Invitatational Swim Meet be discontinued for one year, and that the dates from March 19 through March 23, when the invitational meet has usually been held, be reserved for invitational swim meets to be conducted by individual schools. It was recommended that in 1956 the following four schools be given sanction to conduct these invitational swim meets: Beverly Hills, Redlands, Black Foxe, and a Coast League school.

The Commissioner of Athletics was directed to send a questionnaire to all schools in the Southern Section, inviting them to attend one of these invitational swim meets. Each school would be requested to indicate a first and second choice as to the meet they would like to enter. The Commissioner would then assign schools to the various invitational meets, keeping in mind choice of school, geography, and the relative strength of teams.

- 3. It was agreed that for the relays and championship meets each school in the Los Angeles metropolitan area must furnish, as part of their entry fee, a competent official. Space will be provided on the entry blank to list name of official who will serve. The manager of the meet will contact the officials needed.
- 4. For the championship meet it was agreed that the Smith "Official Diving Form" listing dives be completely filled out by each coach and sent to the C.I.F. Office with the official entry list. Diving entries will not be accepted unless accompanied by the diving forms.
- Once a contestant qualifies for the Finals, he is obligated to compete in that event or be disqualified from the meet.
- 6. In all C.I.F. swim meets the National Collegiate Rules will be followed except that in all free-style events, including free style legs in the relays, some part of the body must touch the wall in the turn.

#### WATER POLO

League Schedules— It was suggested that the Commissioner of Athletics draw up the schedule for the 1955 free lance water polo league, after receipt of confirmation of each school involved, of their official entry into the league. It is anticipated that the Coast and Citrus Belt Leagues will conduct their own league schedules, with the C.I.F. Office arranging two free lance leagues in the metropolitan and Orange County areas.

Playoffs—It was recommended that the 1st and 2nd place teams in the Varsity competition be eligible to enter the playoffs. A playoff will then be arranged by the C.I.F. Office to include the top two teams from the four proposed leagues. The playoff contests will start on Friday, December 2. Class A games will consist of six-minute quarters; Class B, five-minute quarters; and Class C, four-minute quarters.

Rules—The NCAA water polo rules will be followed except in scoring. In all water polo games in the C.I.F., Southern Section, 2 points will be allowed for a successful try for goal, with 1 point allowed for a successful penalty throw. In the last two minutes of a game, when a personal foul is called, if the offended team fails to score, the ball is in play. If the offended team scores on the penalty throw the ball is then awarded to the goal keeper of the scoring team who will put the ball in play.
