VILLANOVA CAPTURES CIF, SS "A" BASEBALL CHAMPIONSHIP

The Tri-Valley League continued its winning ways as its representative in the baseball play-offs, Villanova, captured the CIF, SS "A" baseball championship by downing a stubborn Costa Mesa nine, 6-5, in the final game, which was played before an overflow crowd at the Ventura College Field, on Friday, May 26, 1961.

In a way that would gladden the heart of any old radio soap opera fan, the Villanova Wildcats survived climax after climax to finally subdue their opponents in the 10th inning. At the end of regulation innings the score was 5-5, and it was not until three innings later that pitcher Steve Hovley literally won his own game, by crossing the plate on Mike Maher's perfect squeeze bunt.

Villanova got off to an early 1-0 lead, but Costa Mesa bounced right back to go ahead by scoring four big runs in the third inning. The Wildcats then rallied to post four runs of their own in the fourth inning to give them a lead which they held briefly until the Mustangs tied the score with a single tally in the top of the sixth. Steve Harper, a hard-throwing right hander, went the distance for Costa Mesa, and Riley and Hovley shared the pitching chores for the winners.

The victory was Villanova's 17th without defeat this season and brought the school its first CIF, SS championship in history. To reach the finals the Wildcats turned back Montclair Prep 6-1, Mission of S. L. O., 4-1, and then eked out a victory over Chaminade in the semi-finals 3-1.

Costa Mesa represented the always strong Orange League and after drawing a bye in the opening round, they disposed of Holtville 4-3 and Needles 5-2, to earn the right to participate in the championship game. Capturing second place in this strong playoff grouping is no mean accomplishment, especially for a school like Costa Mesa, which was activated only a few short years ago.

SAN MARCOS HS WINS TEAM GOLF TITLE

An outstanding group of prep golfers from San Marcos HS of Santa Barbara scored an aggregate total of 398 strokes, to capture the CIF, SS Team Golf Championship, which was held at the San Clemente Course on Monday, May 29, 1961. The five-man team representing San Marcos HS consisted of Buddy Allin (80), Corky Nelson (77), Steve Frank (80), Lee Robertson (80), and Dick French with an (81).

Defending champions Long Beach Poly took runner-up honors, one stroke back with a fine 399. Ventura finished third with Sierra winding up in fourth place. The tournament was not decided until the final contestant had posted his score. Jeff Lefebvre of Morningside, who had gone out in 40, needed only to turn the back nine in 40 to give his team the title. With a large gallery waiting on the 18th green, the final foursome holed out and it was learned that Lefebvre had taken 45 strokes on the final nine to give him a total of 85 strokes for the day and relegate his team to fourth position.

Low medal honors went to Steve Hallberg of Leuzinger HS, who shot a 71, the only par recorded during the day's activities. Tim Haap of Chaffey and Gary Lazane of Ventura posted respectable 75's on the long and difficult San Clemente Course.

The scores as a whole were higher than usual, due to the fact that the tees were placed well back and a strong wind bothered many of the golfers. The course was in perfect condition otherwise, and the personnel of the club cooperated to the fullest in seeing that the tournament operated smoothly and with a minimum of delay. Coach Ray Beaver of Capistrano HS served as Official starter and was responsible for getting the 124 contestants off in record time.

TOP GOLFERS PLAY IN CIF, SS TOURNEY

Terry Hartshorn of Long Beach Poly HS turned in a par 71 to capture top honors in the CIF, SS Individual Golf Tournament held at the beautiful Los Posas Country Club Course near Camarillo, on Monday, June 5, 1961. Ideal weather prevailed and when play was concluded, 35 boys had posted scores of 80 or below on this tricky and difficult par 71 course.

Runner-up honors were shared by Dick Nichols of Ventura and Bob Campbell of Redlands HS, who posted identical scores of 73. This necessitated a sudden-death playoff to determine who would get the second place trophy. With a large gallery in attendance the boys teed off on the first hole and Dick Nichols proved to be one stroke better than his talented rival.

A tie also occurred for fourth place when Ted Lyford of California HS, Buddy Allin of San Marcos HS, and Jim Tedford of Alhambra HS all scored 74's. In the sudden-death playoff Lyford captured the fourth place trophy and Allin and Tedford finished fifth and sixth, respectively.

A total of 117 boys, representing 52 schools, entered this year's competition. The majority of entries shot excellent rounds of golf, but as usual there were many boys entered by over-enthusiastic coaches who had no business being at this championship tournament. It is hoped that next year only the top prep golfers will be entered.

The 1961 tournament was one of the finest ever conducted in the Southern Section. The course was in beautiful shape and all of the facilities of the country club were placed at the

disposal of the contestants. The boys were permitted to play free practice rounds on Sunday preceding the event and the fine practice range and putting greens were available. In addition, members of the Ladies Auxiliary from the Los Posas and Saticoy Clubs volunteered to serve as official scorers. One lady accompanied each foursome for the purpose of scoring and we are deeply grateful to them for the fine service they rendered.

Marv Bergstrom and Arnie Saul of Ventura HS ably assisted in the management of the tournament and served as official starters and recorders for the day's activities. The CIF, SS would also like to express its appreciation to Pro Dick Mulvaine, General Manager Cliff Halstead, and the Los Posas Country Club for permitting us the use of its excellent facilities.

CIF, SS HONORS VETERAN EDUCATORS

Time was taken from the Southern Section Council meeting held at Norwalk HS on Saturday, May 20, 1961, for the purpose of honoring four men who are retiring from active school work but who have contributed so much over the years to the growth and development of the fine interscholastic athletic program in Southern California.

Because of the part each has played in the organization and successful operation of the Southern Section, each was presented with a gold life pass which will admit the bearer and his guest to any athletic event conducted by the CIF, SS or one of its member schools.

For the past thirteen years the San Luis Obispo League has been faithfully and ably represented on the Southern Section Council by Mr. George H. Flamson, Superintendent of the Paso Robles City Schools. Born at the turn of the century in Missouri, George was raised on a farm and then entered Park College in Missouri and received his B.A. degree from that institution. Moving west Mr. Flamson taught in different places until he arrived in Paso Robles in 1928, where he was employed as a science teacher.

Since 1928 George Flamson has served the Paso Robles City Schools in the capacity of teacher, coach, vice-principal, principal and in 1945 was made Superintendent. During this long tenure he was vitally interested in the inter-scholastic athletic program and found time to serve in various capacities in the San Luis Obispo athletic league, and did an admirable job as his league's representative on the SS Council. He retires this June with the good wishes of all of his countless friends in the Southern Section.

Mr. Ellsworth N. Green, retiring this June, has long been associated with Bonita HS. He attended Bonita HS as a student where he established school records in the 50 and 100 yd. dash and also served as President of the Student Body during the 1914-15 and 1915-16 school years. Graduating from Oregon State College, he began his teaching career at Lompoc HS, spent two years at El Centro and then returned to Bonita HS where he served in a most outstanding manner for the next 19 years.

Mr. Green coached 17 championship teams during his stay at Bonita HS and some of the athletic greats that he has helped along the road to stardom include Glenn Davis of West Point fame, Ewell Blackwell of the Cincinnati Reds, and Gordon Duval, a great college football player. As Athletic Director for the past 11 years, Ellsworth has also found time to serve the Tri-County League as Secretary, in which capacity he has arranged all schedules and kept

an accurate record of all proceedings.

When Walter W. Bell retired from active school work three years ago, the CIF, SS somehow overlooked honoring him due to the fact that he spent his last couple of years in the Long Beach School District serving in the Recreation Department. We are correcting that oversight, however, by presenting Walter his CIF, SS Life Pass, which he has so rightfully earned through his dedicated service to the SS interscholastic athletic program over the past 35 years.

Mr. Bell graduated from Springfield College in Massachusetts in 1915 and immediately entered Y.M.C.A. work which was just a stepping stone to the field of teaching and coaching where he served for over forty years. Most of Walter's service in Southern California has been connected with Poly HS in Long Beach. At various times he has served as teacher, coach, athletic director and head of the P. E. Department. He has been active in officiating and the number of young men that he has assisted through physical education and coaching would run into the thousands. We were very pleased to have you visit with us, Walter, and would like to extend you a cordial invitation to return at any time.

The last man to be honored was Mr. Oliver Corbin, who retires in June 1961 from his position as Principal of Covina HS. In addition to leaving his administrative duties at Covina, Oliver also found it necessary to resign as President of the SS Executive Committee and as SS representative to the State CIF Federated Council.

During the past ten years no man has given more of his time and effort in serving the interests of young athletes through the CIF, Southern Section, than Mr. Corbin. He has participated on numerous committees, served as state representative, in addition to many local offices and commands the highest respect of educators and especially those who are familiar with his many contributions to the school athletic program. Oliver has a solidarity and calm approach to the problem at hand which inspires confidence. Veterans such as he are largely responsible for the firm foundation on which the Southern Section and State CIF are built.

All of these men have contributed greatly to the development of our program, for which we extend thanks and invite them to attend our meetings and activities whenever time permits. They may be leaving our active ranks, but they will never be forgotten as long as high school boys enjoy athletic competition.

MINUTES OF CIF, SS COUNCIL MEETING, MAY 20, 1961

The final meeting of the CIF, SS Council for the current school year was held on Saturday morning, May 20, 1961, at Norwalk HS. The meeting was called to order by President John Landrum, Principal of San Marino HS, at 9:30 A.M. Official representatives from all leagues except the San Bernardino City, Pasadena Jr. High, and Academy were in attendance. Guests included Willard Redfern, VP of Norwalk HS, Buck Smith and Bill Worthington of Inglewood HS, Chuck Kane of Dominguez HS, Cleo Cordell of Paramount HS and Dave Wetherill.

1. It was moved, seconded and carried to approve the Minutes of the February 4 Council Meeting, as published in the March 1961 Monthly Bulletin.

2. It was moved, seconded and carried to approve the Minutes of the April 19 meeting of the Executive Committee, as read by the secretary.

3. At the last meeting of the Council the following motion was tabled: That the By-Laws of the Southern Section be amended to provide that a 10-day try-out period may be conducted after school, prior to the beginning of the second semester, for the purpose of trying out any boy who had not previously tried out for, or played on a high school baseball or track team in the school in which he is enrolled.

The motion was taken off the table and discussion ensued on the motion. It was then moved, seconded and carried to amend the motion to be effective for all spring sports in which after-school practice is permitted to begin on the opening day of the second semester. The amended motion then read as follows: A ten-day try-out period may be conducted after school prior to the beginning of the second semester, for the purpose of trying out those boys who have not previously tried out for, or played on a high school team in baseball, track, golf, tennis or gymnastics in the school in which he is enrolled. The motion passed unanimously.

4. Mr. Robert Ashton, chairman of the committee delegated to study and prepare recommendations pertaining to the regulation of spring football practice, reviewed the recommendations of his committee. It was then moved and seconded that Plan C, which would provide essentially the same system that is now being used, with present regulations being rewritten to make specific the number of days permitted, personal equipment that might be worn, type of equipment that can be used, and the type of activity that would be prohibited, be adopted.

After some discussion of the matter, the question was called for and a roll call vote with each representative giving the breakdown of the voting in his league was requested. The roll

call vote showed that of the 31 leagues voting, 24 favored the motion and 7 were opposed. The motion was thus passed. The breakdown according to schools showed that 12 favored Plan A, which would eliminate all spring football practice; 39 preferred Plan B, which would have permitted 15 days of spring football practice in full gear; and 151 schools desired Plan C.

5. Mr. Winston Nelson was called upon to review the recommendations of the Football Regulations Committee and the Executive Committee relative to the format to be used for the Southern Section football playoffs in 1961. Mr. Nelson called attention to the Blue mimeographed sheet which outlined the plan providing for no change in the "AAA", "AA", "A", or Small School Football playoffs, but increasing the "AAAA" football playoffs from 8 to 16 competing teams.

Because the proposed change affected only the 14 representatives in the "AAAA" football playoffs, Mr. Nelson suggested that these leagues be polled to determine whether or not they approved the new plan. The leagues were polled and the vote was 12 to 2 favoring the expanded "AAAA" football playoffs for 1961.

It was then moved, seconded and carried to approve the recommendation of the Football Regulation Committee and the Executive Committee which provides that the 1961 Southern Section football playoffs be conducted as they were in 1960 except in the "AAAA" division which will be expanded to include 16 entries instead of 8.

6. Held over from the winter Council meeting was the proposal of the Freeway League to limit all playoff competition to varsity teams and performers. After some discussion it was moved, seconded and unanimously carried that the following regulation be included in our By-Laws: In track and swimming, sectional champions shall be determined in classes A, B and C; in all other sports conducted by the CIF, Southern Section, playoffs leading to sectional championships shall be conducted only in the varsity (A) classification.

7. Mr. Louie Joseph, Coast League representative, informed the Council that his league would like to see a rule adopted on the CIF, SS level which would prescribe and standardize the color of jerseys to be worn by the visiting and home teams in all football and basketball contests played between member schools of the Southern Section. The recommendation of his league was that teams should wear white at home and dark away from home.

Discussion brought out the fact that many schools did not have white jerseys and such a regulation should prescribe light and dark colored jerseys rather than white and dark. It was then moved and seconded that in all CIF, Southern Section football and basketball games,

the home team should wear "light" and the visiting team "dark" colored jerseys. The motion was defeated.

It was then moved and seconded that in all SS football and basketball contests the home school shall wear dark colored jerseys and the visiting school shall wear light colored jerseys. This motion was passed and will become a part of the By-Laws. This rule will apply to all teams in all classifications. If a team only has one set of jerseys, it will be their responsibility to notify their opponent in sufficient time in advance of any scheduled contest, so that proper arrangements can be made to make certain that both teams have contrasting colored jerseys.

8. Held over from the winter Council meeting was the matter relating to the length of quarters to be played in Class B, C and JV football games. After some discussion it was moved, seconded and carried to drop the matter at this time and move on to the next item on the agenda. The Commissioner was instructed to place interpretations of the present rule in our by-laws in the new edition of the Blue Book.

9. The State Federated Council at its last meeting referred to the sections the proposal that the present State Track Meet be discontinued in favor of a meet in the south and one in the northern part of the state. Mr. Nelson spoke in favor of continuing the present state meet. He pointed out that this one activity did a great deal to hold the state together, that it had significant values, particularly to the boys who participate, and that over the years it had developed into the finest prep meet in the country.

Mr. Spaulding, of the Freeway League, expressed the opposite viewpoint. He pointed out that when boys are sent over 600 miles one way to compete in such places as Chico, it was in opposition to National Federation and CIF philosophy which did not encourage athletic competition when the distance involved was greater than 300 miles, one way. It also was in variance with CIF policy which did not permit state competition in any other athletic activity approved by the various sections. A motion was then made and seconded that the SS representatives to the Federated Council be instructed to cast their votes in favor of discontinuing the present California High School Track and Field Meet, and to submit in its place two meets, one to be held in the south and the other in the northern part of the state. This motion was passed by a vote of 26 to 7.

10. President Landrum then requested permission to deviate from the Agenda for the purpose of making some special presentations. Mr. Roland Davis, Moore League representative, then was called upon to present a CIF, SS life pass to Mr. Walter Bell, former athletic administrator who is now retired. In like manner, Mr. Guy Warfel, Harry Bigger and Winston Nel-

son made presentations of CIF, SS life passes to Ellsworth Green, George Flamson and Oliver Corbin, respectively. Details of these presentations may be found elsewhere in this bulletin.

11. The next order of business was a review of regulations adopted last year pertaining to the number of contests permitted and the establishing of an opening date for the beginning of after school practice in basketball, baseball and track. Taking each sport individually, it was unanimously agreed that the basketball regulations had proved satisfactory and no change was needed. Some dissatisfaction was expressed concerning the number of interscholastic athletic contests permitted each school in baseball. It was then moved and seconded that the number of interscholastic baseball games to be permitted each school be increased from 18 to 20. The motion was defeated by a vote of 30 to 3.

Reverend Caruso, Parochial League representative, stated that his league was in favor of increasing the number of dual meets permitted in track from 9 to 12. He then put this in the form of a motion but it died for want of a second. The Commissioner explained that problems had arisen because of the limitation on the number of invitational meets to which a boy might enter. This matter was discussed but there was no motion forthcoming to change the present regulations pertaining to track and field.

12. Mr. Robert Schilling, Chairman of the committee established to conduct a survey and prepare recommendations pertaining to the limiting of athletic contests and establishing an opening date for after school team practice, informed the group that his committee had prepared recommendations for all sports that were not now regulated by the Southern Section. He called the Council members' attention to the recommendations as submitted on the white sheet and suggested that each sport be considered separately.

Each sport was then considered separately and for the purpose of clarity we are reproducing the final regulations that were officially adopted for all sports, effective with the beginning of the 1961-62 school year:

OFFICIAL OPENING DATE FOR AFTER SCHOOL TEAM PRACTICE

1. Cross Country—Opening day of school, each year
2. Water Polo—Opening day of school, each year
3. Wrestling—November 15, of each year
4. Golf—Opening day of second semester
5. Tennis—Opening day of second semester
6. Gymnastics—Opening day of second semester
7. Swimming—First day of school in January

OFFICIAL LIMITATION ON NUMBER OF CONTESTS IN EACH SPORT

1. Cross Country—9 dual meets plus 2 invitationals, league finals and CIF meets
2. Water Polo—12 games not including tournaments or Southern Section playoffs

3. Wrestling—12 dual meets not including tournaments, league finals or Southern Section playoffs
4. Golf—16 team matches not including tournaments or Southern Section playoffs
5. Tennis—20 team matches not including tournaments or Southern Section playoffs
6. Gymnastics—10 dual meets not including tournaments or Southern Section playoffs
7. Swimming—12 dual or triangular meets not including invitational or Southern Section meets

13. The election of CIF, SS officers was the next order of business:

(a) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Winston Nelson as Treasurer of the CIF, SS for the 1961-62 school year.

(b) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Harold Wetzler for a term of four years as a member of the Executive Committee, representing Los Angeles County.

(c) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Frank O. Hopkins as a member of the Executive Committee, representing Orange County, for a term of four years.

(d) It was moved, seconded and carried to cast a unanimous ballot for the election of Frank O. Hopkins to a two-year term as the SS representative to the State Federated Council.

(e) In accordance with the CIF, SS constitution the San Gabriel League representative will succeed to the presidency for the 1961-62 school year. Mr. John Landrum, outgoing Council President, turned the meeting over to Mr. Emmet Larson, official representative from the San Gabriel Valley League.

(f) In similar manner the San Luis Obispo League representative, Mr. Bud Ewing, Principal of Atascadero HS, was announced as Vice-President of the Council for the 1961-62 school year.

Mr. Larson then took over as president and asked if there was any new business to come before the Council.

14. Mr. George Capatanos, representative from the Mountain-Desert League, reported that his league was very unhappy with the recent ruling adopted by the State Junior College Athletic Association which restricted the number of junior colleges a high school graduate might attend and be eligible to participate in athletics. After a brief discussion it was the consensus of opinion that this was a matter that the Southern Section had no control over, because it involved graduates of our high schools.

15. Mr. Charles Ronin, representative from the Citrus Belt League, called the Council's at-

tention to a little-known provision in the State Code, Section 11710, which provides that a school must notify parents in writing when a licensed physician is not to be present at any interscholastic athletic contest. As a result of this regulation, the Citrus Belt League is preparing a form letter to be mailed to parents of athletes appearing on each school's eligibility list stating the type of medical supervision that is provided. All principals are urged to acquaint themselves with this section of the State Code so that they may be aware of its implications and be better able to protect their schools from a damage suit in the event a boy would be injured in a football contest when a doctor is not present.

16. A unanimous vote of appreciation was given to Mr. John Landrum for the outstanding manner in which he served the Southern Section in the capacity of President during the past school year.

17. It was moved, seconded and carried to thank Mr. Ashton and Mr. Redfern for permitting the Southern Section the use of its outstanding facilities at Norwalk HS for the purpose of conducting this meeting of the Council.

There being no further business to come before the meeting, it was moved, seconded and carried to adjourn the meeting at 12:35 P.M.

NEW ATHLETIC LEAGUE ACTIVATED

The Condor League is the name selected by the representatives of six private schools in the Santa Barbara-Ventura area, who are making plans for the activation of this new CIF, SS athletic league effective with the beginning of the 1961-62 school year. The league will include Cate School of Carpinteria, Devereux School of Goleta, Dunn School of Los Olivas, Laguna Blanca School of Santa Barbara, Midland School of Los Olivas, and the Thatcher School of Ojai.

Serving as the first president of the new Condor League will be Mr. Anthony B. Dunn of the Dunn School in Los Olivas. Dana S. Redington of the Cate School will act in the capacity of vice-president and McDonald Halsey will be the league representative on the CIF, SS Council.

The league expects to sponsor full team competition in basketball, track, baseball and tennis and will, of course, send outstanding individuals to CIF, SS competition in golf, swimming and other individual sports when the boys performance merits. With a constitution already approved and a basketball schedule adopted for the 1961-62 season, this new league is looking forward to many years of spirited but friendly athletic competition under the framework of the CIF, Southern Section.

CHAFFEY HS HOSTS OUTSTANDING SS TRACK MEET

The CIF, SS's great Track and Field program for 1961 was brought to a most successful conclusion with the holding of the championship meet at Chaffey HS in Ontario on Saturday, May 27, 1961. Beginning with the preliminary meets on May 12 and continuing through the semi-finals and championship meet, competition was exceptionally keen, which resulted in 11 new SS records being established.

Forrest Beaty, Glendale Hoover's one-man track team, never looked better, as he captured the 100 yd. dash in the fine time of 9.6 and then raced to a new National record in the 220 yd. dash in the unbelievable time of 20.2. The track was lightning fast, and with an allowable aiding wind at his back, Beaty got a perfect start and continued to increase his margin until when he hit the tape he was 6 yards in front of his nearest competitor.

Another National record was set in the 440 yd. dash, when Ullis Williams of Compton HS uncorked a terrific kick to win in the fantastic time of 46.1. This race was run on one turn with all contestants being given staggers and remaining in their lanes during the entire race. Defending champion Williams broke his own SS mark in addition to lowering the present National standard, which is held by Dave Mills of Ohio at 46.6, set in 1958. Conditions all appeared to be satisfactory, so it appears quite probable that both of these marks will be accepted as new National records when the Track Committee of the National Federation holds their annual meeting the first week of July.

Other SS varsity records were established in the mile, shot put, and 880 yd. relay. In the mile run, defending champion Bruce Bess ran a heady race to record a 4:15.1 clocking, which erased the old mark of 4:16.9, set by Dale Story of Orange in the 1959 meet. The only new record in the field events found El Rancho's Bill Pace heaving the 12-pound shot 65' 2 3/4" to better the former standard of 62' 5 1/4", established by Clark Branson of Pasadena HS in 1957. Centennial High School's speedy 880 relay quartet lowered their own former record of 1:27.1, set in 1957, by turning in a fast 1:26.2, which was only a shade off the present National record.

There was no competition for the varsity team title, as Coach Bill Gill's Centennial Apaches ran up 26 1/2 points to easily outdistance runner-up Glendale Hoover which scored 15. Centennial's big guns were James Tucker, who picked up 9 points in the hurdles, a couple of outstanding sprinters and a fine relay team.

Team honors in the Class B division went to Dominguez HS of Compton, which scored 22 points to earn the right to the championship trophy. Most of Dominguez' points were tallied by Mike Douglas and Charles Kanoy, who scored

18 points between them in the sprints and hurdles. Vincent Orr in the shot put and a good relay team accounted for the rest of their scoring. Monrovia captured the second place team trophy by recording 10 1/2 points to barely nose out Downey and Muir, who finished with 10 points each.

Only one new record was set in the Class B meet when a speedy relay team from Monrovia posted a 1:05.7 to lower by .1 of a second the mark set by a Muir HS foursome in the 1959 meet. Another mark was tied as Mike Douglas of Dominguez HS won the 70 yd. hurdles in the fine time of 8.6 to equal the SS record established in 1957 by Wayne Sackett of Glendale HS.

Competition for the team title was much closer in the Class C division as Mira Costa and LB Poly battled right down to the wire, with the Mustangs finally coming out ahead of Poly by a narrow 15 to 14 1/2 margin. Western HS of Anaheim and Centennial were also contenders, and they wound up the day's competition with 12 and 11 1/2 points, respectively.

For the first time competition was held in the Class C 1320 yd. run and the results were amazing. In the semi-final meet held at Huntington Beach HS, Clarence Cregar of Downey won his heat in the remarkable time of 3:10.5, which was only .3 of a second slower than the Class B record. This mark held up for a new SS standard as Dennis Carr of La Habra won the event at Chaffey in the slower time of 3:11.7.

Wayne Perryman of Burroughs of Burbank captured the 660 yd. run in the outstanding time of 1:23.0, to eclipse the former record of 1:24.3, held by Nate McNeil of Centennial HS. In the broad jump another new record was set as Charles Steel of Rancho del Campo completed a fine leap of 22' 7 1/8". George Dingoian of Montebello replaced Bill Pace of El Rancho as the new record holder in the shot put, as he established a new mark of 59' 6 1/8".

Interest in track and field continues to increase in the Southern Section and all seven of our meets revealed outstanding performances and record-breaking crowds. This year for the first time we experimented with holding our preliminaries at night, but we received a bad break from the weatherman and cold weather made participating in, and watching these meets miserable. In 1962 we shall return our preliminary meets to Saturday afternoon events but will continue to hold one semi-final meet at night and the other on Saturday.

We are extremely grateful to the schools who made their fine facilities available for our meets and to the track coaches at the respective schools who did such a capable job of managing their assigned activities.

The managers and locations of our 1961 meets were as follows: Preliminaries were held at Mira Costa HS with Don Cogswell as manager, at Car-

pinteria HS with Lloyd Erhard as manager, at Bellflower HS with Dwight McCracken as manager, and at Arcadia with Bob Jackson as manager. Ernst Hartmann did his usual fine job of managing our semi-final meet at Compton HS, and Jack Rowan turned in a fine job in managing our other semi-final at Huntington Beach HS. The championship at Chaffey was a complete success, and the largest crowd ever to attend a track activity at Chaffey was in attendance.

SECOND PLACE TEAM CAPTURES "AAA" BASEBALL CROWN

For the second straight year a second place team took top honors in the CIF, SS "AAA" baseball playoffs, as Compton High School defeated El Segundo 8-6, in an extra inning thriller played at Bovard Field on the USC campus, Friday, June 3, 1961. Although they were runner-up to Lynwood in the tough Coast League, the Tarbabes hit their peak during the playoffs and their strong pitching staff carried them through to victory.

The championship contest found the usually steady Tarbabes making nine errors and twice blowing a four run lead. In the first inning, Joe Phears hit a 350-ft. grand slam homer and it appeared that Compton was well on its way to an easy victory, particularly when they added two

more runs in the top of the sixth.

A fighting El Segundo team that had come from behind in practically all of its playoff contests again faced up to the challenge and in the bottom of the seventh inning they exploded for four big runs to tie the score and send the game into overtime. In the eighth, the Eagles filled the bases with none out, but could not squeeze across the winning run as Compton's defense stiffened. The winning run came in the top of the ninth on two walks, a fielder's choice and singles by short-stop Jerry Hopkins and center fielder Ron Woods. Wunderlich got credit for the win and King receipted for the loss.

Unseeded and placed in the upper bracket, El Segundo came from behind in their opening round playoff contest to nip a strong Pius X nine 7-6, and set the pattern for things to come. They then traveled to Pomona to engage top-seeded Ganesha, and when the Giants committed nine errors, the Eagles advanced another step by a 3-1 score. The quarter finals found them beating Western High School of Anaheim, 4-2, to qualify for the semi-finals against Lynwood, another seeded team. This was another come from behind victory as El Segundo after being down 4-0, rallied to edge the Knights, 7-6.

Compton on the other hand knocked off Montebello, 3-2, took the measure of Arcadia, 7-1, and nipped St. Anthony in the quarter finals, 4-3. Their semi-final game found them pitted against Arroyo High School, which boasted of having the outstanding pitcher in the CIF, SS in the person of Jack Warner. This was a battle right down to the wire and Compton managed to eke out a victory in a well played game, 2-1, to earn the right to compete in the championship contest.

With 32 of the finest prep baseball teams in the southland entered in the CIF, SS playoffs, interest was high and nearly all of the games attracted capacity crowds. We are especially grateful to USC for permitting us to hold our championship game on their excellent facilities on Bovard Field. This fine college diamond made an ideal setting for this interscholastic championship contest.
