BALDWIN PARK SUCCESSFULLY DEFENDS CIF, SS GYM TITLE

For the second straight year Coach John Draghi's well balanced gymnastics team from Baldwin Park HS proved their superiority over other SS high schools as they ran up a record-breaking total of 129 points in the CIF, Southern Section Championship Gymnastics meet held before a capacity crowd of spectators at El Rancho HS, on Friday night, May 18, 1962.

Scoring in every event on the program, the Braves took an early lead and the final outcome was never in doubt. Lakewood HS scored 75½ points to take runner-up honors and they were closely followed by El Rancho HS with 67½ points.

The highlight of the competition took place in the rope climb, the first event on the program, when Steve Leidner of Muir HS established a new CIF, SS record with an outstanding time of 2.9 seconds. The former CIF, SS record was 3.3, so it is easy to see that Leidner's performance was a tremendous achievement. It was only one-tenth of a second slower than the accepted world record, which Steve tied in a dual meet earlier in the year.

Art Armendariz of Baldwin Park and Jim Amerine of Lakewood captured the eye of the crowd as they fought for top honors in the All-Around competition. When the final scores were in, Armendariz proved to be the winner by the margin of 1.3 points over his worthy adversary, Jim Amerine.

To reach the finals in the championship meet, boys had to qualify in one of three sectional meets which were held on Friday, May 11, at Baldwin Park, Pasadena and Lakewood High Schools. Schools were assigned to these preliminaries in an attempt to balance the strength at the three meets and also take into account the geographical location of the schools. All of the prelims were successful and the credit should go to the following coaches who served as meet managers: John Draghi at Baldwin Park, Dick Flood at Lakewood and Gene Peterson at Pasadena.

The championship meet was under the direction of Tom Eads of El Rancho HS, and his fine pre-meet planning and good organization resulted in one of the finest gym meets in the history of the Southern Section. The events moved along in rapid order and the presentation of awards was accomplished without delay, which made for an interesting evening for the fans fortunate enough to be in attendance.

**MINUTES OF EXECUTIVE COMMITTEE
MEETING OF MAY 18, 1962**

The meeting was called to order by Mr. Keith Gunn, Chairman, at the CIF, Southern Section Office, at 3:00 P.M., on Friday, May 18, 1962. Members present included Messrs. Winston Nelson, Asst. Supt. of Schools of Pomona; Marion Hays, Vice Principal of Harvard School; Harold Wetzler, Vice Principal of Hawthorne HS; Robert D. Ashton, Asst. Supt. of Schools for the Excelsior District; Robert Schilling, Asst. Supt. of Schools at La Puente; Arthur T. Hobson, Principal of California HS; Charles Ronin, Vice Principal of Redlands HS; and Kenneth Fagans, Commissioner of Athletics.

1. It was moved, seconded and carried to approve the minutes of the Executive Committee meeting of April 9, 1962, as read.

2. It was moved, seconded and carried to recommend to the Council that the Happy Valley School of Ojai be admitted to regular membership in the CIF, Southern Section.

3. It was moved, seconded and carried to recommend to the Council that the ten junior high schools comprising the Anaheim Union HS District be admitted to Associate membership in the CIF, SS, effective September, 1962.

4. It was moved, seconded and unanimously carried to direct the Commissioner to write to the Principal of San Bernardino and Dominguez High Schools to inform them of action taken to censure their track coaches for permitting boys to enter more than the prescribed number of events at the Mt. Sac Relays on April 27, 1962. The points scored by the boys in illegal events are not to count and all medals and plaques won as a result of the illegal participation by these boys are to be returned.

5. It was moved, seconded and unanimously carried to direct the Commissioner to write to the Principals of Upland and Holtville High Schools to inform them of action taken to censure their respective baseball coaches for violating CIF, SS regulations which prohibit a team from taking batting practice prior to a play-off game. Both teams were immediately removed from the 1962 play-offs upon confirmation of the violation.

6. It was moved, seconded and unanimously carried to direct the Commissioner to write to the Principal of Garden Grove HS to inform her of action taken to censure the swimming coach for violating a CIF, SS rule by permitting boys to compete in more than one Classification in the same calendar week.

7. After a review of an eligibility case involving Craig Mousel, a former student at El Segundo HS, it was decided that the boy would be eligible upon his return to El Segundo HS this coming semester and would be entitled to four semesters of eligibility. He will be ineligible during his senior year at El Segundo.

8. It was moved, seconded and carried to recommend to the Council that the following section be added to Article XXXII, of the By-Laws: Eighth and ninth grade boys from elementary or junior high schools may not take part in football practice at the high school. High school coaches may not conduct football practice at elementary or junior high schools involving boys from those schools.

9. It was moved, seconded and carried that the swimming violations of the Sunset League be reviewed at the next meeting of the Executive Committee.

10. It was moved, seconded and carried to hold the June meeting of the Executive Committee on Monday, June 18, at a place to be selected later.

There being no further business to come before the committee, the meeting was adjourned at 5:00 PM.

The water polo coaches in a special meeting, however, expressed the unanimous opinion that they would prefer to have the play-offs wind up in November. As a result of this meeting, the 1962 water polo play-offs will be held on November 20, 21, 27, and 30.

**REVISED AMATEUR RULE ADOPTED
FOR CIF, SOUTHERN SECTION**

For the past year a special committee appointed by President Hobson has been studying the problem of amateurism as it is related to the high school interscholastic athletic program. The definition and rules in our By-laws pertaining to this subject were found to be in some cases outmoded and even impractical. It was the opinion of the committee that we should start from scratch to write an amateur or non-professional rule for our organization.

After considerable study the committee drafted recommendations which were presented to our leagues for consideration. These were refined and revised and turned back for further study by our member schools. At the Council meeting held on May 19, an Amateur Rule was finally adopted as a part of our By-laws. It reads as follows:

AMATEUR RULE FOR CIF, SS

1. An amateur sportsman is one who engages in sports for the physical, mental or social benefits he derives therefrom, and to whom the sport is nothing more than an avocation.

2. The spirit of amateurism includes all that is stated in the definition above and more: a high sense of honor, honesty, fair play, and courtesy. It does not permit lowering one's self to petty technicalities, evasions of rules of play, or taking unfair advantage of opponents.

3. The following acts are among those considered as violations of amateurism:

A. Competing in any sport under an assumed name.

B. Competing in any athletic contest where any player or contestant of either team receives compensation, either directly or indirectly, for his participation in the contest.

C. Coaching or teaching athletics for pay.

D. Receipt of payment for services as an official in any sport. Reimbursement of actual travel expenses incurred in officiating would not be a violation.

E. Receiving directly, or indirectly, any pay or financial benefit in consideration of, or as a reward for, participating in any athletic contest.

F. Signing a contract for his services as an athlete.

G. Participating in a try-out for a professional or collegiate team at any time during the school year (September 15 to June 15).

H. Accepting payment for loss of time or wages while participating in athletics.

I. Participating in any athletic competition where cash prizes are awarded to members of any team. For example, a boy could not compete in a bowling league where money prizes were awarded.

J. Acceptance of material or financial inducement to attend a school for the purpose of engaging in athletics, regardless of the source of that material or financial inducement.

K. Acceptance of, or competing for, or participating in competition in which the awards were in excess of \$10.00 in value. This would apply to awards received from any source during the school year (September 15 thru June 15). Such award cannot be cash or a gift certificate. It may be a suitably engraved badge, medal, plaque, ribbon, picture, certificate or trophy. NOTE: During the summer months (June 15 thru September 15) a boy may receive an award in excess of \$10.00 if it does not violate the award rule of the AAU or the respective association controlling the sport in which he is participating.

L. Capitalization of athletic fame by granting or sanctioning the use of one's name to advertise, recommend or promote the sale of goods or apparatus to any person, firm, manufacturer or agent. (High school athletes should not accept any remuneration for permitting the use of their name or photo in school or community papers in connection with the promotion or sale of any type of merchandise.)

4. The following acts are among those not considered as violations of amateurism:

A. Caddying for pay shall not be construed as a violation of this rule.

B. Recreational, playground, or camp employment of a public or semi-public nature is not construed as a violation.

C. Reimbursement of actual travel expenses incurred in officiating or officiating services that are a part of several duties included in a job assignment in a recreation, playground, or camp employment will not cause a boy to lose his amateur standing.

D. Boys serving as life guards or water safety swimming instructors shall not lose their amateur standing, but receipt of payment for coaching for competitive swimming is a violation.

E. A competitor may accept reimbursement for the actual expenses which he incurred in transportation to and from a contest and for meals and lodging while on athletic trips without jeopardizing his amateur standing.

F. A boy may participate in professional baseball tryouts between June 16 and September 14, but no expense money may be accepted by a boy.

G. A boy may compete in an athletic activity that includes professionals provided the professional is not compensated, either directly or indirectly, for his participation in the activity.

5. One who has been declared a professional shall automatically be debarred from further competition during the remainder of that season and for one full year thereafter; and further until re-instated as an amateur.

PHOTO FINISH DECIDES VARSITY TEAM TITLE IN CIF, SS CHAMPIONSHIP TRACK MEET

One of the finest high school track and field meets ever held anywhere in the world was conducted before 9,000 avid fans on the outstanding facilities at Mount San Antonio College on Friday night, May 25, 1962. Attesting to the tremendous competition, there were ten CIF, SS records tied or broken in addition to the establishing of a new National Interscholastic record in the 180 yard low hurdles.

At the conclusion of the meet it appeared that San Bernardino and Glendale Hoover would be declared co-champions, as they each scored 16 points. A review of the slow motion pictures of the finish, however, clearly showed that an error had been made in placing the finishers in the varsity 120-yard high hurdle event. The judges had awarded Massengale of Centennial HS second place over Greenwood of San Bernardino HS, when it should have been the other way around. This reversal gave San Berdoo an additional point which ran their total to 17 and gave them sole possession of the coveted title.

Compton HS with a fine group of underclassmen scored 17½ points to capture the Class B title. They were closely followed by Muir with 15 and LB Poly and Redlands with 14. In the Class C division Santa Ana tallied 19 points to easily outdistance their nearest competitor, Glendale Hoover which accounted for 11 points.

One of the highlights of the meet occurred in the varsity low hurdles event when Tom Hester, a senior at San Bernardino HS, sped to a new National Interscholastic record of 18.3, which lowered the old mark of 18.4, which had been established just last year by Bill Mackey of Bakersfield HS. Hester was out of his blocks quickly and with an allowable aiding wind of 4.3 helping him along, he finished many yards ahead of his nearest competitor. The great distance separating him from the rest of this classy field gave an early indication that a new record was in the making.

In the night's most surprising event, Eric Berge won the pole vault in a marathon battle with Bob Richardson of Ganesha HS. Berge, whose previous best was 13'3", vaulted 14-5¼ to break the CIF, SS record of 14' set by John Rose of Glendale Hoover in 1959. Richardson also bettered the former record as he soared over 14-3¼, but he barely missed on 14-6 and had to settle for second place. Both of these boys tied for first place in the State Meet held one week later in a new record height of 14-3.

Forrest Beaty raced to a 9.5 clocking in the 100 yard dash to equal the CIF, SS record and had he secured a better start, he would most certainly have at least tied the National standard of 9.4. After a poor start Beaty was behind at the halfway mark but put on the steam at that point and still finished with an outstanding time

of 9.5. San Bernardino's fine 880-yd. relay team turned in a 1:26.2 clocking to tie the CIF, SS record set by Centennial HS in 1961.

Three new records were established and one was tied by performers in the Class B division. In the 1320-yard run Hill Daughtry of Glendale HS raced to a time of 3:08.1 to better the mark set last year by his rival from Hoover HS, Bill Anderson. George Clifford of Buena HS in Ventura, only a sophomore, heaved the 10 lb. shot 60' 2¼" to eclipse the old mark of 59' 10" set in 1960 by Dick Nye of Ventura HS.

In the 660 yard relay a speedy foursome from Redlands HS established the third CIF, SS record when they negotiated the distance in 1:05.3, to lower a mark of 1:05.7 set by Monrovia HS last year. A record was tied when James Miles of LB Poly recorded a 12.6 in the 120-yard low hurdles to place his name on the honor roll.

In the Class C division Larry Prielipp of Corona HS tied the established mark in the 120-yard low hurdles of 13.2. In the 440-yard relay the former record was 44.2 and a fine Santa Ana team getting off perfect passes bettered that record by recording a 44.0.

Two additional CIF, SS records were established in the semi-finals which stood up during the championship meet. One of them was in the C 1320-yard run when John Gregg, a senior at Glendora HS, turned in a fine 3:10.3, to lower the record from 3:10.5. In the B low hurdles the CIF, SS record of 8.6 was equalled by John Hertzberg of Sierra HS.

Invitations were extended to all former winners of an event in any CIF, SS Championship Track and Field Meet, to attend this year's finals as guests of the Southern Section. A special section was reserved for such winners and it was gratifying to note that over 60 of these former champions put in an appearance. I am certain that they must have been impressed with the performances turned in by the competitors in this year's great meet.

This was the first year that the Championship Meet was held at night and although the weather was chilly, the turnout was rewarding and the performances turned in by the boys was an indication that they were not affected by the weather. It will be up to the track committee to decide whether or not we will hold the 1963 meet on Friday night, May 24, or Saturday afternoon, May 25.

Four preliminary meets were held on May 12 at Millikan HS, Burroughs HS, Buena Park HS and Poly HS of Riverside. All of these meets were well attended and were conducted with a minimum of problems. We are extremely grateful to these four schools which made their fine facilities available for our meets and to the men who served as managers and officials for them.

The qualifiers from the Burroughs and Millikan meets advanced to the semi-finals which were held at Compton HS under the direction of

Ernst Hartmann, veteran SS track coach. The Compton meet was conducted in two hours and thirty minutes, which attests to the wonderful job Ernie did in planning and supervising this semi-final meet.

The qualifiers from Buena Park and Riverside attended a semi-final held at Bellflower HS under the management of Dwight McCracken. Mac had his meet well organized and the capacity crowd was treated to a well disciplined track activity.

Los Altos and La Puente HS served as co-hosts for our Championship meet and all members of their respective administrative and coaching staffs cooperated to the fullest to assure the success of this activity. They arranged for the hurdle crew, handled the scoring, took charge of the awards and in general supervised the myriad of details which go in to staging a meet of this magnitude.

MINUTES OF CIF, SS COUNCIL MEETING MAY 19, 1962

The final meeting of the CIF, SS Council for the current school year was held on Saturday morning, May 19, 1962, in the patio of the Helms Athletic Foundation. The meeting was called to order by President Arthur T. Hobson, Principal of California HS, at 9:30 A.M. Official representatives from all leagues except the Academy, Condor, Moore and Mt. Baldy were in attendance. Guests included Jim Gregg, Vice Principal at South Pasadena HS and Bill Mumma of Riverside Poly HS.

1. It was moved, seconded and carried to approve the minutes of the February 3 Council Meeting, as published in the March, 1962, Monthly Bulletin.

2. It was moved, seconded and carried to approve the minutes of the April 9 meeting of the Executive Committee, as published in the May, 1962, Monthly Bulletin with the exception of items 12 and 17 which concerned SS Courtesy Cards and a change in the dates for the 1963 CIF, SS "AAA" baseball play-offs.

The action taken by the Executive Committee in authorizing SS Courtesy Cards valid for admission to all athletic activities except play-offs was discussed. It was the feeling of many Council members that Courtesy Cards should be honored at all athletic activities including play-offs. The Commissioner pointed out that there were many problems arising in play-off contests because of the large number of Courtesy Cards being presented for admission. The matter would be particularly critical next year in basketball because we are to use the new Long Beach Sports Arena where every seat will be reserved. It was moved, seconded and carried that the action taken by the Executive Committee be amended to provide that Courtesy Cards be honored for admission to all athletic activities conducted by member schools or the CIF, SS except for the basketball play-offs. This information is to be printed on each card. To compensate for this restriction on basketball play-offs, the Executive Committee was directed to increase the number of complimentary tickets allotted to the participating schools in the basketball play-offs.

By not approving the action of the Executive Committee in changing the dates of the 1963 "AAA" baseball play-offs, the dates will remain as originally scheduled. So there will be no misunderstanding, the official dates for the 1963 "AAA" baseball play-offs are as follows: May 14, 17, 21, 24 and 28, 1963.

3. It was moved, seconded and carried to approve the minutes of the meeting of the Executive Committee, as read by the secretary.

4. Maricopa HS, which is at present a member of the Central Section of the CIF, formally requested transfer of membership to the Southern Section because of their location which makes competition with our schools more practical. The Central Section approves the transfer and the San Luis Obispo League has also

indicated they will accept Maricopa HS as a member of their minor division. It was moved, seconded and carried to accept Maricopa HS as a regular member of the CIF, SS, effective with the 1962-63 school year.

5. Member schools of the Southern Section winning sectional championships are continually faced with the problem of outside organizations desiring to purchase lettermen's jackets for members of the winning squad. As the cost of jackets runs considerably higher than the legal limit of ten dollars prescribed by our awards rule, many devious means have been attempted to circumvent the rule. As a possible solution to this vexing problem, the Commissioner suggested that the CIF, SS, prepare a chenille patch, properly engraved, for presentation to members of winning teams. This patch to be in appropriate colors and to be worn only on the school's official letterman's jacket or sweater. It was moved, seconded and carried to adopt a chenille patch to be awarded to members of teams winning CIF, SS championships and to authorize the Commissioner to design and present for consideration such a patch.

6. The next item of business concerned the grouping of leagues for play-offs in baseball and basketball for the 1963 season. To assist the Council in carrying out this matter the Commissioner surveyed all member schools to ascertain their anticipated enrollment in all grades for the coming school year. A chart was prepared which showed the average enrollment of the upper two grades of all schools in a given league and the average enrollment of all grades of all schools in a given league. It was interesting to note that when the leagues were listed in order with the one with the largest enrollment at the top, there was very little variance between the placement of leagues according to the two methods of determining average enrollment.

It was moved, seconded and carried to group the leagues for basketball and baseball play-offs for the 1963 season according to enrollment as follows:

7. Dr. Nelson Price, chairman of the CIF, SS committee appointed to study and prepare recommendations for changes in our By-laws, made his report. It was decided to consider each change independently and then take action after all of the recommendations had been studied. The recommended changes were as follows:

ARTICLE XXVII—Change Section 7 to read as follows: In football, water polo and baseball, no athlete shall be allowed to compete on two class teams in the same sport in the same calendar week. (Note: He would be an ineligible man in the second contest.)

ARTICLE XXIX — BASEBALL — Change Section 7 to read as follows: A baseball team will be permitted to participate in not more than two inter-school scrimmages which must be held prior to a team's first practice game. A school cannot engage in a scrimmage (competition of any type with another school) after a team has played its first game (practice, league or tournament). (An inter-school scrimmage is defined as one where no score is kept, umpires are not paid, free substitution is allowed and coaches may stop play for the purpose of correcting mistakes of players.)

Add Section 14 as follows: In any baseball game where the coach is ejected from the contest for unsportsmanlike conduct, the game will be declared forfeited at that point.

Add Section 15 as follows: A baseball game will be declared official if the home team is ahead and it is necessary to call the game at the end of at least 3½ innings, or at the end of 4 innings if the

visiting team is ahead.

Add Section 16 as follows. If a game must be called for any reason other than unsportsmanlike conduct before the completion of an official game, the game is to be replayed in its entirety at a time mutually agreeable to both schools.

Add Section 17 as follows: If a baseball game is called after the fourth inning with the score tied, the game will be called a tie and will not be replayed unless it affects league standings at the end of the season, in which case the game will be replayed in its entirety at a time mutually agreeable to both schools.

ARTICLE XXX — BASKETBALL — Add the following section: When doubleheader basketball games are played, there shall not be more than 20 minutes elapsed time between the conclusion of the first game and the start of the second.

ARTICLE XXXI — CROSS COUNTRY — Add the following two sections:

1. Inter-school competition in cross country may not be held until all boys on the squad have had at least eight days of practice.

2. Schools will not be permitted to schedule inter-school scrimmages in cross country. Any inter-school competition in cross country must be counted as one of the permitted number of meets.

ARTICLE XXXIV — GYMNASTICS — Add Section 18 to read as follows: Any inter-school gymnastics competition will be considered as one of the permitted number of meets.

ARTICLE XXXV — SWIMMING — Add the following two sections:

1. Any inter-school swimming competition will be considered as one of the permitted number of meets.

2. During the regular swimming season, no high school boy shall compete in any meet other than a high school sponsored meet except that permission is granted for unattached individual entry into the AAU Championship Meet.

ARTICLE XXXVI — TENNIS — Add the following section: A tennis team will be permitted to schedule not more than two inter-school scrimmages which must be held prior to a team's first match (practice, league or tournament). (A scrimmage is defined as a practice session in which no team score is kept and players may be switched between singles and doubles at the discretion of the coach.)

ARTICLE XXXVII—TRACK AND FIELD Add the following section: Any inter-school track and field competition will be considered as one of the permitted number of dual meets.

ARTICLE XXXVIII — WATER POLO — Add the following three sections:

1. Inter-school competition in water polo may not be held until all boys on the squad have had at least eight days of practice.

2. A water polo team will be permitted to participate in not more than two inter-school scrimmages, which must be held prior to a team's first

practice game. (A scrimmage is defined as a practice session where no score is kept, the officials are not paid and coaches shall have the right to make free substitutions and halt play at any time for the purpose of correcting individual players.)

3. No school may enter more than two tournaments during the water polo season.

ARTICLE XXXIX — WRESTLING—Change Section 6 to read as follows: A wrestling team will be permitted to schedule and compete in a maximum of 12 dual matches or scrimmages during the regular season, not including invitational tournaments, league tournaments or CIF, SS play-off matches. Wrestlers who qualify for CIF, SS competition will be permitted following the close of the league season, to work out with boys from other schools who have also qualified for CIF, SS competition.

ARTICLE XXV—OUTSIDE TEAM COMPETITION—Add the following section: No school belonging to the CIF, SS, shall permit any of its teams to work out, practice or scrimmage with or against a team from any junior or four year college.

ADDITION TO ARTICLES XXIX THRU ARTICLES XXXIX—A member of a high school athletic squad is not during the season of a sport to try out, practice or work out with a college team or under the direction or supervision of a college coach.

It was moved, seconded and carried to approve all of the above changes in our By-laws.

8. The Committee on Regulations of the CIF, SS recommended that ARTICLE X, Section 7, of the By-laws, be amended by adding the following footnote: "This regulation does not cover active duty in a reserve program except in the case of a National emergency." It was moved, seconded and carried to add the above footnote to Article X, Section 7 of the By-laws.

9. The presentation of a CIF, SS gold life pass was made to Mr. C. W. (Bill) Mumma, veteran athletic coach from Riverside Poly HS by Charles Ronin, a member of the Executive Committee. Mr. Mumma will be retiring this June after 39 years as a coach at Poly HS. After graduating from Williams College in Chicago, Bill began his coaching career in 1923 with a C.B.L. championship football team. From then on he compiled an outstanding record as a coach in cross country, football, basketball and baseball. In 1959 he was selected for the Helms Athletic Foundation Coaches Hall of Fame. His influence and guidance of boys will be long remembered and all of his many friends wish him well as he takes up traveling, fishing and resting.

10. It was moved, seconded and carried to approve the revision of Article VI, Section 1 of the By-laws pertaining to our Amateur Rule, as published elsewhere in this Bulletin.

11. The election of CIF, SS officers was the next order of business:

(a) It was moved, seconded and carried to cast a unanimous ballot for the re-election of

Winston Nelson as Treasurer of the CIF, SS for the 1962-63 school year.

(b) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Robert D. Ashton for a term of four years as a member of the Executive Committee, representing Los Angeles County.

(c) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Charles Ronin for a four-year term as a member of the Executive Committee, representing the Citrus Belt area.

(d) It was moved, seconded and carried to cast a unanimous ballot for the election of Winston Nelson to a two-year term as the SS representative to the State Federated Council.

(e) In accordance with the CIF, SS constitution, the San Luis Obispo League representative will succeed to the presidency for the 1962-63 school year. Mr. Arthur T. Hobson, outgoing Council President turned over the meeting to Mr. Roland Ewing, official representative from the San Luis Obispo League.

Mr. Ewing in his capacity as President then inquired as to whether or not there was any new business to come before the Council.

Mr. Hobson, the retiring president, asked for the floor and expressed his appreciation for the fine support he had been accorded during the past year by all members of the Council. He stated that all men serving on the Council had a great responsibility to see that our fine inter-scholastic athletic program received proper direction and continued to serve the needs of the thousands of youngsters now participating. He was discouraged by the increased number of violations by coaches that had occurred during the past year and felt the Council should take heed and maybe institute a program of "moral re-armament."

12. Lyle Martin, representative of the Tri-County League, told of an article that appeared in a Pomona paper criticising the method employed in selecting teams for the 1961 football play-offs. He forwarded the article on to the Commissioner who answered it and pointed out the errors, but of course the damage had been done. It was Mr. Martin's opinion that the Southern Section should consider the possibility of employing a part-time person to handle public relations. After some discussion it was moved, seconded and carried to refer this matter to the Executive Committee for study.

13. It was moved, seconded and carried to express our thanks and appreciation to Bill Schroeder and Helms Athletic Foundation for permitting us the use of their excellent facilities for the holding of our meeting.

There being no further business to come before the Council, the meeting was adjourned at 12:15 P.M.

NEW SCHOOL WINS CIF, SS "A" BASEBALL CHAMPIONSHIP

Savanna HS of Anaheim in only its first year of existence accomplished something that many schools of long standing have failed to do, when they captured the CIF, SS "A" baseball championship by downing Lutheran HS of Los Angeles 5-3, in a game played at Bovard Field on Friday, May 25, 1962.

With only tenth and eleventh grade students, Savanna operated on a free lance basis this year and qualified for the play-offs by winning the required number of games. No one expected them to go far in the competition against league champions but they showed a fighting spirit and under the capable guidance of Coach Noel Sweeney went all the way.

In their opening game they blanked Aquinas, champions of the Arrowhead League and then traveled to Holtville where they were defeated 6-4. The victory was disallowed, however, when it was shown that the Holtville team had violated a CIF, SS rule by holding batting practice prior to the game. With this reprieve Savanna went on to eliminate the pre-tourney favorites Needles HS by a score of 6-1.

In the championship contest played before an overflow crowd, Savanna capitalized on two singles, a wild pitch and a passed ball in the eighth inning to score two runs and win the game. Lutheran had scored two in the bottom of the sixth to tie the score and when neither team could dent the plate in the seventh inning, the game went into overtime.

Lutheran HS, champion of the Olympic League, blasted Chadwick in a first-round encounter 11-1, and then edged Tustin 3-2 to qualify for the semi-finals. It is interesting to note that Lutheran has an enrollment of only 550 students compared to Tustin's 1800. Meeting a strong Chaminade team in the next round, Lutheran triumphed 7-3 to set the stage for the big game with Savanna. Both teams are to be congratulated on their fine showing and are to be complimented on the fine sportsmanship they displayed during the entire baseball play-offs.

Although out-hit by their opponents, Costa Mesa tapped San Marino's pitching wonder Mark Foss for four first-inning runs and made them hold up to capture the CIF, SS "AA" baseball championship by a score of 5-3, in a game played on a neutral diamond in Fullerton on Friday, May 25, 1962.

The big blow for Costa Mesa was a bases-loaded single in the first inning which accounted for two big runs. This seemed to demoralize the Titans momentarily and they committed two errors to let in two more runs. Although racked for 8 hits, Tom Gilman kept them well scattered as he limited San Marino to three runs for the day.

Costa Mesa wound up in a three-way tie with Orange and Santa Ana Valley HS for the Freeway championship, so all three teams were admitted to the play-offs. The Mustangs proved they were entitled to entry by nipping Servite 2-1, in a first-round game. Their next opponent was Pioneer HS and a classic contest was played, which resulted in Costa Mesa edging their opponents in a tense 1-0 struggle. Traveling north to engage the San Luis Obispo League champions, Atascadero HS, the Mustangs played one of their better games to win decisively 8-1.

The upper half of the draw was thrown into confusion when Orange HS protested a 2-0 victory scored by Upland HS because of the fact that Upland had taken batting practice prior to their scheduled contest. The protest was upheld and Orange advanced to the second round of the play-offs where they dropped another 2-0 decision, this time to San Marino HS. The Titans then made it into the finals by downing Santa Ana Valley 5-1.

DISQUALIFICATIONS MAR CIF, SS TEAM GOLF CHAMPIONSHIP

After four schools were disqualified for violation of the rule prohibiting practice on the tournament course the day preceding the tournament, California HS was declared the official CIF, SS Team Golf Champion by virtue of the aggregate score of 405 they posted in the tournament held at the La Cumbre Country Club in Santa Barbara on Monday, May 28, 1962.

California's first three boys came in with fine scores in the seventies, but their number four boy slipped to a ninety, which almost cost his team the championship. Their 405 held up, however, although they were hard pressed by a fine team from Burroughs HS in Burbank, which posted a 406 total which was one shy of the winning score established by the California team.

Low-medal honors went to a consistently fine performer from Pacific HS in San Bernardino, Lynn Audeoud, who shot a 72, the only par recorded during the day's activities. He was closely followed by Jim Furgo of Montebello HS and Buddy Allin of San Marcos, both of whom recorded sparkling 73's.

Thirty teams were entered in the competition, which meant that 150 boys participated in the tournament. This was more than should have been permitted to enter because it was after one o'clock before all the boys were on the course and nearly seven PM before the last boy checked in to the official scorer. Next year more strict qualifying requirements will be established.

Because La Cumbre is a private course, the management asked that none of the high school boys play the course on the Saturday and Sunday preceding the tournament. This is the first year that such a rule was in force and it was unfortunate that boys from four of our competing schools saw fit to violate this regulation and played one or more holes on Sunday. When the violations were confirmed, it was necessary to rule these teams ineligible and it proved pretty costly to San Marcos and L.B. Poly high schools because they posted aggregate scores under 400 and would have been the winner and runner-up had some of their boys not violated the rule.

Clarence Bishop, golf coach at the host school San Marcos, and Bob Mortensen ably assisted in the management of the tournament and served as official starter and recorder for the day's activities. The CIF, SS is indeed grateful to these two men and the La Cumbre Country Club for permitting us to use their outstanding facilities for the holding of this fine prep golf tournament.
