## BUSBY PROPELS MUIR TO CIF CROWN, 24-21, OVER POLY; McCULLOUGH SETS NATIONAL MARKS IN BOTH HURDLES



RECORD BREAKER—Earl McCullough, Long Beach Poly ace, equalled the national record in the highs and bettered it in the lows to highlight the CIF, SS, track finals at Cerritos College. McCullough's times were 13.7 and 18.1.

Come-through performances in the 100, 220 and relay by Harold Busby, who has been fighting a series of injuries since early in the season, sparked Muir High to its second straight CIF, Southern Section track championship before nearly 11,000 fans at Cerritos College on May 29.

Busby, won both the 100 (9.7) and the 220 (21.6) and anchored the Mustang relay team to a first (1:26.7), was a question mark performer right up until meet time. After the 100, Busby applied heat to his injured limbs, until 10 minutes before the start of the 220. He did the same after the 220 until the relay.

Muir won the team title 24-21 over Long Beach Poly, but it was the Jack-rabbit's hurrying hurdler, Earl McCullough, that provided the record crowd with most of its thrills.

In the first running event on the program, the 120 yard lows, McCullough hooked up with Steve Caminiti of Crespi and Roger Moody of Corona, a pair of speedsters who had both equalled the national record of 13.7

McCullough won that one in 13.7 while Moody was close in 13.8 and Caminiti 13.9.

Then in the lows the cast of characters changed, but the outcome was the same. McCullough blazed to an 18.1s, bettering the existing national mark by .2 and trimming Caminiti and third place Greg Heet. Earl, who weighs just 160, but runs like a full-back, also anchored the Poly relay team to a second place, gaining on Busby but not able to overtake him.

While Muir and Poly were battling for the Varsity team title, Millikan of Long Beach waltzed to the C championship behind the triple-threat sophomore Greg Ward. All Ward did was win the 100 (9.9) the 180 (17.4) and anchor the 440 relay team to a new CIF, SS, record of 43.7.

Garden Grove copped the Class B title behind the heroics of Stan Clark and Fred Crowe. Clark won the 100 (10.1) and finished second in the 220 for nine points while Crowe was second in the 1320. The relay team was also second, running the total to 17 points. Notre Dame was second in the B division with 11½ while Muir had 11.

La Mirada was runner up to Millikan with eight points.

Varsity Pole Vault star Paul Wilson of Warren did a "mere" 15-6 in his event after becoming the first prep to clear the magic 16-0 mark in the Compton semi-final on May 22. Wilson missed three attempts at 16-3.

Other CIF, SS, records came in the 880 where Devone Smith of Compton ran a 1:51.1 in a spectacular dual with Larry Arnett of Pasadena who also bettered Dennis Carr's old mark of 1:52.2. Arnett was timed in 1:51.6.

**The Name's the Same**

Huntington Beach High School will be divided into two separate schools next year, and although two principals will administer at two buildings the names will be the same — Huntington Beach.

Next year the old, but remodeled, building will house 1,700 freshmen and the rest of the student body will continue to attend classes in the new building.

Then, in 1965-66 the new building will become Marina High School and the remodeled building will again become the only Huntington Beach High School.

**High Desert Areas Strive to Solve Officiating Problems With Merger**

It's a long, long trip when a school team has to travel 150 miles or more one way for a game and then return the same night.

It's long, too, for an official who has to travel that distance, work a doubleheader, eat two meals away from home (with no compensation), receive meager mileage allotments, and earn for his services modest remuneration.

The situations described above, unheard of in the metropolitan Los Angeles area, are not at all uncommon in the outlying sectors of the CIF, SS, and just a slight exposure to the high degree of dedication and pure pleasure people in these areas receive from their athletic program is a reward in itself.

On a recent visit to the high desert country at the invitation of the Mojave Desert Officials Association, Commissioner Ken Fagans came away with a clear picture of the problems confronting this area as created by the tremendous number of miles traveled for athletic events.

In addition to a colorful tour of the Naval Ordnance Test Station at China Lake, which included an observation-tower vantage point for spectacular engine testing on the SNORT (Supersonic Naval Ordnance Research Track), the Commissioner discussed with members of the Mojave Desert Officials Assn. their ideas and plans for a new, consolidated organization. While the new association won't lessen the number of miles traveled, it may benefit the interscholastic program in other ways.

In the best interest of an improved brand of officiating, strengthening the day-to-day functioning of the association, and to more closely link the schools and the officials, a campaign is underway in the Mojave Desert Assn. to merge that group with those based at Antelope Valley, Barstow, and Owens Valley.

It is the general feeling in the China Lake-based association as well as the Antelope Valley group that a common point of administration is needed concerning officiating in this area. Problems have existed in the past due to tremendous distances involved between schools and overlapping of assignment areas.

One official pointed out a typical Saturday football assignment as follows:

7 a.m. leave China Lake for Bishop (150 miles)  
10 a.m. arrive at Bishop  
11 a.m. work "B" game  
1 p.m. have lunch  
2 p.m. work Varsity game  
4 p.m. head for home  
5 p.m. stop for dinner  
8 p.m. arrive at China Lake

This particular official didn't complain about the fact that he had to purchase his own meals on the road, received just 4¢ per mile for automobile expenses (none if he was a passenger), in addition to receiving the modest fees and spending an entire Saturday away from his family.

One could tell from his discussion, which centered more on the game than on his own problems, that he was a member of a somewhat diminishing breed of official—the one to whom money is not the prime concern but rather who is more interested in helping to promote today's exciting program of interscholastic competition.

Under the temporary chairmanship of Ray Varner, president of the China Lake-based Mojave Desert Officials Assn., the new group is now in the process of reorganization.

It is hoped that each sector—Antelope Valley, Barstow, Owens Valley, and China Lake—will elect a vice-president and secretary who along with the president of the total group will form the directive board of the association.

Each sector will hold its own meetings except for a series of seasonal clinics which will be presented to the total body at the beginning of each sport season and special sessions called by the Board.

The association hopes that through this merger it will be able to establish a top-flight training program, encourage new officials to join the organization, stimulate interest in joining the local booster clubs for meetings and discussions, and establish a common voice for the desert area in dealing with the total officiating program in the Southern Section.

Following the day-long meeting with officials and brief discussion with school representatives from Barstow and Victor Valley, it is believed that, the new Mojave Desert Officials Assn. is ready to get off the ground and on its way to becoming a solidified organization.

It's still 150 miles from China Lake to Bishop but the gaps which once existed between schools and officials may be lessening.

**Lynwood Wins "AAA" Baseball Title With 7-1 Decision Over Arcadia**

Pitcher Greg Conger ran his season-long winning streak to 14 and wound up a brilliant high school pitching career by hurling Lynwood to a 7-1 win over Arcadia in the "AAA" championship game before 2100 fans at Blair Field in Long Beach on May 29.

Conger, who wound up with a nifty 1.33 ERA for the campaign, allowed more hits (eight) than in any game during the season but after Lynwood jumped on Bill Seinoth for five runs in the first two innings the issue was never in doubt.

Leadoff man Barney Mills opened Lynwood's half of the first with a line shot off the left field wall some 360 feet from the plate. Mills scored on an infield error and the Knights were off and running.

In the second Seinoth ran into a streak of temporary wildness and walked three Lynwood hitters. This, combined with three singles, including a bases loaded job by Dennis Sutherland accounted for four more Knight tallies and for all intents, the title.

Conger, the crafty lefty with the sneaky-fast fast ball, the tantalizing

curve, fanned eight Apaches while walking just one. Seinoth walked seven and fanned one.

The win was a fitting climax to the prep coaching career of Knight mentor Ron Squire who moves on to Mt. San Antonio college and the job of helping the Mounties retain their newly acquired State Junior College baseball championship.

Lynwood, top-seeded in the "AAA" playoffs, finished the season with a 23-2 record while Arcadia, a late comer after losing three league games in the first round of Pacific League play, finished with a 18-7 mark.

Enroute to the championship, Lynwood routed Palos Verdes 9-0; topped Arroyo 7-2; smashed Western 12-1 and trimmed Glendale 3-0.

Arcadia nipped Fontana 7-6; edged Serra 3-2; blanked Anaheim 4-0; and kayoed Mayfair 3-0.

Post-game award presentations were made by Kenny Myers, representing the Los Angeles Dodgers and by Robert Ashton, member of the CIF, SS, Executive Committee. Highlighting the awards ceremonies was the presentation of the new perpetual baseball trophy, the B. L. Bergstrom Trophy, donated by Long Beach Poly.

The Bergstrom Trophy will rest in the Lynwood trophy case during the 1964-65 school year.

## Rubidoux Scores Three in Seventh; Trips Buena 3-2 for "AA" CIF Title

Rubidoux High scored three times in the bottom of the seventh to score a 3-2 decision over Buena High of Ventura and capture the first CIF, SS, championship in the history of the school on May 29 at Evans Park in Riverside.

The victory earned Rubidoux the "AA" baseball title and preserved a perfect season for pitcher Mike Corkins who recorded his 16th victory without a loss. Corkins gave up only two hits, two walks, and struck out seven...but trailed 2-0 going into the home half of the last inning.

Catcher Roger Test and Jim Gomez opened the last frame with base hits for the Falcons and after moving up to second and third, both men scored on a line single by Frank Zuniga.

Zuniga later scored the winning run on an error.

Buena had scored both of its runs in the second inning.

The win was not only a tribute to the calibre of baseball in the Tri-County League (Upland finished second in the "AA" playoffs last year) but was a tribute to the league itself which will not operate as the Tri-County League next year.

With relegating juggling teams in the Citrus Belt Area, the teams assigned to the Tri-County will represent two counties. Thus the league has voted to re-name the circuit the San Antonio League. The new Ivy League, into which Rubidoux moves, will also pick up other teams from the old Tri-County.

Rubidoux gained the finals, after winning the league championship without tasting defeat, with wins over Barstow (10-2), Palm Springs (6-3) and South Pasadena (4-0).

Buena advanced to the finals with a 3-0 shut out of San Luis Obispo; a 3-2 decision over Lompoc; and a 5-1 win over Cantwell.

## MINUTES OF CIF, SS, EXECUTIVE COMMITTEE MEETING — MAY 6, 1964

A special meeting of the CIF, SS, Executive Committee was held at the Los Angeles Athletic Club on Wednesday, May 6, 1964. In the absence of Chairman Keith Gunn, the meeting was called to order at 3:30 PM by Acting Chairman Nelson Price. All members of the committee were in attendance.

1. NEW SCHOOLS ADMITTED TO MEMBERSHIP—It was moved, seconded and carried to recommend to the Council that the new Troy HS of the Fullerton U.H.S.D. and the Imperial HS of Pasadena be admitted to regular membership in the CIF, SS, effective in September, 1964. It was then moved, seconded and carried to recommend to the Council that the Sinaloa Jr. HS of Simi be admitted to associate membership in the CIF, SS, effective, September, 1964.

2. APPROVAL OF FOOTBALL PLAY-OFF REQUIREMENTS FOR NEEDLES HS — After a review of the 1964 Football schedule of Needles HS, it was moved, seconded and carried that in order to qualify for the CIF, SS, Small School Football Play-offs in 1964, Needles HS must win all but two of the following seven games on its schedule: Imperial HS, Sept. 25; Calipatria HS, Oct. 3; Blythe HS, Oct. 9; Boulder City HS, Oct. 16; Northridge HS, Oct. 23; Holtville HS, Oct. 30; and St. George HS on Nov. 6, 1964.

It was also moved, seconded and carried to grant permission to Needles HS to play the following out-of-state schools in football during the 1964 season; Dixie HS and St. George HS of Utah, and Parker and Seton Catholic HS of Arizona. This approval was granted because of scheduling difficulties encountered by Needles HS in completing a representative football schedule.

3. BASEBALL TEAMS PLACED ON PROBATION — Because the baseball teams at Pius X and Leuzinger High Schools violated Article XXV, Section 1, of the By-Laws, by playing a game against the USC Frosh team without permission of the Executive Committee, both teams have been placed on probation pending a review of the violation by the Executive Committee. This means that they will not be eligible to enter the CIF, SS, baseball play-offs even though they qualify by placing first or second in their respective leagues.

Article XXV, Section 1, provides that "No school belonging to the CIF, Southern Section, shall compete (scrimmage, work out or play) with any school or team outside the jurisdiction of the CIF, without the consent of the Executive Committee."

4. APPROVAL FOR BIG PINE TO BEGIN FOOTBALL PRACTICE PRIOR TO THE ESTABLISHED OPENING DATE — With an enrollment of only 70 students and located 300 miles from Los Angeles, Big Pine HS has a very difficult time completing a representative football schedule. Because of this it was moved, seconded and carried to permit Big Pine to schedule a contest with the JV team from Hawthorne HS of Nevada on Saturday, September 19, and to allow Big Pine HS to begin football practice on Wednesday, September 2, 1964, so they can complete their required 14 days of practice prior to the game.

5. ELIGIBILITY CASE — Reverend Lawrence Caruso, athletic director at St. Francis HS, and Mr. Lasbury, appeared before the Executive Committee to request a waiver of the eight semester rule to permit Allan Hammond two additional semesters of competition. Their request was based upon the fact that Allan was ill and absent from school 82 days while in attendance in the ninth grade of the local junior high school. Upon graduation from the ninth grade of the junior high school, Allan transferred to St. Francis HS, where he was required to repeat the ninth grade because of poor grades accumulated while in junior high school.

Because our rule permits only six semesters of competition after graduation from the ninth grade of a junior high school, Allan Hammond will be ineligible for interscholastic athletics during his twelfth year at St. Francis HS. The matter was thoroughly discussed, and it was pointed out this was a State rule which would mean that the Southern Section could only recommend and that final determination would have to be made by the State Federated Council. It was then moved, seconded and unanimously carried to deny the request for a waiver of our eight semester rule in the case of Allan Hammond.

6. RETIREMENT PLAN — Mr. Dan Coehlo of the Penn Mutual Life Insurance Company, Frank McCormick of Investors Diversified, and

William W. Russell, Executive Secretary of the State CIF, met with the Executive Committee for the purpose of reviewing and explaining changes in the Retirement Plan now in effect for the Commissioner of Athletics. A new contract was presented for consideration and the committee was brought up to date on all aspects of the plan. It was then moved, seconded and carried to recommend to the Council that the new agreement between the Commissioner and the CIF, Southern Section, relative to the Retirement Plan be approved. Nelson Price, president of the Council, was directed to present the matter to the Council at the next meeting, scheduled for May 9, 1964.

There being no further business to come before the committee, the meeting was adjourned at 5:30 p.m.

## SHARMAN NOW 10th HIGHEST CAGE SCORER IN CIF HISTORY

Jerry Sharman has jumped into the record book as the tenth highest single season scorer in the history of the CIF, SS. Sharman, whose dad is Bill Sharman, former star with the Boston Celtics and now head cage coach at California State at Los Angeles, scored 705 points in 27 games during the just-completed season.

His average of 26.11 is just .07 of a point behind Jerry Pimm (26.18), who is ninth on the list. Pimm played his prep ball at Montebello before attending Fullerton JC and U.S.C. He is now an assistant to Jack Gardner at the University of Utah.

Young Sharman, like his dad, made a good many of his total points from the foul line. In Rio Hondo League play, Jerry hit 91 per cent in 12 games. His seasonal mark was 83 per cent.

While it would be logical that Jerry would be headed for California State at Los Angeles, his Charter Oak coach, Lee Powers, indicates that he could turn up at either U.S.C. or Mt. San Antonio College.

## GOSS TOPS

Incidentally, Freddie Goss is the all-time leading scorer in the CIF, SS, having scored 987 points in 1961 for a 31.8 point-per-game average. John Rudometkin, now with the New York Knickerbockers of the N.B.A. is second . . . 30.2 in 1958.



## MINUTES OF CIF, SOUTHERN SECTION COUNCIL MEETING — MAY 9, 1964

The final meeting of the CIF, SS, Council for the 1963-64 school year was held on Saturday, May 9, 1964, at Harvard School in North Hollywood. The meeting was called to order at 9:30 a.m. by Dr. Nelson Price, President of the Council, with representatives of all but the Tri-Valley League in attendance.

The following guests in attendance were introduced: Mr. Neil Philips, principal, Long Beach Poly; Mr. Al Schoenfield, publisher, Swimming World Magazine; Dr. Norgard, superintendent, Rancho del Campo School District; Mr. Jack Booker, athletic director, Muir High School; Mr. Doc Sooter, President, Southern California Interscholastic Basketball Coaches Assn.; Mr. Skip Rowland, President, Southern California Interscholastic Football Coaches Assn.; Mr. Tex McKown, Vice President, Southern California Interscholastic Football Coaches Assn.

1. MINUTES APPROVED — It was moved, seconded and carried to approve the minutes of the Council Meeting of February 8, 1964, as published in the March, 1964, Monthly Bulletin.

It was moved, seconded and carried to approve the minutes of the Executive Committee meeting of March 7, 1964, as published in the April, 1964, Monthly Bulletin.

It was moved, seconded and carried to approve the minutes of the Special Meeting of the Executive Committee of May 6, 1964, as read by the Commissioner of Athletics.

2. REPORT OF COMMITTEE TO STUDY "OFF SEASON" PRACTICE—Mr. Carl Fisher, representative of the Bay League and acting chairman of the committee appointed last year to study "off-season" practice in CIF, SS, approved sports, presented to the Council the final recommendations of his committee.

Following his report the following action was taken:

a) It was moved, seconded and carried to adopt proposal number one which reads: "... that closing dates be established for each CIF, SS, approved sport. After the closing date of any given sport, no organized team practice may be conducted by a member school or its representative during the remainder of the academic

year, unless otherwise approved." The closing date is interpreted to be the final practice, league or play-off game in a given sport.

b) Under proposal 2, dealing with Team Practice During Physical Education Period, the committee was in unanimous agreement that this is a problem which should be controlled on a league level or by the individual school rather than on the CIF level.

The committee did recommend that no organized team practice be conducted during regular physical education periods outside of the season of the sport but that no rule be adopted to this effect on the CIF, SS, level.

It was moved, seconded and unanimously carried that the Council support the position taken by this committee but agreed that no rule should be instigated in this regard.

c) The third proposal was split into two areas for purposes of discussion.

It was moved, seconded and unanimously carried that "although restrictions must be maintained relative to football practice during the summer vacation period because of the danger of injury, the need for insurance and the necessity of having protective equipment, restriction should not be placed by the CIF, SS, on high school boys participating in other athletic practice and competition during the summer period."

It was moved, seconded and unanimously carried that Article XXX, Section 9, be removed from the Blue Book. This is the rule which prohibits a basketball coach from sitting on his team's bench during the playing of a summer league basketball game. It was felt that this rule had not proven successful inasmuch as it did not prohibit a coach from instructing his team in summer league games from other sections of the gymnasium by means of signals, runners, et cetera.

d) The fourth proposal of the "off-season" practice committee asked for elimination of spring basketball leagues involving high school boys who have further high school basketball eligibility. It was felt by the committee that these leagues were conducted with no provisions made for insuring competitors while the boys competing, in many cases, were using school equipment, the school name, and being coached by the school coach.

After discussion of the matter, it was moved, seconded and carried to table this proposal until the November meeting of the Council.

### 3. CONSIDER AMENDING PRESENT RULE REGARDING EXCHANGE OF FOOTBALL FILMS

Skip Rowland, president of the Southern California Interscholastic Football Coaches Assn., reported to the Council that his association had conducted a survey of its members pertaining to rules of film exchange. A large majority of the coaches felt that the football exchange rule, as it appears in Article 32, Section 21, indicating that only by mutual agreement will films be exchanged, should remain in effect.

After much discussion it was moved and seconded to eliminate the rule. The motion was denied and the rule will remain as it is now stated.

### 4. BASKETBALL OFFICIALS REQUEST FOR RAISE IN FEES—

A request from the Basketball Officials Assn. for a raise in fees was presented to the Council last February and was referred to committee for further study. The committee met on several occasions and recommended to the Council that the raise be granted, giving the following reasons:

That a raise, which affects only the schools in the metropolitan Los Angeles area, will bring with it steps to improve and develop the over-all officiating picture. The committee recommended that whenever possible two sets of officials be assigned to work basketball doubleheaders. Officials would be classified as either certified or probationary, with certified men working the varsity game at night at \$15 and the probationary officials working the JV or B game at a \$6 rate.

The certified official would be required to attend at least one quarter of the preliminary game for the purpose of observing the new man's work. He would then offer suggestions for improving his efficiency and would complete an evaluation report to be submitted to the commissioner.

This procedure would assure a training program for new men and would retain many experienced officials, who are now quitting basketball officiating because they do not care to work doubleheaders.

A set of maximum fees for officiating tournament contests was also recommended by the committee.

It was moved by the Sky League representative, seconded and carried that the basketball officiating fees be raised as recommended and that this new fee structure be made a part of the By-Laws.

5. ADDITION OF TWO MILE RUN TO CIF, SS, TRACK PROGRAM—The Foothill and Pioneer Leagues were given permission this year to conduct the two-mile run on an experimental basis in league meets only, with the stipulation that they submit to the Council at the close of the season a report evaluating this event. Dick Cordano, representative of the Foothill League, submitted an excellent report and recommended that the two-mile run be added to the SS track program. Ted Gossard of the Pioneer League indicated that his league was also in favor of adding this event to the program.

It was then moved, seconded and carried that the two-mile run be added to the CIF, SS, track program for the 1965 season. The Commissioner was authorized to confer with a committee of veteran track coaches for the purpose of determining where in the order of events the two-mile run will be placed.

6. OFF SEASON PRACTICE IN WATER POLO AND CROSS COUNTRY—In line with CIF, SS, policy it was moved, seconded and carried to add to the By-Laws the rule, which has been used in recent years, that no organized team practice in water polo or cross country shall be conducted between September 1 and the opening day of school in any year. (Organized team practice shall be interpreted as meaning the association of a coach with future, potential team members for the purpose of learning or practicing skills of water polo or cross country.)

7. LIFE PASS AWARDS — CIF, SS, Life Passes were awarded to three men for their outstanding contributions over the years to the CIF, Southern Section, interscholastic athletic program. Dick Cordano made the presentation to Vaughn Cummings; Clair Franklin presented the award to Jerry Ogborn; and Dr. Nelson Price made the presentation to Lyle C. Martin.

8. CHANGE IN OPENING DATE OF PRACTICE IN SWIMMING—Mr. Dick Spaulding, Freeway League representative, informed the Council that his league was recommending a change in Article

XXXV, Section 2, pertaining to the opening date of practice in swimming. It was the feeling of Freeway League schools that a change from the present opening date of practice on the first day of school in January to February 1 would eliminate the requests for student schedule changes one month before the close of the semester; avoid conflict with winter season sports, avoid conflict with good P.E. and/or G.A.A. swim programs and bring the start of swimming into conformity with all other spring sports.

It was moved, second and carried to change Article XXXV, Section 2, to read: "Organized after-school team practice in swimming shall not begin prior to the first day of school in February."

9. CONSIDER CHANGE IN BY-LAWS PERTAINING TO HIGH SCHOOL GOLFERS COMPETING IN PRO-AMATEUR TOURNAMENTS—The Commissioner pointed out that there was a conflict between our award rule and amateur rule pertaining to high school golfers competing in pro-am events.

It was moved, seconded and carried that the Commissioner be instructed to meet with a committee of golf coaches and officials and report back to the Council at its next meeting.

10. PROPOSED CHANGE IN ARTICLE XXV, SECTION 1, REGARDING COMPETITION AGAINST NON-MEMBER SCHOOLS AND IT PENALTY — It was pointed out that the penalty prescribed in Article XXV, Section 1, which prohibits CIF, SS, member schools from competing against non-member schools dictates that "a school disregarding this rule SHALL be debarred from participation in that sport during the following season."

It was the feeling of the Executive Committee that this penalty was not in line with the seriousness of the violation and that possibly the section could be changed to read "a school disregarding this rule MAY be debarred..."

It was moved, seconded and carried that in Article XXV, Section 1, the wording be changed from "shall" to "may."

11. ELECTION RESULTS — Ballots were provided each league representative for the purpose of electing two new members of the Executive Committee, one each from Los An-

geles County and the Desert Area, and a representative to the State Federated Council.

a. Mr. Arthur North, principal of Arcadia High School, was elected to a four-year term as a member of the Executive Committee from Los Angeles County.

b. Mr. Clair Franklin, principal of Trona High School, was elected to a four-year term as a member of the Executive Committee from the Desert Area.

c. Mr. Keith Gunn, principal of Victor Valley High School and outgoing chairman of the Executive Committee, was elected to a two-year term as Southern Section representative to the State Federated Council.

d. In accordance with the CIF, SS, Constitution, the Sky League representative, Mr. Steve Miletich, vice principal of Beverly Hills High School, will succeed to the Council presidency for the 1964-65 school year.

12. ORIENTATION MEETINGS —It was suggested by Mr. Winston Nelson, CIF, SS, Treasurer, that more attention be given to the conducting of rules orientation meetings within the leagues as well as those conducted on an area-wide basis by the commissioner each year.

13. APPRECIATION — Dr. Price, before turning the gavel over to the incoming president, expressed his thanks to members of the Council for their dedicated service to education and to the continued betterment of interscholastic athletics.

Incoming President Miletich commended Dr. Price for his outstanding contributions to the CIF, SS, during the year, after which the Council responded with an ovation.

The President thanked the administration of Harvard School — Rev. William Chalmers, headmaster, and Mr. Winston Hays, vice principal — for their gracious hospitality in hosting the meeting.

There being no further business to come before the Council, the meeting was adjourned at 12:05 p.m.

For the fourth successive year, Baldwin Park High School reigns as gymnastics champion of the CIF, Southern Section. Coach John Draghi's powerful Baldwin Park Team more than doubled the number of points scored by runner-up El Rancho in coasting to the team championship in the finals which were held at Baldwin Park on May 15.

The Braves amassed 47 points to win the championship, followed by El Rancho with 22½, Muir with 13½ and Pasadena with 10.

Fred Siebum of El Rancho was the meet's high-point winner, scoring 13.

Individual titles for Baldwin Park went to Jim Chapman in the horizontal bar; Bob Teel in the rings; Richard Elkins in tumbling and Walt Hilleger in parallel bars. That's four individual champions in the eight-event program. Hilleger also won the parallel bars last year.

Other titles went to Garry Wullschlager of Muir in the long horse; Richard Pascale of Montebello in free exercise, Steve Pineda of El Rancho in rope climbing; and Siebum, El Rancho in the side horse.

Pascale, one week earlier, had won the National Free Exercise Championship in the AAU Finals held on the East Coast. He had been exempt from our qualifying meet to participate in the national's. Pascale finished second in long horse competition in the CIF, SS, meet.

Siebum in running up his 13 point total had his first in the side horse and added seconds in the rings and parallel bars.

Additional points for Baldwin Park, aside from the event winners were scored by Elkin who had a third in the long horse and second in free exercise.

Chapman scored a third in parallel bars in addition to his horizontal bars championship; Eugene Toth tied for fourth in free exercise; Larry Zamora was second in horizontal bars; Larry Alfaro third in the rings; Lloyd Neisler second in the rope climb and Jerry Knoll third in the same event; and David Kittrell fourth in side horse.

The Braves have not lost a Montview League dual match since 1957 and have won 64 straight dual meets against all comers dating back to 1959.

And people say "break up the "Yankees."

Qualifying meets were conducted at Pasadena, Millikan, El Rancho and California with the top three qualifiers in each event from each prelim advancing to the finals.
