LONG BEACH POLY WINS SIXTH "AAA" BASKETBALL CHAMPIONSHIP

Playing with all the assurance of the Globe Trotters, unseeded, but never outplayed in playoff games, Long Beach Poly captured its sixth CIF, SS "AAA" basketball championship in the history of the school, defeating Anaheim HS 46 to 39 before a capacity crowd of 5,200 at Los Angeles State College gymnasium Saturday evening, March 12.

The "Jackrabbits" have not been the most spectacular team to watch in their business-like manner of play. It has been team balance and ball control that for the most part enabled Coach Bill Mulligan's boys to win prep basketball's most sought-after honor, the CIF championship! Tom Sisk was Poly's high point man for the season, and there were games when Bruce Reichter, Willie Brown, Leddy Baker, and others were the stars, but the over-all concensus seemed to be that Poly was a team and every player a threat!

Third seeded Anaheim simply ran out of gas in the second half of the championship game against Poly. All of their playoff contests were tense, hard-fought struggles and the boys simply could not continue their torrid pace. After defeating Wilson 50 to 47 in a first round encounter, the Colonists had to battle through two overtime periods to outlast a fine Montebello team 50-49. The quarter-finals found them opposing Santa Barbara on the latter's court, and the victory was achieved in the last two seconds when Tom Ryan made a fine tip-in. The big victory for Anaheim was in the semi-finals when they ousted undefeated and top seeded Hoover of San Diego, 39 to 34, to advance to the final round of play.

One mark of a championship team is the manner in which it reacts to "breaks" of the game. Over the season, Poly refused to be bothered by temporary set-backs and maintained the composure necessary to win the big ones. A

shifting zone defense, a front court press, and a fast break on offense is a description of the game tactics used by the "Jackrabbits". One statement is certain, Poly didn't "back in" or have the benefit of one "hot" night to win. In successive games they defeated: Helix (3rd seeded), 50-48; Ventura (3rd place winner), 65-56; and in the finals, Anahiem. They won their last 14 games in a row finishing with a season record of 25-4.

The playoff surprise and somewhat disappointment to their rooters was San Diego Hoover. The "Cardinals" had a 27-0 record before entering the semi-finals but dropped the two final games to win 4th place in CIF standings. Unseeded Ventura won the consolation game with the Cardinals 53-50 to take third place.

This year, for the first time, individual awards were presented to members of the championship and runner-up teams in all three divisions. Assisting Commissioner Ken Fagans in presenting the awards were Mr. Winston Nelson, President of the State CIF; and Mr. Bill Russell, Executive Secretary of the CIF. With good sportsmanship prevailing throughout the two night's play, the tournament was a complete success and a wonderful experience for athletes and spectators alike—one that all will remember.

The facilities at Los Angeles State College were outstanding and the personnel in charge cooperated to the fullest in seeing that everything ran smoothly. To Scotty Deeds, Assistant Athletic Director, Mike Abbadessa, Building Supervisor and Don McCaleb, Public Relations Director go our sincere thanks and appreciation for their efforts in making this the finest playoff tournament in the history of the CIF, SS. We are looking forward to returning to LA State in 1961.

STARTING TIME FOR SANCTIONED **EVENTS**

Some confusion seems to exist relative to the rule adopted by the Council last May prohibiting sanctioned events from starting earlier than 3:00 PM on a school day. This rule was adopted to correct abuses that had developed over the years whereby sanctioned athletic activities were being scheduled during school hours, causing students to miss regular classes.

You are reminded that this rule applies only to events sanctioned by the CIF, SS Office involving schools from more than one league. It does not apply to league activities, dual or triangular contests, or Southern Section playoff events. For complete information regarding sanctioned events, we would like to refer all administrators and coaches to pages 56, 57, and 58 of the Blue Book.

EL SEGUNDO HS HOSTS SWIM RELAYS

The popular midwinter CIF, SS Swim Relays were brought to a successful conclusion before a capacity crowd of rooters in the El Segundo Natatorium on Friday night, February 26, 1960. The terrific competition resulted in seven new records being established as a result of the evening's activities. Two of the new records were set in varsity events, two in Class B, and three in the Class C division. With members of these record-breaking B and C teams moving up in competition next year, we can expect that more new marks will be written into the book

Coach Walt Puffer's fine team from Beverly

Hills HS captured top honors in the varsity division by scoring 38 points to runner-up California's 34. A sixth in the Medley, a third in the Back Stroke, a first in the 6 x 50 Free Style, and a record-breaking performance in the Butterfly was all that was needed to assure the Normans of the title. In celebration of their great victory, the members of the winning team unceremoniously tossed Coach Puffer into the pool, to the great delight of the spectators.

After sweeping all of the CIF Water Polo honors in the El Segundo pool, Whittier HS continued their winning ways by capturing team titles in the Class B and C divisions. Coach Frank Poucher saw his B team score 50 points to easily outdistance LB Poly, which wound up the evening with a total of 40 points. In the Class C competition, Whittier's boys came through in crucial events to tally 52 points while LB Wilson had to be content with 46, which was good enough to give them second place in the team standings.

Three preliminary meets were held this year for purposes of qualifying teams into the finals. Because some schools do not like to excuse boys from afternoon classes while others prefer not to participate in athletic events on a school night, two of the preliminaries were evening affairs while the other one was conducted in the afternoon. This enabled school administrators to have a choice in the matter of entering their team in either an afternoon or evening meet. The afternoon preliminary was held at California HS on Wednesday, February 24, under the management of "Hap" Waer. The evening meets were held on the same day at L B Poly and Morningside High Schools under the management of Coaches "Buzz" Thayer and Bob Hoffman respectively. We appreciate very much the fine job these men performed in seeing that their meets ran off smoothly.

Coach "Whitey" Saari of El Segundo arranged all of the details connected with the staging of our championship meet. Special provision was made for all of the contestants to sit on the deck of the pool, which freed the bleachers for spectators. Nearly 1,000 persons crowded their way into the limited facilities, which attests to the popularity of swimming in southern California. On behalf of the member schools of the Southern Section and the CIF Office, we would like to extend our congratulations and thanks to the meet managers and other school personnel who contributed so generously of their time and effort to assure the success of our swimming relays.

There were two many new records set in the relays for individual mention but the complete results, with new records established, are reproduced following this article.

SANTA CLARA HS SUCCESSFULLY DEFENDS CIF, SS "A" BASKETBALL **CHAMPIONSHIP**

Santa Clara High School's great basketball team lived up to its pre-tournament selection as the top-seeded favorite to capture the CIF, SS "A" basketball championship, when it decisively defeated Valencia HS 63-46, in a game played before a capacity crowd in the Fullerton J. C. gym, Friday, March 11, 1960.

With a veteran team returning, Coach Lou Cvijanovich and his team set their sights on their second straight CIF, SS "A" championship and they were not to be denied. After winning the Tri-Valley League title without the loss of a single game, the Saints defeated St. Agnes in a first round encounter 72-42, took the measure of Tehachapi 58-25, and topped Aquinas in the semi-finals 54-50, to earn the right to play in the championship contest.

The final game was all Santa Clara, as the end of the first quarter found them leading 12 to six. They maintained this superiority throughout the contest as Valencia, except for a brief second quarter flurry, proved no match for the speedy sharp shooting boys from Oxnard. Steve Miller led the victors with 16 tallies and was a power on the boards throughout the contest.

For the first time in many years, Valencia HS represented the Orange League in the basketball playoffs and their fine team proved an able representative. They hosted Ramona HS in a first round encounter which saw them win by the convincing margin of 62-39. Pasadena Academy offered the competition in the second round and they, too, fell victim by a 56-45 score. In the semi-finals, Valencia traveled north to meet Santa Ynez, runner-up to Santa Clara in the Tri-Valley League. This game was played on a neutral court and the Tigers won the hard fought contest 58-55, to earn the right to host the championship encounter.

With the Council approving the entry of second place teams in the playoffs, interest was high among the small schools of the Southern Section. Twenty-one teams, the largest number in the history of small school competition, qualified for first round play and all of them are to be congratulated on their fine showing. Only one team can emerge the champion and claim the trophy, but all of these fine teams exhibited wonderful sportsmanship and we are certain benefitted from the experience of competing against representatives from other leagues in the Southern Section.

BASKETBALL RULE CHANGE TO BE ENFORCED

Three years ago a new rule was adopted pertaining to the numbering of basketball jerseys. California applied for and was granted permission to delay the enforcement of a penalty for the violation of this rule until schools had an opportunity to dispose of jerseys recently purchased. At the recent meeting of the CIF Federated Council it was moved, seconded and carried that all secondary schools in California be notified that effective during the 1961-62 season, Basketball Rule 3, Section 4, shall be effective for Varsity team jerseys.

For the information of all concerned, this rule reads as follows: "Each player shall be numbered on the front and back of his shirt with plain numbers of solid color contrasting with the color of his shirt, and made of material not less than 3/4 inch wide. The number on the back shall be at least 6 inches high and that on the front at least 4 inches high. NEITHER OF THE SINGLE DIGIT NUMBER (1) OR (2) NOR ANY DIGIT GREATER THAN 5 SHALL BE USED."

POINT LOMA CAPTURES CIF, SS "AA" BASKETBALL CHAMPIONSHIP

Starting with a rush and maintaining pressure throughout the game, Point Loma defeated San Marino 52-36 to win a well-deserved victory and the CIF, SS "AA" basketball title in the second of three games played before a capacity crowd of enthusiastic supporters in the spacious and beautiful Los Angeles State College Gymnasium Friday, March 12, 1960.

In winning the "AA" championship, Point Loma demonstrated control of both backboards and displayed a team of fine shooters. Pacemaker for the winning Pointers with 24 points and key-man in their fast break was Winston Yetta. This fast break offense, along with a tough zone defense, enabled Point Loma to pile up its wide margin of victory.

The pre-tournament favorite to win "AA" honors was defending champion San Marino. The Titans have been frequent contenders for "AA" championships and after their sterling performance in the semi-finals, when they easily defeated a good Orange varsity 74-51, it was expected that they would retain their title in the championship contest. An ankle injury to Bud Wegge and a cold night of shooting eliminated any chance Coach Garland Lewis' boys had for victory.

Point Loma qualified for the semi-finals by edging Beaumont 32-29 and defeating Yucaipa 55-23 and Bosco Tech 54-37. In the semi-final contest, played in the Point Loma gym, the Pointers experienced difficulty in winning over the San Luis Obispo League champions, Lompoc. The final score was 51-40, although the issue was in doubt until the final few minutes of the contest. Point Loma finished with an overall season record of 18 victories and 9 defeats. This does not appear to be too impressive, but when you take into account the fact that 6 of the 9 defeats were suffered at the hand of "AAA" powerhouses like Helix, San Diego Hoover, Lincoln and San Diego, you can readily see that the Pointers have a real fine ball team.

The win regained some of the lost prestige for San Diego fans who were disappointed when top-seeded Hoover did not return the coveted "AAA" title to the border city. CHANGE IN STATE BOXING RULE

At the May 29th meeting the CIF Federated Council referred to the CIF Sections a proposed revision of the boxing rule. It was moved, seconded, and carried that the CIF By-Laws, Article VIII C-"Boxing" be revised to read as follows:

- "(1) The CIF prohibits boxing as an interscholastic sport.
- (2) Any boy who takes part in an exhibition of boxing not under the direct and exclusive control of his school shall be debarred from further high school athletic competition of any kind for a period of one year from the date of the last offense.
- (3) For the purpose of interpretation, an exhibition shall be considered as consisting of a demonstration where the public is invited, an admission charge is made, a contribution solicited, a collection taken, or awards given in excess of \$10 in value. It will be deemed not to be a violation of the CIF rule for a boy to take boxing lessons at a club or camp and to participate in a program of boxing culminating from these lessons; provided, that no admission is charged, nor collections solicited, nor awards given in excess of \$10 in value, nor the public invited, but attendance is limited to parents and club members.
- (4) Boys who participate in "Golden Gloves" tournaments make themselves permanently ineligible for CIF competition.
