MINUTES OF THE CIF-SS EXECUTIVE COMMITTEE MEETING

January 13, 1984

A meeting of the CIF Southern Section Executive Committee was held in Anaheim, California on Friday, January 13, 1984. The meeting was called to order by President Dr. Robert Packer at 11:16 a.m. All members were present.

- 1. MINUTES -- It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of December 1, 1983 as mailed.
- 2. COMMISSIONER'S UPDATE -- Commissioner Ray Plutko reported to the Committee the new Sports and Public Relations Director will be Scott Cathcart. In addition, the Commissioner updated the Committee on the fall playoffs and the problems associated with moving the Big Five football finals to Cerritos College due to inclement weather. The Commissioner also shared with the Committee plans for next year, the Hall of Fame recognition awards program, the status of current eligibility cases, the unfortunate death of a Newbury Park High School soccer player and concerns relative to the number of soccer incidents.
- 3. BOYS' ATHLETIC DIRECTORS' UPDATE -- Mr. Mike Moropoulos updated the Committee on the activities of the various area Athletic Director's groups within the Section.
- 4. GIRLS' ATHLETIC DIRECTORS' UPDATE -- Ms. Sheila Burrud reported on the highly successful sectional, regional and state Girls' volleyball tournaments.
- 5. SUPERINTENDENTS' UPDATE --Ms. Cynthia Grennan updated the Committee on the status of Title 5, Chapter 2, Section 5531 of the Education Code as it relates to legislation dealing with the certification of walk-on coaches.
- 6. TREASURER'S REPORT -- Mr. Bruce Keuning provided an update of the 1983-84 working budget and the fall playoff incomes.
- 7. STATE FEDERATED COUNCIL --
- (A) REPRESENTATION FORMAT: Mr. Tony Balsamo reported on the current study being done by the Equal Opportunities Committee at the state level.
- (B) SECTION RELATIONS REPORT: Dr. Packer commended the Office for the communication recently distributed to member schools relative to the status of proposals forthcoming to the State Federated Council from the Section Relations Committee.
- (C) TRACK BODY SUITS: Following discussion, it was moved, seconded and passed to direct CIF Southern Section representatives to support National Federa-

tion rules and regulations for track relative to the wearing of school-issued shorts when full body suits are worn.

- (D) STATE MANAGEMENT FEES: Following discussion, it was moved, seconded and passed to direct CIF Southern Section representatives to vote for the newly drafted management fees for state playoff activities.
- 8. NATIONAL FEDERATION WINTER MEETING REPORT -- Mr. Tony Balsamo and Commissioner Ray Plutko reported on the National Federation Winter meetings held in Los Angeles in early January. Specific areas covered were the composition of the Executive Committee at the National level, the development of specific budget guidelines by the national governing body, concerns relative to problems associated with athletic eligibility of foreign exchange students, the development of a check and balance system as it relates to the changing of National Federation playing rules and regulations, status of the development of a TV manual drafted by the National Committee on Media and TV, of which Commissioner Plutko is a member. Additionally, the Committee was updated on the 1984-85 football playing rules and regulations with no major changes in the playing rules being evidenced.
- 9. LEGAL UPDATE -- Mr. Andy Patterson reviewed with the Committee litigation involving a handicapped student's participation in football and a soccer injury lawsuit.

- 10. MEMBERSHIP REVIEW -- Mr. Bruce Keuning reviewed with the Committee a proposal from the CIF Southern Section Membership Committee as it relates to membership requirements of schools falling into the category of California Youth Authority and Probationary Schools. Following discussion, it was moved, seconded and passed to take the proposal to the Council for discussion and possible action.
- 11. RIVERSIDE POLY BASKETBALL FOLLOW-UP -- The Executive Committee reviewed communication from the lyv League as it relates to the use of an ineligible player during the 1982-83 regular basketball season by Riverside Poly High School and with that information, Riverside Poly High School would not have represented the league as a playoff entry and so stipulated by the Ivy League constitution. Following discussion, it was moved, seconded and passed to vacate the boys' 1983 3A basketball title. All financial and individual awards will remain, with the school directed to return the championship team trophy. Further, it was moved, seconded and passed that the school be served an official censure and placed on a one-year probation with specific directions to review and reorganize where necessary itsadministrative procedures relating to eligibility checks of students.
- 12. TV AND RADIO CONTRACTS

CATHCART NAMED NEW CIF-SS SPORTS AND PUBLIC RELATIONS DIRECTOR

CERRITOS-- Scott Cathcart, formerly Assistant Sports Information Director at California State University, Long Beach, has been named Sports and Public Relations Director of the California Interscholastic Federation Southern Section.

Cathcart, 29, replaces Maggi Helms, who held the position for the past three years. He was assistant SID at Cal State Long Beach for a year and one-half before accepting his new post at the CIF-SS office.

While at CSULB, Cathcart played an active role in the publicity and staging of several Pacific Coast Athletic Association events in addition to the athletic program at Long Beach. These included the PCAA Football Media Day and basketball tournament as well as the championships of water polo, wrestling and track and field.

In addition, Cathcart has worked with NBC Sports in the coverage of NFL Football and as an intern sportswriter for the Orange County Edition of the Los Angeles Times.

Prior to his stint at Cal State Long Beach, Cathcart was an assistant football coach and football publicity director at Santa Barbara City College from 1977 through 1979. He left the athletic scene for a three-year period (1979-82) to enter into private business in Santa Barbara.

During his years at SBCC, Cathcart coached under Bob Dinaberg, handling the receivers and pass offense as the Vaqueros posted a three-year mark of 21-7. In 1979, SBCC won the Western State Conference Championship and went on to play in the Mission Bowl.

A 1977 graduate of Fresno State University, Cathcart was a scholarship athlete as a collegian, playing two seasons of football for the Bulldogs. He is originally from Santa Barbara, where he played football for his father, Sam Cathcart, who was the head coach at Santa Barbara High School for 19 years. Cathcart attended Santa Barbara City College before moving on to Fresno State.

WHAT'S HAPPENING' IN THE OTHER 49 STATES

ITEM: Coaches involvement with athletics out of season in the State of Kansas. Football, volleyball, wrestling and basketball coaches may not coach their athletes during the summer.

ITEM: School fined for ineligible player in the State of Alabama.

A school was fined \$250 and placed on a year's probation for using an ineligible player during a sport season. In addition all games were forfeited.

ITEM: Rules interpretation meetings in the State of Ohio.

Varsity coaches or school representatives are required to attend rule in terpretation meetings. Any school failing to meet this requirement is in eligible for OHSAA tournament competition.

OVER FIVE MILLION PLAY HIGH SCHOOL **SPORTS**

In pinpointing the scope of in-terscholastic athletics, the 1983 "Sports Participation Survey" conducted by the National Federation has revealed that over five million students participated in competitive sports programs offered last year by the nation's high schools.

Among the National Federation's member State Associations, the California Interscholastic Federation topped the nation in overall participation (445,559) and reported the highest totals for both boys (302,461) and girls (143,098).

Don't Be Caught Unprepared

CHECK THESE SAT & ACT TEST DATES

High School Students participating in interscholastic activities often find conflicts between CIF-SS events and college test dates. Students can find a date which avoids interscholastic events if they arrange to take the test on those dates which do not conflict.

High school counselors and principals are urged to call attention of high school students to test dates and schedules of CIF-SS events contained in the Southern Section Calendar so that test dates can be selected to avoid conflicts.

PLAYOFF GROUPINGS TO BE DECIDED

It's time once again for the CIF-Southern Section to issue its recommendations as to your league's divisional placement (4A, 3A, 2A, 1A, Small Schools) for the 1984-86 school years.

In case you've been curious as to the process used for assigning your league to a particular grouping, here's how it works: First, since leagues (not schools) re grouped into playoff divisions, a commication was sent from the CIF-SS Office to your league to submit suggestions or ideas to the CIF-SS Office no later than March 1, 1984. The Southern Section then uses these recommendations to develop an overall grouping in each sport division as an office recommendation back to your league.

At this juncture, those leagues objecting to their divisional placement are given the opportunity to appeal in writing to the Playoff Groupings Committee. Note leagues are given the appeals option only if they previously recommended changes or if they have been changed from their present status.

Early in April, the final recommendations of the Playoff Groupings Committee will be mailed to League Representatives.

Final disposition in playoff groupings will take place at the last meeting of the CIF-SS Council in May. Leagues which appeared in April that are still dissatisfied may forward a written appeal to the Commissioner's Office asking for time on the Council agenda.

As a separate item, we bring to your attention a directive from the CIF-SS Executive Committee which will create an additional grouping in some sports in the Small Schools Division in order that leagues with very small enrollment should not be placed in a grouping with leagues of far greater enrollment.

Overall, placement for leagues in the Southern Section is based on both average enrollment and success within a playoff grouping, particularly if it appears that a given school or league might perpetuate dominance. Additionally, placement could change based upon movement of schools from one league to another, which may alter the overall strength of a league.

The general meeting of the CIF Southern Section Council was called to order by Dr. WIN

The general meeting of the CIF Southern Section Council was called to order by Dr. Robert Packer at 9:30 a.m. on Thursday, January 19, 1984 at the Saddleback Inn in Norwalk. All leagues were present, with the exception of the Junior High School Representative.

- 1. APPROVAL OF MINUTES --It was moved, seconded and passed to approve the minutes of the CIF Southern Section Council meeting of September 22, 1983 as mailed; minutes of the CIF Southern Section Executive Committee of October 27, 1983 as mailed; minutes of the CIF Southern Section Executive Committee of December 1, 1983 as mailed, and minutes of the CIF Southern Section Executive Committee meeting of January 13, 1984 as distributed to the Council on January 19, 1984.
- 2. PRESIDENT'S MESSAGE -- Dr. Packer, President of the CIF Southern Section, commended those schools that participated in the 1983 fall playoff activities and extended his personal appreciation to Servite and Bishop Amat High Schools for their cooperation and efforts of the CIF-SS Office staff relative to moving the Big Five Championship football contest from Anaheim Stadium to Cerritos College on
- short notice due to the inclement weather. 3. COMMISSIONER'S UPDATE --Commissioner Ray Plutko reviewed with the Council the fall football playoffs, stadium concerns for 1984, concerns relative to an increasing number of soccer incidents and the untimely death of a Newbury Park soccer player, the Hall of Fame recognition awards program, and a manual being published by National Federation of State High School Associations that will be forthcoming in the area of cable TV. Commissioner Plutko also announced that Scott Cathcart has been hired as the new Sports and Public Relations Director for the CIF Southern Section.
- 4. TREASURER REPORT -- Mr. Bruce Keuning, Treasurer, reviewed with the Council the financial report of the fall playoffs and an update of the current working budget. In addition, Mr. Keuning reviewed with the Council a recommendation relative to the purchase of an IBM word-processor and data-processor system. Council was presented two plans by which the system could be purchased. One plan calls for use of \$5,000 which has been set aside in the present 1983-84 working budget (office equipment) coupled with a one-time \$47 assessment to member schools. The second proposal would be to finance the contract with a \$5,000 deposit over a three-year period as part of the CIF-SS working budget. This item will be an action item at the March meeting of the Council.

5. NATIONAL FEDERATION WINTER MEETING REPORT -- Mr. Tony Balsamo reported on the National Federation Winter meetings held in Los Angeles. Specific areas covered were the composition of the Executive Committee at the National level, the development of governance guidelines by the national governing body, concerns relative to athletic eligibility of foreign exchange students, the development of a check and balance system as it relates to changing of National Federation playing rules and regulations. Additionally, the Council was updated on the 1984-85 football playing rules and regulations, with no major changes in the playing rules being evidenc-

- 6. STATE FEDERATED COUNCIL REPORT -- Mr. Tony Balsamo reviewed with the Council items for the upcoming State Federated Council meeting of February 3-4, 1984. Major discussion was held with respect to the section relations report. Following the discussion, it was moved, seconded and passed to direct the CIF Southern Section state delegates to vote for the approval of part one.
- 7. CENTURY LEAGUE FOOTBALL CALENDAR -- Mr. Stan Thomas, representing the Century League, introduced a proposal calling for a adjustment in the football calendar, effective with the 1985-86 school year. Following discussion, it was moved, seconded and passed to reactivate the Season of Sport Committee to report back to the Council on all implications of this proposal relative to overlapping of the fall and winter season. This item, with input from the Season of Sport Committee, will be referred back to leagues for discussion and will be voted upon at the March 22, 1984 meeting of the CIF-SS Council. (Please note, the Century League has asked that the vote be delayed until the May meeting in order that the Season of Sport Committee be provided the opportunity to make its report in March).
- 8. BAY LEAGUE TRACK PROPOSAL --Mrs Melvina Marble, representing the Bay League, introduced a proposal calling for passage and recommendation to the State CIF that all sections return to the two-day State Track Meet format in lieu of the present regional format. The proposal calls for this to take effect with the 1984-85 school year. This item will be referred back to leagues for discussion and will be voted upon at the March 22, 1984 meeting of the CIF-SS Council.
- 9. OFFICIALS' FEES -- Gene Knott, representing the Officials Fees Committee, reported to the Council that a recent recommendation from the Sunset League relative to an adjustment in basketball officials' fees has been tabled until the current fees con-

ract expires.

- 10. SEAVIEW LEAGUE BASKET-BALL PROPOSAL Mr. Dennis Evans reviewed with the Council a proposal on behalf of the Seaview League which calls for the Southern Section to withdraw from the Regional and State playoffs for boys and girls basketball effective with the 1984-85 school year. Following discussion, it was moved, seconded and passed to approve the proposal by a 44-14 vote.
- 11. RELEAGUING PROPOSAL FOR 1984-86 -- Mr. Ray Plutko presented the respective releaguing proposals for the 1984-86 school years. Following discussion, it was moved, seconded and passed to accept the original proposal for the Citrus Belt and Northern areas.
- 12. CENTURY LEAGUE WATER POLO PROPOSAL -- Mr. Stan Thomas reviewed with the Council a proposal on behalf of the Century League calling for an amendment to Article 20, section 2008 of the Southern Section By-Laws which would allow a representative from the schools to be a coach or administrate a non-school sponsored team outside the season of sport with youngsters who have remaining eligibility at that school. Following discussion, the proposal was defeated by a 48-11 test.
- 13. COMMUNICATION FROM THE FLOOR -- Mr. Dennis Evans, representing the Seaview League, addressed the Council with concerns relative to the equity of competition between public and non-public secondary schools. The Chair directed the Commissioner to form a committee to look into the inquiry and report back to the Council prior to the close of this school year.

There being no further business to come before the Council, the meeting was adjourned at 11:43 a.m.


