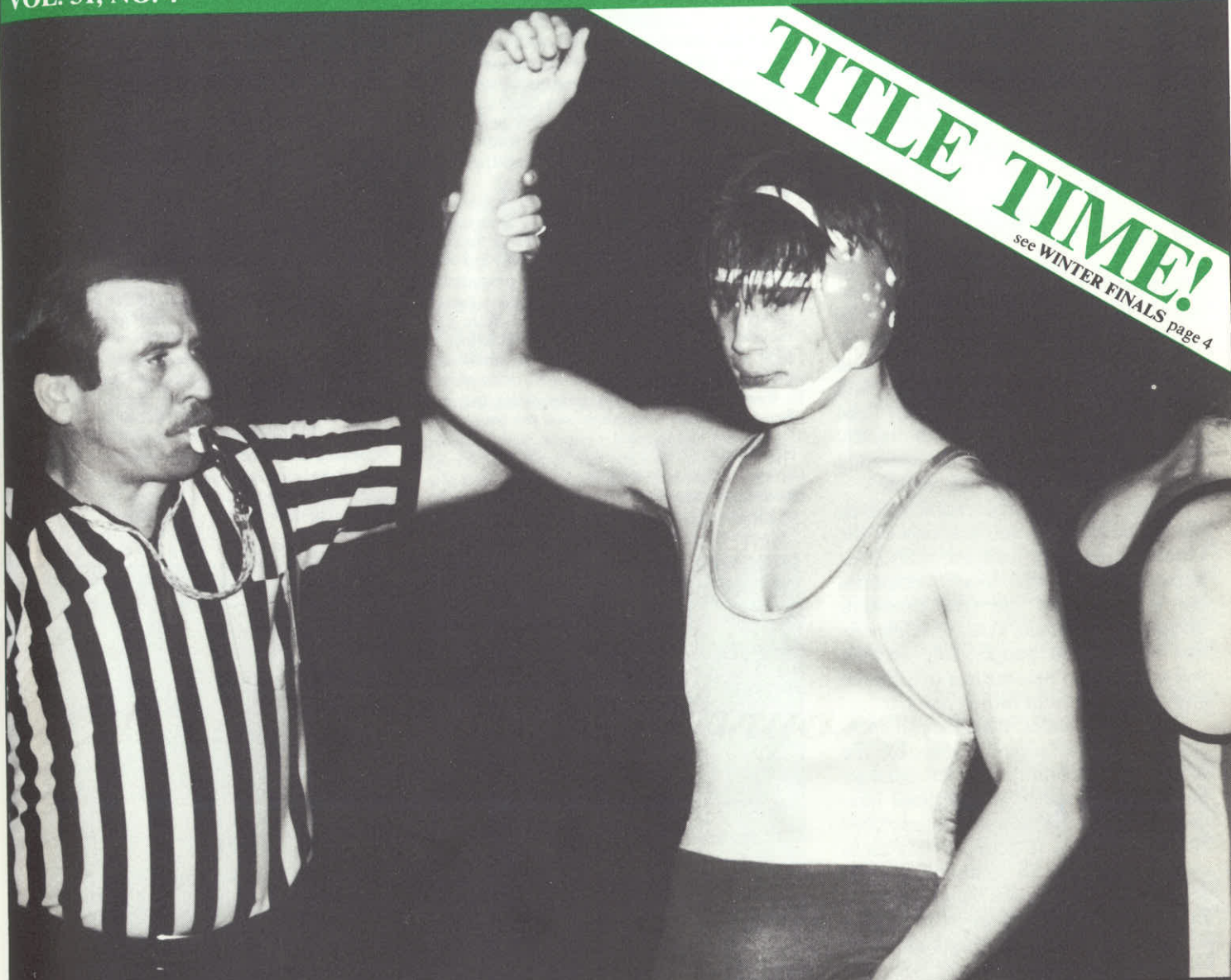

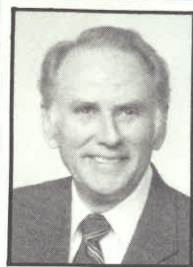

COMMISSIONER'S CORNER



**ROLE
MODELING
AND
PROFESSIONALISM**

Approximately two-thirds of the school year is behind us now, and our first two seasons of sport have been successful, yet marred with violent incidents. Can you ever recall a year in which more than one contest ended with athletes physically attacking game officials?

We have a serious problem in the area of role modeling for coaches relating to the example they set for their student-athletes during a season of play. Yes, television plays a role and we all have seen major-college and professional athletes, coaches and owners acting profane and rudely toward game officials, fans, opposing players and members of the media.

In the high school situation, it must always be the role and function of the coach to properly conduct himself or herself in a manner that exemplifies the standards of the CIF Southern Section. Without the grass root instruction from these people, our athletes will continue to become less disciplined and more violent in future years.

Coaches, athletes, officials and spectators have a responsibility to the school and community to conduct themselves properly and without incident during high school athletic contests. How tragic if those directly associated with CIF-SS activities cannot follow the organization's own Code of Ethics and provide direction to youngsters without profanity, argument and violence.

Yes, sportsmanship is the keynote of the National Federation for the 1989-90 school year. Sportsmanship was also the keynote at our Athletic Administrators Symposium in February. No matter what time of the year, no matter what level the contest, no matter how important winning may seem, the single ingredient that will carry our organization to its highest plane will be a

EXECUTIVE COMMITTEE MINUTES January 13, 1990

The January meeting of the CIF-SS Executive Committee was called to order by Chairman Dr. Tom Jacobson at 9:00 a.m. on Saturday, January 13, 1990 in Palm Springs. All members were present with the exception of Sheri Ross. Also in attendance was State CIF Commissioner Thomas E. Byrnes.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Executive Committee meeting of November 28, 1989.

2. PRESIDENT'S UPDATE - Dr. Tom Jacobson extended his appreciation to the CIF-SS staff for the very successful fall playoff activities, with a commendation to Administrator Bill Clark on the very successful football championships. He also reviewed with the Committee the upcoming Palmdale/Saugus, Victor Valley, Elsinore Christian hearings, and the time spent in preparation and deliberation of these matters. Additionally, Dr. Jacobson reviewed a media legal question with the Committee.

3. COMMISSIONER'S UPDATE - Commissioner Stan Thomas updated the Committee on the Superintendent's Survey regarding summer activities and a recommendation that the staff explore various aspects of summer programs as they relate to year-round schools, with a recommendation to be forwarded to the State CIF requesting a review of rules and regulations in light of the increasing number of year-round programs.

Commissioner Thomas pointed out that the Season of Sport Committee and the Blue Book Committee had rejected a request from Fillmore High School for an early start in pads for the fall of 1990 in football. Following discussion, it was moved, seconded and passed to deny the request of Fillmore High School regarding their request for an early start in football.

Commissioner Thomas reviewed with the Committee the area of corporate support and correspondence with regard to a "grant of rights" proposal with School Properties and the State CIF organization. Following discussion, it was moved, seconded and passed to reject the "grant of rights" proposal.

4. ATHLETIC DIRECTORS' UPDATE - Rich Ramirez, Athletic Directors' Representative, discussed the California State Athletic Directors Conference to be held in Burlingame, an important activity for all Athletic Directors in the State. With so many issues facing the school athletic programs, member schools need to support the State A.D. Association in granting athletic directors professional growth time to attend this important conference.

5. SUPERINTENDENT'S UPDATE - Cynthia Grennan, Superintendents Representative, updated the Committee with reference to current issues facing the State Department of Education and the State Legislature. These items included the Voucher System; Schools of Choice; Open Enrollment; All-year School; Kids at Risk; Secondary School Task Force; and the role and issues with regard to high school booster clubs.

6. TREASURER'S REPORT - Treasurer Ken Gunn gave a brief financial report of the fall sports championships and an update of the 1989-90 working budget. Additionally, he updated the Committee on schools that were still delinquent with reference to membership dues: Clearview, Flintridge Sacred Heart, Riverside Christian, and Valley Torah. Those schools who have not paid their State legal fees include Clearview, Crossroads (Santa Monica) and Salesian. It should be noted that schools failing to meet their obligations by January 18 will have their membership terminated, effective January 19, 1990.

KEEPING TRACK OF ELIGIBILITY

With the recent number of cases involving ineligible students, perhaps this would be a good time to evaluate current eligibility procedures. One of the first things that would trigger a red flag is a new or transfer student joining your athletic program. The name, address, date of birth and of course, who the student-athlete is living with, is of prime concern. A good working relationship with the Counseling Department could help you in isolating potential problems.

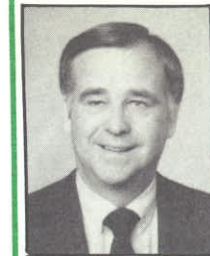
I am sure most of you have some type of procedure for identifying ineligible students, but if you don't, per-

haps the following check list will help you in identifying potential problems.

Never issue any equipment to any athlete without a clearance card. The clearance card should include:

- Name of student athlete
- Address
- Date of birth
- Grade
- Parents name and address
- Permission to participate in athletics
- Physical
- Insurance
- Grade Check:
 - Registrar _____ 2.0
 - Previous reporting period _____ if necessary for probationary status.

OUTSIDE COMPETITION

Of ongoing concern to the student-athletes, coaches and administrators of CIF Southern Section member schools is the eligibility status of students engaged in outside competition during the high school season of sport. The outside competition rule, outlined in Article 6 of the CIF-SS Blue Book, is one that should involve a periodic review between administrators, coaches and all student-athletes, regardless of their competitive level.

What is the eligibility status of a student who competes on an outside team during the season of sport?

It is not always the case that the student will be ineligible. Officially, individual students do not initiate their high school season of sport until they have personally taken part in an interscholastic contest. For example: If the high school team plays its first contest on Feb. 26 and the student did not compete in that contest, it would still be possible for the student to have competed on an outside team on Feb. 25 and then take part in the high school team's next contest (Feb. 28, for example).

Once the student has competed in an interscholastic contest, he or she will no longer be able to compete for the outside team in that same sport until the high school season has been completed. The example provided is in accordance with CIF State and Southern Section Rules 511, 600 and 601.

During the late winter and spring portions of the school year, sports that require special attention with regard to the outside competition rule are baseball, softball and boys volleyball.

CIF SOUTHERN SECTION COUNCIL

January 18, 1990

The January meeting of the CIF Southern Section Council was called to order by President Dr. Tom Jacobson at 9:30 a.m. on Thursday, January 18, 1990 at the Sequoia Athletic Club in Buena Park. All leagues were present with the exception of the Liberty and Metro Leagues.

1. MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Council meeting of September 2, 1989, as published in the CIF-SS Bulletin; the minutes of the CIF-SS Executive Committee meeting of October 26, 1989, as mailed to the Council; and the minutes of the CIF-SS Executive Committee meeting of November 28, 1989, as mailed to the Council.

2. PRESIDENT'S UPDATE - Dr. Tom Jacobson discussed the very successful Southern Section football kick-off luncheon, the summertime rules and regulations survey being sent by the State CIF Superintendents' Committee, and the National Federation Sports Channel America TV package. Additionally, Chairman Jacobson discussed concerns regarding litigation issues that faced the Southern Section during the fall playoffs.

3. COMMISSIONER'S UPDATE - Commissioner Stan Thomas updated the Council on the Athletic Administrators Symposium to be held at the Sequoia Athletic Club on February 7, 1990, the on-going work of the Area Placement Criteria Committee, assigning problems, and corporate support.

4. TREASURER'S UPDATE - Treasurer Ken Gunn reviewed with the Council the financial report of the fall playoffs and an update of the current budget. Additionally, with the dropping of membership by Clearview School, there are no longer any delinquent schools with reference to Southern Section and State dues assessments.

5. NATIONAL FEDERATION WINTER MEETING - Dr. Robert Packer, President-elect of the State Federated Council, provided an overview of the National Federation winter meetings, as it relates to the new high school football rule changes.

6. STATE CIF BUDGET - Dr. Robert Packer, President-elect of the State Federated Council, reviewed with the Council the proposed State CIF budget for the 1990-91 school year. This will be an action item at the March meeting of the CIF-SS Council in order that Southern Section delegates to the State Federated Council may have voting direction.

7. HALL OF FAME COMMITTEE REPORT - Bruce Kitchen, Chairman of the Hall of Fame Committee, reported that former Commissioner Kenny Fagans and stand-out basketball player Cheryl Miller have been nominated for the National Federation Hall of Fame. Honorees for this prestigious award will be announced in the spring with the presentations being made at the National Federation summer meetings in Minneapolis, Minnesota.

8. SEASON OF SPORT COMMITTEE - Ron Barney, Chairperson, presented a report pertaining to an update on R & R Week, the spring practice rule, and a proposed summer dead period. It should be noted that the summer dead period proposal will be reviewed again in March, due to a study with reference to summer rules being conducted by the State CIF. This will be on hold until the March meeting, with a vote taken at the April meeting of the CIF-SS Council.

9. BLUE BOOK COMMITTEE - Mr. Jim DeLong, a member of the CIF-SS Blue Book Committee, reviewed a proposed change to Article 3, Section 31 of the CIF-SS By-laws. The proposed change would give voting rights and membership in the Council to superintendents, principals and assistant principals only.

Proposed change in wording, Article 3, Section 31:

"Each established league shall no later than the May Council meeting of each school year, elect a representative to the Council for the succeeding year. Membership in the Council shall be confined to SUPRENTENDENTS, PRINCIPALS AND ASSISTANT PRINCIPALS ONLY. Alternates designated to attend Council meetings must also meet the above qualifications; no other representatives (i.e., coach, athletic director) shall have voting privileges."

10. PACIFIC LEAGUE AMENDMENT TO RULE 212 - Ken Bierman, representing the Pacific League, presented a proposal dealing with an amendment to the Blue Book which would eliminate illegal ninth grade residence eligibility.

11. AREA PLACEMENT COMMITTEE UPDATE - Clark Stephens, Chairperson of the Committee, updated the Council on discussions and progress of the Area Placement Committee. It should be noted that a proposal will be forthcoming from the Committee in March, with final vote of the Council in April.

12. SPORT ASSIGNER CONCERNS - Associate Commissioner Dean Crowley reviewed with the Council the importance of having athletic directors submitting to Area Assigners completed and accurate schedules of all athletic contests. The volume of changes faced by the officiating units has caused many problems for the Officials Associations and Assigners, which are now being funded entirely by the associations. It is imperative that the number of changes in all sports be reduced in order that the Section may continue with this valuable service to its schools.

13. FOOTBALL PLAYOFF SEMI-FINAL ROUND - Administrator Bill Clark reviewed with the Council results of this year's format pertaining to the semi-final round in football.

14. STATE FEDERATED COUNCIL - ACTION ITEMS included:

(A) A recommendation to amend the CIF Constitution and By-laws, Article 1, Section 11, replacing (a), (b), and (c) with new language. Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support this By-law modification in the State Constitution.

(B) By-law 204 - Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support the new language in this By-law.

(C) By-law 212 - Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support the new language in this By-law.

(D) By-law 226 - Following discussion, it was moved, seconded and passed to direct the Southern Section delegates to the State Federated Council to support the new language in this By-law.

(E) By-law 505 - Not having received the proposed new wording for this By-law, it was moved, seconded and passed that the Southern Section delegated to the State Federated Council attempt to have the proposal tabled, and if this is not successful, to vote against it until such time as the new language can be reviewed by the Southern Section Council.

(F) Proposed Budgetary By-law - Following discussion, it was moved, seconded and passed that the Southern Section delegates to the State Federated Council support this By-law modification in the State Constitution.

(G) Basketball time-out rule - Following discussion, it was moved, seconded and passed that the Southern Section delegates to the State Federated Council support this rule change.

(H) Cross country divisions - Following discussion, it was moved, seconded and passed that the Southern Section delegates to the State Federated Council support the four-division concept for the State Cross Country Championships.

(I) Increase in travel allowance for boys/girls basketball from \$1 to \$2 per mile, effective with the 1990-91 school year - Following discussion, it was moved, seconded and passed that the Southern Section delegates to the State Federated Council not support this travel allowance change.

15. SCHOOL PROPERTIES "GRANT OF RIGHTS" - Following discussion, it was moved, seconded and passed to support an earlier decision of the Executive Committee to reject the School Properties "Grant of Rights" proposal.

16 AT-LARGE COMMITTEE MEMBER - President Tom Jacobson reviewed a proposed By-law change providing for an at-large member on the CIF-SS Executive Committee. Following discussion, it was moved, seconded and passed to approve the proposal.

17. BASEBALL TIME-LIMIT PROPOSAL - Executive Committee member Rich Ramirez reviewed a proposal for the adoption of a baseball time limitation for the lower levels in baseball, effective with the upcoming baseball season. Following discussion, it was moved, seconded and passed to approve this proposal.

18. ALUMNI CONTESTS - President Tom Jacobson reviewed a proposal dealing with the elimination of alumni contests (rule 502, 505). Following discussion, it was moved, seconded and passed to table this issue until such time as Rule 505 is reviewed by the State Federated Council.

19. STARTING DATE - FALL SEASON - Ron Barney, Chairperson, reviewed a proposal dealing with the change in the starting date for Boys' and Girls' cross country, Girls' tennis, Girls' volleyball and water polo to coincide with the starting date for football. Following discussion, it was moved, seconded and passed to approve this proposal.

20. SUMMER FOOTBALL PROPOSAL - Bill Brown, President of the Southern California Football Coaches Assn., reviewed a proposal dealing with summer football camps. Following discussion, it was the decision of the Council not to support the proposal. Additionally, due to liability concerns, the Council felt this item should be brought back for further discussion and study at a later date.

CIF-SS WINTER-SPORT CHAMPIONSHIPS ON TAP

The month of March will indeed "come in like a lion" on the prep athletic scene, as the CIF Southern Section will conclude its winter season of sport, crowning champions in boys and girls basketball, boys and girls soccer and wrestling.

"The conclusion of any season of sport is always an exciting time of the year," points out CIF-SS Commissioner of Athletics Stan Thomas. "But this winter's championship competition will be especially interesting, because we have the greatest number of participating teams and student-athletes in our history."

Post-season competition will come to a climax in the Southern Section CIF/Reebok/Ford Boys and Girls Basketball Championships, slated for various sites the week of Feb. 28 - Mar. 3. For a first time ever, the CIF-SS will crown 10 divisional champions in girls and boys competition. In addition to determining the 1989-90 CIF-SS champions, the competition will qualify Southern Section schools to the CIF/Reebok State Championship Tournaments, scheduled to open Mar. 6 and conclude in Oakland on Mar. 16-17.

The Southern Section CIF/Reebok/Sunny Delight Boys and Girls Soccer Championships will return once again to Gahr High School's Hanford Rants Stadium in Cerritos. The five boys and four girls divisional championship matches will be conducted in two days of competition, slated for Friday and Saturday, March 2-3.

The Southern Section CIF/Reebok Wrestling Championships will be concluded by March 17, but the annual Masters Meet (section state qualifying competition) will be held Feb. 24 at Fountain Valley High School. Six representatives in each of the 13 weight classes from CIF-SS member schools will continue on to the CIF/Reebok State Championships, slated for March 2-3 at the Spanos Center on the campus of the University of Pacific in Stockton.

The complete winter sports championship schedule follows (see box).

ON THE COVER

Senior wrestler Zach Cooper of Anaheim Canyon High School will attempt to be the 191-pound "winner and still champion" in upcoming Southern Section and State CIF finals competition. 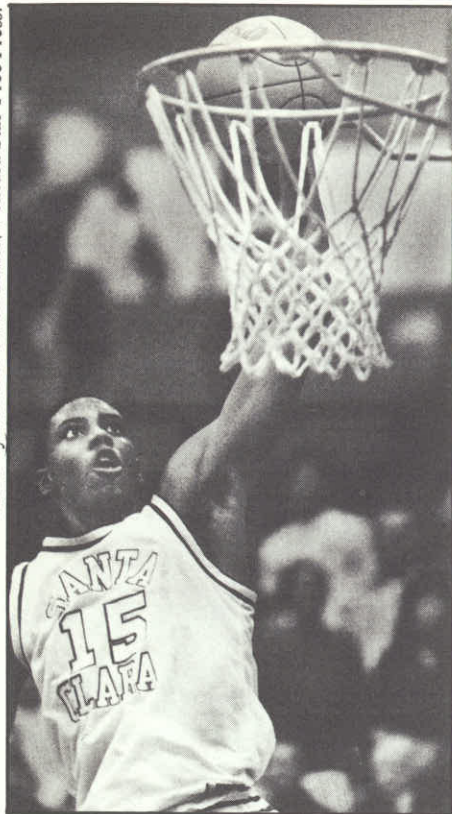

"TWO-PLAYER" VOLLEYBALL ALERT

At the CIF-SS Executive Committee Meeting held on January 13, 1990, "two-player" volleyball competition was reviewed as it pertains to Rule 600 - Outside Competition:

"A student on a high school team becomes ineligible if the student competes on an "outside" team, in the same sport, during the student's high school season of sport."

It was determined that any volleyball athlete who participates in organized "two-player" volleyball competition during his or her high school season of sport would be in violation of the "Outside Competition" Rule 600.

Please review with your coach and volleyball players the above information in order to avoid any possible violation.

consistent display of sportsmanship by the coaches, providing effective role modeling for their student-athletes.

As commissioner, I can neither accept nor rationalize, under any circumstance, the actions of a coach who loses control and projects a boorish behavior toward officials, players, or fans. High school athletics should be conducted without incident, employing serious intent and forethought to the practice of good sportsmanship.

The principal who condones profanity, or turns his or her back upon poor behavior because it is convenient, is making a serious mistake. Under stress, students will react as their coach reacts. Coaches must be required to carry themselves professionally and demonstrate self control, in order to teach young men and women the acceptable standards of citizenship and behavior of our society.

These lessons, when properly taught, will pay dividends far beyond our understanding. However, when they are ignored, the results can become graphic, embarrassing and devastating. As administrators, we must pull in the reins and take a hard look at coaching standards and the ethics of our profession.

Please give this your most serious consideration.

7. **STATE CIF REPORT** - Dr. Robert Packer, State CIF President-elect, reported on the non-renewal of the Coca-Cola corporate sponsorship for the 1990-91 school year, and the Reebok contract with renewal notification due to the State CIF by January 15, 1990.

8. **LEGAL UPDATE** - Attorney Andy Patterson reviewed current legal issues facing State and Southern Section.

9. **SEASON OF SPORT COMMITTEE REPORT** - Dean Crowley reviewed with the Committee the ongoing work of the Season of Sport Committee. It should be noted that the Committee will be discussing with the Council the R & R Week Concept, the spring practice rule, and a summer dead period proposal. Additionally, he reviewed a proposal coming before the Council at its meeting of September 21 that beginning with the 1990-91 year, all fall sports be conducted in conjunction with the starting date for football.

10. **OUTDOOR VOLLEYBALL** - Karen Hellyer reported that it was a State rule interpretation that two-player volleyball would be in violation of the State Outside Competition Rule (600). Following discussion, it was moved, seconded and passed to follow the State interpretation that two-player volleyball violates State Rule 600. It should be noted this is a change from a previous decision made by the Executive Committee at its meeting of June 17, 1989.

11. **NATIONAL FEDERATION TV PROGRAM** - Administrator Bill Clark reported on the Sports Channel America national high school television package. It should be noted that local games included the Carson/Banning football game; two games in the semi-finals of the Ocean View boys' varsity basketball tournament; and the Artesia/Mater Dei basketball game.
