The Annual meeting of the Council was held in the Conference Room at the Woodrow Wilson High School Saturday, May 16, 1936.

The meeting was called to order by President Means of the Tustin High School at 9:30 a. m. Roll call showed the Leagues represented as follows:

Mr. Robinson of the Phoenix, Arizona High School was present and took part in the proceedings when the relations of the Phoenix High School with Southern California high schools was discussed.

- 1. There being no corrections suggested the President ruled the minutes of the February meeting of the Council approved as printed.
- 2. The minutes of the April meeting of the Executive Committee as sent out in the April Bulletin were approved except section (11) which was amended as indicated in section (12) of these minutes.
- 3. Mr. Alman presented the Treasurer's Report reprinted below. Moved by Mr. Thompson, seconded by Mr. Burnight that the report be approved and printed in the minutes of this meeting. Carried.
- 4. The work of the Selection Committee that had chosen the competitors for the finals of the Track Meet was discussed at considerable length. Mr. Hamilton of the Committee explained, that competitors except the first place boy in each Divisional Meet. had been chosen strictly on record performances in the four Divisional Meets. The work of the Selection Committee was unanimously approved without change in a single detail

- 5. Seven nominations were made for the Executive Committee. The election resulted in the choice of the following five men. Mr. John Alman, Mr. Normal Hayhurst, Mr. Kinter Hamilton, Mr. S. Chester McIntosh and Mr. H. J. Moore.
- 6. Mr. H. J. Moore was unanimously elected to succeed himself for a two year term on the State Council Mr. Moore is now finishing his ninth consecutive two year term on the State Council.
- 7. Moved by Mr. McIntosh, seconded by Mr. Blee that Mr. Van Patten be re-elected Commissioner of Athletics for the ensuing year, and as he has stated that this must be his last year of service that a committee of three be appointed by the Chair to report on future plans. Carried.

The Chair appointed Mr. Ernest Fischer, Mr. Normal Hayhurst and Mr. J. C. Peniwell as the Committee.

Moved by Mr. Moore, seconded by Mr. Peniwell that Mr. Van Patten's salary be the same as for the present year. Carried.

8. Moved by Mr. Blee, seconded by Mr. Burnight that for any football training which may be done in the Spring that no football suits be issued and no scrimmage be undertaken. Carried.

Moved by Mr. McIntosh, seconded by Mr. Blee that football practice in any League in the Fall may not start earlier than the opening of regular school work by some school in that League. Carried.

9. A period of about one hour and a half was spent discussing the subject of Releaguing for the year 1936-37.

The League organization as shown on the enclosed page was finally agreed upon. Moved by Mr. Fischer, seconded by Mr. Teach that the list be approved for the year 1936-37. Carried.

10. Mr. Robinson representing Superintendent E. W. Montgomery of the Phoenix, Arizona schools asked to have Phoenix High School admitted to Associate Membership in the C. I. F., Southern Section, and have a representative of the Phoenix High School permitted to attend meetings of the C. I. F., Southern Section and take part in discussions.

Moved by Mr. Blee, seconded by Mr. Teach that the C. I. F., Southern Section favor the request of the Phoenix High School and ask the State Council at its meeting on May 23 to approve Phoenix as an Associate Member of our organization. Carried.

It was informally agreed that pending approval of Phoenix's request by the State Council that any matches arranged between the Phoenix High School and schools of the C. I. F., Southern Section must be approved by the Commissioner of Athletics of the C. I. F., Southern Section.

11. Moved by Mr. Fischer, seconded by Mr. Thompson that the Bay League be authorized to invite Leuzinger High School of Inglewood to join the Bay Leagues. Carried.

 $_{12.}$ Moved by Mr. Teach, seconded by Mr. Perry that any $_{\rm Frce}$ -Lance schools wishing to enter the play-off in any sport must submit its schedule of games to the Executive Committee before the beginning of the season of the sport concerned, and that the Executive Committee be authorized to name conditions under which such Free-Lance Schools may enter play-off.

13. Moved by Mr. Blee, seconded by Mr. Burnight that the Tri-County League be requested to approve a five game football schedule for the smaller schools of the League. Carried.

14. Moved by Mr. McIntosh, seconded by Mr. Hamilton that in Classes B, C and D in football and basketball that playoff arrangements as followed for years past be discontinued and that the winners in any league be allowed to arrange for not more than one interleague championship game. It being understood that these games must be approved by the Commissioner of Athletics and follow usual play-off rules since they are inter-league affairs. Carried.

Receipts:-

15. Moved by Mr. McIntosh, seconded by Mr. Peniwell that the C. I. F., Southern Section invite the C. I. F., Los Angeles City Section to meet our champions in an intersectional playoff in all sports if approval can be secured from the State Council. Carried.

16. Mr. Kinter Hamilton, Representative from the Preparatory League was, according to custom, next in line for the Presidency of the Council for the ensuing year. His formal election by the Council was unanimous.

At 12:45 p. m. he took charge of the meeting. In a few well chosen words he expressed his appreciation of the business like and sportsmanlike manner in which Mr. Means had conducted the Council meetings during the past year. Enthusiastic applause by the members of the Council indicated that Mr. Hamilton had expressed the opinion of the body as a whole.

Mr. Hamilton then adjourned the meeting for lunch and to the finals of the Track Meet.
