HARVEY J. HOLT ANNOUNCES HIS RETIREMENT

After twenty-five years of outstanding service as Principal of Santa Barbara High School, Harvey J. Holt has announced his retirement from school work, effective, June 1955. This will make it necessary for Mr. Holt to sever his active connections with the C.I.F., where he has served faithfully and well as a member of the Executive Committee since 1948.

Harvey Holt grew up in Missouri, and graduated from Central Wesleyan College where he was active in athletics. His first teaching position took him to Charles City, Iowa, where he established the "Twilight Sports League" for younger pupils, an all sports league. Migrating west to California in 1920, Mr. Holt accepted a position in South San Francisco High School and managed to find time to earn his M.A. degree at the University of California.

In 1925, Santa Barbara welcomed him as head of their Science Department. Soon afterwards he was elected Vice-Principal and in 1930 was promoted to the position of principal of Santa Barbara HS. During his years there Mr. Holt has been active in many civic and educational organizations. His interest in youth and athletics resulted in his working for the C.I.F. which led to his election as a member of the Executive Committee, one of the highest positions in the Federation.

EXECUTIVE COMMITTEE MEETING, APRIL 25, 1955

The Executive Committee meeting was called to order by the Chairman, B. L. Bergstrom at Starks Restaurant in Covina, on Monday, April 25, 1955, at 12:30 P.M. The following members were present: Winston Nelson, Pomona HS; Harvey Holt, Santa Barbara HS; Joe Bonnet, Emerson Jr. HS, Pomona; Bruce Lawson, Keppel HS; Oliver Corbin, Covina HS; Floyd Johnson, Hoover HS, San Diego; B. L. Bergstrom, El Monte; and Ken Fagans, Commissioner of Athletics.

1. Mr. Francis Daugherty and Mr. Wm. Lopez of the Los Angeles City Section of the C.I.F. were present to discuss the eligibility of a boy who transferred from Riis HS of the city, to Centennial HS of the Southern Section. After much discussion of the facts it was decided that the boy would be eligible at Centennial HS, only if the official transcript of the boy showed he had passed in 4 subjects at Riis HS, previous to transferring. Mr. Fagans was instructed to check the transcript of the boy at Centennial to determine if the above requirements had been met.

2. Mr. John Marrow, Athletic Director of Beverly Hills HS presented some facts concerning the difficulties encountered by his school in obtaining entries for the Beverly Hills HS basketball tournament, because the assigned date for the tournament came during the middle of league schedules. Because the policy of the C.I.F. has been that invitational meets and tournaments should serve to supplement league and C.I.F. competition, and not to interfere with it, it was felt that the C.I.F. could not request leagues to set aside their own league schedules to compete in an invitational tournament. With

this policy in mind Beverly Hills then requested sanction for their tournament to be moved to the dates of January 4, 5, 6, and 7, 1956, and approval was granted. At the present time there are two tournaments—the Compton and Beverly Hills tournaments—being held the first week in January. The Executive Committee went on record as recommending to our leagues that they consider the problems of these tournaments being held the first week in January and wherever possible try and make their league schedules for that week flexible, so that teams that desire to enter the above tournaments may do so. It was further suggested that the Commissioner be instructed to notify the managers of these tournaments that invitations be extended to our high schools far enough in advance so that schools wishing to participate may have their league arrange their schedules so as to permit their entry.

3. The football schedule for Santa Barbara HS, St. Augustine HS, Santa Monica HS, and Pius X HS were reviewed for possible entry into the 1955 football playoffs. It was moved, seconded, and carried that these schools would qualify for the playoffs if they meet the following standards: (A) Santa Barbara HS must win all but one of the following six games—Pasadena, Phoenix, Bell, Huntington Park, San Diego and Santa Maria; (b) Santa Monica HS must win all but one of the following six games—Inglewood, Centennial, Anaheim, Las Vegas, Garden Grove, and Santa Ana; (c) St. Augustine HS must win all but one of the following six games—Chula Vista, Lincoln, Mission Bay, Point Loma, El Cajon, and Grossmont; and (d) Pius X HS must win all but one of the following six games to qualify for the Northern Group of leagues playoff—Notre Dame, St. Monica's, Tustin, Harvard, Mt. Carmel, and Cantwell. In addition, if the above mentioned schools should not qualify on the above standards and their team does not lose more than 2 of the above six games, the team record will be presented to the special football playoff committee for consideration as a second-place entry to fill a bracket of 16 entries.

4. Applications for membership in the C.I.F. Southern Section were presented from the following schools: Westside Jr. HS, Pomona; Highland Jr. HS of San Bernardino; Rim of the World HS of San Bernardino; and St. John Vianney HS of Los Angeles. It was moved, seconded, and carried that the Executive Committee recommend to the Council that they accept the applications for membership from the above mentioned schools.

It was moved, seconded and carried that Westside Jr. HS of Pomona be placed in the Mt. Baldy League, effective September, 1955; that St. John Vianney HS be placed in the Parochial league effective September, 1955; and that Highland Jr. HS and Rim of the World HS be placed on a free lance status for the 1955-56 school year.

CALIFORNIA ADMISSIONS TAX ON SPORTING EVENTS PROPOSED

Just a few years ago, the united effort of the school people of the nation aided in securing the repeal of the federal admissions tax on high school sporting events. In the California Legislature, Assemblyman Clayton Dills of Gardena recently introduced Assembly Bill #2548 which proposes "A tax is hereby imposed on the privilege of being admitted to any place in which a sporting event of any kind is conducted or held, if an admission fee is charged. The tax shall be paid by the persons paying the admission fee."

Until such time as the Assembly Committee on Revenue and Taxation holds the hearing on the proposal, those interested may write expressing their views to either Mr. Clayton Dills, the author, or to Mr. Glenn E. Coolidge, Chairman of the Assembly Committee on Revenue and Taxation. Letters should be addressed to the two men at the State Capitol Building, Sacramento.

The State C.I.F. Office is keeping in touch with developments of this bill, and will keep all schools informed.

NEW BASKETBALL RULES FOR 1955-56

The National Basketball Rules Committee met in Kansas City, March 20-22, 1955, and came up with only a few important changes in the rules for next year. Listed below are some of the rule changes which might be of interest at this time to our schools.

CIF SWIMMING CHAMPIONSHIPS HELD AT EL SEGUNDO POOL

A new set of team and individual champions were crowned in the CIF Championship Swim Meet held at El Segundo High School's fine pool, on Friday night, May 13, 1955. Before a capacity crowd of enthusiastic rooters Coach Pete Archer's Long Beach Wilson HS team ran away with the varsity championship by scoring 47 points to runner-up Whittier's 31 points. In the Class B division it was Long Beach Poly winning handily with 49 points and in the C Class the home team swimmers from El Segundo HS scored 31 points to edge out Fullerton with 27 points.

The competition was especially close in most events and the judges were hard put to determine the winners. Six new meet records were established by the competitors, with the Class B boys setting the most new standards.

Rule 1, Section: This will be rewritten to indicate that the 12-foot wide lane is prescribed for games between teams of college age and that the 6-foot wide lane is prescribed for teams of high school age. Reference will also be made to the legality of having both lanes marked when such markings seem to be necessary.

Rule 1, Section 12—Note: Last sentence of the note will be deleted and replaced with a statement that a rubber covered ball, will be legal for any high school or Y.M.C.A. game beginning with the 1956-57 season.

Rule 4, Section 10: Second sentence will be revised to provide for held ball in certain situations. The new statement will authorize the official to call a held ball in the front court after five second of control by one player during which he is obviously trying to consume time by holding and/or dribbling the ball for five seconds away from the lane area while making no appreciable advance toward scoring area.

Rule 5, Section 10: This item will be revised to prescribe that the ball becomes alive and a stopped clock is started when, on a jump, the tossed ball is legally tapped.

Rule 10, Section 6: Changed to read that a flagrant technical foul will result in 2 free throws.

Rule 10, Section 7: Will be revised to eliminate the double free throw penalty which has been enforced during the last three minutes of the game. This has the effect of making the bonus penalty apply throughout the entire game.

Entries into the preliminaries were limited to six from each league, and six from a free lance qualifying meet held at Whittier HS. At the two preliminary meets, six boys were qualified to enter the semi-finals at El Segundo, where two heats of six swimmers were held. The six fastest boys by time qualified for the finals. Diving prelims were held separate from the swimming, so that the events could have the attention they deserve. Coach Pete Archer managed the Wilson HS preliminary meet, and all other meets were held at El Segundo HS under the capable direction of Urho Saari.

5. It was moved, seconded, and carried that the Commissioner of Athletics be directed to mail to all superintendents of our member schools copies of our Monthly Bulletin, effective September, 1955.

6. It was moved, seconded, and carried that it be recommended to the Council that approval be granted for the formation of a new league to consist of the following schools: Bellarmine-Jefferson HS, Chaminade HS, Harvard, Lutheran HS, St. Agnes HS, and St. Monica's HS, and that this league be placed in the Northern group of leagues for all playoff competition. This new group of schools will be known as the Olympic League.

7. It was moved, seconded, and carried that the Commissioner of Athletics be authorized to purchase a new adding machine for use in the C.I.F. Office.

8. A review of a survey made by the C.I.F. Office concerning the appointment of officials in our outlying areas was presented by Mr. Fagans. After considerable discussion it was moved, seconded, and carried that Mr. Nelson and Mr. Fagans be instructed to meet and work out a proposal on this matter to be presented to the next meeting of the C.I.F. Council.

9. A letter was read from Mary Star of the Sea HS relating to the participation of two ineligible boys on their basketball and baseball teams. Mary Star of the Sea HS presented evidence that all games in which these boys had participated were forfeited to the opposing school. The Commissioner of Athletics was directed to inform Mary Star of the Sea HS that the Executive Committee was glad to learn that the mistake had been corrected but that in the future Mary Star of the Sea HS should exercise greater care in checking the eligibility of all boys participating in athletic competition before they are certified as eligible.

10. A letter was read from Ralph Alexander of the Los Angeles Examiner requesting the C.I.F. to consider the possibility of combining their football championship game as part of a double header with the championship game of the Los Angeles City Section, to be called the Olympic Bowl game, and to be played in the Los Angeles Memorial Coliseum. Since it has been the policy of the C.I.F. to restrict our playoff games to one of the home communities of schools involved, it was moved, seconded, and carried that because of the geographic difference of locality in schools that might represent the C.I.F. in football playoffs it would not be feasible to restrict our championship game to the Los Angeles area.

11. It was moved, seconded, and carried to accept the basketball playoff financial report as presented by Mr. Fagans.

12. A protest from Trona HS regarding the violation of a C.I.F. rule which occurred in the

Desert-Inyo Relay Carnival, was presented. It was moved, seconded, and carried that because the Desert-Inyo Relay Carnival was sanctioned only by the C.I.F. and not sponsored by the C.I.F. that the protest should be referred to the games committee of the Relay Carnival for action.

13. Mr. Joe Bonnet, President of the C.I.F., Southern Section Council, made the following committee assignments:

(a) Second-place football teams committee: Vernon Weybright, Principal of Burroughs HS, Burbank; Robert Heaman, Principal of Montebello HS; Lawrence Carr, Jr., Principal of San Diego HS; Ernest Payne, Principal of Chaffey HS; Rev. R. H. Shepherd, Director of Athletics of Loyola HS; and Mr. Ken Fagans, Commissioner of Athletics.

(b) Releaguings committee: Keith Gunn, Principal of Victor Valley HS; Glenn Lewis, Principal of Fullerton HS; Robt. Ashton, Vice-Principal of Excelsior HS; Everett Braun, Principal of Oxnard HS; Kenneth Peters, Principal of Beverly Hills HS; and Floyd Johnson, Principal of Hoover HS, San Diego.

There being no further business, meeting was adjourned at 4:45 P.M.

RULING OF ATTORNEY GENERAL

Recently the District Attorney and County Counsel of the County of San Diego presented the following question to the Attorney General of the State of California:

"May a school district authorize the launching of a selling campaign by a national insurance company, on school premises, of a group student accident insurance plan." The conclusion reached by the Attorney General was: "The school district has no such authority."

The quotes printed below are taken from the opinion published by the Attorney General. "It has always been the sound public policy of this state to preclude the introduction of business enterprises into the public school system. Nothing in the statute warrants the conclusion that the Legislature intended to authorize the transaction of private insurance business with the pupils in attendance in the schools of the district. Any exception to the public policy above stated must be not only express and direct, but will be strictly construed. We must accordingly conclude that the authority to permit such business does not exist."

C.I.F. school administrators are asked to note that the opinion refers to private commercial insurance companies. The school benefit and relief association (C.I.F. Protection Fund) is not a private commercial insurance company.

CHANGES IN "B", "C", AND "D" CLASSIFICATIONS

By vote of the C.I.F., Southern Section Council, at their meeting held on February 5, 1955, the sum of exponents for "B", "C", and "D" classifications was raised, effective September 1, 1955. The sum of exponents allowed for Class "D" from 77 to 79; Class "C" from 81 to 83; and Class "B" from 88 to 89.

According to our Blue Book, Section XII, Paragraph 10, "When a boy reaches the maximum points for any classification, he must pass to the next classification the following year." Because of the raise in maximum points allowed in classifications for next year, the above rule will not apply for 1955-56 only. In other words a boy could have been at the maximum in Class "C" for this year at 81 points, but because the maximum has been raised to 83 it is possible he might be able to compete again next year as a class "C", if his total exponents do not exceed the new maximum established at 83.

We know that this change will work to the advantage of certain leagues, and to the detriment of others. We know however, that all

schools will give the new classifications a fair trial during the 1955-56 school year, and if they do not prove satisfactory for a majority of our schools a revision can be made for the following year.

REQUESTS FOR SANCTION OF INVITATIONAL EVENTS SHOULD BE FORWARDED TO COMMISSIONER

Principals of schools which are planning to sponsor athletic events during the 1955-56 school year, are requested to forward their applications for sanction to the C.I.F. Office, 8760 Venice Blvd., Los Angeles 34. Any event that is inter-league in character must receive sanction from the C.I.F. Office.

The State C.I.F. Federated Council has ruled that (1) a boy may not miss more than one day of classes while competing in a basketball tournament; and (2) that no boy may participate in more than one game in a basketball tournament in one day unless the quarters are reduced from eight to five minutes duration in each game that day. Unless the invitational basketball tournaments are held in vacation periods, the State ruling will keep the various entries more localized.

PASADENA CAPTURES GYMNASTICS CROWN

Before the largest crowd to ever witness a CIF, SS gymnastic meet Pasadena HS scored 30 points to capture the CIF, SS title on April 22, 1955, at Bellflower HS. With 21 schools competing the championship was not decided until the final event of the evening. In this event, the Rings, Pasadena HS swept the first three places to finish with a margin of 9 points over their nearest rival, Santa Paula HS.

Gymnastic competition has had a rapid growth in the CIF, SS and it now appears that there will be enough entries to hold two preliminary meets and a championship meet in 1956. Bellflower HS had ideal facilities for staging the 1955 meet and Coach Lyle Draves did an outstanding job as Meet Manager. Ten A.A.U. officials were present to judge the events, and they did a particularly fine job in keeping the meet moving along at a rapid pace.
