B. L. BERGSTROM ANNOUNCES HIS RETIREMENT

After 39 years of dedicated service to the El Monte School District, Superintendent B. L. Bergstrom has announced his retirement from school work effective July, 1960. This will make it necessary for "Bergie", as he is affectionately known to his multitude of friends, to also sever his connections with the CIF, SS, where he is the senior member of the Executive Committee. He has served as its President during the past ten years.

Bernhardt Bergstrom is a native son, having been born some few years ago in San Pedro. When his parents moved to El Monte, "Bergie" enrolled in the local high school where he participated in football, track and baseball for four years while accumulating credits to graduate with honors in 1913. In search of higher education, young Bergstrom matriculated at Pomona College where he proceeded to show exceptional brilliance on the gridiron, diamonds and cinder track. Upon graduating, he found the United States entering the first World War and without hesitation he enrolled and served with distinction as a Second Lieutenant in the 12th U. S. Infantry, 8th Division.

In 1921, his many friends arranged for "Bergie" to return to his old high school as a teach-

er and coach of all varsity teams. Under his capable guidance, El Monte HS established an outstanding record in interscholastic athletics, particularly in football where Coach Bergstrom's teams captured 10 league titles and finished second twice in a span of 12 years.

His inspirational leadership in the coaching field won for him an assignment as Vice Principal of El Monte High School in the fall of 1929. In 1937 he was appointed Principal of El Monte High School, in which capacity he remained until his election as District Superintendent in 1952.

Throughout his career he has always been interested in youth and particularly in connection with their participation in interscholastic athletics. This led him to volunteer his services to the CIF, SS where he has been extremely active during the past three decades. He has been the representative from his league on the SS Council, a member and president of the Executive Committee, and has worked hard over the years on numerous committees. During recent years he has shouldered the responsibility of heading the very important relegating committee and under his capable leadership many serious problems have been resolved due mainly to his conciliatory ability.

In 1956 Mr. Bergstrom was honored by the National Federation of State High School Athletic Associations with the following citation:

"B. L. Bergstrom, Chairman of the CIF, SS Executive Committee and veteran leader in the development of the California Interscholastic Federation has unselfishly served the high schools of California for so many years that his influence is built into the whole school structure of the state and especially of the SS where the school population has grown so rapidly that problems solved today become multiplied problems tomorrow. Mr. Bergstrom has been fortunate in having had background experience as coach, athletic director, principal and superintendent. This has made him a key figure in the solving of problems which arise in the complicated athletic program of the CIF, SS. His wise counsel has been an important factor in keeping the Section program progressive and effective."

With retirement just around the corner, Mr. Bergstrom says that he and his lovely wife, Julia, have no immediate plans except to catch up on golf and bridge. Because they both en-

MINUTES OF EXECUTIVE COMMITTEE MEETING MAY 19, 1960

The meeting was called to order by Mr. B. L. Bergstrom, Chairman, at El Monte HS, at 3:00 P.M., on Thursday, May 19, 1960. Those present were Messrs. B. L. Bergstrom, Supt. of Schools at El Monte; Winston Nelson, Asst. Supt. of Schools at Pomona; B. F. Jamison, Asst. Supt. of Schools at Compton; Robert J. Schilling, Principal of Los Altos HS; Ray Charlson, Vice Principal of Culver City HS; Oliver Corbin, Principal of Covina HS; Frank O. Hopkins, Principal of Brea-Olinda HS; John R. Taylor, Principal of Nordhoff HS; Matthew Korwin, Principal of San Dieguito HS; Keith Gunn, Principal of Victor Valley HS; and Kenneth Fagans, Commissioner of Athletics.

1. It was moved, seconded and carried that the Minutes of the Executive Meeting of March 28 be approved as published in the April, 1960, Monthly Bulletin.

2. It was moved, seconded and carried that it be recommended to the Council that Norco Junior High School of Corona be accepted for associate membership in the CIF, SS.

3. Football schedules from Bosco Tech and Servite HS were reviewed for possible entrance into the 1960 SS football playoffs. It was moved,

seconded and carried that in order to qualify for the playoffs each school must win all but two of seven designated contests on their schedule.

4. Mr. Myron E. Green, Principal of Bolso Grande HS, appeared before the committee to request a ruling on an eligibility case involving a boy who recently transferred to his school from Wisconsin. Due to a very serious operation, the boy had not been enrolled in a high school from June, 1959, until May, 1960. A review of the case indicated that a State rule was involved over which the SS had no control. It was moved, seconded and carried that the Commissioner contact Mr. Russell and see that the matter is placed on the agenda of the next Federated Council Meeting, scheduled for June 4 in Palo Alto. The Executive Committee went on record as unanimously recommending that the State Council give every consideration to declaring this boy eligible for interscholastic athletics effective September, 1960.

5. A letter was read from Inglewood HS in which they requested permission to begin the 25th Annual Inglewood Golf Tournament, scheduled for Friday, April 7, 1961, earlier than 3:00 P.M. The philosophy behind this rule was reviewed and it was reaffirmed that sanctioned events should not begin earlier than 3:00 P.M. on a school day unless the activity was very worthwhile and there was no other time in which it might be scheduled. In the case of the Inglewood Golf Tournament, the Executive Committee recommends that Inglewood HS explore the possibility of scheduling this event during the Easter vacation and report their findings to the Commissioner so that the matter might be placed on the agenda of the June Executive Committee meeting.

6. A communication from St. Agnes HS was read, which informed the committee that St. Agnes HS will be deactivated in June, 1960. The principal submitted an official list of sophomore and junior boys who will find it necessary to transfer to another high school in September, 1960, and requested a ruling as to their eligibility. It was moved, seconded and carried that all boys now attending St. Agnes HS, who will find it necessary to transfer to another high school in September, 1960, shall be declared residentially eligible for interscholastic athletics in the first public school of their choice if it is the district in which their parents or legal guardians reside, or in a private school where they first enroll in September, 1960, provided they are eligible under all other rules of the CIF.

7. Pomona Catholic HS requested that they be given permission to continue the policy of permitting boys from their La Verne and Pomona campuses to combine for athletic purposes under the banner of Pomona Catholic HS. This is necessary because Pomona Catholic HS is in the

process of being converted into an all girls' school and the boys are being transferred, one year at a time, to the new campus in La Verne. It was moved, seconded and carried that Pomona Catholic HS be permitted to continue the policy of combining the freshman and sophomore boys on the La Verne campus with the junior and senior boys on the old Pomona Catholic campus for the purpose of fielding teams to represent Pomona Catholic HS in CIF, SS athletic activities.

8. Long Beach Wilson HS requested an interpretation of Article XVI, Paragraph 14, page 32, of the By-Laws in the Blue Book pertaining to the use of protective equipment in spring football practice. The specific portion of the By-Laws needing interpretation is "Football shoes may be used, but no protective equipment". A discussion ensued as to the meaning of this sentence. The veteran members of the committee were of the unanimous opinion that the rule as written was meant to prohibit a boy from wearing protective equipment other than football shoes and gym suits. It was then moved, seconded and carried that this sentence be revised to read as follows: Football shoes may be used, but a boy may not wear any other type of protective equipment.

9. The Commissioner reported on a violation by Montebello HS whereby the track coach knowingly violated a rule of the CIF, SS by entering certain of his boys in track meets in two different classifications during one calendar week. Upon learning of this breach of rules, the Executive Committee was polled relative to this matter and it was their decision that the following penalties be imposed on Montebello HS for this violation of the classification rule:

- Forfeit the Class B Championship won in the Arroyo Invitational Meet.
- Return the team trophy and individual awards illegally won at the Arroyo Invitational Meet.
- Be denied the right of entering any sanctioned invitational track meets from the date of the violation through the balance of the current season.

10. The Commissioner reported that many unpleasant incidents have arisen in SS baseball games during the current season due mainly to the excessive bench jockeying and unsportsmanlike conduct being exhibited by coaches and members of high school baseball teams. Although professional baseball permits such tactics, it was the unanimous opinion of all concerned that high school baseball should be conducted under the same code of good sportsmanship as in all other sports. It was moved, seconded and carried that the By-Laws should include a code of good sportsmanship that should prevail in all CIF, SS baseball contests and the Com-

missioner should advise all umpires' associations regarding this code and instruct them to enforce its provisions.

11. A letter from Doane M. Lowery, President of the Prep League, was read, in which Mr. Lowery reported that he would be unable to be present at the May 21 Council Meeting, at which time he was to be installed as President of the Council. Mr. Lowery stated in his letter that he could not attend the next two scheduled meetings as well as the 1961 May Council Meeting. He further stated that if his absence was too serious a handicap, the Council should feel free to elect someone else to the presidency. After some discussion, it was moved, seconded and carried that because it was imperative that the President be in attendance at all Council and Executive Meetings, it be recommended to the Council that in accordance with the constitution the presidency of the Council should be filled by the representative of the next league in alphabetical order, which would be the Rio Hondo League.

12. It was moved, seconded and carried to hold the June meeting of the Executive Committee at 9:00 A.M. on Monday, June 20, at a place in Orange County to be selected by the Commissioner.

There being no further business to come before the committee, the meeting was adjourned at 5:45 P.M.

BEVERLY HILLS HS CAPTURES CIF, SS SWIM CHAMPIONSHIP

Beverly Hills HS broke El Segundo's two-year domination of high school swimming by scoring 41 points to capture the varsity team title in the CIF, SS Swimming Championship Meet held at the Santa Monica College pool on Saturday, May 7, 1960. This was the first meet in many years to be held in an outdoor pool and it proved to be the most spectacular swimming finals in CIF history.

This year Coach Walt Puffer and his Beverly Hills team were not to be denied. You may recall that in the 1959 meet Beverly Hills lost out on the title by one point and the margin of difference was a half-hand touch in the final event. Newport Harbor finished a strong second with 39 points, followed by Fullerton with 22½ and El Segundo, the defending champions with 20½.

Record-breaking performances were a dime a dozen as eighteen new CIF, SS records were established and one National record was tied. In the varsity 200-yd. medley relay event, the Beverly Hills team composed of Steve Kern (backstroke), Julian Marx (breast stroke), Steve Ross (butterfly) and Dave Bennett (free style) tied the National mark of 1:45.5. Richard McGeagh of Glendale Hoover had a record-breaking afternoon as he established two new CIF, SS records. In the A-100 yd. backstroke his time was 57.3 and in the A-200 yd. Individual medley he set a new standard of 2:09.9.

Under the expert guidance of Mr. Hap Waer and Don Smith, California's B team captured the Class B championship by scoring 43 points to second place LB Poly's 34. Downey and Beverly Hills tied for third with 27. The upset of the day was supplied by Tom Case of Leuzinger HS who upset Riley Quayle of LB Poly in the Class B butterfly by a hand touch as he established a new CIF, SS record of 58.2

Pete Cutino and his fine Oxnard team took top honors in the Class C division by scoring 29 points to nose out Santa Ana who finished with 27½ points. Nick Schoenman of Glendale continued his record-breaking performances of 1959 by establishing two new CIF, SS records in 1960. Schoenman lowered the C-50 yd. free style record to 23.3 and the C-100 yd. free style record to 52.8.

Preliminary meets were held at Millikan, Montebello and Oxnard High School with Frank Kanarek, Buck Jarnagan and Pete Cutino respectively serving as meet managers. The Millikan meet was held in the evening with the other two being afternoon affairs in order to give the competing schools an opportunity to indicate whether or not they preferred to attend an afternoon or night meet. All preliminaries ran off smoothly and we are indebted to these coaches who volunteered their facilities for these important preliminary meets.

A free lance meet for the purpose of qualifying boys into one of the three preliminaries was held at Whittier HS under the direction of Coach Frank Poucher. This developed into one of our largest meets, as outstanding boys representing nearly 32 high schools officially entered the competition.

The Championship Meet held at Santa Monica was conducted under almost perfect weather conditions and was expertly organized and administered by Mr. Knute Clark, swimming coach at Santa Monica HS. This is a tremendous undertaking and on behalf of our competing schools and the CIF Office, we would like to express our thanks and appreciation to Mr. Clark and his fine corp of assistants who are to be congratulated on a job well done.

MINUTES OF THE CIF, SS COUNCIL MEETING — May 21, 1960

The last regular meeting of the CIF, SS Council for the 1959-60 school year was called to order by President Ray Charlson, at Brea-Olinda HS, at 9:30 A.M., May 21, 1960. Representatives were in attendance from all leagues with the exception of the San Diego East, San Diego West, San Bernardino City and Pasadena Jr. HS.

1. It was moved, seconded and carried that the minutes of the Council meeting of February 6, 1960, be approved as published in the February, 1960, Monthly Bulletin.

2. It was moved, seconded and carried that the Minutes of the Executive Committee meeting of March 28, 1960, be approved as published in the April, 1960, Monthly Bulletin.

3. It was moved, seconded and carried that the Minutes of the Executive Committee meeting of May 19, 1960, be approved as read.

4. Mr. Robert J. Schilling, Principal of Los Altos HS and chairman of the committee delegated with the responsibility of making recommendations pertaining to the problem of summer basketball leagues, presented for consideration the final and revised recommendations of his committee. It was moved and seconded that the following recommendations of the committee be adopted as a part of Article XVII, of the By-laws:

- A varsity basketball coach must not supervise or coach the team at summer recreation basketball games in which students of his high school participate.
- School uniforms must not be used in summer league contests.
- It is strongly RECOMMENDED that boys be encouraged to participate in only one summer league.

The motion was carried by a vote of 22 to 11.

5. Mr. Ray Charlson, Chairman of a committee appointed to study eligibility lists and the compilation of three point records, presented for consideration the following changes in CIF, SS By-laws: (a) Change Article II, Paragraph 2, page 12, to read as follows: "He shall forward to the league president (or if a free lance school, to the Commissioner of Athletics) the three point data required under Article XII, Paragraph 7, of the By-laws." (b) Change Article V, Paragraph 3 to read that eligibility lists shall be exchanged by competing schools "prior to the contest", rather than three days prior to the contest". (c) Revise paragraphs 7 through 11, in Article XII, for better clarity and to detail method of handling Three Point Record data.

It was moved, seconded and unanimously carried to adopt the proposed changes in the By-laws, as presented by the committee.

6. With the withdrawal of the majority of the schools in San Diego County from the SS, a revision was made necessary in the SS Constitution pertaining to membership on the Executive Committee. Mr. B. F. Jamieson presented the recommendations of the Executive Committee in this matter which called for the following revision of Article VII, Paragraph 1, page 8, of the Constitution: "The Executive Committee of the CIF, Southern Section shall consist of eight members elected at the regular May meeting from representative districts for a term of four years each. These districts and their allotted membership on the Executive Committee shall be: Northern, composed of San Luis Obispo, Santa Barbara and Ventura Counties, one member; Eastern, composed of Inyo, San Bernardino, Riverside and Imperial Counties, two members; South Central, composed of Orange County, one member; and Metropolitan, composed of Los Angeles County, four members." It was moved, seconded and unanimously carried that the above change be made in the CIF, SS Constitution.

7. President Charlson called upon Mr. Rollie Davis, Oliver Corbin and Winston Nelson to come forward for the purpose of making special presentations of CIF, SS Life Passes to Mr. Holley Ashcraft, Walter Scott, Don H. McIntosh and B. L. Bergstrom. Details on these presentations may be found elsewhere in this bulletin.

8. At the last meeting of the Council each member was presented with a mimeographed sheet outlining five proposed changes in wording of the CIF, SS Constitution, and they were advised to bring these proposed changes to the attention of their respective leagues and be prepared to vote on their adoption at this meeting. It was moved, seconded and unanimously carried that the following five changes be made in the wording of the CIF, SS Constitution.

Article II, Section 1, line 4—Change second Saturday in December — to — Saturday preceding Thanksgiving.

Article II, Section 2, line 3 — delete "San Diego".

Article II — Add Section 4. Junior High Schools may become associate members of the CIF, Southern Section by a majority vote of the Council.

Article V, Section 4, lines 1 and 2—Delete "a faculty man from one of the member schools". Article XI, Section 1—Add to Constitution—A majority of the Executive Committee shall constitute a quorum.

9. Mr. Sam Zackheim, Chairman of the Committee appointed to study the problem of fees paid to athletic officials who work interscholastic

athletic contests in the SS, was called upon to present the recommendations of his committee. Mr. Zackheim explained some of the background which made necessary the appointment of his committee and then listed the following points which influenced the committee in preparing their recommended maximum officiating fee schedule: (a) there has been no change in Officials Fees for afternoon contests in the past 13 years, (b) the fee for night contests was raised three dollars from \$12.00 to \$15.00 in 1956, (c) certain leagues in the SS were already paying in excess of established maximums because of misinterpretation of existing rules, (d) certain leagues in the SS were paying more than the established maximums by adding travel expense to the fees, in cases where excessive travel was not necessary, (e) in football the Referee is the man charged with the responsibility of directing the crew and making the decisions regarding enforcement of penalties, so should receive a higher fee, (f) working a doubleheader in bas-

*When two sets of officials are employed for a scheduled basketball doubleheader, it is permissible to pay each official the single game rate.

It was moved and seconded that the proposed Officiating Fee Schedule be adopted as presented. After considerable discussion, the question was called for and the motion was passed by a 27 to 6 vote, which means that the new Officiating Fee Schedule will go into effect with the 1960-61 school year.

10. Mr. Len Cohn, football Coach at Claremont HS, and president of the recently formed Football Coaches Association of Southern California, was given time to make a presentation on behalf of his organization relative to the issuing of CIF, SS Courtesy Cards to all varsity football and basketball coaches in our member schools. It was the feeling of the coaches association that such passes be furnished to enable the coaches to more easily gain admittance to SS contests for the purpose of scouting opponents and viewing playoff games.

There was considerable discussion concerning this item, and it was pointed out that it was already a policy of the CIF, SS to furnish each principal with a courtesy card and to send each

ketball takes more time and is considerably more difficult than officiating in other sports, so should receive a higher fee than has been paid in the past, (g) in baseball the plate umpire is the umpire in chief and is required to make many more decisions than the man assigned to the bases and consequently should receive a higher fee, (h) because many leagues can improve their basketball officiating by using two sets of officials on a doubleheader, permission is granted to pay each set of officials according to single game fees, (i) in track and swimming standard fees should be established which would include the cost of shells used by the starter, (j) an attempt was made to standardize all fees as much as possible, keeping in mind the degree of difficulty and the amount of time employed in handling an officiating assignment. Emphasizing that fees recommended were MAXIMUMS only, Mr. Zackheim presented the following Officiating Fee Schedule for the consideration of the Council:

school an additional pass to be assigned to the person in that school who is assigned the responsibility of administering the athletic program. Many of the representatives were of the opinion that an additional pass should not be furnished each school. It was moved and seconded that Article XII, paragraph 4, page 26, of the Blue Book, be amended to provide that each member school be sent a third pass made out to "The Athletic Department" and to be used by any member of the Athletic Department during the school year. This motion was passed by a 20 to 15 vote.

11. The Commissioner brought to the attention of the Council certain problems that were plaguing the interscholastic athletic program due to coaches, particularly in track and swimming, using boys in two and sometimes three different classifications during the season of a sport. It was suggested that consideration be given to enacting a rule which would provide that a boy could not move down in classification after the beginning of the league schedule in any sport.

Discussion brought out the fact that such a rule might work to the detriment of small schools and private schools and that this matter should be referred to committee for further study. It was moved, seconded and carried that the President be directed to appoint a committee which would be charged with the responsibility of studying the problem of boys moving up and down in classification and be prepared to make recommendations concerning this matter at the next meeting of the Council.

12. With the approach of the noon hour President Charlson informed the Council that the meeting would be adjourned for one hour to permit the members to partake of a fine luncheon to be served in the Brea-Olinda HS cafeteria.

13. Upon reconvening after lunch the first order of business was to give consideration to the adopting of regulations on the section level which would establish a starting date for practice and limit the number of contests that could be played in basketball, track and baseball. Chairman Schilling gave some background concerning this matter and informed the Council that he would present the three sports separately so that the Council could consider and act upon each sport individually.

Mr. Schilling first presented the recommendations of his committee pertaining to basketball. The proposed regulations are as follows:

(a) Organized after school team practice in any school cannot begin earlier than November 1.

(b) No inter-school games may be scheduled prior to December 1.

(c) Two inter-school scrimmages may be scheduled between November 15 and November 30. (Scrimmage is defined as practice where no score is kept, spectators are not urged to attend and the practice period is divided into a number of equal segments with running time kept.)

(d) A basketball team will be permitted to play no more than 22 games, including tournaments but excluding SS Playoffs. (Each tournament entered will count as two games.)

It was moved, seconded and carried by a vote of 28 to 5 that the foregoing regulations be made a part of Article XVII of the By-laws and be effective with the beginning of the 1960-61 school year.

The following track regulations were then presented for consideration:

(a) Organized after school team practice in any school cannot begin prior to the beginning of the second semester.

(b) Each school will be permitted 9 dual or triangular meets not including invitational, all league or CIF SS meets.

(c) No high school boy will be permitted to enter two different meets on the same day.

(d) A member of a high school track team will not be permitted to enter more than four sanctioned (invitational) track meets.

It was moved, seconded and unanimously carried that the foregoing regulations be made a part of Article XVIII of the By-laws to be effective with the opening of the 1960-61 school year.

The following baseball regulations were then presented for consideration:

(a) Organized after school team practice in any school cannot begin prior to the beginning of the second semester.

(b) Each team will be permitted two inter-school scrimmages. (An inter-school scrimmage is defined as one where no score is kept, umpires are not paid, free substitution is allowed and coaches may stop play for the purpose of correcting mistakes of players.)

(c) A team will be permitted to play no more than 20 games including tournaments but excluding CIF, SS Playoffs. (Each tournament entered will count as two games.)

It was moved and seconded to adopt the foregoing regulations as a part of Article XIX of the CIF, SS By-laws. Considerable discussion ensued and some representatives were of the opinion that the number of games permitted a high school baseball team should be the same number permitted a basketball team. It was moved and seconded to amend the original motion to provide for 22, instead of 20, as the maximum number of contests allowed in baseball. The motion to amend was defeated by a vote of 22 to 11. The original motion was then voted upon and it was passed by a vote of 29 to 4. These regulations to go into effect in the 1960-61 school year.

14. The Commissioner reported that administrators from some of our member schools and leagues had contacted the SS office to register a protest concerning the lack of publicity being provided our interscholastic athletic program by certain of our metropolitan dailies. The matter was discussed and many of the representatives present reported that schools in their leagues were greatly concerned with the limited space being given to the coverage of prep sports. It was moved, seconded and carried that the Commissioner be authorized to contact in person the editors of papers concerned relative to this matter in an effort to obtain better coverage of the interscholastic athletic program in Southern California.

15. The election of CIF, SS officers was the next order of business.

(a) It was moved, seconded and unanimously

carried that Winston Nelson be re-elected for a term of two years as SS representative to the State Federated Council.

(b) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Winston Nelson as Treasurer of the CIF, SS for the 1960-61 school year.

(c) It was moved, seconded and carried to cast a unanimous ballot for the re-election of Mr. Robert J. Schilling for a term of four years as a member of the Executive Committee, representing Los Angeles County.

(d) With the retirement of Mr. B. L. Bergstrom from school work, it was necessary to elect someone to the Executive Committee to serve the remaining three years of Mr. Bergstrom's four year term. Mr. Robert Ashton, Asst. Supt. of the Excelsior District and Mr. Harold Wetzler, Vice Principal at Hawthorne HS, were nominated. A ballot was cast and Mr. Wetzler was elected to fill out the unexpired term of three years on the Executive Committee.

(e) It was moved, seconded and carried that Mr. Charles Jordan of Colton HS be elected to a four year term on the Executive Committee representing Imperial, Inyo, San Bernardino and Riverside Counties.

(f) It was moved, seconded and carried that Mr. Marion Hays of Harvard School be elected to serve a one year term as a member of the Executive Committee representing Los Angeles County.

(g) In accordance with the CIF, SS Constitution the Rio Hondo League representative will succeed to the presidency for the 1960-61 school year. Mr. Ray Charlson, outgoing Council President, turned the meeting over to Mr. Orval Rodgers, this year's representative from the Rio Hondo League who accepted the Presidency on behalf of Mr. John Landrum, Principal of San Marino HS and the Rio Hondo League representative for the coming year who will also serve as Council President.

(h) In similar manner the San Gabriel Valley League representative, Mr. Emmett E. Larson, Principal of Santa Fe HS, was announced as Vice-President of the Council for the 1960-61 school year.

16. A unanimous standing vote of appreciation was given to Mr. Ray Charlson for the outstanding manner in which he served the CIF, Southern Section as its President during the past school year. Mr. Charlson exhibited great leadership and under his direction the Southern Section experienced one of its finest years.

17. It was moved, seconded and carried to thank Mr. Frank O. Hopkins and Brea-Olinda HS for permitting the Southern Section the use of its outstanding facilities and for the delicious luncheon served in such pleasant surroundings.

There being no further business to come before the meeting it was moved, seconded and carried that the meeting be adjourned at 2:48 P.M.

Coach Jack Bradford of the Titans regards this victory as the "sweetest" in the six years San Marino has had a varsity net squad. Of all the victories that have been won over this period of time, he felt that this was the most unexpected. Every player contributed his share to the victory, and individual determination from the start was the keynote to the championship.

To reach the finals San Marino swept aside La Salle in the opening round and then overwhelmed Rancho Alamitos and Palm Springs in quarter and semi-final matches respectively. Harvard, top seeded in the upper bracket drew a bye in the first round and then took the measure of Claremont 24½ to 3½, and defending champion Thatcher School by a score of 20-8, to reach the championship round.

Coach Jack Bradford and his San Marino netters are to be congratulated on their sterling play, not only this year, but during the past six years. The Titans over this period of time have compiled an enviable record which includes 99 wins in dual matches, five straight Rio Hondo League titles, two CIF, SS championships and two CIF, SS runners-up.

VETERAN EDUCATOR HONORED

In recognition of his many years of service to the CIF, SS, Mr. Donald H. McIntosh, on the eve of his retirement from the Colton High School District, was honored at the May 21 meeting of the Southern Section Council by being presented with a CIF, SS gold Life Pass. The presentation was made by Mr. Oliver Corbin, Principal of Covina HS and a long time member of the Executive Committee.

Mr. Corbin reviewed the highlights of Mr. McIntosh's illustrious career. It seems that Mac was born in Oregon but his folks moved to California where he graduated from San Diego HS after winning letters in football, basketball and baseball. He next attended Occidental College where he again participated in all three sports.

During World War I he served with distinction with the medical corps overseas. In 1919 he started his teaching career at Covina HS where he also served as head athletic coach. His teams won many championships and he personally coached the first prep trackster to run the half mile in less than two minutes. Mac took this boy to the National Track Finals held in Chicago.

In 1925 Mr. McIntosh moved from Covina to Colton HS and after five years of outstanding service was named Principal in 1930. During his lengthy career he has always been extremely interested in athletics but has also been a leader in other fields. He originated the American Legion sponsored Constitution contest that is national today. He started special English classes for students in Spanish speaking homes. He is a leader in Life Adjustment Education, serving as California's representative to this group in the east.

Throughout his tenure at Colton, Mac has served the interests of athletics not only in the powerful Citrus Belt League but in CIF circles as well. He has been the representative of his league on the Council for many years and has headed many of the important committees. The CIF, SS is going to miss Mac and with our best wishes for a long and happy retirement goes a cordial invitation to return and visit at meetings of our Council where he can renew old friendships with many of the men with whom he has worked over the years.

ANTELOPE VALLEY HS CAPTURES CIF, SS GYMNASTICS CHAMPIONSHIP

One of the most exciting prep gymnastics meets ever held in the Southern Section took place at Antelope Valley HS, on Friday night, May 20, when the host school captured the CIF, SS championship by the margin of one-half point, before an overflow crowd of enthusiastic spectators.

Besides capturing their first CIF, SS Baseball championship since 1951, the Saints completed the season with a perfect 18-0 record. To reach the finals Santa Clara blanked Mission of San Luis Obispo 12-0, eked out a victory over Harvard School 11-9, and then took the measure of Valencia 3-1 in the semi-final contest. Rubidoux, a free lance entry, edged by Aquinas in a first round contest 2-1, defeating Ramona 11-8, and then white-washed the defending champs from Needles HS 5-0, to earn the right to meet Santa Clara for the title.

PHOTO FINISH DECIDED TEAM TITLE
IN CIF, SS TRACK CHAMPIONSHIP MEET

Fontana HS captured the 1960 CIF, SS Track Championship in the varsity division by the narrow margin of one point, when they scored 17 points to runner-up Compton's 16. At the conclusion of the meet it appeared that Fontana would have to share the title with Compton HS, but a review of the slow motion movies proved conclusively that John Moore of Compton finished fifth instead of fourth as the finish judges had him picked. This took one point away from Compton's total and gave the coveted championship to Coach Austin Snyder's courageous Steelers.

The meet was held on Saturday, May 28, in the Veterans Memorial Stadium in Long Beach before a crowd of about 5,000 spectators. Unlike the two previous years when the meet was held in this fine stadium under ideal conditions, the track was in deplorable shape which hampered greatly the performance of the young athletes. Although on the surface the track appeared to be hard, a recent shipment of clay contained too much sand which caused the track to break down and become soft in spots, particularly on the pole lane. The problem was discovered halfway through the meet, but of course it was too late to make any adjustment. We can only apologize to the athletes who had to perform under such poor conditions.

Even under poor conditions most of the performances were outstanding and the highlight of the varsity meet was a record breaking performance by Ray Van Asten of Bonita HS, who ran the 880 in 1:53.0, to break the old CIF standard of 1:53.3, set by Jim Cerveney of Mission Bay HS in 1957 on the fast Chaffey oval. No other variety records were set in this meet but in the semi-finals at Compton HS, Ullis Williams, a junior in the host school, raced to a new CIF, SS record in the 440, in the fast time of 47.7. In last week's State meet Ullis won the 440 in the time of 47.0, which is the fastest mark ever recorded in the nation for a junior. Great things are expected of this boy next year.

The Class B division was a dog fight with Jordan of Long Beach scoring 13 points to take the team title, while Western of Anaheim and San Diego each scored 11 points to tie for runner-up honors. An unusual occurrence took place in the B competition when new CIF, SS records were established in all four of the field events. In the high jump James Stewart of Santa Paula leaped 6' 5 1/4" to eclipse the old mark which had been established only the week before in the semi-finals at Compton by Bill French of Jordan HS in Long Beach. In the pole vault a junior from El Cajon HS by the name of Mike Graves also set a new mark when he soared to the almost unbelievable height of 14' in the Pole Vault. When you consider that the winning height in the State meet was only 13' 3", you can realize what an achievement was accomplished by this talented youngster. Vern King of San Diego set a new mark in the broad jump when he recorded a distance of 23' 10 3/4". In the shot put Dick Nye of Ventura approached the magic 60 foot mark when he pushed the iron ball 59' 10" to better the then existing record of 58' 3 3/4" set by Tony Palante of Leuzinger back in 1956.

In the Class C meet it was all Arcadia and Newport Harbor as far as the team title was concerned. The meet went down to the final event before it was decided and the third place scored by Arcadia in the relay gave them enough points, 17, to edge out Newport Harbor which finished with a total of 16. Only one record was established in the Class C meet and that one had an unusual twist in that the record was broken in the semi-finals and then tied by another boy in the finals. On May 21 at Chaffey HS, Robert Britt of Riverside Poly, jumped 22' 3 1/2" to eclipse by 1/4 of an inch, the old record held by Cecil Scott of Pt. Loma. Then in the finals Julius Clark of Washington Jr. HS of Pasadena tied the new mark as he captured the first place medal.

There were four preliminary meets held on May 14 at San Diego, El Rancho HS, Beverly Hills HS and Lakewood HS in Long Beach. The

boys who qualified at San Diego and El Rancho were entered in the semi-finals held at Chaffey, while the qualifiers at Lakewood and Beverly Hills earned the right to compete at Compton. From these semi-final meets held on May 21, boys were qualified into the championship meet which was slated at Long Beach.

All of our seven meets were most successful and the CIF Office is most grateful to the following men who served as meet managers and

did such a wonderful job of conducting their respective meets: Don Clarkson of San Diego, Haskell Elder and Bill Meyer of Lakewood HS, Sam Travis of El Rancho HS, Walt Pepper of Beverly Hills HS, Ernie Hartmann of Compton HS, Trusk Lindsay of Chaffey HS, and Bucky Harris of Millikan HS who served as manager of the Championship meet.
