## CIF ATHLETIC AND PUPIL INSURANCE BENEFITS INCREASED AT NO INCREASE IN FEES

Two major increases in athletic and pupil injury benefits for the 1963-64 school year are announced by the CIF Protection Fund, according to William W. Russell, CIFPF Executive Secretary and State CIF Commissioner. The two increases are:

1. Every CIFPF member will be protected with a "catastrophic Injury" coverage purchased by CIFPF from Security Life and Accident Company of Denver, Colorado. The catastrophic injury coverage will supplement the basic CIFPF benefits. The catastrophic injury coverage will become effective when medical bills have reached \$500 and when hospital bills have reached \$500, the maximum benefits currently available from CIFPF's own coverage. When this occurs, the catastrophic injury coverage provides an additional \$2500 protection against medical expense and an additional \$2500 protection against hospital expense for care rendered within one year from date of injury.

2. Benefits will be provided for services rendered within one year from the date of injury, provided that the first treatment is by a licensed physician and surgeon or hospital within 45 days from date of injury. Previously, benefits were provided for 180 days from date of injury.

Even though CIFPF benefits are greatly increased for both pupil and athletic coverage, there is no change in membership fees. The public schools can secure CIFPF athletic insurance whether or not it uses CIFPF pupil insurance. The increased coverage places the CIF insurance Program still further ahead of anything in the field. The catastrophic injury coverage will not only be of great financial assistance to the pupils and parents when a catastrophic injury does occur, but it quite probably will eliminate the need for "benefit games" to assist in meeting the costs of large hospital and medical bills for which there previously was no coverage from any source.

## COMMITTEE REVIEWS PROBLEM OF GAME FILM EXCHANGE

During the 1962 football play-offs an unfortunate situation developed over the use of game films for scouting purposes in the "AA" championship game involving South Pasadena and Bishop Amat HS. Amat HS had access to films of a recent South Pasadena game but South Pasadena was denied the use of any films of previous Bishop Amat games.

The administration at South Pasadena protested this patently unfair situation to the Executive Committee of the Southern Section, but no official action was taken because no CIF, SS rule had been violated. The Executive Committee agreed, however, that the situation did appear to violate the spirit of fair play and they directed the Commissioner to prepare recommended legislation to alleviate the problem in future play-offs.

A story published in the January Monthly Bulletin reported the situation based on an investigation of the known facts in the case. At a later date word was received in the Southern Section office that some of the statements in the article could be in error. To resolve the situation, the Commissioner then met with official representatives from Bishop Amat, Claremont and South Pasadena High Schools.

A forthright discussion was held and an attempt was made to bring out all of the facts pertinent to the situation. Agreement could not be reached on many points of contention because of conflicting testimony which could not be proved or disproved. It was the consensus of opinion, however, that Coach Dave Lewis, football coach at Bishop Amat HS, had been singled out and unduly criticized for his part in the matter.

We would like at this time to report that the investigation did show that Coach Lewis had made an effort to furnish South Pasadena with scouting reports of his team, but of course he did not see that they received a copy of one of his game films. Because of the effort made by Coach Lewis, we would like to correct the impression that he had acted in an unsportsmanlike manner or attempted to gain an unfair advantage over his opponent. Coach Lewis has always conducted himself as a gentleman in his relations with officials and opponents and we wish him continued success in his chosen field.

**MINUTES OF MAY COUNCIL MEETING  
OF THE CIF, SOUTHERN SECTION**

The final meeting of the CIF, SS Council for the current school year was held on Saturday morning, May 18, 1963, at Chaffey HS in Ontario. The meeting was called to order by President Roland Ewing, Vice Principal of Atascadero HS, at 9:30 AM. Official representatives from all leagues except the Pioneer and Sunset were in attendance. Guests included Dick James of Glenn HS, Reverend Hughes of St. Bernard's HS, Reverend Donald Montrose of Mater Dei HS, Curtis Glass of San Bernardino HS, Frank Serrao of Redlands HS, John Williams of Brethren HS, Carl Fisher of Mira Costa HS, Ken Bullock of San Marino HS, Art North of Arcadia HS, Gil Strothers of Alhambra HS, Nolan Noble of El Rancho HS, Richard Cordano of Muir HS and Hank Azhderian of Boys Republic.

1. APPROVAL OF MINUTES — It was moved, seconded and carried to approve the minutes of the Council meeting held on February 2, 1963, as published in the February, 1963, Monthly Bulletin.

2. APPROVAL OF EXECUTIVE COMMITTEE MEETING MINUTES — It was moved, seconded and carried to approve the minutes of the following Executive Committee meetings: March 9 at Long Beach, April 20 at Palm Springs and May 17 in the Southern Section office.

3. INCREASE NUMBER OF BALL GAMES — It was moved and seconded that the Football League proposal to eliminate the two baseball scrimmages and replace them with practice games, which would increase the total number permitted from 20 to 22, be adopted. After some discussion, a vote was taken and the motion was defeated.

4. BOY PLAYING IN TWO BASKETBALL GAMES IN ONE DAY — An item of old business concerning the number of basketball

games a boy should be permitted to play in one day was brought up for discussion. It was moved, seconded and carried to add the following section to Article XXX of the By-Laws: "A basketball team may not play more than one game in one day except in tournaments, as provided in Section 17. A boy may not participate in more than one game in one day except where he is a member of a team participating in a tournament, as outlined in Section 17."

5. FOOTBALL PLAY-OFFS — At the November Council meeting the problem of play-off divisions in football was discussed and a committee composed of Keith Lee, Principal of Dominguez HS, Ted Gossard, Vice Principal at Aviation HS, and Bill Barnett, of Loyola HS, was appointed to study the situation and make recommendations to the Council relative to resolving the problem. The committee prepared two play-off plans and recommended that Plan A, which provided for 16 entries in the "AAAA" and "AAA" divisions with 8 entries in the "AA", "A", and "Small School" divisions, be adopted. It was moved, seconded and carried to accept the recommendations of the Football Play-off Committee and adopt Plan A for the 1963 football play-offs.

6. PUBLICITY MAN—Winston Nelson reported that, in accordance with action taken by the Council at the May, 1962 meeting, the Executive Committee has been screening candidates in an effort to secure a capable man to handle publicity for the CIF, Southern Section. He indicated that the present staff is overburdened and a publicity man was needed to assist in writing the Monthly Bulletin, publicize and publish programs for play-off activities, compile statistics, issue weekly news-releases and handle public relations for all controversial issues involving the Southern Section.

Mr. Nelson stated that interviews had been conducted and it was hoped that we could allocate approximately \$6,000.00 to \$8,000.00 to employ a part-time publicist. The matter was discussed and many representatives expressed the opinion that the position should be a full-time one, but we should attempt to secure the services of a qualified young journalism teacher or reporter whose starting salary would not be unreasonable. It was then moved, seconded and unanimously carried that \$10,000.00 be set aside in next year's budget for publicity purposes and the Executive Committee be authorized to expend the allocated money to employ a publicist and take care of necessary expenses in connection with the publicity program.

7. REDISTRICTING COMMITTEE—Frank O. Hopkins, chairman of the committee recently appointed to study the possible redistricting of private schools for athletic purposes, reported that his committee met in the Southern Section office on March 28 and discussed all phases of the problem. Many interesting facts not previously known by most of the members of the committee relative to the organization and administra-

tion of Catholic and private schools were raised and discussed.

The committee was informed that plans were already under way for the formation of a special committee of Catholic school principals, who would take an active part in resolving athletic problems affecting Catholic schools. It was hoped that this group would serve as a liaison between the Catholic schools and the CIF, Southern Section, which would result in the Catholic schools resolving many vexing problems such as the one which prompted the formation of a committee to study the possible redistricting of private schools for athletic eligibility purposes.

Mr. Hopkins then indicated that it was the recommendation of his committee that no action be taken by the CIF, SS, at this time in order to give the newly formed Catholic school committee time to study the problem and take any measures they deem necessary to alleviate the objections to the present system of open districts for private schools.

8. WRESTLING DATES — Dick Spaulding, representative of the Freeway League, requested an explanation as to why the CIF, SS Wrestling Championship was to be conducted in 1964 on a Friday. He pointed out that this made it necessary for coaches, officials and contestants to be excused from one day of classes and suggested that this championship meet be held on a Saturday. It was then moved, seconded and carried that the date of the 1964 CIF, SS Wrestling Championship be changed from Friday, February 28, to Saturday, February 29.

9. ELECTION OF OFFICERS — The next order of business was the election of officers for the 1963-64 school year. Ballots were provided and the election was conducted by members of the Nominating Committee.

The results of the election of officers were as follows:

A. Mr. Frank O. Hopkins, Supt. of Brea-Olinda School District, was elected to a two-year term as Southern Section representative to the State Federated Council.

B. Winston Nelson, Asst. Supt. of Pomona School District, was elected to a three year term as Treasurer of the CIF, SS.

C. Harry Bigger, Principal of Fillmore High School, was elected to a four-year term on the Executive Committee as a representative of the Northern Area.

D. Marion Hays, Vice Principal of Harvard School, was elected to a four-year term as a member of the Executive Committee from the Metropolitan Area.

E. Kenneth Fagans was elected to a four-year term as Commissioner of Athletics.

In accordance with the CIF, SS Constitution, the Sierra League representative, Dr. Nelson Price, will succeed to the presidency of the Council for the 1963-64 school year.

10. PLAY-OFF GROUPINGS FOR BASEBALL AND BASKETBALL—The Commissioner requested that this matter be deferred to the

November Council meeting in order that accurate enrollment figures might be secured from all schools in the SS. It was moved, seconded and carried to defer the item pertaining to the establishment of playoff groupings in baseball and basketball for 1964 until the November Council meeting.

11. EIGHT-SEMESTER RULE — John A. Dreyfuss, Condor League representative, presented a proposal by his league to permit the use in Condor League athletic contests of ninth-semester students. He pointed out that the private schools in his league found it necessary to have many students entering in the ninth and tenth grades repeat one year of academic work, which means that when they became seniors, they were ineligible for athletic competition. He stated that his league only wanted to use these boys in contests involving member schools of the Condor League and that whenever outside competition was involved, these boys would not be permitted to participate. After some discussion it was moved, seconded and carried to deny the request of the Condor League to permit the use of ninth-semester boys in league athletic competition.

12. WATER POLO FEES — The Pioneer League representative proposed an increase in the maximum fees for water polo officials in order to assist in the recruitment of officials and so that our high schools might compete with the junior colleges in securing adequate water polo officials. At the present time, junior colleges are paying \$12.00 for one game, while high school officials are being paid only \$12.00 for three games. It was then moved and seconded that the established maximum fee for water polo officials be set at \$15.00 for afternoon contests and \$17.00 for night contests. This motion was passed and will become a part of the By-Laws for next year.

13. CROSS COUNTRY—Jim Faul, Montview League representative, presented the proposal of this league to change Article XXXI, Section 2, to permit organized after-school cross country practice to begin on the day after Labor Day instead of on the opening day of academic classes in each particular school. After some discussion, this proposal was put in the form of a motion and seconded, but the motion was defeated. The rule, therefore, remains the same and organized after-school practice in cross country will not be permitted prior to the opening day of academic classes in a particular school.

14. CIF, SS TRACK DATES—The San Gabriel Valley League representative, Mr. Art Hobson, stated that his league had directed him to bring to the attention of the Council their objections to advancing the dates for the CIF, SS prelims, semis and finals in track because of a change of date in the State Track Meet. After some discussion it was moved and seconded that the dates for the 1964 SS prelims, semis and finals be changed back to May 9, 16 and 22. This motion was defeated so in 1964 the SS prelims



will be held on May 16, the semi-finals on May 22 and 23, and the championship meet on Friday night, May 29.

15. OFF-SEASON ATHLETIC PRACTICE—Mr. Neil Philips, of the Moore League, stated that in the opinion of his league a problem was developing because of off-season practice being conducted by coaches in sports other than football. He then moved that the Southern Section appoint a committee to study the problem of off-season practice in sports other than football. This motion was seconded and unanimously carried and the President appointed the following committee: Neil Philips of the Moore League, John Siexas of the Sierra League, Carl Fisher of the Bay League, and Father Donald Montrose of the Angelus League.

16. EXCHANGE OF FOOTBALL GAME FILMS—During the past football playoff season a number of problems arose concerning the use of game films for scouting purposes. It was felt that this matter should be given some study so that regulations could be established governing the exchange of football films for scouting purposes during the play-offs.

The Southern California Football Officials Association took this matter under study and has made the following recommendations:

"We, the Southern California Interscholastic Football Coaches Association, do agree that the exchange of films between schools in the CIF, Southern Section, play-off games is ethical and desirable.

"However any use, or viewing, of football films for CIF play-off games must be agreed upon between the two head football coaches directly involved.

"It will be considered illegal, and unethical, for any school representative to view a film of a possible future opponent, except by mutual consent of both coaches involved.

"If mutual agreement cannot be arrived at, there will be no films used by either team."

A discussion of the matter brought out the fact that it would be desirable to have rules governing this matter and it was moved, seconded and carried to adopt the recommendation of the Southern California Football Coaches Association relative to the exchange of films for scouting purposes among teams entered in the play-offs.

17. APPRECIATION—It was moved, seconded and unanimously carried to express our thanks and appreciation to Ernie Payne and Chaffey High School for arranging a delightful and tasty luncheon and permitting us the use of their excellent facilities for the holding of our meeting.

18. President Ewing then turned the gavel over to the incoming President, Mr. Nelson Price, representative of the Sierra League. Mr. Price then thanked Mr. Ewing for the outstanding service he has rendered the Southern Section as Council President during the past year. He indicated his pleasure at assuming the re-

sponsibilities of President and assured those in attendance that he would work diligently to carry on the fine interscholastic athletic program that our member schools enjoy in Southern California.

There being no further business to come before the Council, the meeting was adjourned at 11:45 AM.

#### MINUTES OF EXECUTIVE COMMITTEE MEETING — MAY 17, 1963

The meeting was called to order by Chairman Keith Gunn at 2 PM on Friday, May 17, in the CIF, Southern Section office. Those in attendance included Messrs. John A. Taylor, Principal of Nordhoff HS; Winston Nelson, Asst. Supt. of Pomona School District; Frank O. Hopkins, Superintendent of Schools at Brea; Marion C. Hays, Vice Principal of Harvard School; Harold Wetzler, Principal of Hawthorne HS; Charles Ronin, Vice Principal of Redlands HS; Roland Ewing, Vice Principal of Atascadero HS; Robert D. Ashton, Asst. Supt. of Schools for the Excelsior District; and J. Kenneth Fagans, Commissioner of Athletics.

1. MINUTES APPROVED—It was moved, seconded and carried to approve the minutes of the Executive Committee meeting held on April 20, 1963 as published in the April, 1963, Monthly Bulletin.

2. NEW SCHOOL—It was moved, seconded and carried to recommend to the Council that the Peralta Junior High School in Orange be accepted as an Associate member, effective September, 1963.

3. THE TWO-MILE RUN—The Foothill League requested permission to conduct the two-mile race as a part of all varsity meets in the Foothill League during the 1964 season on an experimental basis. It was moved, seconded and carried to grant permission to the Foothill League to conduct the two-mile event on an experimental basis during the 1964 season, provided only league schools were involved and an evaluation prepared and sent to the SS office at the conclusion of the season.

4. AMATEUR RULE—Pacific High School requested an interpretation of our amateur rule, as it would apply to a boy who received a cash prize for winning a motorcycle race during the summer vacation. After a study of the present rule, it was moved, seconded and carried to clarify this rule by stating that the amateur rule applies to high school boys in all sports approved by the CIF. The approved sports are as follows: badminton, baseball, basketball, bowling, canoeing, cross country, cycling, fencing, field hockey, football golf, gymnastics, handball, rugby, skiing, small bore rifle, soccer, softball, speedball, swimming, tennis, track, volleyball, water polo, weight lifting, and wrestling.

It was moved, seconded and carried to further clarify the amateur rule by stating that it applies to any game, exhibition or activity in which the skills and/or equipment of approved CIF sports are employed. This means that a boy could not receive a cash prize or an award in excess of prescribed limits in such activities as a hole-in-one golf tournament, a free-throw shooting contest or a punt or passing contest for distance or accuracy.

5. WEIGHT-LIFTING—At the present time, Article XXXII, Section 36, of our By-Laws, places certain restrictions upon weight-training classes which may be conducted during the summer months. It was felt that weight-lifting classes were worthwhile and such activities should be permitted as long as they were not conducted in conjunction with summer football workouts. It was moved, seconded and carried that the phrase "weight-lifting activity" be deleted from Article XXXII, Section 36, of the By-Laws. It was further recommended that weight-lifting and conditioning activities by recreation departments be encouraged during the summer months.

6. RESIDENCE RULE—Clarification was requested by Ganesha HS relative to Article X, Paragraph 2 of the Blue Book, pertaining to eligibility in the SS. It was pointed out that this section of our residence rule requires a transfer student to have been eligible in the high school from which he transferred. At the present time, there are many exceptions to this rule, as many boys are ineligible in a school because of citizenship; yet when they transfer legally to another high school, this does not deprive them of eligibility in the second school.

It was then moved, seconded and carried to delete from Article X, Paragraph 2, the following phrase: "Must have been eligible under the rules of the CIF, Southern Section, in the school from which he transferred."

7. CERTIFICATION OF COACHES—Mr. Jerry Wyness, representing CAHPER, appeared before the committee to discuss the recent interpretation by our committee pertaining to the use of non-certificated persons to assist in the coaching of high school teams. CAHPER was concerned that the interpretation placed by the Executive Committee on this matter might be in disagreement with the philosophy that professional standards should be upheld by insisting that the coaching of athletic teams be entrusted only to certificated persons.

A discussion of the matter brought out the fact, however, that this was not the case and that both CAHPER and the Executive Committee were in general agreement on the question. To clarify the recent interpretation, it was moved, seconded and carried to direct the Commissioner to inform CAHPER and other interested persons that permission to use a non-certificated person as an assistant to the certified coach had been granted only after it was evident that the principal of the high school had exhausted all possibilities of obtaining a certificated person for the position.

8. TRACK INTERPRETATION—The question of whether or not a boy can compete in two different classifications in the same track meet was discussed. It was unanimously agreed that a boy could not compete in the same track meet in two different classifications. The problem hinged upon whether or not league prelims and finals and CIF prelims, semis and finals were each one meet. It was the majority opinion that league prelims and finals were one meet, as were the prelims, semis and finals of the CIF, SS. It was then moved, seconded and carried to add the following section to Article XXXVII of the By-Laws: No boy shall compete in two different classifications in the same meet. League prelims and finals are considered to be one meet, as are the CIF, SS prelims, semis and finals.

9. "A" TENNIS TOURNAMENT—Because of the increase in the number of leagues playing tennis and the lack of courts available at Long Beach City College, it was moved, seconded and carried that for the 1963 Class A Tennis Tournament, to be held on Saturday, June 1, two singles players and one doubles team from each league be permitted to enter.

10. GOLF TOURNAMENT—In order to eliminate problems arising from high school players attempting to schedule practice rounds on golf courses where CIF, SS team and individual tournaments are to be held, it was moved, seconded and carried to add the following section to Article XXXIII by the By-Laws: No high school golfer, except members of the host school who use the course as their home course, may play any of the holes on the courses selected for the CIF, SS Team and Individual Tournaments for thirty days prior to the date of these scheduled tournaments.

11. RAINED OUT TRACK MEETS—The Montview League requested that consideration be given to the adoption of a rule to govern situations where a dual track meet is called prior to its completion because of inclement weather. After some discussion, it was moved and seconded that in the event a dual track meet is suspended prior to its completion because of inclement weather, it will be rescheduled and conducted in its entirety at a later date. This motion was DEFEATED. It was then decided to refer this question to the Track Committee.

12. OPENING DAY OF PRACTICE IN SPRING SPORTS—Azusa HS requested a clarification of the rule governing the opening day of practice in spring sports. This rule provides that a school may begin practice in the spring sports on the opening day of the second semester. The question raised pertained to the opening day of practice when schools within a league had a different starting date for the opening of the second semester. It was the decision of the committee that the rule must be followed by every member school. It was suggested that if the opening day of school varied among the schools within a league, the league should establish the opening date for practice for spring



sports as the latest day when a school in a league begins the second semester.

13. CROSS COUNTRY PRACTICE—Article XXXI, Section 2 of our By-Laws, states that after-school organized practice in cross country shall not begin prior to the opening day of regular classes in a particular school. A question was raised as to whether or not this rule prohibited organized cross country practice during the summer months. The Executive Committee in interpreting this rule decreed that organized practice in cross country could be conducted any time from the close of the regular season up until the opening day of football practice (the day after Labor Day). Organized after-school practice could not be held during the period starting with the opening day of football practice and the opening day of classes in a particular school. This interpretation would also apply to water polo.

14. It was moved, seconded and carried to hold the next meeting of the Executive Committee at Newport on Saturday, June 15, 1963.

There being no further business to come before the committee, the meeting was adjourned at 5:15 PM.

### BALDWIN PARK HS DOMINATES GYM MEET

In the CIF, Southern Section championship gymnastics meet held at Lakewood HS in Long Beach on Friday, May 17, Coach John Draghi's powerful Baldwin Park HS gym team amassed 44 points to win the coveted championship and more than double the points scored by its nearest rival, El Rancho, which took runner-up honors with 19½ points.

This marks the third straight year that the Montview League champs have taken the title and it begins to appear that a dynasty is in the making. The Braves scored points in each of the eight events on the program and won individual titles in the rings, parallel bars, rope climb and horizontal bar.

Sid Sowder of Anaheim and Sendol Munger of Baldwin Park battled for high point honors and when the competition was over, these two fine all-around gymnasts wound up in a tie with 8½ points. Sowder took home the high-point trophy but a duplicate will be ordered for Munger.

To reach the finals in the championship meet, boys had to qualify in one of three sectional meets, which were held on Friday, May 10, at Baldwin Park, California and Millikan High Schools. Schools were assigned to these preliminaries in an attempt to balance the strength at the three meets and also take into account the geographical location of the schools. All of the prelims were successfully staged and much credit should go to the following coaches who

served as meet managers: John Draghi at Baldwin Park, Bob Lowe at California and Fred Bellmar at Millikan.

The championship meet was under the direction of Dick Flood of Lakewood HS, and his fine pre-meet planning and good organization resulted in one of the finest gym meets in the history of the Southern Section. We are grateful to all of the meet managers for the outstanding service they rendered.

In the class B division, Santa Monica High School took top honors with a total of 23 points. Santa Monica and Loyola were close behind with 17 and 16 points respectively.

Jim Hobson (first ranked in the 16's in Southern California) of Sunny Hills High School took the B singles crown by defeating Ron Wilens of Santa Monica High School 6-2, 6-1. Hobson reached the finals by defeating Rick Reed of Glendale 4-6, 6-1, 6-2. Ron downed Steve Wilson of Whittier 6-4, 6-3 in the semis.

In the C singles, top seeded Doug Verdieck of Redlands Junior High School captured the title by defeating Douglas Dey of Santa Monica 6-3, 6-3. In the semi-finals, Verdieck beat Mike Howard of Loyola 6-3, 6-0, and Dey defeated Steve Ganahl of Servite, 6-0, 9-7.

In the B doubles, Bohrnstedt and van Banks of Redlands defeated Kling and Wilson of Montebello 6-1, 8-6. In the semi-finals Bohrnstedt and van Banks had to fight off Santa Monica's Allen and Gadganda's bid, winning 6-4, 1-6, 6-4.

Kling and Wilson defeated Rapp and Westerdoll of Santa Ana, 6-1, 4-6, 6-1, in the other half.

Picon and Peterson of Montebello defeated Santilli and Stevenson of Mark Keppel 7-5, 6-2 in the C doubles. Picon and Peterson beat Wright and Parrott of Loyola 6-2, 6-4; Santilli and Stevenson edged Freed and Boden of Western 6-3, 6-1.

Among the ranked players entering the well-managed three-day tournament were Jim Hobson, Doug Verdieck, Doug Dey, and Ron Wilens. A record number of entries participated in this year's tournament. The weather was pleasant throughout the whole tournament. Our thanks go to tournament manager Neal Machander, assistant managers Larry West and Fred Milais, and the SASHS tennis team who helped handle much of the miscellaneous work of the tournament. The rule requiring white clothing helped make this year's events more successful. According to Mr. Machander, the players were more enthusiastic, well-behaved, and sportsman-like than last year (which was itself outstanding). These participants were a credit to interscholastic athletics in Southern California.

An excessive number of defaults was the only problem of significance occurring during the tournament. This problem was found to drastically alter the draw and could conceivably have changed the final team results. A special committee will be formed next fall whose purpose will be to study the tennis program in the Southern Section and prepare recommended changes that will improve our tournaments and play-off competition.

Living up to their top seeding, the Long Beach Poly varsity baseball team captured the CIF, Southern Section "AAA" baseball championship by blanking Western HS of Anaheim, 4-0, in a well played game at La Palma Park in Anaheim, on Tuesday, May 28, 1963.

Continuing to receive outstanding pitching, the Jackrabbits dominated the contest as Terry Roe, usually a reliever, allowed only three hits as he went the distance to record the victory. Andy Messersmith, highly-touted Western hurler, lost only his second game in 19 league and play-off starts and was knocked out of the box for the first time. It appeared that young Messersmith, who started all of the play-off games and most of the league contests, was tired and had been given too many starts during the long season.

# MATER DEI HS EXPERIMENTS WITH "SPEED-UP BASEBALL RULES"

In an effort to shorten the time necessary to complete a high school baseball game and to make it more interesting and attractive for the spectators Mater Dei and St. Anthony High Schools conducted an experimental game under new "Speed-up-game procedures" on Monday, March 11, 1963.

Both coaches, Bob Woods of Mater Dei and Tom Carroll of St. Anthony's, were pleased that the rules took nothing away from the game but did speed it up considerably. The entire contest only took one hour and thirty-five minutes in comparison with an average of over two hours for normal games.

The rules used in conducting this experimental contest were as follows:

1. There shall be no warm-up pitches between innings. If the pitcher wants to toss a few before going out each inning, he must do this on the sideline while his team is at bat.

2. Infielders shall not take any warm-up tosses between innings, and shall not toss the ball around the infield after every out.

3. Both offensive and defensive teams must run on and off the field when switching positions between innings. Failure to do so by the offensive team can be penalized by a strike being called on the first batter. Failure to run by the defensive team can result in a ball being called on the first batter.

4. A courtesy runner may be allowed for the

pitcher any time after he has reached base safely—giving him a chance to warm up on the sidelines if he so desires.

5. A courtesy runner will be allowed for the catcher after two out, to give him time to get his gear adjusted without delaying the game.

6. Intentional passes may be given without pitching to the batter—the umpire awarding first base at the request of the pitcher or coach.

7. A new pitcher entering the game may take only five warm-ups from the mound.

# TEAM GOLF CHAMPIONSHIP TO MILLIKAN HS

An outstanding group of prep golfers from Millikan HS of Long Beach scored an aggregate total of 368 strokes, to capture of CIF, SS Team Golf Championship, which was held at the Candlewood Country Club course on Monday, May 27, 1963. The five-man team representing Millikan HS consisted of Dick Mortenson (69), Hank Rams (72), Earl Svenningsen (73), Kemp Richardson (75) and Larry Benson (79).

Defending champion, California HS, took runner-up honors with a 373 total. San Marino HS finished third, with La Serna a stroke back in fourth place.

# OFFICIAL RULES FOR SPORTS

The CIF, Southern Section, now conducts interscholastic athletics in eleven different sports. With many different organizations responsible for the rules in each sport, much confusion is generated as to the rules followed by Southern Section teams in the various sports.

In an attempt to clarify this situation, we are going to list the official rules governing each sport conducted by the CIF, Southern Section. The only exception will be where such rules conflict with rules now or hereafter adopted by the CIF, Southern Section, or which may be modified by our Executive Committee. In cases of such conflict, the rules of the CIF, Southern Section, and the Executive Committee shall apply.

**BASEBALL**—All baseball games in the CIF, Southern Section, will be played under the official Baseball Rules of the Professional Leagues, as published by the Commissioner of Baseball, Mr. Ford C. Frick.

**BASKETBALL**—Rules of the National Basketball Committee of the United States and Canada shall govern this sport.

**CROSS COUNTRY** — National Federation Cross Country Rules will govern, except where they conflict with CIF, Southern Section, rules in the Blue Book.

**FOOTBALL**—The official rules of the National Federation of State High School Athletic Associations.

**GOLF**—The rules of the United States Golf Association.

**SWIMMING**—The N.C.A.A. Swimming and Diving Rules for interscholastic competition.

**TENNIS** — The rules of the United States Lawn Tennis Association.

**TRACK**—The National Federation Track and Field Rules for interscholastic competition.

**WATER POLO**—N.C.A.A. Water Polo Rules shall govern all water polo games of the CIF, Southern Section.

**WRESTLING**—The wrestling rules of the N.C.A.A., with modifications certified by the National Federation of High School Athletic Associations, shall constitute the official rules.



## SMALL SCHOOL TENNIS TITLE TO SAN MARINO HS

Defending champion, San Marino, easily defeated Laguna Beach  $26\frac{1}{2}$  to  $1\frac{1}{2}$  to win the CIF, SS Small School Tennis Championship in a match played on the winner's courts on Tuesday, May 28, 1963. The only point scored by the Laguna Beach squad occurred in the first match of the afternoon when Laguna's first doubles took one set from San Marino's second doubles team.

San Marino's first three singles players—Lewis, Lahmer and Giacchino, were outstanding during the play-offs. In the three play-off matches engaged in by San Marino, this trio scored  $34\frac{1}{2}$  points out of a possible 36 points. With such a nucleus, it is easy to understand why the Titans breezed to the championship.

Pat Wilson took over as coach of the San Marino team this year and led his boys to their eighth consecutive Rio Hondo League title. ## SANTA MONICA SUCCESSFULLY DEFENDS TEAM TENNIS TITLE

Santa Monica captured its second straight CIF, SS large school tennis crown by defeating Redlands,  $22\frac{1}{2}$  -  $5\frac{1}{2}$ , in the championship match played on the courts of the Los Angeles Tennis Club on Monday, May 27, 1963.

The stars of the Samohi team were Ed Grubb and Ron Willens, who went through the play-offs undefeated in singles, and the doubles team of Bill Grimm and Beau Miller, who also were undefeated in first doubles.

Coach Glenn Bassett's well-balanced aggregation swept through the play-offs with a loss of only 11 points. They blanked Santa Barbara, 28-0, took the measure of Palos Verdes,  $25\frac{1}{2}$  -  $2\frac{1}{2}$ , and then overwhelmed Pasadena 25-3 to earn the right a participate in the finals.

Redlands defeated Covina and Arroyo in the first two rounds and then scored a convincing victory over Sunny Hills,  $18\frac{1}{2}$  -  $9\frac{1}{2}$ , to qualify for the championship matches.

Each singles participant plays one set with each of his four opponents, and each doubles team plays two sets with each of two opponent teams. Each set won in singles scores one point and each doubles set won scores  $1\frac{1}{2}$  points. In the event of a tie in scoring, the total number of games won by each school in the dual match would determine the winner.
