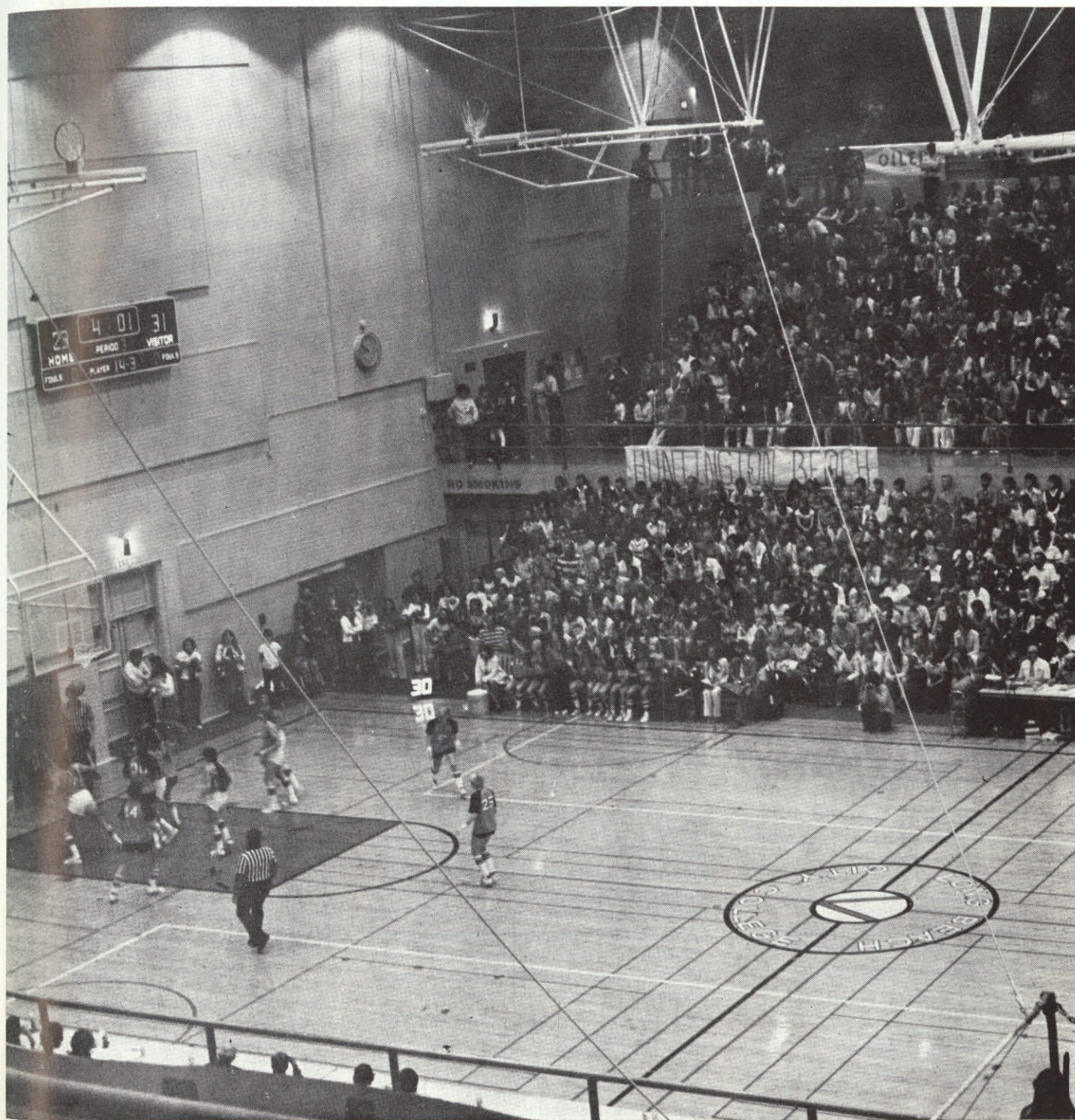

7. To the coach who develops players only, or to the coach who develops men as well as players?

8. To the irresponsible element that "razzes" the official, or to the official who executes the rules and bears the responsibility?

## MINUTES OF THE CIF-SS EXECUTIVE COMMITTEE MEETING MARCH 30, 1978

A special meeting of the CIF-SS Executive Committee was called to order by Chairman Dr. Lou Joseph at 3:30 p.m., Thursday, April 30, 1978 at the CIF-SS Office.

1. Foothill High School Appeal: Mr. Richard Akin and his son John appeared before the CIF-SS Executive Committee seeking to appeal the decision of the CIF-SS Eligibility Committee. Following discussion, it was moved and seconded to sustain the decision of the Eligibility Committee regarding this matter, denying the appeal.

2. Jarvis Amendment: Following discussion, the members of the Executive Committee requested the Commissioner to survey the section on this matter for a possible statement concerning the potential ramifications of the Jarvis Initiative on athletic programs in the Southern Section.

3. Garden Grove School District Request: It was moved and seconded to

deny the request of the Garden Grove School District regarding physical exams.

4. Omega and Christian Leagues Request: It was moved and seconded to approve the restructuring of the Omega and Christian Leagues for 1978-79 school year.

5. Tournament Request: It was moved and seconded to deny a request which would allow boys' basketball tournaments to begin prior to December 1.

6. Ivy League Soccer request: It was moved and seconded to deny the request of North High School (Riv.) to compete against a soccer team from Mexico during Cinco de Mayo celebration.

## MINUTES OF THE CIF-SS EXECUTIVE COMMITTEE MEETING APRIL 27, 1978

The Executive Committee Meeting of the Southern Section of the California Interscholastic Federation was called to order by Chairman Dr. Lou Joseph at 10:30 a.m. Thursday, April 27, 1978 in the Board Room of Anaheim Stadium. All members were present with the exceptions of Dr. Lowell Jackson, Tony Balsamo and Dr. Richard Cordano.

1. **CLARE VAN HOOREBEKE REMEMBRANCE:** The Executive Committee, in remembrance of former member Clare Van Hoorebeke, offered a few moments of silence.

2. **APPROVAL OF MINUTES:** It was moved, seconded and passed to approve the minutes of the Executive Committee Meeting of March 30, 1978 as distributed.

3. **BOYS' ATHLETIC DIRECTOR UPDATE:** Mr. Clyde Francisco, representative to the Committee, highlighted areas of concern in Boys' athletics, noting member schools not utilizing contracts as provided for by the CIF-SS Office; possible suggested areas of growth with area assignment secretaries; and questions of relegating proposals in one or two areas.

4. **STATE FEDERATED COUNCIL:** The following items were discussed with appropriate action taken relative to items on the State Federated Council agenda:

(a) It was moved, seconded and passed to support a recommendation to amend Rule 215A (1) and 215B (1) by changing the words "student's residence" to "student's residential eligibility."

(b) It was moved, seconded and passed to send our representatives uninstructed with reference to a proposal that each CIF Section place a monetary sum in a trust fund to be administered by the State CIF for the purpose of defraying legal costs in the defense of CIF rules.

(c) It was moved, seconded and passed to support the deletion of Rule 1306 from the By-Laws.

(d) It was moved, seconded and passed to support an amendment to Rule 900 to read as follows:

A student may participate in All-Star competition, other than football and basketball, between the conclusion of the CIF Section's season of sport and September 1. A student shall not participate in All-Star competition or on similar teams in contests or exhibitions in any CIF approved sport between September 2 and the conclusion of the CIF Section's season of sport. Upon petition to the State CIF Federated Council, a limited number of high schools may form basketball

teams for international cultural exchange competition between June 15 and September 1.

(e) It was moved, seconded and passed to support the two wrestling proposals dealing with the "Two Up and One Down Rule" and restructuring of the weigh-in date.

(f) It was moved, seconded and passed to deny support to the proposal that the State Track Meet be conducted in the Bay Area every fourth year.

(g) It was moved, seconded and passed to deny support for the CIF-SS partaking in a proposed Girls' Volleyball tournament following the CIF-SS Championships.

5. **WAIVER REQUEST:** It was moved, seconded and passed to deny the request of Pioneer High School to participate in a Boys' varsity basketball tournament prior to the official December 1, 1978 starting date.

6. **JARVIS AMENDMENT:** It was moved, seconded and passed to recommend a proposed draft to CIF-SS Council relative to factual information being disseminated with reference to the Jarvis Amendment.

7. **HI-LO LEAGUE REQUEST:** It was moved, seconded and passed to approve the annual request of the Hi-Lo League to commence football practice one week early to assist in its availability of scheduling with Nevada schools in Eight-Man football.

8. **SAN LUIS OBISPO REQUEST:** It was moved, seconded and passed to approve the request of San Luis Obispo High School's sophomore Boys' Basketball team conducting its games at an alternate site for the 1978-79 season while a new gymnasium is being constructed.

9. **MULTI-CAMPUS REQUEST:** It was moved, seconded and passed to recommend to the State Federated Council support for the multi-campus merger between Corona High School and Raney Junior High School, effective the 1978-79 school year.

10. **WATER POLO RECOMMENDATION:** It was moved, seconded and passed to recommend an amendment to the water polo section of the CIF-SS Blue Book, relative to the number of contests and tournament entry, effective the 1979-80 season. The change would read: "A water polo team would be permitted to play in no more than sixteen (16) contests during the season, including tournaments but excluding CIF-SS playoffs. Games scheduled with the faculty and occurring during the water polo season

would not be charged against the allowable number of contests, but games with alumni would so be charged. Additionally, a team may be entered in no more than two tournaments as part of the allowable 16 contests, with each tournament entered the team being charged for the minimum number of games guaranteed each team in the tournament.

11. **GIRLS' RE-LEAGUING APPEAL:** Sister Marie of Marymount High School, Fr. Barry of Mary Star High School and Fr. Hill representing the Catholic Athletic Association appeared before the Committee relative to appeals on the Girls' releguing proposal for 1978-79. Following discussion it was moved, seconded and passed to deny the request of Mary Star for movement to the Sunshine League. Additionally, it was moved, seconded and passed to move St. Joseph of Lakewood from the Sunrise to the Angelus League and to move Regina Caelie High School from the Sunshine to the Sunrise League.

12. **GIRLS' SCHOOL REPRESENTATION:** Sister Marie of Marymount High School appeared before the Committee relative to representation of all-Girls' private schools on the Council. Following discussion, it was moved, seconded and passed to adopt as procedure that any league comprised of five or more all-Girls' schools would be granted Council representation. This would affect the Horizon and Sunshine Leagues and will be presented to the full Council at its September meeting for approval.

13. **PROFESSIONAL TRY-OUT VIOLATION:** Mr. George Bloch, principal at Garey High School and students Robert Navarette and Diocese Macias appeared before the Committee relative to an inquiry of their status due to a professional try-out infraction. Following discussion, it was moved, seconded and passed that the two said students be placed on probation through the 1978-79 soccer season with no other penalty being imposed due to their inadvertent participation in a professional soccer try-out.

14. **REQUEST TO JOIN SAN DIEGO SECTION:** Mr. Miyoshi Ikeda, principal at Calipatria High School; Mr. George Beaman, principal at Holtville High School; and Mr. Donald Hopper, superintendent of the Imperial Unified School District appeared before the Committee relative to a request of Calipatria, Holtville and Imperial High Schools securing a release from the Southern Section in order to seek membership in the San Diego Section. Following discussion, it was

moved, seconded and passed to grant said release effective the 1980-81 school year with the provision the schools meet their commitments in all Boys and Girls sports with the Chaparral League until that time.

15. **BOYS' GYMNASTICS PLACEMENT:** In an effort to assist with the cross-leaguage structure still conducted in the sport of Boys' gymnastics, discussion was held relative to the placement of Antelope Valley High School for the 1978-79 school year. Following discussion it was moved, seconded and passed that Antelope Valley High School be placed in the Mission Valleys-Pacific League effective the 1978-79 school year.

16. **FOOTBALL EQUIPMENT CONCERN:** Commissioner Byrnes and Administrative Assistant Ray Plutko brought before the Executive Committee information relative to spring football practice and the use of equipment. Background was provided with regards to safety and liability factors and the use of equipment as a possible alternative. Following discussion it was moved, seconded and passed that the Commissioner apprise the Council of the concerns and the matter be taken under advisement by both the Football Advisory Committee and the Athletic Injuries Committee for recommendations.

17. **MEMBERSHIP REQUEST:** It was moved, seconded and passed to grant full membership effective the 1978-79 school year to Pomona Catholic High School (Pomona), St. Michael's High School (Los Angeles), and Calvary Christian High School (Barstow).

18. **TREASURER'S REPORT:** Dr. Hanford Rants, treasurer, reviewed with the Committee the latest input on the 1978-79 budget which will be presented to the full Council at its May 4, 1978 meeting. Dr. Rants also reviewed with the Committee the current status of the 1977-78 budget, noting a successful Boys' basketball format with reference to income for member schools and the Southern Section. Additionally, it was moved, seconded and passed to approve the Commissioner's re-organization plans for the CIF-SS Office.

There being no further business to come before the Executive Committee, the meeting was adjourned at 5:40 p.m.

## MINUTES OF THE CIF-SS COUNCIL MEETING MAY 4, 1978

The May Council meeting of the Southern Section of the California Interscholastic Federation was called to order by Chairman, Dr. Lou Joseph at 9:28 a.m., Thursday, May 4, 1978 at the Saddleback Inn, Norwalk. All leagues were represented with the exception of the Westside League.

**1. CLARE VAN HOOREBEKE REMEMBRANCE:** The Council, in remembrance of former Executive Committee member Clare Van Hoorebeke, offered a few moments of silence.

**2. APPROVAL OF MINUTES:** It was moved, seconded and passed to approve the minutes of the Council meeting of March 16, 1978 as published in the April issue of the Monthly Bulletin; the Executive Committee minutes of March 30, 1978 as distributed to the Council; and the Executive Committee minutes of April 27, 1978 as distributed to the Council.

**3. FOOTHILL LEAGUE RECOMMENDATION:** Mr. George Novinger, representative from the Foothill League, presented background information relative to a recommendation that would call for the Boys' and Girls' gymnastics and the Boys' baseball seasons to start on February 1 as opposed to the present calendar. This was an informational item and will be voted upon at the September meeting of the CIF-SS Council.

**4. FINES COMMITTEE REPORT:** Mr. Gene Hartley, chairman of the Fines Research Committee, presented background information relative to his committee's work. Following discussion it was moved, seconded and passed to table further research and to seek a vote at the September meeting of the CIF-SS Council as to whether the Committee should continue on an active basis for future recommendations.

**5. DE ANZA LEAGUE WRESTLING PROPOSALS:** Dr. Russ Reynolds, representative from the De Anza League, presented background information relative to a proposal that would increase the number of wrestling points from the present (16) in the Southern Section to the current eighteen (18) as permitted by the State. This was an informational item and will be voted upon at the September meeting of the CIF-SS Council.

**6. FOOTBALL EQUIPMENT PROBLEM:** Commissioner Thomas E. Byrnes reviewed with the Council the background leading to the development of spring practice in football, its growth through the years and present

concern relative to areas of liability. The question as it relates to the entire spring practice with reference to injuries, equipment, etc. was referred to the Athletic Injuries Committee and the Football Advisory Committee for further input and possible recommendation.

**7. JARVIS AMENDMENT QUESTION:** It was moved, seconded and passed that the CIF-SS Council, based upon a survey of its member school districts, release information, by way of the Media, with reference to the upcoming Jarvis Initiative:

"The Council of the California Interscholastic Federation, Southern Section, on March 16, 1978, directed the Commissioner of Athletics to survey the section to determine the probable impact of the passage of Proposition 13 on high school athletics as now constituted in Southern California. The findings reveal that in determining your voting decision on the Jarvis-Gann Initiative, the Council of the CIF Southern Section urges consideration of the probability that Boys' and Girls' interscholastic athletics, as we know them, including the many positive values for our young people, will be drastically curtailed, if not eliminated, as a school-sponsored program if Proposition 13 passes."

**8. MODIFICATION OF PHYSICAL EDUCATION REQUIREMENTS:** Mr. Dave Andrews, Orange League representative, presented background information relative to a proposal calling for a change in Article X, Section 3 of the Blue Book with reference to the number of physical education classes accepted for scholastic credits. Following discussion a motion to amend the present ruling was defeated.

**9. MODIFICATION OF SCHOLASTIC UNITS:** Mr. Dave Andrews, Orange League representative, presented background information relative to a proposal calling for an amendment to Article X, Section 2 and 3 of the Blue Book with reference to the twelve (12) quarter or twenty (20) semester units of work. Following discussion, a proposal to decrease the number of units died for lack of a second.

**10. EXECUTIVE COMMITTEE ELECTION:** Mr. Gene Snyder, chairman of the Nominating Committee, presented the ballot for elections to the Executive Committee. Results of the balloting have Mr. Gene Knott (vice

## MEDICAL COMMENT

### PROVEN PROGRAM TO REDUCE KNEE INJURIES

The number of knee injuries to high school football players has been shown during an eight year study to be significantly reduced by a program of total body conditioning before the season.

Bernard R. Cahill, Medical Director of the Great Plains Sports Medicine Foundation in Peoria, Illinois, reported this finding to the National Federation Football Rules Committee during its 1978 meeting in Los Angeles.

Early season injuries, those occurring between the start of practice through the third game, showed the most startling reduction. Those who had participated in the pre-season conditioning program suffered 68% fewer knee injuries during the early season than those athletes who had not participated. There was no significant difference in the frequency of knee injuries after the third game.

Linemen appeared to benefit most from the pre-season conditioning program, having a 61% reduction in knee injuries.

The athletes involved in this study were varsity football players in the Mid-State Nine Conference near Peoria, Illinois. During the first four years, they had no pre-season conditioning program. During the last four years, many participated in the pre-season program made available on a volunteer basis.

There were five checks on the accuracy of the injuries reported. The coaches, emergency rooms in the three area hospitals, and the members of the Peoria Medical Society, reported injuries of any significance directly to Dr. Cahill who examined and treated all but eight of the 135 knee injuries reported during the eight-year survey. High school insurance claims and post-season surveys of football teams provided further verification.

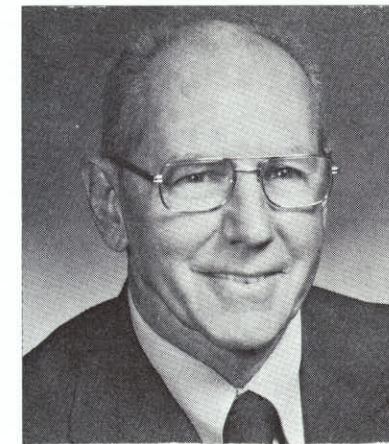

GARDEN GROVE BADMINTON PROPOSAL:** Mr. Roger Braasch, representative from the Garden Grove League, presented background information relative to badminton becoming a co-ed sport on an optional basis. Following discussion, the representative was directed to provide further input at the September meeting of the CIF-SS Council.

**13. NATIONAL CHAMPIONSHIPS:** The Commissioner provided background information relative to the question of National championships in selected sports, which will be voted upon at the National Federation's meeting in July. Following discussion, it was moved, seconded and passed to instruct our State representatives to cast a no vote on said proposal.

**14. OUTSIDE COMPETITION RULE:** The Commissioner provided background information relative to the deletion of Article XI of the State Federated Constitution, with reference to the outside competition rule. Following discussion it was moved, seconded and passed to instruct our State representative to cast a no vote on said proposal.

**15. PLAYOFF GROUPINGS COMMITTEE RECOMMENDATION:** It was moved, seconded and passed to accept the 1978-79 recommendation of the Playoff Groupings Committee (amendments from the Frontier League relative to football and the Rio Hondo League relative to swimming were defeated).

## IN MEMORIAM A COACHING LEGEND PASSES

The CIF-Southern Section is saddened to report the death of one of interscholastic football's most suc-

cessful coaches — Claire Van Hoorebeke.

Van Hoorebeke, a former CIF-SS Executive Committee member, succumbed at Anaheim High, the scene of his greatest triumphs as a coach, on Thursday, April 6, 1978. He was 66 years old.

In 23 years as Anaheim's varsity football coach, Van Hoorebeke guided his teams to an overall 190-50-10 record, earning 19 league titles and two CIF-SS championships.

Under his tutelage, Anaheim played before the two largest crowds in Southern Section history — the 13-13 title game with Downey in 1956 with 41,383 fans at the Los Angeles Memorial Coliseum, and the 1966 CIF semi-final game with Mater Dei, when 33,374 were in attendance at Anaheim Stadium.

Funeral services attended by his many many friends were held at the Melodyland Chapel in Anaheim with Superintendent R. Kenton Wines delivering an inspiring eulogy. Interment followed at Anaheim Cemetery. Van leaves his wife Viola, a daughter Christine Ann Rothmeier and one grandchild.

**16. PRELIMINARY BUDGET:** Dr. Hanford Rants, treasurer, presented background information relative to the preliminary budget for the 1978-79 school year. Following discussion it was moved, seconded and passed to accept the preliminary budget as presented.

**17. PASSING OF THE GAVEL:** Dr. Lou Joseph, chairman for the past two years, relinquished his duties to President-Elect, Mr. Tony Balsamo for the 1978-80 term of the CIF-SS Council. Special recognition was also made to outgoing members Dr. Richard Cordano as past president and Ferren Christensen as representative to the State Federated Council.

There being no further business to come before the Council the meeting was adjourned at 11:52 a.m.

## KNEE INJURIES

"Pre-season conditioning creates an environment that subtly affects athletes and coaches to alter their reactions and motivations," according to Dr. Cahill. "The athlete becomes aware of potential benefits of pre-season conditioning and tends to create his own conditioning program, if he is not participating in the formal program. He is motivated by a desire to make the team and anxiety over injury. The athlete feels he will be forced to compete against those who have had the advantage of participation in the formal pre-conditioning program. The pre-season conditioning environment has altered coaching attitudes so that they tend to withhold athletes who have not participated in the formal program for potential injury producing practices earlier in the season.

"Thus the effect of the athlete's training independently and the coach's reluctance to allow athletes who have not participated in the formal pre-season conditioning program to enter into contact drills early in the season, combine to make the environment of the conditioned athlete distinct from the non-conditioned group."

## HUNTINGTON BEACH, RIGHETTI AND BISHOP DIEGO REPEAT AS GIRLS' BASKETBALL CHAMPIONS

Huntington Beach playing one of its best games of the season, upset top seeded Buena 50-41, to win the CIF-Southern Section girls' 4A basketball title before a record evening session crowd of 3,530 at Long Beach City College.

It was the second consecutive 4A crown for Huntington Beach, who finished the season with a 25-2 record. Previously unbeaten Buena saw its 24 game winning streak end.

Buena, which breezed through the season and playoffs, biggest victory was by 21 points. Its closest game all season was a three point win over Bishop Diego.

Huntington Beach took a lead (12-10) it never relinquished and built it to 23-17 at halftime.

It was the shooting of Cheryl Cady and Debra Burrows which kept Buena out of reach in the second. Cady scored 14 points, eight in the third period, while Burrows had a total of 15. Doyle scored 14 and pulled down 13 rebounds.

The 3A final was a rematch of last year when Righetti beat Upland 52-49. This one was close too until 4:30 left in the game.

Leading, 43-42, Righetti reeled off 10 straight points to put the game away. Kendee Eulart, last year's 3A Player of the Year, scored on a layup following a steal and sank two free throws moments later giving Righetti its biggest lead of the game, 53-42 with a minute to play. From then on it was all over with Righetti posting a 55-46 victory.

Righetti finished the season with a

25-3 record; Upland 27-3.

In the 2A finale topseeded Alta Loma defeated Santa Clara 51-36 to capture the title.

Alta Loma (24-2) was led by Nan Fowler and Janet Davis. Fowler, a 5-3 junior guard averaging 19 points a game, scored 27 points hitting 11 of 20 field goals and 5 of 6 free throws. While teammate Davis, a 6-4 sophomore center, hit 7 of 8 from the field and finished with 15 points and 16 rebounds.

Bishop Diego won its second straight CIF-SS title 36-33. The Cardinals, who had won the 2A title last year, scored the game's first 10 points and held an 18-9 halftime lead. Valley Christian's Marlene Kline, who led all scorers with 12 points, hit a 15-foot jumper to cut the Cardinals' lead to 26-23 at the beginning of the final quarter. Bishop Diego then scored 10 consecutive points to put away the game.

Bishop Diego was led by 6 foot center Diane Sebastian, the 1977 2A Player of the Year, in both basketball and volleyball. She scored 10 points and grabbed 13 rebounds.

Total attendance for the two sessions was 5310 with 1730 at the afternoon finals.

Winning coaches of this year's championship teams were Joanne Kellogg of Huntington Beach, Righetti's Judy McMullen, Mary Pollock of Alta Loma, and Linda Dawson of Bishop Diego.

The 1978 La Jolla team was rated No. 1 in the nation on the prep level among knowledgeable tennis buffs.

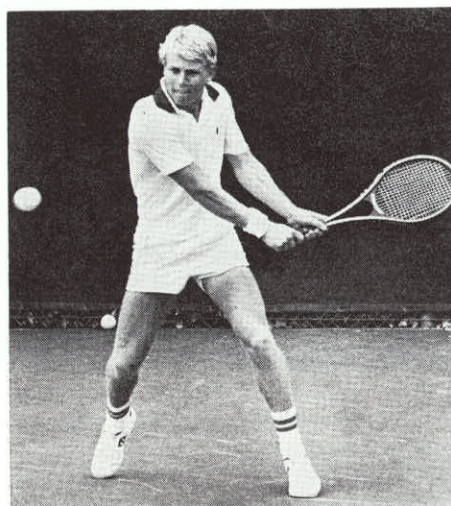

# CORNER

## SUMMER COMPETITION RULES REVIEWED

It's just about time for the close to another year and it would be appropriate for athletic directors to review with their staffs the guidelines covering competition during the summer months.

From the close of school in June until the opening of school in the fall semester, there shall be no restriction on high school coaches working with high school students or entering them in summer competition. A member school, however, may not sponsor a team's entry, provide uniforms, transportation or equipment, or otherwise be responsible for students in summer competition.

Further, schools MAY NOT as part of a summer physical education class, engage in competition (scrimmages, etc.) with another school or excuse students enrolled in said P.E. classes from attending regular classes so that time may be "made up" while competing in a summer league. In summary, any competition during the summer months is to be divorced from P.E. classes in that instructors are being paid for their teaching services and are not to be compensated for coaching during this time span.

Coaches having teams entered in summer competition should be reminded that their teams may NOT start competition prior to the close of their school year in June — even though the league in which they are entered may have an earlier starting date.

### AD'S AND PRINCIPALS NOTE ...

Please be advised, in regards to the recently adopted State Rule regarding unattached competition during the season in individual sports (November Bulletin), the State CIF has ruled that under present rules, an outside organization may provide financial assistance to an athlete without jeopardizing his or her eligibility, as long as the athlete competes as an unattached competitor.

## MAJOR FIELD HOCKEY RULE CHANGES FOR 1978-79 SEASON

Two significant rule changes in high school field hockey were made February 21-22, 1978, during the National Federation Field Hockey Rules Committee meeting held at the National Federation headquarters outside Elgin, Illinois.

Unlimited substitution will be in effect for the first time during the 1978-79 field hockey season. No restrictions will be placed on the number of times a player may leave or enter a game.

Determining a winner of a tie game by using penetration time has been eliminated for the next season. The tie-breaking procedures to be employed for high school field hockey are a ten minute over-time period and, if a tie still exists at the end of the over-time period, alternating penalty strokes.

Other rule revisions include awarding a penalty stroke without prior warning for a single flagrant offense and prohibiting coaches and team personnel from meeting with players during an injury time-out.

The field hockey rules committee members who made these changes are appointed by the Executive Committee of the National Federation. They meet annually to revise and update the interscholastic field hockey rules which govern over 60,000 high school participants.

### MAJOR RULE REVISIONS

**1-3-3** Eliminates the flexible marker at the center line.

**3-3-2** Specifies either team may substitute prior to a defensive hit, free-hit or push-in.

**3-3-4** Specifies a player may re-enter the game any number of times.

**4-3 PENALTIES #1** Indicates a free-hit is awarded for a violation of a push-in or flick-in.

**5-1-3** By state association adoption, tie games may be broken during the regular season, using the tie-breaking method for tournament play.

**5-2-3, 4** Eliminates penetration time as a part of the tie-breaking procedures.

**5-2-5** Specifies tournament game sus-

pended because of weather shall be continued from the point of interruption.

**8-1-2-g** Specifies coaches and team personnel may not meet with players during an injury time-out.

**8-1-2-d PENALTIES** For a single flagrant offense, a penalty stroke shall be awarded without prior warning.

**8-2-2** Permits the officials to have the home management remove spectators which are interfering with the progress of game.

**9-1-3** Timer to follow the official up and down the field in the final thirty seconds.

**9-2-2** Visiting school shall be responsible to provide timer with clock.

**9-2-4** It is recommended that the timer sound an audible device (horn or pistol) at the end of each half.

## NATIONAL RECORD BOOK IN WORKS

The first ever official National Interscholastic Record Book will be published by the National Federation of State High School Associations this summer, with a first printing of 1,000,000 copies being planned.

More than 40,000 names of high school students will be listed. Contents will include team and individual records for both boys and girls, plus state high school association championship results and records, as well as stories and photographs highlighting the outstanding and unusual performances and performers in high school athletics.

Fourteen sports will be covered: Baseball, Basketball, Cross Country, Field Hockey, Football, Boys Gymnastics, Girls Gymnastics, Ice Hockey, Soccer, Softball, Swimming, Track and Field, Volleyball and Wrestling.

The record book will be made available to school athletic departments for sale as a fund raising item. However, the principal reason for publishing the book is to bring attention to the excitement and high quality for the interscholastic program.

## BASKETBALL COMMITTEE REFUSES DRASTIC RULE CHANGES

The first basketball rules committee of the National Federation of State High School Associations held its official meeting March 28-29, 1978 in St. Louis, Missouri.

The committee dropped its membership in the National Basketball Rules Committee of the United States and Canada to formulate and publish basketball playing rules more suitable for high school competition and more reflective of the interests of their coaches and officials.

Drastic rule changes given special attention during the first meeting included: implementing a 30-second clock, requiring the hand to be raised by an individual committing a foul, and outlawing the dunk. None of these changes were adopted.

The dunk rule now allows the player to dunk the ball only during the game at his or her own basket when the ball is alive and at no other time.

Rule changes of significance focus upon a tap (or tip). A tap will not be treated the same as a field goal if the tap is in flight and directed toward his or her basket. Another rule regarding a tap states there cannot be any continuous motion for such a tapped ball because by definition a ball tapped by a player toward his or her basket is not a tap until the ball is in flight from the player's hand(s).

Basketball is the second most popular sport, as over one million boys and girls compete in interscholastic basketball programs across the country. More schools carry basketball programs for both boys and girls than any other sport. Nearly 19,000 schools sponsor basketball programs for boys and 15,000 for girls.

The basketball rules committee is one of 13 National Federation rules committees governing 13 interscholastic sports.

### BASKETBALL RULES DIFFERENCES FOR THE 1978-79 SEASON

**1-7** Both the fan-shaped and rectangular backboards are legal.

**2-2** Hard and unyielding leather, even though covered with soft padding, shall always be declared illegal.

**2-8** The officials shall arrive on the floor at least 15 minutes prior to scheduled starting game time and their jurisdiction extends from their arrival there through the referee's approval of the final score.

**4-28** A tap (or tip) is now defined. When a tap (or tip) by a player is in flight toward his or her basket, it is treated exactly the same as a try for a goal in flight.

**5-5-NOTE-2** A period or periods may be shortened in an emergency or at any time by mutual agreement of the opposing coaches and referee. Playing time for non-varsity game quarters may be reduced by mutual agreement of opposing coaches.

**5-6** If time expires to end a period while the ball is in flight from a tap (or tip) by a player toward his or her basket, the period does not end until the tap (or tip) ends.

**5-11** Clarifies that the official shall grant a player's request for an excess time-out at the expense of a technical foul when the ball is dead or in control of a player of his or her team and when no change of status of the ball is about to occur other than at the expiration of regulation play or after of any overtime period.

**6-7 EXCEPTIONS 1 and 2, and 9-11** These Exceptions and Rule 9-11 now provide identical coverage for a try for field goal in flight and a trapped ball in flight from a player toward his or her team's basket. There cannot be any continuous motion for such a tapped ball because by definition a ball tapped by a player toward his or her basket is not a tap until the ball is in flight from the player's hand(s).

**8-7** After the last free throw following a false double foul (4-11c), the ball shall be put in play as if the penalty for the last foul of the false double foul were the only one administered.

**10-6(f)** A player shall not dunk nor stuff the ball during the time of the official's jurisdiction except during the game at his or her own basket when the ball is alive.

**10-7(h) and 5-9-EXCEPTION (d)** It is now a technical foul on a coach for using more than one minute to replace a disqualified player rather than a charged time-out to the team for the infraction as in the past. 5-9 Exception (d) has been deleted.

#### POINTS OF EMPHASIS:

1. Rule 10, Section 10 pertaining to bench decorum.

2. The five-second front court held ball rule.

3. Contact with a defensive player in a legal position by an airborne player who has, immediately, prior to contact, returned to the floor with or without the ball.

4. Legal and illegal action pertaining to a fumble prior to and immediately following a dribble.
