## STATE CIF SEEKS LEGISLATION TO INSURE MAINTENANCE OF LOCAL CONTROL

Over the past 67 years, the California Interscholastic Federation — and in particular, the CIF Southern Section — has provided the leadership and growth to be considered by many the leading association for the administration of interscholastic athletics in the nation.

It is interesting to note, that over these near-seven decades, the governing structure of the organization has remained constant. In fact, the structure of the organization rests with the concept of local control whereby local school boards, superintendents, principals, athletic directors and coaches are insured the right of determining policies relative to the realm of interscholastic athletics.

However, a question is currently being raised throughout the State of California as to whether the future of interscholastic athletics will continue to be governed in the same manner.

This question is being raised by way of the formation and tenor of the Riles Commission, one which was established in late June and charged with making recommendations to the State Superintendent for the possible overhaul — even to the extent of assuming control — of the interscholastic athletic programs for both public and private schools throughout the State CIF organization.

Representatives from the CIF organization throughout the State, including the Southern Section Office, have been in attendance at the various Commission meetings throughout the summer and early fall, and have collectively become concerned over the apparent direction of the Commission, that of removing local control.

Being that the current structure of the CIF, which identifies local school districts with a task of setting policy of the interscholastic athletic program, the State Federated Council at its meeting of October 17-18, 1980 took the following action:

"That the California Interscholastic Federation seek legislation which would permit local school districts to join voluntary associations which would control and direct interscholastic athletics."

The purpose expressed in seeking this legislation is to clearly place the control and direction of interscholastic athletics in the hands of local school districts. This has been the practice since 1914, but the Federated Council believes that specific legislation should be initiated in order to clearly define the matter for the future.

## Minutes Of The CIF-SS Council Meeting **SEPTEMBER 25, 1980**

The September Council meeting of the Southern Section of the California Interscholastic Federation was called to order by Chairman Dr. Hanford Rants at 9:15 a.m., Thursday, September 25, 1980, at the Saddleback Inn, Norwalk. All leagues were represented with the exception of the Academy League.

1. APPROVAL OF MINUTES - It was moved, seconded and passed to approve the minutes of the CIF-SS Council Meeting of May 1, 1980 as published in the June issue of the "Monthly Bulletin"; the CIF-SS Executive Committee minutes of June 21, 1980 as published in the September issue of the "Monthly Bulletin"; the CIF-SS Executive Committee minutes of September 18, 1980 as distributed to the Council.

2. PRESIDENT'S MESSAGE — Dr. Hanford Rants, new president of the CIF-SS welcomed members to the first CIF-SS Council meeting of the 1980-81 school year.

3. COMMISSIONER'S UPDATE -Mr. Ray Plutko, commissioner, apprised the Council of work done in the areas of support income, officials' accountability and re-orientation of schools and the public to the CIF-Southern Section.

4. TREASURER'S REPORT — It was moved, seconded and passed to accept the 1980-81 budget of the CIF-SS as presented by Mr. James Faul, treasurer.

5. NATIONAL FEDERATION UP-DATE - Mr. Tony Balsamo highlighted points of interest from the National Federation meeting held this summer including a review of the various State Athletic Association structures throughout the country; the National Coaches Association recommendation for National High School Championships; "activities" as well as athletics as a function of the National Federation; and "support income", an area in which California and the Southern Section appear to be leaders in this effort.

6. STATE FEDERATED COUN-CIL UPDATE — Mrs. Barbara Wilson, executive committee member; Dr. Maury Ross, superintendents' representative; and Commissioner Plutko apprised the CIF-SS Council of developments resulting from the State Department of Education's Commission to review the status of the California Interscholastic Federation.

7. LEGAL UPDATE — Mr. Andrew Patterson, CIF-SS attorney, presented background information regarding the involvement of the State Department of Education in athletics from a legal perspective. Mr. Patterson also reviewed aspects of Title 9 and the Office of Civil Rights Complaint as background for members of the CIF-SS Council.

8. STATE BASKETBALL TOUR-NAMENT REPORT - Mr. Ray Plutko, commissioner, reviewed material relative to a proposed State Basketball Tournament for boys and girls which will be discussed at the upcoming October meeting of the State Federated Council.

9. LIBERTY LEAGUE BASEBALL-SOFTBALL PROPOSAL — Mr. Mike Pilcher, Liberty League representative, outlined his league's proposal to change the scrimmage date of baseball-softball from Wednesday, February 25, to Saturday, February 21. This item will be voted upon at the January meeting of the CIF-SS Council.

10. PLACEMENT OF SCHOOLS-Mr. Robert Packer reviewed the guidelines set by the Committee on Placement of Schools within Leagues and recommended that (1) Placement of these teams be made if at all possible before May 1 of the year preceding competition within that league; (2) Placement first be attempted within the area in which the schools are placed for releaguing purposes; (3) A formula on mileage that would take an average of the distance traveled by all regular league members; any mileage over and above this average would be the responsibility of the entering school; (4) Schools that enter without proper lead time shall free lance for that calendar school year. It was moved, seconded and passed to adopt the prop-

11. SUNSET LEAGUE BAND PRO-POSAL - Mr. Thomas Jacobson, Sunset League representative, introduced a Sunset League proposal which would increase the number of pep band members during all CIF-SS playoffs from 12 members to 30 members. Following discussion, a motion for the proposal failed to carry the needed majority.

12. RELEAGUING COMMITTEE FINAL REPORT — Mr. Roger Braasch, releaguing committee chairman, introduced the Releaguing Committee's final report to the CIF-SS Council.

Following discussion, it was moved, seconded and passed to accept the proposals for the Citrus Belt, Coast, Foothill, Mt. San Antonio, Northern, Orange County, San Gabriel, Parochial and Private areas. Further, the Desert area failed to receive the necessary votes for passage and was directed to meet again and formulate a proposal to be presented to the Council at the January meeting for a vote.

13. SPECIAL PRESENTATION -Dr. Hanford Rants acknowledged the long and valued tenure of retiring Executive Committee member, Mr. Steve Miletich. Steve has been president of both the CIF-SS and the State CIF Federated Council. His work in the areas of officiating, releaguing, seasons of sport, and leadership in girls' athletics highlight his career with the Southern Section. Mr. Miletich was presented with a plaque and a CIF-SS life pass in appreciation of his

## **EVALUATE YOUR OFFICIALS**

Want to tell someone about a great official or a poor one? Well, here's your chance coach! Upgrading the officiating program in the Southern Section can be done through the use of a standardized Officials' Evaluation Form provided by your CIF-SS Office this year.

The evaluation form, when completed, is to be returned to your local Area Assignment Coordinator of Officials who will use it as a tool in the overall rating of the officials being assigned to work contests in the Southern Section. In addition, it will serve as a reference when lists of qualified officials for playoff contests are submitted to the CIF-SS Office. Another key aspect of the evaluation will be its use by the local officials' associations in keeping their instructional programs current with the needs of the athletic programs in the Section.

Each head coach is asked to meet with their respective staffs and stress the value of both positive and constructive marks and the importance of a prompt return to the Area Assignment Coordinator. ## SOCCER AND CROSS COUNTRY **GAIN IN CIF-SS SURVEY**

Growing steadily the past several years, soccer teams at CIF-SS high schools now number 269, a number significantly increased with the addition of girls' soccer for the first time this year.

Boys' teams are up to a record 219 participating schools while in this initial playoff year for the girls, 50 schools have joined ranks to compete in the sport.

According to a National Federation survey, soccer heads the list of gainers in boys participation. Soccer devotees will take heart that soccer moved from the tenth to the ninth most popular sport for boys in terms of sponsoring schools nationwide and into the tenth spot for popularity among female athletes in high schools.

Locally, soccer in the Southern Section ranks seventh in popularity for boys and tenth in popularity for girls in terms of sponsoring CIF-SS schools.

Girls' Cross Country On The Move-

In 1976, the Southern Section approved playoffs in the sport of girls' cross country and 80 Southern Section schools were off and running. Today, four short years later, cross country has become the fourth most popular sport in the CIF-SS listing 297 participating schools. This growth is in concert with national figures which show girls cross country participation up from 23,000 girls to 82,000, the fifth most popular sport for girls nationwide.

#### ARE ALL YOUR ATHLETES ELIGIBLE?


Nothing is more important in the interscholastic athletic program than the assurance that all competitors are eligible under the rules of the CIF. Principals, coaches and athletic directors should become familiar with the eligibility provisions in the Blue Book. If there is any question about an athlete's eligibility, it should be checked with the CIF-SS Office at once. School officials are urged to review Eligibility Rules under Section VII of the CIF Southern Section Blue Book. All CIF-SS eligibility rules apply in all games including practice, interscholastic, scrimmage, league, tournament and playoff games.

#### MINUTES OF THE CIF SOUTHERN SECTION EXECUTIVE COMMITTEE MEETING OF SEPTEMBER 18, 1980

The meeting of the Executive Committee of the California Interscholastic Federation Southern Section was called to order by Chairman Dr. Hanford Rants at 9 a.m. on Thursday, September 18, 1980 at Griswold's Inn in Fullerton. All members were present.

1. APPROVAL OF MINUTES — It was moved, seconded and passed to approve the minutes of the June 21, 1980 meeting of the CIF-Southern Section Executive Committee.

2. PRESIDENT'S MESSAGE — Dr. Hanford Rants, new president of the CIF-Southern Section, made a few brief opening remarks regarding plans for the upcoming school year.

3. COMMISSIONER'S UPDATE—Mr. Ray Plutko, commissioner, apprised the Executive Committee of work done in the areas of support income, officials' accountability and re-orientation of schools and the public to the CIF-Southern Section.

4. SUPERINTENDENT'S UPDATE-Dr. Maury Ross, representative to the Executive Committee, provided some background information regarding the State Department of Education.

5. BOYS'ATHLETIC DIRECTORS UPDATE — Mr. Clyde Francisco, representative to the Executive Committee, reported on the enthusiasm generated by the upcoming CIF-SS Athletic Administrators Symposium as well as some concerns with regards to the length of the spring sports season as it compares to the winter season.

6. GIRLS' ATHLETIC DIRECTORS UPDATE — Mrs. Barbara Wilson, representative to the Executive Committee, reported on plans for the Western States Athletic Directors Conference to be held in Las Vegas and on the high interest by Girls' Athletic Directors in the CIF-SS Athletic Administrators Symposium.

7. STATE FEDERATED COUN-CIL — The following items were presented relative to the upcoming agenda of the CIF State Federated Council meeting slated for October: (a) ACADEMY LAWSUIT: Tony Balsamo reported on discussions held between the State CIF and Womens Coaches Academy relative to a possible resolution of the case.

(b) STATE DEPARTMENT OF EDUCATION: Dr. Ross, Mr. Andrew Patterson, CIF-SS attorney, and Mrs. Wilson presented background information and brought committee members up to date with regards to the Riles Commission study of the California Interscholastic Federation.

(c) STATE SEASONS OF SPORT: Mr. Tony Balsamo reviewed a proposal to establish three basic sports seasons throughout the State: Fall - August through November; Winter - November through February; Spring - February through June.

Further, in order for any Section to participate in State level competition for any particular sport, a Section must comply with the CIF adopted "season of sport". Based upon acceptance of this proposal by the Sections, the Federated Council will adopt the following "season of sport" for State Championships: Fall-Volleyball (Girls); Winter - Basketball (Boys and Girls), Wrestling (Boys); Spring - Track (Boys and Girls), Golf (Boys and Girls).

Following discussion, it was moved, seconded and passed to adopt the State Season of Sport as outlined.

(d) CONSTITUTIONAL AMEND-MENT VOTING: Tony Balsamo reviewed a proposal which would allow the State CIF Constitution to be amended at any meeting by two-thirds of the votes cast provided the amendment was proposed at a previous meeting. Additionally, this constitution may be amended at any meeting by three-fourths of the votes cast. Following discussion, it was moved, seconded and passed to approve the proposed amendment.

8. ORANGE COUNTY FEASIBIL-ITY STUDY — Dr. Robert Packer reported to the Executive Committee regarding the on-going feasibility study for an Orange County CIF. 9. LEGAL UPDATE — Mr. Andrew Patterson, CIF-SS attorney, reviewed plans to consider changes in the CIF-SS Blue Book with regards to clarity as well as possibly highlighting the State CIF Rules in bold print.

10. TREASURER's REPORT — Mr. Jim Faul, treasurer, reviewed the Statement of Income and Expense for the fiscal year ending 6-30-80 with the Executive Committee.

11. CIF-SS SYMPOSIUM UPDATE

— Mr. Ray Plutko, commissioner, outlined plans for the upcoming Athletic Administrators Symposium and indicated a full house is expected to be in attendance.

12. KUIKEN RESEARCH REPORT — Dr. Robert Packer reviewed the suggestions given to the Southern Section by Kuiken Associates with regards to long range projects, support income, and the image of high school athletics on the general public.

13. NEW MEMBERSHIP — It was moved, seconded and passed to admit Camp Gonzales (Calabasas), New Jewish High (Los Angeles) and Mountainview Academy (Calabasas) to membership in the CIF-Southern Section. In addition, it was moved, seconded and passed to admit the Orange District Junior High Schools to membership with their proposed adjustment in the season of sports for 1980-81 with the modification that the CIF-Southern Section Season of Sport be followed in 1981-82.

It was moved, seconded and passed to admit Le Lycee to membership pending final verification from the Private Schools area representative Mr. Bruce Keuning of Valley Christian High School.

14. EXECUTIVE COMMITTEE VA-CANCY — It was moved, seconded and passed to fill the remaining term vacated by Mr. Joe Deal of South Hills in the Mt. San Antonio area with Mr. Pat Mauch of Los Altos

15. GANESHA HIGH REVIEW — Dr. Hanford Rants and Commissioner Plutko reviewed with the Committee the following relative to a basketball violation of a high school coach removing his team

# WHAT'S HAPPENIN' IN THE OTHER 49 STATES

(EDITOR'S NOTE: This is another in a series of monthly articles covering items of interest from throughout California and other State Associations in their administration of high school athletics.)

ITEM: N.F.L. Networks named in complaint.

COMMENT: The Colorado High School Activities Association has filed a complaint in the United States District Court requesting the courts to enforce the federal antitrust law which prohibits the telecasting of professional football games in conflict with scheduled high school and college games on Friday nights and Saturdays.

Commissioner Ray Ball noted, "I have difficulty understanding the N.F.L.'s reasons for wanting to jeopardize high school football, which is already struggling for survival against increasing costs for equipment, particularly helmets. Without high school football, there would be no college football, and ultimately, no professional football."

ITEM: Energy Crunch Suggestions.

COMMENT: School administrators in Michigan faced with the problem of taking steps to reduce energy usage have come up with these suggestions: Realign athletic conferences for traveling distance efficiency, schedule double, dual and triple meets at one site; create an "incentive" ticket price for students who ride the bus to athletic events in lieu of driving their cars; use cheerleaders, pep bands at home games only if space on bus is limited. ITEM: Go Metric.

COMMENT: A recent survey of state high school associations indicates the vast majority of states conducted their state final track meets at metric distances this spring. With 47 states responding, only four (4) indicated they have no plans at this time to conduct their state final meets at metric distances.

Eighty-five percent (85%) of those responding are running the 1600 meter and 3200 meter runs in lieu of the mile and two mile runs. Arizona, Connecticut, New Mexico, Oregon and Vermont are the only states reporting who are running the 1500 and 3000 meter runs.

Sixty percent (60%) of those responding will run their 1980 boys and girls state final cross country meet at metric distances. Eighty percent of the boys and 24% of the girls state final cross country competition is conducted over a three mile or 5000 meter race course. The most common distance (51%) reported for girls competition was 2.0 miles or 3000 meters. ITEM: "I've never made a Mistake".

COMMENT: This was heard from a veteran basketball official in one of the "other 49". I have heard it mentioned that all officials know they miss one once in a while. Not True!! I refereed basketball for thirty years and never made a mistake, and I can prove it. In any game I ever refereed, they kept a scorebook and a stat sheet. At the end of the game you could check the scorebook and if I called a foul there was a foul marked against that player. If I said that a player traveled, doubled dribbled, or stayed in the lane too long, the stat sheet showed that player had committed a turnover. For thirty years, the scorebook and stat sheet agreed with everything I ever called. So, there you have it. I refereed for thirty years and never made a mistake and I have proof in black and white."
