Minutes of Adjourned Meeting - Oct. 14, 1920.

The meeting was called to order by Mr. Oliver of Los Angeles High School.

The roll was called with the following results:-

The President declared a quorum present and the meeting open for business.

The minutes of October 9th were read and approved as read.

The Secretary was requested to write to the Leagues not answering to roll call and to request them to attend the meetings, also to make clear that the expense of delegate would be paid by the C.I.F.

The Secretary was requested to write to Long Beach, Whittier, and San Diego and to inform them that their games must be played according to the rules of the C.I.F. and eligibility lists, signed by the Principal, exchanged with the opposing schools.

The committee appointed to investigate the standing of Hall of Long Beach, alias Citrus Union reported as follows:

"The committee finds that according to the evidence in hand that Hall is not eligible to compete for Long Beach. If other evidence in the matter should come to the notice of the committee, the committee stands ready to have this recommendation reconsidered by the C.I.F., Southern Section.

The following committee was then appointed to investigate Hall of Long Beach, Hughes of Hollywood, Hill of Ontario and Green of Inglewood.

A letter was then read from R.W. Jesson, Secretary of the Southern California Football Association, requesting that in the City League games the referee received Ten Dollars, and the umpires and Head Lineman, Five Dollars each.

It was moved, seconded and carried that in any and all league games, the compensation for referee, umpire and head linesman shall not exceed 10, 7½ and 5 dollars respectively.

The amount to be paid to depend upon the importance of the game and the size of the attendance. The amount to be paid to be left to the school, and Mr. Moore the football manager.

It was moved, seconded and carried that when we adjourn, we adjourn to meet Thursday, October 14th at 4.00 P. M.

Manager of Basketball to be selected from Central League. Chair ruled that the George Jr. was a High School and that attendance there must be counted as High School attendance.

Mr. H. J. Moore was requested to notify officials that all games must be called ten minutes after sunset.

The committee on Hall of Citrus vs Long Beach reported that after due investigation, they had found that Mr. Hall of Glendora had not changed his place of residence and that his son had not been compelled to change schools, therefore they recommended that James Hall should not be allowed to play for Long Beach.

The report was accepted.

The committee consisting of the President, Secretary and Mr. Fisher was appointed to meet Monday evening and decide the place of play for any semi-final if the two schools could not agree by Monday noon, this to refer to all semi-finals except the City League vs Long Beach which was located at Long Beach.

Mr. Greer then stated that there was trouble in the Bay League, Venice and Santa Monica having broken Athletic relations and that the Bay League wished to know if the C.I.F. would be willing for Santa Monica to be a free-lance at the end of the football season.

It was moved, seconded and carried that this request would be granted if the Bay League made a formal request for the same and in that event, Long Beach, Whittier and Santa Monica be formed into a triangle league for all other sports.

There being no further business the council adjourned.
