

MINUTES

of
1920 - 1921

Council Interscholastic Federation
Southern Section

October 9th 1920

The meeting was called to order by Mr. Oliver of Los Angeles High School.

Mr. Green of Inglewood Union High School was appointed Secretary pro-tem.

The roll was called as follows:

Bay League - George M. Green of Inglewood
Central League - Mr. C. B. Moore of Franklin.
Citrus League - W. A. Hall of Chaffee.
City League - E. W. Oliver of Los Angeles,
C. P. Fonda of Manual Arts.

Northern League - No answer.
Orange League - J. S. Malcolm of San Juan Capistrano.
San Fernando League - Lester Coxe of Lancaster.
Southern League - No answer.
Valley League - S. C. McIntosh.
State Representative - H. J. Moore of Long Beach.

* Mr. Hughes of Hollywood came in later.

The secretary raised the point of order that since San Juan Capistrano had not been placed in the Orange League by the C.I.F. and that Lancaster had been rejected by the San Fernando Valley League, therefore these leagues were not represented.

The Chair ruled that since Mr. Malcolm had been elected delegate by the Orange League he was entitled to represent that League and since Mr. Coxe had not been elected to represent the San Fernando Valley League, he could not be seated.

He then declared a quorum present and the meeting open for business.

The minutes of September 28th were read and approved.

The President then ruled that in the order of rotation the City League would be entitled to the office of President and the Orange League that of Vice President.

It was moved by Mr. H. J. Moore and seconded by Mr. Malcolm that Pasadena High School be discontinued as continuous secretary. Motion carried.

Mr. Green of Inglewood was elected permanent Secretary.

Mr. H. J. Moore was elected State Representative to succeed himself and Mr. Oliver was elected to fill out the term of Mr. Wilson.

Mr. H. J. Moore was elected Football Manager for the year.

Mr. Coxe of Lancaster then asked permission to state his case. He stated that San Fernando Valley League had excluded Lancaster from the schedule although Lancaster was willing to meet the other schools more than half was having put aside \$900.00 for Athletics.

It was moved, seconded and carried that the C.I.F. request the San Fernando Valley League to reconsider their action and admit Lancaster to their schedule.

Mr. Malcolm of San Juan Capistrano then reported that Whittier had not been reinstated in the Orange League, but that San Juan Capistrano had been admitted subject to the approval of the C.I.F.

It was moved seconded and carried that the action of the Orange League be sustained.

Mr. H. J. Moore of Long Beach then submitted the following schedule: Harvard-San Diego-Pasadena-Whittier and . The President ruled that this was a schedule with representative schools.

It was moved, seconded and carried that the Secretary be instructed to inform Whittier-San Diego and Long Beach that they are expected to win 3 games out of a schedule of 5 games with representative high schools and the schedule submitted to the President for approval.

Mr. J. S. Malcolm of Capistrano High School read a letter from L. E. Plummer of Fullerton in behalf of William Lester who had been compelled to leave school before the end of the year on account of the death of his father.

The chair ruled that it had been the policy of the federation to make no exceptions to the rules.

The following semi-finals were agreed to:

Central vs Citrus

Bay vs Orange

Southern League Sect. I. vs San Diego City vs Sect II

A committee was then appointed to have charge of all semi-finals.

Secretary Green - Chairman

Mr. Hughes of Hollywood and Mr. Blee of Puente.

The Secretary was instructed to write to the George Jr. Republic and ascertain the correct standing of this school.

The question of Armstrong at Los Angeles was then brought up by the Secretary at the request of Venice. A committee of three, consisting of Mr. Moore of Franklin, Mr. Hill of Ontario and Mr. Blee of Puente, was appointed to investigate and report.

Upon motion made by G. M. Green and seconded by C. H. Moore of Franklin, the report was accepted without a dissenting vote.

The committee on Armstrong of L. A. High alias Venice Union reported as follows:

"Report of committee regarding eligibility of Douglas Armstrong: It appears from evidence submitted that Los Angeles is assigned by the father as legal residence. It appears, however, that there is maintained a home at Venice at which the father and one son lives, while there is maintained in Los Angeles a home at which the mother and another son (Douglas) lives. It would not appear from this that Douglas was "compelled" by change of residence to change schools. The committee therefore recommends that he be declared ineligible to compete in athletics at L. A. H. S. this semester or until such time as sufficient evidence has been given this committee that Los Angeles has become the unquestionable residence of the entire family".
