MINUTES OF EXECUTIVE COMMITTEE MEETING

October 4, 1941

The Executive Committee met in the C.I.F. Office at 9:30 A. M.

Mr. John Wilson, Principal and Mr. Dick Cline, Head Physical Education Department of the Jordan High School, and Mr. Dick Arnett of Inglewood High School, were also present for part of the meeting.

- (1) Mr. Van Patten submitted the financial report printed below. There being no questions, the President ruled the report accepted and directed that it be printed as a part of the minutes of the meeting.
- (2) The annual dues for the year were discussed at length. Moved by Mr. Thompson, seconded by Mr. Bergstrom, that the dues for 1941-1942 be set at 2c per A.D.A. for the year 1940-1941. Carried.

(3) Mr. Van Patten presented a letter from the United States Revenue Department showing that the case regarding the taxes on the Santa Barbara - Whittier football game of December 14, 1940, had been closed. The President directed that the letter be filed and the money advanced by Mr. Van Patten in the case be returned.

(4) A letter from Mr. P. D. Diskin of the Las Vegas, Nevada, High School asking admission to the C.I.F., Southern Section was presented. Moved by Mr. Hayhurst, seconded by Mr. Thompson, that we recommend to the State

Council that the request be approved if and when the Principal at Las Vegas joins in the petition. Carried.

- (5) Mr. Paul Wilson, Tennis Coach at the Ventura Junior High School, submitted a tentative team tennis schedule and asked that conditions be named under which Ventura Junior High School may enter the team tennis play-off next May. Moved by Mr. Bergstrom, seconded by Mr. Thompson, that Ventura Junior High School must win nine of twelve games on the schedule submitted to enter the play-off. Carried.
- (6) A letter from Mr. J. P. O'Mara of the Pasadena Junior College asked that the Pasadena "Bull Pups" be placed in a regular league for competition. The President ruled that the Executive Committee does not have authority to place a school in any league. He directed that the Pasadena request be made a regular item of business for the February Council meeting when leaguing for next year is a first order of business.
- (7) Mr. Dick Arnett requested that an improved form of a starting block which he has perfected be recommended for use by all C.I.F. schools.

The President directed that the matter be referred to the track committee for a report.

(8) Eligibility cases—

- (a) Leland Lyon of Holtville attended a private boarding school in Sacramento last year. His mother is now in a hospital and Leland lives with an uncle in Holtville. He was ruled not eligible as he did not return to home of parents.
- (b) Bill Wilson of San Dieguito was ruled ineligible for failure to make passing grade in sufficient hours of work last semester.
- (c) Richard Borchard of Oxnard High School was ruled ineligible as he had changed schools without his parents having changed residence.
- (d) Donald Ward of Needles was ruled ineligible because he had changed schools without a change of residence by his parents.

(e) Raymond Petitfils of Covina High School was ruled not eligible except at Puente High School in which district his parents live.

John Hopkins of Covina High School was ruled not eligible at Covina for one semester as he had enrolled in a Ventura County school this semester and had transferred to Covina without his parents changing residence.

(f) Bill Pickford of Vista High School was ruled ineligible for competition at Vista until his

parents move into a home in Vista.

- (h) Chester Fox of Point Loma High School was ruled ineligible as he had changed schools but his parents had not changed residence.
- (i) Glen Updyke of Fullerton was ruled ineligible as he was not in school ten weeks of last semester.
- (j) The eligibility of Don Walters of Jordan High School was referred to the Superintendent of Schools in Long Beach as to his status under the Long Beach City rules. The ruling of the Superintendent as to eligibility in Long Beach will be followed so far as competition outside of Long Beach is concerned.

Wayne Spence of Jordan High School who attended the John Dewey High School last year was ruled eligible to compete in his home district since the John Dewey High School has ceased to exist as a separate school. This ruling will apply to boys in any school that may go out of

(k) A Santa Monica boy moved to Hoover High School, San Diego, where he lives with a married sister while his parents live in Los Angeles. He was ruled ineligible because he did not enroll in a school adjacent to the district in which his parents live.

The Executive Committee discussed at length the advisability of all eligibility cases being considered by the League concerned before being referred to the Executive Committee for a ruling.

This question will probably be brought to the Council in the form of a constitutional amendment at the February meeting of the Council.

(9) Moved by Mr. Hayhurst, seconded by Mr. Thompson, that Mr. Van Patten be directed to lease the Los Angeles Coliseum for the final play-off football game among the schools of the Major Conference and the Citrus Belt League winner, and the admission fees to this game be set at:

Student Admission-.27 and that the Federal tax be added to these

NEW REVENUE LAW—FACTS AND **OPINIONS**

An interview with Mr. H. G. Barnett, Chief of the Miscellaneous Division in the Internal Revenue Office in Los Angeles brought out the following facts, opinions, and recommendations.

(1) Student body cards sold before October 1, 1941, are not subject to tax under the new law.

Those sold after October 1 are subject to tax under the new law for the entire sale price unless the sale price is broken down showing what proportion is to pay for entertainment features and what part is for other purposes. When so broken down only the entertainment portion is

Mr. Barnett suggests that possibly a card for entertainment only might be issued and the tax problem thus simplified.

(2) In games and entertainments those helping in any way in staging the activity will not be required to pay a tax on admission if admission is complimentary.

Boards of Education, Administrators, C.I.F. Officials, and other athletic functionaries must pay the Federal tax even though they are issued complimentary tickets. Only where such officials

actually assist in staging the event are they exempt from paying the tax.

School lettermen who have graduated, and to whom life passes have been issued, must now pay the Federal tax on admission to games.

Mr. Barnett suggests that all passes issued to administrators, friends, press representatives, etc., contain a statement to the effect,—"This pass is not a ticket of admission. It may be presented at the ticket office and upon payment of the Federal tax a regular ticket of admission will be issued."

(3) Where student tickets are sold for a less price than adult tickets both must pay the tax due on the higher priced ticket so long as both ticket holders may sit in the same section of the stands or the auditorium.

(4) Reports on sale of tickets and payment of the tax must be made during the calendar month following the sale of the ticket. Reports for this month of October, 1941, must be made between November 1 and November 30, 1941.

(5) Forms for schools for making the tax reports are not yet available.

(6) Unused tickets must not be destroyed until a clearance is given by the Revenue Department.

(7) If tickets are serially numbered they need not be dated showing when used. If tickets are not serially numbered then they must be stamped with the date of the event before being sold.

The C.I.F. Office will be glad to present other questions to Mr. Barnett who is ready at all times to help us get properly started in this new field.
