

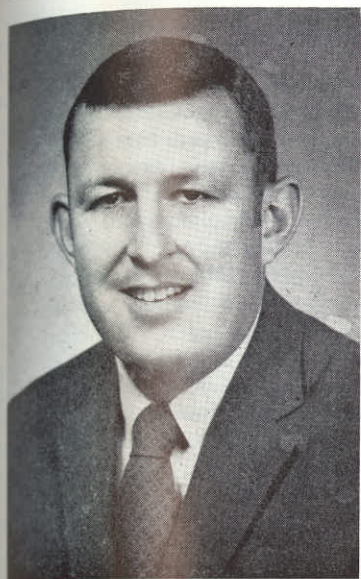

TOM MORGAN TAKES ADMINISTRATIVE ASSISTANTS POST



Tom Morgan, for the past five years Athletic Business Manager at the University of California, Santa Barbara, has been named Administrative Assistant for the California Interscholastic Federation, Southern Section, Commissioner Ken Fagans has announced.

Morgan, who replaces Lou Joseph, assumed his new assignment on Sept. 1. Joseph resigned from the CIF staff in July to assume duties as principal of Villa Park High School.

"We feel extremely fortunate to have obtained a young man of Tom Morgan's capabilities," Fagans said. "At UCSB he was a skillful administrator in the athletic department and we feel we couldn't have found a more qualified nor dedicated man to bring into the CIF office."

Morgan, who was graduated from UCSB with honors in 1963, took over the school's Athletic Business Manager when Jack Curtice became Athletic Director in 1965.

"His services have been invaluable to us," Curtice said, "and while we are most sorry to see him go, we realize the importance of the new challenge ahead which he so justly deserves."

During his five years at UCSB, Morgan completely reorganized the business office of the athletic department and was cited by Curtice "for developing it into a smooth running, highly efficient operation."

Morgan, 30, who was born in Pomona and grew up in the Covina area, served as a lieutenant in the U.S. Army upon his graduation from UCSB. He was a unit commander in the high priority STRIKE Command at Fort Ord.

During his undergraduate days at Santa Barbara he worked part time for the sports department of the Santa Barbara News-Press and he was also employed for five summers by the San Gabriel Valley Daily Tribune where he worked on the sports desk.

Morgan earned several honors at UCSB, including the Associated Men's Students Award as the outstanding male student in 1961-62. He served as sports editor of both the school newspaper, El Gaucho, and the student yearbook, La Cumbre, and was named as the latter's outstanding staff member in 1960.

He graduated from Covina High School in 1958, where he was student body president as a senior and selected as Boys' State Representative during the summer of 1957.

Morgan has remained active in the UCSB Alumni Association as chairman of its athletic awards committee and is a member of the Delta Tau Delta Fraternity.

He is married to the former Toni Haycock of Redlands.

NEW STATUS ACCORDED AA FOOTBALL DIVISION

As a result of action taken last fall by CIF, SS, officials, the AA football playoff division has taken on a new look.

There are now 11 leagues in the AA division, and a like number in the AAAA and AAA. Five leagues which were formerly in the AAA division have been moved to AA, including the Rio Hondo League, which produced last season's AAA champ, South Pasadena.

There are also two new leagues in the AA division, the San Andreas and Desert Valleys Leagues, the results of relegating in the San Bernardino, Riverside and Imperial county areas.

NEW 'ROUTE' TO FOLLOW FOR MONTHLY BULLETIN

Circulation of the Monthly Bulletin has always been a problem.

The CIF, Southern Section, office, in an attempt to solve this problem, has developed the above "routing guide" to help member schools insure that coaches of each sport at all levels will have an opportunity to review the Monthly Bulletin and receive all information pertinent to their particular sports.

This routing guide was designed so that each coach would be able to indicate that he has read the material by initialing in the appropriate box, and it is hoped that athletic directors will be able to take effective advantage of this type of distribution format. The guide will appear each month on the front page of the bulletin.

The CIF, Southern Section considers its Monthly Bulletin to be one of the most important means of sending information to its member schools. The bulletin contains, among other things, minutes from all Council and Executive Committee meetings, playoff calendars and results, lists of games wanted for all sports, and items of importance that need to be brought to the attention of athletic department personnel.

SO. SECTION SCHOOLS BENEFIT FROM AREA COMMISSIONERS OF OFFICIALS

One of the most valuable and least known services provided by the CIF, SS, is the assigning of athletic officials, accomplished for the metropolitan Los Angeles County area through Darol Roundy of the CIF office and through area commissioners of officials in six Southern California districts. The service is provided free of charge.

Commissioners of Officials are appointed for Orange County, Desert area, San Luis Obispo County, Ventura-Santa Barbara Counties, Foothill area, Inland area, and the metropolitan Los Angeles County section.

The area Commissioners of Officials are directly responsible to the CIF, Southern Section, Commissioner of Athletics. The area commissioner maintains a neutral position and represents both the Officials' associations and the leagues in his respective areas.

He does not and cannot give out any interpretations of the CIF, SS, blue book, its rules and regulations. His only responsibility is to assign officials and to secure information and serve as a resource person or consultant in all protest cases when requested by the league.

The following persons handle this important duty: Orange County—John McDonough; Desert area—Walt Dye; Santa Barbara, Ventura and San Luis Obispo—Cal Houston; Inland area—Harry Nicholson; Foothill Section—Truck Lindsey; and Metropolitan Los Angeles County Schools — Darol Roundy.

MINUTES OF EXECUTIVE COMMITTEE MEETING, SEPTEMBER 19, 1970

The September meeting of the CIF, Southern Section, Executive Committee was called to order by Chairman Steve Miletich at 1:30 p.m. on Saturday, September 19, 1970, at the CIF Office.

The following members were in attendance: Chairman Miletich, Vice-Principal, Beverly Hills High School; Donald Cogswell, President of S.S. Council, Vice-Principal, Mira Costa High School; Keith Lee, Treasurer of S.S. Council, Principal, Yucca Valley High School; Alex Alexander, Assistant Superintendent, Desert Sands Unified School District; Tony Balsamo, Principal, Apple Valley High School; Ferren Christensen, Principal, Westminster High School; Richard Cordano, Principal, Arcadia High School; James Faul, Principal, Workman High School; Msgr. Thomas Kiefer, Principal, Bishop Amat High School; and Commissioner of Athletics, J. Kenneth Fagans, and Thomas Morgan, Administrative Assistant, CIF, Southern Section.

1. APPROVAL OF MINUTES —

It was moved, seconded, and passed to approve the minutes of the Executive Committee meeting of June 20, 1970, as published in the September, 1970, Monthly Bulletin.

2. APPLICATIONS FOR MEMBERSHIP. It was moved, seconded, and passed to approve regular membership in the CIF, Southern Section, for the following schools: Pilgrim High School, Los Angeles (effective immediately), and Schurr High School, Montebello (effective September, 1971); and to approve associate membership, effective immediately, for the following schools: Sequoia Junior High School, Santa Susana, and Victor Valley High School, Victorville.

3. DEACTIVATION OF PENN MILITARY ACADEMY. The CIF Office received notification on August 6, 1970, that Penn Military Academy, located in Hesperia, would not open for the fall semester, 1970. Because of the deactivation of the school, and in line with CIF policy regarding a matter such as this, the Executive Committee moved, seconded and passed to declare all affected students residually eligible for interscholastic athletic competition if they transfer to the public school in the attendance area in which their parents reside or at the private school of their first choice.

4. WORKMAN'S COMPENSATION — Commissioner Fagans reported further on the recent order

from the State Department of Labor that the various CIF sections in the state must ensure that Workman's Compensation is provided for all officials assigned to high school athletic contests. The Commissioner had been directed by the Executive Committee, at its meeting of June 20, 1970, to investigate this matter and take necessary action, and on September 1, 1970, the CIF office notified all superintendents and principals that coverage must be secured for each school for the 1970-71 school year. The Executive Committee moved, seconded, and passed to approve this action of the Commissioner, and further authorized him to check with each school, by return mail, to confirm that this directive has been complied with.

5. NATIONAL FEDERATION CONVENTION, 1971. It was moved, seconded, and passed to select Mr. Ferren Christensen, Principal Westminster High School, and Msgr. Thomas Kiefer, Principal, Bishop Amat High School, as representatives to attend the National Federation Convention in July, 1971, at Denver, Colorado.

6. CHANGE OF SCHOOL ORGANIZATION, PASADENA. Pasadena High School informed the CIF office on June 25, 1970, that it would be operating from a multiple campus situation under the supervision of one principal for the 1970-71 school year. In accordance with CIF policy as reviewed by the State Federated Council in June, 1970, the Executive Committee moved, seconded and passed to approve the eligibility of all students affected by this change to a multiple campus to represent one high school in interscholastic athletic competition.

7. ELIGIBILITY CASES. After careful consideration of each case, it was moved, seconded, and passed to waive the transfer rule to permit the following students to be immediately eligible to participate in interscholastic athletics:

It was moved, seconded, and passed to waive the residence rule to permit the following students to be immediately eligible to participate in interscholastic athletics:

It was moved seconded and passed to waive the previous semester rule to permit the following students to be immediately eligible to participate in interscholastic athletics:

David Pierce, Indio HS; William Spade, Righetti HS.

It was moved, seconded, and passed to DENY the request to waive the transfer rule for the following students: Gabriel Hernandez, Cajon HS; Frank Balderama and Robert Salgado, Chino HS; Tony Romero and Edward Warner, Eagle Mountain HS; Ray Padgett, John H. Glenn HS; Stanley Sumibcay, Norco HS; Tim Hutchinson, Ontario Christian HS; Norman Bretches, San Marcos HS.

It was moved, seconded, and passed to DENY the request to waive the previous semester rule for Gary Peckham, Monrovia HS.

It was moved, seconded, and passed to DENY the request to waive the transfer rule for Marvin Jones, Serra HS, and Stephen Parsons, Rancho Alamitos HS. However, Rancho Alamitos HS is reminded that a Form 99 may be processed in the case of Parsons to allow him to participate in any other varsity competition.

8. NEFF HIGH SCHOOL VIOLATIONS. Mr. Gilbert Ulibarri, Principal of Neff High School, La Mirada, Mr. Arvel Goodman, Athletic Director, and Mr. Stan Thomas, Football coach, appeared before the Executive Committee to explain possible violations of CIF, Southern Section, By-Laws, Article XXXXIII, paragraphs 33, 34, and 35, pertaining to summer football conditioning programs. Mr. Ulibarri informed the Committee that his school had indeed been in violation of CIF rules by permitting the use of sleds and blocking bags. He offered no excuse other than the fact that they were attempting to stimulate and maintain interest in their football program, and reported that the man directly responsible, a Class C coach, had been properly disciplined.

Commissioner Fagans then brought to the attention of Mr. Ulibarri and his staff certain charges reaching the CIF office that there may have been additional violations of CIF regulations by Neff High School. Specifically in question was the charge that the school had invited certain outstanding eighth grade football players and their fathers to ride the team bus and sit on the bench during varsity football games. If this did occur, it could be a direct violation of the "undue in-

fluence" rule since eighth grade students, even though they may reside in the attendance area of a public high school, are not bound to attend that school. They could choose to attend a private or parochial school. Mr. Goodman admitted that this type of activity had taken place, but stated that he was not aware that it violated CIF, SS, rules.

The other charges that had been reported to the Commissioner were denied by Neff High School and no evidence of any additional violations was presented.

The Executive Committee thanked the Neff personnel for their appearance and for their complete cooperation in this matter, and expressed its appreciation to Mr. Ulibarri for his assistance in correcting the above situations and for his continued effort to ensure that his staff members comply with all CIF regulations. The guests were then excused and the committee reconvened in executive session.

After considerable discussion, it was moved, seconded, and passed to: 1) Censure the Neff High School administration for allowing this type of activity to continue without its knowledge; 2) Declare all Neff High School football teams ineligible for league championships and to deny them CIF football playoff opportunity, if eligible, for the current 1970-71 school year; and 3) Order that the Athletic Director who admitted that he was responsible for this action be relieved of his duties as Athletic Director and have no further responsibility for the athletic program at Neff High School for the current 1970-71 school year.

9. FREE-LANCE GYMNASTICS. Commissioner Fagans indicated that a problem had been anticipated in Orange County when five schools who compete in a freelance gymnastics league had denied admission to Sonora High School to join the league for the 1970-71 school year. It has always been CIF policy to attempt to group schools in free-lance leagues for sports where all member schools of certain leagues do not sponsor teams. Although this item appeared on the agenda, Mr. Fagans reported that league officials had decided to admit Sonora and the problem had been resolved.

10. WILSON HIGH SCHOOL BASEBALL PROTEST. The Executive Committee was informed that a conflict had developed between the CIF, SS, By-Laws, Article XXXX (Baseball Regulations), paragraph 9, and the Moore League Constitution, which resulted in an official appeal being submitted by Long Beach Wilson High School. The situation in question involved a tie game which the

league did not allow to be replayed, although the CIF rules state that "if a league game is called after the fourth inning with the score tied, the game will be continued from the last completed inning, at the earliest time mutually agreeable to both schools." Commissioner Fagans recommended that the CIF rule be revised in order to preclude a conflict such as this from reoccurring in the future. The Executive Committee directed the Commissioner to respond to Mr. Gene Rowland, baseball coach, Long Beach Wilson High School, to indicate that the matter had been discussed, and further requested the Commissioner's Office to study the situation and to report back to the Committee regarding recommendations for changing this rule.

11. BURGLARY OF CIF OFFICE. The CIF, Southern Section, office was burglarized on September 6, 1970, and nearly \$6,000.00 worth of office equipment was removed from the premises. Although an insurance claim has been submitted, depreciation of the stolen equipment will result in a considerable loss for the CIF to assume. The Executive Committee authorized the Commissioner to proceed immediately to contract for the best available type of silent burglar alarm system to be installed in the CIF office building.

12. ADDITION TO CIF OFFICE BUILDING. With the hiring of a full-time publicist to the CIF administrative staff, problems have been encountered with regard to inadequate office space. In anticipation of this, the Executive Committee last spring authorized the addition of two offices to the present building. Commissioner Fagans reported that the project architect had submitted the job to bid and that it was anticipated construction would begin on or about October 15, 1970.

13. FINANCIAL REPORT AND REVISED BUDGET. Treasurer Lee advised the Executive Committee that, because of personnel changes and after reviewing the auditor's report, some minor alterations were made in the 1970-71 fiscal year budget that had been adopted on June 20, 1970. The Committee reviewed and adopted the revised budget and directed the Commissioner to present a detailed report to the Council at its meeting on September 26, 1970.

There being no further business to come before the Executive Committee, the meeting was adjourned at 5 p.m.

More than 125,000 boys take part in 12 CIF, Southern Section, approved inter-scholastic sports: football, basketball, baseball, track, wrestling, water polo, cross country, swimming, gymnastics, golf, tennis and soccer.

CIF, SS MEMBERSHIP TOTAL DOWN FROM 1969-70, AT 422

Secondary schools currently on the CIF, Southern Section, list now number 422.

Of these, 340 are high schools senior located in the Southern California, which field athletic teams.

There are 11 associate member Nevada and Arizona High Schools, who join the CIF for the purpose of scheduling games with boarder-area California Schools.

Seventy-one Southland junior high schools are also associate members, with membership in these schools limited to ninth graders who are subject to all CIF, SS, eligibility rules.

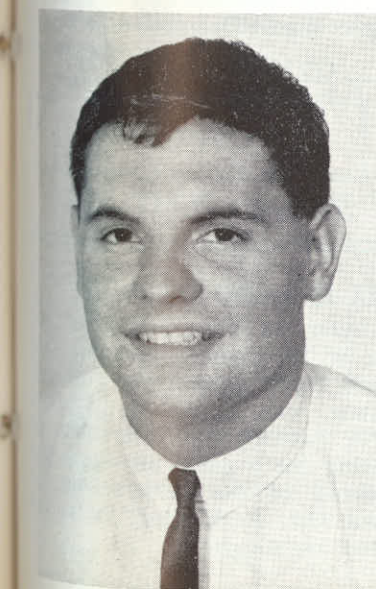
The total is down slightly from last year's all time high of 441, with the reasons being an elimination of the athletic program in the San Bernardino area junior highs and the switching of Paramount and Pasadena areas to four-year high schools, thus incorporating ninth graders of the junior highs into the regular membership high schools.

NOTE: For the 1970-71 season a designated fourth lane space on each side of both free throw lanes has been added.

Rule 1—Section 5

A free throw lane, 12 feet wide measured to the outside of each lane boundary and the semicircle with the free throw line as a diameter, shall be marked at each end of the court with dimensions and markings as shown on the court diagram. All lines designating the free throw lane, but not lane space marks and neutral zone marks, are part of the lane. The color of the lane space marks and neutral zone marks shall contrast with the color of the boundary lines. The lane space marks (2 inches by 8 inches) and neutral zone marks (12 inches by 8 inches) identify areas which extend from the outer edge of the lane lines 36 inches toward the sidelines.

One new league was added to the AAA division, the Marmonte, composed of schools in the northwest Los Angeles and Ventura County areas. The Irvine League has been moved from the AAAA division into AAA, that being the only AAAA change in leagues.

The A division gained the Frontier League, a former AA circuit, and the new Los Padres League, which includes schools in the northwestern-most reaches of the Southern Section, along the coast.

Accordingly, with the enhancement of the AA division, a panel of sports-writers selected by the CIF, SS office will vote on an AA top 10 in football this season, as well as AAAA and AAA.
